# N on-invariant tw o-loop counterterm s for the three-gauge-boson vertices

#### Abstract

Som e practical applications of algebraic renorm alization are discussed. In particular we consider the tw o-loop Q CD corrections to the three-gauge-boson vertiaes involving photons, $Z$ and $W$ bosons. For this purpose also the corresponding two-point functions have to be discussed. A recently developed procedure is used to analyze the breaking term s of the functional identities and explicit form ulae for the universal counterterm $s$ are provided. Special attention is devoted to the treatm ent of in fra-red divergences.


## 1 Introduction

The im pressive experim entalprecision $m$ ainly reached at the electron \｛positron colliders LEP and SLC and at the proton anti\｛proton collider Tevatron has $m$ ade it $m$ andatory to evalu－ ate higher order quantum corrections．The dom inant contributions arise from perturbative calculations in the Standard M odel（SM）of elem entary particle physics and some of its extensions．A s the $m$ om entum integrals occurring $w$ ithin the usual evaluation of quantum corrections are divergent，a regularization accom panied by a renorm alization prescription is adopted．D ue to chiral couplings involving ${ }_{5}$ ，no invariant regularization schem e is known for the Standard M odel \｜leaving aside the lattioe regularization w ith the G insparg－w ilson version of chiral sym $m$ etry ${ }_{[1]}^{1[1] . ~ T h e ~ p r a c t i c a l i t y ~ o f ~ t h e ~ l a t t e r ~ s c h e m ~ e ~ f o r ~ h i g h e r-l o o p ~ c a l c u l a-~}$ tions has to be explored．

It is well known that in the fram ework of dim ensional regularization only the non－ invariant＇t H ooft－Veltm an schem e for 5 is shown to be consistent to all orders［2］， naive dim ensional schem e（NDR）leads to inconsistencies in connection to 5 and the higher order calculations w ithin the SM have already reached a point where these inconsistencies cannot be avoided．In［嗻］it was em phasized that the ND R schem e can still be used in $m$ any speci c calculations and also a practical modi cation of the NDR scheme was proposed． In this paper we want to advertise an e cient consistent calculation using a non－invariant regularization schem e ． T his has the consequence that in general the functional identities like the W ard－Takahashi（W T I）and the Slavnov－T aylor identities（ST I）are violated by local breaking term s．H ow ever，the concept of algebraic renorm alization provides a pow erful tool to $x$ the identities and rem ove the breaking term $s$（see，e．g．，［⿶凵1］）．

In a recent paper，algebraic renorm alization has been considered w ith regard to practical applications［G］］．A procedure has been suggested and wonked out，which allow s an e cient determ ination of the breaking term s．Actually the com putation can be reduced to the evaluation of universal，i．e．regularization－schem e－independent，counterterm s．

In this letter we want to apply the $m$ ethod to the three－gauge－boson vertioes involving two $W$ bosons and a photon（ AW W ）or Z boson（ ZW W ），respectively．They constitute a building block to the im portant $W$ pair production process in $e^{+} e$ annihilation，which plays a cnucial role at LEP 2．Furtherm ore we consider the vertex functions involving three neutral gauge bosons，which wew ill denote by ZAA，AZZ and ZZZ．N ote that A A A vanishes because of Fury＇s theorem．A lso in the context of anom alous couplings the precise study of the three－gauge－boson vertices is of im portance．

In $\left[\begin{array}{ll}{[17}\end{array}\right]$ the one－loop diagram scontributing to $e^{+} e!W^{+} W$ have been com puted in the fram ew ork ofdim ensional regularization．H ow ever，proceeding to higher orders，a consistent treatm ent of 5 becom es $m$ andatory and the popular，naive dim ensional regularization has to be given up．The $m$ ethod of algebraic renorm alization provides the possibility to adopt any convenient regularization｜it only has to be consistent．

Our aim is to focus on two－loop QCD corrections，which has the consequence that at the one－loop order only the ferm ionic contributions have to be considered．Furtherm ore we decided to work in the fram ew ork of the background eld gauge，which has the advantage that only W T Is w ith extemalbackground elds（and no ST Is）have to be considered at the
highest order. They have the sam e structure to any order in perturbation theory.
Let us in the follow ing brie y review the $m$ ain steps elaborated in [6] breaking term $s$. The use of a non-invariant regularization schem e induces breaking term $s$ into the ST Is

which im plem ent the background gauge invariance of the SM. The localbreaking term sare denoted by $\int_{S}^{(n)}$ and ${ }_{W}^{(n)}()$. N ote that the locality is a consequence of the $Q$ uantum A ction Principle (Q AP) tẹ $]$. H ere and in the follow ing ${ }^{(n)}$ denotes the $n$-loop order, regularized and ( $m$ inim ally) subtracted, one-particle-irreducible (1P I) function. $N$ ote that the ST Is and the W T Is are not able to x the G reen functions com pletely. Indeed it is possible to add invariant local term s to the action, changing the nom alization conditions of the functions. A com plete analysis of the nom alization conditions for the SM can be found, for instance,

 them into


${ }^{0}$ corresponds to the pow er counting degree of the $G$ reen functions ${ }^{(n)}$. The new breaking term $s{ }_{s}^{(n)}$ and ${ }_{W}^{(n)}()$ are due to over-subtractions and can be expressed in term sofa linear combination of ultra-violet (UV) nite Green functions and, thus, are independent of the regularization schem e [G]. H ere we assum ed that up to the ( $n \quad 1$ )-loop order the $G$ reen functions are already renorm alized correctly. Them ain di erence between ${ }_{S}^{(n)}$ and ${ }_{\mathrm{W}}^{(\mathrm{n})}(\mathrm{)}$ is due to the linearity of the corresponding operators $S$ and $W$ (), respectively. In the form er case one has to consider non-linear term s arising from lower-loop orders. On the contrary in the latter the linearity of the W T I sim pli es the evaluation of the breaking term s and counterterm s enorm ously. F inally we introduce

where the counterterm ${ }^{(n)}$ is chosen in such a way that the follow ing identities are ful led:

In general it is quite simple to com pute the total counterterm $\left(T^{0}{ }^{(n)}+{ }^{(n)}\right)$, as it can be expressed in term s of $G$ reen functions expanded around zero extemalm om enta.

A s already mentioned above, there is still the freedom to add invariant counterterm s , ${ }_{N}^{(n)}$, to $I^{(n)}$ in Eq. ( $(\underline{i})$. . In other words, we have the freedom to im pose nom alization conditions, which lead, in addition to Eqs. ( $\underset{-1}{ } \mathbf{1})$, to the equations

where the index i runs over all independent param eters of the $S M$. As the $G$ reen function
${ }^{(n)}$ also has to ful 11 this condition, we have for the counterterm

which is a localequation. This m eans that, whenever the e ort to im pose the norm alization conditions is $m$ ade, the changes due to the subtraction are only local changes, which can be easily com pensated. Explicit exam ples w illibe discussed at the end of Section ' the im position of norm alization conditions is a very im portant ingredient of the com putation in order to com pare w th other schem es and in order to sim plify the breaking term $s$ them selves.

The procedure described so far is based on the Taylor operator $T$. In the presence of $m$ assless particles, this $m$ ay introduce $\mathbb{R}$ divergences. In the exam ples discussed in this paper, eventual $\mathbb{R}$ problem s are encountered in interm ediate steps after neglecting one of the quark $m$ asses, a well-justi ed approxim ation in the case of the top \{bottom doublet. $N$ ote that this kind of $\mathbb{R}$ divergences should not be confiused w ith those arising in connection $w$ th on-shell conditions of intemal particle propagators. The appropriate $m$ ethods for dealing w th $\mathbb{R}$ divergences are introduced in Section ${ }^{\prime}$ ' $\overline{-}$.

A thhough we are $m$ ainly interested in the three-point functions, also some two-point functions w th extemal (background) gauge bosons have to be treated properly in order to be able to renorm alize the am plitudes correctly. They w ill be discussed in Section int

In Section'ī', the one-loop sub-diagram s occurring in the tw o-loop calculation are analyzed. In Section introducing the two-point functions, we are ready to discuss the cases AW W and ZW W in Section 'S.

## 2 O ne-lop G reen functions

$T$ his section is devoted to the one-loop sub-diagram s induced by Q CD, which are needed for the renom alization.

In the case of neutral gauge bosons one has to take into account the two-and three-point
 is replaced by the $Z$ boson. For $q$ we have $q 2 f u$; $d g$, where $u$ and $d$ refer to a generic quark doublet. A fter the analysis of the W T Is, also the vertioes w ith the neutral G oldstone

A s we work in the fram ew ork of the BFM, no G reen functions with extemal scalar or gauge elds have to be considered, and we are left w ith only three W T Is:

In this speci c sector only the counterterm $s \underset{u}{(1)}{ }_{d}^{(1)}$ and ${ }_{2 ; \mathrm{d}}^{(1)}$ can be tuned to im posed suitable norm alization conditons, the others are indeed necessary to restore the W T I ( $\overline{1})$.

U sing the notation of the introduction, Eqs. (1] $\overline{\mathrm{G}}$ ) can be expressed in the follow ing com pact form

 speci ed regularization. C learly, the com plete one-loop counterterm $s$, nam ely I (n) $\quad \stackrel{(n)}{\text { bare }}$, have to be taken into account at the two-loop level.

## 3 N eutral-gauge-boson vertices

### 3.1 The AZZ case

The vertex involving a photon and two $Z$ bosons is used to dem onstrate the $m$ ain features of our technique. This exam ple clari es also the issue of anom aly cancellation in our form alism . In principle there is also the vertex ZAA. H ow ever, it is very sim ilar to A ZZ. Thus we will not present explicit results for ZAA as the corresponding equations are sim ply obtained by replacing one of the $Z$ bosons by a photon.

A s we are dealing w ith extemalbackground elds, W T Is can be used to $x$ the counterterm $s$ for these am plitudes. In order to derive the com plete set of identities, one of the gauge elds has to be replaced by the in nitesim al param eter of the badkground gauge transform ations and then the derivatives of the functionalW T I have to be perform ed (cf. R ef. $\left.\left[\frac{1}{6}\right]\right)$. This leads to six identities, which naturally split into two sets depending on whether the index of the photon or the $Z$ boson is contracted $w$ ith the extemalm om entum . W e get the follow ing closed (under renorm alization) set of equations

There are in principle three $m$ ore equations where the contraction is perform ed $w$ ith $q$. H ow ever, they contain no new inform ation.

The breaking term $s$ in Eqs. ( 1 [1]) have $m$ ass dim ension two. Thus we have to apply the operator ( $1 \quad T_{p ; q}^{2}$ ) in order to rem ove them. $T$ his leads to

In order to rem ove ${\underset{W}{W} \hat{A} \hat{A}}_{(n)}^{z} \hat{z}(\mathrm{p} ; q)$, a counterterm, $\hat{\hat{A}}_{\hat{A} \hat{z} \hat{z}}^{(n)}$, has to be introduced for the G reen functions $\hat{\hat{A} \hat{A} \hat{z} \hat{z}} \hat{(p ; q)}$. N otioe, how ever, that this $G$ reen function also appears in

 we obtain
 index. Thus, combining the two argum ents, we deduce that the breaking term itself has to be zero.

W e have checked this prediction by explicit calculations at the one- and tw o-loop levels. At one-loop order, the contribution from one ferm ion species gives
with ${ }^{0123}=1$. The only rem inder on the ferm ion type is the third com ponent of the isospin, the charge and the coupling to the $Z$ boson. T hus, after sum $m$ ing over a com plete fam ily of quarks and leptons one gets zero. This is the sam e mechanism which leads to the cancellation of the A dler\{B ardeen anom aly in the SM [ī]. At tw o loops already the sum over all contributing diagram s of one quark avour is zero as we checked by an explicit calculation.

This exam ple provides a nice dem onstration of the power of our technique. Regardless of the regularization adopted to com pute the G reen functions ${ }^{(n)}$, the zero-m om entum subtraction xes autom atically the non-invariant counterterm s needed to restore the sym $m$ etries. In particular, we found that besides one-loop counterterm $s$ (w hich were discussed in Section ('2, 1 ) no other counterterm is necessary to de ne the properly renorm alized am pli-
 level ( $n=1 ; 2$ ) show s how the anom aly coe cient can be com puted and the A dler\{B ardeen non-renorm alization theorem can be veri ed in the present fram ew ork.

### 3.2 The Z Z Z case

A lso in the ZZZ case there is no tree-levelcontribution, which $m$ akes it sim ilar to the previous case. H ere the closed system of W T Is looks as follow s

## 4 Ferm ionic contribution to the tw o-point functions

A proper renorm alization of the two-point functions is needed in order to be able to correctly renorm alize the three-point $G$ reen functions AW W and ZW W. M oreover, m ost of the norm alization conditions are expressed in term $s$ of two-point functions. In this section we $m$ ainly concentrate on the results needed in the forthcom ing parts of the paper, while details can be found in Ref. $\left[\frac{1}{-1}\right]$.

A pplying our prescriptions to the two-point $G$ reen functions $w$ ith extemalbadkground elds show s that only the selfenergies of the (background) W and $Z$ bosons are a ected by breaking term $s$. The corresponding sym $m$ etrical $G$ reen functions read

In particular, in contrast to the previous exam ples, $A Z Z$ and ZZZ, the $W$ T Is for the AW $W$ am plitudes appear $m$ ore cum bersom $e$ because of the presence oftwo-point functions. In the conventionalalgebraic renom alization $m$ ethods this is very cum bersom e , as all G reen functions appearing in the $\mathrm{W} T$ Is have to be com puted | often for o -shellm om enta. W ew ill see that in our approach only a few $G$ reen functions rem ain which have to be evaluated w th zero extemalm om entum .

(1] $\overline{1} \overline{2})\{$ (1] $\overline{-1}))$.

N ote that the equations ( $(\underset{4}{4} \overline{9})$ are only unique up the consistency conditions (sim ilar to the one in Eq. ( $\overline{4} \bar{i} \bar{i})$ ) am ong the W T Is.

As in the previous case, the wave-function renorm alization of the background eld $\hat{z}$ is xed by the W T Is. In particular, in our analysis the $w$-angle is xed by the on-shell condition $M_{W}=M_{z}=C_{\mathrm{W}}$, where $\mathrm{M}_{\mathrm{w}}$ and $\mathrm{M}_{\mathrm{z}}$ are the physicalm asses. A ctually, using the above equations one obtains two equations which $x_{\hat{z} ; i}^{(n)}(i=1 ; 2)$

where $\underset{\hat{w} ; i}{(n)}$ is given in Eq. $(\underset{-1}{(3)} 9)$. A gain, using the consistency conditions, one can check that other possible equations are not independent.

F inally we want to rem ark that at higher orders also other counterterm sm ay be involved in the analysis. H ow ever, this depends on the speci c type of radiative corrections which are taken into account. In particular, ${\underset{G^{0}}{ }{ }^{(3)} \hat{G}}^{(1)}$ is only needed if three-loop electro-weak corrections are considered.

## $6 \mathbb{R}$ re-shu ing

In practical applications quark $m$ asses can often be neglected. H ow ever, through the Taylor subtraction this can in general induce $\mathbb{R}$ divergences in the corresponding tw O - and threepoint fiunctions. On the other hand it is im portant that the breaking term s are $\mathbb{R}$ - nite. In this section we discuss the $m$ odi cations of our procedure needed to deal w th these cases. In a rst step we want to approach the problem from a m ore theoretical point of view and only then apply it to the case of AW W .

A careful analysis of the o shell $\mathbb{R}$ problem s in the SM sull nom alization conditions are su cient to guarantee the $\mathbb{R}$ niteness of $G$ reen functions in case non-exceptionalm om enta are chosen. H ow ever, Taylor subtraction around zero extemal m om enta m ay cause problem s . Let us assum e that only the highest order of the derivative leads to $\mathbb{R}$ divergences. This $m$ eans that for a given $G$ reen function,$w$ th $U V$ divergence
degree ！，$T^{!}$is $\mathbb{R}$－divergent but $T!1$ is not．It is then tempting not to perform the com plete Taylor expansion and leave out the term with highest power of derivative．This


A cting on a broken W T I such as Eq．（2̄）w ith the Taylor operator（ $1 \quad \mathrm{~T}$ ），we obtain

where ${ }^{0}$ is the naive power counting degree of ${ }^{(n)}$ ．In general，one has ${ }^{0}$ ，Therefore the com m utation of the Taylor operator $w$ ith $W$（）leads to over－subtractions of ${ }^{(n)}$ and，thus， to the new breaking term $s{ }_{W}^{(n)}()$ occurring on the rh．s．of Eq．（5̄2i））（form ore details see ［－ब］ 1 ］．

In Eq．（ $5\left({ }_{2}^{2}\right)$ ）both term $s, T^{0}{ }^{(n)}$ and ${ }_{w}^{(n)}()$ ，could be $\mathbb{R}$ divergent．$T$ his suggests a re－shu ing of the term $s$ from the rh．s．to the lh．s．，which de nes a new breaking term through

$N$ ote that ${ }_{I R}=0 \quad 1$ is used for the $\mathbb{R}$－divergent $G$ reen functions．In this way all term $s$ of Eq．（ $(\overline{5} \overline{-} \overline{-})$ are $\mathbb{R}$－safe．The price of the re－shu ing is that the expression for ${ }_{w}^{o(n)}()$ becom es in generalm ore com plicated than the originalbreaking term，${ }_{\mathrm{w}}^{(\mathrm{n})}()$ ．H ow ever，its com pu－ tation is still sim pler than ${ }_{\mathrm{w}}^{(\mathrm{n})}()$ of Eq．（2⿹勹巳一） ．The only requirem ent is an interm ediate $\mathbb{R}$ regulator，needed for the evaluation of the individualG reen functions appearing in ${ }_{\mathrm{W}}^{0(\mathrm{~m})}(\mathrm{I})$ ．
$W$ e also have to $m$ ention that the new breaking term $s{ }_{\mathrm{w}}^{0(\mathrm{n})}(\mathrm{)}$ and the corresponding counterterm $s{ }_{W}^{(n)}$ depend on the UV subtraction．In fact，since ${ }_{\text {IR }}=0 \quad 1$ ，some Green functions are only super cially nite because of the UV subtraction．This implies that
${ }_{W}^{0(n)}()$ as well as the nal counterterm $T^{\text {IR }}{ }^{(n)}+{ }^{(n)}$（see Eq．（G）））depends on the com putation details．In addition，the dependence on the $U V$ regulator of the breaking term $s$ and the corresponding non－invariant counterterm sbreaks the universality of the com putation （see［बَ－1］）．

A s an explicit exam ple let us consider the case AW W．In particular，we specify to the top－bottom doublet and neglect the $m$ ass of the bottom quark．In this case the one－loop sub－divergences（cf．Section．．${ }_{2} \mathbf{i}_{\text {i }}$ ）becom $\in \mathbb{R}$－divergent．U sing the $\mathbb{R}$ re－shu ing discussed above Eq．（ $(\underset{-}{\overline{-}})$ transform $s$ to

Of course，no $\mathbb{R}$ divergences appear for the $A t t$ vertex and thus we still have ${ }_{A}^{(1)}=0$ ． N otioe that the advantages due to the zero－m om entum subtractions have only slightly been
reduced. The com putation of the breaking term s still relies on $G$ reen functions expanded around zero extemalm om enta. W e also stress that the proposed rearrangem ent solves the spurious $\mathbb{R}$ problem due to Taylor subtractions in general.

The problem of $\mathbb{R}$ divergences appears also at two loops. In that case, one has to handle the interm ediate regularization procedure w ith som e care. For com pleteness conceming the AW W description, we present an exam ple of $\mathbb{R}$ re-shu ing at two loops.

It is easy to see that the zero-m om entum subtraction of the rst of $E$ qs. ( $\overline{3} \overline{6} \bar{\prime})$ and the breaking term ${ }_{A}^{(2)}{ }_{+1}\left(p_{+} ; p\right)$ are $\mathbb{R}$-divergent in the approxim ation that $m_{b}=0$. So, we have to recom bine the $G$ reen functions in such a way that the com putation is $\mathbb{R}$-safe. For that purpose, we can notioe that also the zero-m om entum subtraction of $I_{\hat{A^{\prime}} \hat{Z}}^{(2)}$ and $I_{\hat{A} \hat{A}}^{(2)}$ produces $\mathbb{R}$ divergence. Therefore, the $m$ ost natural $\mathbb{R}$-safe recom bination is

where $q=p_{+}+p .{ }_{A}^{0 ;(2)}+\hat{w} \quad$ is $\mathbb{R}$-safe and, thus, can be used to com pute the counterterm $s$.

## 7 C onclusion

The techniques developed in [-6] have been applied to the three-gauge-boson vertioes. In the fram ew ork of the BFM all fiunctional identities are derived at the n-loop order. Since in the SM there exists no invariant regularization schem e (besides the lattioe regularization w th the G insparg-W ilson version ofchiralsym $m$ etry) the functional identities are broken by local term s . M ost of them are sim ply rem oved by the application of the Taylor operator t, t- $]$. The analysis of the rem aining ones is presented up to the two-loop level, where additional QCD corrections to the one-loop ferm ionic diagram s are considered. Finally subtleties in connection to $\mathbb{R}$ divergences resulting for the expansion around zero extemalm om enta are discussed in detail.
