## Isgur{W is function in a relativistic m odel of constituent quarks

## Abstract

The integral representation for Isgur { W ise function (IW F) is obtained in the fram ework of instant{form relativistic H am iltonian dynamics for mesons with one heavy quark. The upper and lower limits are calculated for the slope parameter of IW F  $^2$  by the model independent way. IW F is calculated for di erent wave functions of quarks in the meson. The di erence between the limits of  $^2$  equals 1/3. The constraint on the slope parameter is in a good agreement with experiments. The weak dependence of IW F on the choice of wave functions is found.

The quark composite systems with one heavy quark have been the focus of attention for the last several years. In the in nite heavy quark mass limit the additional spin-avour symmetries appear and simplify the calculation of matrix elements of electroweak transitions [1, 2]. Therefore all mesons form factors of the electroweak transitions are determined by a single universal Isgur { W is function (IW F)  $_{IW}$  (w) [1] (w = (v  $\frac{6}{3}$ , v<sup>0</sup> and v are 4{velocities of initial and nalmeson).

The calculation of this function is nonperturbative in principle. Several approaches exist to this problem, for example, the calculations on lattices [3], QCD sum rules [2, 4, 5, 6, 7, 8, 9], quasipotential approach [10] [11], and di erent form s of relativistic H am iltonian dynam ics (RHD): light-front dynam ics [12, 13], point [14] and instant form s [15, 16].

The slope parameter  $^2 = 0_{IW}$  (w = 1) is of special interest, while studying the properties of IW F. This interest, in particular, is explained by recent measurements of this value [17], [18], [19]. By these experiments, one can discriminate diment models or, additionally, constraint parameters of the models. The results of calculation of the slope parameter in diment approaches dimensionally [2, 3, 4, 6, 10, 12, 13, 15, 16].

In this work,  $\mathbb{W}$  F is calculated for m esons which contain one heavy quark. For slope parameter <sup>2</sup> the strong restriction is obtained. This result depends weakly on interaction model for quarks. The interval of restriction on the slope parameter equals 1/3.

The calculations of IW F are performed for dierent phenomenological wave functions of quarks in meson. It is shown that IW F depends weakly enough on the choice of the model wave functions (about 10% at w 2).

For calculation in our work we use the instant form of RHD in the version developed by the authors [20, 21](RHD is discussed in greater detail in Ref. [22] and references therein). Our approach is closely related to that in Refs. [15, 16]. However, our approach contains some original features, e.g., the method of construction of current transition matrix elements [21].

In our work, IW F is calculated from the sem ileptonic decay of pseudoscalar meson form factors [21]. The hadron part of invariant amplitude of the sem ileptonic decay of pseudoscalar meson can be expressed through two form factors F:

where  $p_c$ ;  $p_{c^0}^0$  are 3-m on enta of mesons,  $P = (p_c p_{c^0}^0)$ ;  $P_+ = (p_c + p_{c^0}^0)$ ;  $t = (p_c p_{c^0}^0)^2$ :

In our approach, the form factors F (t);  $F_+$  (t) have the following integral representation in the in pulse approximation [21]:

where  $G^{(0)}(s;Q^2;s^0)$  are the so-called free two-partical form factors,  $\prime_{c^0}$ ;  $\prime_{c}$  are phenom enological wave functions of initial and nalm esons in the sense of RHD. They are normalized with relativistic density states:

Where  $k(s) = \frac{q}{(s^2 - 2s(m_Q^2 + m_q^2) + (m_Q^2 - m_q^2)^2) = 4s}$ ,  $m_Q$ ;  $m_q$  are masses of heavy and light quarks respectively, u(k) is the non-relativistic wave function.

Free two-partical form factors  $G^{(0)}$  have been calculated in Ref. [21]:

M  $_1$  is the light quark mass, M  $_{2,3}$  are the heavy quark masses. Quark form factors in the approximation of pointlike quarks have a form [21]:

The matrix element of the semileptonic decay of pseudoscalar meson can be determined in terms of form factors h (w) (see, for example, [12]):

Here M  $_{\rm C^0}$  ; M  $_{\rm c}$  are m asses of m esons in initial and nalstates.

The form factors in Eq. (5) are connected with the form factors in Eqs. (1), (2) by the following formula:

Scalar product of 4 {velocities is determ ined through the square of momentum transfer:  $w = (M_c^2 + M_{c^0}^2 t) = (2M_cM_{c^0})$ : The IW F can be obtained from expressions (2), (6) by nding the lim it M<sub>2</sub> M<sub>3</sub> m<sub>Q</sub> ! 1 ; M<sub>1</sub> = m<sub>q</sub>:

In our calculations, we have assumed that the wave functions in Eq. (2) become independent on the avour of heavy quark and coincide in initial and nal states in  $\lim it$  (7).

The result of calculation of IW F can be presented in following form :

The condition  $_{IW}$  (1) = 1 is a consequence of the normalization (3).

In analogy with the works [14, 15, 16], the slope parameter of  $\mathbb{I} \mathbb{W} = 1$  can be represented as the sum of three term s:

The term s in Eq. (9) describe the contributions of form of wave function (with the consideration of relativistic normalization (3)), W igner rotation, and quark current, respectively. The contribution  $\frac{2}{W_R}$  and the second term in  $\frac{2}{\text{space}}$  have relativistic nature. Let us remark that our value of  $\frac{2}{\text{quark}}$  coincides with that from [15].

The integrals of the wave function can be transformed into space coordinate representation:

Here  $hr^2 i$  is the mean square radius in the ground state with wave function  $_0$  (r).

Notice that all integrals in Eqs. (9), (10) are positive. From equations (9), (10), (11) the restriction on possible values of  $^2$  can be established. To do so, let us consider the relativistic terms in Eqs. (9), (10) ( $^2_{WR}$  and the second term in  $^2_{space}$ ).

In the non-relativistic lim it these positive terms disappear in Eq. (10) and we obtain the lower bound for the slope parameter:

In the ultrarelativistic lim it these relativistic terms in Eq. (9) take the maximum values and we obtain the upper bound for  $^{2}$ :

Let us remark that the di erence between these maximum and minimum of the slope param eter equals 1/3.

Now we shall use the results of works [23]. In these works a recurrence formula was derived: D = E

Here l is the orbital angular m om entum,  $r^{21}$  multipole m om ents in ground state of twobody system,  $E_0$  ground state energy,  $E_1$  (1) energy of the lowest level of multipolarity 1,

reduced mass, in the limit (7),  $= m_q$ . Recurrent formula (14) is satisfied within 1% accuracy as equality for conning potential.

For estimation of mean square radius in (12) and (13) by means of Eq. (14), we have used two measurements of energy levels of D-meson (1S $_0$  and 1P $_1$ ) [24].

For further estimation, let us transform integrals in expressions (12) and (13):

Here  $\hat{p}$  is the operator of canonical 3-m om entum of system .

For model independent estimation of integral in right part of Eq. (15), we have used quasiclassical approximation. In ground state, this approximation gives (rp) = 0 because the mean value of r(t) sweeps a circle in the quasiclassical approximation. Therefore, the left hand side of Eq. (15) is approximately equal to unit.

For estimation of quantum corrections of this result, it is possible to calculate exactly the integral in the left part of Eq. (15) in some models. Let us perform the calculation for the model with linear connement and C oulomb behavior at small distances [25]:

In Eq.(16), a and b are the param eters of linear and C oulom b parts of potential, respectively. We use the value of b = 4=3 s. In doing so, we have used the value s = 0.52 at a scale of heavy m eson m asses. The param eter of linear part of potential  $a = 0.0816 \text{ GeV}^2$  was obtained by thing of the m ean square radius in ground state of D {m eson which was calculated from Eq. (14). In this way the quantum correction ' 0.07 was obtained.

As follows from the general conditions of application of the quasiclassical approximation, the less steep potential (r; < 1 or  $\ln r$ ) must result in smaller quantum corrections. Hence, for such class of models, the following restriction is valid to within '0.07 accuracy:

The light quark m assm  $_{q}$  is now the only free parameter in our estimations. In our relativistic calculation in Refs. [20], [21] we used the value m  $_{q} = 0.25$  GeV. This calculation are in reasonably good agreement with experiments on electroweak properties of light mesons. In this case, Eq. (14) gives  $hr^{2}i = 0.422$  fm<sup>2</sup>. Hence, inequalities (17) are reduced to the following limitation:

If the mass m<sub>q</sub> is varied within the limits in which the modern relativistic calculations are performed in dimension of m<sub>q</sub> 0.33 GeV) then the region of possible <sup>2</sup> increases:

The derived restrictions are exam ined in our work for the following di erent model wave functions: the harm onic-oscillator potential model (see, for exam ple, [26])

and already mentioned wave function with linear con nement and a Coulomb behavior at small distances which is described by Eq. (16). The wave function parameters were determined by tting of mean square radius of the D { meson which was calculated by formula (14). The tting gives the following values: in the model corresponding to Eq. (20) we obtain b = 0.372 GeV, in the model (21) we nd b = 0.526 GeV for n = 2 and b = 0.731 GeV for n = 3. W ith the presented wave functions the following values for slope parameter in Eq. (9) were obtained:  $^2 = 1.32$  in the model (20),  $^2 = 1.13$  in the model (21) for n = 2 and  $^2 = 1.20$  for n = 3, and  $^2 = 1.20$  in the model (16).

The result in m odel of harm on ic-oscillator satis as inequalities (18) within the accuracy of our calculations. Let us rem ind in this connection that the restrictions (17) were obtained for the m odel with potential increasing slow lier than linearly. It is possible that the restrictions (17) are valid for wider class of m odels. The calculations with exact form ulae (9), (10) for m odels (16), (21) satisfy the restriction (18).

Let us compare our results (18), (19) with recent experimental values of  $^2$ . Result of CLEO Collaboration [17], [19] ( $^2 = 1.67 \ 0.11$  (stat) 0.22 (syst)) satisfies our "soft" result (19) and is slightly outside the region (18). The average LEP result [18], [19] ( $^2 = 1.13 \ 0.08$  (stat) 0.16 (syst)) satisfies the "hard" restriction (18).

Let us consider results for  $2^{\circ}$  in other approaches. The two restrictions on slope parameter  $2^{\circ}$  were obtained in QCD sum rules:  $2^{\circ}$  0.25 [4],  $2^{\circ}$  1:7 [9]. Quasipotential approach gives  $2^{\circ}$  0.81 [11]. Another restriction was obtained in the fram ework of RHD [15]  $2^{\circ}$  3=4. A swe see, our restriction (18) does not contradict these results but reinforces them . However, our result, as well as that of work [15] and experiments [17], [18], is in poor correlation with the result of Ref. [5] obtained in the fram ework of QCD sum rules  $2^{\circ}$  0:75 0:15.

Now let us consider the calculations in the fram ework of instant form of RHD. In work [16], the calculations are performed for di erent interaction models of quarks in meson and results are within the range from 0.97 to 1.28, that is very close to (18). The result of quasipotential approach [10] coincides with that of ours,  $^{2} = 1.02$ .

The results of di erent calculations of <sup>2</sup> in the fram ework of QCD sum rules di er considerably: 1:00 0:02 [8];0:84 0:02 [6];0:66 0:05 [2];0:70 0:25 [7]: First and fourth of these values are near our range (18).

The lattice calculations [3] are in good correlation with our result, but we should point the large errors of these calculations:  $^2 = 0.9^{+0.2+0.4}_{-0.3-0.2}$ .

Now let us discuss brie y the calculation of W F in our approach. In g.1 the results of calculation for W F with the described model wave functions are shown. The calculation was carried out with the parameters of this work at  $m_q = 0.25 \text{ GeV}$ . As can be seen from the g.1, one of the most interesting features of our calculations is the weak dependence of W F on the choice of model wave functions at w 2. Hence, the properties of W F are mainly determined by the relativistic kinematics of light quark or so-called "light" degrees of freedom.

So, in the present work, the Isgur { W ise function is calculated in the fram ework of the instant form of relativistic H am iltonian dynam ics. A strong m odel{independent restriction is obtained for the slope parameter of Isgur { W ise function. This restriction reinforces the restrictions that were given in other approaches. We have also shown that Isgur { W ise function depends weakly on the choice of the m odel wave functions at w 2.
