# Longitudinal, transverse-plus and transverse-m inus $W$-bosons in unpolarized top quark decays at $O$ ( s)

W e consider the $O(\mathrm{~s}$ ) radiative corrections to the decay of an unpolarized top quark into a bottom quark and a $W$-gauge boson where the helicities of the $W$ are speci ed as longitudinal, transverse-plus and transverse-m inus. The O ( s) radiative corrections low er the norm alized longitudinal rate $\mathrm{L}=$ by 1:06\% and increase the norm alized transverse-m inus rate
$=$ by $2: 17 \%$. W e nd that the norm alized transverse-plus rate $+=$, which vanishes at the $B$ om term level form $\mathrm{b}!0$, receives radiative correction contributions at the sub-percent level. W e discuss $m_{b} \in e^{2}$ ects for the Bom term and the $s$-contributions but nd these to be $s m$ all. O ur results are discussed in the light of recent $m$ easurem ents of the helicity content of the $W$ in top quark decays by the CDF C ollaboration.

## I. IN T R O D U C T IO N

The CDF C ollaboration has recently published the results of a rst m easurem ent of the helicity content of the W gauge boson in top quark decays $\left[\frac{1}{[1]}\right]$. T heir results are

where L and + denote the rates into the longitudinaland transverse-plus polarization state of the W -boson and is the total rate.
$T$ he errors on this $m$ easurem ent are still rather large but will be much reduced w hen larger data sam ples becom e available in the future from TEVATRON RUN II, and, at a later stage, from the LHC. Optim istically the $m$ easurem ent errors can eventually be reduced to the (1 2) \% level Nㅣㄴ. If such a level of accuracy can in fact be reached it is im portant to discuss the radiative
 the fact that the $O(\mathrm{~s})$ radiative corrections to the total w idth are rather large ( $8: 5 \%$ ) 伎 1

The transverse-plus rate + is particularly interesting in this regard. Sim ple helicity considerations show that

+ vanishes at the B om term level in the $\mathrm{m}_{\mathrm{b}}=0$ lim it. A nonvanishing transvense-phus rate could arise from i) $m_{b} \in O$ e ects, ii) $O(\mathrm{~s})$ radiative corrections due to ghon em ission, or from iii) non-SM $t$ ! b currents. A s we shall show the $O(\mathrm{~s})$ and the $\mathrm{m}_{\mathrm{b}} \neq 0$ corrections to the transverse-plus rate occur only at the sub-percent level. It is safe to say that, if top quark decays reveala violation of the Standard M odel (SM ) (V A) current structure that exceeds the 1\% level, the violations m ust have a non-SM origin. In this context we m ention that
a possible ( $V+A$ ) adm ixture to the $t$ ! b current is already severely bounded indirectly by existing data on b ! $\mathrm{s}+\mathrm{decays}$ [1d!11].

T he results of the radiative correction calculation have already been published before by som e of $[\overline{13}[\underline{1}]$. H ow ever, in $R$ ef. [3] $\left[\frac{1}{0}\right.$ the em phasis $w$ as on polarized top decay. Besides, in $R$ ef. [3T] ofthe W weregiven for the \unpolarized-transverse" and the \forw ard-backw ard" com ponents which di er from those used in the CDF analysis. W e thought it would be usefiul to collect together in one place all form ulae relevant for an understanding of the new CDF m easurem ent. $T h i s$ includes also a discussion of $m_{b} \in 0$ e ects for the B om term and for the $s$ radiative corrections, which is new.

## II. ANGULAR DECAY D ISTRIBUTION

Let us begin by w riting down the angular decay distribution for the decay process $t!X_{b}+W^{+}$followed by $\mathrm{W}^{+}$! $\mathrm{I}^{+}+1$ (or by $\mathrm{W}^{+}$! $\mathrm{q}+\mathrm{q}$ ). For unpolarized top decay the angular decay distribution is determ ined by tw o transverse com ponents (transverse-plus and transversem inus) and the longitudinal com ponent of the $W$ booson. Integrating over cos one recovers the total rate

W e describe the angular decay distribution in cascade fashion, i.e. the polar angle is $m$ easured in the $W$ rest fram e where the lepton pair or the quark pair em erges back-to-back. The angle denotes the polar angle betw een the $\mathrm{W}^{+} \mathrm{m}$ om entum direction and the antilepton
$I^{+}$(or the antiquark q) (see Fig.1). T he various contributions in ( $\mathbf{3}$ ) are re ected in the shape of the lepton energy spectrum in the rest fram e of the top quark. From the angular factors in ( $\mathbf{3}$ ) it is clear that the contribution of + makes the lepton spectrum harder while softens the spectrum where the hardness or softness is gauged relative to the longitudinal contribution. The only surviving contribution in the forw ard direction $=0$ com es from + . The fact that + is predicted to be quite sm all im plies that the lepton spectrum will be soft. The CD F $m$ easurem ent of the helicity content ofthe $W^{+}$in top decayswas in fact done by tting the values of the helicity rates to the shape of the lepton's energy spectrum .

The angular decay distribution of the antitop decay $t!X_{b}+W$ followed by $W$ ! $1+1$ (or by $W$ ! q+ q) can be obtained from the angular decay distribution $(3)$ ) by the substitution $(1+\cos )^{2} \$(1 \mathrm{cos})^{2}$. The polar angle is now de ned w ith regard to the lepton 1 (or the quark) direction.

In Eqs. ( $\bar{G})$ we have also listed the leading com ponents of the $s m a l l y^{2}$ expansion of the $B$ om term rate ratios. As the second equation of ( $(\bar{q})$ show $s$ and as already re$m$ arked on before, the transverse-plus B om term contribution vanishes in the $\mathrm{m}_{\mathrm{b}}=0 \mathrm{lim}$ it. N ote that the leading contribution to the transverse-plus rate is proportional to $\left(m_{b}=m_{t}\right)^{2}$ and not proportional to $\left(m_{b}=m_{W}\right)^{2}$ as stated in Ref. $[1]$

The $m_{b} 0$ è ects are quite $s m$ all. U sing $m_{t}=$ 175 GeV , $_{-} \underline{\mathrm{m}}_{\mathrm{w}}=80: 419 \mathrm{GeV}$, and a pole m ass of $\mathrm{m}_{\mathrm{b}}=$ $4: 8 \mathrm{GeV}$ [12], one nds that $0, \mathrm{~L}=0$, and $=0$ decrease by $0: 27 \%, 0: 091 \%$, and $0: 095 \%$, resp. when going from $\mathrm{m}_{\mathrm{b}}=0$ to $\mathrm{m}_{\mathrm{b}}=4: 8 \mathrm{GeV}$. The leakage into the transverse-plus rate ratio $+=0$ from bottom $m$ ass effects is a m ere 0:036\% .

## IV. O(s) RADIATIVE CORRECTIONS

The O (s) corrections are determ ined by the one-loop vertex correction show n_in Fig. $\overline{2}$ p and the gluon em ission graphs shown in Figs. 'zic and have already been know $n$ for quite som e tim e [13,1 $\left.14^{1}\right]$ and w ill not be discussed any further.

W edo want to m ake a few technicalrem arksabout how the tree-graph integration w asdone. W e use a ghon $m$ ass to regularize the $\mathbb{R}$ singularity. C onceming the collinear singularity w e have kept the fullbottom m ass dependence in our calculation and have only set the bottom $m$ ass to zero at the very end. W e have thus e ectively used a $m$ ass regulator to regularize the collinear singularity.

The tree-graph integration has to be done over tw odim ensional phase space. As phase space variables we use the gluon energy $\mathrm{k}_{0}$ and the W energy $\mathrm{g}_{0}$. The $\mathbb{R}$ behaviour of the hadronic tree-graph $m$ atrix elem ent W ( $\mathrm{q}_{0} ; \mathrm{k}_{0}$ ) was im proved by subtracting from it the softghon contribution $G\left(q_{0} ; k_{0}\right)$ which was then added again according to the prescription

The rst piece (W $\left.\left(q_{0} ; k_{0}\right) \quad G \quad\left(q_{0} ; k_{0}\right)\right)$ has thereby been rendered $\mathbb{R}$ nite and can be integrated without a gluon $m$ ass regulator which considerably sim pli es the phase space integration. $T$ he $\mathbb{R}$ singularity resides in the soft ghon piece $G \quad\left(q_{0} ; k_{0}\right)$ which is, how ever, sim ple and universal and can be easily integrated. In fact the soft ghoon contribution factorizes into the Bom term contribution B and a universal soft ghon factor $S\left(q_{0} ; k_{0}\right)$ according to

$N$ ote that the tensor structure carrying the spin inform ation of the produced $W$-boson has been factored out and is now entirely contained in the Bom term factor B . Since the Bom term factor does not depend on the phase space variables, the phase space integration needs to be done only w ith respect to the soft gluon factor $S\left(q_{0} ; k_{0}\right)$ and thus needs to be done only once irrespective of the polarisation of the W -boson. N eedless to say that this is a very welcom e sim plifying feature of the above subtraction procedure.
$T$ his is di erent for the phase space integration of the $\mathbb{R}$ - nite piece ( $\left.W \quad\left(q_{0} ; k_{0}\right) \quad G \quad\left(q_{0} ; k_{0}\right)\right)$ where the integration has to be done separately for each polarization state of the W -boson. To do the necessary twodim ensional phase space integrations in analytical form is som ew hat involved. In particular the integrations are $m$ ore di cult than those needed for the total rate calculation which has already been done som e tim e ago [5్|l $T$ he com plicating feature can be best appreciated by discussing how one obtains the various helicity com ponents of the $W$ booson.

W e chose to use covariant projectors to project out the various helicity com ponents of the $W$-boson. For the total rate one has the fam iliar form

where we have added the label ( $\mathrm{U}+\mathrm{L}$ ) for added em phasis. In the follow ing we shall freely sw itch betw een the notation and $U+I$ for the total rate. The pro jector ( $12 \bar{I}_{1}^{\prime}$ ) can be seen to reduce to the appropiate three-dim ensional form ij in the $W$ rest system. T he longitudinal helicity rate is obtained w th the help of the pro jector

The transverse-plus and transverse-m inushelicity pro jectors are obtained in an indirect way by rst considering the sum and the di erence of the transverse-plus and transverse-m inus pro jectors. T he sum is labelled by the index U (unpolarized-transverse), and the corresponding projector is obtained from $P_{U}=P_{U+L} \quad P_{L}$. The di erence of the transverse-plus and transverse-m inus helicity projectors is labelled by the index F (forwardbackw ard) projector which is given by

The transverse-plus and transverse-m inus pro jectors are thus determ ined by the linear combinations $P=$ $\frac{1}{2}\left(\mathrm{P}_{\mathrm{U}} \quad \mathrm{P}_{\mathrm{F}}\right)$.
$T$ he inverse pow ens of the $m$ agnitude $\dot{q} j=P \overline{q_{0}^{2}} \quad m_{W}^{2}$ of the three-m om entum of the $W$-boson appear in the pro jectors for norm alization reasons. It is $m$ ainly because of the additional factors of $\dot{\mathcal{M}} j^{n}$ in the helicity rates that $m$ akes their phase space integration technically $m$ ore involved than the total rate integration since new classes of phase space integrals appear.

O ur nal results are presented for the $m_{b}=0 \mathrm{~lm}$ it where the rate expressions reduce to a rather com pact form. W e add together the B om term, the one-loop and the tree-graph contribution. T he results are taken from Ref. [kill l . W e divide out the total $\mathrm{m}_{\mathrm{b}}=0 \mathrm{Bom}$ term rate and denote the scaled rates ${ }^{{ }_{i}}={ }_{i}=0(i=U+$ L ;L;+; ) by a hat sym bol. The two transverse helicity rates $i=+$; are obtained from the $i=U ; F$ rates given in $\left[\frac{1}{1} 1\right]$ by taking the linear com binations $=\frac{1}{2}\left(\begin{array}{ll}\mathrm{U} & \mathrm{F}\end{array}\right)$ as discussed before. O ne has ( $\mathrm{C}_{\mathrm{F}}=4=3$ )

The expressions for the rates contain the usual logarithm ic and dilogarithm ic factors that appear in oneloop radiative correction calculations. A s expected, the transverse-plus rate becom es non-zero only at the O ( s) level. N ote that the entire $O(\mathrm{~s}$ ) contribution to the transverse-plus rate com es from the tree-graph contribution since the one-loop graph does not contribute to the transverse-plus rate as can easily be seen by looking at the one-loop am plitude corresponding to Fig. pected, the longitudinal rate becom es dom inant in the high energy lim it as $m_{t}$ ! 1 for both the Bom term and the $O$ ( s) corrections.

## V.NUMERICALRESULTS

W e are now in a position to discuss our num erical results. O ur input values are $\mathrm{m}_{\mathrm{t}}=175 \mathrm{GeV}$ and $\mathrm{m}_{\mathrm{w}}=$ $80: 419 \mathrm{G} \mathrm{eV}$, as before. For the strong coupling constant we use $s\left(m_{t}\right)=0: 107$ which was evolved dow nward from $s\left(m_{z}\right)=0: 1175$. O ur num erical results are presented in term $s$ of the hatted helicity rates ${ }_{i}={ }_{i}=0$ ( $i=U+L ; L ;+;$ ) introduced in Sec. 4. In order to be able to quickly assess the percentage changes induced by the O (s) corrections, we have factored out the B om
term helicity rates (when applicable) from the $O$ ( s ) results. O ne has

$T$ he radiative corrections to the longitudinal and transverse-m inus rates are sizeable where the radiative correction to the longitudinal rate is largest. T he radiative corrections low er the norm alized longitudinal rate $\mathrm{L}=$ by 1:06\% and increase the norm alized transversem inus rate $=$ by $2: 17 \%$. T he radiative correction to the transverse-plus rate is quite sm all. For the nom alized transverse-plus rate + = we obtain a m ere 0:10\% which is only m arginally larger than the value of $0: 036 \%$ obtained from the Bom term level $m_{b} \in 0$ e ects discussed in Sec. 3.

The $\mathrm{m}_{\mathrm{b}} \notin 0$ corrections to the s -contributions can be obtained by using the results given in Ref. [ $\overline{[1]}]$ where the fill $\mathrm{m}_{\mathrm{b}}$ dependence $w$ as included in the radiative correction calculation. Taking again a pole mass of $\mathrm{m}_{\mathrm{b}}=4: 8 \mathrm{GeV}$ [12] we nd that the full rate and the helicity rates $\mathrm{L},+$ and change by by $0: 16 \%$,
$0: 21 \%$, $+19: 91 \%$ and $0: 10 \%$, respectively. The corresponding num bers for the Bom term alone for , $L$ and are $0: 27 \%$, $0: 35 \%$ and $0: 17 \%$. The leakage into the Bom term rate + through $\mathrm{m}_{\mathrm{b}} \not 0$ e ects was given in Sec. 3. It is interesting to note that the $\mathrm{m}_{\mathrm{b}} \notin 0$ corrections to the $s$ contributions are larger than those for the Bom term s . This can be understood in part by noting that the latter contain contributions proportional to $\left(m_{b}^{2}=m_{W}^{2}\right) \ln \left(m_{b}^{2}=m_{t}^{2}\right)=0: 026$ which is not a very sm all num ber.

## VI.SUMMARYAND CONCLUSIONS

W e have presented results on the $O$ ( s ) radiative corrections to the three helicity rates in unpolarized top quark decays which can be determ ined from doing an angular analysis on the decay products or from an analysis of the shape of the lepton spectrum . W hile the radiative corrections to the unnorm alized transverse-m inus and longitudinal rate are sizable ( 6 10\%), the radiative corrections to the norm alized helicity rates are sm aller ( $12 \%$ ). The radiative correction to the transverse-plus rate is very sm all. The measurem ents of the helicity rates by the CDF Collaboration can be seen to be fully com patible w ith the predictions of the Standard M odel. The errors on these $m$ easurem ents are, how ever, too large to allow one to $m$ eaningfully com pare the present $m$ easurem ents $w$ ith quantum e ects brought in by Q CD radiative corrections. T here is hope that this will change in the future.
