THE 7=11 RULE AND AN ESTIMATE OF m

The two-point functions for the vector and axial currents $V=\overline{d}$ u and $A=\overline{d}$ 5u contain information on the hadronic resonances , 0 , a_1 , etc. While it has thus far not been possible to calculate these two-point functions from QCD, their behavior is constrained at low energy by ChiralPerturbation Theory (ChPT), at high energy by the OPE, and at all scales by large N_c, in which limit the two-point functions are saturated by an in nite tower of narrow resonances:

$$\frac{1}{2} \text{Im} \quad V \text{ (t)} = \sum_{n=1}^{X^{k}} 2f_{n}^{2} m_{n}^{2} \text{ (t } m_{n}^{2}); \tag{1}$$

with m $_1$ = m , f_1 = f the EM decay constant of the . Similarly, the axial two-point function is a tower of resonances starting with and a_1 in large N $_{\rm C}$. The above-mentioned constraints lead to relations between these resonance parameters, ChPT parameters and condensates.

Since eq. (1) contains in nitely many parameters, we need additional input, which we will take to be the LMD ansatz, 1

$$\frac{1}{2} \text{Im} \quad v \text{ (t)} = 2f^2 m^2 \quad \text{(t} \quad m^2) + \frac{4}{3} \frac{N_c}{(4)^2} + \dots \quad \text{(t} \quad s_0); \tag{2}$$

where the second term is obtained from large-N $_{\rm C}$ QCD perturbation theory (pQCD), starting from a scale s_0 . A similar ansatz is used in the axial channel, with the same s_0 , motivated by the fact that pQCD does not break chiral symmetry. The parameter s_0 is a parameter to be determined. Clearly, one needs $s_0 > m^2$; $m_{a_1}^2$ for consistency. More explicit resonances can be put in.

Considering $_{\rm V;A}$ for large space-like Q 2 term by term in the (large-N $_{\rm C}$) O PE, one obtains (from the rst two terms) the well-known W einberg sum rules, and from the four-ferm ion condensate the new relation (in the chiral lim it, and to leading order in $_{\rm S}$) 2

the \7/11" rule. From the rst W einberg sum rule, $f^2m^2 > f^2$, from which it follows that f > 0.15, just from the fact that the rhs of eq. (3) has to be negative. If we use also the relation $f^2m^2 = 2f^2$, we not, using eq. (3) and the W einberg sum rules, that f = 8.8, f = 1.4, and $f = 2f_{a_1} = 0.16$, in remarkable agreement with experiment. We not that $f = 2f_{a_1} = 0.16$, in remarkable agreement with experiment. We not that $f = 2f_{a_1} = 0.16$, hence it is not unreasonable to use pQCD above f = 1.4. There are perturbative corrections to the 7/11 rule, unlike the W einberg sum rules but, to the order we are working, the rule does not depend on any condensates. Furtherm one the phenomenological results are robust to 0 (f = 1.4) corrections.

For completeness, we also considered two-point functions for the scalar and pseudo-scalar densities, to the same order in the OPE. The idea is to use the gluon and four-ferm ion condensates predicted in this approach in the (axial-)vector sector, and see what we learn in the (pseudo-)scalar sector. In this case, there are two instead of one subtractions for each two-point function, because of the lack of current conservation, and we end up with only four instead of six equations, with ve parameters, the scalar mass m_S, m_o, the amplitudes c_m , d_m replacing $f_{(a_1)}$, and s_0 , equivalent, but not equal, to s_0 . We supplemented the four equations with $L_8 = c_m^2 = 2m_S^2$ $d_m^2 = 2m_0^2 = 0.0009(3)$.

Our ndings are as follows. W ith the condensates from the vector sector, we nd no solutions with $\frac{p}{s_0} > m$, essentially because of a clash in the equations for \$0 involving dim ension-six operators. Instead, we elim inated this quantity (i.e. the terms originating from the pQCD part of our ansatz for the (pseudo-)scalar two-point functions) from the equations involving the four-ferm ion condensate, took m $_{\circ}$ = 1300 M eV as input, and found c_{m} = 41 M eV, $d_m = 27$ M eV, $m_S = 860$ M eV, $\frac{1}{50} = 2.2$ G eV. This solution is very insensitive to the gluon condensate, $_{\rm s}$, and m $_{\rm o}$, and 700 < m $_{\rm S}$ < 1200 (M eV) for $12 > 10^4 L_8 > 6$. Hence, for the central value of L_8 , phenom enological results are rather insensitive to our input, and one always nds a scalar mass of order 800 900 M eV in the chiral and large-N $_{\text{c}}$ lim its. Our result for c_{m} is in good agreement with other estimates. Using our results as additional input in the analysis of Peris et al., 1 good predictions for $L_{1;2;3;5;8;9;10}$ are obtained if a N am bu {Jona-Lasinio-type m odel is assum ed. W e conclude with noting that the fact that we do not nd a \perfect" solution for the combined vector and scalar sectors suggests that other resonances m ay have to be taken into account.
