A bstract

In this paper we determ ine the one loop radiative correction to the higgs potential due to quantum uctuations about the background metric of R andall-Sundrum model. We then exam ine the elects of the one loop elective potential on the stability of the classical vacuum paying particular attention to the tadpole term s which could dom inate over the classical potential for small eld con gurations. We not that although the one loop potential due to scale uctuations could develop a tadpole term in certain regions of the parameter space, it is positive for either sign of H. The quadratic and quartic term s in the radiative correction are too small to cause any instability to the classical vacuum for eld con qurations that do not violate the lim its of ordinary perturbation theory.

Introduction

R evently several proposals based on theories in extra dim ensions have been put forw ard to explain the hierarchy problem . A m ong them the R and all-Sundrum m odel is particularly interesting since it proposes a ve dim ensional world based on a non-factorizable m etric

Here r_c m easures the size of the extra dimensions which is an $\frac{S^{\,1}}{Z_{\,2}}$ orbifold. is the coordinate of the extra dim ension with identi ed. k is a m ass param eter of the and order of the fundam ental P lanck m ass M . Two 3 branes are placed at the orbifold xed points = 0 (hidden brane) and =(visible brane). Randall and Sundrum showed that eld on the visible brane with a fundam ental mass parameter m_0 gets an elective anv $m ass m = m_0 e^{kr_c}$ due to the exponential warp factor. Therefore for kr_c 12 the weak scale is generated from the P lanck scale by geom etry. Note that the com pacti cation scale $_{\rm c}$ $\frac{1}{r_{\rm c}}$ $\frac{k}{12}$ that is required to generate the large hierarchy is only an order of magnitude sm aller than M unlike in theories with large extra dimensions.

In the Randall-Sundrum model r_c is the vacuum expectation value of a massless scalar eld T (x). The modulus is therefore not stabilized by some dynamics. In order to stabilize the modulus Goldberger and W ise introduced a scalar eld (x;) in the bulk with interaction potentials localised on the branes. This they showed could generate a potential for T (x) and stabilize the modulus at the right value (kr_c 12) needed for the hierarchy without any excessive ne tuning of the parameters.

The couplings of the radion (scale uctuations) and the graviton (tensor uctuations) to the SM higgs scalar localized on the visible brane is completely determined by general covariance. In this paper we shall determ ine the couplings of the radion and the graviton to the SM higgs scalar. We then use these couplings to derive the one loop elective potential of the higgs boson arising from uctuations about the background metric. Finally we exam ine the elect of the radiative corrections on the stability of the classical vacuum

by paying particular attention towards the possible occurrence of tadpole terms in the radiative corrections which could dom in the over the classical potential for sm all H.

Radion couplings to the higgs scalar

We shall determ in the e ects of scale uctuations and tensor uctuations on the higgs potential separately. First consider the e ect of scale uctuations. The couplings of the radion to the higgs scalar can be determ ined from the following action

where V (H) = $\frac{1}{2}m_{H}^{2}H^{2} + vH^{3} + \frac{1}{4}H^{4}$. H is a small uctuation of the higgs eld from its classical vacuum v. The constant vacuum energy V (0) has been subtracted out from V (H). In the absœnce of scale uctuations we have $g = e^{2k T(x)} = (\frac{1}{f})^{2}$, $p - \frac{1}{g} = (\frac{1}{f})^{4}$ and $= fe^{k T(x)}$. Here f is a mass parameter of the order of the fundamental Planck mass M. Rescaling H and v as H ! $\frac{f}{h i}h$ and v ! $\frac{f}{h i}v$ we get

Let ^ denote a sm all uctuation of the radion from its vev h i. W e then get

where the dots represent terms of order $(\hat{h_{n,i}})^2$ and higher. It is easy to see that the couplings of cubic and higher order uctuations to the higgs eld do not contribute to the one loop e ective potential. Further in this paper to simplify matters we shall ignore the e ects of the couplings of quadratic radion uctuations to the higgs scalar. Under this approximation we need to consider only vertices with one and only one radion eld. A more complete treatment that takes into account the e ects of the couplings of quadratic radion uctuations to the couplings of quadratic radion eld. A

R adion contribution to the one loop e ective potential

W e would like to note that since in the evaluation of the e ective potential the external lines are assumed to have zero momenta the kinetic energy term of the higgs scalar in eqn. (4) does not contribute to the one loop e ective potential. To simplify our discussion we shall rst consider the radion coupling only to the mass term of the higgs scalar. The generalization to the case where the radion couplings to all the three terms of V (H) are taken into account is straightforward and will be presented at the end of this section. W e shall follow the method of C olem an-W einberg and sum up an in nite series of one loop diagram s with an arbitrary number of higgs lines at zero momenta attached to it. From each ^hh vertex we have to choose one external higgs line leaving one ^ and one higgs line to go into the loop. It therefore follows that only loop daiagram s with even number of external higgs lines need to be considered. Sum ming all such one loop diagram s we get

Evaluating the above integral with a physical cut o M_s (the string scale) we get

term s that are independent of H contributes to the vacuum energy and could be subtracted out. The term ${}^{2} \ln \frac{M_{s}^{2}}{2}$ can be absorbed into the mass counter term of the higgs scalar. The remaining H dependent term s are nite (independent of the cut o M_s) and they represent the renormalized one loop correction to the higgs potential due to linear radion

uctuations. In deriving the above result we have considered the radion coupling only to the mass term of V (H). If we consider the radion couplings to all the three terms of V (H) then each vertex can be either 2 , 2 H 3 or 2 H 4 . It can be shown that under this condition the radiative correction (unrenorm alized) to the higgs potential is given by

where $^{0} = \frac{6H^{2}}{vh i}$ and $^{00} = \frac{2H^{3}}{v^{2}h i}$. We not that for small uctuations of the higgs eld from its classical vacuum (i.e. for H < v) the contributions of $^{1}H^{3}$ and $^{1}H^{4}$ vertices to the higgs potential are suppressed compared to that of $^{1}H^{2}$.

G raviton couplings to the higgs scalar

We shall now consider the e ects of graviton uctuations on the higgs potential. In the following discussion we shall ignore the radion uctuations and take the metric to be

The graviton couplings to the higgs scalar are completely determ ined by general ∞ -variance and can be derived from the action given in eqn (2).

As in the case of the radion we shall be interested only in the radiative corrections that arise from the couplings of linear graviton uctuations to the higgs eld. Under this approximation we have

Rescaling the higgs eld and its vev properly we get

The graviton couplings to the higgs scalar is therefore given by

It can be shown that as long as the mass m_n of the Kaluza-K lein mode is much small compared to the fundamental Planck mass M, _n() $e^{r_{c}} \frac{p}{kr_{c}}$ and ₀() = $\frac{p}{kr_{c}}$. Choosing = $\frac{2}{M \frac{3}{p^{2}}}$ we nally get

where $M_p e^{kr_c} = 0$ (Tev).

So the coupling of the zero m ode to the higgs scalar (or any other SM eld) is inversely proportional to the P lanck scale but the coupling of the higher K aluza-K lein m odes to the higgs scalar is inversely proportional to the Tev scale. It is this feature that m akes the K aluza-K lein m odes accessible at Tev energies. As in the case of the radion the K E . term of the higgs eld does not contribute to the one loop elective potential which is computed with the external lines at zero m om entum. Also the contributions of the higgs scalar. So the relevant interaction Lagrangian for us is given by $L_{I} = \frac{m_{H}^{2}}{2} P_{n=1}^{P} h_{n}$ H².

U sing this interaction it can be shown that

The mass m_n of the Kaluza-K lein modes are given by $m_n = e^{-k} r_c k x_n$ where x_n are the roots of the Bessel function $J_1(x_n)$ [6]. The sum runs over all the massive Kaluza-K lein graviton modes. Adding all such contributions arising from diagram s with an even number of external higgs lines we get

where $_n = \frac{2}{3}a_n^2 \frac{H^2}{2}$ and $V_0 (M_s) = \frac{(m_{H^2}^2)^2}{32^2} P_n^R x \ln(1+x) dx$. The mass m_n of the rst few Kaluza-K lein modes usually lie in the several Tev range. Thus if the higgs boson

is light i.e. $m_{\rm H} < 1$ Tev the coe cients $a_{\rm n}$ are much small compared to unity. Hence for small eld con gurations the radiative correction due to radion dominates over that of gravitons. The terms inside the st pair of brackets are independent of H and can be absorbed in the vacuum energy. The terms within the second pair of brackets depend both on the cut o and H. These terms can be absorbed in the counter terms that has to be added to the classical higgs potential to make the one loop e ective potential insensitive to the cut o . The terms inside the third pair of brackets depend on H but not on the cut o . They represent the renorm alized radiative correction to the higgs potential due to graviton uctuations. We would like to note that if $_n$ and $\frac{n}{a_n}$ are small then $\ln(1 - n)$, $\frac{(1+2\frac{n}{a_n})}{(1-n)^2}$ can be expanded into an in nite power series in H. Since the interaction of the KK graviton m odes to the higgs scalar is non-renorm alizable we need an in nite num ber of local counter terms to absorb the cut o dependent terms of the one loop e ective potential.

E ect of the radiative correction on the vacuum stability

Examining the one loop radiative correction due to graviton uctuations we nd that there is no potentially dangerous tadpole term that could destabilize the classical vacuum. The lowest order term is quadractic in the higgs eld. Further it is suppressed by a loop factor of $\frac{1}{64-2}$ and another factor of $\frac{m_{H}^{4}}{m_{h}^{2}}$ arising from KK graviton couplings to higgs scalar. The quadratic term arising from radiative corrections due to gravitons is therefore sm aller than the quadratic term present in the classical potential. Further although there are higher order terms in the graviton induced radiative correction these terms are sm all within the limits of validity of perturbation theory. The higgs eld con gurations that are needed for these terms to dom in the and cause any instability occur outside the limits of ordinary perturbation theory.

The form of the lowest order term in the radiative correction due to the radion is di cult to determ ine in general since and and have a complicated dependence on h. W e shall therefore study it under two special cases.

Case I: In this case we shall assume that 1 2. It then follows that $\frac{1+}{2}$ and $\frac{1+}{2}$ + . Substituting the values of and we get

Therefore in this case the radion induced radative correction give a tadpole term which can dom inate over the quadaratic and quartic terms in the classical potenitial for sm all H. How ever the tadpole term is positive for both signs of h and therefore it does not destabilize the classical vacuum.

Case II: We shall now consider the case when 1 2. It then follows that $\frac{2}{(1-2)}$ and $1 + \frac{2}{(1-2)}$. Substituting the values of and in Y we get

The lowest order term in this case is quadartic in the higgs eld. However it is suppressed by a loop factor of $\frac{1}{32^{-2}}$ and an additional factor of $\frac{m}{h}\frac{2}{1^2}$ coming from radion couplings. Hence in this case we do not expect any insatability to the classical vacuum to develop within the limits of perturbation theory.

Conclusion

In this paper we have determ ined the one loop radiative correction to the higgs potentail due to linear radion and graviton uctuations in the R andall-Sundrum m odel. W e nd that the radiative correction due to graviton uctuations do not give rise to tadpole term. On the other hand although the radiative correction due to radion uctautions does

give rise to a tadpole term under som e cases it is positive for both sign of H. The quadratic

and higher order terms in the radiative correction for both kinds of uctuations are too sm all compared to the classical potential for any instability to develop within the limits of ordinary perturbation theory.
