# Sgoldstino events in top decays at the LHC

#### Abstract

We study top-quark decays in models with light spoldstinos. The o-diagonal entries in the squark mass matrices can lead to FCNC top two-body decays into a spoldstino and a c (or u) quark. We compute the rates for these decays and discuss the corresponding signatures that could manifest the presence of spoldstinos in top decays at the LHC. We expect that a supersymmetry breaking parameter  $\overline{F}$  up to a scale of order 10 TeV could be probed through this process, for a maximal squark mixing with the third generation. Justi ed by our preliminary analysis, a thorough study of the corresponding signal versus background and system atics in the LHC environment would be most welcome, in order to accurately assess the potential of this promising process in determining  $\overline{F}$ .

### 1 Introduction

Am ong the various supersymmetric extensions of the Standard M odel (SM) of elementary particles, there is a set of m odels where the goldstino superpartners are fairly light, even lighter than the electroweak bosons. Such m odels emerge in the framework of no-scale supergravity [1] as well as in gauge mediation (see R ef. [2] and references therein). These goldstino superpartners | the scalar S and the pseudoscalar P | will be referred to as sgoldstinos in what follows. Their couplings to the SM elds are governed by ratios of some soft terms from the superpartner sector and the supersymmetry breaking parameter  $\overline{F}$ . In general, sgoldstino coupling constants receive contributions from various terms in the Lagrangian of the underlying theory, but there are always contributions proportional to soft M SSM terms. In what follows we will consider only the latter contributions.

If spoldstinos are light enough, they may appear in the products of decays of mesons (e.g., in  $J= ! S \text{ and } K^+ ! S^+$ ). This issue was analyzed in Ref. [3]. Current experimental results on the measurements of meson rare-decay rates place strong bounds on light spoldstino couplings. If the supersymmetry breaking soft terms are assumed to be of the order of the electroweak scale (as motivated by the supersymmetric solution to the gauge hierarchy problem of the SM ), then the bounds on spoldstino avor-conserving coupling constants provide limits on F of the order of several hundred G eV. F lavor-violating spoldstino

interactions might play a more important role in meson physics. The corresponding coupling constants are proportional to the o -diagonal entries in the squark soft squared mass matrices. Then, if the o -diagonal entries are of the order of the current limits coming from the absence of FCNC, the measurements of mesons decay rates can give bounds on sgoldstino avor-yiolating couplings that are strong enough to probe a scale of supersymmetry breaking

up to  $F = 10^7 \text{ GeV } [3].$ 

W hereas the spoldstino interactions with quarks of the rst and second generations and with a b quark could be measured in the mesons decays, the most direct way of determining spoldstino avor-violating couplings to the top-quark would be through anom alous top decays (see also [4]). This approach can be relevant even for spoldstino masses  $m_{S(P)}$  & 10 GeV, for which the constraints on  $\overline{F}$  arising from the analysis of the meson rare decays become invalid.

This is indeed the subject of the present letter. We study the anom abus top decays into a spokstino and an up-type quark t! cS (P) and t! uS (P). Subsequently, depending on the superpartner spectrum and the value of the S (P) mass, spokstinos can decay into SM particles or gravitinos. Thus, diement nal states could be exploited as a signature of a spokstino coupled to the top quark. The spokstino masses  $m_s$  and  $m_p$  that will be relevant for our study are larger than a few G eV's and smaller than  $m_{top}$ .

In order to set the LHC potential, we recall that  $10^7$   $10^8$  top quarks are expected to be produced with (10 100) fb<sup>-1</sup> of integrated lum inosity at the LHC [5]. Then, on a purely statistical basis, one will be able to probe top branching ratios (BR) down to about  $10^{-6}$   $10^{-7}$ . In the following, we will assume this BR range to be the LHC statistical threshold for the observation of a particular top decay channel. Of course, background problem s and system atics will considerably weaken this potential. Indeed, for some rare top decays that were analyzed through dedicated M onte C arbo's the corresponding reduction in the potential has been estim ated to be of at least one order of m agnitude [5].

In this paper, we rst compute the top decay BR's for the channels t! cS;t! uS;t! cP;t! uP. Then, after reviewing the sgoldstino decay channels and the corresponding rates, we discuss the possible strategies for an experimental search for events with a top decaying into sgoldstinos at the LHC.

### 2 Top decay rates into sgoldstinos

In this section, we work out the width for top decays into sgoldstinos through FCNC processes. The relevant e ective Lagrangian reads [6, 7]

where  $(m_{U_{ij}}^{LR})^2$  are the o -diagonal entries into the up-squark soft squared m ass m atrix (for convenience we consider these parameters to be real<sup>1</sup>). Then, the relevant top decay widths are given by

where we ignore the nalquark masses and introduce the parameters  $U_{ij} = (m U_{ij}^{LR})^2 = m U_{ij}^2$ , with  $m_U$  being the average mass of up-squarks. These parameters can be constrained from the absence of FCNC [9] only for the soldstino couplings to the quarks of the rst two generations. For example, the current upper bound on  $U_{12}$  at  $m_U = M_3 = 500 \text{ GeV}$  is about  $10^2 \text{ [9]}^2$ . However, for the couplings to top-squarks there is no such a constraint yet, and the corresponding value of  $U_{3i}$  (with j = 1;2) may be as large as 1.

In Figure 1 we present the top BR into a soldstino (either scalar or pseudoscalar) and a charm -quark (or up-quark) as a function of  $\overline{F}$ , for an average up-squark mass  $m_{U} = 1 \text{ TeV}$ . The three curves refer to three di erent values of  $U_{3j}$  (i.e.,  $10^{-2}$ ;  $10^{-1}$ ; 1). For the soldstino mass, we assume m  $_{S(P)} = 50 \text{ GeV}$ , that is a value quite far from where phase-space e ects become important. Only one out of the four possible channels t! cS;t! uS;t! cP;t! uP is assumed to be open in the computation of the top total width.

The quartic dependence on 1=<sup>+</sup> F of the width makes the BR for the top decay into a spoldstino quite sensitive to the supersymmetry breaking scale. In the most promising case of maximal mixing (i.e.,  $U_{3j} = 1$ ), one gets BR (t ! cS) > 10<sup>-4</sup> for  $\overline{F}$  up to 10 TeV, that corresponds to more than  $10^2$  interesting decays occurring at the LHC for a wide range of  $\overline{F}$  (from now on we refer to each of all the possible channels t ! cS;t ! uS;t ! cP;t ! uP by simply indicating t ! cS, unless di erently specied). On the other hand, decreasing the mixing  $U_{3j}$  by a factor 10 reduces BR (t ! cS) by a factor  $10^2$ . For  $U_{3j} = 10^{-2}$ , BR (t ! cS) is more than  $10^{-6}$  only up to  $\overline{F}$  3 TeV, when  $m_U = 1$  TeV.

In Figures 2 and 3, we show the phase-space reduction of BR (t ! cS) for heavier m<sub>s</sub> values. We assume, respectively,  $\overline{F} = 4$  TeV and  $U_{3j} = 1$  in Figure 2, and  $\overline{F} = 2$  TeV and  $U_{3j} = 0.1$  in Figure 3. The three curves in each gure correspond to di erent values (i.e., 0.5, 1, 1.5 TeV) for the average up-squark mass. One can see that going to values m<sub>s</sub> > 150 GeV, a reduction of the BR by m ore than a factor 10, with respect to the m assless case, makes the problem quite harder in general. On the other hand, at xed relative mixing  $U_{3j}$ , a heavier up-squark mass m<sub>U</sub> enhances BR remarkably. In general, larger values of  $\overline{F}$  will be explorable for higher values of  $U_{3j}$  and  $m_U$ , and smaller m<sub>s</sub>.

### 3 Possible signatures at the LHC

In order to analyze the possible experimental signatures by which a top decaying into a soldstino would manifest at the LHC, one has to consider the subsequent decay of the soldstino inside the experimental apparatus. Indeed, for the range of parameters that are relevant for this study, soldstinos are expected to decay inside the experimental apparatus, not far from the collision point [10]. Then, assuming that the supersymmetric partners (others than the gravitinos G) are too heavy to be relevant for the soldstino decays, the main decay channels are (for  $m_t \& m_{S(P)}$ ):

The corresponding widths have been computed in [10].

For a sgoldstinos decaying into a pair of photons, one has

where  $M = M_1 \cos^2 w + M_2 \sin^2 w$ , and w is the electroweak mixing angle.

 $<sup>^2</sup>B\,y$  M  $_1$  , M  $_2$  and M  $_3$  we denote the gaugino m asses, the  $\,$  rst two for the electroweak groups, and the third for SU (3)  $_{\rm c}$  .

For the two-gluons decay, one similarly nds

that, for M  $_3$ , dom instes over the photonic channel due to the color factor enhancement.

For the F values we are interested in, gravitinos are very light, with m asses in the range  $m_{G} = \frac{1}{8} = 3 F = M_{Pl}' 10^{-3} 10^{-1} \text{ eV}$ . Then, the spoldstino decay rates into two gravitinos are given by

and become comparable with the rate into two photons for quite heavy syndstinos, such that m  $_{S\,(\!P\,)}$   $\,$  M  $\,$  .

Sgoldstinos can also decay into ferm ion pairs, with rates

where  $A_f$  is the soft trilinear coupling constant, and  $N_c = 3$  for quarks or  $N_c = 1$  for leptons. One can see that, far from the threshold, the ferm ionic BR's are suppressed by a factor  $m_f^2 = m_s^2$  in general. Hence, the decay S(P)! ff can be relevant for large trilinear couplings and/or if the sgoldstino m ass happens to be not too far from  $m_f$ .

Finally, spoldstinos lighter than the top quark can decay into massive vector bosons states. For  $m_{S(P)} > M_Z$  and  $m_{S(P)} > 2M_W$ , the Z and  $W^+W$  channels open up, respectively. The corresponding rates read

where M  $_{z} = (M_{2} M_{1}) \cos_{W} \sin_{W}$ , and the variable  $_{a}$  that enters (S ! W  $^{+}W$  ) is the higgsino mixing mass parameter.

In Figure 4, we present the BR's for all the scalar spoklstino decay modes for six di erent sets of the MSSM parameters  $M_1, M_2, M_3, A_b$ , and  $_a = 200 \text{ GeV}$ . The only channel that is a ected by the parameter  $_a$  is S ! WW, that, since  $m_s > 2M_W$ , is anyhow suppressed in the chain t ! Sc ! WW c by the small phase-space factor in the top decay BR. For this reason, in the Figure 4 we do not analyze the BR's dependence on  $_a$ , that was however chosen negative in order to enhance the corresponding BR (S ! WW).

For a typical M  $_1$ ; M  $_2$ ; M  $_3$  hierarchy, that corresponds to the gauge uni cation conditions in the M SSM, one nds that the S decay into gluons S ! gg always dom inates over the

other channels. Then, the S decay into photons S ! has a BR typically in the range  $10^{2}$   $10^{1}$ . Decays into GG, Z and W W can be important for relatively large m<sub>S</sub> that, how ever, are disfavored by the phase-space factor in the top decay BR (cf. Figures 2 and 3) <sup>3</sup>. On the other hand, the spoldstino decay into b quarks S ! bb can have BR values in an interesting range when the soft trilinear coupling A<sub>f</sub> is large enough, and for m oderate m<sub>S</sub>. For the parameter sets of Figures 4, c) and d), BR (S ! bb) reaches values even larger than  $10^{1}$ , for m<sub>S</sub> < 50G eV . Particularly interesting in view of the possibility of detecting a signal in a hadron collider (see also below) is the case where one drops the typical M<sub>1</sub>; M<sub>2</sub>; M<sub>3</sub> hierarchy of the M SSM , and allows M<sub>1</sub> and/or M<sub>2</sub> to be larger than M<sub>3</sub>. Representative exam ples of this case are considered in Figures 4, e) and f), where one reaches com parable values of BR (S ! ) and BR (S ! gg), and even BR (S ! ) > BR (S ! gg). In the same e fram ework, also the decay S ! Z is enhanced up to values of order  $10^{1}$ , although part of the relevant m<sub>S</sub> range is penalized by the top decay phase-space.

The main features of this discussion hold also for the pseudoscalar syndstino P. The major di erence with respect to the S case lies in the P! WW width (that is independent of  $_a$ ). Again, this channel is relevant only for  $m_P$  values penalized by the top decay phase space.

We now discuss the relevance of the di erent S decay channels in view of the possible detection of a t ! Sc signal at the LHC. A complete analysis will require a thorough study via M onte C arlo's that can treat each particular signal versus the complicated backgrounds and system atics of a hadronic machine.

Here, we will work out a few qualitative conclusions, based on the results of previous dedicated studies that set the threshold for the observation of top rare decays and Higgs decays at the LHC [5, 11, 12]. These results sum up in the following assumptions for our analysis:

i) we require the production of 10 events for a given signature (or particular decay of S following t ! S c) to be observable. On a purely statistical basis, this corresponds to a total top BR in that channel, given by the product BR (t ! S c) BR (S ! :::), in the range  $10^{6}$   $10^{7}$ , for  $10^{7}$   $10^{8}$  top quarks produced at the LHC.

ii) we assume that a generic electroweak-like signature (like the ones involving photons, Z's, W 's and/orm issing momentum) can be detected at the LHC, and measured with an e ciency of the order of 10% due to the background subtraction and system atics. The same e ciency is assumed for the detection of a resonant bb system.

iii) we assume that a completely hadronic (non b-like) signature of a top rare decay will not be manageable at the LHC because of the QCD backgrounds. This excludes from our study the S(P)! gg channel.

In this fram ework, in order to be able to detect a sgoldstino decaying into the channel S  $!\,$  X at the LHC, one needs

and X "giving rise to either an electroweak-like signature or a bb system .

Let's go through som e details on the detection of the possibly relevant S decay m odes:

#### S(P)!

This spokes time decay mode gives rise to the total nalstatett ! (W + b-jet) + (+jet)in top pair production at the LHC. One should tag one of the top in the usual (W + b-jet) way. Then one has a hard hadronic jet plus a resonant two-photon system, with a total invariant mass of the (2 + jet) system of about  $m_t$ . A proper cut on the

invariant m ass can help in suppressing the background through similar strategies to the ones worked out for the H ! detection at the LHC [11]. Assuming the threshold rate of Eq.(10) and a typical BR (S (P) ! ) 10<sup>2</sup> 10<sup>1</sup>, one can explore through this very distinctive signature a value for BR (t ! Sc) down to 10<sup>3</sup> 10<sup>4</sup>. In particular, for a maxim al squark mixing and  $m_{U} = 1$  TeV, one can probe F up to about 10 TeV (cf. Figure 1). For a squark mixing 10<sup>1</sup> one can cover up to F 3 TeV. The dedicated assumptions of a broken M<sub>1</sub>;M<sub>2</sub>;M<sub>3</sub> hierarchy in Figures 4, e) and f), would translate into even m ore promising ranges, with BR (t ! Sc) explorable down to 10<sup>5</sup>, and, correspondingly, into larger values of F.

S(P)! bo

In this case, the total nalsignature is tt !  $(W + b-jet) + (2b-jets + jet) with a resonant 2b-jets system. For large soft trilinear couplings <math>A_f$  and moderate  $m_s$  (i.e., less then about 50 GeV), one could explore BR (t ! Sc) ranges down to 10<sup>-3</sup> 10<sup>-4</sup>, assuming the threshold in Eq.(10). Hence, this channel could have a comparable potential to the S (P) ! one, but for a restricted  $m_s$  range.

S(P)! GG

G ravitinos give rise to m issing transverse energy in the event. The total nalsignature is then (W + b-jet + jet +  $E_t^{m is}$ ). A ssum ing that the threshold in Eq.(10) is also e ective in this case, this channel can be useful for interm ediate values of  $m_s$  in the range 100 150 G eV. Indeed, the relevant S width rises as the fth power of  $m_s$  and is typically of the order 10 <sup>2</sup> orm ore in this range. Larger values of  $m_s$  are penalized by the phase-space factor in the top decay BR. Hence, through this channel, one can hope to investigate top BR's into a spoldstino down to 10 <sup>3</sup> in the  $m_s$  range 100 150 G eV.

#### S(P)! Z

This channel has a nice signature (W + b-jet+ Z + jet), with a resonant Z system. On the other hand, BR (S ! Z) is hardly larger than 10<sup>-3</sup>, unless one breaks the gauge-uni cation hierarchy, assum ing M<sub>1</sub> and/or M<sub>2</sub> larger than M<sub>3</sub>, [cf. F igures 4, e) and f)]. In the latter case, one can have BR (S ! Z) 10<sup>-1</sup> at m<sub>s</sub> > 120 G eV, with a corresponding reach of 10<sup>-4</sup> for the top BR in the m<sub>s</sub> range 120 150 G eV.

S(P)! W W

This channel can be interesting from the point of view of the BR (S (P) ! W W) value that can easily reach the 10<sup>-1</sup> level. On the other end, the complete signature (W + b-jet+W + W + jet) is hardly viable, since it is relevant for a m<sub>s</sub> range (m<sub>s</sub> > 160G eV) where the phase-space suppression of the top width is fully elective.

Note that one could also exploit the single-top production sample of top quarks, with a di erent nal signature. This would enlarge the present statistics by about 15% -20% [5].

## 4 Conclusions

W e considered the possibility to detect at the LHC anom alous top decays into light sgoldstinos, proceeding through o -diagonal avor-violating entries in the squark-mass matrices. We studied both the decay rates and the relevant experimental signatures. The most promising signatures are the ones associated with the decay chains t! qS ! q and t! qS ! qdb, where q is either a c or a u quark. The rst can be elective for the complete m<sub>s</sub> range (from a few G eV up to about 150 G eV), while the latter can be useful for rather light sgoldstinos. A ssum ing a total 10% election of these signatures versus backgrounds and system atics, BR (t ! qS) values can be studied down to 10<sup>4</sup>, on the basis of the 10<sup>7</sup> 10<sup>8</sup> top quarks produced with a (10 100) fb<sup>-1</sup> integrated lum inosity at the LHC [5].

For a maximal avor-violating LR-mixing of the stop with the other up-type squark, one could than explore the scale of supersymmetry breaking  $\overline{F}$  up to about 10 TeV, that is, e.g., much further than what is reachable in searches for light gravitinos at the LHC [13]. A dedicated and thorough analysis via M onte C arb techniques will be required in order to accurately assess the potential of this promising process.
