R adiative decays of m esons in the NJL m odel

Abstract

W e revisit the theoretical predictions for anom alous radiative decays of pseudoscalar and vector m esons. Our analysis is performed in the fram ework of the N am bu {Jona-Lasinio m odel, introducing adequate parameters to account for the breakdown of chiral symmetry. The results are comparable with those obtained in previous approaches.

I. IN TRODUCTION

The analysis of vector and axial-vector m eson physics represents a nontrivial task from the theoretical point of view. This is basically due to the characteristic energy scales at which these particles manifest, namely an intermediate range between low energy hadron physics and the high energy region where QCD can be treated perturvatively. In order to deal with the subject, one possible approach is to start from an elective m eson Lagrangian; another possible way is to derive the corresponding elective interactions from QCD -inspired fermionic schemes.

In the last two decades, the development of chiral e ective models [1] has provided a protable framework to analyze various phenomena related to the physics of vector and axial-vector mesons [2[4]. These models have been built taking into account the symmetries of QCD, together with the so{called axial anomaly introduced through the Wess-Zumino-Witten (WZW) [5] elective action. As an alternative approach, the analysis of spin one meson physics can be performed by starting with the Lagrangian proposed by N am bu and Jona{Lasinio (NJL) [6]. This Lagrangian is based in 4-fermion interactions, showing the chiral symmetry of QCD, and leads to an elective theory for scalar, pseudoscalar, vector and axial{vector mesons after proper bosonization. The elective meson Lagrangian can be obtained by constructing a generating functional, and evaluating the real and imaginary parts of the fermion determinant [7].

In this work we follow this second approach, studying the phenom enology of spin 1 m esons in the fram ework of the NJL m odel. We propose a ferm ionic Lagrangian that shows an approximate U (3)_L U (3)_R chiral symmetry, explicitly violated by current quark m asses, as is the case of QCD in the limit of large number of colours N_c. In particular, we revisit the predictions given by thism odel for anom abus radiative decays of vector m esons, taking into account the explicit breakdown of the SU (3) avour symmetry to SU (2) isospin symmetry with the assumption $m_u = m_d \notin m_s$. We perform the bosonization of the NJL theory by carrying out an expansion of the fermion determinant in term softhem eson leds. This gives rise to a set of one{loop Feynm an diagram s [8{12] from which one can derive the relevant e ective m eson interactions. Taking into account present experimental data, we analyze possible input param eters for the m odel, in order to obtain an acceptable phenom enological pattern for the observed anom abus decays of pseudoscalar and vector m esons.

The paper is organized as follows: In Sect. II we introduce the NJL Lagrangian and the bosonization technique. In Sect. III we derive the elective Lagrangian to account for vector and axial-vector meson interactions, considering the explicit breakdown of avour SU (3) symmetry. This leads to some relations between vector meson masses and decay constants that can be written in terms of symmetry breaking parameters. Then, in Sect. IV, we concentrate on the anom alous radiative decays of pseudoscalar and vector mesons, which proceed through the U (1) axial anom aly. In Sect. V we discuss the numerical results for the corresponding branching ratios, in comparison with the present experimental information. Finally in Sect. V I we present our conclusions. The Appendix includes a brief description of the regularization scheme used throughout our analysis.

II. NAM BU {JONA {LASIN IO LAGRANGIAN AND BOSON IZAT ION

Chiral e ective models have proved to reproduce the low energy hadron phenomena with signi cant success. For that reason, a signi cant e ort has been done in order to derive these e ective schemes from a microscopic theory as QCD. The elective four ferm ion Lagrangian proposed by Nambu and Jona {Lasinio [6], which shows the chiral symmetry of QCD, represents one of the most popular ways to achieve this goal. The NJL model provides, after proper bosonization, not only the expected elective couplings for scalar, pseudoscalar, vector and axial{vectorm esons but also the W ess{Zum ino{W itten sector [5] which accounts for the anom alous meson decays. The explicit form of the NJL Lagrangian reads

where q denotes the N - avour quark spinor, $\stackrel{a}{\not{q}} a = 0; :::; N^2$ 1 are the generators of the U (N) avour group (we norm alize $^0 = 2=N$ 1) and \mathfrak{m}_0 stands for the current quark mass matrix, which explicitly breaks the chiral symmetry. The coupling constants G_1 and G_2 , as well as the quark masses, are introduced as free parameters of the model. In the absence of the mass term, the NJL Lagrangian shows at the quantum level the SU (N)_A SU (N)_V U (1)_V symmetry characteristic of massless QCD.

It is possible to reduce the ferm ionic degrees of freedom to bosonic ones by standard bosonization techniques. W ith the introduction of colorless boson elds and an appropriate use of the Stratonovich identity, one obtains an elds action where the ferm ions couple to the bosons in a bilinear form. The couplings driven by G_1 in (1) lead to the introduction of scalar and pseudoscalar boson elds, whereas those carrying G_2 lead to the inclusion of vector and axial{vector m esons.

To be denite, let us consider the vector m eson sector w ith N = 3 avours, u, d and s. By m eans of the Stratonovich identity, the vector{vector coupling in (1) can be transform ed as

where V i V^a a=2. The spin 1 elds V a can be identified with the usual nonet of vector m esons,

which transform in such a way to preserve the chiral symmetry of the original NJL Lagrangian (and therefore that of QCD). Notice that the rst term in the right hand side of Eq. (2) is nothing but a mass term for the vector elds V^a, thus the vector {m eson m asses are governed by the coupling G₂ in the NJL Lagrangian. It can be seen that these m asses are degenerate in the lim it where the quark m asses are degenerate.

Now, the quark elds can be integrated out, leading to an elective Lagrangian which only contains bosonic degrees of freedom. This procedure can be carried out by taking into account the generating functional

and perform ing the calculation of the ferm ion determ inant (a detailed analysis can be found in [7]). A similar procedure can be followed for the full NJL Lagrangian (1), leading to the interactions involving scalar, pseudoscalar and axial{vector bosons. In this way, the nal e ective Lagrangian is written only in term s of spin 0 and spin 1 colorless hadron elds.

Here we have performed the bosonization by carrying out an expansion of the ferm ion determ inant, which gives rise to a set of one { bop Feynm an diagram s [8]. In order to build up the nallelective meson Lagrangian, we have obtained the local part of the relevant interactions by taking the leading order of a gradient expansion in powers of the external momenta, and considering the dom inant contributions in $1=N_c$. The divergent integrals have been treated using a proper{time regularization scheme with a momentum cut{o, keeping the leading contributions. The procedure is developed in detail in the next section.

III.EFFECTIVE MESON COUPLINGS AND SYMMETRY-BREAKING PARAMETERS

In this section we describe the e ective meson interactions derived from the NJL Lagrangian. We begin by calculating the relevant one { bop self{energy diagram s contributing to the meson kinetic and mass term s, and those leading to the elective weak and strong meson decay couplings. Notice that the meson leds introduced through the bosonization technique acquire their dynamics via the self{energy one{bop diagram s.

In our fram ework, the poles of the quark propagators occur at the so{called constituent m asses, i.e. dynam ically generated m asses which arise as a consequence of the spontaneous breakdown of the chiral sym m etry. The constituent m asses appear as solutions of Schw inger-D yson self-consistency equations (gap equations), which are governed by the scalar coupling G_1 in the NJL Lagrangian (1). Here we will not concentrate in the scalar sector of the m odel, thus the constituent quark m asses, as well as the pseudoscalar boson m asses, will be considered as free param eters.

O urmain interest is focused in the anom abus radiative decays of vector m esons. Nevertheless, we need to consider also the axial (vector sector of the model, since the axial (vectors m ix with the pseudoscalars at the one (loop level (P A m ixing).

A .K inetic term s and m asses of the spin-1 m esons

The generating functional (4) gives rise to e ective kinetic terms for the spin-1 vector mesons via one { loop diagrams, as shown in Fig.1(a). The analysis in the case of the axial { vector mesons can be performed in an analogous way, with the additional ingredient of P A mixing given by Fig.1(b).

The loop in Fig. 1 (a) gives a contribution to the vector meson self-energy given by

where m $_1$ and m $_2$ are the constituent m asses of the quarks entering the loop, N $_C$ is the number of colors, and the trace acts over the avour and D irac indices.

As stated above, we will take only the leading order in the external momentum p, which means to evaluate the integral at p = 0 after extracting the relevant kinem atical factors. In this case, this is equivalent to consider only the divergent piece of (5):

As it was previously mentioned, in order to regularize the divergence we use the proper{time regularization scheme [13] with a cut{o, which will be treated as a free parameter of the model. Details of the procedure can be found in the Appendix. We obtain

From (6), the kinetic terms for the vector m esons in the elective Lagrangian are given by

param eterize the m agnitude of the SU (3) avour sym m etry breaking.

The kinetic Lagrangian in (9) has been expressed in terms of the vector elds in (3), with the additional rotation

which diagonalizes the neutral sector. It is easy to see that here the rotation is \ideal", i.e., the spin 1 m ass eigenstates and ! are composed by pure light u and d quarks, while the m eson is a bound state ss. The ! rotation angle is given by $\sin_0 = 1 = 3$. Slight deviations from the ideal mixing condition will be considered below to allow for the decay ! ⁰ observed recently.

The mass terms for the vector mesons are given by the $(V)^2$ term in (2), plus a divergent one { bop contribution given by the second term in the square brackets in (6), which vanishes in the SU (3) avour limit. This leads to

Notice that (as expected) the mass terms turn out to be diagonal in the (!;) basis.

We proceed now to the wave function renormalization required by the kinetic terms in (9). The vector meson elds can be properly redened by V $\begin{array}{c} I \\ Z_V \end{array}$, with

thus the meson mass can be written in terms of the mass and the avour symmetry breaking parameter . In the case of the K , the corresponding mass relation includes both the parameter and a quark {mass dependent contribution that arises from the loop in Fig. 1 (a).

A similar analysis can be performed for the axial (vector meson sector. By replacing $\frac{1}{5}$ in the quark (meson vertices in Fig. 1 (a), one nds

As in the vector m eson case, the Lagrangian is diagonal in the chosen basis, where f_1 and f_1^0 are obtained from the U (3) states A_8 and A_1 through an ideal rotation. Notice that both neutral and charged axial{vector boson masses receive a contribution proportional to G_2^{1} , which arises from eld transformations as in Eq. (2), plus additional (positive) contributions proportional to the quark masses. In this way, the axial{vector m esons are in general expected to be heavier than their vector m eson counterparts.

Finally, we have to take into account the mixing between the axial{vector mesons and the pseudoscalars. This requires the analysis of the pseudoscalar{axial vector couplings and the pseudoscalar kinetic terms, given by the one{loop diagrams in Fig. 1 (b) and (c) respectively. The elective couplings read

Once again, we have chosen a basis for the neutral elds in which the states $_{\rm u}$, $_{\rm s}$ are obtained from the U (3) states $_{8, 1}$ through an ideal rotation. However, these states cannot be treated as approxim atem ass eigenstates due to the presence of the U (1)_A anom aly, which breaks the U (3) symmetry down to SU (3). A lthough form ally of order 1=N_C, this anom aly leads to a relatively large mass splitting between the observed and ⁰ physical states. Still, large N_C considerations are shown to be powerful enough to dealwith the interactions of the $_1$ and $_8$ elds as members of an U (3) nonet. As stated, we will not concentrate here in the pseudoscalar mass sector, and consequently, in the U (1)_A symmetry breaking mechanism responsible for the ⁰ m ass. In the NJL framework, one way to proceed is to include the so-called 't Hooff interaction [14,15], which emulates the e ect of the anomaly. Instead of following this way (which means to include six-ferm ion interaction vertices) we will introduce the ⁰ m ixing angle as a parameter of the model. Thus we write $_{\rm u}$ and $_{\rm s}$ in terms of the physical states as

In order to write the elective Lagrangian in terms of the physical elds, one needs not only the relevant wave function renorm alizations but also the diagonalization of the P A couplings. This can be achieved by means of the transform ations

As can be immediately seen from (16), the wave function renormalization for the axial{vector m esons is equivalent to that performed in the vector m eson sector, c.f. Eq. (13). U sing these relations and those in (14), the axial{vector m eson m asses turn out to be constrained by

B.W eak and strong decay constants

W e want to analyze the ability of the e ective m odel under consideration to describe the low energy behaviour of pseudoscalar and vector m esons. Let us begin by studying som e fundam ental decay processes, in order to evaluate the relevant decay constants in term s of the m odel param eters.

The pseudoscalar weak decay constants F and F_K can be obtained from the one{loop transitions represented in Fig.2, where P = ,K. As in the self{energy case, these diagrams are found to be logarithm ically divergent and can be regularized using the proper{time scheme. We will keep as before only the leading contributions in the limit of vanishing external momenta, which amounts to take only the divergent piece of the loop integrals.

The decay constants $F_{\,P}\,$ are de ned as usual by

where have made use of Eqs. (22). In these equations, the statem sarise from the graph in Fig. 2 (a), whereas the contributions proportional to C $_{,K}$ are due to the P A mixing diagram s. Using now Eqs. (23), we end up with the simple relations

Next, let us study the basic decay constants g, g_k and g, which account for the strong decays of the vector m esons into two pseudoscalars. The decay constants can be de ned from the total decay rates according to

Notice that for the ! K K width we have taken into account the mass di erence between the neutral and charged kaons. Though tiny, this mass di erence becomes in portant in view of the very narrow phase space allowed.

W ithin the elective model analyzed here, the decay rates (28) are dominated by the one { bop graphs shown in Fig. 3. As before, we keep here the dominant, bgarithm ically divergent contribution, and the leading order in the external momenta (the corresponding diagram swith two axial { vector legs vanish in this limit). From the evaluation of the ! and ! a_1 diagram s, and using (13), (22) and (23), we nd

In the case of g the evaluation of the dom inant contribution is more involved, since the loop includes two di erent quark propagators. The loop integral has the form

O noe again the divergence is logarithm ic, thus it is natural to express the integral in term s of I_2 (m_i;m_j). However, owing to the avour symmetry breakdown, there is an ambiguity at the moment of choosing the in nite part of (30). Here we follow the criterion of respecting the natural hierarchy given by the quark content of the decaying vector meson, that means, we use the k² factor in the integrand to remove the m²_u pole. We have then

In the same way we proceed for the case of the K to two meson decay. Here, due to the SU (3) symmetry breaking, the analogous of Eq. (29) for g_K leads to a relation between g_K and g which can be written in terms of Z $_{K}$ and C $_{K}$. At rst approximation, however, the dependence on these parameters cancels and one can write

In this way, both $\$ and K $\$ strong decay constants can be predicted in terms of the measured value of g and the symmetry breaking parameters $\$ and $\$. The corresponding numerical evaluation will be done in Sect.V.

IV . ANOM ALOUS RAD IAT IVE DECAYS OF PSEUDOSCALAR AND VECTOR M ESONS

O ur goal is to test the ability of this relatively simple, NJL {like model to reproduce the observed pattern for the anom abus radiative decays of pseudoscalar and vector mesons once the breakdown of chiral symmetry is taken into account. These decays are mainly originated by the U (1)_A anomaly. In the framework of our model, they occur through the well{known triangle graphs shown in Fig. 4, which lead to an anomalous Wess{Zum ino{W itten e ective Lagrangian. The corresponding diagrams including an axial{vector which mixes with the pseudoscalar meson gives a vanishing contribution [16]. This can be seen e.g. by looking at the elective anomalous Lagrangian obtained by gauging the Wess{Zum ino{W itten action, as shown in Ref. [3].

The couplings between the vector m esons and the outgoing (on {shell) photons follow from the assumption of vector m eson dom in ance of the electrom agnetic interactions. In our fram ework, these couplings can be obtained from quark { loop diagram s connecting photons and vector m esons (see R ef. [7,11] for details). A fter the proper inclusion of the sym m etry breaking parameters and , the V couplings read

Let us begin by analyzing the decays of the neutral pseudoscalars $^{\circ}$, and $^{\circ}$ into two photons. These processes arise at the one{loop level from the triangle diagram s shown in Fig. 4 (a). The diagram s are found to be convergent, and the limit of vanishing external momenta can be taken trivially. For $^{\circ}$! we get

where is the electrom agnetic ne structure constant. This expression coincides with the result obtained in standard ChiralPerturbation Theory [1]. In the case of and ⁰ decays to two photons, one has the additional problem of ⁰ m ixing. In our fram ework, instead of dealing with the U (3) states ₁ and ₈, it is natural to work with the _u and _s states de ned above, which determ ine the avour content of the quark propagators in the loop. Taking into account the corresponding pseudoscalar wave{function renorm alizations, we nd

Now we analyze the radiative vector $m \mbox{ econys V} \ ! \ P$. The corresponding widths can be conveniently parameterized as

where the coe cients C $_{\rm VP}$ can be obtained from the loop diagram s shown in Fig. 4 (b). C learly, the evaluation of the relevant triangle quark loops is entirely sim ilar to that performed for the P ! case.

For the processes 0 ; ! 0 we can use Eqs. (13a), (27) and (29) to eliminate the pseudoscalar and spin 1 wave function renorm alization factors. In this way the coe cients C ${}^{\circ}$ o and C ${}_{!}$ o are simply given by

The same procedure applies in the case of V !; ⁰ processes, with the additional inclusion of the ⁰ m ixing angle and the avour symmetry breaking parameter . We have

For the decays K ! K , the calculation is slightly more complicated due to the presence of di erent constituent masses for the quark propagators in the loop. The coe cients depend now on the symmetry breaking parameter and the mass ratio $m_s = m_u$ according to

Finally let us consider the decays 0 ! and 0 ! !, which can be treated in a completely similar way just taking into account the spin 0 character of the decaying particle when averaging over the initial spin states. Using the same parameterization as in (38) we obtain

We have skipped in this discussion the decay ! ⁰ since the corresponding coe cient C vanishes in our framework, owing to the purely strange avour content of the meson.

However, in view of the present experimental results, it is interesting to remove the ideal mixing angle condition in the ! sector allowing for a tiny nonstrange component for the eld. If this is parameterized by a smallmixing angle 'v, one trivially gets [12]

The present experimental value for the branching ratio ! ⁰ leads to a mixing angle '_v of about 32 [12,17], which does not represent a significant change in the other, nonvanishing radiative decay widths involving and !.

V.MODEL PARAM ETERS AND NUM ERICAL ANALYSIS

In order to perform the phenom enological analysis of the model, and to obtain de nite predictions for pseudoscalar and vector m eson decay processes, it is necessary to establish a strategy, choosing a suitable set of parameters to be used as input values.

Let us begin with the basic decay processes analyzed in Section III.U sing the and K weak decays, it is possible to write the pseudoscalar wave function renormalization factors Z and Z_K in terms of the well(measured decay constants F and F_K , which will be taken as input parameters. In the same way, the wave function renormalization factor Z can be obtained from the phenomenological value g ' 6 arising from (28). Now, from (8) and (13a), we can relate g with the loop integral I_2 (m_u; m_u) to estimate

Next we use the mass relations (14) to determ ine a phenom enological acceptable set of values for the cut $\{0\}$ and the strange quark mass m_s. A reasonable choice is

which lead to m = 0.99 GeV (exp.1.02 GeV) and $m_K = 0.91 \text{ GeV}$ (exp.0.89 GeV), with a light quark mass $m_u = m_d$ ' 310 MeV. The symmetry breaking parameters , and de ned in the previous sections are then given by

U sing the relations (32) and (33), the phenom enological value of g, together with the results in (47) allow to predict the values for the strong decay constants g_K and g. In this way we obtain

while the corresponding experimental values read (K ! K) = 50.8 :9 MeV, (! K⁰K⁰) = 1:51 0:03 MeV and (! K⁺K) = 2:19 0:03 MeV [18]. The results are in agreement with the predicted values within an accuracy of a 15% level, which can be taken as a lower bound for the expected intrinsic theoretical error of the model.

As an alternative procedure, we could have derived the values for F $\,$ and F $_{
m K}$ from the relations (23), where the axial-vector m eson m asses can be taken either from Eqs. (24) or just as input parameters. For instance, with the chosen value of $m_{\rm u}$ we can obtain from Eq. (24) a prediction for the a₁ m ass of about 1080 M eV [18]. This value is som ew hat low, but once again agrees within a 15% accuracy with the present experimental result of $m_{a_1} = 1230$ 40 M eV. In fact, it is natural to expect the m odel to describe the axial-vector m eson sector only in a roughly approxim ate way, due to the relatively high m asses involved, the broad character of the resonances and the adm ixtures with close states with same quantum numbers. Hence we choose to rely on the well-known low energy decay constants F and F_{K} as our input m agnitudes.

F inally, using the analytical expressions obtained in the previous section, we can look at the model predictions for pseudoscalar and vector meson radiative decays. In the case of the decays involving and ⁰ m esons, it is necessary to x two m ore input param eters, which can be chosen as the decay constant ${\rm F}_{\rm s}$ (or equivalently the pseudoscalar wave function renorm alization Z_o) and the $_{1}$ ₈ m ixing angle _P. The latter is related with \prime_{P} by

where $_0$ ' 35:3 is the \ideal" rotation angle introduced above.

Our numerical results are shown in Table I, where we quote the values corresponding to four dierent sets for F_s and P_r , together with the present experimental widths [18]. In order to get the theoretical results, we have used the physical values for the pseudoscalar and vector m eson m asses entering Eq. (38). We have chosen the values of F_s and $_P$ that lead to a better agreem ent for the whole set of decays, always having in m ind that an intrinsic theoretical error of at least 15% can be expected from the NJL scheme. In general, we nd that the best results for $_{\rm P}$ lie within the usually expected range between 10 and 20 [17,19], while the model seems to prefer a rather large value for the ratio $F_s = F$, higher than 3/2. We quote for completeness the results corresponding to a ratio $F_s = F = 1.4$, favored by large-N_c arguments [20], which leads in this case to too large widths for the decays involving

and mesons.

W hen varying F_s and P_s , and comparing with the experimental values, it is found that an accurate agreem ent for certain widths worsens the predictions in other cases. Nevertheless, considering the relatively in portant intrinsic theoretical error of the model, it can be said that the values in Table I show a phenom enologically acceptable pattern for the pseudoscalar and vector meson anom abus radiative decays. Our results are found to be of similar quality to those presented e.g. in Ref. $[\beta]$, where the authors start from a nonlinear sign a model, and Ref. [12], where a di erent param eterization of the chiral avour symmetry breaking is introduced (notice that several experim ental values have changed in the last years).

VI.CONCLUSIONS

Starting from an elective four{ferm ion NJL Lagrangian, we have analyzed the phenom enology associated with anom alous radiative decays of pseudoscalar and vector m esons. The elective interactions between spin 0 and spin 1 mesons have been derived from the bosonization of the ferm ionic theory through the evaluation of the relevant quark loop diagram s, taking the leading order both in the external momenta and $1=N_{\rm C}$ power expansions. The divergent loops have been treated using a proper{time regularization scheme with a momentum cut{o}.

We have taken into account the breakdown of the chiral symmetry considering constituent quark masses $m_u = m_d \notin m_s$. The departure of the elective couplings from the global SU (3) arour symmetry limit has been introduced through the parameters and , which correspond to properly regularized ferm ion loop integrals.

In order to perform the phenom enological analysis, we have chosen a few fundam ental input parameters, namely the basic decay constants F , F_K and g , the meson mass, the momentum cut{o (or equivalently the light quark massmu), and the constituent mass of the strange quark m_s. We have also taken into account the physical values of the pseudoscalar meson masses. To account for the decays involving and ⁰ mesons, this set has been complemented with the parameter F_s and the ⁰ mixing angle _P. We have shown that with the choice ' 12 G eV and m_s' 510 M eV this simple model leads to an acceptable pattern for the vector meson mass spectrum, as well as the branching ratios for the strong decays ! , ! K K and K ! K . The agreement is found within a 15% level, that can be taken as a lower bound for the intrinsic theoretical error of the model.

We have evaluated within this fram ework the branching ratios for anom alous radiative decays of pseudoscalar and vector mesons. In the case of those processes involving the and 0 , the contrast between the predictions of our model and the present experimental data is optimized for a $_{\rm P}$ mixing angle between 10 and 20, in agreement with usual expectations. On the other hand, we not that the preferred ratio $F_{\rm s}{=}F$ lies in the range 1.75 to 2, which is a rather high value in comparison with the result arising from large N $_{\rm C}$ considerations. In general, taking into account the relatively large theoretical error, we see that the model leads to reasonably good predictions for the main radiative pseudoscalar and vector meson decay widths. The quality of our results is comparable to that obtained in previous works which use di erent elective models and/or parameterizations for the avour symmetry breaking elects.

APPENDIX:
