# The Bose-E instein distribution functions and the multiparticle production at high energies

#### Abstract

The evolution properties of propagating particles produced at high energies in a random ly distributed environment are studied. The – nite size of the phase space of the multiparticle production region as well as the chaoticity can be derived.

### 1 Introduction

Interest in (charged) particles "m oving" in an environment of quantum elds taking into account the relations between quantum uctuations and chaoticity is still attracted by the particle physics society. The events of high multiplicity at high energies is an interesting subject because of increasing energies of current and future colliders ( $e^+e$ , pp, pp) of particles. One of the m ost in portant tasks of superhigh energy particle studies is to analyze uctuations and correlations such as the Bose-E instein (BE) correlation [1] of produced particles. This is a rather instructive tool to study high multiplicity hadron processes in detail. W e understand the multiparticle (M P) production as the

process of colliding particles where the kinetic energy is dissipated into the m ass of produced particles [2]. We consider the incident energy r s means the quantum chromodynamics (QCD) scale. Phenomenowhere logical models [3,4] describing the crucial properties of multiparticle correlations are very useful for system atic investigations of the properties caused by uctuations and correlations. By considering them, one can obtain the characteristic properties of the internal structure of disordering of produced particles in order to extract the information on the space-time size of the multiparticle production region (MPPR), to estimate the lifetime of the particle em itter, etc. There were used the analysis of correlation functions (CF) and distriburion functions (DF) in [5,6] to understand the possible view on the quark-gluon plasm a form ation. In this paper, we present the model to describe the very high multiplicity e ects at high energies. The most characteristic point of our model is that the BE both DF's and CF's are taken into account on the quantum level (the operators of production and annihilations are used) with the random source contributions coming from the environm ent. W e de ne the average m ean multiplicity hN i via M P CF w (K) as hN i =  $^{K}d_{3}$  K w (K), where K is the spatial momentum of a particle. Following a natural way we suppose hN i N, while N  $N_{0} = 5 = m$ , where O (0:1 G eV). The main object in this investigation is the MP thermal m DF W (k; k<sup>0</sup>) related to hN i as

where hN i is de ned as the scale of the produced-particle multiplicity N at four-momentum k ( is the Lorenz index), the normalized DF f (k ) is nite, i.e.  $d_4kf(k) < 1$  and the label in (1.1)) means the temperature T (of the phase space occupied by operators  $b^+$  (k ) and b(k )) inverse. The nature of operators  $b^+$  (k ) and b(k ) will be clari ed in Sec.3.

In this paper, we claim that the observation of the size e ect in a M P production is derived via M P CF's and DF's as well as the so-called chaoticity which will be introduced in Sec.4. The M P CF form alism concerns the statistical physics based on the Langevin-type of equations. The Langevin equation to be introduced in Sec.3 is considered as a basis for studying the approach to equilibrium of the particle(s). It is assumed that the heat bath being in essence in nite in size remains for all times in equilibrium as well. W e use the method applied to the model where a relativistic particle moving in the Fock space is described by the number representation underlying the second quantization formulation of the canonical eld theory. We deal with the microscopic look at the problem with the elements of quantum eld theory (QFT) at the stochastic level with the sem iphenom enological noise embedded into the evolution dissipative equation of motion.

# 2 The model of dual representation within the dissipative dynamics

Let us suppose that the evolution of particles produced at high energies is described by the solutions of the m odel H am iltonian where any physical system of particles is described by the doublet of eld operators. We introduce the dual states in the eigenbasis f ki; k() ig of the H am iltonian H, where 0 < 1 is identied as the frequency representing the energy of the object and jki is a discrete eigenstate. We consider the simple dual m odel where H is given within the dam ped harm onic oscillator

Here, we identify  $k_i$ ,  $k_i$  () i and  $k_j$   $k_i$  () jwith the special mode operators of annihilation  $a_ib()$  and creation  $a^{\dagger}$ ;  $b^{\dagger}$  (), respectively, e.g., for "quarks" and "gluons" or their combinations. In the interaction H am iltonian (2.3), is the coupling constant, while g() provides the transition between discrete and continuous states.

The next step is to give the relations between the variables and couplings of the m odel (2.1) and the phenom enological constants, e.g., the frequency E and the dam ping constant involved into the dissipative dynam ics given by the Boltzm ann-type equations in the relaxation time approxim ation:

as ! 1.0 ne can conclude that the phenom enological constants E and in (2.4) (2.5) are nothing else but  $_0$  and 2  $^2$  g<sup>2</sup>( $_0$ ), respectively, i.e. the m icroscopic parameters coming from the model H am iltonian (2.1).

# 3 Stochastic model. Langevin equation

As it was pointed out in the Introduction, to derive the characteristic features of the M P production physics at high energies, one should specify the model on the quantal level. Let us assume that only the particles  $p_i$  of the same kind of statistics labeled by index i are produced just after the high energy collision process occured, e.g., pp;pp !  $p_i$ . In order to extend the m ethod of stochastically distributed particles in the environment, we propose that rather complicated real physical processes happened in the MP formation region should be replaced by a single-constituent propagation of particles provided by a special kernel operator (in the stochastically evolution equation) considered as an input of the model and disturbed by the random force F [5,6]. We assume that F can be the external source being both a c-num ber function and an operator. In such a hypothetical system of excited (therm al) local phase we deal with the canonical operator a (k;t) and its H erm itian conjugate a<sup>+</sup> (k;t). We form ulate DF of produced particles in term s of a point-to-point equal-tim e tem perature-dependent therm al CF of two operators

For simplicity, we deal with operators a and b as if they are the single boson or ferm ion operators. Considering the "propagation" of a particle with the momentum  $\tilde{k}$  in the quantum equilibrium phase space under the influence of

a random force coming from surrounding particles, the dissipative dynamics of the relevant system is described by the equation containing only the rst order time derivatives of the dynamic degrees of freedom, the operators  $b(\tilde{k};t)$  and  $b^{\dagger}$  ( $\tilde{k};t$ ) [5]:

The particle transitions are provided by the random source operator F (K;t) while P stands for a stationary external force. An interplay of particles with surroundings is embedded into the interaction complex kernel K (K;t), while the real physical transitions are provided by the random source operator F (K;t) with the zeroth value of the statistical average, hF i = 0. The random evolution eld operator K (K;t) in (3.7) stands for the random noise and it is assumed to vary stochastically with a - like equal time correlation function

In our model, we suppose that a heat bath (an environment) is an assembly of damped oscillators coupled to the produced particles which in turn are distributed by the random force  $\Re(k)$ . In addition, there is the assumption that the heat bath is statistically distributed. The random force operator  $\Re(k;t)$  can be expanded by using the Fourier integral

The quantitative inform ation (longitudinal  $r_z$  and transverse  $r_t$  components of MPPR, the temperature T of the environment) could be extracted by tting the theoretical form ula (4.5) to the measured D-function and estimating the errors of the t parameters. Hence, the measurement of the space-time evolution of the multiparticle source would provide information of the multiparticle process and the general reaction mechanism. The temperature of the environment enters into formula (4.5) through the two-particle CF (k; k<sup>0</sup>; T). If T is unstable, the R-functions (4.1) will change due to a change of DF f which, in fact, can be considered as an elective density of

In fact, the function D (k ;k<sup>0</sup>;T) in (4.5) could not be observed because of som e m odel uncertainties. In the real world, D -function has to contain background contributions which have not been included in the calculation. To be close to the experimental data, one has to expand the D - function as projected on som e well-de ned function (in S (< 4)) of the relative momentum of bosons produced D (k ;k<sup>0</sup>;T)! D (Q<sup>2</sup>;T): Thus, it will be very instructive to use the polynom ial expansion which is suitable to avoid any uncertainties as well as to characterize the degree of deviation from the G aussian distribution, for example. Thus, the observation of the multiparticle correlation enables one to extract the properties of the structure of  $q^2$ , i.e. the space-time size of MMPR. It remains to sketch how one goes about calculating the therm odynam – ical quantities in a local therm alized system of produced particles. Taking into account the positive- and negative-frequency parts of the boson eld operator (3.2) to be applied to the energy-momentum tensor T (x) =:  $_{B}(x) \tilde{K} \tilde{K}_{B}(x)$ : and the particle ow operator (x) =:  $_{B}(x) \tilde{K}_{B}(x)$ : we can calculate the energy density E (), the pressure V () and the entropy density S () in the local system of the volume v for bosons in the equilibrium therm alized phase space. Here, we suppose that the therm alized MPPR is isotropic, and one can use the space-averaged operators norm alized to the volume v, taking ensemble averages (4.6) and (4.7). It is easy to see that both E () and V () tend to their maximum values with rising T, while the entropy S () changes not so much essentially even if T ! 1.

#### 5 Statistical distributions

From a widely accepted point of view, at high energies, there are two channels, at least, for multiparticle production where produced particles occupy the MMPR consisting of i elementary cells. The Boltzm ann behaviour should be realized in the case when ! 1, i.e. the main contribution to the uctuating behaviour of the R (Q; )-function should come from the random source contribution (see (4.5) and (4.8)). We found that the enhancement of the R (Q; )-function, mainly, the shape of this function, strongly depends on the transverse size  $r_t$  of the phase space and has a very weak dependence of the y size of a separate elementary cell. The increasing of  $r_t$  makes that the shape of the R (Q; )-function becomes more crucial.

Obviously, (hN (s)i) is the normalization constant in (4.2), where hN (s)i should be derived at the origion of  $Q^2$  precisely from R (Q = 0; )  $R_0$  (s) as

can be extracted from the experiment at some chosen value of (= 0 should be taken into account as well). On the other hand, the R (Q; )-function allows one to measure  $= {}^{0}$  which parametrizes the random source

contribution as well as the splitting between and  $^{0}$ . Neglecting the random source contribution (i.e., putting =  $^{0}$  = 0) we can estim ate the chaoticity  $^{\sim}$  (!; ) by measuring R (Q; ) as Q<sup>2</sup> ! 0.

In fact, the theoretical prediction that D (Q; ) > 1 m eans that in M PPR one should select the single boson "dressing" of som e quantum numbers, and the particles suited near it in the phase space are "dressed" with the same set of quantum numbers. The amount of such neighbour particles has to be as many as possible. This allows to form a cell in the space-time occupied by equal-statistics particles only. Such a procedure can be repeated while all the particles will occur in the M PPR. This leads to the space-time BE distribution of produced particles in the phase-space cells form ed only for bosons. In fact, there is no restriction of the number of bosons occupying the chosen elementary cells. It means that D (Q; )-function are de ned for all orders.

# 6 Summary and discussion

We investigated the nite temperature BE correlations of identical particles in the multiparticle production using the solutions of the operator eld Langevin-type equation in  $S(<_4)$ , the quantum version of the N yquist theorem and the quantum statistical methods. The model considered states that all the particles are produced directly from the a high-energy collision process. There was presented the crucial role of the model in describing the BE correlations via calculations of DF's as functions of the mean multiplicity and chaoticity at each four-momentum  $Q^2$ . Based on this model, one can com pare the e ects on single particle spectra and multiparticle distribution caused by multiparticle correlations. There are several parameters in the model: ; y;  $(^{0})$ . One can focus on the statement that the deviation of the D (Q; )-function from zero at nite values of the physical variables  $q^2$ and the model parameter indicates that the MPPR should be considered as the phase-space consisting of the elementary cells (with the size y of each) which are occupied by the particles of identical statistics. The Boltzmann behaviour of R-function is available only at large enough values of which m eans the leading role of the random source contribution to the distribution function. An important feature of the model is getting the information on the space-time structure of the multiparticle production region. We are able

to predict the source size and the intercept parameter the chaoticity as well. We have found that  $D \in R(Q; )$  depends on the number of elementary dened by the size y in the rapidity y-space.

Of course, the best check of any model could be done if various kinds of high energy experim ental data on them ultiparticle correlations would be well reproduced by the model in consideration. Our model can be applied to the data which are available from the ALEPH experiment [10] at 5 = 91.2 GeV. The ALEPH data applied to R(Q)-function (in the notation of our model) in the region 0:1G eV 1G eV have an essential nonm onotonic behaviour. Q It means that the sign of the slope parameter of R (Q) changes in this region, and the values of R (Q) are less than unity. In accordance with our model, this e ect could be interpreted as the fact that in the domain 0:1G eV Q 1GeV the mean multiplicity hN (s) i has a small value which gives the strong suppression for the R(Q)-function normalized to (hN (s)i). In the case of higher energies of colliding particles (Tevatron, LHC), the expected (from our model) averaged multiplicity should be very large 300-400, and the nonmonotonic e ect will not occur. We hope that experiments at the Tevatron and LHC will measure the observables like R (Q) more precisely and the puzzle regarding the nonmonotonic behavior of the multiparticle distribution will be clari ed.
