# The C P - violating asym $m$ etry in ! + $e^{+} e$

#### Abstract

$W$ e study the CP-violating asym metry $A_{C P}$, which arises, in ! $\quad+\quad e^{+} e$, from the angular correlation of the $\mathrm{e}^{+} \mathrm{e}$ and ${ }^{+}$planes due to the interference betw een the $m$ agnetic and electric decay am plitudes. $W$ ith the phenom enologically determ ined $m$ agnetic am plitude and branching ratio as input, the asym $m$ etry, induced by the electric brem sstrah lung am plitude through the C P -violating decay ! ${ }^{+}$, and by an unconventional tensor type operator, has been estim ated respectively. The upper bound of $A_{C P}$ from the form er is about $10^{3}$, and the asymm etry from the latter $m$ ight be up to $O\left(10^{2}\right)$. O ne can therefore expect that this CP asym $m$ etry would be an interesting CP-violating observable for the future precise $m$ easurem ents in the factories.


[^0]CP violation has been observed experim entally in the avor-changing weak decays of the neutral $K \rightarrow m$ esons [1, 2, 3] and B $m$ esons [4, 5]. H ow ever, the origin of the violation rem ains unclear in the $m$ odem particle physics. The standard $m$ odel predicts that the only way that CP is violated is through the Cabbibo-K obayashiM askawa (CKM) mechanism [6]. Speci cally, the source of CP violation is a single phase in the CKM m ixing $m$ atrix that describes the avor-changing weak interaction couplings ofquarks. A though the predictions based on CKM mechanism are consistent with the observations in $K$ and $B$ system $S$, it would be interesting to look for the other sources of CP violation beyond the CKM phase and outside avor-changing processes, in order both to increase our understanding in the CP violation itself and to look for new physics e ects beyond the standard model 灲.
$R$ are decays provide a good laboratory for the above $m$ otivations, and CP violation in som e rare decays has been explored by experim entalists [GG]. Theorectally, P violation and CP violation in the decay of ! + have been discussed by H erczeg and Singer [G] nearly thirty years before; very recently, G eng, N g , and $\mathrm{W} u$ [10] studied the CP -violating e ects in this decay by considering the photon polarizations, and they predicted that a sizable linear photon polarization could be expected in som e unconventional new physics soenarios. In the neutral $K$ system, a large CP asymmetry, which arises from the interference between the parity-conserving $m$ agnetic am plitudes and the parity-violating electric am plitudes of $K_{L}!+{ }^{+}!e^{+} e$, has been predicted theoretically by $m$ any authors [11, 12, 13] and con m ed experim entally 14, 2]. The purpose of this paper is to extend the above analyses to the decay of ! + ! + $e^{+} e$, thus to probe possible new CP-violating
 be constructed if a relevant parity-violating electric transition exists.

The invariant decay am plitude of (p)! ${ }^{+}\left(p_{+}\right) \quad(\mathrm{p}) \mathrm{e}^{+}\left(\mathrm{k}_{+}\right) \mathrm{e}(\mathrm{k})$ can be expressed as follow s

The Lorentz invariant form factors $M$ and $E$ stand forparity-conserving $m$ agnetic and parity-violating electric transitions respectively, which depend on scalar products of $q, p_{+}$and $p$. In order to discuss CP violation in ! $+e^{+} e$, it is convenient to use the sam e kinem atic variables as those in $K_{L}$ ! ${ }^{+} e^{+} e$, which have been used by $P$ ais and Triem an for sem ileptonic $K, 4$ decays [15, 16]. They are: $s=\left(p_{+}+p\right)^{2}$, invariant $m$ ass squared of ${ }^{+} ; q^{2}=\left(k_{+}+k\right)^{2}$, invariant $m$ ass squared of $e^{+} e$; , the angle between the ${ }^{+}$threem om entum and the threem om entum in the ${ }^{+}$rest fram e; e, the angle between the $e$ threem om entum and the threem om entum in the $e^{+} e$ rest fram $e$; , the angle between the $\mathrm{e}^{+} \mathrm{e}$ and ${ }^{+}$planes in the rest frame. U sing these kinem atic variables, a CP-violating observable could be found by analyzing the distribution of the


Now in term sof the invariant form factors de ned in eq. (B), and integrating over cos $e$ and , we obtain

The decay rate of ! + has been $m$ easured [17] and is dom inated by the $m$ agnetic transition [18, 19]. H ow ever, the prediction to the decay rate from the low est order chiral perturbation theory are som ew hat low er than the experim ental value [18]. Phenom enologically, one can adopt the follow ing $m$ agnetic form factor [20], constructed using chiralm odels, for the $m$ agnetic transition of !

which yields the decay width very close to the experin ental value of (! ${ }^{+}$). N ote that, in eq. (6), $\mathrm{m}_{\mathrm{v}}=770 \mathrm{MeV}$ is the vectorm eson m ass; $\mathrm{f}=93 \mathrm{MeV}, \mathrm{f}_{8}=1: 3 \mathrm{f}$, and $\mathrm{f}_{0}=1: 1 \mathrm{f}$; $=20^{\circ}$ is the angle of the $\quad{ }^{0} \mathrm{~m}$ ixing.

Since the CP asymmetry in eq. (3) arises from the interference between the $M$ and $E$ term S , in order to get nonzero $\mathrm{A}_{\mathrm{CP}}$, we have to look for the possible interaction which could yield the electric transitions of ! $+\quad!{ }^{+} e^{+} e$. As pointed out in Ref. [10], it is easy to see that brem sstrahlung electric am plitudes can be induced through the interm ediate state which violates CP sym m etry. Thus it is straightforw ard to get

where $g+$ is the ective coupling of ! + 21, 10]. From the experim ental upper bound $\operatorname{Br}(!+\quad)<3: 310{ }^{4}$ [17], one can get

N ow using eqs. (3) | (8) together with the follow ing scalar products of four-vectors

The branching ratio of ! + $e^{+} e$ has been $m$ easured. Its value listed in the present Particle D ata Book 17] is

which is from a very old $m$ easurem ent [22]. The very recent $m$ easurem ent is from CM D -2 C ollaboration 23]:

O bviously, the situation for the observed $\operatorname{Br}\left(!{ }^{+} \mathrm{e}^{+} \mathrm{e}\right)$ is not very good due to the existing large uncertainty, which of course needs to be further im proved. A s a phenom enological analysis in the present paper, we use the central value in eq. (14) instead of the theoretical prediction from eq. (1) to illustrate the num erical value for the CP-violating asym $m$ etry $A_{C P}$.

The experim ental constraint on $g$ + has been obtained in eq. (G) by the lim it of $\operatorname{Br}\left(!+\right.$ ), which $m$ akes the upper bound of $A_{C P}$ be about $10{ }^{3}$. Theoretically, in Ref. 21], the CP-violating decay ! + together $w$ ith the e ective coupling $g+$ has been studied both in the standard model based on CKM mechanism [6] and/or strong
term lagrangian [24] and in the spontaneous $C P$ violation $m$ odel based on the $W$ einberg $m$ echanism 25]. Unfortunately, the values of $g+$ given by the above $m$ echanism $s$ are $m$ uch less than the upper bound in eq. (9), which im plies that CP asym $m$ etry in eq. (12) is very sm all and fully negligible. A s explained in Ref. [10], this is not surprising at allbecause the CP -violating quantities such as and ${ }^{0}$ in the $K^{0}$ system, and the neutron electric dipole $m$ om ents $d_{n}$ have im posed very strong constraints on the coupling of $!+$. . ne of the good choices to evade these constraints is that, we should search for som e unconventional sources of CP violation which do not contribute directly to, 0 , and $d_{n}$ and yet has a contribution to the decay ! + ( ). A type of such operators, avor-conserving CP
violating four-quark operators involving two strange quarks together with com binations of other light quarks, have been proposed in [10], which can be explicitly w ritten as follow s

where denotes up or down quarks, $G$ is a dim ensionless param eter originating from shortdistance physics and it can be taken real due to the CPT invariance. In order to evaluate the contribution from eq. (15) to ! + , the authors of $R$ ef. [10] used a factorization approxim ation that the ${ }^{+}$part is from and the transition involves only part containing strangeness. Follow ing the sam e procedure, it is easy to get the electric form factors of ! ${ }^{+} e^{+} e$ as

where $F$ ( $s$ ) param eterizes the form factor of the ! transition. It has been estim ated as F (s) F (0) 0:19 by the authors of Ref. 19] using the light front quark $m$ odel 26]. From eqs. (3), (6), (16), and (17), we obtain

IfG is $O$ (1), $A_{C P}$ could be about 2:0 $10^{2}$, which is one order larger than the upper bound in eq. (12). N ote that, for $G \quad 1$, we still have $\neq j$ is much large than $\xi j$ which does not essentially change the prediction from eq. (G) for the decay rate of ! ${ }^{+} .0 n$ the other hand, asm entioned in Ref. [19], since the operator in eq. [15) cannot directly generate the decay ! + and also cannot induce $d_{n}$ either, the CP-violating contributions from the operator in eq. (15) are free of the strong constraints from, ${ }^{0}$, and $d_{n}$. Hence, there are basically no direct constraints for $G$ from both low and high energy experim ents. Thus in principle, $G \quad O(1)$ is allowed, and a sizable CP asym m etry $A_{C P}$ could be expected.

In this paper, we are concemed about the general aspects of the CP-violating asym $m$ etry in ! ${ }^{+} e^{+} e$, and our study seem $s$ to indicate that there exists the possiblity of observing such e ects. O ne m ight suspect that G $O(1)$ is over-estim ated. This is not very surprising because generally the CP asymmetry of this decay is strongly suppressed in $m$ any conventionalm echanism s . W e should further explore how to realize the uncoventional operators of eq. (15) in som e explicit theoreticalm odels, in which G could be enhanced up to $O$ (1) or not $m$ uch $s m$ aller than 1 . This is not the task of the present paper, and it $w i l l$ be considered in the fiuture study. On the other hand, the $m$ easurem ent of the $C P$ asym $m$ etry
$A_{C p}$ in ! + $e^{+} e$ would provide an interesting lim it on $G$, thus further im pose the constraints on the theoreticalm odels.

The CP -violating e ects in ! + , which is generated from the interference betw een the $m$ agnetic and electric am plitudes of the decay $w$ ith explicit photon polarization, has been studied in Ref. [10], and a sizable CP-violating e ect could be induced when the contributions from an unconventional CP-violating interaction in term sof a tensor type operator in eq. [15) are considered. N ote that such CP-violating e ects will be invisible as long as the polarization of the photon is not observed. A $s$ an altemative to $m$ easuring the photon polarization, we consider in the present paper the decay ! ${ }^{+} \mathrm{e}^{+} \mathrm{e}$ resulting from the intemal conversion of the photon into an $\mathrm{e}^{+} \mathrm{e}$ pair, and the CP-violating e ects hidden in the polarization of the photon now can be translated into the CP asymmetry $A_{C P}$ in the angular correlation of the $e^{+} e$ plane relative to the ${ }^{+}$plane. The upperbound of $A_{C P}$ is about $10{ }^{3}$ by using the experim entallim it ofBr(! $r$ ); $m$ ore interestingly, the value of $A_{C P} m$ ight be enhanced up to $O$ ( $1 \%$ ) in som e unconventional scenarios. H opefully, for the future high statistics experim ents in the factories, this asym $m$ etry could be a useful CP-violating observable both to increase our know ledge on CP violation and to search for new physics e ects beyond the standard $m$ odel.
