## Top quark associated production of the neutral top-pion at high energy e<sup>+</sup>e colliders

In the context of topcolor-assisted technicolor (TC2) models, we calculate the associated production of the neutral top-pion  ${}^0_t$  with a pair of top quarks via the process  $e^+e^-$ ! tt  ${}^0_t$ . We not that the production cross section is larger than that of the process  $e^+e^-$ ! ttH both in the standard model (SM) and in the minimal supersymmetric SM. W ith reasonable values of the parameters in TC2 models, the cross section can reach 20fb. The neutral top-pion  ${}^0_t$  m ay be direct observed via this process.

The mechanism of electroweak symmetry breaking (EW SB) remains the most prominent mystery in elementary particle physics despite the success of the standard model (SM) tested by the high energy experimental data. The present and next generation of colliders will help explaining the nature of the EW SB and the origin of fermion masses. The LHC is expected to directly probe possible new physics (NP) beyond the SM up to a scale of a few TeV, while the high energy linear  $e^+e^-$  collider (LC) is required to complement the probe of the new particles with detailed measurements. Furthermore, some kinds of NP predict the existence of new particles that would be manifested as rather spectacular resonance in the LC experiments, if the achievable centre-ofm ass energy is su cient. Even their masses exceed the centre-ofm ass energy, it also retains an indirect sensitivity through a precision study of the virtual corrections to electroweak observable. A LC represents an ideal laboratory for studying this kind of NP [1].

Until a Higgs boson with large coupling to gauge boson pair is discovered, the possibility of strong EW SB must be entertained [2]. The most commonly studied class of theories is technicolor (TC) [3], which dynamical break the electroweak symmetry. A Ethough TC models have many theoretical problems as well as conicts with data and broad classes of these models have been ruled out, there are still viable models worthy of investigation in light of the capabilities of the current generation of experiments.

It is widely believed that the top quark will be a sensitive probe into physics beyond the SM .The properties of the top quark could reveal inform ation about avor physics, EW SB, as well as NP [4]. Given the large value of the top quark m ass and the sizable splitting between the m asses of the top and bottom quarks, it is natural to wonder whether  $m_t$  has a di erent origin from the m asses of the other quarks and leptons. There m ay be a comm on origin for EW SB and top quark m ass generation. M uch theoretical work has been carried out in connection to the top quark and EW SB. The TC2 m odels [5], the top see-saw m odels [6], and the avor universal TC2 m odels [7] are three of such examples. Such type ofm odels generally predict a num ber of scalars with large Y ukaw a coupling to the third generation. For exam ple, TC2 m odels predict the existence of the top-pions (t, t). These new particles are m ost directly related to the EW SB. Thus, studying the possible signatures of these new particles at present and future high energy colliders would provide crucial inform ation for the EW SB and can be used to test TC2 theory.

The production of a Higgs boson predicted by the SM or the minimal supersymmetric SM (MSSM) in association with a pair of top-antitop quarks is of extreme interest for two reasons [8]. First, the ttH production mode can be important for discover of a Higgs boson around 120 130G eV at the LHC, and even at the Run II of the Tevatron with high enough luminosity [9]. Although it has a small event rate (1 5fb) for a SM -like Higgs boson, and even lower for an MSSM Higgs boson, the signature is quite spectacular. Second, this production mode o ers a direct handle on the Yukawa coupling of the top quark, supposedly the most relevant one to understand the nature of ferm ion m asses. Both the LHC and LC can use the second feature to try a precision m easurement of the ttH coupling.

The signals of the ttH production m ode has been studied quite extensively in the LC [10], Tevatron and LHC [9] in the context of the SM and MSSM. Recently, Ref [11] has investigated the associated production of a neutral scalar predicted by TC2 m odels with a pair of top quarks at hadron colliders. They nd that the neutral scalar m ay be observed

at the LHC via the process pp ! tt . In this paper, we will calculate the production cross section of the process  $e^+e^-$ ! tt  $_t^0$  and the discuss the possibility of the detecting  $_t^0$  via this process in the future LC experiments. We ind the production cross section is larger than that of the process  $e^+e^-$ ! ttH. In most of the parameter space of the TC2 models, the production cross section is larger than 5fb which may be detected in the future LC experiments.

TC2 models generate the large top quark mass through the form ation of a dynam ical tt condensation and provide possible dynam ical mechanism for breaking electroweak symmetry. In TC2 models, the EW SB is driven mainly by TC interaction, ETC interactions give contribution to all ordinary quark and lepton masses including a very small portion of the top quark mass, namely  $m_t^0 = m_t$  with 1. The top color interactions also make small contributions to the EW SB and give rise to the main part of the top quark mass  $m_t m_t^0 = (1) m_t$  similar to the constituent masses of the light quark in QCD. This means that the associated top-pions  $t_t^0$ , t are not the longitudinal bosons W and Z, but separately, physically observable objects.

To maintain eletroweak symmetry between top and bottom quarks and get not generate  $m_b = m_t$ , the topcolor gauge group is usually take to be a strongly coupled SU (3)  $^{N}$  U (1). At the 1 TeV, the dynamics of a general TC2 model involves the following structure [5,12]:

where SU (3)<sub>1</sub><sup>N</sup> U (1)<sub>Y1</sub> (SU (3)<sub>2</sub><sup>N</sup> U (1)<sub>Y2</sub>) generally preferentially to the third (rst and second) generations. The U (1)<sub>Y2</sub> are just strongly rescaled versions of electroweak U (1)<sub>Y</sub>. The above breaking scenario gives rise to the topoolor gauge bosons including the color-octet coloron B<sup>A</sup> and color-singlet extra U (1) gauge bosons Z<sup>0</sup>. The relevant couplings of the new gauge boson Z<sup>0</sup> to ordinary ferm ions can be written as:

where  $g_1$  is the U  $(1)_{Y_1}$  coupling constant at the scale  $T_C$  and 0 is the mixing angle with tan  $0 = g_1 = (2^{D} \ k_1)$ . To obtain proper vacuum tilting (the topcolor interactions only condense the top quark but not the bottom quark), the coupling constant  $k_1$  should satisfy certain constraint, i.e.  $k_1 = 1$  [7,12]. In the following estimation, we will take  $k_1 = 1$ . The choice  $k_1 = 1$  corresponds to  $\tan^2 = 0 = 0.01$  [12].

For TC2 models, the underlying interactions, topcolor interactions, are non-universal and therefore do not posses a G M mechanism. The non-universal gauge interactions can result in the avor changing (FC) coupling vertices when one writes the interactions in the quark mass eigen-basis. Thus, the top-pions have large Y ukawa couplings to the third family quarks and can induce the new FC scalar couplings. For the neutral top-pion  $^{0}_{t}$ , the relevant coupling can be written as [5,13]:

where  $F_t$  is the top-pion decay constant and  $w = -\frac{p}{2} = 174$  GeV. It has been shown that the values of these coupling parameters can be taken as:

From above discussion, we can see that the tt  $_{t}^{0}$  production channels can be represent by the processes:

U sing Eq.(2)-(4) and other relevant Feynnm an rules, we can give the invariant scattering amplitude of the process  $e^+e^-!$  tt  $^0_t$ .

W here p = 1 is the centre-ofm ass energy of the LC experiments and M  $_{z^{\circ}}$  is the mass of the top color gauge boson Z<sup>0</sup>. The decay width  $_{z^{\circ}}$  is dominated by tt, bb and we have [14]:

which corresponds to  $\tan^2 = 0.01$ .

To obtain numerical results we take the SM parameters as  $\sin^2 = 0.2315$ ,  $= \frac{1}{128.8}$ ,  $m_z = 91.2 \text{GeV}$ , z = 2.495 GeV and  $m_t = 175 \text{GeV}$  [15]. For TC2 models, the parameters

m  $_{t}$ , and M  $_{Z^{0}}$  are the free parameters. To see how those parameters a ect our num erical results, we take 200G eV m  $_{t}$  450G eV, 0:01 0:1, and 2T eV  $_{z}$ M 6T eV.

The tt  $_{t}^{0}$  production cross section is plotted in Fig.1 as a function of m  $_{t}$  for the centre-ofm ass energy  $^{P}s = 1.5T \text{ eV}$ , M  $_{z^{0}} = 2.5T \text{ eV}$  and three values of the parameter . From Fig.1 we can see that is not sensitive to the value of parameter and decreases with m  $_{t}$  increasing. Thus, in the following numerical estimation, we will take = 0.05. For = 0.05, varies between 10.7fb and 48fb for the neutral top-pion mass m  $_{t}$  in the range of 200 400G eV.

To see the e ect of the extra U (1) $_{y}$  gauge bosons Z<sup>0</sup> m ass M  $_{z^0}$  on the cross section , we plot the as function of M  $_{z^0}$  for  $s = 1.5T \, \text{eV}$  in Fig.2, in which the full, broken and dotted-dashed curves stand for m  $_t = 250G \, \text{eV}$ , 350G eV, and 450G eV, respectively. One can see from Fig.2 that decreases with m  $_{z^0}$  increasing. In most of the parameter space, the production cross section is larger than 5.8 fb.

Recently, Ref.[16] has shown that BB m ixing provides strong lower bounds on the masses of B<sup>A</sup> and Z<sup>0</sup> bosons, i.e. there must be larger than 4T eV. In Fig.3 we take M<sub>Z<sup>0</sup></sub> = 5T eV and plot as a function of  $\bar{s}$  for three values of the top-pion mass. From Fig.3 we can see that, when  $\bar{s}$  is larger than 2T eV, the cross section is not sensitive to the value of the centre-ofm ass energy  $\bar{s}$ . For  $\bar{s} = 2T$  eV and = 0.05, increase from 6.8fb to 21.8fb as m<sub>t</sub> decreasing from 450G eV to 250G eV.

The process e<sup>+</sup> e ! ttH has been extensively studied and calculated both in the SM and in the MSSM at O ( $_{\rm s}$ ) [10]. The cross section turns out to be highly sensitive to the top Yukawa coupling g<sub>ttH</sub> over most of the parameter space. A lthough the cross section is very smaller than 2fb for m<sub>H</sub> = 120 130G eV, the signature for ttH production mode is spectacular. It has been shown that the top Yukawa coupling g<sub>ttH</sub> can be measured with a precision of the order of 7 15% at  $^{\rm P}$  s = 11 eV for M<sub>H</sub> = 120 130G eV, assuming a b-tagging e ciency between 0.6 and 1 [17] and with a precision of 55% at  $^{\rm P}$  s = 800G eV, when optim alb-tagging e ciency is assumed [18]. The cross section of the process e<sup>+</sup> e ! tt  $_{\rm t}^{0}$  is larger than 5fb, even for M<sub>Z</sub> = 5TeV and = 0.01, which is signi cantly larger than that of the process e<sup>+</sup> e ! ttH . Thus, the top Yukawa coupling g<sub>tt  $_{\rm t}^{0}$ </sub> can be precisely measured in the future LC experiments. The signatures for tt  $_{\rm t}^{0}$  production mode may be detected.

Since the negative top-pion corrections to the Z ! bb branching  $R_{\rm b}$  become smaller when the top-pion is heavier, the LEP/SLD data of R<sub>b</sub> give low er bound on the top-pion m ass [19]. Ref.[20] has shown that the top-pion m ass is allowed to be in the range of a few hundred G eV depending on the values of the parameters in the TC2 models. So we have take the mass of the top-pion to vary in the range of 200G eV 450G eV . For 200G eV m , 350G eV, the dom inate decay channel is  $_{t}^{0}$  ! tc. If we take K  $_{UR}^{tc}$  = 0:05, m  $_{t}$  = 300G eV, we have that the branching ratio  $B_r(t_t^0 ! tc)$  is approximately equal to 60% and  $B_r(t_t^0 ! gg)$  is only equal to 16% [21]. This is di erent from that of Ref.[11], which has assumed that the top-pion can not induce the FC scalar coupling. Thus, the produce m ode tt  $^0_{\rm t}$  should be detected via the dominate decay channel  $\frac{0}{t}$ ! tc, which has been extensively studied in Ref.[13]. For  $m_{+}$  > 350G eV, the branching ratio of the decay channel  $_{+}^{0}$ ! tt is close to 100%, all other decay channels may be ignored. In this case, the associated production of the  $\frac{0}{t}$  with a pair of top quarks induces an four top quark nal state, which may be experim entally observable [22].

From triviality, we see that the SM can only be an elective theory valid below some

high energy scale , the strong EW SB theories might be needed [23]. The strong top dynam ics models, such as TC2 models, are the modern dynam ical models of EW SB. Such type of models generally predict a number of scalars with large top Y ukawa couplings. Direct observation of these new particles via their large top Y ukawa coupling would be con rm ation that the EW SB sector realized in nature is not the SM or part of the M SSM. In this paper, we investigate the top quark associated production with the neutral top-pion  $_{t}^{0}$  and calculated the cross section of the tt  $_{t}^{0}$  production mode via the process  $e^{+}e + tt _{t}^{0}$  in the context of TC2 models. Our results show that the cross section is signil cantly larger than that of the process  $e^{+}e + tt$  and is larger 5fb in most of the parameter space. With reasonable values of the parameters in TC2 models, the cross section can reach 20 fb. Thus, the neutral top-pion  $_{t}^{0}$  may be direct observed via the process  $e^{+}e + tt _{t}^{0}$ .
