Charge Neutrality E ects on 2- avor Color Superconductivity

The e ect of electric and color charge neutrality on 2- avor color superconductivity has been investigated. It has been found that the e ect of the charge neutrality on a 2- avor quark system is very dierent from that on a 3- avor system. The BCS diquark pair in 2- avor color superconducting phase has been largely reduced by the large Ferm im on entum of electron, the diquark condensate rst increases with the increase of quark's chem ical potential , then decreases rapidly and nally disappears at about = 535M eV, at which the therm odynam ic potential equals to that in the neutral norm al 2- avor quark m atter.

I. IN TRODUCTION

Because of the existence of an attractive interaction in the anti-triplet quark-quark channel in QCD, the cold and dense quark matter has been believed to favor the formation of diquark condensate and being in the superconducting phase [1]-[4].

The QCD phase structure at high baryon density is determined by how many kinds of quarks can participate in the pairing. If we have an ideal system with two massless quarks u and d, and the three colored u quarks and three colored d quarks have the same Ferm i surface, the system will be in 2 avor color superconducting phase (2SC); and if we have an ideal system with three massless quarks u, d and s, and all the nine quarks have the same Ferm i surface, then all the quarks will participate in pairing and form a color- avor-locking phase (CFL) [5].

In the real world, the strange quark m ass m_s should be considered, which will reduce the strange quark's Ferm i surface. If m_s is large enough, there will be no pairing between us and ds, and a 2SC + s phase will be favored [6].

A lso, in reality, the system should be electric and color neutral, the existence of eletrons in the system will shift the Ferm i surface of the two pairing quarks, and the system can be in BCS phase or crystalline phase [7] or norm all quark matter, depending on how large the di erence in the chem ical potentials of the two pairing quarks is.

In a recent paper [8], it has been argued that the 2SC + s phase would not appear if the electric and color charge neutrality condition is added, which is also agreed with the results in [9] by using SU (3) NJL m odel and taking into account the self-consistent electric quark m ass m_f(), where f refers to u;d;s. It is found in [9] that the charge neutrality has a large electron the s quark m ass, i.e., m_s() begins to decrease at a smaller ' 400M eV than the case if no charge neutrality is considered like in [10] [11], where m_s() begins to decrease at a smaller ' 550M eV .

In this paper, complementary to [9], we investigate the e ect of charge neutrality on 2- avor color superconductivity assuming that there is no strange quark involved in the

chem ical potential regime < 550M eV .

This paper is organized as following: in Sec. II, we extend our method in [12] to derive the therm odynam ic potential when charge neutrality is considered; the gap equations and charge neutrality conditions will be derived in Sec. III, and in Sec. IV, we will give our numerical results; the conclusions and discussions will be given at the end.

II. THERMODYNAM IC POTENTIAL

A. The Lagrangian

A ssum ing that the strange quark does not appear in the system, we use the SU (2) N am bu-Jona-Lasinio m odel, and only consider scalar, pseudoscalar m esons and scalar diquark. The Lagrangian density has the form as

where $q^{c} = C q^{T}$, $q^{c} = q^{T}C$ are charge-conjugate spinors, $C = i^{2} {}^{0}$ is the charge conjugation matrix (the superscript T denotes the transposition operation), the quark eld $q = q_{i}$ with i = 1;2 and = 1;2;3 is a avor doublet and color triplet, as well as a four-component D irac spinor, $\sim = (1; 2; 3)$ are Pauli matrices in the avor space, and $(")^{ik} = "^{ik}$, $(b) = b^{b}$ are antisymmetric tensors in the avor and color spaces respectively. G_{s} and G_{p} are independent e ective coupling constants in the scalar quark-antiquark and scalar diquark channel.

A fter bosonization, one can obtain the linearized version of the model (1)

where we have assumed that there will be no pion condensate and introduced the constituent quark mass

From general considerations, there should be eight scalar diquark condensates [13] [14]. In the case of the NJL type model, the diquark condensates related to momentum vanish, and there is only one 0⁺ diquark gap with D irac structure $= _5$ for m assless quark, and another 0⁺ diquark condensate with D irac structure $= _0 _5$ at nonzero quark m ass. In this paper, we assume that the contribution of the diquark condensate with $= _0 _5$ is small, and only consider the diquark condensate with $= _5$. The diquark condensate with D irac structure $= _5$ has been recently discussed in [15].

We can choose the diquark condenses in the third color direction, i.e., only the rst two colors participate in the condensate, while the third one does not.

The model is non-renorm alizable, and a momentum cut-o should be introduced. The parameters G_s and in the chiral lim it m₀ = 0 are xed as

The corresponding elective mass m = 0.314GeV, and we will choose G_D = 3=4G_S in our num erical calculations.

B.Partition function and therm odynam ic potential

The partition function of the grand canonical ensemble can be evaluated by using standard m ethod [16] [17],

where = 1=T is the inverse of tem perature T, and is the chem ical potential. When electric and color charge neutrality is considered, the chem ical potential is a diagonal 6 6 m atrix in avor and color space, and can be expressed as

where $_1$; $_2$; $_3$ are for the three colored u quarks, and $_4$; $_5$; $_6$ are for the three colored d quarks.

Like in [8] [9], the chemical potential for each color and avor quark is specified by its electric and color charges $_{i} = Q_{e}_{e} + T_{3}_{3c} + T_{8}_{8c}$, where Q_{e} ; T_{3} and T_{8} are generators of U (1)_Q; U (1)₃ and U (1)₈. Because the diquark condenses in the third color direction, and the rst two colored quarks are degenerate, we can assume $_{3c} = 0$. For the same avor, the difference of chemical potentials between the rst two colored quarks and the third colored quarks and the third colored quarks and the third colored quark is induced by $_{8c}$, and for the same color, the difference of chemical potentials between q and q are generated by $_{8c}$.

The explicit expressions for each color and avor quark's chem ical potential are:

Because the third colored u and d, i.e., the 3rd and 6th quarks do not participate in the diquark condensate, the partition function can be written as a product of three parts,

 Z_{36} part is for the unpairing quarks q_3 (u_3) and q_6 (d_3), and $Z_{15;24}$ part is for the quarks participating in pairing, q_1 (u_1) paired with q_5 (d_2), and q_2 (u_2) paired with q_4 (d_1). In the following two subsections, we will derive the contributions of Z_{36} and $Z_{15;24}$.

1. Calculation of Z $_{36}$

Introducing the 8-spinors for $q_{\!\scriptscriptstyle B}$ and $q_{\!\scriptscriptstyle B}$,

The calculation of $Z_{15;24}$ here is much more complicated than that when the two pairing quarks have the same Ferm i surface [12].

III.GAP EQUATIONS AND CHARGE NEUTRALITY CONDITION

From the therm odynam ic potential Eq.(32), we can derive the gap equations of the order parameters m and for the chiral and color superconducting phase transitions.

A . G ap equation for quark m ass

The gap equation for quark m ass can be derived by using

IV . NUMERICAL RESULTS

In the num erical results, we investigate the following four dierent cases: 1), no color superconducting phase, no charge neutrality condition; 2), no color superconducting phase,

electic charge neutrality condition added, the electron's chem ical potential in this phase will be characterized by ${}^{0}_{e}$; 3), color superconducting phase exists, no charge neutrality condition, the diquark condensate in this phase will be characterized by ${}^{0}_{0}$; 4), color superconducting phase exists, electric and color charge neutrality condition added, the electron's chem ical potential and diquark condensate in this phase will be characterized by ${}^{0}_{e}$ and respectively.

Fig. 1 is for the chiral phase transition in the case of no electric neutrality considered, which is fam iliar to all of us, the quark posses a large constituent m ass in the low baryon density regime due to chiral symmetry breaking, and restores chiral symmetry at high baryon density.

Fig. 2 is the chiral phase diagram when the electric charge neutrality is considered, the solid squares and the solid circles are for quark mass m and electron's chem ical potential $\frac{0}{e}$ respectively. It is found that, in the chiral symmetric phase, there is a large Ferm i surface for electrons, and the electron's chem ical potential $\frac{0}{e}$ increases linearly with the increase of quark's chem ical potential .

Fig. 3 is the phase diagram for color superconductivity without charge neutrality constraints, the quark mass m (squares) and diquark condensate $_0$ (circles) are plotted as functions of quark's chemical potential . It is found that in the color superconducting phase, the magnitude of the diquark condensate $_0$ is about 100M eV by using the param – eter $G_D = 3=4G_S$. $_0$ rst increases with increasing , and this tendency stops at about = 530M eV, which is related to the momentum cut-o .

Fig. 4 is the phase diagram for color superconductivity when electric and color charge neutrality condition is considered, the quark mass m (squares), diquark condensate (triangles) and the electron's chem ical potential $_{\rm e}$ (circles) are plotted as functions of quark's chem ical potential . It is found that when chiral symmetry restores, the color superconducting phase appears. In the color superconducting phase, it is found that both the diquark condensate and the electron's chem ical potential rst increase with increasing , and reaches their maximum at about = 475M eV, then decrease rapidly with increasing

, and the diquark condensate disappears at about = 535M eV .

In Fig. 5, we show the chemical potential $_{8c}$ as a function of , which ensures the system having zero net color charge T_8 . It is found that $_{8c}$ can be negative and positive, but its value is very sm all, only about several M eV. It means that for the same avor quark u or d, the di erence of Ferm im on enta between the third colored quark and the rst two colored quarks can be neglected.

In order to explicitly see what happens to a color superconducting phase when charge neutrality condition is added, we compare the electron's chem ical potential in the neutral norm all quark matter $\frac{0}{e}$ (light circles) and in the neutral superconducting phase $_{e}$ (solid circles) in Fig. 6, and compare the diquark condensate $_{0}$ (light squares) and (solid circles) in the electric charged and neutral superconducting phases in Fig. 7.

From Fig. 6, we not that the electron has a larger Ferm i surface in the neutral superconducting phase than that in the neutral norm all quark matter. This is because in the superconducting phase, the isospin is mainly carried by unpaired quarks only, and $_{e}$ has to be larger in order to get the same isospin density. $_{e}$ is equal to $_{e}^{0}$ at about = 535M eV, at which the diquark condensate disappears. We separate $_{e}$ into two parts as $_{e} = _{e}^{0} + _{e}$, where $_{e}$ relects the elect induced by diquark condensate, comparing $_{e}$ (light squares) and (solid squares) in Fig. 6, we can see that $_{e}$ increases when increases, and decreases when decreases, and when = 0, $_{e} = 0$, too.

From Fig. 7, we can see that the diquark condensate in the neutral superconducting phase has a much smaller value than $_0$ in the charged superconducting phase, it means that the difference of the Ferm is urfaces of the two pairing quarks reduces the magnitude of the diquark condensate .

From Fig. 6 and Fig. 7, we can see a distinguished characteristic in the neutral superconducting phase, i.e., both the electon's chem ical potential $_{\rm e}$ and the magnitude of the diquark condensate rst increase with increasing , then at about = 475M eV, decrease with increasing . Now we try to understand this phenomena.

The magnitude of the diquark condensate is not only a ected by , but also by $= e^{2}$,

which describes the di erence of Ferm i surface between the two paired quarks and reduces the diquark condensate as seen in Fig. 7. The diquark condensate rst increases with increasing , which is the result of the increasing density of states. At about = 475M eV, where $_{d}$ = +1=3 $_{e}$ is about 530M eV, the diquark condensate starts to be a ected by the momentum cut-o . Like that in the charged color superconducting phase, the diquark condensate stops increasing with , so does $_{e}$. However, when > 475M eV, $_{e}^{0}$ keeps increasing with , which reduces the diquark condensate largely. This is why we see decreases with increasing . Finally at a certain chem ical potential = 535M eV, where $_{d}$ is about 580M eV, the diquark condensate disappears. Because $_{e}$ decreases with the decreases of , the total $_{e}$ decreases in the chemical potential regime > 475M eV.

At last, in Fig.8, we show the therm odynam ic potentials in the four di erent cases as functions of chem ical potential , the light squares and circles are for the cases with and without charge neutrality and without diquark condensate, the dark circles and squares are for the cases with and without charge neutrality and with diquark condensate. It can be seen that in the chiral sym m etric phase, the charged superconducting phase has the lowest therm odynam ic potential, and the charged norm al quark m atter has the second lowest . The neutral superconducting phase has a little bit lower than that of the neutral quark m atter in the chem ical potential region < 535M eV, and at = 535M eV, the two s coincide with each other. Therefore, in the chiral sym m etric phase, the stable state of the neutral system is the color superconducting phase for < < 535M eV. At = 535M eV, the stable phase is the nom oral neutral quark m atter.

V.CONCLUSIONS

We invetigated the e ect of charge neutrality on a two avor quark system. It has been found that the BCS diquark pair has been largely reduced by the large Ferm in on entum of electron, the diquark condensate rst increases with the increase of quark's chemical potential, then decreases rapidly and diappears at about = $535M \, \text{eV}$, at which the

therm odynam ic potential equals to that in the neutral norm alguark m atter. In the chem – ical potential region 330M eV < 535M eV, the stable neutral system is in the color superconducting phase if no strange quark involved.

A swem entioned in the introduction, we did not consider the strange quark in the system, which should be considered and has been investigated self-consistently in [9]. C om paring our results with their results about the diquark gap , the electron's chemical potential $_{e}$ and the chemical potential $_{8c}$ in 2SC, it can be found that them ain di erence lies in the chemical potential region > 400M eV. In [9], the diquark condensate in the neutral superconducting phase is largely reduced only in a small chemical potential region 370M eV < 400M eV. $_{e}$ rst increases with then begins to decrease at about = 400M eV. As for $_{8c}$, the tendency also becomes di erent from our results at about = 400M eV. The reason lies in that, in [9], the strange quark involves in the system when > 400M eV. This shows that the e ect of the charge neutrality condition on three- and two- avor quark system is quite di erent.
