## Param etric resonance in quantum eld theory

We present the rst study of parametric resonance in quantum eld theory from a complete next-to-leading order calculation in a 1=N -expansion of the 2PIe ective action, which includes scattering and memory eects. We present a complete numerical solution for an O(N)-symmetric scalar theory and provide an approximate analytic description of the nonlinear dynamics in the entire amplication range. We note that the classical resonant amplication at early times is followed by a collective amplication regime with explosive particle production in a broad momentum range, which is not accessible in a leading-order calculation.

In quantum eld theory the phenomenon of parametric resonance describes the resonant amplication of quantum uctuations, which can be interpreted as particle production. It provides an important building block for our understanding of the (pre)heating of the early universe after a period of in ation [1]. It has been frequently discussed for relativistic heavy—ion collisions in the form ation of discriented chiral condensates [2], or the decay of Polyakov—loop condensates [3], or parity—odd bubbles [4].

Despite being a basic phenomenon that can occur in a large variety of quantum eld theories, param etric resonance is a rather complex process, which has so far de ed m ost attem pts for a com plete analytic treatm ent even for simple theories. It is a far-from -equilibrium phenom enon involving densities inversely proportional to the coupling. The nonperturbatively large occupation numbers cannot be described by standard kinetic descriptions. So far, classical statistical eld theory simulations on the lattice have been the only quantitative approach available [5]. These are valid for not too late times, before the approach to quantum therm alequilibrium sets in. Up to now, studies in quantum eld theory have been mainly limited to linear or mean-eld type approximations (leading-order in large-N, Hartree) [6], which present a valid description for su ciently early times. However, they are known to fail to describe therm alization and m iss im portant rescattering e ects [5, 7]. Going beyond mean-eld has long been a major diculty in practice: Similar to perturbation theory, standard approximations such as based on 1=N (expansions of the one-particle irreducible (1PI) e ective action can be secular in time and do not provide a valid description. In contrast, it has recently been dem onstrated [8, 9] for 1 + 1 dim ensional theories that far-from -equilibrium dynamics and subsequent therm alization can be described using a 1=N -expansion of the two-particle irreducible (2P I) e ective action [9, 10, 11]. Below, we show that this provides a system atic and practicable nonperturbative approach for quantum eld theories in 3+1 dim ensions and with a nonzero macroscopic eld , relevant for realistic particle physics applications. In this work, we present the rst quantum eld theo-

retical description of the phenom enon of param etric resonance taking into account rescattering: For an O (N) { symmetric scalar eld theory we employ the 2PI 1=Nexpansion to next-to-leading order (NLO), which includes o -shell and memory e ects [9, 11]. We point out that the approach solves the problem of an explicit description of the dynamics of correlation functions at nonperturbatively large densities. We present a complete num erical solution of the corresponding equations of motion. M oreover, we identify the relevant contributions to the dynamics at various times and provide an approxim ate analytic description of the nonlinear dynam ics for the entire amplication range. Apart from the resonant am pli cation in the linear regim e, we identify two characteristic tim e scales, which signal strongly enhanced particle production in a broad m om entum range due to nonlinear, source e ects. This collective amplication is crucial for the rapid approach to a subsequent, quasistationary regin e, where direct scattering drive a very slow evolution towards therm al equilibrium. We emphasize that these processes cannot be seen in mean-eld approximations. Sim ilar phenom ena have been observed in classical eld theories [5], and we present an analytic criterion for the validity of classical statistical approximations. These e ects are in portant for a reliable description of the system at the end of the resonance stage for  $nite N \cdot 1 = .$ For realistic in ationary models with typically is, in particular, crucial to determ ine whether there are any radiatively restored sym m etries.

We consider a relativistic real scalar eld'a (a = 1;:::;N) with action S[] =  $_{\rm x} {\rm f}_2^1{}'_{\rm a} (_{\rm x} + {\rm m}^2)'_{\rm a} + {\rm m}^2)'_{\rm a}$  where sum mation over repeated indices is implied. We use the notation  $_{\rm x}$   $_{\rm C} {\rm dx}^0$  dx with C denoting a closed time path along the real axis. All correlation functions of the quantum theory can be obtained from the 2PI generating functional for G reen's functions [;G], parametrized by the eld expectation value  $_{\rm a}$ (x) =  ${\rm h}'_{\rm a}$ (x)i and the connected propagator  ${\rm G}_{\rm ab}$ (x;y) =  ${\rm h}''_{\rm c}$ (x)'  $_{\rm b}$ (y)i  $_{\rm a}$ (x)  $_{\rm b}$ (y) [10]:




FIG. 1: The dots indicate that each diagram is obtained from the previous one by adding another \rung" with two full propagator lines at each vertex. The crosses denote eld insertions.

where iG  $_{0;ab}^{-1}(x;y;)$   $\frac{^2S[]}{_a(x)_{-b}(y)}$ . The term  $_2[;G]$  contains all contributions beyond one-loop order and can be represented as a sum over closed 2P I graphs [10]. To NLO in the 2P I 1=N -expansion,  $_2[;G]$  contains the diagrams with topology shown in Fig. 1 [9, 11]. The in nite series can be sum med analytically:

with B (x;y;G)  $(x y) + \frac{i}{6N}G^2(x;y)$  and  $G^2(x;y)$  G ab (x;y)G ab (x;y). The equations of motion [14] are

As we will show below, for the phenom enon of parametric resonance, each diagram of the in nite series in Fig. 1 eventually contributes at the same order in the coupling. In this sense, the 2PI 1=N -expansion to NLO represents a minimal approach for a controlled description including rescattering. This justimes the rather involved complexity of the approximation.




FIG. 2: Total energy (solid line) and classical-eld energy (dotted line) as a function of time for  $=10^{-6}$ . The dashed line represents the uctuation part, showing a transition from a classical-eld to a uctuation dominated regime.

O verview. Param etric am pli cation of quantum uctuations can be best studied in a weakly coupled system that is initially in a pure quantum state, characterized by a large \classical" eld amplitude  $_{a}$  (t) = (t)M  $_{0}$  6N =  $_{a1}$ , and small quantum uctuations, corresponding to vanishing particle numbers at initialtime. Here Mosets our unit of mass and the rescaled eld (t = 0)o is of order unity. We rst present results from a full num erical [15] integration of the time evolution at NLO. In Fig. 2 we show the classical-eld and the uctuation contributions to the (conserved) total energy as functions of time. The former dominates at early times and one observes that more and more energy is converted into uctuations as the system evolves. A characteristic time { denoted as  $t_{nonpert}$  in Fig. 2 { is reached when the classical and the uctuation part of the energy become of the same size. Before this time, the coherent oscillations of the eld lead to a resonant enhancement of uctuations in a narrow range of




FIG. 3: E ective particle number density for the transverse modes as a function of time for various momenta p  $5p_0$ . At early times, modes with p '  $p_0$  are exponentially amplied with a rate 2  $_0$ . Due to nonlinearities, one observes subsequently an enhanced growth with rate 6  $_0$  for a broad momentum range.




FIG. 4: Same as in Fig. 3, for the longitudinal modes. Non-linear source e ects trigger an exponential growth with rate 4  $_0$  for p.  $2p_0$ . The thick line corresponds to a mode in the parametric resonance band, and the long-dashed line for a similar one outside the band. The resonant amplication is quickly dominated by source—induced particle production.




FIG.5: The rescaled eld as a function of time for = 10  $^6$  (up) and = 10 (below).

m om enta around a speci c value pj' po: this is param etric resonance [1, 6]. Nonlinear interactions between eld modes then cause this amplication to spread to a broad range of m om enta. We nd that the resulting rate of amplication exceeds the characteristic rate 0 for the resonant growth. This is illustrated in Figs. 3 and 4, where the e ective particle numbers [8] are displayed for various m om enta as a function of time, both for the transverse (G  $_{?}$  ) and the longitudinal (G  $_{k}$  ) sector, with  $G_{ab} = diagfG_k$ ;  $G_?$ ;  $G_?$   $G_?$  Gin contrast to the rapid changes for particle num bers before t<sub>nonpert</sub>, a comparably slow quasistationary evolution takes place at later times. The uctuation dom inated regime for t & tnonpert is characterized by strong nonlinearities. For instance, from Fig. 2 one infers for t' t<sub>nonpert</sub> that the classical eld decay \overshoots" and is temporarily reversed by feed-back from the modes. This can be directly seen in the evolution for the rescaled eld shown in Fig. 5. The particle numbers of Figs. 3 and 4 exhibit correspondingly a reverse behavior. Very sim ilar phenom ena have been observed in related classicaltheories [5], though a direct comparison requires sim ulations for the same model as studied here [12]. There the full nonlinearities, i.e. including all orders in 1=N, are taken into account while leaving out quantum corrections. This indicates the capability of the 2PI 1=N expansion at NLO to capture the dominant nonlinear dynamics.

The characteristic properties described above can be understood analytically from the evolution equations for the Fourier modes of the one—and two-point functions. Separating realand imaginary parts with  $G_{k;?}$  (t;t<sup>0</sup>;p) =  $F_{k;?}$  (t;t<sup>0</sup>;p)  $\frac{i}{2}$   $_{k;?}$  (t;t<sup>0</sup>;p) sign<sub>C</sub> (t  $\frac{t}{2}$ ), the real  $_{k;?}$  denote the spectral and  $F_{k;?}$  the statistical two-point functions [8, 9]. We define

where  $T_{k;?}$  (t) =  $\frac{dp}{(2)^3}F_{k;?}$  (t;t;p) with  $p_0$ . Initially,  $F_k$  (0;0;p) =  $1=2!_k$  (p),  $\theta_tF_k$  (t;0;p) $\dot{j}_{=0} = 0$ ,  $\theta_t\theta_t\circ F_k$  (t;t';p) $\dot{j}_{=t^0=0} = !_k$  (p)=2, and similarly for  $F_?$ .

The frequencies are  $!_k$  (p) =  $[p^2 + M_0^2 (1+3_0^2)]^{1=2}$ ,  $M_0^2 (0)$ , and similarly for  $!_?$  (p) with  $3_0^2 !_0^2$ . The initial conditions for the spectral functions are xed by the equal-time commutation relations:  $k_{;;?}$  (t;  $t^0$ ; p)  $j_{t=t^0} = 0$  and  $0_{t=k_{;;?}}$  (t;  $t^0$ ; p)  $j_{t=t^0} = 1$  [8, 9].

(I) Early-time linear (Lame) regime: parametric resonance. At early times the { eld evolution equation receives the dom inant (0 ( $^{0}$ )) contributions from the classical action S. The classical eld dynamics is characterized by rapid oscillations with constant amplitude and period  $2 = !_0$ . The evolution equations for the two-point functions at 0 (0) correspond to free-eld equations with the addition of a time dependent mass term  $3^{-2}$  (t) for the longitudinal and 2 (t) for the transverse modes. The dynam ics in this linear regim e has been extensively studied in the literature and is known to be described by the solution of a Lam e equation [1, 6]: Param etric resonance m anifests itself by an exponential growth of the statistical two-point functions describing particle production in a narrow m om entum range w ith  $p^2$  $\frac{1}{2}$ . A veraging over  $!_0$  one nds for the transverse the short-time scale m odes for t;t0

for the maximally enhanced mode with  $p_0$  '  $\frac{0}{2}$ . One nds a much smaller growth for the longitudinal modes (cf. also Fig. 4). The analytic solution to 0 (  $^0$ ) agrees accurately with the NLO numerical results at early times.

(II) Source—induced am pli cation regime: enhanced particle production for longitudinal modes. Because of the exponential growth of the transverse uctuations for  $_0\mathsf{t}$  1, the 0 (  $^0$ ) approximation eventually breaks down at some time. Using the two-loop graphs of Fig. 1, at 0 ( ) the evolution equation for F $_k$  can be approximated by

with  $\frac{F}{?}(t;t^0;p) = \frac{R}{dqF_?}(t;t^0;p)$   $q)F_?(t;t^0;q)$ , and  $= \frac{N}{(2^-)^3} \frac{N}{6N} \frac{1}{1_0^2} \frac{c^2}{N}$  with constant c 1. Here, we have used that the momentum integrals are dominated by the amplied transverse modes. In addition, we exploit the fact that, for  $t^{00}$  / t.  $t_{nonpert}$ ,

Its validity can be seen from (3) and the corresponding behavior of  $_{?}$  (t;  $t^{\varpi};p_{0})$  =  $^{\circ}$  (t  $t^{\varpi})$  for  $t^{\varpi}$  . t. We em – phasize that strictly neglecting in the evolution equations <sup>2</sup>-term s as compared to F <sup>2</sup>-term s for all modes and all tim es corresponds to the classical statistical eld theory lim it [9]. This provides an explicit analytic criterion for the applicability of the classicalm ethods employed in [5]. For su ciently early times, all momentum integrals are indeed dom inated by the enhanced modes p'  $p_0$  for which (5) is valid. A detailed analysis reveals that the m em ory integrals appearing in the equations of motion are dominated by the latest times  $t^{00}$  't: One can explicitely verify that e extive locality, described by the replacement  $\int_{0}^{R_{t}} dt^{0}$  !  $\int_{t}^{R_{t}} dt^{0}$  (cf. Eq. (4)), is valid for the tim e-averaged behavior over the short-tim e scale  $!_{\scriptscriptstyle 0}^{\phantom{0}1}$  . W e conclude that classical statistical approxim ations can provide a good description in this regime.

The rst term on the RHS of (4) is a NLO contribution to the mass, whereas the second term represents a source-term, resulting from annihilations of amplied transverse modes as well as stimulated emission processes. To evaluate the momentum integrals, we use a saddle point approximation around p'  $p_0$ , valid for t;  $t^0$  0, with  $F_2$  (t;  $t^0$ ;  $p_0$ )'  $F_2$  (t;  $t^0$ ;  $p_0$ ) exp  $[ j_0^0 j(t+t^0)$  ( $p_0$ )  $p_0$ )2=2]:

Here we wrote the source term for its maximum at p=0. M ore precisely, it a ects all modes with  $p\cdot 2p_0$ . An im-

portant characteristic time is reached when the mass corrections become comparable to the classical mass term. This can be seen to happen at  $t_{\rm nonpert}$  ' (In  $^{-1}$ )=(2  $_0$ ), when T  $_2$  ' O ( $^{-1}$ ) (see also [6]). Note that at this time, both the LO and the NLO mass terms are of the same order in , but with opposite sign. We point out that the source term in (4) becomes important at the earlier time

when  $F_{?}$  (t;t<sup>0</sup>;p<sub>0</sub>) ' O (N <sup>0</sup> <sup>1=2</sup>). For t & t<sub>source</sub>, the exponentially growing source drives the dynam ics of longitudinalm odes and one nds a strong amplication for p. 2p<sub>0</sub>:  $F_k$  (t;t<sup>0</sup>;p) exp[2<sub>0</sub> (t+t<sup>0</sup>)]. This agrees precisely with the numerical results shown in Fig. 4.

(III) Collective ampli cation regime: explosive particle production in a broad momentum range. A similar analysis can be made for the transverse uctuations. The approximate evolution equation for  $F_{\,?}$  has a similar structure as (4). Beyond the O (  $^0$ ) (Lame) description, it receives contributions from the feed-back of the longitudinal modes at O ( ) and from the ampli ed transverses mode at O (  $^2$ ). The corresponding mass corrections remains malluntil  $t_{\rm nonpert}$ , whereas the source term is parametrically of the form  $$^2F_{\,?}^{\,3}=\!\!N$ . This leads to the characteristic time

at which  $F_?$  (t;t<sup>0</sup>;p<sub>0</sub>) ' O (N <sup>1=3</sup> <sup>2=3</sup>). Correspondingly, for  $t_{collect}$ . t.  $t_{nonpert}$  one nds a large particle production rate  $6_0$  for a wide range of m omenta, in agreement with the full N LO results in Fig. 3. In this time range the longitudinal modes exhibit an enhanced amplication as well (cf. Fig. 4). The abundant particle production is accompanied by an exponential decrease of the classicaled energy. We emphasize that the collective amplication regime is absent in the LO large-N approximation. Consequently, even for the transverse sector the latter does not give an accurate description at intermediate times if  $t_{collect}$   $t_{honpert}$ , that is for N .

(IV) Nonperturbative regime: quasistationary evolution. Att'  $t_{\text{nonpert}}$  one nds  $F_{?}$  (t;  $t^{0}$ ;  $p_{0}$ ) ' O (N  $^{0}$   $^{1}$ ).

As a consequence, there are leading contributions ( to the dynamics coming from all loop orders (cf. Fig. 1). In particular, the evolution equations are no longer \bcal" in the sense described under (II) and memory effects become important. In contrast to the rapid resonant dynam ics before tnonpert, a comparably slow, quasistationary evolution driven by direct scattering sets in. We emphasize that the collective amplication regime triggered a rapid approach to monotonously decreasing particle num ber distributions as functions of m om entum, which become quasistationary afterwards (cf. Figs. 3, 4). The approach to true therm alequilibrium is exceedingly slow for the employed range of couplings =  $10^{-6}$ for which a non-negligible parametric resonance regime can be observed. For phenom enological applications it is therefore crucial that in the quasistationary, pre-them al regim e in the spirit of Refs. [2, 12] a num ber of aspects do not dier much from the late-time thermal regime [13].
