## Phonons and gluons in the crystalline color superconducting phase of Q C D

#### A bstract

The High Density E ective Theory formalism is used to calculate the low energy properties of the phonons and gluons in the Larkin-O vchinnikov-Fulde-Ferrell (LOFF) phase of two-avor QCD. The effective phonon Lagrangian for the cubic crystal structure, which is favored according to a recent study, depends, at the second order in the derivatives, on three parameters which we calculate in this paper. We also compute for soft momenta the elective lagrangian for the gluons of the unbroken SU (2)c group, both for a single plane wave structure and for the cube. In both cases the Meissner gluon mass vanishes as in the case of complete isotropy; on the other hand there is a partial Debye screening due to the existence of blocking regions on the Ferm ispheres. For the single plane wave structure the gluon dielectric tensor is non isotropic, while it is isotropic for the cubic crystal, in spite of the intrinsic anisotropy of the structure.

#### 1 Introduction

The study of the color superconducting phases of QCD [1] [2] has recently received much attention and is at the moment one of the most studied frontier

problem of QCD [3]. Cold QCD with three degenerate avors, for very large values of the quark number chemical potential , is in the so-called coloravor locked (CFL) phase [4]. In this phase, pairs of quarks of opposite momenta, each of them lying near the Fermi surface, condense according to the BCS pairing scheme known from ordinary superconductivity.

The CFL phase is expected to persist also below asymptotic values of , when the avor degeneracy is broken, with the strange quark having a larger mass than the lighter quarks. In absence of electrons, the CFL phase is electrically neutral. It has the same number of u, d, and s quarks, which corresponds to the lowest energy for the Cooper pairs.

When the value of is further decreased, one expects that pairing between quarks of non vanishing total momentum becomes possible. Each quark momentum will lie near its Fermi surface (Fermi spheres will now be of dierent radii) [5,6,7,8,9]. Closeness to their Fermi surfaces for both quarks in the pair will correspond to a lower free energy. Such a possibility for the quark pairing leads to the suggestion of a crystalline color superconductivity [5,6,7,8,9]. We assume the existence of this phase and we will limit our analysis, as in the existing literature, to two avors, with [6,0]0 (the dierence in the quark chemical potentials).

In certain condensed matter systems (ferrom agnetic systems with paramagnetic impurities) [10] the possibility of ferm ion pairing of non vanishing total momentum had already been discussed. The name LOFF phase is therefore commonly used, formed from the initials of the authors of ref. [10].

Translational and rotational invariance are spontaneously broken within a LOFF phase. The gaps are expected to vary according to some crystalline structure. The determination of such a structure is obviously of the uppermost importance and this problem is discussed and approximately solved by Bowers and Rajagopal [11] in a recent paper. To understand the crystalline superconductivity one has indeed to know the space dependence of the Cooper pair condensate. A simple plane wave ansatz had been used for a preliminary understanding of the possible dynamics. The plane wave has the nitemomentum of the Cooper pairs, on the assumption that all the possible Cooper pairmomenta choose a unique direction. These studies (see [5] and [10]) already lead to the conclusion that LOFF pairing is favored, over BCS pairing or absence of pairing, within a certain window in . The window starts with a rst order phase transition to the crystalline phase. It ends with a second order transition where translation invariance is restored. The window for QCD with two avors had been found in ref. [5] by modeling

quark interactions via four-linear Ferm i couplings am ong quarks and for the case of a plane-wave condensate structure. A much wider window is found however in a model based on gluon exchange [8]. This follows essentially from the fact that gluon exchange favors forward scattering, rather than the s-wave scattering typical of the Ferm i couplings. The elective low energy phonon lagrangian for the case of the single plane wave structure has been discussed in [7]. Since translation invariance is only partially broken one phonon is present.

A comprehensive study of the dierent possible crystal structures for the crystalline color superconducting phase of QCD is presented in [11] where the authors perform a Ginzburg-Landau expansion in the vicinity of the phase transition. Instead of the single plane wave ansatz they now introduce a multiple plane wave ansatz and nd that a face-centered cubic crystal is favored. This structure is built up by eight plane waves directed to the comers of a cube. At least qualitatively it seems true that the cubic crystal remains the favored structure also in complete QCD (although not perhaps at very asymptotic densities). It is important to note that for the cubic crystal structure three phonons should be present since translational invariance is completely broken.

The crystalline color superconductivity has a relevant place in the QCD phase diagram and as such it deserves to be studied and to be known in its main features. Moreover it can play a role in the physics of compact stellar systems where, within the core, a crystalline phase might be reached. The authors of ref. [5] had already pointed out that, if the compact star is rotating, the ensuing rotational vortices may become pinned and as such play a role in the formation of glitches. This subject is certainly interesting, but we shall not discuss it here (for a review see ref. [12]).

We have already mentioned that crystalline superconductivity had initially been proposed in condensed matter physics. The QCD studies, in particular also the present one, may be translated into corresponding properties for condensed systems, at least for the phonon properties. We mention in particular the eld of atom ic systems, gases of fermionic atoms below their Fermitem perature [13], [14]. An advantage of testing the ideas of crystalline superconductivity on these systems is that their parameter space is less rigid than for QCD. For example see ref. [15].

The plan of the present work is as follows. In section 2 we rst brie y review the form alism we will use in this paper, i.e. the High Density E ective Theory (HDET). This e ective theory is based on the limit! 1 and uses

velocity dependent elds in the same spirit of the Heavy Quark E ective Theory (HQET) [16] where the lim it m<sub>Q</sub> ! 1 is taken. It is discussed in [17, 18, 19] and more extensively in ref. [20], where the method and the notations are explained in more detail. In section 3 we discuss the low energy dynam ics of the phonons. In section 4 we calculate the parameters of the e ective phonon lagrangian. In section 5 we study the properties of the gluons of the unbroken SU (2)<sub>c</sub> for the case of the plane wave structure and in section 6 we perform the same calculation for the LOFF condensate with the cubic sym metry. The application to the cubic crystal structure requires some group theoretical de nitions which are sum marized in Appendix 1. In Appendix 2 and 3 we report some details of the calculations.

# 2 Heavy Density E ective Theory in the LOFF phase

We begin with the elective lagrangian of HDET for gluons and ungapped massless quarks. If  $L_0$  is the free quark lagrangian and  $L_1$  represents the coupling of quarks to one gluon, the high density elective lagrangian can be written as

The other velocity-dependent eld  $_{\forall}$  is obtained from  $_{+}$  by the change  $\forall$  !  $\forall$ . Therefore the average over the Ferm i velocities is de ned as follows:

The extra factor  $\frac{1}{2}$  is introduced because, after the introduction of the eld with opposite velocity , one doubles the degrees of freedom, which implies that the integration is only over half solid angle.

The e ective lagrangian (1) is obtained in the lim it  $\,!\,$  1 [17, 18, 19, 20]. Therefore  $L_0$  and  $L_1$  do not contain the chem ical potential because the dependence on  $\,$  has been extracted from the quark  $\,$  eld operators. We also note that one has a single sum over the velocities, because the quark  $\,$  elds are evaluated at the same Ferm i velocity; as a matter of fact the  $\,$  -diagonal term  $\,$ s are cancelled by the rapid oscillations of the exponential factor in the  $\,$ ! 1  $\,$  lim it. This point  $\,$  will be discussed in a more detailed way in the sequel.

Besides  $L_0$  and  $L_1$  eq.(1) contains the term

to any number of gluons and gives contribution to the gluon M eissner m ass  $(\infty)$  below). We have put

This construction is valid for any theory describing massless ferm ions at high density provided one excludes degrees of freedom far from the Ferm i surface. Let us now exam ine the modication in the formalism in the presence of a LOFF condensate; to begin with we consider the approximation of one plane wave. The two factors = R arising from the x and y components are absorbed into a wave function renormalization of the quark elds, both in the kinetic and in the gap term s. As for the z component one remains with the factor

in the gap term, whereas for the kinetic term we get a factor of 1.

As we noted already, in ref. [21] we used as a sm earing function  $g_{\rm I}$  (see eq. (19)) and  $_{\rm R}$  turned out to be given by

Both eqns. (33) and (23) de ne regions where  $_R \notin 0$ , i.e. de ne domains where pairing between the two quarks can occur; they correspond to the pairing region (in contrast with the blocking region, where  $_R = 0$ ), using the term inology of [4]. However, given the results of [11], which show that the di erent sections of the pairing domain for the LOFF cubic structure are non-overlapping, we prefer to choose the prescription (21) and, consequently, eq.

(23) for  $_R$ . We explicitly observe that, owing to (30), with x = v n = cos, eq. (23) de nes a 'ring' on the Ferm isphere. Our approximation consists in putting exp [i2qhz] = 1 in eq. (31), owing to the presence of  $_R$  that enhances the domain of integration where h = 0, for R su ciently large.

Let us discuss the range of values of  $R^1$  for the plane wave ansatz in more detail. We notice that R=1 implies the vanishing of the pairing region. The precise value of R could be xed by the gap equation. For instance, by using the fact that near the second order phase transition the pairing region has an angular width of order = (see for a discussion [11]), from the de nition of R we not (for ! 0)

These form ulae can be easily generalized to the case of the face centered cube [11]. This is characterized by eight  $q_j$  vectors with equal length q== and directions corresponding to the eight vertices of a cube.




Fig. 1 – The gure shows some of the symmetry axes of the cube, denoted as  $C_2$ ,  $C_3$  and  $C_4$  (see the appendix for details). We show also the parameterization used for the coordinates of the vertices.

In Fig. 1 som e of the symmetry axes of this cube are shown: they are denoted as  $C_4$  (the three 4-fold axes),  $C_3$  (the four 3-fold axes) and  $C_2$  (the

six 2-fold axes). For more details on the symmetry group of the cube see Appendix 1 and [22]. The space dependence of the condensate corresponding to this lattice is as follows

An interesting point can be noted in connection with eq. (51). This equation shows that the pairing region for the cubic LOFF condensate is formed by eight distinct rings; each ring is associated to one vertex of the cube and has as its symmetry axis one of the  $C_3$  axes of g.1.A coording to the analysis of [11] the LOFF vacuum state corresponds to a situation where these domains have at most one common point. Given the symmetry of the cubic structure we can limit the analysis to one pair of rings, for example those associated to the vertices  $n_1$ ;  $n_5$  in g.1. The common point between these two rings lies on the axis  $C_2$  of g.1 and has  $v = \frac{1}{p-1}(1;1;0)$ : Since it must also belong to the boundary of the two pairing regions we have the condition (23):

### 3 Phonons in a cubic LOFF crystal

The condensate (45) breaks both translations and rotations. It is however invariant under the discrete group  $0_h$ , the sym m etry group of the cube. This can be seen by noticing that the condensate is invariant under the following coordinate transform ations

that is rotations of =2 around the coordinate axes, and the inversion with respect to the origin. Since the group  $O_h$  is generated by the previous 4 elements (see Appendix 1) the invariance follows at once.

The crystal de ned by the condensate (45) can uctuate and its local deform ations de ne three phonon elds <sup>(i)</sup> that are the Nambu-Goldstone bosons associated to the breaking of the translational symmetry. They can be form ally introduced by the substitution in (45)

All these considerations become super uous when one realizes that we are actually interested in an elective description of the elds  $k_1, k_2, k_3$  in the low energy  $k_1, k_2$

Integrating out the Ferm i degrees of freedom one gets an e ective lagrangian containing only the light degrees of freedom, i.e. the gluons of the unbroken subgroup SU  $(2)_c$  and the phonons. We will discuss gluons in Section 6 and we consider here only the phonon e ective lagrangian.

The e ective lagrangian for the elds  $^{(i)}$  has to enjoy the following symmetries: rotational and translational invariance;  $O_h$  symmetry on the elds  $^{(i)}$ . The latter requirement follows from the invariance of the coupling (65) under the group  $O_h$  acting upon  $^{(i)}$ . The phonon elds  $^{(i)}$ (x) and the coordinates  $x^i$  must transform under the diagonal discrete group obtained from the direct product of the rotation group acting over the coordinates and the  $O_h$  group acting over  $^{(i)}$ (x). This is indeed the symmetry left after the breaking of translational and rotational invariance.

In order to build up the e ective lagrangian, we start noticing that if X  $_{\rm i}$  are quantities transform ing as the same representation of the  $^{\rm (i)}$ 's under O  $_{\rm h}$  (a 3-dim ensional representation), then all the invariant expressions can be obtained by the following three basic invariant expressions




Fig. 2. Self-energy (a) and tadpole (b) diagram s.

The e ective theory depends on three arbitrary parameters, a result that follows also from the general theory of the propagation of elastic waves in crystals [24].

# 4 Param eters of the e ective lagrangian for the phonon elds

In this Section we will compute the parameters a; b; c appearing in (69). We use the gradient expansion. First we introduce external elds with the same quantum numbers of the NGB's and then we perform a derivative expansion of the generating functional. This gives rise to the elective action for the NGB. At the lowest order one has to consider the diagrams in Fig. 2, i.e. the self-energy, Fig. 2a, and the tadpole, Fig. 2b. The diagrams can be computed observing that, by expanding (65) in the phonon elds, one has

Both terms in the rhs. of eq. (76) present a double sum: m ; k = 1; ...; 8 (see eq. (51) for  $_{\rm eff}$ ); we have seen at the end of section 2 that the eight rings that de ne the pairing region are non overlapping. Therefore only the terms with m = k survive and one immediately veri es the validity of the Goldstone's theorem. i.e. the vanishing of (76). Notice that in our approximation the masses of the Goldstone bosons vanish only if the pairing regions are not overlapping, signaling that when the regions overlap we are not at the minimum of the free-energy (see [11]).

One can note that these values for the parameters of the phonon e ective lagrangian satisfy the positivity constraints found in [23].

In [23] one can indicate the general discussion of the dispersion relation for arbitrary values of the parameters a, b and c. In the present paper we give the expression for the eigenvalues of  $E^2$ , according to the direction of propagation of the momentum p, in table 1.

# 5 Gluon dynamics in the the LOFF phase: single plane wave structure

In this Section and in the subsequent one we wish to derive the e ective lagragian for the gluons of the unbroken SU (2)<sub>c</sub> subgroup of the two- avor LOFF phase. To start with we review the results obtained for the gluon e ective lagrangian at one-loop in the 2SC isotropic phase [5]. They were obtained in [25]; in [26] the results of [25] were obtained by the method of the High Density E ective Theory and extended to the three-gluon and four-gluon vertices. In the 2SC phase one considers massless quarks of two dierent avors at the same chemical potential and at low temperature. Color superconductivity breaks the color group SU (3)<sub>c</sub> down to a SU (2)<sub>c</sub> subgroup and the quarks with nontrivial SU (2)<sub>c</sub> charges acquire a gap  $_{0}$ . Therefore only the three gluons relative to the generators of the unbroken subgroup remain massless.

The lagrangian including one loop corrections for the SU  $(2)_c$  gluons can be written as [25], [26]

It is interesting to note that, in absence of LOFF pairing, i.e. if the pairing region vanishes and  $\cos_a = \cos_b$ , one gets for the M eissner and D ebye m ass the same results obtained in the hard dense loop approximation for the model with two avors in the normal (not superconducting) state, see e.g. [27]. On the other hand if the blocking region vanishes ( $\cos_a = 1$ ,  $\cos_b = +1$ ) one is in the 2SC phase and eq. (105) gives  $m_D = 0$  as expected.

Next consider <sub>ab</sub> (p). The contribution of the blocking region vanishes as discussed in Appendix 3. Therefore the only non vanishing contribution

to  $_{ab}$  (p) comes from the pairing region. It could be computed exactly, but the corresponding expressions are cumbersome and shed little light on the underlying physics. Therefore we prefer to work in the approximation of smallmomenta ( $\dot{p}$  $\dot{j}$ ). We nd






Fig. 3 P lots of the functions f(R) and g(R).

total m om entum of the Cooper pairs along the z direction. Therefore we distinguish the dielectric constant along the z axis, which is

# 6 Gluon dynamics in the LOFF phase: cubic structure

The condensate in this case is given by eq. (45), so that we will use the results of sec. 2 with  $_{\rm eff}$  given by (51). The calculations are similar to the previous case and, similarly, the SU (2) gluons have vanishing M eissner mass and exhibit partial Debye screening. However the dispersion law of the gluons is dierent.

As a m atter of fact we write the one loop lagrangian for the SU (2)  $_{\rm c}$  gluons as

where  $\cos_{a,b}$  are solutions of eq. (106). It should also be noted that the values of the param eter R for the cube and the plane wave can be di erent.

The isotropy of these results can be easily understood noticing that  $\ L$  is a symmetric function of its arguments. As a matter of fact it must be symmetric under the residual symmetry  $O_h$  and therefore it must be built up from the three elementary symmetric functions  $I_2$  ( $X_i$ ),  $I_4$  ( $X_i$ ) and  $I_6$  ( $X_i$ ), defined in eq. (66), with  $X_i = E_i^a$ . The invariance of L follows from the invariance of these functions under the three elementary rotations  $R_i$  and the inversion I. However it is clear from (125) that L is second-order in  $E_a^i$  and therefore the only function that can be involved is  $I_2$ . In conclusion in the cubic lattice one necessarily gets




Fig. 4 P lot of the function t(R).

We nally note that, even if the crystalline structure is not isotropic, in eq. (126) the O (3) invariance is restored. This happens because the tensor  $\gamma_{ij}$  is proportional to the identity. Therefore the dielectric properties of the medium will be isotropic and the velocity of propagation of the gluons will be the same in all the directions. We stress that these results are valid in the approximation of soft gluon momenta.

#### 7 Conclusions

We have used the High Density E ective Theory (HDET) form alism to calculate the low energy properties of phonons and gluons in the LOFF phase of QCD. The HDET form alism is very useful to simplify the dynamics as it allows direct elimination of the degrees of freedom which are far from the Ferm i surface. It bears useful resemblances with the Heavy Quark E ective Theory of general use when dealing with heavy hadrons. We have rst made the modication for the case of a single plane wave condensate and we have derived the quark propagators. After that we have gone to the relevant case of the cubic structure of ref. [11] corresponding to the sum of eight plane waves. We have added the suitable term in the Lagrangian bearing the sum over the eight plane waves of the cubic structure and derived for this more complex case the quark propagators to be used in the calculations.

The three phonons correspond to the local deform ations from the uctuations of the crystal as de ned by the cubic condensate. They are the Nambu-Goldstone bosons from the breaking of translational symmetry. We have studied the low energy limit, where wavelengths are much longer than lattice spacing, and built up an elective lagrangian for the phonons, which, at the second order in the derivatives, depends on three parameters, in agreement with the general theory of the elastic waves in crystals [24].

The param eters of the e ective phonon lagrangian are calculated by introducing external elds with the phonon quantum numbers and performing the derivative expansion of the generating functional. The phonons remain massless, as expected. The nal results for the param eters are remarkably simple, the only quantity appearing in the result being the ratio of to the common length of the eight wave vectors appearing in the condensate.

We have also derived the elective lagrangian of the gluons of the unbroken SU (2)<sub>c</sub> subgroup. The gluon self energy diagrams at one loop can be evaluated from the derived elective action. The Meissner mass vanishes as in the case of complete isotropy; on the other hand there is a partial Debye screening originating from the existence of blocking regions on the Ferm is spheres. For soft gluon momenta, in the case of a single plane wave, the dielectric constant of the medium is non isotropic and it takes on dierent values according to its direction; also the gluon velocity is anisotropic. In the case of the cubic crystal the gluon dispersion law for small momenta is however isotropic. It is interesting to remark that at least for gluon long wavelengths, the essential anisotropy of the cubic structure is washed out,

while it remains visible for the plane wave crystal structure.

four 3-fold axes, denoted as G in Fig. 1;

six 2-fold axes, denoted as G in Fig. 1.
