Particle oscillations in external chaotic elds

We review here the development of the general formalism for the study of fermion propagation in the presence of stochastic media. This formalism allows the systematic derivation of evolution equations for averaged quantities as survival probabilities and higher order distribution moments. The formalism equally applies to any nite dimensional Schrodinger equation in the presence of a stochastic external eld. New integrodimential equations valid for nite correlated processes are obtained for the rest time. For the particular case of exponentially correlated processes a second order ordinary equation is obtained. As a consequence, the Red eld equation valid for Gaussian delta-correlated noise is rederived in a simple way: it has been obtained directly and as the zero-order term of an asymptotic expansion in the inverse of the correlation length. The formalism, together with the quantum correlation theorem is applied to the computation of higher moments and correlation functions. It is shown that equal and unequal time correlators follow similar differential equations.

1. IN TRODUCTION

We review here the general form alism for the study of neutrino propagation in the presence of stochastic media [1]. This form alism will allow the system atic derivation of evolution equations for averaged quantities as survival probabilities and higher order moments of them. New integrodi erential equations valid for nite correlation processes are obtained for the rest time. For exponentially correlated processes a second order ordinary equation is obtained as a consequence. The Red eld equation valid for Gaussian delta-correlated noise is rederived in a simple way as a particular case: it can be obtained directly or as the zero-order term of an asymptotic expansion in the inverse of the correlation length. In the context of neutrino oscillations, it is shown that the presence of matter noise induces the appearance of a elective complex part in the matter density. Finally the formalism, together with the quantum correlation theorem, will be applied to the problem of the computation of distribution higher moments and non-equal-time correlation functions.

The form alism may be applied to any quantum system governed by similar Schrodinger equations: equations where a stochastic function appears multiplicatively in some part of the Hamiltonian. For simplicity of notation, in this work we will always deal with Hamiltonians which are nited in ensional operators in some Hilbert space, the equations will be obviously of the same type for general systems described by in nite-dimensional Hamiltonians.

2. THE GENERAL CASE

Let us consider a general system whose evolution is described by the following linear random Schrodinger equation:

$$i\theta_t X = (t) L(t) X; X(0) = X_0;$$

where X is a vector (i.e., a multi avor wave function) or a matrix (i.e., a density matrix) of arbitrary dimension. Equation (1) is defined in an interaction representation, any additive non-stochastic term has been solved for and absorbed in the definitions of X (t) and L (t). L (t) is a general linear operator. It can be an ordinary matrix if X represents a wave function. If X is a density matrix, L (t) is a commutator:

Any other linear operator is admissible: obviously it is always possible to de ne an enlarged vector space where the action of L is represented by a matrix.

We will assume that (t) in Eq.(1) is a scalar Gaussian process completely determined by its rst two moments, which, without loss of generality can be taken as

In other term s, (t) is characterized completely by the measure

An important particular case is when the process is -correlated, the correlation function is then of the form

$$f(t;t^0) = {}^2 jt t^0 j:$$

A convenient way of parametrizing a correlation function with a nite correlation length is to use an exponential function:

$$f(t;t^0) = {}^2 \exp jt t^0 j :$$

In this case the correlation length is de ned as = 1 = . The expression (5) is reobtained letting ! 0 or ! 1 in Eq.(6).

X (t), the solution to Eq.(1), is a stochastic function. The objective of this work is to obtain equations for its ensemble average and higher moments in a systematic way. Let us remark that for us Eq.(1) is purely phenomenological, we assume that it is the result of a more complete microscopic analysis which can account for the randomness of (t) (see for example, Refs.[8,11,19,20]).

To obtain a di erential equation for the average of X we make use of the following well known property: For any Gaussian process (t) characterized by a -correlation function (6) and any functional F [] we have the following relation [12]:

For a Gaussian process with an arbitrary correlation function [Eq. (4)] we have instead the general relation:

Let us consider now the evolution operator U for a particular realization of Eq.(1). By de nition,

The operator U $(t;t_0)$ is a functional of , it has the following form all expression in terms of a time ordered exponential:

The functional derivative of U with respect to (t) can be computed by direct methods. By dierentiating term by term the series expansion for Eq.(10), the result is

In order to obtain a di erential equation for hX i we observe that

$$ih\theta_t X i = i\theta_t h X i = L (t)h (t)X i;$$

Combining together Eqs. (8), (9), (11) we easily obtain the result that the evolution equation for the ensemble average is in the general case an integrod i erential equation given by

$$i\theta_t hX (t)i = i \int_0^{Z_t} dt^0 f(t;t^0)L(t)L(t^0)hX(t^0)i; hX(0)i = X_0;$$
 (13)

This equation, which is exact and of very general validity, is the equation which we were looking for and one of the main results of the present work. Note that previously integrodi erential equations have been obtained, valid for particular cases or in particular limits, using heuristic ad hoc arguments (for example, in Ref. [10]). The derivation of Eq.(13) which has been done here is the rigorous justication for such approaches.

In some notable cases Eq.(13) can be reduced to an ordinary dierential equation. In the next sections we will see how it can be reduced to, respectively, rst and second order equations for the correlation functions given by Eqs. (5) and (6).

3. THE PARTICULAR -CORRELATED CASE

For the particular case where the correlation function is of exponential type, a second order ordinary di erential equation can be obtained as we will see below. On the other hand, for the simpler -correlated case the evolution equation (13) becomes the ordinary dierential equation

Taking L as a commutator, this last equation coincides with the Red eld equation derived by Ref. [3]. Note that the elective "Ham iltonian" appearing in the second part of Eq. (14) is not Herm itic anymore (an example of a uctuation-dissipation elect).

In cases of interest for the neutrino oscillation problem , the original equation for the density m atrix is of the slightly $\sin p \ln p$

where we have written the commutator explicitly. (t) is a stochastic function as before and g(t) an arbitrary scalar function. H $_0$; H $_1$ are H am iltonian m atrices, the former contains the

average part of (t): H_0 H_0^0 (t) + H_0^0 (t) H_0 with H_0^0 = h i. The latter is assumed to be time independent.

For the problem described by Eq. (15) the corresponding Red eld equation for the averaged density matrix is of the form

where in the last line the following e ective H am iltonians were de ned:

The solution of what is called the \coherent" part of Eq. (17) (two rst terms of the Hamiltonian) is accomplished by dening the average evolution operator:

The coherent part of the density matrix is then

$$hX i_{coh} = U X_0 U^{+ Y}; (19)$$

De ning a new \coherent" interaction representation by the relations

we arrive at the equation we were looking for, the resolution of the original equation is equivalent to the resolution of the following one:

$$i\theta_t hX i_T = 2i^2 g^2 (t) H_L hX i_T H_R$$

There are some important particular cases where Eq. (14) can be solved or considerably simplied by taking into account the algebraic properties of a specic L (in what followsk(t) is always a scalar function).

(a) Let us assume that L is such that L^2 (t) = k (t)L (t). This case appears in the computation of the average wave function with matter density noise. Equation (14) reduces to

The averaged equation is similar to the original one, the nonrandom part of the density is \renormalized" acquiring an imaginary term

This is the density which will appear in the coherent elective H amiltonians H $_{\scriptscriptstyle 0}$.

(b) The case where L^2 (t) = k (t)I with I the identity matrix appears in the computation of the averaged neutrino wave function under noisy magnetic spin-avor precession. The resulting equation can trivially be integrated (to be compared with the previous case):

The average wave oscillation is damped by a factor equivalent to the one rst calculated by Nicolaidis [2]. A similar damping also appears when computing the average density matrix

from Eq. (21). From these di erences of behavior with respect to case (a) it is expected that the presence of magnetic eld noise can have some in uence even if applied far from any resonance region.

(c) The case where L^4 (t) = $k(t)L^2$ (t) appears in the computation of the average density m atrix with matter or magnetic noise. We can obtain in this case the \conservation law"

 L^{2} (t) is not invertible because the operator L (t) has a zero eigenvalue. The previous expression has proved to be of practical in portance in som e concrete num erical applications [13, 14, 15].

The presence of zero eigenvalues distinguishes cases (a) and (b) from (c); it can have consequences in the long term behavior of the respective ensemble averages as is shown elsewhere [16].

4. AN ASYMPTOTIC EXPANSION FOR EXPONENTIALLY CORRELATED SYSTEM S

We will see now how Eq. (14) can be obtained as a limiting case when the correlation length tends to zero. For this purpose we use an exponential correlation function as Eq. (6), the integrodi erential evolution equation becom es in this case

$$i\theta_t hX (t)i = i^2 \exp(t) \int_0^{Z_t} dt^0 \exp(t) L(t) L(t^0) hX(t^0) i;$$

Let us compute the asymptotic expansion of the second term of Eq. (22) valid for large; the following expansion is valid for any function g(t):

Inserting this expression into Eq. (22), we obtain the following expansion in powers of:

$$i\theta_t hX i = i^2 L^2 (t) hX i + i - L (t) \theta_t (L (t) hX i) + o \frac{1}{2}$$

To leading order in 1=, we recover the expression corresponding to the -correlated case. At next-to-leading order we get nite-correlation correction terms

$$iQ_thX i = i^2L^2(t)hX i + i - L(t)L^0(t)hX i + i - L^2(t)Q_thX i$$

or, equivalently,

Finally, We get the following dierential equation valid to order 1=, making the assumption that the operator which multiplies the left term is invertible:

This equation can be used for nite, but relatively large, correlation lengths. We see that, up to this degree of approximation, not only the ratio level of noise to correlation length (2 =) is im portant. We have dierent regimes according to the value of 2. The rst term will be more important for a low noise amplitude ($^2 << 1$). For strong noise ($^2 >> 1$) the second term, proportional in this case to L4, will dom in ate.

5. AN EXACT DIFFERENTIAL EQUATION FOR EXPONENTIALLY CORRE-LATED SYSTEMS

In contrast with the approxim at approach used in the previous section, we can actually derive a simple, ordinary second order differential equation for the case of exponential correlation. Let us assume that the original equation is of the same decomposable type as the one appearing in Eq. (15) but let us include other cases using the general notation

$$i\theta_t X = (L_0(t) + (t)g(t)L_1)X; X(0) = X_0;$$
 (28)

with L_0 ; L_1 general linear operators as before, the latter time independent. In this case Eq. (13) is of the form

$$i\theta_t hX i = L_0(t) hX i \quad i^2 L_1^2 e^{-t} g(t) \int_0^{Z_t} dt^0 g(t^0) e^{t^0} hX(t^0) i;$$
(29)

D i erentiating the equation once and perform ing some simple algebra we obtain the following ordinary second order dierential equation:

with

(t) +
$$g^0(t)=g(t)$$
:

Let us remark that this equation is exact and probably the most important result of this work from a practical point of view.

6. HIGHER ORDER MOMENTS AND THE QUANTUM REGRESSION THE-OREM

Second order distribution m oments, expressions of the type hX $_i$ X $_j$ i, or in general, m oments of any order, can also be computed using equations similar to Eq. (13). The straightforward procedure is to de neproducts X $_{ij} = _k X _i X _j _k X$ and write dierential equations for them using the constitutive equations for each of the X $_i$. The resulting equations are of the same type as Eq. (1). The similarity is obvious when one adopts a tensorial notation and denes products of the form X $^{(n)} = X$ X: The task of obtaining evolution equations is especially simple within this notation.

Correlators of quantities at di erent times also appear in the computation of averages of quantities of physical interest, i.e., expected signal rates. In the most simple case expressions of the type hX $_{\rm i}$ (t) i. We will shortly show that the knowledge of equal-time moments and the application of the quantum correlation theorem is su cient for the computation of this kind of correlators.

Our objective now is the computation of the correlation function appearing in two steps. First we dene the generalized density matrix $X^{(2)}$ as the tensorial product of usual density matrices at two dierent times and energies:

The average of the element hX $_{1111}^{(2)}$ i = hX $_{11}$ X $_{11}i$ is evidently the probability correlation function we are looking for.

The di erential equation for the equal time function $X^{(2)}$ (E₁; E₂; t; t) is obtained from the individual evolution equations for the matrices $X_{1;2}$ X (E_{1;2}) [indices (1,2) label expressions where E₁; E₂ appear respectively]

Equation (32) is a random linear dierential equation, linear in the stochastic variable (t). Applying the form alism developed in the previous section, we can immediately write the equation for the ensemble average hX $^{(2)}$ i Eqs. (13{14}). Once we know the equal time correlator, we obtain the expression for any other pair (t;t⁰) using the quantum regression theorem [18] which reads as follows. For any vector Markov process Y, if the ensemble average of Y fulls a Schrodinger-like equation of the type

with G (t) an arbitrary matrix, then the second order correlations will obey the following equation:

$$0 \ hY_{i}(t+)Y_{l}(t)i = X G_{ij}()hY_{j}(t+)Y_{l}(t)i;$$

Note that the quantum regression theorem is in principle not applicable to systems described by the integral equation Eq. (13). Nevertheless it is applicable to problems where the integral equation can be reduced to an ordinary dierential equation such as Eq. (30). Such a second order equation can easily be expressed as a rst order one by dening the auxiliary pair process $Y = (X; \theta_{t} X)$.

For the sim plest case where is a correlated process the equation for non-equal time correlators is explicitly given by

$$i@ hX^{(2)}(t+ ;t)i = i^2L^2()hX^{(2)}(t+ ;t)i;$$
 (35)

The initial condition, $X^{(2)}$ (t;t), is the equal time correlator previously obtained. For exponentially correlated problems second order equations similar to Eq. (30) can immediately be obtained.

7. CONCLUSIONS AND FINAL REMARKS

In conclusion, in this work we have developed the general form alism for the study of neutrino propagation in stochastic media. This form alism has allowed the system atic derivation of evolution equations for averaged quantities as survival probabilities and higher order moments of them. New integrodi erential equations valid for nite correlation processes have been obtained for the rst time. For exponentially correlated processes a second order ordinary equation is obtained as a consequence. The Red eld equation valid for Gaussian—correlated noise is rederived in a simple way: it has been obtained directly and as the zero-order term of an asymptotic expansion in the inverse of the correlation length.

The form alism can be generalized in an obvious way to obtain the ensemble average of equations of a slightly m ore general type than Eq. (1), equations of the form

$$i \theta_t X = \int_{i}^{X} (t) L_i(t) X; X(0) = X_0;$$

These equations appear, for example, in the chaotic neutrino magnetic precession. The result for the case where the $\,_{\rm i}$ are $\,$ -correlated in time but mutually uncorrelated is simply

$$i\theta_t hX$$
 (t) $i = i \int_{i}^{X} L_i^2(t) hX$ (t) i : (37)

The generalization to continuous Schrodinger equations in the presence of random potentials or random external forces is also obvious if we leave aside the m athem atical dierences coming from the appearance of in nite-dimensional Hilbert spaces. The formalism is of general application to any quantum system governed by similar Schrodinger equations: equations where a stochastic function appears multiplicatively in some term of the Hamiltonian.
