# $P$ article oscillations in external chaotic elds

W e review here the developm ent of the general form alism for the study of ferm ion propagation in the presence of stochastic $m$ edia. This form alism allow s the system atic derivation ofevolution equations for averaged quantities as survivalprobabilities and higher order distribution $m$ om ents. The form alism equally applies to any nite dim ensionalSchrodinger equation in the presence of a stochastic extemal eld. New integrodi erential equations valid for nite correlated processes are obtained for the rst tim e. For the particular case of exponentially correlated processes a second order ordinary equation is obtained. A s a consequence, the $R$ ed eld equation valid for $G$ aussian delta-correlated noise is rederived in a sim ple way: it has been obtained directly and as the zero-order term of an asym ptotic expansion in the inverse of the correlation length. $T$ he form alism, together w ith the quantum correlation theorem is applied to the com putation of higher $m$ om ents and correlation functions. It is show $n$ that equal and unequaltim e correlators follow sim ilar di erential equations.

## 1. IN TRODUCTION

W e review here the general form alism for the study of neutrino propagation in the presence of stochastic $m$ edia ['111]. $T$ his form alism $w$ ill allow the system atic derivation of evolution equations for averaged quantities as survival probabilities and higher order $m$ om ents of them . N ew integrodi erential equations valid for nite correlation processes are obtained for the rst tim e. For exponentially correlated processes a second order ordinary equation is obtained as a consequence. The Red eld equation valid for $G$ aussian delta-correlated noise is rederived in a sim ple w ay as a particular case: it can be obtained directly or as the zero-order term of an asym ptotic expansion in the inverse of the correlation length. In the context of neutrino oscillations, it is show $n$ that the presence ofm atter noise induces the appearance of a e ective com plex part in the $m$ atter density. Finally the form alism, together $w$ ith the quantum correlation theorem, will be applied to the problem of the com putation of distribution higher $m$ om ents and non-equal-tim e correlation functions.

The form alism $m$ ay be applied to any quantum system govemed by sim ilar Schrodinger equations: equations w here a stochastic fiunction appears multiplicatively in som e part of the H am iltonian. For sim plicity of notation, in this work we will alw ays dealw ith H am iltonians which are nite dim ensional operators in som e H ilbert space, the equations w ill be obviously of the sam e type for general system s described by in nite-dim ensional H am ittonians.

## 2. THE GENERALCASE

Let us consider a general system whose evolution is described by the follow ing linear random Schrodinger equation:

Equation ( $(\overline{1} 1)$ is de ned in an interaction representation, any additive nonstochastic term has been solved for and absorbed in the de nitions of $X(t)$ and $L(t)$. L ( $t$ ) is a general linear operator. It can be an ordinary $m$ atrix if $X$ represents a $w$ ave function. If $X$ is a density $m$ atrix, $L(t)$ is a com $m$ utator:

A ny other linear operator is adm issible: obviously it is alw ays possible to de ne an en larged vector space where the action of $L$ is represented by a $m$ atrix.

W e w ill assum e that ( t ) in Eq. (1-1) is a scalar G aussian process com pletely determ ined by its rst tw o m om ents, which, w thout loss of generality can be taken as

X ( t ), the solution to Eq. ( $\left.\bar{I}_{1}^{\prime}\right)$, is a stochastic function. The ob jective of this work is to obtain equations for its ensemble average and higher $m$ om ents in a system atic way. Let us rem ark that for us Eq. (1') is purely phenom enological, we assum e that it is the result of a m ore com plete $m$ icroscopic analysis which can account for the random ness of ( $t$ ) (see for exam ple, Refs.[ ! 8 , 1

To obtain a di erentialequation for the average of X wem ake use of the follow ing w ell known property: For any G aussian process (t) characterized by a -correlation function (G), and any functional $F$ [ ] we have the follow ing relation [ $\overline{1} \overline{2} \overline{2}$ ']:

In order to obtain a di erential equation for $h X$ i we observe that

 the ensemble average is in the general case an integrodi erential equation given by

This equation, which is exact and of very general validity, is the equation which we were looking for and one of the $m$ ain results of the present work. $N$ ote that previously integrodi erential equations have been obtained, valid for particular cases or in particular lim its, using heuristic ad hoc argum ents (for exam ple, in Ref. [ [1] 11$]$ ). The derivation of Eq. ( 1 here is the rigorous justi cation for such approaches.

In som e notable cases Eq. (1] sections we will see how it can be reduced to, respectively, rst and second order equations for the correlation functions given by Eqs. ( $\left.{ }_{(1)}\right)$ and (G)

## 3. THE PARTICULAR -CORRELATED CASE

For the particular case where the correlation function is of exponential type, a second order ordinary di erential equation can be obtained as we will see below. On the other hand, for the sim pler -correlated case the evolution equation (1]

Taking $L$ as a com $m$ utator, this last equation coincides $w$ ith the $R$ ed eld equation derived by Ref. ['in-1;1]. N ote that the e ective "H am iltonian" appearing in the second part of Eq. (1] $\bar{L}-\bar{i}$ ) is not Herm itic anym ore (an exam ple of a uctuation-dissipation e ect).

In cases of interest for the neutrino oscillation problem, the original equation for the density $m$ atrix is of the slightly sim pler form

where we have written the com $m$ utator explicitly. ( $t$ ) is a stochastic function as before and $g(t)$ an arbitrary scalar function. $\mathrm{H}_{0} ; \mathrm{H}_{1}$ are H am iltonian m atrioes, the form er contains the
average part of $(t): H_{0} \quad H_{0}^{0}(t)+0(t) H_{1}$, w ith $0=h i$. The latter is assum ed to be time independent.

For the problem described by Eq. (1-5) the corresponding $R$ ed eld equation for the averaged density $m$ atrix is of the form

The solution of what is called the \coherent" part of Eq. [1] $\overline{1}$ ) (tw o rst term s of the H am irtonian) is accom plished by de ning the average evolution operator:

we arrive at the equation we w ere looking for, the resolution of the originalequation is equivalent to the resolution of the follow ing one:

There are some im portant particular cases where Eq. (14) can be solved or considerably sim pli ed by taking into account the algebraic properties of a speci c $L$ (in what follow $s k$ ( $t$ ) is alw ays a scalar function).
(a) Let us assum e that $L$ is such that $L^{2}(t)=k(t) L(t)$. This case appears in the com putation of the average $w$ ave function $w$ ith $m$ atter density noise. Equation (14) reduces to

The averaged equation is sim ilar to the original one, the nonrandom part of the density is \renorm alized" acquiring an im aginary term

This is the density which will appear in the coherent e ective H am iltonians $\mathrm{H}_{0}$.
(b) The case where $L^{2}(t)=k(t) I w$ th $I$ the identity $m$ atrix appears in the com putation of the averaged neutrino w ave function under noisy m agnetic spin- avor precession. T he resulting equation can trivially be integrated (to be com pared w ith the previous case):

The average wave oscillation is dam ped by a factor equivalent to the one rst calculated by N icolaidis [ ['는]. A sim ilar dam ping also appears when com puting the average density $m$ atrix
from Eq. ([2]ī). From these di erences ofbehavior w ith respect to case (a) it is expected that the presence ofm agnetic eld noise can have som e in uence even if applied far from any resonance region.
(c) The case where $L^{4}(t)=k(t) L^{2}(t)$ appears in the com putation of the average density $m$ atrix $w$ ith $m$ atter or $m$ agnetic noise. $W$ e can obtain in this case the \conservation law "

$L^{2}(t)$ is not invertible because the operator $L(t)$ has a zero eigenvahe. T he previous expression has proved to be of practical im portance in som e concrete num erical applications [
$T$ he presence of zero eigenvalues distinguishes cases (a) and (b) from (c); it can have consequences in the long term behavior of the respective ensem ble averages as is shown elsew here [ '1]
4. AN ASYMPTOTIC EXPANSION FOR EXPONENTIALLY CORRELATED SY STEM S

W e w ill see now how Eq. ( $\left.\overline{1} \overline{4} \overline{4}_{1}^{\prime}\right)$ can be obtained as a lim $i t i n g$ case when the correlation length tends to zero. For this purpose we use an exponential correlation function as Eq. (GQ), the integrodi erential evolution equation becom es in this case

Let us com pute the asym ptotic expansion of the second term of Eq. ( $2 \overline{2} \overline{2})$ valid for large ; the follow ing expansion is valid for any function $g(t)$ :

To leading order in $1=$, we recover the expression corresponding to the correlated case. At next-to-leading order we get nite-correlation correction term $s$

Finally, $W$ e get the follow ing di erential equation valid to order $1=$, $m$ aking the assum ption that the operator which multiplies the left term is invertible:

This equation can be used for nite, but relatively large, correlation lengths. W e see that, up to this degree of approxim ation, not only the ratio level of noise to correlation length ( ${ }^{2}=$ ) is im portant. W e have di erent regim es according to the value of ${ }^{2}$. The rst term willbe more im portant for a low noise amplitude ( ${ }^{2} \ll 1$ ). For strong noise ( ${ }^{2} \gg 1$ ) the second term, proportional in this case to $L^{4}, w i l l$ dom inate.

## 5. AN EXACT D FFERENTIALEQUATION FOREXPONENTIALLY CORRELATED SYSTEMS

In contrast w ith the approxim ate approach used in the previous section, we can actually derive a sim ple, ordinary second order di erential equation for the case of exponential correlation. Let us assum $e$ that the original equation is of the sam e decom posable type as the one appearing in Eq. (1్ָ) but let us include other cases using the general notation

D i erentiating the equation once and perform ing som e sim ple algebra we obtain the follow ing ordinary second order di erential equation:

Let us rem ark that this equation is exact and probably the $m$ ost im portant result of this work from a practical point of view.
6. HIGHER ORDER MOMENTSAND THE QUANTUM REGRESSION THEOREM

Second order distribution $m$ om ents, expressions of the type $h X_{i} X_{j} i$, or in general, $m$ om ents of any order, can also be com puted using equations sim ilar to Eq. (1] procedure is to de ne products $X_{i j} \quad=_{k} X_{i} X_{j} \quad k$ and $w$ rite di erential equations for them using the constilutive equations for each of the $X_{i}$. The resulting equations are of the sam etype as Eq. (1]). The sim ilarity is obvious when one adopts a tensorial notation and de nes products of the form $X^{(n)}=X \quad X: T$ he task of obtaining evolution equations is especially sim ple $w$ thin this notation.

C orrelators of quantities at di erent tim es also appear in the com putation of averages of quantities of physical interest, i.e., expected signal rates. In the $m$ ost sim ple case expressions of the type $\mathrm{hX} \mathrm{i}_{\mathrm{i}}(\mathrm{t}+) \mathrm{X}_{\mathrm{j}}(\mathrm{t}) \mathrm{i}$. Wewill shortly show that the know ledge of equal-tim emom ents and the application of the quantum correlation theorem is su cient for the com putation of this kind of correlators.

O ur ob jective now is the com putation of the correlation function appearing in two steps. First we de ne the generalized density $m$ atrix $X{ }^{(2)}$ as the tensorial product of usual density $m$ atrices at two di erent tim es and energies:

$T$ he average of the elem ent $h X_{1111}^{(2)} i=h X_{11} X_{11} i$ is evidently the probability correlation function we are looking for.

The di erential equation for the equal tim e function $X{ }^{(2)}\left(E_{1} ; \mathrm{E}_{2} ; \mathrm{t} ; \mathrm{t}\right)$ is obtained from the individual evolution equations for the $m$ atrices $X_{1 ; 2} \quad X\left(E_{1 ; 2}\right)$ [indioes (1,2) label expressions where $\mathrm{E}_{1} ; \mathrm{E}_{2}$ appear respectively]
$@_{\mathrm{t}} \mathrm{X}^{(2)}=\mathrm{H}_{1} \mathrm{X}^{(2)}+\mathrm{X}^{(2)} \mathrm{H}_{2} \quad \mathrm{LX}{ }^{(2)}$ :
Equation ( $\overline{3} \overline{2} \overline{2})$ is a random linear di erential equation, linear in the stochastic variable (t). A pplying the form alism developed in the previous section, w e can im m ediately w rite the equation for the ensemble average $h X{ }^{(2)}$ i $\mathbb{E q s}$. ( 1 obtain the expression for any other pair ( $t ; t^{0}$ ) using the quantum regression theorem [1' $\left.\overline{1} \overline{\mathrm{G}}\right]$ whidh reads as follow s. For any vector $M$ arkov process $Y$, if the ensemble average of $Y$ ful lls a Schrodinger-like equation of the type

$N$ ote that the quantum regression theorem is in principle not applicable to system s described by the integral equation Eq. (13). N evertheless it is applicable to problem sw here the integral equation can be reduced to an ordinary di erential equation such as Eq. ( $\overline{\mathrm{S}} \overline{\mathrm{O}} \overline{\mathrm{N}}^{\prime}$ ) Such a second order equation can easily be expressed as a rst order one by de ning the auxiliary pair process $Y=\left(X ; @_{t} X\right)$.

For the sim plest case where is a correlated process the equation for non-equal tim ecorrelators is explicitly given by
iه $h X^{(2)}(t+; t) i=i^{2} L^{2}() h X{ }^{(2)}(t+\quad ; t) i$ :
The in itial condition, $X^{(2)}(t ; t)$, is the equal tim e correlator previously obtained. For exponentially correlated problem s second order equations sim ilar to Eq. ( $\left.\overline{3} \overline{0} \bar{O}_{1}\right)$ can im m ediately be obtained.

## 7. CONCLUSIONSAND FINALREMARKS

In conclusion, in this w ork we have developed the general form alism for the study of neutrino propagation in stochastic $m$ edia. This form alism has allow ed the system atic derivation of evolution equations for averaged quantities as survival probabilities and higher order $m$ om ents of them. $N$ ew integrodi erentialequations valid for nite correlation processes have been obtained for the rst time. For exponentially correlated processes a second order ordinary equation is obtained as a consequence. The Red eld equation valid for $G$ aussian -correlated noise is rederived in a sim ple way: it has been obtained directly and as the zero-order term of an asym ptotic expansion in the inverse of the correlation length.
$T$ he form alism can be generalized in an obvious w ay to obtain the ensem ble average of equations of a slightly $m$ ore general type than Eq. (11ㅣ), equations of the form

These equations appear, for exam ple, in the chaotic neutrino $m$ agnetic precession. The result for the case where the $i$ are correlated in tim e but m utually uncorrelated is sim ply

The generalization to continuous Schrodinger equations in the presence ofrandom potentials or random extemal forces is also obvious if we leave aside the $m$ athem aticaldi erences com ing from the appearance of in nite-dim ensionalH ilbert spaces. The form alism is ofgeneralapplication to any quantum system govemed by sim ilar Schrodinger equations: equations where a stochastic function appears $m$ ultiplicatively in som e term of the $H$ am iltonian.
