Impact of Tau Polarization for the determination of high tan and A $^{\rm x}$

Abstract

In order to determ ine the fundam ental MSSM param eters M_1 , M_2 , and tan the tau polarization from ~ decays can be explored as a bridge' between the gaugino/higgsino and the stau sector in particular in the high tan range. Even in the case of high tan an accuracy of (tan) 5% with an simultanous determ ination of A is possible without assuming a speci c SUSY breaking scheme.

1 Introduction

The M inim al Supersymmetric extension of the Standard M odel (M SSM) is one of the most promising extensions of the Standard M odel (SM). However, SUSY has to be broken and in the unconstrained version of the M SSM a parameterization of all possible soft SUSY breaking terms leads to 105 new parameters in addition to the ones of the SM.

A linear collider (LC) is, due to its clear signatures, the most promising tool for revealing the underlying structure of the physics beyond the SM as e.g. the precise determination of these parameters.

Strategies to determ ine the fundam ental param eters in the chargino/neutralino sector have already been worked out in [1, 2] and references therein. However, for tan > 10, the gaugino/higgsino sector is weak dependent on tan so that its determ ination becomes rather inaccurate. We therefore concentrate in this paper on the production of the SUSY partners $\sim_{1,2}$ and their decays into \sim_1^0 and using the polarization of the 's for the accurate determ ination of high tan . Since the polarization involves simultanously

m ixing parameters from both neutralino and stau sectors it plays the role of a bridge' between these two sectors.

The importance of the polarization has already been pointed out in [3, 4]. We derive the compact formula for the polarization including the general mixing in the neutralino sector and show in which regions of MSSM parameter space the polarization will be a suitable observable. Contrary to the former studies we assume no speci c character of the LSP \sim_1^0 or speci c GUT relations between the underlying gaugino parameters. We show with an numerical example that the polarization on 's is well suited for a rather accurate determination even of high tan as well as for a simultanous determination of A.

2 The Stau Sector

2.1 Masses and Mixing

Since the lepton has the largest Y ukawa coupling of the three lepton fam ilies the weak eigenstates $\gamma_{L,R}$ m ix to the mass eigenstates $\gamma_{1,2}$, where the mass matrix is given by:

with the D-term s D_L = ($\frac{1}{2} + \sin^2 w$) cos(2) m²_Z and D_R = $\sin^2 w$ cos(2) m²_Z, the trilinear slepton (Higgs $r_R - r_L + H_1$ coupling A, the higgsino mass parameter, the ratio of the Higgs expectation values tan = $v_2 = v_1$ and the SU (2) doublet (singlet) mass parameters M_L (M_E). The mass parameters m²_{LL}, m²_{RR} have to be positiv for tan > 1, whereas the sign of the o {diagonal term s m²_{LR} depends on A and .

The mass eigenvalues are given by

and a large mass di erence may be quite natural. In many SUSY scenarios \sim_1 is similar light as light charginos/neutralinos. A future high L LC will be well suited to measure the masses with an high accuracy of e.g. about $(m_{\sim_1}) = 0.6$ GeV [5].

The stau mixing angle $_{, 0; 0; 0}$] is given by:

so that the mass parameters m_{LL}^2 , m_{RR}^2 , m_{LR}^2 can also be expressed via the measurable observables $m_{\gamma_{12}}^2$:

One sees from (4) and (5) that one can distinguish the two cases

1. if $m_{LL}^2 > m_{RR}^2$ then $\cos(2 ~) = \frac{p_{1+2}}{p_{1+2}} < 0$ 2. if $m_{LL}^2 < m_{RR}^2$ then $\cos(2 ~) = + \frac{p_{1+2}}{p_{1+2}} > 0$

The cross section for $\sim_i \sim_i$ production depends on the mixing angle $\cos 2 \sim$ ([6] and references therein) and $\cos \sim$ can be accurately determined, with a two{fold ambiguity, via the cross section for \sim_i production with polarized beam s or via a polarization asymmetry $A_{Pol} = (L_R) = (L_R)$.

In the following we discuss the polarization from γ_1 decays $P_{\gamma_1!}$. The tau polarization P can be derived from the energy distribution of the decay products of the tau lepton.

2.2 polarization from \sim_i decays

In this section we study the polarization P from the decays

taking into account a general neutralino mixing in the M SSM [7].

The tau polarization for (7) is given by (using the narrow width approximation) [3]:

Taking into account a general mixing in the neutralino sector we derive the polarization:

where the mixing angle $_{\sim}$ i.e. is given by (3) and $P_{\sim_2!}$ can be obtained from eq. (13) by changing the sign of $\cos 2_{\sim}$ and $\sin 2_{\sim}$.

The coe cient x_W contains the complete contribution from the gaugino components, y_h is a combination of the factors of the Yukawa coupling and the complete contribution from the higgsino components x_h .

O ne sees from eq. (13) that the transform ation between the two cases $m_{LL}^2 > m_{RR}^2$, whose hierarchy is motivated by the M SSM as far as no addional D {terms have to be included, and $m_{LL}^2 < m_{RR}^2$ lead only to an exchange of P_{γ_1} .

2.2.1 tan dependence of the polarization

W ith the coe cients x_{W} and x_{h} in eqn. (13){ (14) the complete tan dependence from the neutralino sector has been separated and the coe cient y_{h} shows the interplay between the Yukawa coupling and the \sim_{i}^{0} higgsino admixture. All components of (15), (16) are given explicitly as function of the fundamental MSSM parameters in [2] and in an approximation, which is valid for high values of tan in [7].

One can summarize that the dependence on tan of $P_{\gamma_{1,2}}$ is given in a three-fold way:

- 1. by the tan dependence of the mixing angle $_{\sim}$ (3) and the o -diagonal term in (1);
- 2. by the coe cients $x_{\ W}$ and x_h , which corresponds to the tan dependence of the neutralino sector,
- 3. by the coe cient y_h which corresponds to the ~ Yukawa coupling $\frac{1}{\cos \frac{m}{m_w}}$.

One sees clearly from (16) that for a given mixing angle or only the coe cient y_h contains a strong dependence on tan of P_{-1} from the Yukawa coupling. O by ously a su cient large higgsino admixture part x_h has to be for that.

The tan dependence of x_W and x_h is weak since the neutralino mass eigenvalues m $_i^2$ as well as the components of the eigenvectors N_{ij} become in the high tan approximation f (1 + const $\frac{1}{\tan}$). Therefore it is a good approximation to take all neutralino mixing contributions in the high tan approximation.

2.3 Limiting cases: extrem a for the mixing angle

A sum ing no constraints for the m ass parameters one can vary the m ixing angle $_{\sim}$ from 0 to , i.e. from 0 ! 1, and we get for these extrem a the following expressions:

The form use for the tau polarization even simplies for specic neutralinom ixing cases. We give the corresponding expressions in Table 1 for the processes $\gamma_1 ! \qquad \gamma_1^0$ and $\gamma_2 ! \qquad \gamma_1^0$. The conventions are chosen so that in a no{mixing case, i.e. $\gamma_1 ! \qquad \gamma_R < \gamma_2 ! \qquad \gamma_L$, and when only a pure U (1) gauge coupling interacts between $\gamma \sim 0$, the polarization $P_{\gamma_1 ! \ R} = +1$ and $P_{\gamma_2 ! \ L} = 1$. Studying the polarization of the antiparticle + one has to take into account that the SUSY partner of $\frac{1}{L_{R}}$ is $\gamma_{R,L}^+$, so that $P_{\gamma_{R}^+! \ L}^+ = 1$ and $P_{\gamma_{L}^+! \ R}^+ = +1$. We show in Fig.1 representative examples for illustration.

The corresponding plot for case a), Table 1, is given in Fig. 1a. The asymptotic limit $\frac{3}{5}$ for ! 1 can clearly be seen.

The corresponding plot for case b), Table 1, is given in Fig. 1b. The asymptotic limit depends now on the gaugino parameters and since the wino fraction x_W^2 is less than 1 the polarization P_{-1} gets closer to 1 and will always be higher than the asyptotic value $\frac{3}{5}$ of the pure bino case a).

In the pure higgsino case c), Table 1, the no{stau{m ixing case shows a helicity ipping behaviour, P_{γ_1} ! 1 and P_{γ_2} ! + 1, which is the typical feature of the Yukawa couplings.

To give a feeling even for the neutralino mixing e ects we plot in Fig.2a the polarizations P_{γ_1} , P_{γ_2} , for the mixed case $x_W = 0.8$ and $y_h = 0.6$. The polarizations even interchange for a speci c mixing angle.



Figure 1: The dependence of the tau polarizations $P_{\gamma_1!}$ and $P_{\gamma_2!}$ from the mixing angles for a pure bino case (left) with the neutralino mixing variables $x_W = 1$, $y_h = 0$ and for a pure gaugino case (right) with $x_W = 0.5$, $y_h = 0$.

So if the fraction of the higgsino m ixing part is small compared to the gaugino m ixing one expects P_{γ_1} close to unity and P_{γ_2} variable in a large range, eqn. (17) { (20). This is the case for all the SPS scenarios [8] as shown in the Table 2.

In order to demonstrate the tan dependence coming from the interplay between the Yukawa coupling and the higgsino admixture of the LSP we show in Fig. 2b the polarizations P_{γ_1} and P_{γ_2} for the case with a rather large higgsino admixture and set $! 0, ie. \gamma ! \gamma_B and \gamma_2 ! \gamma_L$.

Table 2: Tau polarization and tan slopes for the SPS scenarios [8]. The program ISA JET 7.58 [9] has been used for the parameter evaluation. The SPS 2 focuspoint point scenario does not have a stable slope.

In order to get an impression in which ranges of the parameter space the tau polarizations from $\gamma_{1,2}$ decays may have large variations, we show in Fig. 3 the polarizations $P_{\gamma_{1,2}}$ as functions of M₂ and . The other relevant parameters have been chosen to tan = 40, M_L = 300 GeV, M_E = 150 GeV, A = 2542 GeV. Both plots show that one could get high values for the polarization for a large region of the M₂ parameter space. In particular in the higgsino{like region with $< M_2$ the polarization P_{γ_1}! is very variable.

3 M SSM parameter determination for high tan

3.1 Parameter determination in the $\sim_{1,2}$ sector

We assume that one can measure at a high L LC the masses with rather high accuracy of about % level via mass threshold scans.

We study the light system $e^+e^-! \sim_1 \sim_1$ and determ ine the mixing angle $\cos \sim_1$ via polarized cross sections $(e^+_{L,R}e^-_{R,L}! \sim_1 \sim_1) \cos(2 \sim)$ or via the asymmetry $A_{pol} = (L_{R_{r}}) = (L_{R_{r}}) = (L_{R_{r}})$. If one wants to derive \sim_1 unambigously one would also need $(e^+e^-! \sim_1 \sim_2) = \sin(2 \sim_1)$, which is more tricky because of the di cult reconstruction of the , decay products from the \sim_2 decays.

We determ ine the mixing angle via measuring the production $e^+ ! \sim_1 \sim_1^+ in$ the con guration (RL), P (e) = +80%, P (e⁺) = 60%, since in this case the worse background from W⁺W is strongly suppressed and in contrary the signal is enhanced. From the rates _{RL} we could derive the mixing angle rather accurately, $\cos = 0.15 \quad 0.01$, Fig.4, if we measure _{RL} ($\sim_1 \sim_1^+$) = 112 fb at P = 500 GeV and assume that a statistical error of 1 was taken into account. In Table 3 we list the corresponding cross sections $(\sim_1 \sim_1)$ for P = 500 GeV and P = 800 GeV.

In principle one can alternatively also derive the mixing angle via measuring the polarization asymmetry A_{pol} of the production process. Taking rates with left polarized electrons leads, however, to an enhancement of the strong W W background and a tricky analysis would be needed to get the wanted experimental information.

Generically the cross section is a quadratic polynom in $\cos(2 \$). With a suitably high degree of beam polarization, however, the quadratic term s are suppressed and only one solution survives.

3.2 Measurement of the polarization

We have computed the cross sections and disctributions for the 4 nal state particle processes with all spin correlations taken into account:

In order to measure the polarization of the 's one has to study their decays into or

{m econs and to t kinem atically the energy distributions of the decay products β]. The decays of polarized to - and -m econs are implemented into C om pHEP and are cross checked with TAUOLA [10].

The calculations are performed by means of the CompHEPV41 [11] with implemented MSSM and mSUGRA models. In order to estimate an accuracy of polarization measurements we have generated a number of unweighted events which correspond to the production cross section with the corresponding decay branching fractions and the overall registration e ciency of signal events:

Based on the results of MC analysis given in [3] we assumed 30% for the e ciency and we assume 500 fb¹ for a lum inosity. So in total about 3300 um weighted events have been simulated.

The pion energy distribution is shown in the Fig. 5 left. The distribution is described by the form ular presented in a slightly dimension form as that one given in [3].

The t of the energy distribution by the above form ula (23) gives for the tau polarization P_{γ_1} about 57% 3%, compared to the theoretical value of polarization for the reference point of 56%.

The presented example is meant as an illustration only. Measurements of the lepton decay mode to with its subsequent decays may help to get even a better accuracy.

3.3 Determination of tan and the A parameter

In the last section we have shown that P_{γ_1} could be measured within about 5% accuracy. We derive the value of tan via inversion of (13) for the calculated values of x_W and x_h and the measured mixing angle cos \sim , see Fig. 5 right, and we determ ine in our scenario the high tan with an error of about 5% :

In the case that also the heavier mass of \sim_2 can be determined in the experiment, we can even determine the parameter A without assuming anything about the SUSY breaking scheme and GUT relations:

$$A = \frac{1}{m} \left(\frac{1}{2} \left(m \frac{2}{r_1} - m \frac{2}{r_2} \right) \sin \left(2 - \right) + m \quad \tan \right):$$

W ith an error of about 5% in tan and of about 5% in m_{-2} one could derive A with an accuracy about 8%. For the application of this method on the B and t sector and a detailed simulation study see [7].

4 Conclusions

Tau polarization from stau decays might be an important variable for the determination of the fundam ental M SSM parameters. It serves as a bridge' between chargino/neutralino and stau sectors.

The stau mixing angles can be precisely determined via polarized rates and in case that the decay neutralino has a suitable higgsino admixture, the study of P_{γ_1} leads to an accurate determination of tan even in the case of high tan . For these procedure it is enough to measure only the light system: m_{γ_1} and (e⁺ e ! $\gamma_1 \gamma_1$). In case that also m_{γ_2} can be measured, even the parameter A can be derived without an assumption about the underlying SUSY breaking scheme.

For a given example we explored $P_{\sim_1!}$ and showed that one can determ ine simultanously A and tan , e.g. in the case of high tan , within 5% accuracy.

A system atic simulation of the process as well as the application of this method on the \mathcal{B} and \mathcal{T} sector will be presented in a following paper [7].
