Direct C P V iolation In B! + V W ith 0! M ixing E ects: Phenomenological Approach

A bstract

We present a detailed study of direct CP violation and branching ratios in the channels B 0 ; $^+$ V 0 ; , where V is a vector meson (K 0 ; or). Emphasis is placed upon the important role played by 0 ! mixing elects in the estimation of the CP -violating asymmetry parameter, $a_{\rm cp}$, associated with the dierence of B and B decay amplitudes. A thorough study of the helicity amplitudes is presented as a function of the pion-pion invariant mass. All of the calculations and simulations considered correspond to channels which will be analyzed at the LHCb facility.

1 Introduction

Understanding the physical origin of the violation of CP (Charge Conjugation Parity) symmetry is one of the main goals of Particle Physics at the present time. Recent experiments at e⁺e colliders (BaBar, Belle) have produced fundamental results which strengthen the CKM picture of CP violation [1, 2] in the B meson sector [3, 4]. However, the main results of these two collaborations are related to B decays into pairs of pseudo-scalar mesons or into a vector plus a pseudo-scalar meson.

A very broad physics program can also be carried out in the sector with two vector mesons in the nal state, following B decay. A part from measuring the standard angles, ; and of the Unitary Triangle (UT), the vector mesons are polarized and their decay products (usually long-lived 0 $^+$ mesons) are correlated. This opens the possibility of making interesting cross-checks of the Standard M odel predictions as well testing some special models of CP violation beyond the SM approach (BSM).

In the special case of two neutral vector m esons, the orbital angular m om entum, ', and the total spin, S, of the $V_1^0V_2^0$ system satisfy the equality '= S = 0;1;2. The CP eigenvalues are de ned as (1) Because of the allowed values for the angular m om entum, ', one has a very clear indication of any m ixing of dierent CP eigenstates and hence of CP non-conservation. The separation of the dierent CP eigenstates requires a detailed analysis of the nal angular distributions [5]. However, because this analysis can be carried out in a model-independent way, it provides a signicant constraint on any model.

A fler explaining the helicity form alism (Section II), a special study is devoted to the nal state interactions (FSI) and the key role of 0 ! m ixing (Section III). A complete and realistic determ ination of the helicity amplitudes, in the framework of the elective H amiltonian approach, is introduced in Section IV. Then, the main results of the Monte-Carlo simulations, providing estimates of the various density matrix elements h_{ij} , are shown in Section V. In the following section (Section VI) the numerical analysis and discussions about the branching ratios and asymmetries for B decays into two vectors (B! 0 (!) 0

2 General form alism for B ! V_1V_2 decays

2.1 Helicity fram e

Because the B m eson has spin 0, the naltwo vector m esons, V_1 and V_2 , have the same helicity, $v_1 = v_2 = v_3 + 1$; and their angular distribution is isotropic in the B rest frame. Let H w be the weak H am iltonian which governs the B decays. Any transition amplitude between the initial and nal states will have the following form:

where the common helicity is = 1;0;+1. Then, each vector meson V_i will decay into two pseudo-scalar mesons, $a_i;b_i$, where a_i and b_i can be either a pion or a kaon, and the angular distributions of a_i and b_i depend on the polarization of V_i .

The helicity frame of a vector-meson V_i is dened in the Brest frame such that the direction of the Z-axis is given by its momentum, pi. Schematically, the whole process gets the form:

where the amplitudes $A_i(V_i ! a_i + b_i)$ are related to the decay of the resonances V_i . The $A_i(V_i! a_i + b_i)$ are given by the following expressions:

These equalities are an illustration of the W igner-E ckart theorem. In Eq. (3), the c_1 and c_2 param eters represent, respectively, the dynamical decays of the V_1 and V_2 resonances. The term $D_{m,i}^{1}$ (i; i; i) is the W igner rotation matrix element for a spin-1 particle and we let (ai) and (bi) be the respective helicities of the nalparticles ai and bi in the V_i rest fram e. 1 is the polar angle of a_1 in the V_1 helicity fram e. The decay plane of V_1 is identified with the (X-Z) plane and consequently the azim uthal angle $_1$ is set to 0. Sim ilarly, 2 and are respectively the polar and azim uthal angles of particle a_2 in the V_2 helicity fram e. Finally, the coe cients m i are de ned as:

The analytic expression in Eq. (7) exhibits a very general form. It depends on neither the speci c nature of the interm ediate resonances nor their decay modes (except for the spin of the nalparticles). This approach also presents three key advantages. The rst one comes from the fact that all the dynamics of the B decay is introduced into the coe cients h ; \circ . This allows us to use various theoretical models involving dierent dynamical processes and form factors. The second is associated with the fact that the form alexpressions for F; \circ (1) and G; \circ (2;), which are related to the polarization of the intermediate resonances, remain unchanged whatever the coe cients h; \circ happen to be. Finally, correlations among nalparticles arise in a straightforward way because of the previous expression which relates the angles 1; 2 and . Consequently, a probability density function (pdf) can be inferred from the general expression and one gets:

where the angles $_1$; $_2$ and $_3$ were de ned earlier and (B ! V_1V_2) is the partial decay width. This function allows one to compute three other pdfs separately for the variables $_1$; $_2$ and .

The previous calculations are illustrated by the reaction B 0 ! K 0 0 where K 0 ! K $^{+}$ and 0 ! $^{+}$. In this channel, since all the nalparticles have spin zero, the coe cients m $_{1}$ and m $_{2}$, de ned in Eq. (4), are equal to zero. The three-fold di erential width has the following form:

where all the terms in Eq. (9) have been already specified. It is worth noticing that the expression in Eq. (9) is completely symmetric in $_1$ and $_2$ and consequently, the angular distributions of a_1 in the V_1 frame is identical that of a_2 in the V_2 frame. From Eqs. (8) and (9) the normalized pdfs of $_1$, $_2$ and can be derived and one nds:

2.2 Transversity fram e

Initially, the transversity fram e (TF) was introduced by A.Bohr [7] in order to facilitate the determ ination of the spin and parity of a resonance decaying into stable particles. It can be extended to a system of two vectors e sons coming from a heavy e eson, B or B, in order to perform tests of CP symmetry. In displaying new angular distributions, the TF

provides com plem entary physical inform ation to that seen in the standard helicity fram e. The construction of the TF and its use require several steps. For a clear illustration, see Fig. 1, where the channel B $^{\,0}$! $^{\,0}$ K $^{\,0}$ is chosen.

Departing from the B rest frame, the common helicity axis, ($_{\rm H}$), is given by the direction of the momentum p_1 . This and the decay plane, ($_{\rm D}$), of the vector meson (K 0 ! K $^{+}$) are the main ingredients of the TF. The vector meson 0 is taken at rest (origin of the frame) and the X-axis is given by ($_{\rm H}$). In the decay plane, ($_{\rm D}$), the Y-axis which is orthogonal to the X-axis, is chosen in such a way that the K $^{+}$ meson has the Y-component of its momentum greater than or equal to zero. The Z-axis, which is orthogonal to the plane ($_{\rm D}$), is obtained by the classical relation ${\bf e}_{\rm Z}={\bf e}_{\rm X}$ ${\bf e}_{\rm Y}$.

The angular distributions of the com ing from the com decay are referred to the new Z-axis. It is worthy noticing that, in the TF, the com ying m eson and its decay products are very energetic compared to the B fram e. Explicitly, the com energy is given by the relation,

where m $_1$ and m $_2$ refer to the m asses of the K 0 and 0 resonances, respectively. As far as the transition amplitudes in the TF are concerned, they are a simple linear combination of the helicity amplitudes, namely:

3 Final state interactions and $^{ m 0}$ $^{ m l}$ m ixing

3.1 Factorization hypothesis

Final state interactions (FSI) represent unavoidable e ects in hadronic physics and they play a crucial role in heavy resonance decays [8]. In the case of a B m eson, characterized by a center-ofm assenergy $\frac{p}{s}$ 5:3 GeV, the charm less weak decays of the b-quark lead to light energetic quarks which can exchange several gluons amongst them selves as well as with the spectator quark in the B m eson. This fundamental process occurs in decays described by tree, penguin and annihilation diagrams and is characterized by two regimes: perturbative and non-perturbative. In order to handle the FSI in both regimes, the usual method is inspired by the elective Lagrangian approach. Perturbative calculations at next-to-leading order (NLO) are performed for a scale higher than m_b (since our analysis is focused on B decays) and the non-perturbative elects are inserted for a scale lower than m_b. This general method is called the factorization procedure [9] and further details are given below.

In the factorization approximation, either the vector m eson 0 (!) or the K is generated by one current in the elective Hamiltonian which has the appropriate quantum

The matrix elements for B! X (where X denotes a vector meson) can be decomposed as follows [10],

where J is the weak current, de ned as J=q (1 $_5$)b with q=u;d;s and $k=p_B$ p_X and is the polarization vector of X. The form factors $A_0;A_1;A_2;A_3$ and V describe the transition 0! 1. Finally, in order to cancel the poles at $q^2=0$, the form factors respect the condition:

In the evaluation of m atrix elements, the elective number of colors, N $_{\rm c}^{\rm eff}$, enters through a Fierz transformation. In general, for an operator O $_{\rm i}$, one can write,

here $_{\rm i}$ describes non-factorizable e ects. $_{\rm i}$ is assumed to be universal for all the operators O $_{\rm i}$. Naive factorization assumes that we can replace -in a heavy quark decay-them atrix element of a four fermion operator by the product of them atrix elements of two currents. This reduces to the product of a form factor and a decay constant. This assumption is only rigorously justified at large values of N $_{\rm c}$. But it is known that naive factorization may give a good estimate of the magnitude of the B decay amplitude in many cases [11].

3.2 FSI at the quark level: strong phase generated by the penquin diagram s

Let A be the amplitude for the decay B ! $^{0}(!)K$! $^{+}$ K (a similar procedure applies in the case where we have a [12] instead of the K), then one has,

$3.3\,$ Strong phase generated by the $^0\,$! m ixing

In the vector meson dominance model [14], the photon propagator is dressed by coupling to vector mesons. From this, the $^{\circ}$! mixing mechanism [15] was developed. In order to obtain a large signal for direct CP violation, we need some mechanism to make both sin and r large. We stress that $^{\circ}$! mixing has the dual advantages that the strong phase dierence is large (passing through 90° at the! resonance) and well known [12, 16]. With this mechanism, to rst order in isospin violation, we have the following results when the invariant mass of the pair is near the mass of the! resonance,

Here t_V (V= or!) is the tree amplitude and p_V the penguin amplitude for producing a vector meson, V, g is the coupling for 0 ! $^+$, $^\sim$! is the elective 0 ! mixing amplitude, and s_V is the inverse propagator of the vector meson V,

with p \bar{s} being the invariant mass of the $^{+}$ pair. We stress that the direct coupling !! $^{+}$ is electively absorbed into $^{\sim}$! [17], leading to the explicit sidependence of $^{\sim}$!. Making the expansion $^{\sim}$! (s) = $^{\sim}$! (m $_{.}^{2}$) + (s m $_{w}^{2}$) $^{\sim}$! where the total strong phase, , is mainly proportional to the ratio of the penguin and tree diagram contributions.

3.4 Im portance of the strong phase for B B asym m etry

Under a CP transform ation the strong phase, , rem ains unchanged, while the weak phase, , which is related to the CKM matrix elements, changes sign. Thus, the asymmetry parameter, $a_{\text{CP}}^{\text{dir}}$, which can reveal direct CP violation, can be deduced in the following way:

It is straightforward to see that the parameter $a_{CP}^{\rm dir}$ depends on both the strong phase and the weak phase and, consequently, that the maximum value of $a_{CP}^{\rm dir}$ can be reached if $\sin = 1$. This is why the strong nal state interaction (FSI) among pions coming from 0 ! mixing enhances the direct CP violation in the vicinity of the mass of the! resonance.

In the W olfenstein parametrization [19], the weak phase comes from $[V_{tb}V_{ts}=V_{ub}V_{us}]$ and one has for the decay B ! 0 (!) K ,

4 Explicit calculations according to the e ective H am iltonian

4.1 Generalities concerning the OPE for weak hadronic decays

4.1.1 Operator product expansion

The operator product expansion (OPE) [20] is an extremely useful tool in the analysis of weak interaction processes involving quarks. Dening the decay amplitude A (M ! F)

where $C_i()$ are the W ilson coe cients (see Section 4.12), $O_i()$ are the operators given by the OPE and is an energy scale, one sees that the OPE separates the calculation of the amplitude, A (M $\,!\,$ F), into two distinct physical regimes. One is related to hard or short-distance physics, represented by $C_i()$ and calculated by a perturbative approach. The other is the soft or long-distance regime. This part must be treated by non-perturbative approaches such as the 1=N expansion [21], QCD sum rules [22], hadronic sum rules or lattice QCD.

The operators, O_i, are local operators which can be written in the general form:

where $_{n1}$ and $_{n2}$ denote a combination of gamma matrices and q the quark avor. They should respect the D irac structure, the color structure and the types of quarks relevant for the decay being studied. They can be divided into two classes according to topology: tree operators $(O_1;O_2)$, and penguin operators $(O_3 \text{ to } O_{10})$. For tree contributions (where $O_1;O_2$), the Feynman diagram is shown in Fig. 2 (left). The current-current operators related to the tree diagram are the following:

where and are the color indices. The penguin terms can be divided into two sets. The rst is from the QCD penguin diagrams where gluons are exchanged, while the second is from the electroweak penguin diagrams (where either a or a Z^0 is exchanged). The Feynman diagram for the QCD penguin diagram is shown in Fig. 2 (right) and the corresponding operators are written as follows:

4.1.2 W ilson coe cients

As we mentioned in the preceding subsection, the W ilson coe cients [23], C_i (), represent the physical contributions from scales higher than (the OPE describes physics for scales lower than). Since QCD has the property of asymptotic freedom, they can be calculated in perturbation theory. The W ilson coe cients include the contributions of all heavy particles, such as the top quark, the W bosons, and the charged H iggs boson. U sually, the scale is chosen to be of O (m b) for B decays. The W ilson coe cients have been calculated to next-to-leading order (NLO). The evolution of C () (the matrix that includes C_i ()) is given by,

Based on simple arguments at the quark level, the value of q^2 is chosen in the range $0.3 < q^2 = m_b^2 < 0.5$ [12, 27]. From Eqs. (38-41) we can obtain numerical values for C_i^0 . These values are listed in Table 2, where we have taken $_{\rm S}$ (m $_{\rm Z}$) = 0.112; $_{\rm em}$ (m $_{\rm b}$) = 1=132.2; $_{\rm m}$ $_{\rm b}$ = 5 GeV, and $_{\rm m}$ $_{\rm C}$ = 1.35 GeV.

4.1.3 E ective H am iltonian

In any phenom enological treatm ent of the weak decays of hadrons, the starting point is the weak e ective H am iltonian at low energy [28]. It is obtained by integrating out the heavy elds (e.g. the top quark, W and Z bosons) from the standard model Lagrangian. It can be written as:

4.3 CKM matrix and form factors

In phenom enological applications, the widely used representation of the CKM matrix is the W olfenstein parametrization [19]. The form factors, $V(k^2)$ and $A_j(k^2)$, depend on the inner structure of the hadrons. Here we will adopt two dierent theoretical approaches. The rst was proposed by Bauer, Stech, and W irbel [10] (BSW), who used the overlap integrals of wave functions in order to evaluate the meson-meson matrix elements of the corresponding current. In that case the momentum dependence of the form factors is based on a single-pole ansatz. The second approach was developed by Guo and Huang (GH) [29], who modied the BSW model by using some wave functions described in the light-cone framework. Nevertheless, both of these models use phenomenological form factors which are parametrized by making the assumption of nearest pole dominance. The explicit k^2 dependence of the form factor is [10, 30]:

5 M onte-C arlo simulations: computation of h_{ij} and general results

5.1 Num erical inputs

5.1.1 CKM values

In our num erical calculations we have several param eters: q^2 ; N_c^{eff} and the CKM m atrix elements in the W olfenstein param etrization. As mentioned in Section IV, the value of q^2 is conventionally chosen to be in the range $0.3 < q^2 = m_b^2 < 0.5$. The CKM matrix, which should be determined from experimental data, is expressed in terms of the W olfenstein parameters, A; c; , and [19]. Here, we shall use the latest values [31], which were extracted from charmless semileptonic B decays, (J_{ub}), charmed semileptonic B decays, (J_{ub}), s and d mass oscillations, m s; m d, and CP violation in the kaon system (J_{ub}), (J_{ub}). Hence, one has,

5.1.2 Ouark masses

The running quark masses are used in order to calculate the matrix elements of penguin operators. The quark mass is evaluated at the scale \prime m_b in B decays. Therefore one

5.1.3 Form factors and decay constants

In Table 4 we list the relevant form factor values at zero m omentum transfer [10, 29, 33] for the B ! K , B ! and B ! ! transitions. The dierent models are dened as follows: model (1) is the BSW model where the q^2 dependence of the form factors is described by a single-ansatz. Model (2) is the GH model with the same momentum dependence as model (1). Finally, we dene the decay constant for vector (f_V) meson as usual by,

Finally, the free parameter (e ective number of color, N $_{\rm c}^{\rm eff}$) is taken to lie between the lower(upper) lim its 0.66 (2.84) for b! s transition. Nevertheless, we focus our analysis on values of N $_{\rm c}^{\rm eff}$ bigger than 1, as suggested in [34]. Regarding the b! d transition, the lower(upper) lim its for N $_{\rm c}^{\rm eff}$ are 0.98 (2.01) [34].

5.2 Simulation of the 0 ! mixing

A lithe channels studied here include at least one 0 m eson which m ixes with the ! m eson. The other vector m esons are either a K 0 ; or a . Thus, the m ass of each resonance is generated according to a relativistic B reit-W igner:

where C_N is a norm alization constant. In Eq. (71), M_R and R_R are respectively the mass and the width of the vector meson which have been determined experimentally. M is the mass of the generated resonance. A simple and phenomenological relation describing

the amplitude for 0 ! mixing is used for the Monte-Carlo simulations [35]. In the expression for the Breit-Wigner, the 0 -propagator is replaced by the following one:

Because the same physical processes enter the production of both the 0 and ! resonances (they are both made out from un and dd quark pairs with the same weight 1=2), it seems natural to choose $T_!=T_i=1$. Because of the very narrow width of the !, ($_{!}$ = 8:44 M eV), we notice a high and narrow peak at the ! pole (7 82 M eV).

5.3 Density matrix h . •

Three main parameters remain free in our simulations: the ratio q^2 =m $_b^2$ (related to the penguin diagram s), the form factor model (GH or BSW) and the e ective number of colors, N_c^{eff} (associated with the factorization hypothesis). The histogram s plotted in Fig. 5 display spectra of the diagonal and normalized density matrix elements him, for the channels B 0 ! 0 (!)K 0 (left hand-side) and B $^{+}$! 0 (!) $^{+}$ (right hand-side). The input num erical param eters are q^2 =m 2 b = 0:3, N $_{\rm c}^{\rm eff}$ = 2:84 (left hand-side gure) or $N_c^{eff} = 2.01$ (right hand-side gure), and the GH form factor model is applied for both decays. Note also that the average values of CKM parameters and are used. The wide spectrum of values of the density matrix element h:, is caused by the resonance widths (especially that of the) which provides, in turn, a large spectrum for the common m om entum p_V in the B rest-fram e. W hatever the $(!)V_2$ channel is, $h_{00} = \frac{1}{2}I_0$ which corresponds to longitudinal polarization, is the dom inant value. Num erically, for the B $^{\circ}$! $^{\circ}$ (!)K $^{\circ}$ decay, the mean value of h_{00} is around 0.87 while it is of order 0.90 for B $^+$! 0 (!) $^+$. The dom inance of the longitudinal polarization has already been con mr ed experim entally, since recent experim ental data related to the channel B! J= K show clearly that the longitudinal decay amplitude dom inates in that case, with $\#_0^2 = 0.59$ 0.06 0.01 [36]. Extrapolating these results to the charm less vector m eson nal states requires som e m odi cations of the form factors without a big change of the relative contributions of the polarization states. Regarding $h = \frac{\pi}{1} + \frac{\pi^2}{1}$, it represents less than 0.5% of the total amplitude for both decays. This numerical result is con med by complete analytical calculations.

In Figs. 6 and 7, the real and imaginary parts of the non-diagonal and normalized density matrix elements $h_{i,j}$ are shown for the channels B^0 ! 0 (!) K^0 and B^+ ! 0 (!) $^+$, respectively. The input parameters are the same as previously mentioned. The main feature of the non-diagonal matrix elements, $h_{i,j}$, is the smallness of both the imaginary

and real parts { the im aginary part being at least one order of m agnitude sm aller than the real part one. For the B $^+$! 0 (!) $^+$ decay, we observe that the mean value of all the im aginary parts is zero, whereas it can vary for the other decay. Note also that each of the three real parts are quite similar for both decays. Because of the tiny value of $h = \frac{1}{1}H_{-1}\frac{1}{2}$, the moduli of the non-diagonal elements, $h_+ = H_+H_-$ and $h_0 = H_0H_-$, are very small, while the modulus of $h_{+0} = H_+H_0$ is around 0:3 for both decays. As a rst conclusion, the general behavior of the density matrix seems to be similar whatever the decay is. Experimentally, only the mean values of the diagonal elements and h_+ will be able to be measured through the angular distributions.

These angular distributions are plotted in Figs. 8 and 9 in the helicity fram e and in the transversity fram e, respectively for B $^{\circ}$! $^{\circ}$ (!)K $^{\circ}$ and for the usual input parameters. Their normalized pdfs have been displayed above in Eq. (10). As a consequence of the small value of hh₊ i, the azimuthal angle distribution in the helicity frame is nearly at, whereas it is sinusoidal in the transversity frame. From the distribution as a function of polar angle (in the TF) displayed in Eq. (13), one can infer a mean value of the H $_{\rm T}$ amplitude. This represents an additional piece of information through which one can access the dynamics of B (B) decays into two charm less hadrons.

6 Branching ratio and asymmetry in B decays into two vector mesons

The analytic expressions for the density matrix elements, h_{ij} allow us to calculate the hadronic branching ratios B (B ! 0 (!)V₂) and to estimate the asymmetries related to B and B decays. All these physical observables depend primarily on a subset of the parameters mentioned previously, such as the form factors, the ratio $q^2 = m_b^2$ (where q^2 is the mass of the virtual gluon in the penguin diagram), the elective number of colors, N $_c^{eff}$ (used as a free parameter in the framework of the factorization hypothesis), and the CKM matrix element parameters and .

6.1 Branching ratio: results and discussions

Departing from the de nition of the branching ratio (B (B! f)),

the width (B ! V_1V_2) can be inferred from its dierential form given by the standard relation [37]:

In Eq. (75), P = (M;0), where $M = m_b$ and $(E_1;p_1)$ and $(E_2;p_2)$ are the 4-m omenta of V_1 and V_2 , respectively, in the B rest frame. Because of the large width of the meson (150 MeV) and the K meson (50 MeV), the energy, E_i , and the momentum, p_i , of each vector meson vary according to the generated event. Computation of (B! $(!)V_2$) could not be done analytically but numerically by Monte-Carlo

m ethods. A total num ber of 50000 events have been generated in order to obtain a precise estimate of this decay width.

In Tables 5 and 6 we list (respectively) the branching ratios for B ! 0 (!) V_{2} and B ! 0 (!) V_{2} and their dependence on the form factor models (BSW and GH), $q^{2}=m_{b}^{2}$, N_{c}^{eff} and the average values of the CKM parameters and . For a xed value of $q^{2}=m_{b}^{2}$, there are important variations of the branching ratios, depending on the form—factor model. They can vary by up to a factor two. In the framework of a given form—factor model, some branching ratio modi cations appear with $q^{2}=m_{b}^{2}$, especially in the channels including a K . However, these changes do not exceed 34% . Regarding the ratio between B (B 0 ! 0 (!) K 0) and B (B $^{+}$! 0 (!) K $^{+}$), its value is found to be of the order 0:40 for the BSW model and 0:34 for the GH model.

Finally, we observe that the relative di erence between two conjugate branching ratios, B (B ! f) and B (B ! f), is almost independent of the form -factor models, for a xed value of $q^2 = m_b^2$. It can be computed from the two tables just mentioned and, usually, it does not exceed 20%. The exception is for the K 0 (!) channels, where it reaches 39%.

6.2 A sym m etry: results and discussions

A search for direct CP violation requires asymmetries between conjugate nal states coming from B and B decays respectively. In our case, these searches are performed in two complementary ways. We consider rst the global CP-violating asymmetry a_{CP} , calculated from branching ratios:

Secondly, we use the partial widths of B (! f) and B (! f), calculated as described above together with the di erential asymmetries investigated as a function of the invariant mass in the whole range of the 0 B reit-W igner resonance. Hence, a_{CP} (m) takes the following form:

where m is the $^+$ invariant mass. $_{\rm m}$ (B ! f) and $_{\rm m}$ (B ! f) in Eq. (77) are the partial widths written as a function of m .

In Table 7 we list the global C P -violating asymmetry between the B and B decays for the channels under investigation. It can be noticed that, for a xed value of $q^2 = m_b^2$, the two form factor models provide quite similar results. For dierent $q^2 = m_b^2$ values, the corresponding results could vary, especially in the K 0 (!) channels. In Figs. 10 and 11 we show, respectively, the histogram of the direct C P -violating asymmetry parameter $a_{\rm CP}$ (m), for the decays B 0 ! 0 (!)K 0 and B $^+$! 0 (!) $^+$, as a function of the $^+$ invariant mass in the ! mass region and for both form factor models. The asymmetry reaches its maximum when $^{1/2}$ s is around 780 M eV. However, outside the displayed windows, the asymmetry goes to zero in any case. The peak of the asymmetry is emphasized when the GH form factor model is used in our simulations. For the K 0 0(!) channels, the maximum of the CP violating asymmetry is around 13% and 16%, for the BSW model and the GH model, respectively. Finally, we emphasise that the 0 (!) channels present

the most intriguing results because, in any case, their asymmetry is at least 80% (BSW model) and can reach 95% (GH model). This last channel is highly recommended for a direct search for CP violation.

7 Perspectives and conclusions

We have studied direct CP violation in decay process such as B! 0 (!) V_2 ! $^+$ V_2 , where V_2 is either K 0 ; or , with the inclusion of 0 ! mixing. When the invariant mass of the $^+$ pair is in the vicinity of the! resonance, it is found that the CP - violating asymmetry, a_{CP} (m), reaches its maximum value. In our analysis we have also investigated the branching ratios for the same channels. Thanks to the standard helicity and transversity formalisms, rigorous and detailed calculations of the B 0 decays into two charmless vector mesons have been carried out completely. Using the elective Hamiltonian based on the operator product expansion with the appropriate Wilson coelients, we derived in detail the amplitudes corresponding to B! 0 (!) V_2 ! $^+$ V_2 decay and the density matrix, h 0 as well.

In order to apply our form alism, we used a M onte-C arb m ethod for all the num erical simulations. M oreover, we dealt at length with the uncertainties coming from the input parameters. In particular, these include the C abibbo-K obayashi-M askawa matrix element parameters, and , the elective number of colors, $N_{\rm c}^{\rm eff}$, coming from the naive factorization and two phenomenological models in order to show the possible dependence on form factors, GH or BSW. These form factors vary slightly according to the nal states. Recall that this work was achieved by applying a phenomenological treatment, where some assumptions regarding the evaluation of the hadronic matrix elements have been made. In this approach, corrections associated with the limit of validity of the factorization hypothesis were parameterized phenomenologically and may involve large uncertainties.

As a major result, the predom inance of the longitudinal polarization, h_{00} , has been pointed out in all the investigated decays. We also found a large direct CP-violating asymmetry in these B decays into two charmless vector mesons. We stress that, without the inclusion of 0 ! mixing, we would not have a large CP-violating asymmetry. Finally, we predicted branching ratios to be of the order 0:7 2:1 10 6 for K 0 0 (!) and of the order 2:3 6:6 10 6 for K 0 (!) (depending on the dierent phenomenological models). For the channel 0 (!), we found the branching ratios to be of the order 11 24 10 6 .

Two main conclusions can be drawn. The rst is the relative importance of the form factor model which is used, since some branching ratios in B $\,!\,$ 0 (!) V_2 could change by up to a factor two. The second is the important role of 0 $\,!\,$ mixing, which can enhance considerably the asymmetry parameter $a_{C\,P}$, between the conjugate $\,$ nal states coming, respectively, from B and B decays.

Beside the \standard" ways to look for direct CP violation, such as the di erence between branching ratios and/or discrepancies in the angular distributions of the decay products, we have presented a detailed discussion of a new method. This involves the variation of $a_{\rm CP}$ as a function of the ⁺ invariant m assover the whole range of the ⁰ resonance [12, 34]. We believe that this method will be very fruitful for future experiments and has already been in plemented in the generator of the LHCb experiment. Indeed, we look forward to being able to apply the formalism developed here to the analysis of

experim ental data for decays such as B ! 0 (!) V_{2} (with V_{2} being either a K or a) in the near future.

The weak hadronic amplitude is therefore decomposed, in the helicity basis, according to the general method developed by Bauer, Stech and W irbel [10]. This will allow one to obtain two interesting results. Firstly, one can isolate the contribution of each helicity state to the total amplitude. Secondly, the contributions of the tree and penguin operators to the total amplitude can be separated via the helicity states.




Figure 1: Transversity frame for B ! 0 K .




Figure 2: Tree diagram (left), and QCD-penguin diagram (right), for B decays.




Figure 3: Electroweak-penguin diagram (left), and electroweak-penguin diagram with coupling between Z; and W (right), for B decays.




Figure 4: Spectrum of 0 ! m ixing (in M eV $/c^{2}$), simulated by the interference of two B reit-W igner curves.




Figure 5: Spectrum of h ; h_{00} ; h_{++} . Histograms on the left correspond to the channel B 0 ! 0 (!)K 0 where the parameters used are: q^2 =m 2 _b = 0.3, N $_c^{eff}$ = 2.84, = 0.229; = 0.325 and form factors from the GH model. Histograms on the right correspond to the channel B $^+$! 0 (!) $^+$ for the same parameters with N $_c^{eff}$ = 2.01.




Figure 6: Spectrum of Re(h_{ij}) and I m (h_{ij}) where i \in j. Histograms correspond to channel B⁰! ⁰(!)K ⁰ where the used parameters are: $q^2 = m_b^2 = 0.3$, N $_c^{eff} = 2.84$, = 0.229; = 0.325 and form factors from the G H m odel.




Figure 7: Spectrum of Re(h_{ij}) and I m (h_{ij}) where i \in j. Histograms correspond to the channel B $^+$! 0 (!) $^+$ where the used parameters are: $q^2 = m^2_b = 0.3$, N $_c^{eff} = 2.01$, = 0.229; = 0.325 and form factors from the G H m odel.




Figure 8: Spectrum of polar angle (upper gure) and azim uthal angle (lower one) in the helicity frame for the channel B 0 ! 0 (!)K 0 . Parameters used are: q^{2} =m 2 b = 0:3, N $_{c}^{eff}$ = 2:84, = 0:229; = 0:325 and form factors from the G H m odel.




Figure 9: Spectrum of polar angle (upper gure) and azimuthal angle (lower one) in the transversity frame for the channel B 0 ! 0 (!)K 0 . Parameters are: q^{2} =m 2 _b = 0:3, N $_{c}^{eff}$ = 2:84, = 0:229; = 0:325 and form factors from the G H m odel.




Figure 10: CP-violating asym m etry param eter a_{CP} (m), as a function of the invariant m ass in the vicinity of the! m ass region for the channel B 0 ! 0 (!) K 0 . Param eters are: q^2 =m 2 _b = 0:3, N $_c^{eff}$ = 2:84, = 0:229; = 0:325. Solid triangles up and circles correspond to the BSW and GH form factor models respectively.




Figure 11: CP-violating asymmetry parameter a_{CP} (m), as a function of the 'invariant m ass in the vicinity of the! mass region for the channel B'! '(!) '. Parameters are: q^2 =m 2 _b = 0:3, N $_{\text{C}}^{\text{eff}}$ = 2:01, = 0:229; = 0:325. Solid triangles down and circles correspond to the BSW and GH form factor models respectively.
