# R ole of baryonic resonances in the dilepton em ission in nucleon-nucleon collisions

W thin an e ective Lagrangian $m$ odel, we present calculations for cross sections of the dilepton production in proton-proton and proton-neutron collisions at laboratory kinetic energies in $1-5 \mathrm{GeV}$ range. P roduction am plitudes include contributions from the nucleon-nucleon brem sstrahlung as w ell as from them echanism ofexcitation, propagation, and radiative decay of (1232) and N (1520) interm ediate baryonic resonances. It is found that the delta isobar term $s$ dom inate the cross sections in the entire considered beam energy range. O ur calculations are able to explain the data of the D LS collaboration on the dilepton production in proton-proton collisions for beam energies below 1.3 GeV . H ow ever, for incident energies higher than this the inclusion of contributions from other dilepton sources like $D$ alitz decay of 0 and $m$ esons, and direct decay of ${ }^{0}$ and $!\mathrm{m}$ esons is necessary to describe the data.

[^0]D ileptons observed in the nucleus-nucleus collisions travel relatively unscathed from the production point to the detector. Therefore, they are expected to provide clear inform ation about the early dense and hot stage of heavy ion collisions [1\{3], which is in contrast to the hadronic probes which often su er from strong nal state interactions and the infor$m$ ation about the collision history carried by them $m$ ay be lost due to the rescattering in the expansion phase [4]. O ne of the phenom ena predicted [5\{13] at higher nuclear $m$ atter densities is the restoration of chiral sym $m$ etry which is $m$ anifested in the $m$ odi cation of $m$ asses of the vector $m$ esons as a function of the nuclear $m$ atter density. C onsequences of this e ect can be observed in the dilepton ( $e^{+} e$ ) spectra $m$ easured in nucleus-nucleus collisions [14]. E nhancem ents (above known souroes) observed in the m easured [15,16] soft lepton pair production cross sections in heavy ion collisions at the SP S energies, have been attributed [17\{21] to in $m$ edium $m$ odi cations of the vector $m$ eson propenties rather than to re ection of a new state of hadronic $m$ atter. A though, such a scenario has not been fully successfiul [22\{24] in explaining the dilepton spectra $m$ easured in these reactions at $m u c h$ low er beam energies (a few $\mathrm{GeV} /$ nucleon) [25] where the tem perature and density regim $e$ is di erent and one does not expect a phase transition.

In this context, the investigation of the dilepton production in elem entary nucleonnucleon ( $N$ N) collisions is of interest because the corresponding cross sections enter in the transport $m$ odel calculations of the $e^{+} e$ spectra in the heavy ion collisions. Therefore, a quantitative understanding of this process is a natural prerequisite to an unequivocal determ ination of in m edium e ectsm entioned above. The study ofthis process is of interest in its own right as it is expected to provide deeper insight into the hadronic structure and the photon-hadron interactions. This investigation $m$ ay give fundam ental inform ation on the electrom agnetic form factor of the nucleon in the tim e-like region around the vector-m eson $m$ asses which is otherw ise hard to access (see, e.g., [4]).

It hasbeen known for som e tim e that interm ediate baryonic resonancesplay an im portant role in the dilepton production in the N N collisions. D alitz decay of the isobar has been shown to be a strong dilepton production channel [26\{28]. The im portance of the baryonic resonance N (1520) has ben em phasized for this process in Refs. 29,30 ] where it is pointed out that the subthreshold production (and its subsequent decay) via this resonance $m$ akes im portant contributions to the dilepton spectrum observed in the protonproton ( pp ) collisions. T herefore, the investigation of the dilepton production is expected to provide a useful tool to probe the param eters (e:g:, coupling constants, form factors etc.) of the nucleon-resonance-photon vertioes and $m$ asses and $w$ idths of the relevant nucleon resonances.

The aim of this paper is to investigate the dilepton production in nucleon-nucleon collisions in the beam energy range of $1-5 \mathrm{GeV}$ w thin an e ective Lagrangian model (ELM) which has been successfiully applied to the description of pion and associated kaon production in pp collisions [31\{33]. Initial interaction between two incom ing nucleons is m odeled by an e ective Lagrangian which is based on the exchange of the , , and mesons. The coupling constants at the nucleon-nucleon-m eson vertioes are determ ined by directly tting the $T \mathrm{~m}$ atrices of the nucleon-nucleon (NN) scattering in the relevant energy region. $T$ he e ective Lagrangian uses the pseudovector (PV) coupling for the nucleon-nucleon-pion
vertex and thus incorporates the low energy theorem s of current algebra and the hypothesis ofPCAC.The $e^{+}$e production proceeds via excitation, propagation and radiative decay of
(1232) and N (1520) baryonic resonance states. A lso included are the nucleon interm ediate states (which gives rise to the $\mathrm{N} N$ brem sstrahlung contribution). The interference term S between various am plitudes are taken into account. The gauge invariance at the electrom agnetic vertices is preserved in our calculations. O ur m odel is sim ilar in spirit to those of Refs. [28,34,35]. H ow ever, in Ref. [35] no resonance contribution was considered whereas in Ref. $[28,34]$ resonance contributions were lim ted to the isobar only. The latter, though, did include the interference betw een the nucleon and term s . In calculations presented in Refs. [29,30,36], N N brem sstrahlung contributions were ignored. W e would like to stress that in Refs. 29,30$]$ constant $m$ atrix elem ents have been used for various processes and the total dilepton production cross sections have been calculated by adding the corresponding cross sections and not the am plitudes, so part of the $m$ otivation of the present study is the investigation of the so far neglected quantum mechanicale ects.

W e investigate the role of baryonic resonances in the invariant $m$ ass spectrum of the dilepton produced in proton-proton and proton-neutron collisions at various beam energies in the $1-5 \mathrm{GeV}$ range. To this end, we present the rst eld theoretic calculation of the dilepton production in N N collisions where excitation, propagation and radiative decay of the N (1520) baryonic resonance are fully accounted for. W e also com pare our calculations w ith the published data [37] on the dilepton production in elem entary proton-proton collisions, by the D ilepton Spectrom eter (D LS) collaboration. In order to describe these data the contributions from other dilepton souroes ( ${ }^{0}$ and $D$ alitz decay and direct decay of ${ }^{0}$ and ! m esons) have also been considered.

The rem ainder of this paper is organized in the follow ing way. Section II contains details of our theoretical approach. Section III com prises the results of our analysis and their discussions. The sum m ary and conclusions of our work is presented in Sec. IV .

## II. FORMALISM

A representative of the lowest order Feynm an diagram s contributing to the dilepton production as considered by us, is show $n$ in F ig. 1. T he interm ediate nucleon or resonances can radiate a virtual photon which decays into a dilepton ( $F$ igs. 1 a and 1 b ). There are also their exchange counterparts. In addition, there are diagram s of these types where the virtual photon is em itted from the nucleon line on the right side. The intemalm eson lines can also lead to dilepton em ission (see F ig 1c). M om enta of various particles are indicated in F ig. $1 \mathrm{a} . \mathrm{q}, \mathrm{p}_{\mathrm{i}}$, and k are four m om enta of the exchanged m eson, the interm ediate resonance (or nucleon) and the photon, respectively. To evaluate various am plitudes, we have used the e ective Lagrangians for the nucleon-nucleon-m eson, resonance-nucleon-m eson, nucleon-nucleon-photon and resonanœ-nucleon-photon vertices. These are discussed in the follow ing subsections.

## A. $\mathrm{Nucleon-nucleon-m} \mathrm{eson} \mathrm{vertex}$

As done before in the investigation of pp! pp ${ }^{0}$, pp! $\mathrm{pn}^{+}$[31] and pp! $\mathrm{p}^{+} \mathrm{K}^{+}$[33] reactions, the param eters for these vertioes are determ ined by tting the $\mathrm{N} N$ elastic scattering $\mathrm{T} m$ atrix w ith an e ective $\mathrm{N} N$ interaction based on the , , ! and $m$ eson exchanges. The e ective m eson-N N Lagrangians are (see, e.g., $[38,39]$ )

In Eqs. (1)-(4), we have used the notations and conventions of B jorken and D rell [40] and de nitions of various term $s$ are the sam e as those given there. In Eq. (1) $\mathrm{m}_{\mathrm{N}}$ denotes the nucleon m ass. It should be noted that we use a PV coupling for the $\mathrm{N} N$ vertex. Since these Lagrangians are used to directly model the N N T m atrix, we have also included a nucleon-nucleon-axial-vector-isovector vertex, w ith the e ective Lagrangian given by

where A represents the axial-vectorm eson eld. This term is introduced because ifthem ass of the axialm eson $A$ is chosen to be very large ( $m_{N}$ ) [28] and $g_{N N A}$ is de ned as

it cures the unphysicalbehavior in the angular distribution of N N scattering caused by the contact term in the one-pion exchange am plitude. It should be $m$ entioned here that A is di erent from the $a_{1}$ (1260) m eson resonance to be discussed later on. The role of the A vertex is to explicitly subtract out the contact term of the one-pion exchange part of the N N interaction. Sim ilar term in the coordinate space potential is e ectively sw itched o by the repulsive hard core.

At each interaction vertex, the follow ing form factor is introduced
$w$ here $q_{i}$ and $m_{i}$ are the four $m$ om entum and $m$ ass of the ith exchanged $m$ eson and $i$ is the corresponding cut-o param eter. The latter govems the range of suppression of the contributions of high $m$ om enta which is done via the form factor. Since $N N$ scattering cross sections decrease gradually w ith the beam energy (beyond certain value), and since we $t$ the elastic T m atrix directly, the coupling constants are expected to be energy dependent. Therefore, while keeping the cut-o s i [in Eq. (7)] energy independent, we take energy dependent $m$ eson-nucleon coupling constants of the follow ing form

here $s$ is the square of the totalCM energy. The param eters $g_{0}, ~ `$, and were determ ined by tting to the $T \mathrm{~m}$ atrix to the relevant proton-proton and proton-neutron scattering data at the beam energies in the range of 800 M eV to 4.00 GeV [28]. This procedure also xes the sign of the e ective Lagrangians $\mathbb{E}$ qs. (1)-(5)]. The values of various param eters are shown in Table I the signs of all the coupling constants ( $g$ ) are positive]. In this table the param eters of the A exchange vertex are not explicitly shown as they are related to those of the pion via Eq. (6). The $m$ ass of the A $m$ eson is taken to be 18 GeV . The sam e param eters w ere also used to describe the initialN N interaction in the calculations reported in Refs. $28,31,33]$. This ensures that the elastic $N N$ elastic scattering channel rem ains the

sam e in the description of various inelastic processes within this m odel, as it should be.
The exchange of $a_{1} m$ eson ( $m$ ass $=1260 \mathrm{M} \mathrm{eV}$ ), which is the chiralpartner of the $m$ eson has also been considered by some authors [41] in the description of the $\mathrm{N} N$ interaction. H ow ever, its contribution there is $m$ asked to a considerable extent by the strong shortranged repulsion originating from ! exchange. M oreover, as can be seen from Table I, the values of the cut-o param eters appearing in the form factors $\mathbb{E q}$. (7)] are in the region of $1.0-2.0 \mathrm{G} \mathrm{eV}$. Therefore, it does not seem m eaningfiul to include exchange of m esons w th m asses lying in the region where m odi cations due to the extended structure of hadrons are applied. $N$ evertheless, $a_{1} m$ eson (if included) can contribute to the dilepton spectrum through diagram s like the one shown in Fig. 1 (c). H ow ever, the couplings of this $m$ eson to nucleons and resonances are largely unknown. In any case, contributions of such processes are expected to be of relevance only for the dilepton invariant m asses $>1.5 \mathrm{GeV}$ [42]. This region is excluded by the D LS data. D ue to these reasons we have not inchuded the exchange of $\mathrm{a}_{1} \mathrm{~m}$ eson in our calculations.

## B. Resonance-nucleon-m eson vertex

In addition to nucleonic interm ediate states (N N brem sstrahlung), we have considered in this work also the contributions from the (1232) isobar and $N$ (1520) nucleon resonance interm ediate states. The latter is a spin $-\frac{3}{2}$ negative parity resonance. W hile only and $m$ esons couple to isobar, all of the four exchanged $m$ esons, nam ely, , , !, and can couple to N (1520) resonance.

For spin $-\frac{3}{2}$ resonances, we use the follow ing e ective Lagrangians [43]

Here, ${ }^{R}$ is the vector spinor for the spin $-\frac{3}{2}$ particle. In Eqs. [(9) - (12)], the operator

is unity for even parity resonance and 5 for the odd parity one, whereas is 5 for the even parity resonance and unity for the odd parity one. Them eson elds in above equations need to be replaced by (where corresponds to , , ! or $m$ eson elds) and $T$ (where $T$ and are the isospin transition operator and Pauli isospin $m$ atrices, respectively) for isospin $-\frac{1}{2}$ and isospin $-\frac{3}{2}$ resonances, respectively. The values of the coupling constants $g$ N and $g \mathrm{n}$ are show n in Table II; these are the sam e as those determ ined in Ref. [28] by tting to experim entaldata on pp! $n^{++}$reaction at kinetic energies in the range of1-2 $\mathrm{GeV} . \mathrm{We}$ have assum ed that the o-shell dependence of the resonanœ-nucleon vertex is determ ined solely by m ultiplying the vertex constant by a form factor. Sim ilar to $R$ ef. [28,31], we have used the follow ing form factor for the vertioes
w ith the values of the cut-o param eters as and asgiven in Table II which are exactly the sam e as those used earlier $[28,31,33]$.

For the N N and N N vertices the coupling constants have been determ ined from the observed branching ratios for the decay of the resonance to N and N channels, respectively. In the later case the nite lifetim e for the decay ! has been taken into account by introducing an integration over the corresponding phase space. The details of this $m$ ethod are provided in Ref [33]. The coupling constants $g_{N} N$ ! and $g_{N} N$ are deter$m$ ined by vector $m$ eson dom inance (VM D) hypothesis [44] and from the branching ratio of the decay of this resonance into the two pion channel [33], respectively. It should be noted that there is considerable uncertainty in the latter two coupling constants. H ow ever, the contributions of these term $s$ to the total dilepton production am plitude are alm ost negligible. A s branching ratios determ ine only the square of the corresponding coupling constants, their signs rem ain uncertain in this $m$ ethod. P redictions from the independent calculations can, how ever, be used to constrain these signs $[43,45,46]$. G uided by the results of these studies, we have chosen the positive sign for the coupling constants for these vertices. The values of various coupling constants are given in Table II.

A $s$ in Refs. $[43,44]$, we have used the follow ing form factor for the $N \mathrm{~N}$ vertioes
$w$ th the value of the cut-o param eter being 0.8 GeV in all the cases. It $m$ ay how ever be $m$ entioned that identical results $w$ ill be obtained if one uses the form factor as given by Eq. (13) w ith di erent cut-o param eters.

## C. N ucleon-nucleon-photon vertex

In the nucleonic brem sstrahlung process ofdilepton production the interm ediate nucleon is necessarily o -shell. The general form of the e ective Lagrangian is given by

In Eq. T$ he factor $\mathrm{F}_{3}$ is not independent but is constrained by the W ard-Takahashi identity [50] (i.e. by the requirem ent of gauge invarianœ)

where $\mathrm{e}_{\mathrm{v}}$ is the nucleon charge in units of je j.
In this work, we have adopted the procedure followed in Refs. [28,51] where one uses the on-shell form of the vertex function also for the $o$-shell $m$ om enta. This $m$ eans, one assum es $F_{1}^{+}=F_{1}=F_{1}$ and $F_{2}^{+}=F_{2}=F_{2}$ and $F_{3}^{+}=F_{3}=0$. This vertex does not in general satisfy gauge invariance. H ow ever, this can be achieved (see also [52]) by multiplying the extemal photon em ission vertioes by the same form factors that $m u l t i p l y$ the hadronic vertioes Eq. (7)] and by multiplying the intemal photon production diagram s by the follow ing additional factor:

$w$ here $q_{1}$ and $q_{2}$ are the four $m$ om entum transfers at the left and right vertioes, respectively. In this way various electrom agnetic form factors can be im plem ented for the hadronsw ithout loosing gauge invariance. Unfortunately, there are problem s and ambiguities in the the selection of form factors $\mathrm{F}_{1 ; 2}$ (see e.g., [53] for a detailed discussion). It has been show n already in Ref. [28] that $N \mathrm{~N}$ brem sstrahlung contributions depend sensitively on the choice of these form factors and that cross sections calculated with no form factors are closest to the data. In our calculations, we have used the prescription $[43,53]$ of using no form factors at the electrom agnetic vertiges of the nucleon term and replacing $F_{1}$ by the nucleon charge and $F_{2}$ by nucleon anom alous $m$ agnetic $m$ om ent.

## D. Resonance-nucleon-photon vertex

For spin- $\frac{3}{2}$ resonance-nucleon- vertiges, the form of the vertex functions is

where $Z$ is 5 for the even parity resonance and unity for the odd parity one. Values of the coupling constants $g_{1}, g_{2}$, and $g_{3}$ used in our calculations are shown in Table III. T he rst two are taken from [43], while the last one from [54]. The vertex function given by Eq. (19) ful lls gauge invariance [55] by the way of its construction.

It should be noted that the vector spinor vertioes Eqs. (9)-(12) and (19)] should in addition be contracted by an 0 -shell projector $\quad(z)=9 \quad \frac{1}{2}(1+2 z) \quad$ where $z$ is the o -shell param eter $[43,56]$. This operator describes the o -shell adm ixture of spin$\frac{1}{2}$ elds [57]. The choice of the 0 -shell param eter $z$ is arbitrary and it is treated as a free param eter to be determ ined by tting the data. H ow ever, recently, the authors of Ref. [58] have proposed a di erent $N$ interaction which leads to am pltudes where spin $-\frac{1}{2}$ com ponents of the R arita-Schw inger propagator (see in section E) drop out, thus $m$ aking the o -shellparam eters redundant (see, e:g:, 53,58$]$ for further details). The full im plication of this prescription on observables calculated w ithin the e ective Lagrangian m odelw illbe investigated in future. In the present study we w onk w ith the couplings given by Eqs. (9)-(12) and (19).

## E.P ropagators

In the calculation of the am plitudes, the propagators for various $m$ esons and nucleon resonanœes are required. For pion, $m$ eson and axial-vector $m$ esons, they are given by

In Eq. (22), the $m$ ass of the axialm eson is taken to be very large, as the corresponding am plitude is that of the contact term. The propagators for ! and $m$ esons are sim ilar to those given by Eqs. (21) and (20), respectively.

In Eqs. (24), $R$ is the totalw idth of the resonance which is introduced in the denom inator term ( $\rho^{2} m_{R}^{2}$ ) to account for the fact that the resonances are not the stable particles; they have a nite life time for the decay into various channels. $R$ is a function of the center of $m$ ass $m$ om entum of the decay channel, and it is taken to be the sum of the corresponding w idths for its decays to pion and rho channels (the other decay channels are considered only im plicitly by adding their branching ratios to that of the pion channel):

The partialdecay width $R$ ! $N$ is calculated in the sam eway as in Ref. [33]. This m ethod is also identical to that used in Ref. [29]; the only di erence is that while Ref. [33] uses a fully relativistic expression, that em ployed in [29] is its non-relativistic counterpart. The partial width $R!\mathrm{N}$ is taken as [29]

In Eq. (26), ` and 0 are 2 and 0.095 GeV for the N (1520) resonance, and 1 and 0.120 GeV for isobar, respectively.

It should be noted that no width is included in the propagator Eq. (21)] as it corresponds to a exchange process betw een tw o nucleons where $q^{2}$ is in the space-like region and hence $m$ eson has a zero width. H ow ever, this width is nite in the propagator in, e.g., $N N!N N!N N e^{+} e$ process where the corresponding $m$ om entum is tim e-like.

## F.Amplitudes and cross sections

A fter having established the e ective Lagrangians, coupling constants and form of the propagators, we can now proceed to calculate the am plitudes for various diagram s associated with the NN! NN e $e$ reaction. These am plitudes can be w ritten by follow ing the well know $n$ Feynm an rules [50] and calculated num erically. It should be stressed here that the signs of the various am plitudes are xed, by those of the e ective Lagrangians, coupling constants and the propagators as described above. T hese signs are not allow ed to change anyw here in the calculations.

The general form ula for the invariant cross section of the $N+N \quad N+N+e^{+} e$ reaction is w ritten as
where $A^{f i}$ represents the total am plitude, $P_{i}$ and $P_{f}$ the sum of all the $m$ om enta in the initial and nalstates, respectively, and $\mathrm{p}_{\mathrm{a}}$ the m om enta of the particles in the nal state. In Eq. (28) $m_{e}$ represents the $m$ ass of the electron. The term $j A^{f i}$ jalready includes a sum over nal spin and average over initial spin degrees of freedom of all particles. M ore details of the evaluation of Eq. (28) are given in appendix A.

III.RESULTSAND D ISCUSSIONS

In Fig. 2, we show the invariant m ass spectra for dilepton production in both pp and pn collisions at bom barding energies of $1.04 \mathrm{GeV}, 2.09 \mathrm{G} \mathrm{eV}$ and 4.88 G eV . It can be noted that in all the cases the dom inant contribution arrises from the interm ediate states consisting of the isobar resonance. In fact the total yields are alm ost equal to the contributions of the am plitude alone. The pn cross sections are about a factor of 2-3 larger than those for the pp reactions even at the higher beam energy of 4.88 G eV . For beam energies of 1.04 GeV and 2.09 GeV , the contributions of the N (1520) term s are sim ilar to those of the N N brem sstrahlung processes for the pp collisions, while for the pn case the latter are larger than the form er. H ow ever, at 4.88 GeV , the N channel prevails over the brem sstrahlung one in both cases. A ny way, the isobar production term s are still dom inant even at this high energy.

T he contributions of the nucleon brem sstrah lung process (graphs involving only interm ediate nucleon lines) are considerably larger in case of pn reaction as com pared to those for the pp case for all the beam energies. W e do not observe the reversal of this trend at 4.88 GeV as seen in the soft-photon $m$ odel calculations of Ref [27] (where $\mathrm{N} N$ brem sstrahlung is larger for pp reaction as com pared to that for pn one). On the other hand, if the o-shell behavior of the e ective NN interaction is described by using a $T \mathrm{~m}$ atrix which includes the degrees of freedom, instead of the $m$ eson exchange $m$ echanism as em ployed in our m odel, the pp brem sstrahlung contributions tum out to be larger than those of ours at the bom barding energy of 1 GeV . Yet due to lack of calculations for the pn case, it m ay not be possible to m ake com m ents about the relative pp and pn brem sstrahlung contributions w ithin this approach. In any case, the coherent sum of the and brem sstrahlung term $s$ as obtained with in our $m$ odel are sim ilar to those calculated $w$ ith the $T \mathrm{~m}$ atrix m ethod.

The role of the interference e ects betw een various term $s$ is investigated explicitly in F ig. 3 w here we com pare the cross sections obtained by coherent and incoherent sum $m$ ations of the am plitudes corresponding to various processes shown in Fig. 2. The form er are the sam e as those show $n$ by solid lines in $F$ ig. 2. It is already noted in $F$ ig. 2 that the delta

contributions are slightly larger than the total ones at the larger m ass end of the spectrum for all the beam energies in both the cases. In Fig. 3, one can fiurther see that the interference e ects are notioeable tow ards the larger $m$ ass ends of the spectra for beam energies below 4.88 G eV in case of pp collisions. For the 4.88 G eV case these e ects show up also at lower values of the invariant $m$ ass. O $n$ the other hand, they are relatively sm aller for the pn case everyw here.

C ontributions of various term $s$ to the excitation function (integrated dilepton cross section) are shown in Fig. 4 for the pp (top) and pn (bottom) collisions. The totalcross section at 1.04 GeV is slightly larger than that at 1.27 G eV in both the cases. H ow ever, after this it rises $m$ onotonously $w$ th the beam energy. The delta isobar term $s$ dom inate the total production yields for all the beam energies. Forpp collisions, $N \mathrm{~N}$ brem sstrahlung and $N$ (1520) term s are of sim ilarm agnitude except at the beam energy of 4.88 G eV where the latter term is larger than the form er. H ow ever, in the pn case, the $\mathrm{N} N$ brem sstrahlung contributions are larger than those of the $N$ (1520) at low er beam energies while the tw o term s contribute sim ilarly at 4.88 G eV . Furthem ore, the di erence in the interference e ects of

various term $s$ in two case, should also be noted. C ross sections obtained by coherent (show $n$ by open circles) and incoherent (show $n$ by plus signs) sum $m$ ations of the am plitudes di er very slightly for all the beam energies in case of the pn collisions and at energies sm aller than 4.88 G eV for the pp case. This can be understood from the fact that the regions where the interference e ects are visible in Fig. 3, contribute very little to the integrated cross sections for these cases. H ow ever, the interference e ects do show up even in the totaldilepton yields for pp collisions at 4.88 GeV beam energy.

The cross sections shown in Figs. 2 and 3 can not be com pared data of the D LS collaboration. They have to be folded w ith appropriate experim ental lter, which is a function of the invariant $m$ ass $(M)$, transverse $m$ om entum ( $p_{I}$ ) and the rapidity in the laboratory frame ( $\mathrm{y}_{\mathrm{lab}}$ ) of the produced dileptons. W e have used the D LS acceptance lter (version 4.1) in the folding procedure. In Fig. 5, we present a com parison of the folded invariant $m$ ass spectra (which also include the nalm ass resolution [29]) and the data from the D LS collaboration. We note that at the beam energies of 1.04 GeV and 1.27 GeV the e ective Lagrangian $m$ odel calculations are able to describe the data reasonably well in the region of

M $>0.1 \mathrm{GeV} . \mathrm{H}$ owever, at beam energies higher than 127 GeV , our calculations fail to reproduce the data, being lower than them by factors ranging from 2-20. C learly, w ith increasing beam energy, other dilepton sources becom e im portant; these include $D$ alitz decays of hadrons ( ${ }^{0}$, and !) [23,29,30], direct decay of ! and ${ }^{0} \mathrm{~m}$ eson to dileptons, processes leading to multi-hadronic nal states [27] and two pion annihilation [60]. N evertheless, it is encouraging that the present e ective Lagrangian $m$ odel is able to account for the dilepton yields in pp collisions at beam energies around 1.0 GeV . Therefore, this theory could be usefiul in $m$ aking predictions for the dilepton spectra to be $m$ easured by the HADES spectrom eter at G SI, for beam energies in this region.

In order to study the role of other dilepton production processes not considered in the present e ective Lagrangian $m$ odel, we have included the contributions of the $D$ alitz decays:
${ }^{0}!e^{+} e$ and ! $e^{+} e$, and the direct decays ${ }^{0}!e^{+} e$ and!! $e^{+} e$. The details of these calculations are described in Ref. [29] and im portant relevant form ulas are listed
in appendix B. The cross sections of these processes were incoherently sum $m$ ed to those of the totalm ass di erential cross sections (solid lines in Fig. 5) of the ELM. The results are show $n$ in $F$ ig. 6 together w ith the D LS data. At the beam energies of 1.04 GeV and 1.27 GeV , we have shown explicitly only the contributions of ${ }^{0}$ and ${ }^{0}$ and decay processes, respectively together w ith the ELM results as cross sections for the other decay channels are insigni cant here. At incident energies of 1.61 GeV and 1.85 GeV we show in addition the contributions of ${ }^{0}$ direct decay also; the ! direct decay is insigni cant at these energies. H ow ever, at 2.09 GeV and 4.88 GeV , contributions of all the decay channels as m entioned above are shown explicitely.

It is clear that now the data can be described reasonably well for all the beam energies. This com parison suggests that the low est points in the $m$ ass distributions of the dilepton stem from the ${ }^{0} \mathrm{D}$ alitz decay. The D alitz decay is im portant at the interm ediate m asses for beam energies between 1.61 GeV to 4.88 G eV , while ${ }^{0}$ and! direct decay processes are im portant at higher $m$ ass ends of the spectra for these beam energies. In addition to these processes, the multi-hadron nal state brem sstrahlung mechanism could also contribute signi cantly in the low mass region at the beam energy of 4.88 GeV [27]. W e would like to $m$ ention that although several processes are included in our results show $n$ in $F$ ig. 6, the double counting problem is unlikely to be present there. The D alitz decay and the direct decay processes ofdilepton production are excluded from thee ective Lagrangian treatm ent. Furtherm ore, we have not considered the processes like NN! NR! NN ${ }^{0}$ ! $N N e^{+} e$ (term ed as the subthreshold resonance production). Therefore, problem s of double counting in the vector $m$ eson direct decay contributions as suggested in $R$ ef. [61], are not present in our calculations.
IV.SUMMARYAND CONCLUSIONS

W e investigated the dilepton production in the nucleon-nucleon collisions at beam energies in the range of $1-5 \mathrm{GeV}$ within an e ective Lagrangian model, which in proven to describe well the pion and kaon production in N N collisions. M ost of the param eters of this modelare xed by tting to the elastic N N T matrix; this restricts the freedom of varying the param eters of the m odelto provide a $t$ to the data. A long w th the $N \mathrm{~N}$ brem sstrahlung process, the $m$ odel also includes the excitation, propagation and radiative decay of (1232) and N (1520) interm ediate nucleon resonant states. The coupling constants at vertioes involving resonances have been determ ined from the experim ental branching ratios of their decay into various relevant channels. The interference term $s$ am ong various am plitudes are inchuded in the total T m atrix.

The reaction proceeds predom inantly via excitation of the interm ediate state in the entire beam energy range considered in this work. The contributions of $N$ (1520) term $s$ are relatively sm all. The N N brem sstrahlung contributions are also weak in com parison to those of the delta isobar except for the higher $m$ ass region of the invariant $m$ ass spectra at the beam energy of 1.04 GeV . In this region of these spectra considerable interference between various term $s$ is also visible. For the case of pp collisions, the N N brem sstrahlung and $N$ (1520) contributions are sim ilar in $m$ agnitude at low er beam energies. H ow ever, for the pn case, the form er is larger than the latter at these energies. On the other hand, for the beam energies of $4.88 \mathrm{GeV}, \mathrm{N}$ (1520) term s are larger than those of the brem sstrahlung
in both the cases. A key result of our study is that the pn brem sstrahlung is stronger than the pp one even at the beam energy of 4.88 G eV .

At the low er beam energies ( 1.04 GeV and 1.27 GeV ), the e ective Lagrangian m odel calculations are able to explain the data of the D LS collaboration for the invariant $m$ ass distribution of dilepton em ilted in pp collisions except for the low est m ass point. This is encouraging in the context of the analysis of the new experim ental data on the dilepton production expected shortly from the HADES collaboration at G SI, D arm stadt.

H ow ever, at higher beam energies ( $1.61 \mathrm{GeV}, 1.85 \mathrm{GeV}, 2.09 \mathrm{GeV}$ and 4.88 GeV ), the e ective Lagrangian $m$ odel underpredicts the D LS data. This indicates that $w$ ith increasing energy, other dilepton production souroes becom e im portant. To stress this point further, we incoherently sum $m$ ed the ${ }^{0}$ and $D$ alitz decay and ${ }^{0}$ and! direct decay contributions to the cross sections of the ELM. W ith this procedure, it is possible to provide a good description of the D LS data on the invariant $m$ ass distribution at all the beam energies. T his also rem oves the discrepancy observed between the e ective Lagrangian model calculations and the D LS invariant $m$ ass distribution data for the low est $m$ ass point at the beam energies of 1.04 GeV and 1.27 GeV .

O ur study has clari ed the role of and $N$ (1520) interm ediate baryonic resonance states in the dilepton production in the $\mathrm{N} N$ collisions. The interference e ects of various term s are visible tow ards the large invariant $m$ ass ends of the spectra for proton-proton collisions. H ow ever, the D LS experim ental lter e ectively cuts o this m ass region. Therefore, these e ects do not show up when calculations are com pared with the data. This may imply that an incoherent com bination of resonance and decay contributions is su cient to explain the D LS data. H ow ever, w ith im proved quality of the data this im pression could change. T herefore, precise data where also the hadrons in the nal channel are detected would be weloom e. Thisw ould put constraint on them odels calculating the role of variousm echanism s in the dilepton production in nucleon-nucleon collisions. The present e ective Lagrangian approach should be im proved by including the am plitudes for the decay processes also so that they can be sum $m$ ed coherently w ith the am plinudes of the other channels considered already.

> APPENDIX A: SOMEDETAILS OF THE PHASE SPACEAND THE AMPLITUDE

In this appendix we give additional details of the calculation of the four-body phase space factor and the am plitude $\mathrm{A}^{\text {fi }}$.

The kinem atical situation for calculating the di erential cross section Eq. (28)] is illustrated in $F$ ig. 7 where $p_{1}$ and $p_{2}$ depict the initialm om enta of tw o nucleons while $p_{3}$ and
$p_{4}$ their nalm om enta. Them om enta of $e^{+}$and $e$ are show $n$ by $p_{+}$and $p$, respectively. $P$ represents half of the total center of $m$ ass (CM) dilepton $m$ om entum. The di erential cross section can be w ritten as

where $Q_{L}=P \quad-P$ and $Q_{N}=p_{3}+P .1_{2}$ and 2 are angles between $P$ and $Q_{L}$, and $P$ and $Q_{N}$, respectively. In Eq. (A 1), we have de ned $E_{1+}=E_{+}+E$ and $E_{1}=E_{+} \quad E$, where $E_{+}$and $E$ are energies of $e^{+}$and $e$, respectively. $E_{p}$ and $\mathcal{P}_{p} j$ are the energy and m om entum of the projectile nucleon in the CM system. The invariant $m$ ass of the dilepton is given by, $M^{2}=\left(p_{+}+p\right)^{2}$. Integrations over the residual degrees of freedom in the di erential cross section Eq. (A 1] are carried out by using the $M$ onte $C$ arlo techniques.

A total num ber of 90 diagram $s$ [ 42 for $N \mathrm{~N}$ brem sstrahlung, 16 involving interm ediate states and 32 involving $N$ (1520)] contribute to the am plitude $\mathrm{A}^{\text {fi }}$. D ue to their large number, it is hard to calculate them by usual trace techniques. Instead we follow the procedure, given below. Sím ilar m ethod has also been used in our previous calculations w thin this m odel.

W e rst note that am plitude corresponding to each individual diagram can be split into a hadronic part and a leptonic part as

The calculation of the process pp! M X ! $e^{+} e$ proceeds in two steps. First the $m$ eson M ( and ) is produced in the pp collisions and then the D alitz decay M ! et e is considered. In the procedure of $R$ ef. [29], the pram etrizations of $R$ efs. [3,14,62] are used to calculate the $M$ production cross sections. The $D$ alitz decay to $e^{t} e$ is given by (see also [63])
