Higher-order QED corrections to W -boson m ass determ ination at hadron colliders

Abstract

The impact of higher-order nal-state photonic corrections on the precise determ ination of the W -boson m ass at the Tevatron and LHC colliders is evaluated. In the presence of realistic selection criteria, the shift in the W m ass from a t to the transverse m ass distribution is found to be about 10 M eV in the W ! channel and alm ost negligible in the W ! e channel. The calculation, which is implemented in a M onte C arb event generator for data analysis, can contribute to reduce the uncertainty associated to the W m ass measurement at future hadron collider experiments.

P recision tests of the Standard M odel require a m ore and m ore accurate know ledge of the basic param eters of the theory. In particular, future m easurem ents of the W -boson and top quark m asses at the Tevatron and the LHC colliders are expected to considerably in prove the present indirect bound on the H iggs-boson m ass from electroweak precision data. As recently discussed in the literature [1], a precision of 27 M eV (16 M eV) for the W m assM $_{\rm W}$ is the target value for R un IIa (R un IIb) of the Tevatron. An accuracy of 15 M eV is the nalgoal of LHC 2].

In order to measure M with such a high precision in a hadron collider environment, it ism and atory to keep under control higher-order QCD and electrow eak radiative corrections to the W and Z production processes. The status of QCD corrections to weak boson production in hadronic collisions is reviewed in Ref. β , while recent progress in the calculation of electroweak corrections, as achieved by means of independent calculations [4, 5, 6], is sum marized in Ref. [7]. As shown in Refs. [4, 5, 6, 7], electroweak corrections are dom inated by photon radiation e ects and, in particular, by nal-state photon em ission, which gives rise to collinear logarithms of the form $= \log(\$ = m_1^2)$, where \$ is the e extive centre of mass (cm.) energy and m_1 is the mass of the nal-state lepton. This poses the question of the impact of higher-order (i.e. beyond order) leading logarithm ic corrections due to multi-photon radiation. A stattempt toward the inclusion of O (2) QED corrections was the calculation of the double-brem sstrahlung matrix elements qq^0 ! W ! 1 and qq! ;Z ! 11 (l = e;) performed in Ref. §]. The aim of the present work is to evaluate the impact of higher-order nal-state QED corrections on the W mass determ ination at hadron colliders, by including both real brem sstrahlung and virtual corrections. To this end, a Parton Shower (PS) approach in QED [9] is employed to simulate multi-photon radiation e ects. An independent calculation of multiphoton radiative corrections in leptonic W decays has appeared very recently [10], but without quantifying their in pact on the W mass measurement. The uncertainty in the W mass due to higher-order QED e ects is presently estimated by the CDF collaboration at the Tevatron to be 20 M eV in the W ! e channel, and 10 M eV in the W ! channel [1]. An uncertainty of 12 M eV is assigned by the D collaboration to the W ! e channel [2].

From our analysis, we not that the shift in the tted W mass is about 10 MeV in the W ! channel and almost negligible in the W ! e channel. The inclusion of the present calculation in the experimental analysis would reduce significantly such a theoretical

uncertainty in future improved measurements of the W mass at hadron colliders.

An appropriate theoretical tool to compute photonic radiative corrections in the leading log approximation is the QED PS approach [9]. It consists in a numerical solution of the QED G ribov-Lipatov-A ltarelli-Parisi evolution equation for the charged lepton Structure Function D ($x;Q^2$) in the non-singlet channel. The solution can be cast in the form [9]

 $(s_1;s_2) = \exp \left[\frac{R_{s_1}}{2} \frac{ds^0}{s_2} \frac{R_{x_1}}{s^0} dz P(z)\right]$ is the Sudakov form factor, P(z) is the where splitting function and x_{+} is an infrared regulator, separating the soft+virtual e! e+ region from hard brem sstrahlung. Equation (1) allows to compute D ($x;Q^2$) by means of a Monte Carlo algorithm which, as shown in Ref. [9], simulates the emission of a shower of (real and virtual) photons by a charged ferm ion and accounts for exponentiation of soft photons and re-sum m ation of collinear logarithm s due to multiple hard brem sstrahlung. A remarkable advantage of the PS algorithm with respect to a strictly collinear approximation is the possibility of generating transverse momentum p_T of ferm ions and photons at each branching, thus allowing an exclusive event generation suitable to implement experimental cuts according to a realistic event selection. The generation of transverse degrees of freedom can be performed according to di erent recipes, as described in detail in Ref. 9]. Here, we generate photon angular variables according to the leading pole behavior 1=(1) $1 \cos \#_1$), where $_1$ is the lepton velocity and $\#_1$ is the relative lepton-photon angle.

A simple recipe to evaluate nal-state corrections to $p_{p}^{(i)}$! W ! loonsists in attaching a single structure function D (x;Q²) to the lepton coming from the W decay. Needless to say, this amounts to neglect photonic corrections due to initial-state radiation, initial nal-state interference and W -boson emission. However, it is known that radiation from an internal o -shell particle can not contribute to leading logarithm ic corrections, which are the main concern of the present study. Further, initial-state photon radiation requires an appropriate treatment, since radiation o quarks gives rise to quark mass singularities which, as discussed in Refs. [4, 5, 6, 7], can be reabsorbed in Parton D istribution Functions (PDF), in analogy

to gluon emission in QCD. These considerations imply that the treatment of nal-state photon radiation alone is not gauge invariant. Nevertheless, it can be easily checked, by comparing the PS spectrum with the gauge-invariant factor for collinear photon emission by a ferm ion [13], that gauge violations are conned to the next-to-leading order corrections, which are beyond the approximation of the present analysis. This issue is further discussed in the following, by means of a quantitative comparison with the independent, gauge-invariant calculation of Ref. [5].

In order to quantify the e ect of higher-order nal-state QED corrections on the W m ass determ ination, we developed a M onte C arlo event generator following the approach described above and performed a number of M onte C arlo experiments. The technical details of the M onte C arlo code H O RACE (Higher O rder RA diative C ornections) will be presented elsewhere. Before the phenom enological analysis, we performed a tuned comparison between the predictions of H O RACE and those of W G RAD [5, 14], to verify the accuracy of our calculation. The results of such a comparison are shown in Tab. I, using default PDFs, input parameters and cuts as in Ref. [14]. W G RAD includes the full set of O () electroweak radiative corrections to W production (second line in Tab. I) but it also gives the possibility to select the e ect of a gauge-invariant subset due to nal-state corrections (W G RAD nal-state in Tab. I). Therefore, the di erence, at a few per mille level, between W G RAD and W G RAD nal-state points out, when comparing with the Born predictions, the dom in ance

of nal-state radiation within the full set of O () electroweak corrections. On the other hand, it can be seen that the predictions by W G RAD nal-state are in very good agreement with our results by HORACE O (), which is an order expansion of the complete PS algorithm. Since the di erences are well below the 0.1% level, this comparison demonstrates that the gauge-invariance violations present in our approach are num erically negligible. The contribution of higher-order e ects can be seen by comparing HORACE O () with our complete predictions given by HORACE exponentiated. Their e ect on the integrated cross section is tiny, within 0.1%. For the sake of completeness, we perform ed also comparisons between W GRAD and HORACE at the level of di erential distributions, such as lepton transverse m om entum and transverse m ass distributions, nding perfect agreement.

Having established the physical and technical accuracy of our calculation, we move to the analysis of the W mass shift due to higher-order corrections. The input parameters used in the simulations are:

We adopt the G scheme and xed-width scheme in our calculation. At the parton level, we consider the processes

and their charge conjugate, with l = e; and CKM matrix elements according to Ref. [15]. The results for the processes pp ! W ! l+ (Tevatron) and pp ! W ! l+ (LHC) are obtained by convoluting the parton-level matrix element with CTEQ 6 PDFs [16]. The virtuality scale Q² is set to be Q² = \$, \$ being the elective cml energy affergluon radiation, in both PDFs and lepton Structure Function. The cml energies considered are p = 2 TeV for the Tevatron and p = 14 TeV for the LHC. To model the acceptance cuts used by the CDF and D collaborations in their W mass analyses, we impose the following transverse momentum (p_T) and pseudo-rapidity () cuts:

However, in order to perform a realistic phenom enological analysis and study the dependence of the W mass shift from detector e ects, we implement, in addition to the above cuts, the lepton identication requirements quoted in Table I of Ref. §]. A coording to these criteria, electron and photon four-momenta are recombined for small opening angles between the two particles, consistently with a calorimetric particle identication, while muons are identiced as hits in the muon chambers with an associated track consistent with a minimum ionizing particle. Furthermore, we simulate uncertainties in the energy and momentum measurements of the charged leptons in the detector by means of a Gaussian smearing of the particle four-momenta, using as standard deviation values the specications relative to electrons and muons for the Run IID detector [17].

The strategy followed by the CDF and D collaborations to extract M_W from the data is to perform a maximum likelihood to the transverse mass distribution of the nal-state lepton pair or to the transverse momentum of the charged lepton. Here we consider the transverse mass, which is the preferred quantity to determ ine the W mass and is de ned as

where p_T (1) and p_T () are the transverse m on entum of the lepton and neutrino, and ¹ is the angle between the lepton and the neutrino in the transverse plane. The transverse m ass distribution, as obtained by our simulation, is shown in Fig. 1 at $p_{\bar{s}} = 2$ TeV. The distribution without lepton identication requirements and smearing elects (solid histogram) is compared to the distribution including lepton identication criteria (markers) and detector resolutions (shaded histogram). The shape of the M_T spectrum is considerably modiled by detector resolution elects, in agreement with the results shown in Refs. [1, 12]. The arrows in Fig. 1 select the range 65 G eV < M_T < 100 G eV, which is used by CDF collaboration in its W m ass analysis and we also adopt in the tting procedure described below.

To evaluate the shift induced by higher-order corrections on the W mass, we perform binned 2 ts and binned maximum likelihood ts to the M_T distribution, in complete analogy with the experimental thing procedure. Here we show only the results of the 2

ts, because the results of the maximum likelihood ts are in perfect agreement with the former. Using HORACE, we generate a sample of pseudo-data and calculate with high numerical precision the m_T spectrum (binned into 100 bins) at the Born level and for a xed, "physical" value of the W mass, i.e. $M_W^{ref} = 80.423 \text{ GeV} \cdot \text{Next}$, we compute the m_T spectrum including O () leading-log corrections for 20 hypothesized W mass values, with a spacing of 5 M eV for the W ! e channel and 10 M eV for the W ! channel. We then normalize the spectra within the tinterval and we calculate, for each M_W value, the ² as

where $_{i,B \text{ orn}}$ and $_{i}$; are the M onte C arb predictions for the i^{th} bin at the B om and O () level, respectively, and $_{i,B \text{ orn}}$; $_{i}$; the corresponding statistical errors due to num erical integration. This allows to quantify the m ass shift due to O () corrections. The shift due to higher-order corrections is derived according to the same procedure, by generating a sam ple ofpseudo-data for the M_T distribution at O () and thing them in term softhe M_T spectrum obtained including higher-order corrections for 10 hypothesized W m ass values. In this case, we use 1 M eV spacing between m asses. Figure 2 shows the $^2 = ^2 \frac{2}{m \text{ in}}$ distributions

as a function of $M_W = M_W = M_W^{ref}$, for the twith O () corrections (left) and the t with higher-order corrections (right). The mass shift observed for O () corrections amounts to about 20 MeV for the W ! e decay (dashed line) and to 110 MeV for the W ! decay (solid line), as a consequence of the di erent identication requirements. These shifts are in reasonable agreement with the results of the CDF and D collaborations, even in the absence of a complete detector simulation. The mass shift due to higher-order e ects is about 10 MeV for the W ! channel (solid line) and a few MeV (dashed line) for the W ! e channel. We performed the same analysis for the LHC collider (using the cuts and pseudo-detector simulation of the Tevatron collider) and found that the same conclusions do apply to the LHC.

In conclusion, we have evaluated the impact of higher-order nal-state QED corrections on the determ ination of the W mass at hadron colliders, in view of future improved measurements with an accuracy of 15–30 MeV. In the presence of realistic selection criteria, we have found that the shift due to these corrections is about 10 MeV in the W ! channel and practically negligible in the W ! e channel. The calculation, if included in future experimental analyses, would reduce the uncertainty in the precision measurement of the W mass at hadron colliders. To this end, the M onte Carlo program HORACE is available for data

analysis. A more realistic analysis would require a full detector simulation, which is beyond the scope of the present paper. The study of the neutral-current process $p_{p}^{(\prime)}$! ;Z ! I l is left to a future work.
