H igher Twists in the P ion Structure Function

Abstract

W e calculate the QCD m om ents of the pion structure function using D rell-Y an data on the quark distributions in the pion and a phenom enologicalm odel for the resonance region. The extracted higher twist corrections are found to be larger than those for the nucleon, contributing around 50% of the lowest m om ent at $Q^2 = 1 \text{ GeV}^2$.

Understanding the structure of the pion represents a fundam ental challenge in QCD. As the lightest qq bound state, the pion presents itself as som ewhat of a dichotom y: on the one hand, its anom alously sm all mass suggests that it should be identified with the pseudo-G oldstone mode of dynam ical breaking of chiral symmetry in QCD, essential for describing the long-range structure and interactions of hadrons; on the other, high energy scattering experiments reveal a rich substructure which can be elicently described in terms of current quarks and gluons.

The duality between quark and hadron degrees of freedom reveals itself in most spectacular fashion through the phenom enon of B bom -G ilm an duality in inclusive deep-inelastic scattering. Here the inclusive F_2 structure function measured at low hadron nalstatem ass W, in the region dom inated by low -lying resonances, has been found in the case of the proton [1,2] to follow a global scaling curve which describes high W data, to which the resonance structure function averages. Furtherm ore, the equivalence of the averaged resonance and scaling structure functions for each prom inent resonance region separately suggests that the resonance{scaling duality also exists to some extent locally.

W ithin QCD, the appearance of B bom -G ilm an duality for the m om ents of structure functions can be related through the operator product expansion to the size of high twist corrections to the scaling structure function [3]. The apparent early onset of duality for the proton structure function indicates the dom inance of single-quark (leading twist) scattering even at low m om entum transfers. It is not a priori clear, how ever, whether this is due to an overall suppression of coherent e ects in inclusive scattering, or because of fortuitous cancellations of possibly large corrections. Indeed, there are some indications from m odels of QCD that the workings of duality m ay be rather di erent in the neutron than in the proton [4,5], or for spin-independent and spin-dependent structure functions. G iven that B bom -G ilm an duality is em pirically established only for baryons (speci cally, the proton), while the application of theoretical m odels is generally m ore straightforward in the m eson sector, a natural question to consider is whether, and to what extent, duality m an ifests itself phenom enologically for the simplest qq system in QCD | the pion.

In this note we report the rst analysis of the role of resonances in the QCD m om ents of the pion structure function, and obtain a rst estim ate of the size of higher twist corrections to the scaling contribution. Sim ilar analyses for the nucleon have been m ade in Refs. [6{8]. A coording to the operator product expansion in QCD, at large Q² the m om ents of the pion F_2 structure function,

can be expanded as a power series in $1=Q^2$, with coe cients given by matrix elements of local operators of a given twist ,

$$M_{n}(Q^{2}) = \bigwedge_{=2}^{X^{1}} A^{n}_{2}(_{s}(Q^{2})) \frac{1}{Q^{2}} \stackrel{!}{=} 2 \qquad (2)$$

Here the leading twist = 2 term A_0^n corresponds to free quark scattering, and is responsible for the scaling of the structure functions (m odulo perturbative $_s(Q^2)$ corrections). The higher twist term s $A_{>2}^n$ represent m atrix elements of operators involving both quark and gluon elds, and are suppressed by powers of $1=Q^2$. The higher twist contributions re ect the strength of nonperturbative QCD e ects, such as multi-parton correlations, associated with con nement.

Note that the de nition of M $_n$ (Q²) includes the elastic contribution at W = m , corresponding to $x = Q^2 = (W^2 m^2 + Q^2) = 1$, which is given by the square of the elastic pion form factor, F (Q²),

$$F_{2}^{(el)}(x = 1;Q^{2}) = 2m$$

A lthough negligible at high Q², the elastic contribution has been found to be important numerically at intermediate Q² for moments of the nucleon structure function [6{10}]. In Eq. (1) we use the Comwall-N orton moments rather than the N achtmann moments, which are expressed in terms of the N achtmann scaling variable, $= 2x=(1 + \frac{1}{1 + 4x^2m^2 = Q^2})$, and include e ects of the target mass. Because of the small value of m, the di erence between the variables x and , and therefore between the x- and -m oments, is negligible for the pion.

The pioneering analysis of D e Rujula et al. [3] (see also Ref. [6]) showed that the size of the higher tw ist m atrix elem ents directly governs the onset of quark-hadron duality. N am ely, there is a region of n and Q^2 in which the m on ents of the structure function are dom inated by low m ass resonances, where the higher tw ist contributions are neither overwhelm ing nor negligible. For example, even though there are large contributions from the resonance region (W < 2 G eV) to the n = 2 m om ent of the proton F_2 structure function (70% at $Q^2 = 1 \text{ G eV}^2$), the higher tw ist e ects are only of the order 10{20% at the same Q^2 [6]. The question we address here is whether there is an analogous region for the pion, where the resonance contributions are in portant, but higher tw ist e ects are sm all enough for duality to be approximately valid.

Of course, strictly speaking the distinction between the resonance region and the deep inelastic continuum (D IS) is somewhat arbitrary, as can be illustrated in the large N_c lim it of QCD. There the nalstate in deep inelastic scattering from the pion is populated by in nitely narrow resonances, even in the B prken lim it, while the structure function calculated at the parton level produces a smooth, scaling function [4,11]. Phenom enologically the spectrum of the excited states of the pion is expected to be rather smooth su ciently above the mass, for W > 1 G eV. C ontributions from the excitation of heavierm esons are not expected to be easily discernible from the D IS continuum | the a_1 m eson, for instance, appears at a m ass W 1:3 G eV, and has a rather broad width (350{500 M eV}).

The pion structure function has been measured in the N D rell-Yan process [12{14] over a large range of x, 0.2 < x < 1, and for Q^2 typically > 20 G eV². It has also been studied at HERA in sem i-inclusive DIS at very low x and high W [15]. No data exist on F_2 at low W , however, in the region where mesonic resonances would dominate the cross section. The spectrum could in principle be reconstructed by observing low t neutrons at low W produced in the sem i-inclusive charge exchange reaction, ep ! enX, where t is the m om entum transfer squared between the proton and neutron. In the absence of such data, to obtain a quantitative estimate of the importance of the resonance region, we model the pion spectrum at low W in terms of the elastic and pole contributions, on top of the D IS continuum which is evaluated by evolving the leading twist structure function to lower Q^2 . The latter can be reconstructed from parameterizations [16(18) of leading twist quark distributions in the pion obtained from global analyses of the pion D rell-Y an data. In this work we use the low Q^2 t from Ref. [16], which gives the leading twist parton distributions in the pion for $Q^2 > 0.25 \text{ GeV}^2$, although our conclusions do not change with the use of other param eterizations [17,18]. For the elastic contribution we use a param eterization of the world's data [19] which interpolates smoothly between the perturbative QCD and photoproduction lim its [20].

The contribution is described by the ! transition form factor, F (Q^2), and is expected to fall as $1=Q^4$ at large Q^2 (compared with $1=Q^2$ for F (Q^2)). Since there is no empirical information on F (Q^2), we consider several models in the literature, based on a relativistic Bethe-Salpeter vertex function [21], a covariant D yson-Schwinger approach [22], and light-cone QCD sum rules [23]. These represent a range of 100% in the magnitude of F (Q^2) over the region of Q^2 covered in this analysis. The calculation of R ef. [23] gives a som ew hat sm aller result than in R efs. [21,22], which give a similar magnitude for F . The di erence between these can be viewed as an estimate of the uncertainty in this contribution.

In Fig. 1 we plot the contributions to the moments of the pion structure function from the \resonance region", $M_n^{\text{res}}(Q^2)$, as a ratio to the total moment, for n = 2; ;10. The resonance region here is de ned by $W < W_{\text{res}} = 1 \text{ GeV}$, corresponding to restricting the integral in Eq. (1) to the range $x_{\text{res}} = Q^2 = (W_{\text{res}}^2 - m^2 + Q^2)$ to the elastic point at x = 1. For the n = 2 moment the low W region contributes as much as 50% at $Q^2 = 2 \text{ GeV}^2$, decreasing to < 1% for $Q^2 > 10 \text{ GeV}^2$. Higher moments, which are more sensitive to the large x region, subsequently receive larger contributions from low W. The n = 10 moment, for example, is virtually saturated by the resonance region at $Q^2 = 2 \text{ GeV}^2$, and still has some 40% of its strength coming from W < 1 GeV even at $Q^2 = 10$ GeV².

The large size of the resonance contributions suggests that, at a given scale Q^2 , higher twist e ects play a more important role in the moments of the pion structure function than

in the case of the nucleon. The lowest (n = 2) m om ent of F_2 is displayed in Fig.2, including the leading twist and elastic contributions to M $_2$ (Q 2). The leading twist component,

$$M_{n}^{LT}(Q^{2}) = \int_{q}^{X} e_{q}^{2} \int_{0}^{2} dx x^{n-1} q (x;Q^{2}); \qquad (4)$$

is expressed (at leading order in $_{\rm s}(Q^2)$) in terms of the twist-2 quark distributions in the pion, q (x;Q²). The leading twist contribution is dom inant at Q² > 5 GeV², while the deviation of the total moment from the leading twist at low er Q² indicates the increasingly in portant role played by higher twists there. In particular, while negligible beyond Q² 4 GeV^2 , the elastic contribution is as large as the leading twist already at Q² 1 GeV^2 . The contribution from the ! transition is more uncertain, and the band in Fig.2 represents the total moment calculated using di erent models [21{23} of F (Q²). However, while the current uncertainty in this contribution is conservatively taken to be 100%, doubling this would lead to a modest increase of the band in Fig.2. Uncertainty arising from poor know ledge of the leading twist distributions at small x [16{18}] is not expected to be large.

The higher twist part of the moments can be de ned as the di erence between the total moment M $_n$ (Q²) and the leading twist contribution in Eq. (4), which includes a term arising from target mass corrections,

$$M_{n}^{HT}(Q^{2}) = M_{n}(Q^{2}) \quad M_{n}^{LT}(Q^{2}) \quad M_{n}^{TM}(Q^{2}) :$$

A lthough nonperturbative e ects can in principle m ix higher twist with higher order e ects in $_{s}$, rendering the form alseparation of the two am biguous [24] (the perturbative expansion

itselfm ay not even be convergent), by restricting ourselves to the region of Q² in which the $1=Q^2$ term is significantly larger than the next order correction in $_{\rm s}$, the ambiguity in defining the higher twist terms can be neglected [6]. Because the target mass correction, M $_{\rm n}^{\rm TM}$ (Q²), which is formally of leading twist, is proportional to m²=Q², its contribution will only be felt when Q² m², which is far from the region where the twist expansion is expected to be valid. The higher twist contribution to the n = 2 m on ent is plotted in Fig. 3 as a ratio to the totalm on ent, as a function of Q². The band represents an estimate of the uncertainty in the ! transition form factor, as in Fig. 2. The higher twist contribution is as large as the leading twist at Q² = 1 G eV², is around 1/3 at Q² = 2 G eV², and vanishes rapidly for Q² > 5 G eV².

The higher twist contribution at Q^2 1 GeV² appears larger than that found in similar analyses of the proton F_2 [6] and g_1 [8] structure functions. This can be qualitatively understood in terms of the intrinsic transverse momentum of quarks in the hadron, hk_T^2 i, which typically sets the scale of the higher twist e ects [3,6,25,26]. By analyzing the x ! 1 dependence of the measured ⁺ pairs produced in N collisions, and the angular distribution at large x, the E 615 C ollaboration [14] indeed nds the value $hk_T^2 i = 0.8$ 0.3 GeV^2 within the higher twist m odel of R ef. [25], which is larger than the typical quark transverse momentum in the nucleon (O (500 M eV)). The implication is that duality would therefore be expected to set in at larger Q^2 for the pion than for the nucleon.

In sum mary, we have evaluated moments of the pion structure function, and studied in

particular the role of the resonance region. M aking the reasonable assumption that the low W resonant spectrum is dominated by the elastic and ! transitions, we have presented a rst quantitative estimate of the size of higher twist contributions. For the lowest moment of F_2 we nd that the resonance region (W < 1 G eV) contributes 50% of the strength at Q² 2 G eV², dropping to below 10% for Q² > 5 G eV². The elastic component, while insigni cant for Q² > 3 G eV², is as large as the leading twist contribution at Q² 1 G eV². The higher twist corrections to the n = 2 moment amount to 50% at Q² = 1 G eV², 30% at Q² = 2 G eV², and become negligible beyond Q² 6 G eV².

Uncertainties in these estimates are mainly due to the poor knowledge of the inclusive pion spectrum at low W, which limits the extent to which duality in the pion can be tested quantitatively. Only the elastic form factor has been accurately measured to $Q^2 = 2 \text{ GeV}^2$, although at larger Q^2 it is poorly constrained. The inclusive pion spectrum can be extracted from data from the sem i-inclusive charge-exchange reaction, ep ! enX, at low t, for instance with CLAS at Je erson Lab. This could also allow one to determ ine the individual exclusive channels at low W. In addition, a Rosenbluth separation would allow the transverse and longitudinal structure functions of the pion to be extracted.
