Infrared regularization with spin-3/2 elds

A bstract

W e present a Lorentz { invariant form u lation of baryon chiral perturbation theory including spin-3/2 elds. Particular attention is paid to the projection on the spin-3/2 components of the delta elds. W e also discuss the nucleon m ass and the pion-nucleon sign a term.

1. The delta resonance plays a special role in low energy nuclear and particle physics, due to its near mass degeneracy with the nucleon and its strong couplings to pions, nucleons and photons. It was therefore argued early that spin-3/2 (decuplet) states should be included in baryon chiral perturbation theory [1], which is the low -energy e ective eld theory of the Standard M odel. The work of [1] and subsequent authors m ade use of the heavy baryon approach, which treats the baryons as static sources like in heavy quark e ective eld theory and allows for a system atic power counting in the presence of matter elds, as pioneered in [2] and system atically explored in [3]. A lso, special care has to be taken about the decoupling of resonances in the chiral lim it [4]. This approach was system atized by counting the nucleon-delta m ass splitting as an additional sm all param eter in R ef. [5], the corresponding power counting was called the \sm all scale expansion". The heavy baryon approach has been successfully applied to a variety of processes, for reviews see [6, 7], and a status report on chiral e ective eld theories with deltas is given in [8]. More recently, a Lorentz-invariant formulation of baryon chiral perturbation theory has become available [9], the so{called \infrared regularization" (IR). A similar approach had been presented earlier in [10]. Such a formulation allows to include strictures from analyticity and is thus particularly suited for extensions of chiral perturbation theory based on dispersion relations, see e.g. [11, 12, 13, 14, 15, 16, 17]. Furtherm ore, the use of the D irac propagator as opposed to the static ferm ion propagator in the heavy baryon scheme allows for a resummation of important recoil ects, see e.g. the work on electrom agnetic form factors [18] or the nucleon spin structure [19, 20]. The chiral expansion of the baryon m asses also seems to converge faster in this scheme [21] whereas the description of pion {nucleon scattering is not yet in a satisfactory status [2, 23]. The renorm alization of relativistic baryon chiral perturbation theory has been discussed in detail in [24]. In this Letter, we give a consistent extension of the infrared regularization m ethod in the presence of spin-3/2 # ⁴. W hat is new here is that we explicitly project onto the spin-3/2 parts and that the method easily allows to include any external source in a chiral and gauge invariant fashion (in contrast to the recent proposal in [25]). As simple applications, we calculate the delta loop contribution to the nucleon self-energy and the pion {nucleon sigm a term .

2. In this section, we brie y review the form alism necessary to describe spin-3/2 elds. M ore details can e.g. be found in [26, 27, 28]. We rst write down the propagator for a free spin-3/2 eld (called the delta propagator form here on) in d space{tim e dimensions,

with m the delta m ass. This may be rewritten by projection onto the spin 3=2 and 1=2 components

Note the infrared singular pieces $1=p^2$ appearing in the spin-projected parts of the propagator, which will play an important role later on . A lso, we remark that the spin-1/2 pieces do not propagate and thus one should

be able to absorb their contribution in purely polynom ial terms (which amounts to a rede nition of certain low-energy constants in the elective eld theory). If one considers processes where the center-of-m ass energy reaches the delta m ass, p = m, the free delta propagator has to be resummed as described in detaileg. in [10, 25]. Let us now brie y discuss the leading chiral pion-delta-nucleon Lagrangian. It is given by

where describes the Rarita-Schwinger (spin-3/2) eld, the nucleon doublet, $w_i = Tr(iu) = 2$ the axial current and = g + (Z = 1=2). The dependence on the so-called o -shell parameter Z is, however, spurious, since it does not appear in the spin-3/2 contributions and thus physical observables do not depend on it. The axial-vector coupling constant c_A , which is related to the pion-delta-nucleon coupling g_N , is frequently called h_A in the literature. More precisely, what appears in Eq.(5) is the the coupling c_A in the chiral limit. For simplicity, we use in the following the SU (4) coupling constant relation

The resulting value is som ewhat larger than found in typical to say to pion-nucleon scattering data or from tting the ! N width, see e.g. [29, 30]. We remark that like in Eq.(5), we are using standard chiral-invariant couplings of the N system, because di erences to other couplings appearing in the literature can simply be absorbed in the polynom ial contributions to be discussed in the following.

3. Next, we make some short remarks about the elective eld theory of massive spin-1/2 elds chirally coupled to Goldstone bosons and external sources, called baryon chiral perturbation theory. It is complicated by the fact that the nucleon m ass does not vanish in the chiral lim it and thus introduces a new m ass scale apart from the ones set by the quark m asses. Therefore, any power of the quark m asses can be generated by chiral bops in the nucleon (baryon) case, spoiling the one (to (one correspondence between the loop expansion and the one in the small parameter q. One method to overcome this is the heavy mass expansion (called heavy baryon chiral perturbation theory, for short HBCHPT) where the nucleon mass is transformed from the propagator into a string of vertices with increasing powers of 1=m. Then, a consistent power counting emerges^{# 5}. However, this method has the disadvantage that certain types of diagram s are at odds with strictures from analyticity. The best example is the so{called triangle graph, which enters e.g. the scalar form factor or the isovector electrom agnetic form factors of the nucleon. In a fully relativistic treatment, such constraints from analyticity are autom atically ful lled. It was argued in [10] that relativistic one { loop integrals can be separated into \soft" and \hard" parts. While for the form er the power counting as in HBCHPT applies, the contributions from the latter can be absorbed in certain LECs. In this way, one can combine the advantages of both m ethods. A m ore form aland rigorous in plem entation of such a program was given in [9]. The underlying m ethod is called \infrared regularization". Any dimensionally regularized one { loop integral H is split into an infrared singular (called I) and a regular part (called R) by a particular choice of Feynm an param eterization,

Consider isst the regular part. If one chirally expands the contributions to R, one generates polynom ials in m om enta and quark masses. Consequently, to any order, R can be absorbed in the LECs of the elective Lagrangian. On the other hand, the infrared (IR) singular part has the same analytical properties as the full integral H in the low {energy region and its chiral expansion leads to the non{trivialm om entum and quark {m asses dependences of CHPT, like e.g. the chiral logs or fractional powers of the quark masses. For a typical one{ loop integral (like e.g. the nucleon self{energy) this splitting can be achieved in the following way (om itting prefactors)

with $A = M^2 k^2 i$, $B = m^2 (p k)^2 i$, $! 0^+$, M the pion mass and d the number of space{time dimensions. A ny general one{bop diagram with arbitrary many insertions from external sources can be brought into this form by combining the propagators to a single pion and a single nucleon propagator. It was also show n that this procedure leads to a unique, i.e. process{independent result, in accordance with the chiral W and identities of QCD [9]. Consequently, the transition from any one{bop graph H to its IR singular piece I de nes a sym metry {preserving regularization. For m ore details, the reader is referred to [9].

4. Next, we develop a system atic infrared regularization for elective eld theories with spin-3/2 elds. This should be considered the main result of this paper. Due to the presence of the R singular terms $1=p^2$ when one projects the delta propagator onto its spin-3/2 and spin-1/2 components, cf. Eq.(3), one has to deal with a type of integrals that do not appear in the pure pion {nucleon approach. To be specific, consider the integral appearing in the self-energy (details of the self-energy calculation will be given below)

In the region of low momenta, where the chiral expansion is expected to converge quickly, the rst factor in the denom inator is of 0 (q^0), while the second is of 0 (q^2) so that the chiral dimension of the integral should be 0 (q^{d-2}). We remark that at x = 1, the integrand develops a pole. Following [9], we perform a change of variables

We see that a complication arises due to the infrared singular piece $1=(k p)^2$ in the spin-projected parts of the propagator. Specically, due to the term u^2 , the denominator brings some additional contribution when performing the integral. $J_0^0(p^2)$ turns out to behave as M^{d4} instead of the expected M^{d2}. If one evaluates this integral straightforwardly, one nds that it contains a logarithm ic contribution that indeed has the correct chiral behavior. The disturbing contribution is due to the factor (1 u) which stems from the pole at x = 1 of the infrared singular part of the propagator. In fact, such contributions should be contained in the regular part, since they have nothing to do with the chiral expansion. To form ally achieve this separation, one rew rites the integral as (d = 4 2")

From the second integral one then obtains the irregular part by letting 1 = ! 1. Therefore, the separation of the integral $J_0^0 (p^2)$ into the irregular and the regular term s reads, $J_0^0 (p^2) = I_0^0 (p^2) + R_0^0 (p^2)$,

with $_{\rm E}$ the Euler-M ascheroniconstant and we have set the running scale of dimensional regularization, , to be the nucleon m ass [9]. Furthermore, the pion tadpole contribution is given by the well-known loop integral

O f course, the scale that naturally appears in bop integrals with deltas is m, not m, as used in Eqs.(15,16). However, the di erences due to this choice of scale can be absorbed in polynomial (regular) terms, so that one can work with one scale only in the coupled pion-nucleon-delta system. However, to assess the theoretical uncertainty at a given order, one can set = m in the delta bop diagrams. Eq.(15) also shows that the non-propagating parts of the projected propagator will be absorbed in tadpole contributions, as it is expected since such contributions can be understood as a very heavy delta shrunk to a point-like vertex.

A med with this prescription, we can now set up a consistent expansion in smallexternalm omenta, pion m asses and the N mass splitting = m m, in complete analogy to the small scale expansion form ulated for heavy spin-3/2 elds [5]. We therefore refrain from discussing here in any detail the corresponding power counting and the construction of the chiral elective Lagrangian (most of this is available in the literature). As discussed in detail in [31], special care has to be taken to full the decoupling theorem of QCD, which states that leading chiral singularities can not be modified by resonance elds. From here on, all small parameters (quark m asses, externalm omenta, nucleon-delta m ass splitting) are collectively denoted as \cdot

5. We rst calculate the leading one-bop contribution to the nucleon self-energy with an interm ediate delta without any reference to a special regularization and with the full propagator, Eq.(1), see Fig. 1. This is done for the following reasons. First, such a calculation allows one to study di erent regularization procedures. Second, one can explicitly study the role of the non-propagating spin-1/2 components. Third, one can also easier compare with existing calculations in the literature. We have

In IR, we have = 0, and J_0 (m²) (J_1 (m²)) is of order 0 () (0 (²)), so that to lowest (third) order

where the last equation is valid for $^2 > M^2$ (as it is the case in nature). This result agrees with the one in [30]. Note also that for a more compact notation and easier comparison with the existing literature, we have retained some higher order terms in the form ula expressing the mass shift in terms of the loop functions J_0 and J_1 .

As noted above, we have not yet separated the spin-3/2 from the spin-1/2 components. Since the spin-1/2 components do not propagate, their contribution should be entirely absorbed in polynomial pieces (contact term s). Utilizing the projection operators given in Eq.(3), the spin-3/2 contribution to the self-energy takes the form Z

We also have the bop function relation $J_1^0(p^2) = (p^2 + M^2)J_0^0(p^2) = (2p^2) + = (2p^2)$ (in dimensional regularization). Noting now that the bop functions $J_0^0(m^2)$ and $J_1^0(m^2)$ are of order O (²) in the chiral expansion, the lowest (third) order result for the mass shift derived from Eq.(26) agrees with the one given in Eq.(24) but di ers of course in the higher order terms. It is also in portant to stress that the spin-3/2 contribution to the mass shift is independent of Z, as it should be.

Next, we consider the spin-1/2 contribution to the self-energy, $^{1=2}$ (p²). The corresponding mass shift has the form (we again give for simplicity the result for Z = 1=2)

We have thus shown explicitly that these contributions can be completely absorbed into polynom ial terms appearing in the chiral expansion of the nucleon mass beyond leading one (loop order [32, 9],

where c_1 ; k_1 and k_2 are (combinations of) dimension two and four low {energy constants and m_0 is the nucleon mass in the chiral lim it. Furtherm ore, all Z -dependence is of course included in these polynomial terms, too.

From the mass shift, one can directly derive the delta loop contribution to the sigm a term using the Feynman-Hellm ann theorem , $\$

To leading order one has (using the full or the spin 3/2 part of the propagator):

Eq. (31) naturally agrees with the result of R ef. [23] but di ers by a polynom ial contribution in from the one of [10] due to the use of a d{independent propagator in that paper. A gain, for easier comparison we have retained some higher order terms in the upper expression in Eq. (31). This concludes the form alism and we now turn to a num erical evaluation of the m ass shift and the sigm a term.

6. We are now in the position to evaluate the delta loop contribution to the nucleon m ass shift and the sigm a term. We use $g_A = 1.267$, M = 139.57 MeV, F = 92.4 MeV and = 271 MeV. From Eq.(6) it follows that $c_A = 1:34$. We remark that the resulting numbers scale linearly with the axial-vector coupling constant c_A. The delta contribution to the nucleon mass shift and the sigm a term are collected in Table 1. We give the lowest (third) order result which is the same if one uses the full or the projected spin-3/2 propagator, as pointed out earlier. However, in IR the integrals also contain higher order pieces which can be retained (see e.g. the detailed discussion in [18]). In that case, one has to project onto the spin-3/2 pieces to get rid of the unphysical contribution from the spin-1/2 components. However, as shown in the table, the di erence is num erically irrelevant for the observables considered here. Furtherm ore, these higher order corrections am ount to a very sm all correction to the lowest order result. This, how ever, is not always the case, see e.g. [18]. We also rem ark a certain sensitivity to the scale of dimensional regularization. This dependence, how ever, will be balanced by counter terms not considered here. The results shown in Table 1 are not very di erent from earlier ones obtained in the heavy baryon approach [34, 33], which is expected since to this order neither the delta loop contribution to the nucleon mass shift nor to the sigma term is very sensitive to recoil corrections or similar e ects. W e stress again that a com plete analysis of the nucleon m ass or the sigm a term would require a novel determ ination of certain low energy constants to ful 11 the requirem ents of decoupling. This, however, goes beyond the scope of this Letter.

7. In this Letter, we constructed a system atic infrared regularization for chiral elective eld theories including spin-3/2 elds. To arrive at a consistent formulation, one has to project onto the spin-3/2 components of these elds. This projection leads to a new type of integrals as compared to the pure pion-nucleon theory. We have shown that the IR scheme of [9] can be extended system atically and furtherm ore, this procedure allows for a chiral invariant inclusion of external sources, like e.g. photons or weak currents. The contributions from the spin-1/2 components get completely absorbed into the polynom ial pieces of the elective Lagrangian. Furtherm ore, the frequently used o {shell parameters (X;Y;Z) are also contained in these polynoms and thus do not lead to observable consequences. It is now in portant to apply this method to observables, where loops are expected to play a signi cant role, like in all types of C ompton scattering. W ork along these lines is underway.
