# H om eotic supersym m etry

It is commonly believed that unbroken supersymmetry (SUSY) in plies that all members of a supermultiplet have the same mass. We demonstrate that this is not true, by exhibiting a simple counterexample. We employ the formalism of homeotic fermions, in a simple model where CPT conjugate fermions have dierent masses. This model can be supersymmetrized to a hypermultiplet of elds which form a representation of the conventional N=2 SUSY algebra. Nevertheless, CPT conjugate states in this hypermultiplet have dierent masses. These surprising results do not violate either the CPT theorem nor the Haag-Lopuszanski-Sohnius theorem.

#### INTRODUCTION

Supersym m etries are the only possible extensions of the four dimensional Poincare invariance observed ubiquitously in particle interactions [1, 2]. Supersym metry (SUSY) plays a fundamental role in string theory, and there are many strong phenomenological motivations for believing that supersym metry is realized in nature, in spontaneously broken form. On the other hand, no superpartner particles have yet been observed, and spontaneously broken supersym metry makes a prediction for the cosmological vacuum energy density which is too large by at least 60 orders ofmagnitude. Thus it is important to push the boundaries of our fundamental understanding of supersym metry, and more especially to look for novel ways of expressing supersym metry in physical systems.

It is widely believed that unbroken supersym m etry in plies that all m em bers of a supermultiplet have the same m ass. For example Sohnius' authoritative review article states explicitly that \supersym m etry m ust be broken in nature where elem entary particles do not come in m assdegenerate multiplets" [3]. This belief is based upon the strong constraint that any conserved supercharge Q m ust commute with the 4-m omentum operator P , which in turn in plies the 0 'R aifeartaigh theorem:

In spite of these facts, we demonstrate in this letter that exact supersymmetry does not always imply mass-degenerate multiplets. We employ the formalism of hom eotic fermions [4], developed previously by us as a toy model for CPT violation in the neutrino sector [5, 6, 7, 8, 9]. Our starting point is an extremely simple model where CPT conjugate fermions have dierent masses. This model can be supersymmetrized to a hypermultiplet of elds which form a representation of the conventional N = 2 SUSY algebra. Nevertheless, CPT conjugate states in this hypermultiplet have dierent masses. Each fermion state is still mass-degenerate with a boson

state, however the hypermultiplet is not reducible to a pair of mass-degenerate supermultiplets. These surprising results do not violate either the CPT theorem [10] nor the Haag-Lopuszanski-Sohnius theorem [1].

#### HOMEOTIC FERM IONS

Hom eotic ferm ions, like Dirac ferm ions, are denoted by 4-component complex spinor elds (x). In the free hom eotic theory the Fourier-transform ed ferm ion elds obey the equation of motion:

which di ers from the D irac equation by the presence of (p<sub>0</sub>), the sign function of delta calculus. Solutions of (2) are solutions of the K lein-G ordon equation; the hom eotic theory can be regarded as \the other square root" of the K lein-G ordon equation. The hom eotic case is usually neglected because the equation of motion is nonlocal in position space:

where P denotes the principal value integral, which we will now assume throughout. Despite this nonlocality, it was demonstrated in [4] that causal interacting hom eoticeld theories exist, in the sense of having a well-de ned perturbative S-m atrix.

As noted in [4], the combination of a homeotic mass term with a Dirac mass term violates CPT. Consider the simple free theory dened by the lagrangian

If we de ne the CPT operator such that the D irac m ass term is CPT even, then the hom eotic m ass term is CPT odd, and vice-versa. CPT conjugate spinors in this theory have m ass-squared eigenvalues  $(m_d m_h)^2$ .

### THE N = 2 SUSY ALGEBRA

We would now like to extend this theory of 4-component complex spinors to a supermultiplet of elds which furnish a representation of the standard N=2 SUSY algebra. In the 4-component notation of Sohnius [3] the relevant parts of the N=2 algebra are:

where the Q  $_{i}$ ,  $_{i}$  = 1, 2, are sym plectic M a jorana spinor supercharges, and Z is the (antiherm itian) central charge operator, which commutes with all of the other generators of the algebra. The supercharges form a doublet under the SU (2) R symmetry of N = 2 SU SY; the index i is raised and lowered with the two-dimensional Levic Civita tensors  $_{ij}$ =  $^{ij}$ . In our derivation we will need a number of identities for bilinears of symplectic M a jorana spinors:

Let  $A_i(x)$  denote a doublet of complex scalar elds, and (x) a 4-component complex ferm ion eld. We want these elds to form an N=2 hypermultiplet, i.e., to furnish a representation of the algebra (5). The fundamental relation between the elds is

one additional input is required:

where  $F_i(x)$  is a doublet of complex bosonic auxiliary elds; we will specify the precise form of  $F_i(x)$  later.

Expressions (7) and (8), together with the algebra (5), the Jacobi identities, and the identities (6), now imply:

These relations de ne a set of hypermultiplet elds  $A_i(x)$ , (x), and  $F_i(x)$  which form a representation of N = 2 SUSY. These relations determ ine uniquely the equations of motion for the dynamical elds  $A_i(x)$  and (x), once we specify the auxiliary elds  $F_i(x)$ . If e.g. we write

then (8) combined with (9) in plies that the  $A_i(x)$  satisfy the K lein-G ordon equation, while (7) combined with (9) im plies that (x) obeys the D irac equation.

## SIM PLE EXAM PLE OF HOM EOTIC SUPERSYM M ETRY

We obtain the sim plest example of homeotic supersymmetry by specifying the auxiliary elds as follows:

Applying the relations (7-9), we determ ine the equations of motion to be:

The action which reproduces (11), (12) is given by

It is easy to check that all four pieces of the action are separately invariant under the standard N=2 SUSY transform ations of the elds:

We can proceed further to construct the conserved supercurrent in terms of the component elds. However the usual Noether procedure does not yield a conserved current; this is a generic feature of nonlocal eld theories, and was noted in our previous work with regard to the ferm ion number current of the hom eotic ferm ion theory. Let us rst review that case, in which we employed a trick of Pauli's construct the conserved ferm ion number current:

It is easily seen using the ferm ion equation of motion (12) that J(x) is conserved on-shell. Despite its ugly form in position space, J(x) reduces to the usual number current in the creation/annihilation Fock basis.

In a supersymmetric theory the conserved bosonic current J (x) must belong to a supermultiplet of conserved currents. In particular, we can immediately obtain an expression for the supercurrent  $j^i$ , by applying the supersymmetry transformations (15) to the component elds in (16). The result is:

$$j^{i}(x) = \sum_{i=0}^{p} \frac{1}{2} = F^{yi} + Q^{yi}(x) + Q^{yi}(x)$$

U sing the equations of motion (11), (12), one nds that  $j^{i}(x)$  is conserved on-shell. It thus represents the supercurrent modulo possible \improvement" terms [3].

## M ASS SPECTRUM

B oth the bosonic and ferm ionic parts of the action (13) violate CPT. Let us focus rst on the bosonic sector. We can expand the elds  $A_i(x)$  in positive and negative frequency plane wave solutions of the equations of motion (12):

W e quantize the theory by assum ing that  $a_{p\,i}$ ,  $b_{p\,i}$  satisfy the commutation relations of creation/annihilation operators. It follows that the general commutator of  $A_i(x)$  with its conjugate i (x) is given by

Thus the equal-time commutator is canonical, but the general commutator is not. Using (19) we can now verify that the supercharge extracted from (16) satis es (7).

A nother novel feature appears when we construct the bosonic part of the ham iltonian in term s of  $a_{p\,i}$ ,  $b_{p\,i}$ . The canonical ham iltonian is not diagonalized in the basis de ned by (18); it is instead diagonalized in the basis de ned by

In this basis the bosonic ham iltonian is

$$H_b = d^3x !_+ a_p^{yi} a_{pi} + ! b_p^{yi} b_{pi} ;$$

showing that the CPT conjugate single particle states have a mass-squared splitting equal to j4m  $_{\rm d}$ m  $_{\rm h}$  j.

A similar analysis for the ferm ions diagonalizes the ferm ionic part of the ham iltonian in terms of the anti-commuting Fock operators  $a_{ps}$ ,  $\tilde{b}_{ps}$ , where s is the spin label:

A gain the CPT conjugate states have a mass-squared splitting equal to j4m  $_{\rm d}m$   $_{\rm h}$  j.

### COMMENTS

It would be interesting to extend the above construction to produce an interacting theory. A conventional N=2 hypermultiplet can interact with an N=2 vector multiplet, or can have self-interactions describing a nonlinear sigm a model [11]. For the hom eotic case neither extension appears entirely straightforward.

The hom eotic N=2 hypermultiplet has 8 real on-shell degrees of freedom . We have just seen that half of these describe a boson-ferm ion pair with mass jm  $_d+m_h$  j while the other half describe a boson-ferm ion pair with mass im  $_d-m_h$  j.

Since an ordinary N=2 hyperm ultiplet can be split into two N=1 chiralm ultiplets, it is in portant to ask whether our hom eotic N=2 hyperm ultiplet is reducible into two N=1 multiplets. The answer is no. This can be seen by in posing the Majorana condition on the fermions in (4), and observing that the hom eotic mass term then vanishes identically. Alternatively, one notes that the usual decomposition of the hypermultiplet into chiral multiplets can be written in the Fock basis as

obviously in the hom eotic case this would  ${\tt m}$  ix operators with di erent dispersion relations.

The irreducibility of the hom eotic N=2 hyperm ultiplet is in fact very analogous to the irreducibility of the ordinary N=1 chiral multiplet. In this case one nds the 4 on-shell degrees of freedom consist of two CPT conjugate pairs; each pair has one boson and one ferm ion state, related by supersymmetry. However it is not possible to reduce the multiplet, due to the non-existence of Majorana-Weyl spinors in four dimensions [12]. This

is the analog of the non-existence of hom eotic M a jorana spinors in four dim ensions.

As a parting remark, let's inquire how one might attempt to contruct a supermultiplet in which bose-ferm i degeneracy is violated. At the level of the on-shell ham iltonian, this does not appear to be particularly dicult. Let H  $_0$  (m) be a mass term with mass parameterm for a free supersymmetric ham iltonian containing two species of ferm ions, and construct a new ham iltonian de ned by

$$H_1 = H_0 \text{ (m)} + (1)^{F_1 + F_2} H_0 \text{ (m)}$$

where  $F_1$  and  $F_2$  are the ferm ion number operators for the two species of ferm ions. Clearly the single particle eigenstates of  $H_1$  have dierent masses for bosons and ferm ions: the bosons have mass m + m  $^0$  while the ferm ions have mass m m  $^0$ . It is easy to see that, acting on single particle states:

from which it follows that, acting on single particle states:

$$[Q;H_0] = 0$$
)  $[Q;H_1] = 0$ ; (26)

and thus supersymmetry is unbroken. The challenge, of course, is to realize such a scheme in eld theory.
