Seesaw Neutrino Masses with Large Mixings from Dimensional Deconstruction

A bstract

We demonstrate a dynamical origin for the dimension—ve seesaw operator in dimensional deconstruction models. Light neutrino masses arise from the seesaw scale which corresponds to the inverse lattice spacing. It is shown that the deconstructing limit naturally prefers maximal leptonic mixing. Higher-order corrections which are allowed by gauge invariance can transform the bimaximal into a bi-large mixing. These terms may appear to be non-renormalizable at scales smaller than the deconstruction scale.




Figure 1: The two-site model.

1 Introduction

In contrast to the quark sector, the present state-of-the-art neutrino experiments [1] dem and large or even maximalmixings. An attempt to unication requires new physics beyond the standard model (SM). For instance, in SO (10) models, one can relate the spectra of both the charged and neutral fermions in agreement with known phenomenology [2]. Broadly, most eorts to explain avour physics are either (i) strongly model dependent (see e.g. [3]) or (ii) require initial assumptions on the neutrino spectra (see e.g. [4]). Another option is to explore the framework of dimensional deconstruction [5], where the ects of higher dimensions originate as a pure dynamical ect in the infrared limit. In this context, it is interesting to study the impact on the Yukawa sector of a model [6]. Here, we recover the salient aspects of neutrino phenomenology, namely large mixings and light masses, from a completely massless four dimensional theory at some large scale. The lightness of the neutrino masses are an outcome of deconstruction which projects out the dimension—ve seesaw operator [7]. This scenario contains massless Nambu-Goldstone modes corresponding to a symmetry which can be associated with large mixings. All of these basic features can be easily understood by considering a simple two-site lattice model.

2 The two-site model

Consider a $G = G_{SM}$ SU (m) SU (m) gauge theory for deconstructed extra dimensions, where G_{SM} denotes the SM gauge group. The left-handed lepton doublets are denoted by ' = ($_L$; e_L) T and the corresponding right-handed charged leptons by E , where the G reek indices denote the usual avors (e; and). We will assume that 'and E transform as \overline{m}_1 under SU (m) and 'and E transform as m_2 under SU (m) and 'and E transform as m_2 under SU (m) while N transforms as m_2 under SU (m) and N , where N transforms as the bi-fundamental representation (m_1 ; m_2) the neighboring SU (m) groups. This eld theory is sum marized by the \moose" or \quiver" [8] diagram in Fig. 1. The most general renormalizable Yukawa interactions for the neutrinos are then given by



The kinetic term for the link eld is $(D)^{9}D$; $D=(0)^{1}gA_{1}^{a}T_{a}+ig_{2}A_{2}^{a}T_{a})$, where A_{1}^{a} (i=1;2) are the gauge elds and T_{a} represent the group generators along with the dimensionless gauge couplings, g_{1} and g_{2} . In (1), $H=i^{2}H$ is the charge conjugated Higgs doublet and Y; Y; f are complex Yukawa couplings of O(1). Note that in (1) the bare Dirac and Majorana mass terms of the types $\overline{N^{c}N}$ and $\overline{N^{c}N}$ or $\overline{N^{c}N}$ are forbidden by invariance under the group G. For a suitable scalar potential the eld can acquire a VEV such that $hi=M_{x}$, thereby generating a mass for the scalar eld. M_{x} is identified with the deconstruction scale at which the SU (m)₁ SU (m) sym metry is broken down to the diagonal SU (m), thereby eating one adjoint Nambu-Goldstone multiplet in the process. The corresponding lattice spacing is a $1=M_{x}$. A fter spontaneous sym metry breaking, the light elective Majorana mass matrix takes the form

hH i ' 10 G eV is the electroweak scale and M $_{\rm x}$ ' 10 G eV is the seesaw scale. This simple analysis leads to our main observations. It is not dicult to identify the mass matrix in (2) as the one which arises from the usual dimension-ve operator of HH. In other words, for length scales r а 1=M, the renormalizable and gauge invariant Yukawa interaction in (1) reproduces the e ects of the fith dimension. a, we retain a completely renormalizable four-dimensional interaction as de ned in (1). In addition, contrary to the conventional seesaw operator, dimensional deconstruction can naturally lead to maximal mixings between the two active neutrino and . This is realized due to the eld which mediates a symmetry between each of the ferm ions (N ,). This symmetry can be interpreted as an interaction which conserves a charge L L which is rejected in the resulting mass matrix for N $\,$. This is retained after symmetry breaking as there exists the diagonal subgroup SU (m) which respects the symmetry such that the eld would transform as $(m; \overline{m})$. In the gauge sector, this unbroken symmetry corresponds to the presence of a zero mode and is A a (0) $(q_2A_1^a + q_1A_2^a)$. The D irac sector of the model remains diagonal due to the nature of this construction while maximal mixings are introduced from the heavy Maiprana sector of the resulting seesaw operator. Equivalently, the qualitative features of this system are not altered even if one allows for both the ferm ions and scalars to be link variables. We use this freedom when we discuss the phenomenology for this mechanism in section 3.




Figure 2: Cases (i) (left panel) and (ii) (right panel).




Figure 3: Case (iii).

Next, we would like to understand how generic is the interaction described in (2). To answer this question, we consider three possible modi cations to Fig. 1 which are sum marised in Fig. 2 and Fig. 3 as cases (i)-(iii). Clearly, in case (i), only higher-order terms of the form 'H'N are possible, but a priori, there is no information on mixings or masses. In case (ii), we have an interaction $Y \cdot H'N + Y \cdot H'N + fN \cdot N$ which leads to M = 0. Interestingly, for case (iii), depending on the representation of the fermionic elds, we can envisage two distinct interactions. The rst one is of the type $Y \cdot H'N + Y \cdot H'N$

which gives D irac masses with arbitrary masses and mixings. The second possibility is of the type $Y \cdot H \cdot N + fM \cdot N \cdot N$ which again results in M = 0. Note that in the latter case, gauge invariance allows for a bare mass term which is in contrast to (1). From the dierent cases (i)—(iii) we observe a restrictive pattern for the allowed ferm ion masses; this is unlike (1) which ensures a renormalizable mass term for all of the resulting D irac and Majorana ferm ions. This maxim is the allowed Yukawa interactions and leads also to maximal mixings. In a realistic framework, the basic structure of (1) is always expected to be borne out as we shall demonstrate.

3 A realistic m odel




Figure 4: A four-site model.

We exam ine a generalization to the case of a moose mesh [9]. Consider a $^4_{i=1}SU$ (m) $_i$ gauge theory containing ve scalar link variables $_i$ (i = 1;:::;5) and the ferm ion elds is the set f'; E; N g. This model is depicted in Fig. 4 and up to mass dimension six, we have

where the dots represent non-renorm alizable interactions of the leptons with elective scalar operators involving only the elds H and/or $_{i}$. In (3), Y and f_{i} (i = 1;:::;6) are complex couplings and (h_{i} i) denotes the scale such that, for lattice spacing a 1= , the theory is fully renormalizable. After symmetry breaking and giving universal VEVs h_{i} i M_{x} , the D irac and M a jorana mass matrices take the form

where only the order ofm agnitude of the term swith mass dimension 6 has been indicated. We note that in (4), as a consequence of the lattice geometry M $_{\rm D}$ is nearly diagonal while the M a jorana sector carries the $\overline{\rm L}={\rm L_e}$ L symmetry which is softly broken by a nonzero . In the limit ! 0, both (1) and (3) reproduce similar features. Neglecting the smallmixing in the Dirac sector and setting Y 'Y alongwith real couplings, $f_1=f_2=f_3=f_4=f_5$ f, the elective light neutrino mass matrix comes to a familiar pattern [10] with

The relations between the solar and atm ospheric mass-squared dierences, m 2 and m 2 are respectively, and the solar mixing angle $_{12}$ are

For illustration, we choose = 0.22, $Y_e = f$, $Y = f_6$, $Y = Y_e = 2.5$ and we obtain an atm ospheric m ixing angle $_{23}$ ' =4 and a reactor m ixing angle close to zero, i.e., U_{e3} ' 0. Such an allowed choice m in im ally alters the basic features of a renorm alizable Lagrangian, leading to a soft breaking of the L sym m etry. Furtherm ore, taking m $_{atm}^2 = 2.5 \quad 10^3 \text{ eV}^2$, we obtain a norm all neutrino m ass hierarchy with m $_{2}$ ' 7.5 $_{10}^5$ eV $_{2}^2$ and $_{12}$ ' 32 which is in agreement with the M SW LMA-I solution [11]. For the above values, the system predicts an elective neutrinoless double beta decay mass, m $_{ee}$ ' 10 $_{3}^{3}$ eV .




Figure 5: A three-site model.

We brie youtline two dierent variations to (3). Let us ret consider a $\frac{3}{i=1}$ SU (3)_i product gauge group with a representation content as speci ed in Fig. 5 where the arrows de ne as before the eld transform ations. We use the Froggatt-Nielsen mechanism [12] to break the L sym m etry by putting on each of the sites SU (3)1 and SU (3)2 two extra SM singlet elds; these are two scalars ($_{\rm e}$;) and two heavy D irac ferm ion elds (F $_{\rm e}$;F). To retain soft-breaking of the \overline{L} symmetry, we need to impose a Z_4 symmetry ! \mathbf{F}_{L} , $_{3}$! $_{3}$, where = e; . We assume that the SU (3) $_{1}$ and SU (3) $_2$ sym m etries are broken by bare M a jorana m ass term s F_R^c M F_R at som e aquire the VEVsh i = M_x the heavy right-handed M_{x} . W hen the elds $f_{N}M_{x}\overline{N}^{c}N$ and ferm ions F_R are integrated out leading to the dimension-ve terms fgM $_{\rm x}$ N $_{\rm e}$ N $_{\rm e}$, where ' M $_{\rm x}$ =M . The right-handed neutrino m ass matrix is given by M $_{\rm R}$ in (4) with f_4 ; f_5 ' 0 and hence one obtains the relations as in (6). A Itematively, if we perform the identication, 2! 0 and SU $(3)_i!$ U $(1)_i$ and the elds (';N) (= e; ;) are assigned appropriate U (1) charges, it is not dicult to derive a model leading to (4). In conclusion, we argue that upon deconstruction (i) a light neutrino mass is a general result and (ii) maximal mixing is inevitable due to the specic Yukawa interactions in (1). In the lim it of a large lattice site model (of size N 1), one can draw comparisons to the genuine extra-dim ensional scenarios (of radius R) with the identications to the ve-

In the limit of a large lattice site model (of size N 1), one can draw comparisons to the genuine extra-dimensional scenarios (of radius R) with the identications to the vedimensional gauge couplings, g_5 (y_i)! $R = N g_i$, where y_i denotes the fifth coordinate. In this analysis, we have $\lim_{n \to \infty} \operatorname{ited}$ ourselves to describing the physics of a periodic lattice where it is su cient to examine the periodic interval of any one Brillouin zone. In general, we predict a small U_{e3} which depends on the pattern of the underlying \overline{L} symmetry breaking.
