# Universal Texture of Quark and Lepton M ass M atrices

### Abstract

A gainst the conventional picture that the mass matrix forms in the quark sectors will take som ewhat di erent structures from those in the lepton sectors, a possibility that all the mass matrices of quarks and leptons have the same form as in the neutrinos is investigated. For the lepton sectors, the model leads to a nearly bim axim alm ixing with the prediction  $\mathbf{j}\mathbf{U}_{e3}\mathbf{j}^2 = \mathbf{m}_e = 2\mathbf{m} = 0.0024$  and  $\tan^2_{sol}$  ' m  $_1 = m_2$ , and so on. For the quark sectors, it can lead to reasonable values of the CKM mixing matrix and masses:  $\mathbf{j}\mathbf{U}_{us}\mathbf{j}$ ,  $\mathbf{p} = \mathbf{m}_{e} = \mathbf{m}_{e}$ ,  $\mathbf{j}_{ub}\mathbf{j}$ ,  $\mathbf{j}_{ub}\mathbf{j}$ ,  $\mathbf{j}_{ub}\mathbf{j}$ ,  $\mathbf{j}_{ub}\mathbf{j}$ ,  $\mathbf{j}_{ub}\mathbf{j}$ ,  $\mathbf{j}_{ub}\mathbf{j}$ , and so on.

#### I.M ODEL

Recent neutrino oscillation experiments [1 {4] have highly suggested a nearly bin aximal mixing ( $\sin^2 2_{12}$  1,  $\sin^2 2_{23}$  '1) together with a small ratio R m  $_{12}^2$  m  $_{23}^2$  10<sup>2</sup>. On the other hand, we know that the observed quark mixing matrix V<sub>CKM</sub> is characterized by smallmixing angles. Thus, the mixing matrices of quarks and leptons are very di erent from each other. Therefore, usually, the following picture is accepted: the mass matrix forms in the quark sectors will take som ewhat di erent structures from those in the lepton sectors.

A gainst such a conventional picture, we investigate a possibility that all them assm atrices of quarks and leptons have the same form s as in the neutrino sector:

where  $P_f = \text{diag}(e^{i\frac{f}{1}};e^{i\frac{f}{2}};e^{i\frac{f}{3}})$ , and the mass matrix  $M_f$  is invariant under a permutation symmetry between second and third generations. The mass matrix parameters  $a_f$ ,  $b_f$ , and  $c_f$  can be expressed in terms of the mass eigenvalues as  $a_f = \frac{q}{m_{f2}m_{f1}=2}$ ,  $b_f = (m_{f3}=2) [1 + (m_{f2} - m_{f1})=m_{f3}]$ , and  $c_f = (m_{f3}=2) [1 - (m_{f2} - m_{f1})=m_{f3}]$ .

The mass matrix form (2) was suggested from the neutrino mass matrix form [5] which leads to a nearly bin axim almixing

where  $U^T M U = \text{diag}(m_1; m_2; m_3)$  and

Note that the matrix form (1) with (2) is almost invariant under the renormalization group equation (RGE) e ects, so that we can use the expression (1) with (2) for the predictions of the physical quantities in the low-energy region, as well as those at the unication scale. The zeros in this mass matrix are constrained by a discrete symmetry  $Z_3$  that is discussed in Ref. [6], de ned at a unication scale (the scale does not always mean \grand unication scale"). This discrete symmetry  $Z_3$  is broken below = M<sub>R</sub>, at which the right-handed neutrinos acquire heavy M a prana masses. Therefore, the matrix form (1) will, in general, be changed by the RGE e ects. Nevertheless, we can use the expression (1) with (2) for the predictions of the physical quantities in the low-energy region, as discussed in Ref. [6].

### II.QUARK M IX ING MATRIX

The quark mass matrices with the form (1) are diagonalized by the biunitary transformation  $D_f = U_{Lf}^{Y} M_f U_{Rf}$ , where  $U_{Lf} = P_{Lf}^{Y} O_f$ ,  $U_{Rf} = P_{Rf}^{Y} O_f$ , and  $O_d (O_u)$  is given by

(For simplicity, hereafter, we will take  $P_R = P_L^{y}$ , so that the matrix  $M_f$  becomes a symmetric matrix. However, this assumption is not essential for the results in the present model.) Then, the Cabibbo {K obayashi {M askawa (CKM) quark mixing matrix V is given by

Here we have put P  $P_u P_d^{Y}$  diag ( $e^{i_1}; e^{i_2}; e^{i_3}$ ), and we have taken  $_1 = 0$  without loss of generality.

From the expression (6), we obtain the phase-parameter independent predictions (the 3rd generation quark-m ass independent predictions [7])

which are alm ost independent of the RGE e ects.

Next let us x the parameters  $_3$  and  $_2$ . From the relation

and the observed value [8]  $\mathbf{y}_{cb}\mathbf{j} = 0.0412 = 0.0020$ , we obtain  $_{3}_{2} = 4.59 = 0.21$ . A lso, from the expression of  $\mathbf{y}_{us}\mathbf{j}$  we can obtain the value  $_{3} + _{2} = 93 = 22$ . Because of the small value  $\sin \left( \begin{array}{cc} & \\ & 2 \end{array}\right) = 2' = 0.04$ , we obtain the following approximate relations

which are consistent with the present experim ental data [8].

In the present model, the rephasing invariant Jarlskog parameter J is given by

Therefore, the phase factor in the standard expression of V corresponds to  $'_3 + _2=2$ in the present model. We predict jJ j= (1:91 0:38)  $10^5$ .

#### III.LEPTON M IX ING MATRIX

We assume that the neutrino masses are generated via the seesaw mechanism  $M = M_D M_R^{-1} M_D^{-T}$ . Here  $M_D$  and  $M_R$  are the D irac neutrino and the right-handed M a jorana neutrino mass matrices. Note that when we assume the same matrix form s (1) for  $M_D$  and

 $M_R$ , the electric neutrino mass matrix  $M = M_D M_R^{-1} M_D$  is again given by the same texture (1):

Therefore, we obtain the lepton m ixing m atrix U

$$U = O_{e}^{T} P O = B_{e}^{B} S_{e}C + S_{e}S - S_{e}S + S_{e}C - S_{e}C$$

where P  $P_eP^Y$  diag ( $e^{i-1}$ ;  $e^{i-2}$ ;  $e^{i-3}$ ). Hereafter we will again take  $_1 = 0$  without loss of generality. Note that  $V = O_u^T PO_d$ , while  $U = O_e^T PO$ , so that all the mixing formulae in the lepton sectors are given by the replacement ( $m_u$ ;  $m_c$ ;  $m_t$ ) ! ( $m_e$ ;  $m_r$ ;  $m_r$ ) and ( $m_d$ ;  $m_s$ ;  $m_b$ ) ! ( $m_1$ ;  $m_2$ ;  $m_3$ ) in those in the quark sectors. However, this does not means that the physics in the up-quark (down-quark) sector corresponds to the physics in the charged lepton (neutrino) sector. In fact, as we see in Table 1, the parameter values in each sector are di erent from the other.

W e obtain the phase-param eter independent predictions

The neutrino mixing angle  $a_{tm}$  under the constraint jm  $^2_{23}$  j m  $^2_{12}$  j is given by

We assume the maximal mixing between and , so that we take  $_3$   $_2 = =2$ . Then, the model predicts

which is consistent with the constraint  $\mathbf{j} \mathbf{J}_{13} \mathbf{j}_{xp}^2 < 0.03$  from the CHOOZ data [3]. Them ixing angle solar is given by

which leads to the relation m  $_1 = m_2$  '  $\tan^2_{\text{solar}}$ . Therefore, the best t value [2]  $\tan^2_{\text{solar}} = 0.34$  predicts the neutrino m asseratio m  $_1 = m_2$  ' 0.34, so that we can obtain the neutrino m asses

$$m_1 = 0.0030 \text{ eV}$$
;  $m_2 = 0.0088 \text{ eV}$ ;  $m_3 = 0.050 \text{ eV}$ ; (3.7)

where we have used the best t values [4,1] of m  $_{solar}^2$  = 6.9 10<sup>5</sup> eV<sup>2</sup> and m  $_{atm}^2$  = 2.5 10<sup>3</sup> eV<sup>2</sup>.

We also obtain the averaged neutrino mass hm i  $(10^3 \ 10^4)$  eV, but the explicit value is highly dependent on the value of  $(_3 + _2)=2$ . At present, we cannot x the value of .

#### IV.CONCLUSION

In conclusion, stimulated by recent neutrino data, which suggest a nearly bin aximal mixing, we have investigated a possibility that all the mass matrices of quarks and leptons have the same texture as the neutrino mass matrix. In spite of the assumption of the universal texture for all the ferm ion mass matrices, we can obtain the di erences between  $V_{quark}$  and  $V_{lepton}$  as follows: (i) the mixing between 1st and 2nd generations is given by  $\tan_{12} = \frac{q}{m_1 = m_2}$ , so that the well-known empirical relation  $\mathbf{j}_{us}\mathbf{j}' = \frac{q}{m_1 = m_s}$  is due to the observed mass rations  $\mathbf{m}_u = \mathbf{m}_c$   $\mathbf{m}_d = \mathbf{m}_s$  1, and the nearly maximal mixing  $\mathbf{j}_{e2}\mathbf{j}$   $\mathbf{1} = \frac{p}{2}$  is due to the approximate degeneracy  $\mathbf{m}_1$   $\mathbf{m}_2$  and the observed mass ratio  $\mathbf{m}_e = \mathbf{m}_1$ ; (ii) the mixing between 2nd and 3rd generations is given by the relation (9) (and the corresponding relation in the lepton sector), so that the small value  $\mathbf{j}_{db}\mathbf{j}'$  0.04 means  $(a_{12})=2'$  0.04 and  $\mathbf{m}_u=\mathbf{m}_c$  1, and them aximal mixing  $\mathbf{V}_3' = \frac{p}{2}$  means  $a_{12} = 2'$  together with  $\mathbf{m}_e = \mathbf{m}_1$ .

The present data in the quark sectors have already xed the CP violating phase parameters  $_3$  and  $_2$ , while the present neutrino data have yet not xed the parameter ( $_3+_2$ )=2,

although they have xed the value of  $\begin{pmatrix} 3 \\ 2 \end{pmatrix} = 2$ . We hope that future experiments on the CP violation will x our remaining parameter . Then, we will be able to obtain a clue to the origin of our phase parameters  $_{i}$  ( $_{i}$ ).

Since, in the present model, each mass matrix  $M_f$  (i.e. the Yukawa coupling  $Y_f$ ) takes di erent values of the parameters  $a_f$ ,  $b_f$ , and so on, the present model cannot be embedded into a GUT scenario. In spite of such a demerit, however, it is worth while noting that the present model can give a uni ed description of quark and lepton mass matrices with the same texture.
