THE G IN ZBURG —LANDAU THEORY AND THE SURFACE ENERGY OF A COLOUR SUPERCONDUCTOR

A bstract

We apply the Ginzburg-Landau theory to the colour superconducting phase of a lum p of dense quark matter. We calculate the surface energy of a domain wall separating the normal phase from the super phase with the bulk equilibrium maintained by a critical external magnetic eld. Because of the symmetry of the problem, we are able to sim plify the G inzburg-Landau equations and express them in terms of two components of the diquark condensate and one component of the gauge potential. The equations also contain two dim ensionless param eters: the Ginzburg-Landau parameter and . The main result of this paper is a set of inequalities obeyed by the critical value of the G inzburg-Landau param eter{the value of for which the surface energy changes sign (and its derivative with respect to . In addition we prove a num ber of inequalities of the functional dependence of the surface energy on the parameters of the problem and obtain a numerical solution of the G inzburg-Landau equations. Finally a criterion for the types of colour superconductivity (type I or type II) is established in the weak coupling approxim ation.

1. Introduction.

The G inzburg-Landau theory provides a powerful tool for exploring systems with inhom ogeneous order param eters near the critical tem perature. For instance, its application to the surface energy of a normal-superconducting interface led to the discovery of the two types of superconductors. When an external magnetic eld whose magnitude is less than a critical value H $_{\rm C}$, is applied to type I superconductors, the eld is expelled from the interior of the sample (the M eissner e ect). As the magnitude of the magnetic eld increases above H $_{\rm C}$, superconductivity disappears completely and the normal phase is restored. In the case of type II superconductors, the sample behaves in a similar manner as long as the external magnetic eld remains below a lower critical magnitude, H $_{\rm cl}$. A qualitatively diserent behaviour emerges when the applied magnetic eld lies in the range H $_{\rm cl}$ < H $_{\rm C}$ < H $_{\rm C2}$, where it becomes energetically favourable for the magnetic eld to penetrate the sample in the form of quantized ux lines called vortices. Beyond the upper critical magnitude of the eld, the vortices are too dense to maintain the condensate, and the normal phase is once again restored.

The criterion that determ ines whether a superconductor is of type I or type II is the G inzburg-Landau parameter. It is defined as the ratio of the penetration depth of the magnetic eld over the coherence length, the distance over which changes in the order parameter occur, i.e. = -. These characteristic lengths in ply that uctuations in the magnitude of the condensate decay as e while the magnetic eld inside the superconductor falls of as e. In their original paper, G inzburg and Landau [1] analyzed the energy of the interface between a normal and a superconducting phase, kept in equilibrium in the bulk by an external magnetic eld at the critical value. They found analytically that the surface energy vanishes at

The physical meaning of this critical value was clarified further by Abrikosov [2]. It represents the demarcation line between type I ($< \frac{1}{2}$) and type II ($> \frac{1}{2}$) superconductors.

In the present paper we shall carry out a sim ilar analysis of the G inzburg-Landau theory for colour superconductors. C olour superconductivity is essentially the quark analog of BCS superconductivity [3], [4], [5], [6]. Because of attractive quark-quark interactions in QCD, the Ferm isphere of quarks becomes unstable against the formation of Cooper pairs and the system becomes superconducting at suiciently low temperatures. In this paper we shall consider a domain wall separating the normal and colour superconducting phases in equilibrium under the in under of an external magnetic eld and calculate the surface free energy per unit area. The G inzburg-Landau equations for this system are considerably more complicated than the analogous equations for an ordinary superconductor [7], [8],

[9], [10], [11], because of the non-abelian nature of the problem . By using symmetry arguments, we were able to simplify the problem of the domain wall and express the G-L equations in terms of one gauge potential and two components of the di-quark condensate. When expressed in terms of dimensionless quantities, the G-L equations contains two dimensionless parameters: the usual Ginzburg-Landau parameter and another parameter. We eak coupling calculations x the value of to be equal to $\frac{1}{2}$. Although we were unable to derive an analytical result analogous to (1.1) we proved the following inequalities for the critical G-L parameter and its derivative with respect to :

In section 2 of this paper, we shall review the G inzburg-Landau theory of colour superconductivity. The analytical and numerical solution of the domain wall problem will be presented in section 3. In the nal section of the paper we shall summarize our results and in the appendix we shall discuss the validity of the G inzburg-Landau theory in the presence of the uctuations of the gauge eld.

2. The Ginzburg-Landau Theory of Colour Superconductivity.

The sym metry group of QCD in the chiral lim it is

where the subscript c denotes colour, the subscript f_R (f_L) the right (left)-hand avour and B the baryon number. The electrom agnetic gauge group U (1)_{em} is not a separate symmetry group, but a subgroup of SU (3)_{fR} SU (3)_{fL}. The dominant pairing channel consists of two quarks of the same helicity and the corresponding order parameters in a colour superconducting quark matter will be denoted by $_R$ and $_L$. These condensates transform into each other under space inversions. Neglecting the parity violating processess,

where $A = A^{1}T^{1}$ denotes the classical vector potential of the SU (3) colour gauge eld, A the electrom agnetic eld, and eq_f is the electric charge of the f-th avour quark. The SU (3) generator T^{1} is in its fundam ental representation.

At weak coupling, the parameters are calculable from either the perturbative onegluon exchange interaction of QCD or from the Nambu-Jona-Lasinio e ective action. Both approaches lead to the same expression [7], [8]:

Since in this paper we address the dom ain wall problem - the interface between a norm al and a superconducting phase in an external magnetic eld-the boundary conditions select the even parity sector of (2.2)

The one-gluon exchange process that dom inates the di-quark interaction at ultrahigh them ical potential is attractive for quarks within the colour antisym metric channel. Thus the Cooper pairs realise the colour antisym metric representation to the leading order of the QCD running coupling constant at T=0 [12], [13], or to the leading order of $\left(1-\frac{T}{T_0}\right)$

near T_c [8]. Assuming such a pairing pattern persists even at moderately high chemical potential, the di-quark condensate can be expressed in terms of a 3 complex matrix,

3) For b_1 and b_2 outside the region speci ed by 1) and 2), the free energy is no longer bounded from below. Higher powers of the order parameter have to be included and the superconducting transition becomes rst order. Since case 2) is mathematically identical to a metallic superconductor, we shall not address it in this paper.

The excitations that violate (2.5) correspond to the Goldstone bosons associated with chiral sym metry breaking, and the particle that becomes massive through the anomaly.

In the rest of this section, we shall determ ine the critical magnetic eld of a homogeneous colour superconductor. For sim plicity, the diam agnetic response of the quarks in the normal phase will be neglected. In the presence of an external magnetic eld, the therm odynam ic function to be minimized is the G ibbs free energy $\tilde{\ }$, which is a Legendre transformation of the Helm holtz free energy $\$, i.e.

which is much higher than the typical magnetic eld inside a neutron star. This estimation of course depends on the validity of the extrapolation of the weak coupling formulas to realistic values of the chemical potential.

3. The Domain Wall Problem.

Let's consider an interface between the normal phase and the colour superconducting phase, for example the y z plane. The equilibrium in the bulk is maintained by a uniform external magnetic eld of critical magnitude, H = H $_{\rm c}$. All quantities then in both phases will depend solely on x. It is evident from symmetry that the gauge eld lies in one plane, let this be the x y plane, so that $V = V(x)\hat{y}$ and r $V = \frac{dV}{dx}$. The boundary conditions on the G inzburg-Landau equations in the problem that we are considering (corresponding to the normal and colour superconducting phases as x V 1 and x V 1) are

Since this ansatz in plements the maximum symmetry allowed by the boundary conditions, we expect that it includes the solution that minimizes the free energy of the domain wall.

In the presence of a non-zero A, as it is required by the boundary conditions, this set of equations does not adm it a solution in which u = v everywhere. Stated dierently, in the presence of an inhom ogeneity and a non-zero gauge potential the unlocked condensate—the octet-has to acquire a non-zero value som ewhere. This situation is analogous to the Ginzburg-Landau theory of a cuprate superconductor [15], where the s-wave condensate




Figure 1. The critical G in zburg-Landau param eter $\,_{\text{c}}$ vs. the param eter $\,_{\text{c}}$




Figure 2.The solutions to the G inzburg-Landau equations (3.10) for $=\frac{1}{2}$ and =0.589. The solid line represents the colour-avour locked component, $\frac{1}{3}$ (u + 2v), the dashed line represents the colour-avour octet component, $\frac{2}{3}$ (v u) and the dotted line the colour-magnetic eld, A⁰.

The critical GL parameter, $_{\rm C}$ versus is plotted in Fig.1. The critical value of GL parameter in the weak coupling approximation (= $\frac{1}{2}$), is $_{\rm C}$ = 0:589. The two components of the di-quark condensate, the colour-avour locked and the colour-avour octet, and the corresponding magnetic eld, that correspond to the solution with = $\frac{1}{2}$ and = $_{\rm C}$ are plotted in Fig. 2. The numerical results are consistent with the inequalities (3.18) and (3.19) that we derived analytically.

If we consider a realistic value for the chem ical potential, for exam ple $\,=\,400\text{M}$ eV , it follows from (1.3) that the colour superconductor will be of type I if k_B $T_c<14\text{M}$ eV and of type II otherwise. Furthermore if we extrapolate the weak coupling formula for T_c [16], [17], [18], [19], [20], which is valid at asymptotic densities, to $\,=\,400\text{M}$ eV we nd k_B $T_c=3.5\text{M}$ eV and the colour superconductor is of type I.O f course if nonperturbative e ects raise T_c signicantly, for example by one order of magnitude, the colour superconductor could be of type II.

4. Concluding Remarks.

In this paper we have applied the Ginzburg-Landau theory to the problem of a domain wall which separates the normal phase from the colour superconducting phase of dense quark matter. The main purpose of this work was to establish a criterion that determ ines whether the colour superconductor is type I or type II with respect to an external magnetic eld. We initially derived the Ginzburg-Landau equations of motion for the gauge elds and the order parameter by minimizing the surface energy of the interface between the two phases. The condition that the surface energy is a minimum is equivalent to the requirem ent that the normal and the colour superconducting phases are in stable equilibrium with each other. This equilibrium is maintained by an external magnetic eld. Using symmetry arguments we were able to simplify the original set of equations and rewrite them in terms of only two components of the order parameter and one gauge potential. The equations also contain two dimensionless parameters: the Ginzburg-Landau parameter and . Therefore the problem is more complicated than the problem of the m etallic superconductor which was addressed by G inzburg and Landau. A Ithough we were unable to derive an analytical result analogous to the G inzburg-Landau criterion (1.1), we derived several rigorous inequalities about the critical parameter of the value for which the surface energy vanishes, and its derivative with respect to . Those analytical results are supported by a num erical solution of the Ginzburg-Landau equations. By extrapolating the weak coupling approximation formulas for the parameters to realistic values of the chem ical potential, for exam ple = 400M eV, we not that the colour superconductor is of type I (type II) if the transition tem perature is below (above) 14M eV.

The value of our work is mainly theoretical. It addresses the broken U (1) gauge eld onto which the electrom agnetic eld has a small projection. A lithough we have been referring to the typical chemical potential of a neutron star, the implications of our work might be quite limited [14]. First of all, there has not been any evidence yet that colour superconductivity is realised in the core of a neutron star. Even if this is the case, the critical magnetic eld (2.35) is too high for the distintion between type I and type II to be observed unless the pairing force is strong enough to reduce the lower critical eld by several orders of magnitude. In addition the small mixing angle (2.34) and the dependence of the magnetic response on the thickness of the crust of the CSC core make it discult to observe the partial magnetic Meissner elect and the appearance of vortex laments.

Because of the strength of the QCD coupling and the ultra-relativistic Ferm i sea, the uctuations of the gauge eld could be more signicant than those in a non-relativistic superconductor [21]. These uctuations contribute to the Ginzburg-Landau free energy functional an energy density

As the condensate energy (2.16) is proportional to $(1 \quad \frac{T}{T_c})^2$ while $\frac{q}{1 \quad \frac{T}{T_c}}$, the contribution from the uctuations will-eventually dominate as T approaches T_c and modify the nature of the phase transition.

The uctuation energy is estimated in the appendix within the framework of the Ginzburg-Landau theory, where we demonstrate that the inclusion of this energy modies the phase transition from second order to rst order. The parameter

which describes the deviation of the $\,$ rst order transition tem perature T from the second order one T_c , is used as a measure of the importance of the uctuations. We not that for realistic values of the quark chem ical potential, $\,=\,400\text{M}$ eV and $k_B\,T_c\,\,$ 13M eV , t $\,$ 0:1. In that case, the G inzburg-Landau free energy functional (2.2) represents a reasonable approximation.

For t 1 the approximation employed to derive the Ginzburg-Landau free energy (2.2) with (2.4) from QCD or from the Nambu-Jona-Lasinio e ective action breaks down. Higher powers of the order parameter have to be included. It would be very interesting to develop a systematic weak coupling approximation in this case and we hope to be able to report progress in the future.

6. A ppendix.

In this appendix we shall estim ate the e ect of the uctuations of the gauge eld. A system atic evaluation of the contribution from the uctuations to the free energy requires a resum mation of a set of ring diagrams of QCD at nite temperature. Here we shall follow the treatment of Bailin and Love [21] and estimate the uctuation terms within the fram ework of the Ginzburg-Landau theory. Due to the Debye screening the contributions of

the longitudinal components of the gauge potentials are supressed, and only the transeverse components contribute in the static limit. We expect that our simplement inded estimation captures the uctuation terms to the leading order of the condensate.

Assuming that the small uctuations are governed by the quadratic form of the Ginzburg-Landau free energy functional, the shift of the free energy due to the Meissner e ect is given by $_{\rm D}$
