BFKL Pom eron at non-zero tem perature and integrability of the Reggeon dynam ics in multi-colour QCD

Abstract

We consider the QCD scattering am plitudes at high energies p s and xed momentum transfers T in the leading logarithm ic approximation at a non-zero temperature T in the t-channel. It is shown that the BFKL Ham iltonian has the property of holom orphic separability. The Pomeron wave function for arbitrary T is calculated using an integral of motion. In multi-colour QCD, the holom orphic Ham iltonian for n-reggeized gluons at temperature T is shown to coincide with the local Ham iltonian of an integrable Heisenberg m odel and can be obtained from the T = 0 Ham iltonian by an unitary transformation. We discuss the wave functions and the spectrum of intercepts for the colourless reggeon states.

1. In QCD the scattering amplitudes A (s;t) in Regge kinematics for high energies $2E = \frac{p}{s}$ and xed momentum transfers $q = \frac{p}{t}$ are obtained in the leading logarithmic approximation $s \ln s$ 1; $s = \frac{q^2}{4}$! 0 (g is the QCD coupling constant) by summing the largest contributions ($s \ln s$)ⁿ to allorders of perturbation theory within the approach of Balitsky, Fadin, Kuraev and Lipatov (BFKL) [1]. The BFKL Pomeron in the t-channel turns out to be a composite state of two reggeized gluons (it is valid also in the next-to-leading approximation [2]). Its wave function (~ 1 ; \sim_2) satis es the Schrödinger equation in the two dimensional in pact-parameter space ~

The intercept of the Pomeron, related to the high energy asymptotics t s of the total cross-section, is proportional to the ground state energy E

The kinetic part $H_{kin} = \ln \dot{p}_1 \dot{f} + \ln \dot{p}_2 \dot{f}$ of H_{12} is a sum of two gluon Regge trajectories and its potential part H_{pot} is related by a similarity transform ation to the two-dimensional Green function $\ln j_{12} \dot{f}$, where $_{12} = _1 _2$. We introduced here the complex coordinates $_r = x_r + iy_r$ and the corresponding momenta $p_r = i\theta_r$].

The BFKL equation is used for the description of the deep-inelastic lepton-hadron scattering together with the DGLAP equation [3] (see for example [4]). It is invariant under the M obius transform ations [5]

with arbitrary complex parameters $a_ib_ic_id$ and H_{12} has the property of holom orphic separability (see [4] [6])

The wave functions belong to the principal series of unitary representations of the M obius group with conform alweights m = 1=2 + i + n=2; m = 1=2 + i - n=2 expressed in terms of the anom alous dimension = 1 + 2i and the integer conform al spin n for the local gauge-invariant operators [5]. The conform alweights are related to the eigenvalues m (m 1), m (m 1) of the Casim ir operators M² and M², where

Here $M^{(r)}$ are the M obius group generators

The eigenfunctions of H_{12} can be considered as the three-point functions of a twodimensional conform all eld theory and have the property of holom orphic factorization [5],

One can calculate the energy putting this Ansatz in the BFKL equation [1]

The minimum of $E_{m,re}$ is obtained at m = rh = 1=2 leading to a large intercept = $4 - N_c \ln 2$ of the BFKL Pomeron. In the next-to-leading approximation the intercept is comparatively small (0.2 for the QCD case) [7].

2. On the other hand, now a signi cant interest is devoted to the quark-gluon plasma (QGP) generation in heavy nucleus collisions (see for example [9]). Current theoretical understanding suggests that the QGP therm alizes via parton-parton scattering. The QGP is understood to cool down by hydrodynam ic expansion till the tem perature reaches the hadronization scale 160M eV. One interesting phenomena is the suppression of the -m eson production in the heavy nucleus collisions due to the disappearance of the con ming potential between q and q at high tem perature [9]. A similar elect should exist for glueballs constructed from gluons. Because the Pomeron is considered as a composite state of reggeized gluons, the in uence of the tem perature on its properties is of great interest. In this paper we construct the BFKL equation at tem perature T in the center-m ass system of the t-channel (where T = 2) and investigate the integrability properties of the BFKL dynam ics in a therm ostat for composite states of n reggeized gluons in multi-colour QCD.

Let us consider the Regge kinematics in which the total particle energy r s is asymptotically large in comparison with the temperature T. In this case one can neglect the temperature e ects in the propagators of the initial and intermediate particles in the direct channels s and u. But the momentum transfer jqj is considered to be of the order of T (note, that q is the vector orthogonal to the initial momenta q q^2). As it is well known [8], the particle wave functions (x) at temperature T are periodic in the euclidean time = it with period 1=T.

W e introduce the tem perature T in the center of m ass fram e of the t-channel. Thus, the euclidean energies of the interm ediate gluons in the t-channel becom e quantized as

In the s-channel the invariant t is negative and therefore the analytically continued 4m om enta of the t-channel particles can be considered as euclidean vectors. It m eans, that at tem perature T, the wave functions for virtual gluons are periodic functions of the holom orphic im pact-parameter = x + iy with im aginary period $\frac{i}{T}$. A loo, the canonically conjugated m om enta p have their im aginary part quantized,

with integer 1 (note that $p = (p_1 + ip_2)=2$).

It is convenient to rescale the transverse coordinates and corresponding momenta as follows

In these dimensionless variables one obtains

The calculation of the Regge trajectory 1 + ! (t) of the gluon at tem perature T in the tchannel, in one-loop approximation reduces to the integration over the real part k_1 of the transverse m on entum \tilde{k}_2 of the virtual gluon and to the sum mation over its imaginary part $k_2 = 1$. In such a way we obtain the following result for the trajectory having the separability property [cf. [6]],

where we regularized the infrared divergence for the zero m ode l = 0 introducing a m ass for the gluon (see [1]).

A similar divergence appears in the Fourier transformation G ($_{12}^{!}$) of the elective gluon propagator ($K_2^2 + _2^{-1}$) ¹ contained in the product of the elective vertices $q_1 k^{-1} q_2$ for the production of a gluon with momentum k (cf. [4])

Therefore, the divergence at ! 0 cancels in the sum of kinetic and potential contributions to the BFKL equation and the Ham iltonian H₁₂ for the Pomeron in a therm ostat has the property of holom orphic separability with the holom orphic Ham iltonian given below [cf. eq.(2)]

3. The Ham iltonian (6) is a periodic function of $_{12}$. Therefore its eigenfunctions are quasi-periodic functions of this variable. The behaviour of h_{12} for sm all $_{12}$ corresponds to the low temperature regime. Hence, the eigenfunctions of h_{12} behave for $_{12}$! 0 as the holom orphic part of the zero-tem perature wave functions eq.(3),

Notice that 1 m (12) is an eigenfunction too.

We not the small-T expansion of h_{12} near its singularities $_{12} = 2$ il. For example, for small $_{12}$ and large $p_1; p_2$ we have

where h_{12}^0 is the holom orphic BFKL Ham iltonian at a zero tem perature [given by eq.(2)] and the B_{2k} are the Bernoulli numbers. This representation for h_{12} permits us to d the

small-T expansion of its eigenfunctions. For example, at a vanishing momentum transfer $Q = p_1 + p_2$ we obtain for the eigenfunction $m(1_2)$,

These eigenfunctions are parametrized by the conform alweight m .

On the other hand, from the above expansion it is possible to verify, that the holom orphic H am iltonian has the non-trivial integral of motion:

Therefore, instead of solving the Schrödinger equation we can search for the eigenfunctions of the operator A. For non-zero Q one can write the holom orphic wave function as a product of a plane wave depending on $R = (_1 + _2)=2$ times a solution of the following equation for the relative motion of two gluons

The two independent solutions of the above di erential equation can be expressed in terms of hypergeom etric functions

For ! 0 eq.(7) holds and the singularities of (r)(;Q) at 1 = 1 and 1 = 1 correspond to the points = 1 and = 1, respectively.

The analytic continuation of (r) along the imaginary axes from = 0 to = 2 i is equivalent to the continuation of these eigenfunctions in a circle passed in a clock-wise direction around the singularity at = 1. The monodrom y matrix expressing the analytically continued solutions in terms of the initial ones can be easily calculated.

The Pomeron wave functions can be written as a bilinear combination of holom orphic and anti-holom orphic eigenfunctions ^(r) (;Q) and ^(r) (;Q). The property of singlevaluedness in the cylinder topology corresponding to the periodicity on the boundaries of the strip 0 < Im $_{12}$ < 2 is easily imposed to such Pomeron wave function using the monodrom y matrix for ^(r) (;Q). The resulting wave function can be written as,

4. The Pom eron wave function can be constructed directly in coordinate space. For this purpose we use the conform al transform ation

and the integral of m otion eq.(8) becomes

Thus, A coincides in the variables r^0_r with the Casim ir operator of the conform al group whose eigenfunctions are well known (see [5]). Thus, the Pom eron wave function at non-zero tem perature having the property of single-valuedness and periodicity takes the form

The orthogonality and completeness relations for these functions can be easily obtained from the analogous results for T = 0 (see [5]) using the above conform al transform ation. These wave functions are proportional to the Fourier transform ation of the wave functions $m \pi^{e}$ (~;Q).

M oreover, the pair BFK L H am iltonian h_{12} can be expressed in term s of the BFK L H am iltonian at zero tem perature in the new variables

where $p_r^0 = i \frac{\theta}{\theta_r^0}$. In the course of the derivation the following operator identity (see [4])

was used to transform the kinetic part as well as properties of the -function.

In sum m ary, the exponential m apping eq.(11) which in dimensional variables takes the form

m aps the reggeon dynamics from zero temperature to temperature T. This mapping explicitly exhibits a periodicity $! + \frac{i}{T}$ for a thermal state. It must be noticed that such class of mappings are known to describe thermal situations for quantum elds in accelerated fram es and in black hole backgrounds [23].

5. As it is well known [10], the BFKL equation at T = 0 can be generalized to composite states of n reggeized gluons. In the multi-colour lim it N_c ! 1 the BKP equations are signi cantly simplied thanks to their conform al invariance [5], holom orphic separability [6] and integrals of motion [11]. The generating function for the holom orphic integrals of motion coincides with the transferm atrix for an integrable lattice spin model [12] [13]. The transfer matrix is the trace of the monodrom y matrix

satisfying the Yang-Baxter equations [13]. The integrability of the n-reggeon dynam ics in multi-colour QCD is valid also at non-zero tem perature T, where, according to the above arguments we should take the L-operator in the form

In particular, the holom orphic H am iltonian is the local H am iltonian of the integrable H eisenberg m odel with the spins being unitarily transform ed generators of the M obius group (cf. [14] [15])

 $M_k = Q_k$; $M_+ = e^{k} Q_k$; $M_- = e^{k} Q_k$:

Because the H am iltonian at non-zero tem perature can be obtained by an unitary transform ation from the zero tem perature H am iltonian, the spectrum of the intercepts for multi-gluon states is the same as for zero tem perature [16]-[20] and the wave functions of the composite states can be calculated by the substitution $_{k}$! e^k.

Furtherm ore, the non-linear Balitsky-K ovchegov equation [21] can be generalized to the case of non-zero tem perature as follows,

where $N_{\sim_1 \not\sim_2}$ is the amplitude of nding a dipole with the impact parameters \sim_1 and \sim_2 in a hadron and the integration over $_0$ is performed over the strip $0 < Im_0 < 2$. Note, however, that in this equation one takes into account only fan diagrams for the Pomeron interactions among all possible diagrams for reggeized gluons appearing in the high energy e ective action [22].
