## New interactions in the radiative pion decay

#### Abstract

The prelim inary results of P IBETA experiment strongly suggest the presence of non V A anomalous interactions in the radiative pion decay. W ithout a guiding idea about the nature of these new interactions it is very di cult to interpret and t experimental data. We assume that they arise as a result of the exchange of new intermediate chiral bosons which interact anom alously with matter. Their mixing with W -bosons leads e ectively to a small anom alous weak moment for W. Based on these assumptions, we show that the most general form of the radiative pion decay rate can be parametrized by three new coupling constants of the anomalous interactions.

#### 1 Introduction

The Standard M odel (SM ) is now a well established theory of the electroweak and the strong interactions. Its experimental success is impressively great and, therefore, all anomalies in the present and the past experiments are usually considered as their artifacts or statistical uctuations. Nevertheless, from the general point of view we believe that SM is just the limit of a more general theory with new particles and an enlarged symmetry.

M any people trust that this is the supersymmetry (SUSY). The present phenom enological SUSY models are constructed by simply doubling of the known particles without introducing really new kinds of elds. Therefore, for their description the contemporary framework of the quantum eld theory can be used. In such models all processes can be computed and predictions for their experimental manifestation can be made.

In the present paper we discuss a new kind of vector particles, whose full theory is not constructed yet. However, a phenom enological approach is possible, and, moreover, it is motivated by the available experimental data. The introduction of such type of particles is natural and does not contradict the basic axiom s of the quantum

eld theory. In the paper [1] we have shown that such type of particles exists as com – posite quark-antiquark hadron vector resonances. Based on this idea, the dynam ic properties of the vector m esons and the new m ass relations among the hadron vector resonances have been derived.

The prelim inary results of the PIBETA experim ent [2] on the radiative pion decay (RPD) may represent one of the main indications of the existence of such particles also on a fundam ental level. Using a simple phenom enological model we will show how these results can be interpreted.

#### 2 The tensor interactions

The radiative pion decay ! e is a unique system for searching physics beyond SM . Due to chirality suppression the usual electroweak interactions are very weak while new interactions, which do not preserve chirality of ferm ions, can be enhanced. However, the enhancem ent occurs only in a certain part of the kinem atically allowed region and, therefore, the previous experiments [3] have not detected the new inter-actions.

The rst experiment, which has alarmed about deviations from SM in RPD, was ISTRA experiment [4]. The RPD in ight was investigated in a wide kinematical region with dramatic conclusions for SM. It has been found that the measured number of events is about 30% smaller than the expected ones. This cannot be explained neither by radiative corrections [5] nor by SUSY extension of SM [6]. The interpretation of these results in the framework of SM leads to a huge violation of CVC hypothesis.

In order to describe this strange result a new interaction with a tensor lepton current

with  $F_T = (5.6 \ 1.7) \ 10^3$  was introduced [7]. Here  $G = G_F V_{ud}$  and " (q) is the photon polarization vector. The additional interaction helps to explain the lack of events with respect to SM prediction, caused by the destructive interference of the new term with inner-brem sstrahlung (IB) am plitude. Moreover, it leads to a correct events distribution over the D alitz plot.

Such type of a phenom enologically introduced amplitude can be induced by a four-ferm ion tensor interaction of quark and lepton currents

As far as tensor interm ediate bosons are absent in SM and its popular extensions, the conclusion was made that such type of interaction can be generated only by a leptoquark exchange [8]. However, according to the G rand Uni ed M odels (GUT) the leptoquarks should be very massive  $10^{15}$  G eV and, hence, their in uence at the electroweak scale should be negligibly sm all.

The introduction of the new tensor interaction (1) leads to another problem, following from the strong constraint on  $F_T$  [9] from pion decay ! e . On one hand the tensor interaction does not contribute directly to sem ileptonic two-particle pion decay ! e , due to kinem atical reasons. On the other hand, however, owing to electrom agnetic radiative corrections, the pseudotensor current u <sup>5</sup>d leads to a generation of a pseudoscalar quark current, to which the pion decay is very sensitive. As a result,  $F_T$  should be two orders ofm agnitude smaller than its required value for the explanation of ISTRA results.

To avoid this problem a new tensor amplitude

was introduced [10] in addition to (1). Here Q = (p q) is the momentum transfer to the lepton pair. This amplitude is generated by the following four-ferm ion tensor interaction

Since this interaction includes quark current with an opposite chirality to the one in (2), and also the interaction (2) can be identically rewritten as

then the pseudotensor term s u  ${}^{5}d$  cancel out in the sum of the eqs. (2) and (4), if  $f_T = f_T^0$ . The tensor term u d does not contribute to pseudoscalar pion decay due to parity conservation in electrom agnetic interactions.

Therefore, the t of experimental data with only one amplitude (1) is not acceptable because of the contradiction with present experimental data on pion decay. Consequently, it is not a surprise that the values  $F_T$  for ISTRA and PIBETA experiments, which run in dimenst kinematical regions, are diment.

# 3 Themodel

The sum of the interactions (2) and (4) is not the most general Lagrangian including di erent tensor currents. Follow ing the idea of renorm alizability one can generate the e ective four-ferm ion tensor interactions (2) and (4) by exchange of new chiral vector particles, which interact with matter only anom alously  $g_T T \hat{Q}$  (1 <sup>5</sup>), where  $\hat{Q} = \frac{p}{Q^2}$ . If these particles m ix with W -bosons, the latter could acquire the anom alous weak moment introduced in [11]. Hence, the most general interaction of W -boson can be written in the form

introducing in general three new independent parameters  $g_e^T$ ,  $g_V^T$  and  $g_A^T$ . It leads e ectively to venew four-ferm ion interactions

with only three independent parameters. In order to get the amplitude of RPD it is necessary to calculate the following matrix elements for - transition

which can be parametrized by three form factors  $F_V^0$ ,  $F_A^0$  and  $F_T^0$ . These form factors weakly depend on the square of momentum transfer to the lepton pair  $Q^2 = (p - q)^2$  and can be taken as constants.

A sum ing CVC hypothesis, the vector form factor  $F_v^0$  is directly related to the <sup>0</sup>! am plitude and can be extracted from the experimental width of this decay

This value is in fair agreem ent with the calculations in the relativistic quark model (RQM) and with the leading order calculations of the chiral perturbation theory (CHPT)

where  $F = (130.7 \quad 0.4)$  M eV is the pion decay constant.

An axial form factor  $F_A^0$  '  $0.4F_V^0$  has been measured in previous experiments [3] in the kinematical region where the contribution of new tensor terms is not essential. This value is also in agreement with the calculations in CHPT [12].

The tensor form factor  $F_T^0$  can be calculated by applying the QCD sum rules techniques [13] and the PCAC hypothesis

here =  $(5:7 \ 0:6) \ \text{GeV}^2$  is the magnetic susceptibility of the quark condensate and its vacuum expectation value is h0 jqgDi  $(0.24 \ \text{GeV})^3$ .

The most general matrix element for radiative pion decay

can be rewritten through four form factors  $F_V$ ,  $F_A$ ,  $F_T$  and  $F_T^0$  [14]. Here the rst term " ! #

is a QED radiative correction to the ! e decay (IB) and it does not depend on any form factors. The structure-dependent amplitude

is parametrized by two form factors  $F_V$  and  $F_A$ . However, due to mixed tensor-vector interactions (second term in (7)) the form factors  $F_V$  and  $F_A$  are not constants anym ore and depend on  $Q^2$  in a speci c way

The expressions for the tensor amplitudes M  $_{\rm T}$  and M  $_{\rm T}^0$  coincide with (1) and (3), but the form factors F  $_{\rm T}$  and F  $_{\rm T}^0$  are not constants. In our model they have strong Q  $^2$  dependence and due to vector-tensor mixed interactions (third term in (7)) they depend also on the vector F  $_{\rm V}^0$  and the axial-vector F  $_{\rm A}^0$  form factors as well

## 4 The decay rate

In the general case the decay rate depends on the squares of the am plitudes and their various interference term s. In our case, when the electron m ass is vanishingly sm all, the interference between the SD am plitude on the one hand, and the IB am plitude or the tensor am plitudes on the other hand, can be safely neglected.

In this approxim ation the di erential decay width is

In the pion rest frame the variables x and are defined as x = 2E = m and  $= 2E_e = m \sin^2(e_e = 2)$ .

To analyse the contribution of the new terms into the decay rate (18) one can use the analytical expressions for the D alitz plot densities (19) and the form factors dependences (16) and (17). The squared momentum transfer to the lepton pair  $Q^2 = m^2 (1 \ x) \ m_e^2$  is constrained from below and the maximale ects of the new terms on  $F_V$  and  $F_A$  reveal exactly at this low limit. In other words, the events with the maximal photon energy x ' 1 represent the interesting region of the D alitz plot, where the new terms select is maximal. To avoid the contradiction with the discussed constraint from the pion decay ! e , the anom alous axial coupling constant  $q_i^T$  should be very small. Hence, for thing one can use actually only two of the three independent parameters.

In the case when the anom abus tensor coupling constant  $g_V^T$  is negative, one can get e ectively lower value for the vector form factor  $F_V$  than the CVC predicted one. Noticeably, exactly such e ect has been observed in ISTRA [4] and PIBETA [15] ts.

A nother manifestation of the new interactions can be observed as a destructive interference between the IB amplitude and the amplitudes with the tensor lepton currents at x ' 1. This result immediately follows from the expressions (17) for the tensor form factors, in case the natural universality hypothesis about the sign of the tensor coupling constants  $g_e^T$  and  $g_V^T$  is accepted. The e ect of the destructive interference is the maxim alone at ' 0.

#### 5 Conclusions

In this paper we present a simple model for an explanation of ISTRA and PIBETA results on the radiative pion decay. A smalladm ixture of anom abus couplings for the W -boson interactions with a speci c form (6) allow sto explain the essential features of the observed deviations from SM in these experiments. Hopefully, the correct thing according to this model of experimental data of high statistics PIBETA experiment will reveal new directions for probing physics beyond the Standard M odel.
