! Interference in J= Decays and ! + ⁰ Decay

A bstract W e study ! interference by analyzing J = ! + 0.0. PDG-2002 data on J = decays into PP and PV (P denotes pseudoscalar m esons; V, vector m esons) are used to t a generic m odel which describes the J = decays. From the ts, we obtain anom alously large branching ratio Br(0 ! $^{+}$ 0) 10 3 10 2 . A theoretical analysis for it is also provided, and the prediction is in good agreement with the anom alously large Br(0 ! $^{+}$ 0). By the t, we also get the 0 m ixing angle = 19:68° 1:49° and the constituent quark m ass ratio m $_{u}$ =m $_{s}$ 0:6 which are all reasonable.

1 introduction

Recently it has been predicted in ref.^[1] that there is a large isospin symmetry breaking enhancement e ect in the decay ⁰! ⁰ comparing with ! due to !-interference, which was called as hidden isospin-breaking e ects in ^[1]. This prediction has been commed by the renewed data in PDG-2002^[2]. Following the discussion of ^[1], it could be expected that a similar large hidden isospin-breaking e ect should also exist in ⁰! 3 due to ! interference. In this paper we try to analyze J= ! (⁰;!)(^o; ; ⁰)! (3)(⁰; ; ⁰), and to reveal !-interference e ect and then nally to abstract out the branching ratio of ⁰! 3. Such an analysis should be necessary for further comming the enhancement e ects mentioned above, and be also interesting for the G-parity violating process studies.

It is very di cult to directly measure B $_{\rm r}$ (0 ! 3) experimentally both because >> (m $_{\rm l}$ m) and because the G-parity conserving decay mode of ! ! 3 is dominate. This is the reason why there is still no a reliable value for B $_{\rm r}$ (! 3) yet so far in the literature²¹⁽³⁾. Fortunately, this quantity can be obtained by tting the data of J= ! PP and PV (where P

denotes the pseudoscalar m eson nonet (;K;;⁰), and V, the vector m esons (;!;K;))^[4]. A ctually, m ore than freen years ago, B_r(⁰! 3) was estimated in ref.^[4] by using the MARK – III data of (J= ! PP; PV)-decays with P = (;K) and V = (;!;K). However, people including the authors of ref.^[4] does not think their result of B_r(⁰! 3) is very reliable (see the discussion in ref.^[4] and ref.^[2]). The reasons are multiply, and some of them may be as follows: 1, the J= -decay data quality at that time was not good enough; 2, the tting is not complete because the processes of (J= ! V; ⁰V; P) were not considered; 3, lacking a theoretical understanding why their result is so signi cantly di erent from the result of ref.^[3] which is quoted by PDG^[2]. Our motive of this paper is to try to solve those problem s: 1, W e shall use now adays data of (J= ! PP; PV) in PDG -2002^[2] to perform the t; 2, (J= ! V; ⁰V; P) will be considered in our analysis; 3, And the rationality of the result will be argued, i.e., we'll see that the result is just consistent with the theoretical analysis in ref.^[1].

The contents of the paper are organized as follows. In section 2 we describe the ! interference in the process J = ! + 0 0, and give the the branching ratio form ulas for (J ! PP; PV). In section 3, by using the PDG-2002 J = decay data and the form ulas given in the section 2 we perform the datum ts. The Br(0 ! + 0) is obtained. The section 4 is devoted to estimate Br(0 ! + 0) by theoretical analysis. Finally, we brie y discuss the results.

2 ! Interference and branching ratios of J= decays into PV and PP

The elusive 0 ! $^{+}$ 0 decay could be observed in J= decays into the $^{+}$ 0 0 nal state^[4]. Indeed, this decay can proceed through the interfering channels J= ! ! 0 ! $^{+}$ 0 0 and J= ! 0 ! $^{+}$ 0 0 . Because J= ! 0 is caused both by strong interaction via 3 gluons and by electrom agnetic (EM) interaction and J= ! ! 0 is caused by EM interaction merely, the passibility of the decay J= ! 0 is much larger than one of J= ! ! 0 , i.e., (J= ! 0) >> (J= ! ! 0) (by using the 2002-PDG data^[2] we have (J= ! 0) ' 2:5 10^{2} (J= ! ! 0)). Consequently, even though (! ! $^{+}$ 0) may be much larger than (! $^{+}$ 0), it is stillhopefulto measure (! $^{+}$ 0) by studying the !-interference e ects in the process of J= ! $^{+}$ 0 0 .

To J= ! (;!) ⁰ ! 3 ⁰, the corresponding s-dependence B reit-W igner is written as^[4] F (s) $BW_{!}(s) + e^{i \beta W}(s)$, where

is the norm alized B reit-W igner curve for i = !, resonance with the mass of m_i and total width of $_i$. The factor (⁰) is the modulus (phase) of the amplitude proceeding through the resonance relative to ! resonance, which can be written as:

The third term of the expression (3), $2 \cos^{0}(\frac{p_{\frac{1}{2}}}{p_{\frac{1}{2}}})$, is the ! interference term . A coording to ref.^{[4]1}, the phase ⁰ is equal to zero, and the interference e ect produces a m agni cent factor as a whole (we assume that the ! resonance contribution is one), ie.

where ' 16 $\frac{2}{2}$ has been used. Then, the interference between and ! in the J= ! 4 provides a relation as follows

The BR (J= ! ! () 0 ! 4) can be detected directly in experiments, but there is no a direct experiment way to measure BR (J= ! ! 0 ! 4) in the right hand side of the above relation. Fortunately, it can be got by thing the branch ratios of J= ! PP and PV (where P and V denote pseudoscalar- and vector mesons respectively)^[4]. As both BR (J= ! ! () 0 ! 4) and BR (J= ! ! 0 ! 4) are known, we will have by Eq.5 and then obtain desired quantity BR (0 ! 3) via Eq.2.

Decays of J= into (PV) and into (PP) can be factorized by a very simple and general consideration described as follow $s^{[4]}$. The decays proceed through a strongly interacting three-gluon (ggg) interm ediate state and through electrom agnetic interaction m ediated by one photon and (gg) states. In the gluonic case, there are two I = 0 transitions cc ! ggg ! $\frac{(uu+d)}{p-2}$ and

cc! ggg! ss, which are proportional to the am plitude A and $\frac{A}{2}$ respectively. The parameter accounts for avor-SU (3) breaking e ect. The electrom agnetic transitions generate the I = 1 state $\frac{(uu - dd)}{p}$ and two I = 0 states ($\frac{(uu + dd)}{p}$ and ss). Their am plitude are proportional to 3a; a and $\frac{p}{2}$ a respectively. The avor space wave functions for P including and ⁰ read

where is their relative phase between A and a, and the parameter A and a are real. In the Eq.24 the ! interference e ect is subtracted from the branching ratio of $J = ! ^{0}$. In the Eq.27, a m agnicent factor $1 + ! ^{2}$ has been added due to Eq.5 in order to taking the ! interference e ects into account. A ctually, through directly detecting the data of J = ! 4 one can only get Br(! (0) ⁰) rather than Br(! ⁰) which is equal to $f_{v}^{2} 9a^{2}$.

In the branching ratio form ulae of Eqs. 21-33 we do not write out the corresponding phasespace factors explicitly which are proportional to the cube of the nalmomenta in two-body decays. They will be taken into account in the practical phenomenological t later.

3 Datum t to obtain BR ($!^{+}$ ⁰)

Let's now use the data in PDG-2002^[2] to perform the t to all branching ratios of Eq.21-33. This t will lead to determ ining the and BR (! ⁺ ⁰). The experimental branching ratio data of PDG-2002 are listed in the second column of Table 1.

Firstly, following ref.^[4], we use the branch ratio data of $(J = ! PP; V({}^{0};K))$ only to perform a t to Eqs. 21–27 (call it as $(PP;V({}^{0};K))$) thereafter). In this case, there are seven equations with six adjustable free parameters a; A; ; ; f_V ; , and hence it is an over-determ ination problem with potential of predictions. The twith minimum ${}^2 = 0.46$ leads to the values of the parameters and seven corresponding branching ratios listed in the third column of Table 1, in which $(! {}^{0})_{un \, cor}$ and $(! {}^{0})_{cor}$ represent $Br(J = ! ! () {}^{0}! 4$) and $Br(J = ! ! {}^{0}! 4$) respectively, i.e.,

In the t (see Table 1), we have $(! ^{0})_{un cor} = (4.2 \ 0.61) \ 10^{-4}$, $a = 0.21 \ 0.02$, $A = 2.94 \ 0.72$ and the interference factor $= 0.71 \ 0.58$, then we obtain $(! ^{0})_{cor} = f_{v}^{2} 9a^{2} = (1.89 \ 0.83)$ 10^{-4} . In other hand, from Eqs.(2) (11) (14), reads

Substituting the a ; A and values obtained from the t (see the third column of Table 1) and experiment data of Br(! ! 3) into Eq. 34 and Eq. 36, we then obtain the (PP;V(0 ;K)) t's results as follows

TABLE 1: The second column displayed the experim ental values for the branch ratios of J= ! PP and J= ! PV in PDG-2000 datum . The results of a t to the rst seven branching ratios is listed in the third column. The results of a t to the total thirteen branching ratios is listed in the forth column.

Secondly, we perform more complete datum t in which the processes of J = ! V and $J = ! V ^{0}$ are included. In this case, there are 13 equations (21-33) and eight free parameters: a; A; ; ; f_{V} ; ; ; r. And hence it is an over-determ ination problem with more constraints, and will be called as (P P; V (0 ; K; ; 0)) thereafter. The results are as follows

where ⁰ m ixing angle is agreem ent with one in ref.^{5][6]}, and both Br(J= ! ! ⁰)_{cor} and Br(! ^{+ 0}) are reasonable agreem ent with the results (37) (38) obtained by (PP;V(⁰;K)) t within the errors.

The parameter is the constituent quark mass ratio $m_u = m_s$ which should be about $0.6^{[6][7][8]}$ due to light avor SU (3)-breaking. The results of ' 0:6 0:1 for (PP;V(⁰;K)) t and ' 0:62 0:03 for (PP;V(⁰;K;;⁰)) t indicate the tsmeet this requirement, and, hence, the results yielded by them are rather reliable.

4 Large isospin breaking e ect in decay $^{0}!$ + 0

In this section, following ref.^[1], we provide a theoretical estimation to Br(0 ! + 0). Using Feynman propagators method, the on-shell amplitude^[1] of the decay ! + 0 is determined by

where, the momentum -dependent $^0\,$! interference amplitude $_{!}$ (q^2) is dened by the $\,$! interaction Lagrangian L $_{!}\,$ as follow s

The rst and second term of expression (42) correspond to the contributions of direct coupling (0 3) and ! resonance exchange respectively. Because m ' m_! and _! is small, the denom inator of the second term is small. Therefore, contribution from ! resonance exchange is large. This is called "hidden isospin symmetry breaking e ect" according to ^[1]. This e ect brings a signi cant contribution and plays an essential role in the decay ! + ⁰. So when we deal with the decay of ! + ⁰, the process ! !! + ⁰ must be considered.

In fact, the contributions of ⁰ ! interference are dom inant and the direct coupling can be om itted. The direct coupling f₃ / (m_d m_u), therefore, it is very small. In order to be sure of this point, we derive this quantity in a practical model called as U (2)_L U (2)_R chiral theory of mesons ^[9] in follows. Denoting the direct vertices of ⁰ 3 as L₃ = f₃ it ⁰ ⁰ ⁱ ⁰ ^j ^k, then f₃ can be calculated in this theory ^[9] and has the form

where the values of m odel's parameters m; g; c determ ined in ref.^[9] have been used. To the second term in the parentheses of expression (42), $\frac{1}{2}$ (m²) has be determ ined to approxim ate

4 10^{3} M eV² [10; 11]. ! ! 3 is the dom inant channel for ! decays, and hence f_{!3} can be estim ated by using the width _{!!3} = 7.5M eV. It's approxim ate value is about 3 10 ⁷M eV³. Thus the typical value of the second term in expression (42) is (5 + 2i) 10 ⁸M eV³ approximately. Comparing it with expression (44), we can see that the direct coupling f₃ is indeed very small, and it is ignorable. Therefore, discarding f₃ in expression (42), we have, approximately,

This equation means that the contributions due to ! interference to Br(0 ! 3) are dominate, or the hidden isospin-breaking e ects introduced in ${}^{[1]}$ are dominate for the process 0 ! 3 : From expression (45) we obtain desired result as follows

O ur experim ent datum tting result (40) is consistent with this theoretical estimation result. This fact indicates that both (PP;V(0 ;K)) t and (PP;V(0 ;K;; 0)) t are reasonable even though the resulting BR(0 ! 3) is much larger than one in ref.^[3] and rather closes the upper limit for it in ref.^[12].

5 D iscussion

Through the study presented in the above, we conclude that ! interference e ects can be detected in the J= ! + 0 decay, which receives a contribution from the ! + 0 decay mode. J= decays o er an almost unique opportunity for observing ! + 0, where the smallness of Br(! + 0)=Br(! ! + 0) is compensated by the large ratio A (J= ! 0)=A (J= ! ! 0) between a (simply Zweig-forbidden) strong am plitude over an EM one. This is the key point for the practical determ ining Br(! + 0) through employing J= decay branching radios. Our results for 2 datum - ts are Br(! 0)jp P;V(0;K;; 0) = (0:59 0:315) 10² respectively, which are anom abusly large and m atch each otherw ithin the errors.

In order to pursue whether these anom abusly large results of Br(! + 0) are reasonable or not, a theoretical estimation for ! interference e ects to the process of (! + 0) has also been discussed in this paper. Following ref.^[1], we found that the contributions due to so called hidden isospin-breaking e ects are dom inate for the process ! + 0. The theoretical prediction is BR (0 ! 3) ' 0.2 10 ² which is in good agreement with our datum - t results. Then, considering this fact and noting that both result of 0 angle and the result of constituent quark ratio = $m_u = m_s$ obtained by the ts are also reasonable, we conclude that Br(! + 0) 10 ³ 10 ² is reliable.

F inally, we like to argue that in order to reduce the error-bar of Br(! ^{+ 0}), m ore precisely experim entalm easurem ents to (J=! PP; PV) are expected. The high quality data for J= in the future BESIII would be useful.
