CP V iolation in the N eutral H iggs Sector of a N on-m in im al Supersymmetric Standard M odelwith M ultiple H iggs Singlets

Abstract

The possibility of CP violation is studied in the Higgs sector of a supersymmetric standard model with multiple Higgs singlets. The tree-level Lagrangian in this model is assumed to conserve the CP symmetry. We not that CP violation is viable in this model at the one-loop level, in an explicit way, if the radiative corrections from the third generation of quarks and squarks are taken into account. In the presence of explicit CP violation, at the one-loop level, the upper bound on the mass of the lightest neutral Higgs boson and the productions of the neutral Higgs bosons via the Higgsstrahlung process in high-energy e^+e^- collisions are calculated. We not that the upper bound on the mass of the lightest neutral Higgs boson increases as the number of Higgs singlets increases in a regulated manner. The production cross sections of the neutral Higgs bosons also show a reasonable increasing behavior with respect to the number of Higgs singlets.

I. IN TRODUCTION

The Standard M odel (SM) possesses a com plex phase in the C abbibo K obayashiM askawa (CKM) m atrix, but the size of the com plex phase in the SM , as determ ined by several precision experiment, is too small to account, in terms of the Sakharov mechanism [1], for the baryon asymmetry of the universe [2]. In this context, a study has been devoted to the possibility of explaining CP violation in the minimal supersymmetric standard m odel (M SSM) [3]. The supersymmetry (SU SY) itself is widely regarded as an essential ingredient for the new physics beyond the SM [4]. Supersymmetrically-extended standard m odels may have various sources of com plex phases, either explicitly or spontaneously. These com plex phases may arise from the H iggs sector during the spontaneous symmetry breaking or from radiative corrections at higher level. A lso, the soft SU SY -breaking terms, which are required as essential ingredients to construct the full Lagrangian density for practical analysis of the supersymmetric m odels, m ight be com plex.

The minimal supersymmetric standard model, which has no Higgs singlet and, thus, is the simplest version of supersymmetric standard model, has been investigated exhaustively with respect to various aspects of phenomenology [5], and the possibility of the CP violation [6]. It has been noticed that it can accommodate CP violation at the one-loop level, as complex phases in the soft SUSY -breaking terms may induce explicit CP mixings between the scalar and the pseudoscalar Higgs bosons in the neutral Higgs sector [7].

The Higgs sector of the M SSM m ay be enlarged by adding a Higgs singlet. This model is known as the next-to-M SSM, and m ight be referred to as the (M + 1)SSM. One of the motivations for the enlargement is to solve dynam ically the so-called dimensional -parameter problem in the M SSM by means of the vacuum expectation value (VEV) of the Higgs singlet. The (M + 1)SSM, including the CP phenomenology, has also been investigated by m any authors [8–10]. At the tree level, the (M + 1)SSM m ay contain at most one nontrivial CP phase after rede ning the Higgs elds. At the one-loop level, it is observed that there are noticeable elds of explicit CP violation in the (M + 1)SSM on the neutral and charged Higgs boson m asses, when radiative corrections due to relevant particles and their superpartners are taken into account [10].

A further extension of the M SSM with two additional H iggs singlets is also possible. This model m ight be referred to as the (M + 2)SSM. Actually, in the literature, some attempts

have been reported to study the viability of spontaneous CP violation in the H iggs sector of the (M + 2)SSM [11]. It has been found that, at the tree level, the spontaneous CP violation m ight occur in the H iggs sector of the (M + 2)SSM.

In principle, at the weak scale, the supersymmetrically-extended standard model, which has at least two Higgs doublets, may embrace additional Higgs multiplets. In other words, from the theoretical point of view, one may add an arbitrary number of Higgs singlets to the MSSM. Let us denote the MSSM with n additional Higgs singlets as the (M + n)SSM. In order for the (M + n)SSM to be theoretically interesting and consistent with experimental constraints, its phenom enological implications should be studied. With respect to the Higgs phenom enology, it should satisfy two important ingredients for the no-lose theorem to discover a neutral Higgs boson at the Linear Collider (LC), the future e⁺ e linear collider. O ne ingredient is that the lightest neutral Higgs boson should have a mass controlled by the electroweak scale, and the other is that at least one of the couplings of the Higgs bosons to a pair of Z boson is as large as that of the SM.

In Ref. 12, Espinosa and Quiros investigated the Higgs sector of the (M + n)SSM, under the assumption of CP conservation. They calculated the upper bound on the lightest scalar Higgs boson m ass in the (M + n)SSM by using the renorm alization group approach. A coording to their calculations, the lightest scalar Higgs boson m ass of the (M + n)SSM is smaller than 145 G eV, if the gauge couplings in the theory are assumed to remain perturbative up to a very large energy, which they take as the G rand U ni ed Theory scale = 10^{16} G eV. The upper bound on the lightest scalar Higgs boson m ass strongly depends on the scale . In fact, they found that the upper bound on the lightest scalar Higgs boson m ass increase from 145 G eV to 400 G eV, as changed from 10^{16} G eV down to 10^4 G eV.

We are motivated by the previous works of Ref. 12, where CP symmetry is conserved in the Higgs sector of the (M + n)SSM. In this article, we are interested in the possibility of CP violation in the Higgs sector of the (M + n)SSM. We would like to study whether the (M + n)SSM m ay accommodate complex phases in its Higgs sector for CP violation, while examining if the two above-mentioned phenomenological ingredients are, indeed, satisted by it. An absolute upper bound on the lightest neutral Higgs boson mass will be obtained, and the possibility of discovering the lightest neutral Higgs boson at the LC will be discussed.

The purpose of this article is not only to satisfy our theoretical curiosity about the (M + n)SSM but also to establish the phenom enological plausibility of the (M + n)SSM within

the context of CP violation. In this article, we study CP violation in the Higgs sector of the (M + n)SSM. By taking the vacuum expectation values (VEVs) of the neutral Higgs elds and the relevant parameters in the tree-level Higgs potential as real, we assume that at the tree level, the Higgs potential of the (M + n)SSM has no complex phase. CP symmetry may then be violated at the one-loop level in an explicit way as radiative corrections are taken into account. For radiative corrections, we consider only the contributions from the third generation of quarks and squarks.

We obtain the upper bound on the lightest neutral H iggs boson m ass in the (M + n)SSM for given n by allowing the relevant parameters to vary within reasonable ranges; The m ass depends evidently on n: The m ass is found to increase as n grows to 10, but does not exceed 220 G eV for larger n. This maximum value of the upper bound is constrained by the condition that the squared m asses of squarks be positive. Thus, production of the lightest neutral H iggs boson in the (M + n)SSM is kinematically allowed at the LC .W e, furtherm ore, investigate prospects for discovering the neutral H iggs bosons of the (M + n)SSM at the LC .The minimum cross section for producing any one of the neutral H iggs bosons of the (M + n)SSM in e⁺ e collisions via the H iggsstrahlung process is found to decrease as n increases.

This article is organized as follows: In the next section, we describe the H iggs potential of the (M + n)SSM and calculate the m asses of the neutral H iggs bosons in the explicit CP violation scenario at the one-loop level. We then calculate the production cross section of the neutral H iggs bosons via the H iggsstrahlung process at the LC. Conclusions are presented in the last section.

II. THE HIGGS SECTOR

The Higgs sector of the (M + n)SSM contains the two Higgs doublet super elds H₁^T = $(H_1^0; H)$ and $H_2^T = (H^+; H_2^0)$ of the MSSM and an additional n neutral Higgs singlet super elds N₁ (l = 1 to n). In term s of these Higgs super elds, the most general form of the superpotential of the (M + n)SSM may be written as

where $_{i}$ and k_{ij1} (i; j; l = 1 to n) are dimensionless coupling constants, and is the usual antisymmetric 2 2 matrix with $_{12} = _{21} = 1$. Here, for simplicity, the Yukawa couplings for the third generation are taken into account: The SU (2) doublet super eld Q^T = (t_L; b_L) consists of the left-handed quark super elds, the SU (2) singlet super elds t_{R}^{c} and b_{R}^{c} are the charge conjugate of the right-handed quark super elds of the third generation, and h_{t} and h_{b} are the top and the bottom Yukawa coupling constants, respectively.

At the tree level, the relevant H iggs potential of the (M + n)SSM consists of D term s, F term s, and soft term s as

where g_1 and g_2 are the U (1) and the SU (2) gauge coupling constants, respectively, ^ (¹; ²; ³) are the Paulim atrices, and $H_1^T = (H_1^0; H_1), H_2^T = (H^+; H_2^0)$, and N_1 (l = 1 to n) are, respectively, Higgs doublet elds and Higgs singlet elds. Note that the soft SU SY breaking m asses m_{H_1}, m_{H_2} , and m_{N_1} (i = 1 to n) are introduced in V_S , where A_i and $A_{k_{ij1}}$ (i; j; l = 1 to n) are the trilinear soft SU SY breaking parameters with a dimension of m ass. W e assume that the parameters in V⁰ are real. Thus, the CP symmetry is assumed to be conserved at the tree level.

The total number of degrees of freedom in the Higgs sector of the (M + n)SSM from two Higgs doublets and n Higgs singlets is 2n + 8. A fler the spontaneous breaking of electroweak symmetry, three of them are gauged away, becoming a neutral G oldstone boson and a pair of charged ones. The remaining 2n + 5 degrees of freedom correspond to 2n + 3 neutral Higgs bosons and a pair of charged Higgs bosons. In terms of the physical Higgs elds, after the spontaneous breaking of electroweak symmetry, the Higgs doublets and the n Higgs singlets

m ay be expressed as

where h_1 (l = 1 to 2n+3) are the neutral Higgs elds, C⁺ is the charged Higgs eld, and v_1, v_2, x_j (j = 1 to n) are the VEVs, respectively, of H₁, H₂, N_j (j = 1 to n). We assume that the VEVs are real. W ith the above form for the Higgs doublets, one may take the constraints $m_W^2 = g_2^2 v^2 = 2$ and $m_Z^2 = (g_1^2 + g_2^2)v^2 = 2$ for the electroweak gauge bosons with $v = {}^p \overline{v_1^2 + v_2^2} = 175 \text{ GeV}$. Note that tan is given by the ratio of the VEVs of the two Higgs doublets, $v_1 = v_2$.

Now, we consider higher-order corrections. The Higgs sector of supersymmetric models at the tree level is well observed to be significantly a lected by radiative corrections. The total Higgs potential at the one-loop level may be written as

where V¹ represents the one-loop corrections. The e ective potential method allows us to obtain V¹ as [13]

where M $_{q_1}^2$ (l = 1 to 4) and M $_q^2$ (q = b;t) are, respectively, the eld-dependent squark and quark m assess for the third generation, and is the renorm alization scale in the modi ed m inim al subtraction (\overline{MS}) scheme. We consider here the radiative corrections due to the bops of quarks and squarks of only the third generation.

Note that the squark terms are positive whereas the quark terms are negative in V^1 . Because of the opposite sign between the squark and the quark terms, they would exactly cancel out if the masses of the quarks and the squarks were equal. Then, there would be no contribution to V^1 . However, this is not the case because no squarks with masses comparable to quarks have been observed. Thus, we assume that the quarks and the squarks of the third generation have di erent masses, so the radiative corrections due to them should persist. The masses of the stop and sbottom quarks are obtained as

where m_Q , m_T , and m_B are the soft SUSY-breaking masses, and $m_t = h_t v_2$ and $m_b = h_b v_1$ are, respectively, the top quark mass and the bottom quark mass after the electroweak symmetry breakdown. The mixing between the two stop quarks is represented by X_t, and the mixing between the two sbottom quarks by X_b. The two stop quarks or the two sbottom quarks will be degenerate in mass if X_t or X_b vanishes. We assume that they are not degenerate. They are, respectively, given as

where A_t and A_b are the trilinear soft SUSY breaking parameters with a dimension of mass.

We assume that A_t and A_b are complex, and we denote their phases by t and b, respectively. If A_t and A_b are real, t and b will be absent in the above expressions. Their presence implies CP violation at the one-loop level. CP symmetry is assumed to be conserved at the tree level, as the VEVs of the neutral Higgs elds and the relevant parameters in V⁰ are taken as real. Now, CP symmetry is allowed to be broken explicitly at the one-loop level in the Higgs sector of the (M + n)SSM by complex A_t and A_b .

If CP symmetry is conserved at the tree level and is broken explicitly at the one-loop level in the (M + n)SSM, there are non-trivial CP-odd tadpole minimum conditions for the neutral imaginary parts of H₁, H₂, and N_j (j = 1 to n), namely, h₃ and h_(2j+3) (j = 1 to n). Thus, the number of CP-odd tadpole minimum conditions in the (M + n)SSM is n + 1. They read

A s can be seen from the structure of the above equations, the n+1 CP-odd tadpole m in imum conditions m ay be reduced into just one equation, namely,

Further, the soft SUSY -breaking m asses $m_{H_1}^2$, $m_{H_2}^2$, and $m_{N_j}^2$ (j = 1 to n) are eliminated by using the n+2 m inimum conditions.

The squared m assess of the 2n+3 neutral H iggs bosons, $m_{h_1}^2$ (l = 1 to 2n+3), are given by the eigenvalues of a m ass m atrix. These eigenvalues are obtained by the second derivatives of the H iggs potential with respect to the neutral H iggs elds h_1 (l = 1 to 2n+3), where the m inimum conditions are employed. The symmetric (2n+3) (2n+3) m ass m atrix for the neutral H iggs bosons, M_{ij}^2 , m ay be expressed in the basis of (h_1 , h_2 , ($_{2n}h_{3}$)). It is understood that, after diagonalizing the m ass m atrix, we sort the eigenvalues in increasing order by rearranging the neutral H iggs elds such that the (1,1)-element of the diagonalized m ass m atrix is $m_{h_1}^2$, the (2,2)-one is $m_{h_2}^2$, and so on. Thus, we implicitly assume hereafter that h_1 is not the neutral real component of the H₁ H iggs eld, but the lightest neutral H iggs boson, h_2 is not that of H₂ but the second lightest neutral H iggs boson, and so on.

Let us concentrate on the upper-left 2 2 sub-m atrix of M_{ij}^2 . It is mathem atically known that the upper bound on $m_{h_1}^2$ can be obtained from the upper-left 2 2 sub-m atrix of M_{ij}^2 , regardless of the remaining matrix elements. The upper bound on $m_{h_1}^2$ is then obtained as

It can be observed that $m_{h_1,m\,ax}^2$ depends on j (j = 1 to n). As $_1$ increases, $m_{h_1,m\,ax}^2$ increases. It is worthwhile noticing that, if we replace $P_{j=1,j}^n$ by and $P_{j=1,x_j}^n$ by x, the above expression for $m_{h_1;m\,ax}^2$ looks exactly the same as the corresponding formula for the upper bound on the lightest H iggs boson m ass in the (M + 1)SSM, where m and x are, respectively, the dimensionless coupling constant and the VEV of the H iggs singlet in the (M + 1)SSM.

Now, in order to obtain the numerical value for $m_{h_1;max}^2$, one has to take the values of j and x_j (j = 1 to n), as well as other relevant parameter values. For simplicity, we set $A_t = A_b$ and $m_Q = m_T = m_B$. We choose a region of parameter space dened by 2 tan 40, 0 < j 0:7, $0 < x_j; m_Q; A_t$ 1000 GeV (j = 1 to n), and =100 t; b 99 =100. We exam the random ly 10⁶ points in the dened region of the parameter space. For each point, we check if $m_{q_1} > m_t = 175$ GeV and if $m_{q_2} \notin m_{q_1}$ (q = t; b). The rst condition is physically justified because it makes $m_{h_1;max}^2$ more restrictive; and the second condition is required for numerical stability. If these two conditions are satisted, we then calculate $m_{h_1; m_{ax}}^2$. In this way, we obtain the upper bound on the mass of the lightest neutral H iggs boson in the (M + n)SSM for given n, which is an absolute upper bound in the sense that we exam ine the whole meaningful parameter space.

Figure 1 show sm $_{h_1;max}^2$ plotted against n, the num ber of H iggs singlets in the (M + n)SSM. As n increases, m $_{h_1;max}^2$ increases from 148 GeV for n = 1. However, notice that it does not grow inde nitely. We nd that it reaches 220 GeV for n= 15 and then very gradually decreases for n > 15. Thus, the universal upper bound on m $_{h_1}$ in the (M + n)SSM at the one-bop level for arbitrary num ber of H iggs singlets m ight be said to be 220 GeV.

The upper bound on m_{h_1} is actually set by the condition that the squared m asses of the scalar quarks should be positive. From the expressions for the squark m asses shown in Eq. 4, it is clear that $p_{\overline{X}_{q}}$ (q = t or b) m ight be restricted from above in order for the squared m asses of the scalar quarks to be positive. Since the maximum value of m_{Q} (= $m_{T} = m_{B}$) is on a SUSY -breaking scale (1000 GeV), $p_{\overline{X}_{q}}$ (q = t or b) m ust be smaller than (1000 GeV)². O therw ise, the electroweak symmetry breaking will not occur. M oreover, we have assumed that the lighter scalar quark m asses are larger than the top quark m ass.

We note that in the (M + n)SSM, one can impose two additional constraints on the parameter space. For any SUSY models in general, the heavier scalar quark masses must be smaller than the SUSY-breaking scale (1000 G eV). That is, an absolute di erence between the mass of any ordinary particle and the mass of its corresponding superpartner must be controlled by the SUSY-breaking scale. In particular, in SUSY models with Higgs singlets, the value of $\binom{P}{j=1} \binom{n}{j=1} \binom{P}{j=1} x_j$ is limited by the electrow eak scale m_{EW} 300 G eV. If these two conditions are further in posed on the parameter space, $m_{h_1; max}^2$ should be low ered from 220 G eV. In our calculations, these two constraints are not in posed. Thus, our result is a more conservative value.

For the other neutral H iggs bosons, one can obtain an upper bound on $m_{h_1}^2$ (l = 2 to 2n+3) as functions of $m_{h_1,max}^2$ and $m_{h_1}^2$. Let O be the (2n+3) (2n+3) orthogonalmatrix that diagonalizes the neutral H iggs boson m ass matrix. We now introduce

 $R_1 = O_{11} \cos + O_{12} \sin$

(l = 1 to 2n + 3). It is clear that 0 R_1^2 1 and that a kind of orthogonality condition, namely, $P_{l=1}^{(2n+3)}R_1^2 = 1$, is satisfied. The R_1 represent collectively the whole parameter

space of the (M + n)SSM. Thus, it is more convenient to consider them than examining the parameter space itself because a particular set of R_1 (l = 1 to 2n + 3) corresponds to a particular set of parameter values of the (M + n)SSM. In terms of R_1 (l = 1 to 2n + 3), the upper bounds on the squared m asses for the rest of neutral H iggs bosons are known to be given by

for l = 2 to 2n+3.

In the (M + n)SSM, we expect that $Z Z h_1$ (l = 1 to 2n + 3), the coupling of a neutral H iggs boson to a pair of neutral gauge bosons, to decrease if n increases because the dimension of the neutral H iggs boson m assmatrix increases by two for each additional H iggs singlet. Thus, for example, the production cross section of a neutral H iggs boson via the H iggsstrahlung process e⁺ e ! $Z h_1$ in e⁺ e collisions decreases if n increases. In fact, the production cross section via the H iggsstrahlung process gets smaller if m ore H iggs singlets are added to the m odel (a large number of singlets is predicted in some string m odels) or if there is CP violation w ith a m ixing of scalar and pseudoscalar H iggs bosons [14].

Now, let us consider the possibility of discovering any one of the neutral H iggs bosons in the (M + n)SSM at the LC.W e calculate the production cross sections of neutral H iggs bosons via the H iggsstrahlung process in e⁺ e collisions. For the center of m ass energy of the future LC, we take p = 500 GeV, 1000 GeV, and 2000 GeV.

W hether or not any one of h_1 (l = 1 to 2n + 3) m ight be produced via the H iggsstrahlung process with realZ is determined by the threshold energy of E_T = m_Z + h₁. For the LC with $p_{\overline{s}} = 500, 1000$, and 2000 G eV, h_1 production is kinematically allowed because m_{h1} < 220 G eV. If the production cross section of h_1 via the H iggsstrahlung process is small, one should then examine whether any of the other h_1 (l = 2 to 2n+3) has a production cross section large enough to be detected at the LC.

Let $_{SM}$ (m) be the production cross section for the SM Higgs boson of mass m via the Higgsstrahlung process at a given center of mass energy. Then, in the (M + n)SSM, the production cross section $_1$ (l = 1 to 2n+3) for the l-th neutral Higgs boson via the Higgsstrahlung process at a given center of mass energy is given by

In particular, the production cross section for the heaviest neutral Higgs boson may be written as

Since the production cross section via the Higgsstrahlung process decreases as the neutral Higgs boson m ass increases, we have for any of them

Hence, for given m $_{h_1}$ and R $_1$ (l = 1 to 2n+3), $_1$ (m $_{h_1}$) satisfy

and so on. The minimum values, l_{min} (l = 1 to 2n+3), depend on m_{h_1max} and R_1 (l = 1 to 2n+3) such that

and so on, because $m_{h_1m}^2$ depend on R_1 (l = 1 to 2n+3). Examining these 2n+3 values l_{min} (l = 1 to 2n+3), we may determ ine the possibility of detecting one of the 2n+3 H iggs bosons in e^+e^- collisions.

For given n, $m_{h_1,m_{ax}}$ is xed between 148 and 220 GeV. Then, for each n and for given R_1^2 between 0 and 1, we random ly generate R_1^2 (l = 2 to 2n+3) between 0 and 1 with the constraint $P_{l=1}^{(2n+3)} R_1^2 = 1$ in order to calculate $l_{m_{in}}$ (l = 1 to 2n+3). A ctually, this job is equivalent to exploring the whole parameter space of the (M + n)SSM. Am ong the 2n+3 $l_{m_{in}}$ (l = 1 to 2n+3) for given n, let us select the largest one and denote it as

This value is the minimum production cross section, above which at least one of the 2n+3 neutral H iggs bosons is produced via the H iggsstrahlung process in e^+e^- collisions. If we select, on the other hand, the smallest of them, it is the minimum production cross section,

above which all of the 2n+3 neutral H iggs bosons are produced via the H iggsstrahlung process in e^+e^- collisions.

We rst set n = 1, and check the consistency of our analysis with previous studies in the (M + 1)SSM. In the (M + 1)SSM, there is only one Higgs singlet and veneutral Higgs bosons. We plot in Fig. 2 $^{max}(R_1^2)$ in the (M + 1)SSM with explicit CP violation as a function of R_1^2 , for $^{p}s = 500$, 1000, and 2000 GeV. Our results are consistent with previous studies. For $0 R_1^2$ 1, that is, for the entire parameter space of the (M + 1)SSM, the $^{max}(R_1^2)$ seem s to be well-behaved.

From Fig. 2, we nd that the $^{max}(R_1^2)$ in (M + 1)SSM at $^{P}\bar{s} = 500 \text{ GeV}$ is no smaller than 10 fb. This implies that at least one of the veneutral Higgs bosons in the (M + 1)SSMmight be produced in e⁺ e collisions for a certain set of parameter values of the (M + 1)SSM, with its production cross section being larger than 10 fb. If the cm. energy of the e⁺ e system increases, we nd that the minimum value of $^{max}(R_1^2)$ in (M + 1)SSM decreases: At $^{P}\bar{s} = 1000 \text{ GeV}$, $^{max}(R_1^2)$ is no smaller than 2.5 fb, and at $^{P}\bar{s} = 2000 \text{ GeV}$, $^{max}(R_1^2)$ is no smaller than 0.6 fb. Therefore, we may expect the integrated luminosity for 50 events of detecting one of the veneutral Higgs bosons in the (M + 1)SSM to be about 10 fb⁻¹ for the LC with $^{P}\bar{s} = 500 \text{ GeV}$, about 40 fb⁻¹ for the LC with $^{P}\bar{s} = 1000 \text{ GeV}$, and about 166 fb⁻¹ for the LC with $^{P}\bar{s} = 2000 \text{ GeV}$ if we assume that the e ciency of the machine is about 50%.

Now, let us consider the (M + n)SSM for n > 1. One may introduce a dimensionless parameter in order to investigate the size of the CP mixing between the scalar and the pseudoscalar Higgs bosons. This parameter is de ned in the (M + n)SSM by

The range of is from 0 to 1 because the R_1 (l = 1 to 2n+3) satisfy the condition of $P_{l=1}^{2n+3}R_1^2 = 1$. If = 0, there is no explicit CP violation in the Higgs sector of the (M+n)SSM. On the other hand, if = 1, CP symmetry is maximally violated by them ixing between the scalar and the pseudoscalar Higgs bosons. The maximal CP violation that leads to = 1 takes place when $R_1^2 = R_2^2 = R_3^2 = 1 = (2n+3)$. In the case of maximal CP violation, the neutral Higgs boson search is extremely di cult. A ctually, this can be seen in Fig. 2 for (M+1)SSM, where $\max(R_1^2)$ becomes smallest at R_1^2 = 1=5. In the (M+1)SSM where we have veneutral Higgs bosons and $R_1^2 = R_2^2 = \frac{2}{5}$, Rehem aximal CP violation

will take place when $R_1^2 = R_2^2 = \frac{2}{5} \neq 1=5$. We deduce from Fig. 2 that the minimum of $\max(R_1^2)$ occurs at R_1^2 1=5 in the (M + 1)SSM when the rest parameters R_j^2 (j = 2 to 5) also become incidentally about 0.2 during random generation between 0 and 1.

For each n > 1, we repeatly determ ine the minimum of $\max(\mathbb{R}_1^2)$ for $\mathbb{P}_s = 500, 1000$, and 2000 GeV. Our result is shown in Fig. 3, where the minimum of $\max(\mathbb{R}_1^2)$ is plotted against n for $\mathbb{P}_s = 500, 1000$, and 2000 GeV. We see that the minimum of $\max(\mathbb{R}_1^2)$ decreases monotonically as n increases: This is because the coupling coe cient of the Higgs bosons to the Z boson pair, at the ZZh_j vertex, decreases as n increases. For example, for $\mathbb{P}_s = 2000 \text{ GeV}$, the minimum of $\max(\mathbb{R}_1^2)$ is as small as about 0.08 fb for n = 15.

In Fig. 4, we plot the integrated lum inosity for 50 events of H iggs production against n in units of fb¹ for p = 500, 1000, and 2000 G eV, where the e ciency of the e⁺e⁻ collider is assumed to be about 50%. For example, for n = 15, the integrated lum inosity should be about 1084 fb¹ for the future LC with p = 2000 G eV in order to detect 50 events of H iggs production via the H iggsstrahlung process.

III. CONCLUSIONS

W e study the (M + n)SSM, a non-m inim al supersymmetric standard model with n Higgs singlets and examine the possibility of CP violation in the model. We assume the CP symmetry is intact at the tree level, but is explicitly violated at the one-loop level in the Higgs sector. CP violation is induced by the mixing between scalar and pseudoscalar Higgs bosons due to the radiative corrections that are contributed by quarks and squarks of the third generation. In the presence of CP violation at the one-loop level, we calculate the upper bound on the mass of the lightest of the 2n+3 neutral Higgs bosons and their productions via the Higgsstrahlung process in e⁺ e collisions at $\frac{P}{s} = 500, 1000, and 2000 \text{ GeV}$.

The results of our study for n = 1 are consistent with previous studies for the (M + 1)SSM. Our calculations yield an upper bound on the mass of the lightest neutral H iggs boson for n = 1 of about 148 GeV. The production cross section for at least one of the ve neutral H iggs bosons of the (M + 1)SSM via the H iggsstrahlung process in e^+e^- collisions at p = 500 GeV, according to our calculations, is no smaller than 10 fb.

We also study the model for other values of n > 1. The upper bound on the mass of lightest neutral Higgs boson increases up to 220 GeV for n = 15. This value of 220 GeV

m ight be a universal upper bound on the mass of the lightest neutral H iggs boson at the one-loop level in the (M + n)SSM for any number of H iggs singlets. This result suggests that the H iggs sector of the (M + n)SSM is regulated, showing no divergence or uncontrollable behavior for large n.

The possibility of discovering at least one of the 2n+3 neutral Higgs bosons in e^+e^- collisions via the Higgsstrahlung process was examined by calculating the minimum of the production cross section. We nd that the minimum of the production cross section decreases monotonically for p = 5 = 500 GeV, from about 10 fb for n = 1 to about 2.5 fb for n = 15. In terms of the luminosity, we require higher luminosity for the future LC if we try to discover at least one of 2n+3 neutral Higgs bosons in the (M + n)SSM via the Higgsstrahlung process for larger n. Our calculations suggest that an integrated luminosity of about 10 fb 1 for n = 1 to about 20 fb 1 for n = 15 is required in order to detect 50 events of Higgs production at a future LC with p = 500 GeV via the Higgsstrahlung process. We anticipate that a future LC with su cient luminosity will yield experimental clues that may tell us how many Higgs singlets may be accommodated in the supersymmetric standard model.
