

Looking for the Charged Higgs Boson

Abstract

This review article starts with a brief introduction to the charged Higgs boson ($H^\pm$) in the Minimal Supersymmetric Standard Model (MSSM). It then discusses the prospects of a relatively light $H^\pm$ boson search via top quark decay at Tevatron/LHC, and finally a heavy $H^\pm$ boson search at LHC. The viable channels for $H^\pm$ search are identified in both the cases, with particular emphasis on the $H^\pm \rightarrow t\bar{b}$ decay channel. The effects of NLO QCD correction in the SM as well as the MSSM are discussed briefly.

1 Introduction

The minimal supersymmetric extension of the Standard Model (MSSM) contains two Higgs doublets H_u^0 and H_d^0 , with opposite hypercharge $Y = \pm 1$, to give masses to the up and down type quarks and leptons. This also ensures anomaly cancellation between their fermionic partners. The two doublets of complex scalars correspond to 8 degrees of freedom, 3 of which are absorbed as Goldstone bosons to give mass and longitudinal components to the $W^\pm$ and Z bosons. This leaves 5 physical states: two neutral scalars h^0 and H^0 , a pseudo-scalar A^0 , and a pair of charged Higgs bosons $H^\pm$. While it may be hard to distinguish any one of these neutral Higgs bosons from that of the Standard Model, the $H^\pm$ pair carry a

distinctive hallmark of the MSSM. Hence the charged Higgs boson plays a very important role in the search of the SUSY Higgs sector.

1.1 Masses and Couplings

At the tree-level all the MSSM Higgs masses and couplings are given in terms of two parameters { the ratio of the vacuum expectation values, $\tan\beta = h_u^0/h_d^0$, and any one of the masses, usually taken to be M_A . The physical $H^\pm$ and A^0 states correspond to the combinations

$$\begin{aligned} H^\pm &= \frac{1}{\sqrt{2}}(h_u^\pm \cos\beta + h_d^\pm \sin\beta); \\ A^0 &= \frac{1}{\sqrt{2}}(h_u^0 \sin\beta - h_d^0 \cos\beta); \end{aligned} \quad (1)$$

while their masses are related by

$$M_{H^\pm}^2 = M_A^2 + M_W^2; \quad (2)$$

with negligible radiative corrections [1]. However, the neutral scalars get a large radiative correction from the top quark loop along with the top squark loop,

$$\Delta M_{A,H}^2 = \frac{3g^2 m_t^4}{8\pi^2 M_W^2} \ln \frac{M_{\tilde{t}}^2}{m_t^2}; \quad (3)$$

where $M_{\tilde{t}}$ denotes the average mass of the two top squarks ($\tilde{t}_{1,2}$). Including this radiative correction, the mass-squared matrix of the neutral scalars is given by

$$\begin{pmatrix} M_A^2 \sin^2\beta + M_Z^2 \cos^2\beta & (M_A^2 + M_Z^2) \sin\beta \cos\beta \\ (M_A^2 + M_Z^2) \sin\beta \cos\beta & M_A^2 \cos^2\beta + M_Z^2 \sin^2\beta + \Delta^0 \end{pmatrix}; \quad (4)$$

where $\Delta^0 = \Delta M_{A,H}^2 = \Delta M_{\tilde{t}}^2$. Thus the physical h^0 and H^0 masses correspond to the eigen values

$$M_{h,H}^2 = \frac{1}{2} [M_A^2 + M_Z^2 + \Delta^0 \pm \sqrt{(M_A^2 + M_Z^2 + \Delta^0)^2 - 4M_A^2 M_Z^2 \cos^2 2\beta}]^{1/2}; \quad (5)$$

The corresponding eigen vectors are the two orthogonal combinations of $\text{Re}(h_{u,d}^0)$ with mixing angle α , which diagonalizes this matrix, i.e.

$$\tan 2\alpha = \tan 2\beta \frac{M_A^2 + M_Z^2}{M_Z^2 - M_A^2 - \Delta^0} \cos 2\beta; \quad -\pi/2 < \alpha < 0; \quad (6)$$

For $M_A \gg M_Z$; $\Delta^0 \ll M_A^2$. Note that $M_{H^\pm}^2$ and $M_{A^0}^2 \approx M_A^2$, while the lighter scalar mass approaches a finite limit

$$M_h^2 \approx M_Z^2 \cos^2 2\beta + \Delta^0; \quad (7)$$

Finally there is an additional radiative contribution to this limit from $\tilde{t}_{L,R}$ mixing [1, 2],

$$\Delta m_{\tilde{t}}^2 = \frac{3g^2 m_t^4}{8\pi^2 M_W^2} \frac{X_t^2}{M_{\tilde{t}}^2} \left[1 - \frac{X_t^2}{12M_{\tilde{t}}^2} \right] - \frac{9g^2 m_t^4}{8\pi^2 M_W^2}; \quad (8)$$

Table 1: Important couplings of the MSSM neutral Higgs bosons h , H and A relative to those of the SM Higgs boson.

where $X_t = A_t \cot\beta$. Thus while $m_{H^\pm}$ is a function of the SUSY breaking trilinear coupling A_t and the Higgsino mass parameter μ , it has a constant upper limit (M_W^2), which is reached at $X_t^2 = 6M_t^2$. One can also check from (3) that M_W^2 for a SUSY breaking scale of $M_t \approx 1$ TeV. Adding the nonleading radiative contributions to eqs.(7) and (8) gives a limit on the light scalar mass

$$M_h^{MA} \approx M_Z \approx 118 \text{ GeV} (130 \text{ GeV}) \text{ at } \tan\beta = 3 \quad (30) \quad (9)$$

for the top quark pole mass of 175 GeV [1, 2].

Table 1 shows the important couplings of the MSSM neutral Higgs bosons relative to those of the SM Higgs boson. The limiting values of these couplings at large M_A are indicated by arrows. The important couplings of the charged Higgs boson, which has no SM analogue, are

$$\begin{aligned} H^\pm tb &: \mp \frac{g}{2M_W} (m_t \cot\beta + m_b \tan\beta); H^\pm &: \mp \frac{g}{2M_W} m_t \tan\beta; \\ H^\pm cs &: \mp \frac{g}{2M_W} (m_c \cot\beta + m_s \tan\beta); H^\pm W^\pm Z &: 0; \end{aligned} \quad (10)$$

with negligible radiative corrections.

The coefficients of the fermion mass terms of eq.(10) and Table 1 reflect the compositions of the respective Higgs bosons in terms of $\nu_{\tau d}$. It is clear from eqs.(2) and (10) that measurements of $H^\pm$ mass and couplings will determine the masses and couplings of the other MSSM Higgs bosons via the underlying parameters M_A and $\tan\beta$.

1.2 Indirect constraints on $\tan\beta$ and M_A

The $H^\pm tb$ Yukawa coupling of eq.(10) is ultraviolet divergent. Assuming it to remain perturbative upto the GUT scale implies

$$1 < \tan\beta < m_t/m_b \quad (50): \quad (11)$$

However this assumes the absence of any new physics beyond the MSSM upto the GUT scale { i.e. the so called desert scenario. Without this assumption one gets weaker limits from the perturbative bounds on this coupling at the electroweak scale, i.e.

$$0.3 < \tan\beta < 200: \quad (12)$$

Moreover there is a strong constraint on the M_A - $\tan\beta$ parameter space coming from the LEP-2 bound on the H_{SM} mass, which is also applicable to M_h at low $\tan\beta$, i.e. $M_h > 114$ GeV [2]. Comparing this with the MSSM prediction (9) implies $\tan\beta > 2.4$ for any value of M_A [1, 2] (see Fig. 4 below). Note however from eqs. (3),(7) and (8) that the MSSM prediction depends sensitively on the top quark mass. The recent increase of this mass from 175 to 178 ± 4.3 GeV [3] along with a more exact evaluation of the radiative correction [4] have resulted in a significant weakening of this constraint. In fact there is no LEP bound on $\tan\beta$ now, which would be valid for all values of M_A . Nonetheless it implies $M_A > 150$ GeV ($M_h > 170$ GeV) over the low $\tan\beta$ (< 2) region. But being an indirect bound, it depends strongly on the underlying model. There is no such bound in the CP violating MSSM due to h - A mixing [5]. Moreover there are singlet extensions of the MSSM Higgs sector like the so called NMSSM, which invalidate these M_A (M_h) bounds without disturbing the charged Higgs boson [6]. In fact there is an additional contribution to the tree-level mass relation (2) in the NMSSM, which permits $H^\pm$ to be even lighter than the $W^\pm$ boson. Therefore it is prudent to relax these indirect constraints on M_h and $\tan\beta$, and search for $H^\pm$ over the widest possible parameter space. It should be noted here that the $H^\pm$ couplings of eq.(10) continue to hold over a wide class of models. In fact the fermionic couplings hold for the general class of Type-II two-Higgs-doublet models, where one doublet couples to up type and the other to down type quarks and leptons [1].

1.3 Direct $H^\pm$ Mass Limit from LEP

Figure 1 shows a direct mass limit of $M_h > 80$ GeV from LEP-2, which is in agreement with the MSSM prediction (2). It is based on both the decay channels $H^\pm \rightarrow \tau^\pm \nu$ and $H^\pm \rightarrow t\bar{b}$ of eq.(10). Hence it is a robust limit, spanning the full $\tan\beta$ range of eq.(12). The limit is broadly restricted to the W mass region because of the $W^\pm W^\pm$ background. However one gets a slightly stronger limit (> 90 GeV) from the $H^\pm \rightarrow t\bar{b}$ channel, which is reflected in the $\tan\beta > 1$ region.

2 Search for a Light $H^\pm$ ($M_h < m_t$) at Tevatron/LHC

The main production mechanism in this case is top quark pair production

$$q\bar{q}; g\bar{g} \rightarrow t\bar{t}; \quad (13)$$

followed by

$$t \rightarrow bH^+ \text{ and/or } t \rightarrow bH^- : \quad (14)$$

The dominant decay channels of $H^\pm$ are

$$H^\pm \rightarrow cs; c^+ \text{ and } Wbb + hc; \quad (15)$$

where the 3-body final state comes via the virtual tb channel. All these decay widths are easily calculated from the Yukawa couplings of eq.(10). The QCD correction can be simply implemented in the leading log approximation by substituting the quark masses appearing in the Yukawa couplings by their running masses at the $H^\pm$ mass scale [7]. Its main effect is to reduce the b and c pole masses of 4.6 and 1.8 GeV respectively [2] to their running masses $m_b(M_H) \simeq 2.8$ GeV and $m_c(M_H) \simeq 1$ GeV. The corresponding reduction in the t pole mass of 175 GeV is only $\sim 5\%$.

The resulting branching ratios for the four decay processes of (14) and (15) are shown in Fig. 2 against $\tan\beta$ for a representative $H^\pm$ mass of 140 GeV. The $t \rightarrow bH^\pm$ branching ratio is seen to be large at $\tan\beta < 1$ and $\tan\beta > m_t/m_b$, which are driven by the m_t and the m_b term of the $H^\pm tb$ coupling respectively. However it has a pronounced minimum around $\tan\beta = m_t/m_b \simeq 7.5$, where the SM decay of $t \rightarrow bW$ is dominant. The $H^\pm$ is expected to decay dominantly into the cs channel for $\tan\beta > 1$, while the cs and the bbW channels dominate in the $\tan\beta < 1$ region. This can be easily understood in terms of the respective couplings of eq.(10). Note however that the $H^\pm \rightarrow bbW$ three-body decay via virtual tb channel is larger than the $H^\pm \rightarrow cs$ decay for $M_H > 140$ GeV, although the former is a higher order process [8, 9]. This is because the $H^\pm tb$ coupling is larger than the $H^\pm cs$ coupling by a factor of $m_t/m_c > 100$ in the low $\tan\beta$ region.

2.1 $H^\pm$ Search in the cs and bbW Channels ($\tan\beta < 1$)

One can look for a possible top quark decay into the $H^\pm \rightarrow cs$ channel in the Tevatron $t\bar{t}$ data in the leptonic and dileptonic channels using the so called indirect or disappearance method [10]. Here

$$\sigma_{t\bar{t}} = \sigma_{t\bar{t}}^{SM} (1 - B); \quad \sigma_{t\bar{t}} = \sigma_{t\bar{t}}^{SM} B^2 : \quad (16)$$

Using the QCD prediction for $\sigma_{t\bar{t}} = 5.55$ pb [11] and SM prediction for $B_{cs} = B(t \rightarrow (e; \mu)b) = 2/9$ one can predict the number of such events. In the presence of $t \rightarrow bH^\pm$ ($H^\pm \rightarrow cs$) decay channel one expects a reduction in B_{cs} and hence the number of $t\bar{t}$ events in the leptonic and dileptonic channels with respect to the SM prediction.

No such reduction was found in the $t\bar{t}$ data of the DØ [12] and CDF [13] experiments. The resulting exclusion region in the M_H - $\tan\beta$ parameter space is shown on the left side of Fig. 1. It is seen to exclude the $M_H < 130$ GeV, $\tan\beta < 1$ region, where the $H^\pm \rightarrow cs$ is the dominant decay mode. Indeed a comparison with Fig. 2 shows that the bulk of the parameter space for which $H^\pm \rightarrow cs$ is the dominant decay mode is already excluded by these data. This method is no longer applicable for $M_H > 140$ GeV, where $H^\pm \rightarrow bbW$ is the dominant decay mode. Here the signal consists of $t \rightarrow bbW$ events against the SM background of $t \rightarrow bW$, followed by either leptonic or hadronic decay of W . So one has to look for an excess of b tags in the $t\bar{t}$ events compared to the SM prediction [9]. With a large

number of $t\bar{t}$ events expected from the future Tevatron Runs and especially from the LHC one expects to use this method to extend the H probe to significantly higher values of M_H at low $\tan\beta$ (< 1).

2.2 H Search in the $\tau\tau$ Channel ($\tan\beta > 1$)

As discussed earlier the $\tan\beta > 1$ region is theoretically favoured. Fig. 2 shows that $H \rightarrow \tau\tau$ is the dominant decay mode over this region. Therefore the $\tau\tau$ channel is the most important channel for H search. The above mentioned disappearance (indirect) method is equally applicable to this channel. The resulting exclusion regions from the DØ [12] and CDF [13] experiments can be seen on the right side of Fig. 1. Evidently the disappearance method is not viable when the signal is $< 10\%$ of the SM background, since this is the typical uncertainty in the QCD prediction of $\sigma_{t\bar{t}}$. This explains why the resulting exclusion regions cover only extreme values of $\tan\beta$ (compare Fig. 2). In order to extend the probe to the theoretically favoured range of $\tan\beta = 1-50$, one has to directly search for the $t \rightarrow b$ events. Using the universality of W coupling one can easily predict the number of $t \rightarrow b$ events via W from that of $t \rightarrow b^*$ events. Since H couples only to the former any excess of $\tau\tau$ events over the universality prediction constitutes a signal for $t \rightarrow bH$ decay. The CDF group has used a small data sample in the inclusive $\tau\tau$ channel to search for the direct $t \rightarrow bH$ signal [14]. The resulting exclusion region can be seen on the right side of Fig. 1, which is roughly overlapping with that obtained via the indirect method. With the much higher event rates expected from future Tevatron Runs and LHC it will be better to use the $\tau\tau$ channel for H search instead of the inclusive $\tau\tau$, since the former is a cleaner and far more robust channel [15, 16]. It corresponds to the decay of one of the $t\bar{t}$ pair into $\tau\tau$ via W while the other decays into a $\tau\tau$ channel.

2.3 Polarization Effect

The discovery reach of the $\tau\tau$ channel for H search at Tevatron and LHC can be significantly enhanced by exploiting the opposite polarization of τ coming from the $H \rightarrow \tau\tau$ ($P = +1$) and $W \rightarrow \tau\nu$ ($P = -1$) decays [17]. Let us briefly describe this simple but very powerful method. The best channel for τ -detection in terms of efficiency and purity is its 1-prong hadronic decay channel, which accounts for 50% of its total decay width. The main contributors to this channel are

$$\begin{aligned} & \tau \rightarrow \pi \nu \quad (12.5\%); \quad \tau \rightarrow \rho \nu \quad (26\%); \\ & \tau \rightarrow a_1 \nu \quad (7.5\%); \end{aligned} \quad (17)$$

where the branching fractions of the π and ρ channels include the small K and K^* contributions respectively [2], which have identical polarization effects. Together they account for more than 90% of the 1-prong hadronic decay of τ . The CM angular distributions of τ decay into π or a vector meson $v (= \rho; a_1)$ is simply given in terms of its polarization as

$$\frac{1}{\Gamma} \frac{d\Gamma}{d\cos\theta} = \frac{1}{2} (1 + P \cos\theta);$$

$$\begin{aligned}\frac{1}{v} \frac{d_{vL}}{d\cos} &= \frac{\frac{1}{2}m^2}{m^2 + 2m_v^2} (1 + P \cos); \\ \frac{1}{v} \frac{d_{vT}}{d\cos} &= \frac{m_v^2}{m^2 + 2m_v^2} (1 - P \cos);\end{aligned}\quad (18)$$

where L;T denote the longitudinal and transverse polarization states of the vector meson [17, 18]. This angle is related to the fraction x of the lab. momentum carried by the meson, i.e. the (visible) γ -jet momentum, via

$$\cos = \frac{2x - 1 - \frac{m_{\gamma}^2 - m^2}{m^2 + 2m_v^2}}{1 - \frac{m_{\gamma}^2 - m^2}{m^2 + 2m_v^2}}; \quad (19)$$

It is clear from (18) and (19) that the signal ($P = +1$) has a harder γ -jet than the background ($P = -1$) for the $_{L}; a_{1L}$ contributions; but it is the opposite for $_{T}; a_{1T}$ contributions. Now, it is possible to suppress the transverse $_{T}$ and a_1 contributions and enhance the hardness of the signal γ -jet relative to the background even without identifying the individual resonance contributions to this channel. This is because the transverse $_{T}$ and a_1 decays favour even sharing of momentum among the decay pions, while the longitudinal $_{L}$ and a_1 decays favour uneven distributions, where the charged pion carries either very little or most of the momentum [17, 18]. Figure 3 shows the decay distributions of $_{L}; a_{1L}$ and $_{T}; a_{1T}$ in the momentum fraction carried by the charged pion, i.e.

$$x^0 = p_{\gamma} / p_{\text{jet}}; \quad (20)$$

The distributions are clearly peaked near $x^0 \sim 0$ and $x^0 \sim 1$ for the longitudinal $_{L}$ and a_1 , while they are peaked in the middle for the transverse ones. Note that the $\gamma \rightarrow \pi^+ \pi^-$ decay would appear as a δ function at $x^0 = 1$ on this plot. Thus requiring the γ to carry $> 80\%$ of the γ -jet momentum,

$$x^0 > 0.8; \quad (21)$$

retains about half the longitudinal $_{L}$ along with the pion but very little of the transverse contributions. This cut suppresses not only the $W \rightarrow \pi^+ \pi^-$ background but also the fake background from QCD jets¹. Consequently the γ -channel can be used for H search over a wider range of parameters. The resulting H discovery reach of LHC is shown on the left side of Fig.4 [19]. It goes upto $M_A \sim 100$ GeV ($M_H \sim 130$ GeV) around the dip region of $\tan \beta \sim 7.5$ and upto $M_A \sim 140$ GeV ($M_H \sim 160$ GeV) outside this region.

3 Search for a Heavy H ($M_H > m_t$) at LHC

The main production process here is the leading order (LO) process [20]

$$gb \rightarrow t\bar{t} + h, c; \quad (22)$$

The complete NLO QCD corrections have been recently calculated by two groups [21, 22], in agreement with one another. Their main results are summarized below:

¹Note that the $x^0 \sim 0$ peak from $_{L}$ and a_{1L} can not be used in practice, since γ -identification requires a hard γ , which will not be swept away from the accompanying neutrals by the magnetic field.

- (i) The effect of NLO corrections can be incorporated by multiplying the above LO cross-section by a K factor, with practically no change in its kinematic distributions.
- (ii) With the usual choice of renormalization and factorization scales, $\mu_R = \mu_F = M_H + m_t$, one gets $K \approx 1.5$ over the large M_H and $\tan\beta$ range of interest.
- (iii) The overall NLO correction of 50% comes from two main sources | (a) 80% correction from gluon emission and virtual gluon exchange contributions to the LO process (22), and (b) 30% correction from the NLO process

$$gg \rightarrow t\bar{t} b + h.c.; \quad (23)$$

after subtracting the overlapping piece from (22) to avoid double counting.

- (iv) As clearly shown in [22], the negative correction from (b) is an artifact of the common choice of factorization and renormalization scales. With a more appropriate choice of the factorization scale, $\mu_F \approx (M_H + m_t)/5$, the correction from (b) practically vanishes while that from (a) reduces to 60%. Note however that the overall K factor is insensitive to this scale variation.
- (v) Hence for simplicity one can keep a common scale of $\mu_{F,R} = M_H + m_t$ along with a K factor of 1.5, with an estimated uncertainty of 20%. Note that for the process (22) the running quark masses of the $H \rightarrow t\bar{t}$ coupling (10) are to be evaluated at μ_R , while the parton densities are evaluated at μ_F .

The dominant decay mode for a heavy H is into the $t\bar{t}$ channel. The $H \rightarrow W^+ W^-$ is the largest subdominant channel at large $\tan\beta$ (> 10), while the $H \rightarrow W^+ h^0$ can be the largest subdominant channel over a part of the small $\tan\beta$ region [1]. Let us look at the prospects of a heavy H search at LHC in each of these channels. The dominant background in each case comes from the $t\bar{t}$ production process (13).

3.1 Heavy H Search in the $t\bar{t}$ Channel

This constitutes the most important channel for a heavy H search at LHC in the large $\tan\beta$ region. Over a large part of this region, $\tan\beta > 10$ and $M_H > 300$ GeV, we have

$$BR(H \rightarrow t\bar{t}) = 20 \pm 5\%; \quad (24)$$

The H signal coming from (22) and (24) is distinguished by very hard b -jet and missing- p_T ($\cancel{p}_T$),

$$p_{jet}^T > 100 \text{ GeV and } \cancel{p}_T > 100 \text{ GeV}; \quad (25)$$

with hadronic decay of the accompanying top quark ($t \rightarrow bqq$) [23]. The main background comes from the $t\bar{t}$ production process (13), followed by $t \rightarrow b\bar{b}$, while the other t decays hadronically. This has however a much softer b -jet and can be suppressed significantly with the cut (25). Moreover the opposite polarizations for the signal and background can be used to suppress the background further, as discussed earlier. Figure 5 shows the signal and background cross-sections against the fractional b -jet momentum carried by the charged

pion (20). The hard charged pion cut of (21) suppresses the background by a factor of 5-6 while retaining almost half the signal cross-section. Moreover the signal γ -jet has a considerably harder p_T and larger azimuthal opening angle with the p_T in comparison with the background. Consequently the signal has a much broader distribution in the transverse mass of the γ -jet with the p_T , extending upto M_H , while the background goes only upto M_W . Figure 6 shows these distributions both with and without the hard charged pion cut (21). One can effectively separate the H signal from the background and estimate the H mass from this distribution. The LHC discovery reach of this channel is shown in Fig. 4, which clearly shows it to be the best channel for a heavy H search at large $\tan\beta$. It should be added here that the transition region between $M_H > m_t$ and $< m_t$ has been recently analysed in [24] by combining the production process of (22) with (13,14). As a result it has been possible to bridge the gap between the two discovery contours of Fig. 4 via the channel.

3.2 Heavy H Search in the tb Channel

Let us discuss this first for 3 and then 4 b-tags. In the first case the signal comes from (22), followed by

$$H \rightarrow tb; tb: \quad (26)$$

The background comes from the NLO QCD processes

$$gg \rightarrow t\bar{t}b; gb \rightarrow t\bar{t}b + h.c.; gg \rightarrow ttg; \quad (27)$$

where the gluon jet in the last case can be mistagged as b (with a typical probability of 1%). One requires leptonic decay of one of the t pair and hadronic decay of the other with a $p_T > 30$ GeV cut on all the jets [25]. For this cut the b-tagging efficiency at LHC is expected to be 50%. After reconstruction of both the top masses, the remaining (3rd) b quark jet is expected to be hard for the signal (22,26), but soft for the background processes (27). A $p_T > 80$ GeV cut on this b -jet improves the signal/background ratio. Finally this b -jet is combined with each of the reconstructed top pair to give two entries of M_{tb} per event. For the signal events, one of them corresponds to the H mass while the other constitutes a combinatorial background. Figure 7 shows this invariant mass distribution for the signal along with the above mentioned background processes for different H masses at $\tan\beta = 40$. Similar results hold for $\tan\beta = 1.5$. One can check that the significance level of the signal is $S/\sqrt{B} > 5$ [25]. The corresponding H discovery reaches in the high and low $\tan\beta$ regions are shown in Fig. 4. While the discovery reach via tb is weaker than that via the $\gamma\gamma$ channel in the high $\tan\beta$ region, the former offers the best H discovery reach in the low $\tan\beta$ region. This is particularly important in view of the fact that the indirect LEP limit shown in Fig. 4 gets significantly weaker with the reported increase in the top quark mass, as discussed earlier. Indeed this $H \rightarrow tb$ discovery contour constitutes the most robust discovery limit for the MSSM Higgs sector over the low $\tan\beta$ region. On the other hand the $H \rightarrow b\bar{b}$ contour is competitive with that from the $H \rightarrow A^0 \rightarrow \tau\tau$ channel as the best MSSM Higgs discovery limit over the high $\tan\beta$ region. Finally the corresponding $H \rightarrow b\bar{b}$ contour from $t \rightarrow bH^+$ decay, also shown in Fig. 4, constitutes the best discovery limit of the MSSM Higgs sector over the low M_A region (see e.g. Fig. 27 of ref.[1]).

One can also use 4 b-tags to look for the $H \rightarrow tb$ signal [26]. The signal comes from (23,26), and the background from the first process of (27). After the reconstruction of the $t\bar{t}$ pair, both the remaining pair of b-jets are expected to be soft for the background, since they come from gluon splitting. For the signal, however, one of them comes from the H decay (26); and hence expected to be hard and uncorrelated with the other b-jet. Thus requiring a $p_T > 120$ GeV cut on the harder of the two b-jets along with large invariant mass ($M_{bb} > 120$ GeV) and opening angle ($\cos \theta_{bb} < 0.75$) for the pair, one can enhance the signal/background ratio substantially. Unfortunately the requirement of 4 b-tags makes the signal size very small. Moreover the signal contains one soft b-jet from (23), for which one has to reduce the p_T threshold from 30 to 20 GeV. The resulting signal and background cross-sections are shown in Fig. 8 for $\tan \beta = 40$. In comparison with Fig. 7 one can see a significant enhancement in the signal/background ratio, but at the cost of a much smaller signal size. Nonetheless this can be used as a supplementary channel for H search, provided one can achieve good b-tagging for $p_T > 20$ GeV jets.

3.3 Heavy H Search in the $W h^0$ Channel

The tree level coupling for this channel is

$$H^+ W^- h^0 : \frac{1}{2} g \cos(\alpha) q_t; \quad (28)$$

where q_t is the h^0 momentum in the H^+ rest frame. The LEP limit of $M_{h^0} > 100$ GeV in the MSSM implies that the $H \rightarrow W h^0$ decay channel has at least as high a threshold as the tb channel. The maximum value of its decay BR,

$$B^{\max}(H \rightarrow W h^0) \sim 5\%; \quad (29)$$

is reached for H mass near this threshold and low $\tan \beta$. The small BR for this decay channel is due the suppression of the $H^+ W^- h^0$ coupling (28) by the q_t and the $\cos(\alpha)$ factors relative to the $H^+ tb$ coupling (10). Note that both the decay channels correspond the same final state, $H \rightarrow b\bar{b}W$, along with an accompanying top from the production process (22). Nonetheless one can distinguish the $H \rightarrow W h^0$ from the $H \rightarrow tb$ as well as the corresponding backgrounds (27) by looking for a clustering of the $b\bar{b}$ invariant mass around M_{h^0} along with a veto on the second top [27]. Unfortunately the BR of (29) is too small to give a viable signal for this decay channel. Note however that the LEP limit of $M_{h^0} > 100$ GeV does not hold in the CP violating MSSM [5] or the singlet extensions of the MSSM Higgs sector like the NMSSM [6]. Therefore it is possible to have a $W h^0$ threshold significantly below m_t in these models. Consequently one can have a H boson lighter than the top quark in these models in the low $\tan \beta$ region, which can dominantly decay into the $W h^0$ channel. Thus it is possible to have spectacular $t \rightarrow bH^+ \rightarrow bW h^0$ decay signals at LHC in the NMSSM [27] as well as the CP violating MSSM [28].

4 Concluding Remarks

Let me conclude by commenting on a few aspects of H boson search, which could not be discussed in this brief review. The associated production of H with W boson has been

investigated in [29], and the $H \rightarrow H$ and $H \rightarrow A^0$ productions in [30]. Being second order electroweak processes, however, they give much smaller signals than (22), while suffering from the same background. However one can get potentially large H signal from the decay of strongly produced squarks and gluinos at LHC, which can help to fill in the gap in the intermediate $\tan \beta$ region of Fig. 4 for favourable SUSY parameters [31].

Finally, the virtual SUSY contribution to the NLO correction for H production can be potentially important since it is known to be nondecoupling, i.e. it remains finite even for very large SUSY mass parameters. The reason for this of course is that the H mass is related to the superparticle masses in SUSY models (e.g. in minimal SUGRA model the H mass is of similar size as the sfermion masses). Therefore the two mass scales can not be decoupled. Consequently the calculation of virtual SUSY correction to H production has received a lot of attention [32, 33, 34]. The main contribution comes from the virtual squark-gluino exchange contribution to the H^+tb vertex. Its effect can be approximated by a renormalisation of the $t m_{b\bar{t}}$ factors in the corresponding coupling (10) by $1=(1+\delta_{b\bar{t}})$, where [1, 22]

$$\delta_{b\bar{t}} = \frac{2}{3} s_g (A_b + \tan \beta) I(m_{\tilde{b}1}; m_{\tilde{b}2}; m_g);$$

$$I(a; b; c) = \frac{a^2 b^2 \ln(a^2=b^2) + b^2 c^2 \ln(b^2=c^2) + c^2 a^2 \ln(c^2=a^2)}{(a^2 - b^2)(b^2 - c^2)(c^2 - a^2)}$$

$$1 = \max(a^2; b^2; c^2); \quad (30)$$

and there is a similar expression for $\delta_{t\bar{b}}$. Thus in the large $\tan \beta$ region, where the m_b term dominates the H^+tb coupling, and for $m_g \approx m_{\tilde{b}1,2}$, we get

$$\delta_{b\bar{t}} \approx \frac{2}{3} s_g \frac{\tan \beta}{m_g}; \quad (31)$$

which can be very large for $j \approx m_g$ [34]. On the other hand in most SUSY models of common interest we have $j \approx M_Z$ for naturalness, while $m_g \approx M_Z$. Therefore the above SUSY correction has only modest effect on H production in these models. Indeed a systematic study of this effect for the known mass points and slopes [35], carried out in [22], shows that the SUSY correction to the cross-section for the LO process (22) remains $< 20\%$ for $\tan \beta < 30$. This is true not only for minimal SUGRA but for other popular alternatives like gauge and anomaly mediated SUSY breaking models as well. As mentioned earlier, the theoretical uncertainty in the estimate of the NLO QCD correction (K factor) in the SM is also $\sim 20\%$ [22]. Therefore one need not worry too much about the effect of SUSY quantum correction on the H boson signal at LHC.

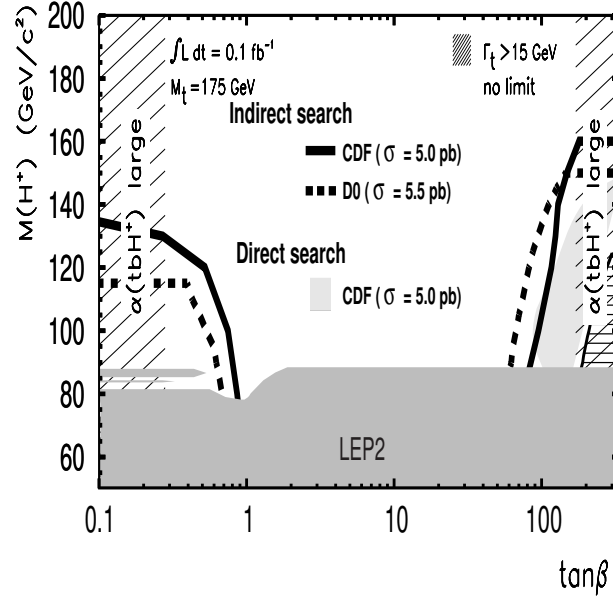


Figure 1: The 95% CL limits in M_H - $\tan \beta$ plane from LEP-2 (dark grey band) and Tevatron [2]. The Tevatron indirect search limits from D0 [12] and CDF [13] experiments are shown along with the direct search limit from CDF [14]. The cross-hatched regions at extreme values of $\tan \beta$ lie outside the perturbative bounds of eq.(12).

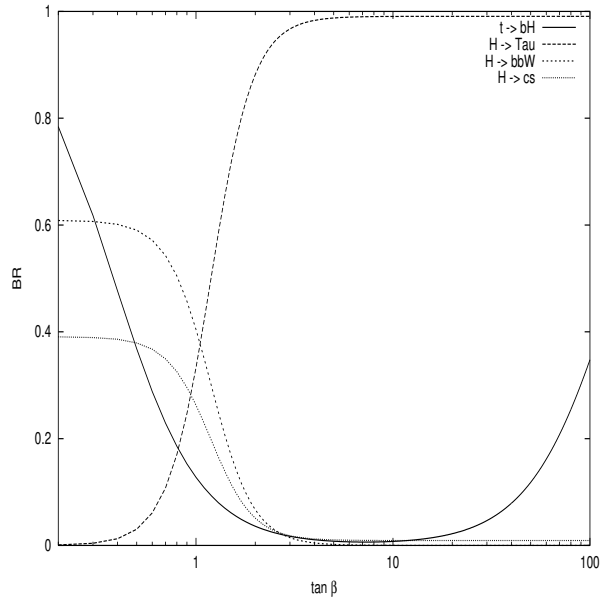


Figure 2: The Branching Ratio of top decay into a 140 GeV H boson (14) shown against $\tan \beta$ along with those for the three main decay modes (15) of this H boson.

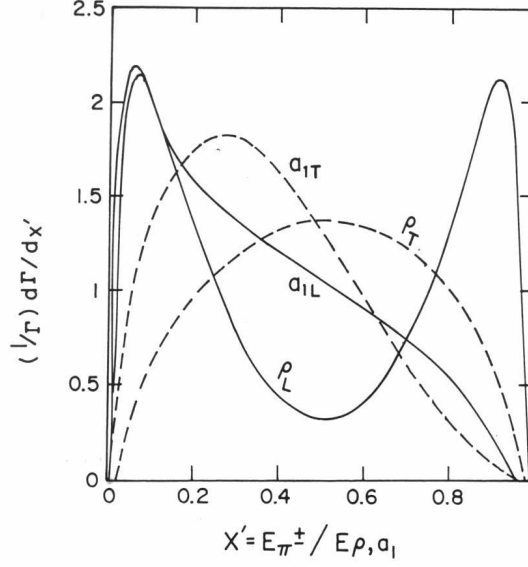


Figure 3: Distributions of the normalised decay widths of ρ_L and a_{1L} in the momentum fraction carried by the charged pion [17]. On this plot the ρ_T decay would correspond to a δ -function at $x' = 1$.

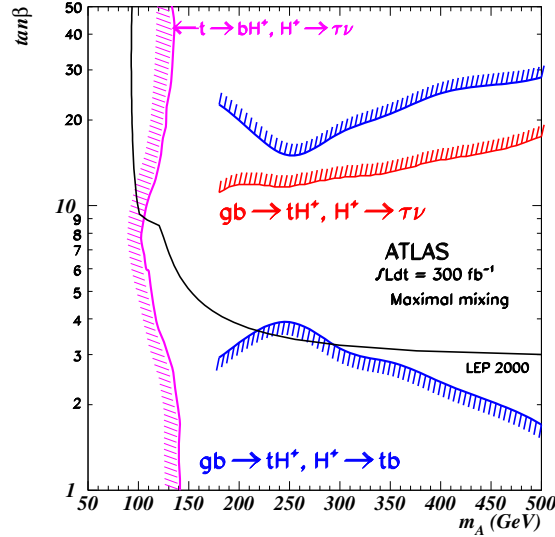


Figure 4: The 5- σ H boson discovery contours of the ATLAS experiment at LHC from $t \rightarrow bH^+; H^+ \rightarrow \tau\nu$ (vertical); $gb \rightarrow tH^+; H^+ \rightarrow \tau\nu$ (middle horizontal) and $gb \rightarrow tH^+; H^+ \rightarrow tb$ (upper and lower horizontal) channels [19]. One can see similar contours for the CMS experiment in the second paper of ref.[19]. The horizontal part of indirect LEP limit shown here has weakened significantly now as explained in the text.

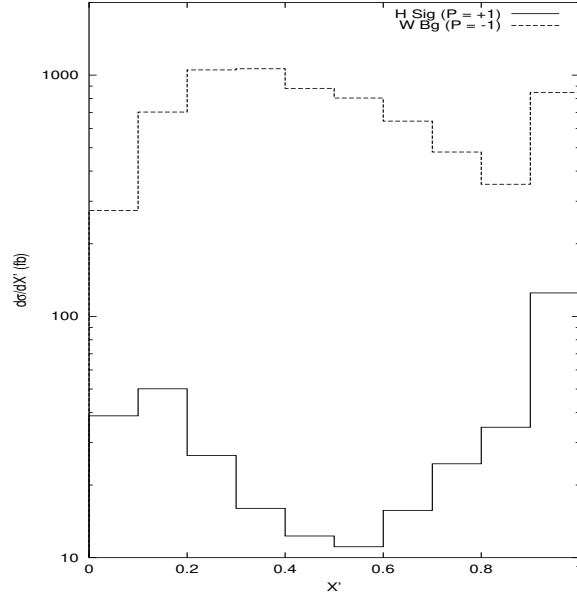


Figure 5: The LHC cross-section for a 300 GeV H^- signal at $\tan \beta = 40$ shown along with the $t\bar{t}$ background in the 1-prong $-\text{jet}$ channel, as functions of the $-\text{jet}$ momentum fraction carried by the charged pion.

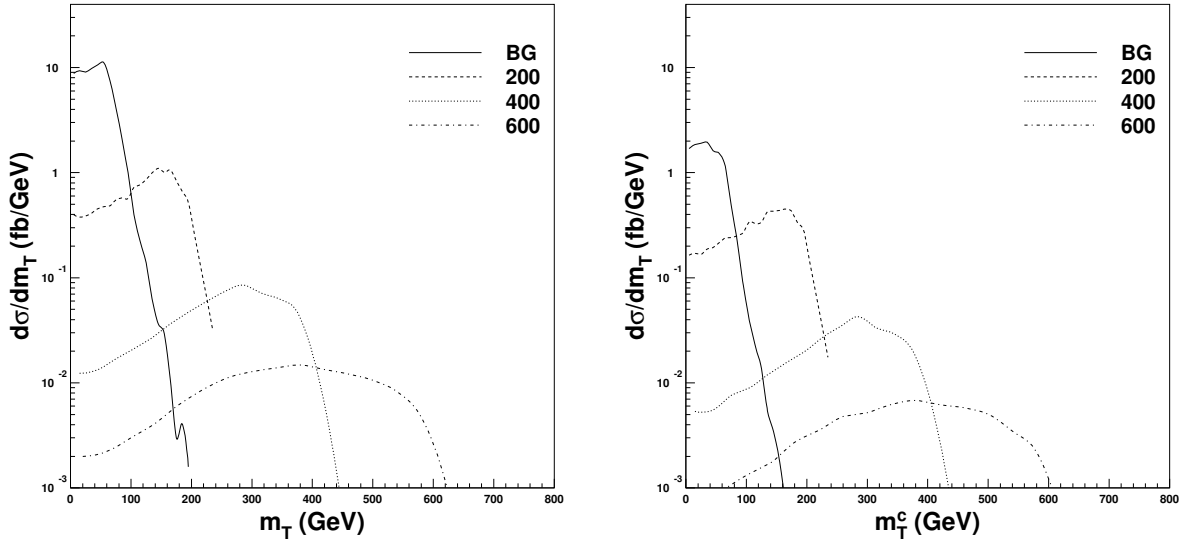


Figure 6: Distributions of the H^- signal and the $t\bar{t}$ background cross-sections in the transverse mass of the $-\text{jet}$ with p_T for (left) all 1-prong $-\text{jets}$, and (right) those with the charged pion carrying $> 80\%$ of the $-\text{jet}$ momentum ($M_H = 200, 400, 600$ GeV and $\tan \beta = 40$) [23].

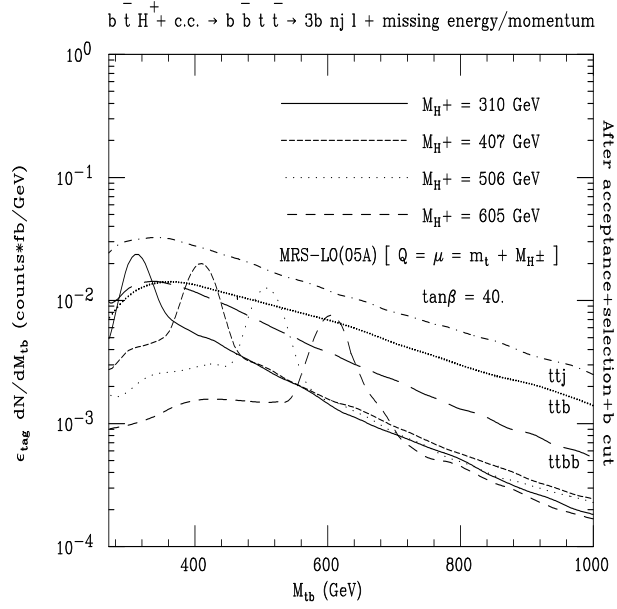


Figure 7: The reconstructed tb invariant mass distribution of the $H^\pm$ signal and different QCD backgrounds in the isolated lepton plus multijet channel with 3 b -tags [25].

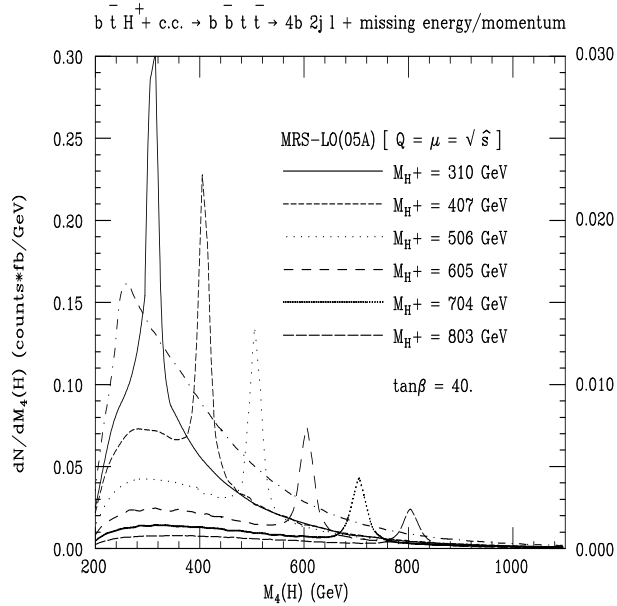


Figure 8: The reconstructed tb invariant mass distribution of the $H^\pm$ signal and the QCD background in the isolated lepton plus multijet channel with 4 b -tags [26]. The scale on the right corresponds to applying a b -tagging efficiency factor $\epsilon_b^4 = 0.1$.
