# A nalytic determ ination of the T phase diagram of the chiral quark m odel

A bstract. U sing a gap equation for the pion m ass a nonperturbative m ethod is given for solving the chiral quark-m eson m odel in the chiral lim it at the lowest order in the ferm ion contributions encountered in a large N<sub>f</sub> approximation. The location of the tricritical point is analytically determ ined. A mean eld potential is constructed from which critical exponents can be obtained.

## 1. Introduction

Due to the possibility of exploring parts of the phase diagram of strongly interacting matter in current (RHIC) or forthcoming (LHC, GSI) experiments, both numerical (lattice) and analytical investigations have recently received much attention. Theoretically, the phase boundary of QCD depends on the number of quark avors taken into account and the m assess of the quarks [1]. At vanishing chemical potential QCD with two massless quarks undergoes as a function of temperature a second order transition from a hadron to a quark-gluon dominated phase. At zero temperature and large values of the chemical potential the transition from hadronic

to m ore exotic phases is of rst order. W ith increasing tem perature, the line of the rst order transitions ends in a tricritical point (TCP). For non-vanishing m asses of the u and d quarks TCP becomes a critical end point (CEP) which separates the rst order line from a crossover line de ned by the locations of nite m axim a of some susceptibilities. The decreasing value of the strange quark has the same e ect as increasing the value of the chem ical potential, namely it turns the transition into a rst order one. Therefore, one can expect that for a physical value of the strange quark m ass the CEP in the T plane will be closer to the tem perature axis.

To locate TCP/CEP nonperturbative m ethods are required. First principle lattice investigations using MC m ethods based on importance sampling are m ade useless by the fact that the ferm ion determ inant in the partition function is complex at non-vanishing baryonic chem ical potential. To avoid this problem, recently new techniques were developed (for a review see e.g. [2]) to extract, in the =T . 1 region, information for nite from simulations at zero chem ical potential (multiparam eter rew eighting of observables, Taylor expansion of the ferm ion determ inant) or at imaginary chem ical potential, follow ed by analytical continuation w ith or w ithout Taylor expansion. U sing the multiparam eter rew eighting m ethod the CEP was obtained for  $n_f = 2 + 1$  dynam ical staggered quarks w ith physical m asses in [3]. The location of CEP was estim ated in the same range in [4] using an extrapolation based on simulation perform ed w ith 3 degenerate quarks.

A nalytically, the phase structure of QCD and the location of TCP/CEP can be obtained using the Schwinger-D yson approach [5] or the strong coupling expansion of the lattice action [6]. A lternatively, one can investigate e ective models of QCD [7]. Due to its low energy nature, an elective model might prove not satisfactory in giving the exact location of the endpoint and the shape of the phase boundary, but one can still expect to obtain some insight into the physics near TCP/CEP such as nonequilibrium dynamics. It can tell us what is the soft mode at the CEP, and by predicting species signatures [8] it may help inding its location. Traces of a possible overlap between the critical regions of TCP and CEP manifesting itself in the T plane as discussed in [9] could be in principle verified exponents as the system s pass closer and closer to CEP.

The outline of this paper is as follows. In sec. 2 we introduce an elective quarkm eson model and present our method for its solution. In sec. 3 we sum marise the main results obtained for the phase diagram and investigate the relation between the elective potential of the theory and the conventional treatment of the TCP in terms of a mean eld Landau-type potential. We conclude in sec. 4.

### 2. The model and the large $N_f$ method of its solution

In the broken symmetry phase characterised by the hom ogeneous vacuum expectation value the usual shift in the radial direction ! N + and the requirement of a nite constituent quark mass  $m_q = g$  as N ! 1 denes the following elective

where m<sup>2</sup><sub>0</sub> = m<sup>2</sup> +  $\frac{1}{2}$ <sup>2</sup>, m<sup>2</sup><sub>0</sub> = m<sup>2</sup> +  $\frac{1}{6}$ <sup>2</sup>, <sup>2</sup> = <sup>2</sup> +  $\sim^2$  and L<sub>ct</sub>[; <sup>a</sup>; ] is the counterterm Lagrangian. For ferm ions the chem ical potential is introduced by the replacement:  $\theta_t$ !  $\theta_t$  i. One can see that the ferm ions start contributing at level O (1=  $\frac{1}{N}$ ) in the large N expansion, that is at an interm ediate level between LO and NLO of the mesonic sector. Since we want to calculate ferm ionic corrections to the LO which has O (N) symmetry we disregard the second independent quartic coupling of the SU (N<sub>f</sub>) SU (N<sub>f</sub>) linear model which is present for N<sub>f</sub> > 2 and is proportional with the product of two totally symmetric structure constants d.

O urm ethod consists in taking into account perturbatively  $N_f = \sqrt[r]{N+1}$  avors of  $N_c$  coloured quarks to O (1= N) at one loop order both in the EoS

and in the gap equation iG  $^{1}$  (p<sup>2</sup> = M  $^{2}$ ) = 0 which resum s the superdaisy diagram s m ade of pions with one possible one loop ferm ion insertion.  $T_{B\ (F\ )}$  is the bosonic (ferm ionic) tadpole contribution with m ass M (m  $_{q}$ ). The inverse pion propagator reads as

The contribution of the ferm ionic one-loop bubble (\ sh" diagram ) B  $_1$  can be related to the ferm ionic tadpole:

where  $I_F$  (p;m<sub>q</sub>) is the scalar bubble integral with external momentum p evaluated with mass m<sub>q</sub> and with Ferm i-D irac distribution,  $f_F$  (!) = 1=(exp((!))+1). Substituting relation (4) into (3) and making use of (2) one nds that for  $p^2 = 0$  the inverse propagator vanishes, that is G oldstone's theorem is full led at the minimum of the e ective potential i.e. M = 0. Another way for seeing this is to use the de nition of H (<sup>2</sup>) given in (2) in the expression of the gap equation. Then one has

which shows that in the spontaneously sym m etry broken regime de ned by H ( $^2$ ) = 0,  $\neq$  0 the physical pion m ass is always zero.

## 3. A nalytical determ ination of the TCP

O ne can choose to study the phase structure by expanding in powers of either the EoS or the elective potential and investigate its behaviour near the transition. In ref. [10] we chose the inst possibility and determ ined the line of continuous transitions by requiring the vanishing of the square bracket of (2) at = 0. The pion mass was is xed at M = 0 and only the ferm ion tadpole was expanded. The line of the  $2^{nd}$  order phase transitions comes from the condition

The location of the TCP is determined by requiring in addition to  $m_T^2 = 0$  also the vanishing of the coe cient of  $^2$  in the square bracket of (2)

Here  $\ln (c_1=2) = 1$  <sub>E</sub> + and =  $\ln (M_{0B} = M_{0F})$  gives a relation between  $M_{0B}$ and  $M_{0F}$ , the renorm alisation scales of the bosonic and ferm ionic tadpoles. The parameters of the model are xed at T = 0. Choosing  $m_{q0} = m_N = 3$  312:67 and requiring  $_0 = f = 2$  for the solution of the EoS in the case of two avors  $(N_f = 2)$  we get g = 6:72. = 400 is xed by requiring a good agreement between the location of the complex pole of the sigm a propagator on the  $2^{nd}$  R isom ann sheet and the experimentally favoured mass and width of the sigm a particle. Then one can solve the above equations and nd the line of  $2^{nd}$  order phase transitions, the

rst spinodal line and the location of TCP. This is shown in the lh.s. of Fig. 1. The other lines in the qure are obtained numerically. In the rhs. we see the variation of the TCP and critical temperature with  $M_{OB}$ . The study of the pole structure of the propagator restricts the allowed range of  $M_{0B}$  to the right from the arrow, appearing on the horizontal axis of the gure. In this region no low scale in aginary poles appear besides the well known large scale tachyon, whose scale increases with decreasing values of the coupling constant . In this region one can arrange very easily  $T_{c}$  ( = 0) to occur in the region 150–170 M eV but the TCP stays robustly below 70 M eV. Previous e ective model studies [7], and a recent renorm alisation group improved investigation [11], give similar values which are very low when compared with the CEP temperature of the QCD obtained in [3] for physical num ber of quark avors and m asses. This di erence could m ean that the phase transition is not driven by the light degrees of freedom but by higher excited hadronic states. This possibility was supported by [12] when trying to reproduce lattice results on quark num ber susceptibilities and pressure with a noninteracting hadron resonance gas model. It was shown in [13] using renorm alisation

group techniques that the inclusion of gluon degrees of freedom is in portant around T = 150 MeV. On the other hand we should keep in m ind that we worked in the lim it of an in nitely heavy strange quark, and that lattice studies revealed a very strong dependence on the values of quark m asses [14].

We now discuss a second method, in which we keep the -dependence of the mass gap M. The elective potential is obtained by integrating the functional form of EoS away from equilibrium. This analysis reveals an interesting property of the O (N) models in the large N limit: the vanishing of the elective coupling at the critical point [15]. To see this let us rst note that = 0 becomes a minimum of the potential as T ! T<sub>c</sub> and so M ! 0. The fourth derivative of the elective potential at this point is  $V_{e}^{000}$  (= 0) = 4H <sup>0</sup>(0) where H <sup>0</sup>(<sup>2</sup>) =  $\frac{dM^{2}}{d^{2}}$  1  $\frac{2g^{2}N_{c}}{F_{N}}$  M  $rm_{q}$   $\frac{2g^{2}N_{c}}{F_{N}}$  M  $2\frac{1_{F}(M, rm_{q})}{d^{2}}$ . Since the last term vanishes at T<sub>c</sub> one has to study the behaviour of  $\frac{dM^{2}}{d^{2}}$  which can be form ally expressed from the derivative of EoS with respect to 2:

U sing a high tem perature expansion  $T_B (M^2) ' \frac{T^2}{12} \frac{M T}{4} + \frac{M^2}{8^2} \ln \frac{c_2 T}{M_{0B}}$  and one has  $\frac{dT_B (M)}{dM^2} M^{\frac{1}{2}} M^{\frac{1}{2}} = 0 = \frac{48 M}{c_1^2} (\frac{1}{6} - \frac{4g^4 N_c}{N} \frac{dT_F (m_q)}{dm_q}) M^{\frac{1}{2}} 0$ .

This means that along the line of  $2^{nd}$  order phase transitions  $V_e^{000}$  vanishes. Still one should be able to provide a link between the elective potential of the model and Landau's theory of the tricritical point in which the location of the TCP is obtained from the condition of a vanishing quartic coupling. In order to achieve this, we rst perform a high temperature expansion in H (<sup>2</sup>) given by (2) which yields

where  $U = \frac{T}{48}$  and  $= \frac{g^6 N_{c^2}}{16^{-2^P} N} \frac{1}{T^2} \frac{\theta}{\theta n}$  Li<sub>n</sub> (e<sup>=T</sup>) + Li<sub>n</sub> (e<sup>=T</sup>) <sub>n=-2</sub>. In the following discussion for the sake of simplicity we om it in (5) the one-loop fermion contribution I<sub>F</sub> (M;m<sub>q</sub>). We then rewrite the resulting H (<sup>2</sup>) = M<sup>2</sup> relation as an equation which determines the <sup>2</sup> dependence of M

where  $W = 1 = \frac{2}{48^{-2}} \ln \frac{c_2 T}{M_0}$  and  $\ln \frac{c_2}{4} = \frac{1}{2}$ . The solution of (9) approximates H (<sup>2</sup>), so after substituting it into (2) it can be integrated to obtain an approximation to the elective potential. Subsequent expansion in powers of <sup>2</sup> yields

A few remarks are in order here. First of all whether this potential has the right shape, and whether this approximation has the correct physical meaning depends on the actual values of the param eters. O ne can easily verify that for the param eters used in drawing Fig. 1, W < 0 in the temperature range of the  $2^{nd}$  order phase transition. For increasing values of =T, changes sign at 1.91 from negative to positive values. Since around TCP has to be positive, this sign change restricts the location of the TCP to large values of : it must be in the region > 2T. Second, in the broken symmetry phase  $m_{T}^{2} < 0$  and it vanishes at  $T_{c}$  meaning that the coe cient of the quartic term in vanishes also. A round T  $_{\rm c}$  from (6) one gets  $m_T^2$  T T<sub>c</sub>. Therefore the scaling of the elective mass m<sub>e</sub> =  $\frac{m_T^2}{2UW}$ Τ Τ<sub>c</sub>j gives the correct leading order critical exponent = 1 for the 0 (N) model at large N. Third, to the expression in the square bracket in (10) the usual Landau type analysis applies. The location of the TCP is determined by the same conditions as in the analysis based on EoS, namely (6) and (7). To obtain the scaling exponent of the order parameter on the second order line we need only the set two terms in (10). The minimum condition gives  $2 = \frac{3m_T^2}{T}$ )  $(T T_c)$ , = 1=2. At TCP one can set = 0 in (10) and keep the sixth order term. The minimum condition gives  $4 = \frac{m_T^2}{2}$ ) (T T  $_{\rm c}$ ) , = 1=4. We veried numerically using the exact EoS that the value of on the second order line and at the TCP agrees within the num erical accuracy with their mean eld estimates given above.

Re nem ent of the approximation is needed if one wants to enter the metastable region between the spinodals where  $m_T^2 > 0$  and < 0, but we think that nevertheless the presented analysis captures essential features of the phenom enon.

# 4.Conclusions

In the  $1 = \frac{\nu}{N}$  order of the large N approximation to the solution of the chiral quarkmeson model we presented in the chiral limit an analytical determination of the phase diagram and of the location of the tricritical point. We have shown that with a reasonable approximation which works ne at high temperature, the elective potential of the theory can be related to mean eld Landau type potential, from which the critical exponents can be determined.

In order to assess to what extent a description of the phase diagram of QCD is possible using a low energy elective model, one has both to improve our method of solving the model and to get as close as possible to the physical case of 2+1 avors. The rst issue necessitates taking into account the fullmomentum dependence of the self-consistent pion propagator, the implementation of a new resummation method and solving the D yson-Schwinger equation for the fermions. The latter problem requires the extension of our method to the SU (3)<sub>L</sub> SU (3)<sub>R</sub> case.
