# Theoretical Implications of the LEP Higgs Search

W e study the in plications for them in in alsupersymm etric standard model (M SSM) of the absence of a direct discovery of a Higgs boson at LEP.F inst we exhibit 15 physically diment ways in which one or more Higgs bosons lighter than the LEP limit could still exist. For each of these cases { as well as the case that the lightest Higgs eigenstate is at, or slightly above, the current LEP limit { we provide explicit sample con gurations of the Higgs sector as well as the soft supersymmetry breaking Lagrangian parameters necessary to generate these outcomes. We argue that all of the cases seem ne-tuned, with the least ne-tuned outcome being that with m  $_{\rm h}$  ' 115 GeV. Seeking to m in in ize this tuning we investigate ways in which the \m axim al-m ixing" scenario with large top-quark trilinear A -term can be obtained from simple string-inspired supergravity models. We not these obvious approaches lead to heavy gauginos and/or problem atic low-energy phenom enology with m inim al improvement in ne-tuning.

The M inim al Supersymm etric Standard M odel is dened as the simplest supersymmetric extension of the Standard M odel (SM ). Every SM particle has a superpartner, the basic Lagrangian is supersymm etric, and the gauge group is the sam e SU (3) SU (2) U (1) as that of the SM . The full supersymmetry is softly broken by certain dimension two and three operators. There is considerable indirect evidence that this theory is likely to be part of the description of nature. If it is, a Higgs boson with mass less than about 130 GeV must exist, and superpartners must be found with masses not too much larger than those of the W , Z and top quark. W hile the Higgs boson mass can be as heavy as 130 GeV in the M SSM , it has been known for some time that most naive models imply a lighter state, usually below about 110 GeV, when constraints from non-observation of superpartners (real or virtual) are imposed, and including the constraint that the indirect argum ents for supersym metry are valid without ne-tuning.

W hile it is not in possible that perhaps LEP has seen a Higgs boson with m<sub>h</sub> ' 115 G eV, the data collected up through center-ofm ass energy of 209 G eV [1] yields no unam biguous signal for such a light Higgs eigenstate. O ne obvious explanation for this fact is that the lightest Higgs boson is heavier than 115 G eV. A nother is that one orm ore eigenstates are lighter than the kinem atic cut-o but that they do not couple signi cantly to the Z-boson. Thus it is natural to ask whether the Higgs sector of the M SSM could be such that LEP would not have found a signal because of reduced Higgs cross sections or reduced branching ratios in som e part of the general M SSM param eter space. U sing the reported LEP lim its on the cross-section branching ratio for Higgs eigenstates as

a quide, it is possible to nd 15 logically distinct ways in which this could indeed have been the case at LEP. Together with the possibility that the lightest Higgs boson is at 115 GeV, and the possibility that it is much larger in mass, there are 17 distinct con gurations of the M SSM Higgs sector consistent with the LEP results. These cases are summarized in Table I of Section II below, with an explicit example con guration for each case given in Table II. The results in Table I are not the outcom e of a complete parameter scan, but instead represent a general classi cation of logical possibilities for the M SSM Higgs sector. All of our example points allowed by other data. All satisfy the constraints for electroweak symmetry breaking, though som etim es in unconventionalways. All of the example con gurations are detectable at the Ferm ilab Tevatron collider with su cient lum inosity.<sup>1</sup> If the M SSM is the correct description of nature just above the electroweak scale then one of these 17 cases is the true Higgs sector of the M SSM .

In Section I we review the data collected at LEP, with particular attention paid to what is strictly measured and how these measurements are converted into limits on Higgs eigenstate masses. As mentioned above, there is no clear indication for the presence of Higgs bosons in

the LEP data. Nevertheless there are three distinct cases where an excess of observed events in a particular channel resulted in an experimental bound on the cross section branching ratio that was weaker than the expected limit at the 2 level [3, 4, 5, 6]. In these \excess regions" care must be taken in extracting a mass bound on the possible Higgs eigenstates involved. U sing these regions as a guide we classify the possible consistent Higgs con gurations in Section II. In that section we provide a general description of each of the 17 logically distinct cases as well as a concrete example con guration to illustrate each case.

W ith these 17 cases in hand it is natural to then ask whether any of them are less ne-tuned than the others, and thus m ight be more likely to point to a particular underlying theory. To address this issue it is necessary to construct a soft supersymmetry breaking Lagrangian capable of giving rise to each of the 17 possible con gurations. Since not all 105 param eters of the M SSM are relevant for determ ining the Higgs sector of the theory, there is some inevitable arbitrariness in this construction. It is for this reason that LEP results are offen interpreted in the light of certain \benchm ark" models to reduce this arbitrariness. We have chosen to work in a less restrictive environm ent and provide candidate soft Lagrangian param eters at both the electrow eak scale and the high-energy (in this case GUT) scale in Section III. Interestingly, only 4 of the 17 cases can be obtained from a model such as minimal supergravity (m SUGRA) with a universal gaugino m ass, universal scalar m ass and universal soft trilinear coupling at the GUT scale. This includes the cases where the lightest H iggs boson is at, or much larger than, 115 G eV. D espite the 15 distinct ways the Higgs could have been lighter than 115 GeV and escaped detection, the most natural conclusion within the M SSM is still that the H iggs is at, or just slightly above, 115 GeV in mass. This conclusion is arrived at in Section III through a variety of means: investigating the low energy parameter space, examining the high energy soft Lagrangian as well as a ne-tuning analysis using the sensitivity parameters of Barbieri and Giudice [7].

A chieving such a large Higgs mass in the MSSM will necessitate at least som e level of uncom fortable tuning because the tree level H iggs mass is bounded by M  $_{\rm Z}$ and thus the one loop corrections have to supply about  $m_h^2$  ' (70 GeV)<sup>2</sup> when added in quadrature. This tuning is most mitigated in the so-called \maxim al-mixing" regime, which implies a very large soft trilinear coupling involving the stop and where the gluino can be made as light as possible. W hile widely used as a benchm ark case in low -energy studies of the Higgs sector of SU SY m odels, such a regime does not seem to be a robust outcome of any of the standard SUSY breaking/transm ission m odels typically considered in the literature. W e study the general improvement in ne-tuning when maximal-mixing in the stop sector is obtained in Section IV. In Section V we focus on string-based m odels and look at ways to engineer such large m ixing in the stop sector. We nd that the most obvious ways to approach maxim alm ixing result in either heavy gauginos or a problem atic low energy phenom enology. Thus explaining the LEP result without excessive tuning in these simple models seems di cult. We conclude with some speculation on how extending these string-based models in theoretically well-motivated directions could alleviate the problem.

## I. OVERVIEW OF THE LEP RESULTS

In order to appreciate the theoretical implication of the LEP Higgs search on high energy models it is necessary to understand the way in which data is collected and interpreted by the LEP experimental collaborations. This, in turm, requires a brief review of the salient features of the Higgs sector in the M SSM. In this section we aim to provide su cient background to motivate the classication scheme for low-energy models adopted in Section II.

#### A. W hat is measured at LEP

There are three neutral Higgs states in the MSSM. If there is no CP violating phases then these neutral Higgs mass eigenstates are also CP eigenstates: two of them are CP-even and one is CP-odd. If Higgs bosons are produced at LEP then the relevant process will be  $e^+ e + Z + i_Z$  or  $e^+ e + Z + i_J$ , where  $i_I represents$  any of the three neutral Higgs mass eigenstates. It is therefore convenient to de ne the follow ing Higgs/Z-boson couplings

Since the Standard M odel H iggs boson has the coupling Z Z H  $_{\rm sm}$ :  $g_2m_Z = \cos_W$ , the C  $_i$ 's are to be interpreted as ratios of the true couplings to those of the SM .W hen C P is conserved we m ay use h, H and A to denote the lighter C P -even, heavier C P -even and C P -odd H iggs states, respectively. In this C P -conserving case only C  $_h$ , C  $_H$ , C  $_{hA}$  and C  $_{HA}$  are non-zero and we have the relations

The C<sub>i</sub> can be related to the Higgs mixing angle and the ratio of the vevs of the up-type to down-type Higgs eld de ned by tan =  $v_u = v_d$ . For example, in the CP-conserving case the one independent variable can be written as C<sub>h</sub> = sin ( ). In addition to the proportionality factor C<sub>ij</sub>, when a CP-even Higgs boson is produced in association with the CP-odd state there is a kinematic p-wave suppression factor such that  $(e^+e \ A_i) / m_s$  where

A llof these proportionality factors are m odel-dependent, as are the m asses of the various H iggs eigenstates.

Once produced, Higgs eigenstates are identied through their decay products. In most of the MSSM param eter space the three neutral Higgs eigenstates decay predom inantly into the heaviest accessible ferm ion { typically either a b; b or <sup>+</sup>; pair. In some a reas of param eter space decays into other quark/antiquark pairs are im portant, particularly to charm quarks. In still other regions of the MSSM parameter space a heavy Higgs eigenstate m ay decay into lighter eigenstates (though only in the presence of CP violation) and/or decay into light neutralinos which can escape the detector. We shall refer to the latter case as an \invisible decay," though such event signatures can be and have been analyzed at LEP.

In both production processes Z  $_{i}$  and  $_{i}$   $_{j}$ , a crucial element in reconstructing the event as one involving a Higgs eigenstate is the reconstruction of the associated partner { whether it be a Z-boson or another Higgs eigenstate. Thus the most in portant category of event signature is a four-jet event, with both the Higgs eigenstate and the associated production partner decaying into quark/anti-quark pairs. To reduce the background from processes such as  $e^+ e + ZZ; W^+W$  b-tagging is typically used to require that at least one pair of jets arise from a b; b pair. As the Higgs states tend to decay to b quarks m ore frequently than Standard M odel gauge bosons, this data set will tend to have a larger proportion of Higgs events.

Thus we might crudely think of classifying events at LEP in terms of a set of topologies. Some of these topologies, such as bb'' (with ' either an electron or a muon), are more likely to come from the process  $e^+e$  ! Z i than from  $e^+e$  ! i j. O thers, such as bb + , may t quite well with either production mechanism. To account for this ambiguity, each event that passes the initial cuts is assigned a measure of its \signal-like" properties under the hypothesis of the process  $e^+e$  ! Z i and the process  $e^+e$  ! <sub>i i</sub>. An event where the invariant mass of a lepton pair closely matches the Z-boson mass, for example, will then be m ore \signal-like" under the form er hypothesis than under the latter. This weight is a function not only of the experim entally reconstructed Higgs m ass for the state i but also of the true H iggs m ass m \_i for that state. Thus asking whether a given event \looks like a Higgs event" is complicated by the need to ask this question only in the context of a given hypothesis about how this Higgs state was created and what its true mass is. Equally challenging is asking the question of how many events of a given topology LEP should have seen for a given Higgs m ass. W hat's m ore, the likelihood that a particular event represents a signal is model-dependent, and will vary depending on whether we assume CP is conserved in the Higgs sector, or whether we assume a certain hierarchy of Higgs masses among the eigenstates.

It is therefore more useful to think of a limit on the production cross-section branching ratio for the pro-

cess e<sup>+</sup> e ! Z<sub>i</sub> and the process e<sup>+</sup> e ! <sub>i j</sub> as a function of the H iggs eigenstate m asses involved, bearing in m ind that this lim it will contain som e residual model dependence. Since the Standard m odel production rate is known for a given H iggs m ass m<sub>i</sub>, we can norm alize the lim it to this quantity (and the known Z-boson branching ratios) to obtain the parameter <sup>2</sup> reported by LEP

For each of the two production mechanisms, and each of the nalstate signatures, the elective number of events observed at LEP can be translated into a limit on the elective coupling  $^2$  for a given Higgs mass m<sub>1</sub>.

Deciding whether a given point in the MSSM parameter space is \ruled out" by the LEP data is then more involved than simply calculating the masses of the Higgs eigenstates. Of key importance is the expected limit on <sup>2</sup> for a particular channel. This is the bound that would be placed if all observed events that received some non-zero weight as \signal" events were in fact merely Standard M odel background events. W hile the actual bound obtained by the LEP collaborations is consistent with this expected bound, there are three distinct excesses where the experim entally obtained bound was weaker than the expectation by approximately 2 [3, 4, 5, 6]. The most celebrated of these is in the channel  $e^+e$  ! Z h which shows an excess around  $m_h$  ' 115 GeV. The two others occur in the  $channele^+e$  ! Z h w ith m h ' 98 G eV and in the channele<sup>+</sup> e ! Ah with m<sub>h</sub> + m<sub>A</sub> = 187 G eV . Any M SSM m odel that yields a Higgs con guration near one of these areas is governed by constraints from LEP that are quite dierent from those that yield a Higgs sector far from these areas.

## B. How are mass lim its obtained at LEP

The relative couplings given by the C<sub>i</sub> in (1) are functions of the H iggs m ass spectrum . Thus, lim its on the electric couplings <sup>2</sup> can be translated into lim its on these m asses. The H iggs m ass spectrum, in the CP-conserving lim it, is determ ined at tree level by just two input parameters at the electroweak scale. These could be two eigenstate m asses such as m<sub>h</sub> and m<sub>A</sub>, or two angles such as the Higgs m ixing angle and the ratio of H iggs vevs given by tan , or som e combination of the two. N ote that these electroweak scale inputs are derived quantities and are not fundamental from the high-energy, underlying theory point of view.

At the loop level the Higgsm ass spectrum requires several more inputs from the soft supersymmetry-breaking Lagrangian. A mong these are the running squark masses for the third generation left-handed doublet m<sup>2</sup><sub>\$\mathcal{P}\_3\$</sub> = m<sup>2</sup><sub>\$\mathcal{E}\_L\$</sub> = m<sup>2</sup><sub>\$\mathcal{B}\_L\$</sub> and the right-handed third generation singlets m<sup>2</sup><sub>\$\mathcal{E}\_R\$</sub> and m<sup>2</sup><sub>\$\mathcal{B}\_R\$</sub>, the trilinear scalar couplings associated associated the second seco

ated with the top quark Yukawa  $A_t$  and bottom quark Yukawa  $A_b$ , and the (supersymmetric) Higgs bilinear coupling . At the next order the gluino mass is also in portant, not only in determining the Higgs mass spectrum but also for its contribution to the bottom quark Yukawa coupling which determines the Higgs branching fraction to b; bpairs. If we allow for CP violation in the Higgs sector we will also involve the relative phase between and

 $A_t$ , which a ects the masses of the various H iggs states as well as their couplings to the Z-boson.

In the presence of a CP violating phase (for example, the relative phase A between the parameter and the soft supersymmetry breaking trilinear coupling of the top squark) the mass matrix for the neutral Higgs states is a 3 matrix. In the basis  $fRe(h_d)$   $V_d; Re(h_u)$  $v_u; sin Im (h_d) + cos Im (h_u) g this is given by$

where  $e = 3 \frac{2}{t} = 16 \frac{2}{8}$ ]. The mass  $m_A^2$  is proportional to the tree level value  $m_A^2$  of the CP conserving case and reduces to it in the limit of  $_A$  ! 0. We have chosen to use the pairm  $_A$  and tan asour tree level input variables for the moment. The quantities  $_{ij}$  represent radiative corrections to the tree level values of the CP even subsector. Explicit expressions for these quantities can be found in [9, 10, 11, 12]. The quantity represents radiative corrections that are only present in the case of CP violation. Its value, as well as the dimensionless proportionality factors r and s, can be found in [8].

W hen we neglect the LR entries of the squark mass matrix (which is the case of \m inim alm ixing"), we have the following leading radiative corrections

and  $_{12} = 0$ . Note that the sizes of  $_{11}$  and  $_{22}$  are quite di erent: even in the large tan regime, where t b, the ratio  $_{22} = _{11}$  ' 400. Given that the one-loop correction  $_{22}$  from the stop sector has a typical size on the order of 30 G eV, it follows that the one-loop correction  $_{11}$  from the scalar bottom sector has a typical size  $_{11}$  0:1 G eV and is therefore negligible.

A particularly simple form for the above matrix which is offen assumed is obtained under the assumptions that (i) there is no CP violation (ii) the tree levelo -diagonal entries in (6) can be ignored and that (iii)  $m_A$  sin  $m_Z \cos s$ . Then the approximate mass eigenvalues are  $m_A^2$ ,  $m_H^2 = m_A^2 \sin^2$  and  $m_h^2 = m_Z^2 \sin^2 + m_A^2 \cos^2 + \frac{e_m_t^2 \ln [(m_{t_1}^2 m_{t_2}^2) = m_t^4]$ . A more useful approximation to the lightest CP even Higgs mass is obtained when the stop left-right mixing is restored. In this case the appropriate expression in the large tan limit is  $m_h^2$ ,  $m_Z^2$  +  $m_R^2$

The additional contributions from the second term in (8) are maximized for particular values of the stop mixing parameter X<sub>t</sub> (A<sub>t</sub> cot)=M<sub>susy</sub>. This property has been used to de ne the so-called  $\mbox{m}_{h^0}$ -max" scenario [13] which generates the maximum possible Higgs mass for a given value of tan and typical Higgs mass. W e will refer to this regime by its more common (though misleading) name of the  $\mbox{m}$  aximal mixing" scenario.<sup>2</sup> The speci c point de ned in [13] is given by the follow ing combination of parameters:




FIG.1: D istribution of con dence level in the (m  $_{\rm h}$  ;m  $_{\rm A}$ ) plane for the m  $_{\rm h}^0$ -m ax scenario [1]. The white area m arked < 1 the observed number of events shows a de cit or is less than 1 above the background prediction for this scenario. Sim ilarly, the green shaded region m arked > 1 and the blue shaded region m arked > 2 show ed an excess of observed events above the Standard M odel background over 1 and 2, respectively. The 95% con dence level exclusion contour is given by the dashed line { points to the left of this line are excluded. W e have highlighted two areas of particular interest: one centered around m  $_{\rm h}$  = 114 GeV (A) and one centered around m  $_{\rm h}$  = 98 GeV (B).

and the value of tan restricted to lie in the range 0:4 < tan < 50. W ithin this paradigm, the constraints on the various <sup>2</sup> can be translated into the lim its displayed in Figure 1 for the ( $m_{h^0}$ ;  $m_A$ ) plane [1]. The 95 % exclusion contour is represented by the dashed line in Figure 1: combinations of  $m_h$  and  $m_A$  above and to the left of this line would require a coupling <sup>2</sup> for some process excluded at the 95% con dence level. In other words, within the context of the  $\mbox{m}_{h^0}$ -m ax" scenario these combinations would have produced too m any signal-like events at LEP. The utility of the  $m_{h^0}$ -m ax scenario is that the lim its on the Standard M odel-like H iggs eigenstate of the M SSM are the m ost conservative possible. It must be remembered, how ever, that the lim its, the con dence level regions and the theoretically

excluded areas will all change if the m  $_{\rm h^{0}}$  -m ax scenario is replaced with a di erent interpretive paradigm .

## II. LOW -ENERGY CLASSIFICATION

We have learned from the preceding section that one can identify three distinct 2 excesses in the LEP data consistent with the hypothesis that one or more Higgs eigenstates is produced. These correspond to the production of a (mostly) CP-even eigenstate of mass 98 G eV and/or 115 G eV, as well as the production of two Higgs eigenstates with one being (mostly) CP-odd. By \mostly" we mean that in the presence of CP violating e ects in the Higgs sector the wavefunction for the state in question is dom inated by the component with the appropriate CP quantum number. We will see below that som e interpretations of these excesses will require a degree of CP violation.

For the rem ainder of this section we will refer to these as 2 \signals," bearing in m ind that some or all of these excesses may be simply the result of uctuations in the background rate. Logically speaking, one can divide the M SSM parameter space into classes capable of producing one, two or three signals { as well as a much larger class that would give rise to no excess events at all. G iven that properly applying the LEP constraints on Higgs m asses depends on whether those m asses fall near one of these excess regions, we believe this is a useful system for classifying possible M SSM models.

In all we discontained physically distinct scenarios compatible with the LEP results. In freen cases the lightest Higgs mass is kinematically accessible at LEP II but no signal is produced due to a reduction in the production cross section and/or branching ratios to bottom quarks. In addition there is the case where the lightest Higgs eigenstate is indeed Standard M odel like with a mass  $m_h = 115 \text{ GeV}$  (No. 10) and the case where it is heavier than about 115 GeV (No. 17). These di erent con gurations are summarized in Table I.

As m entioned in the previous section, the low-energy param eter space that determ ines the properties of the Higgs sector relevant for the LEP search is large. We have not attempted a complete scan of this space so the ranges we present for each case in mass values and tan should be regarded as representative. For investigating the Higgs sector at low energies we use the FOR-TRAN code CP superH [14] which uses an e ective potential method for computing Higgs mass eigenvalues and couplings. To keep the survey manageable we scanned over the low-energy quantities tan ,  $m_H$  ,  $A_t = A_b$ ,  $m_{Q_3}^2$ ,  $m_{U_3}^2 = m_{D_3}^2$ , and the relative phase between  $A_t$ and them u param eter in generating Table I. For the case where the lightest Higgs eigenstate decays into neutralinos (no. 15) we included the gaugino mass variables M  $_1$ and M  $_2$  in the scan.

Note that the ranges presented in the table do not assume any particular model for the soft Lagrangian at either the low or high scale, such as the maxim alm ixing scenario. We will discuss possible im plications for the soft supersymmetry breaking Lagrangian in Section III. For the remainder of this section, how ever, we will discuss som e general features of the entries in Table I and investigate in further detail som e speci c points representing cases with three, two, one and zero excesses.

Let us begin with a description of the various quantities in Table I. A fter giving the entry number we provide the neutralHiggsmass spectrum.When CP is conserved we call the states by the usual nam es h, H and A; one can show here that  $m_h$  is always less than  $max(M_Z; m_A)$ , even allowing one-loop corrections for m<sub>h</sub>, so any model with m  $_{\rm A}$  and M  $_{\rm Z}$  < m  $_{\rm h}$  requires a non-trivial phase. This conclusion does not include loop e ects for  $m_A$ , so one can have  $m_A$  a few GeV less than  $m_h$  for certain param eters if tan is large. The reader should keep in m ind that in the CP violating cases the mass eigenstates are not CP eigenstates. The column headed has a Y if a non-trivial phase (not zero or ) plays a role for a given model. Because the one loop top/stop radiative correction to the Higgs potential is rather large, a large phase (speci cally the relative phase of  $A_t$ ) can enter, and lead to a relative phase between the Higgs vevs at the minimum of the potential. This phase is physical and cannot be rotated away. It leads to mixing between the mass eigenstates, and a ects the production rates and decay branching ratios [16, 17, 18, 19, 20].

The fourth column is the charged Higgs mass and it can be schematically written as  $m_{H}^{2} = m_{W}^{2} + m_{A}^{2} +$ loop corrections. For som e row s, the charged H iggs m ass is alm ost xed and we give the num erical value in the table for these cases. For the remaining cases where there is a range for the  $m_{H}$  we merely indicate  $m_{H}$ m⊿ since it does not dier from m A signicantly. In most cases the charged H iggs m ass m  $_{\rm H}$  is less than the top quark mass, so the decay t ! b + H is allowed. Existing data from D0 excludes m<sub>H</sub> below about 125 G eV for tan larger than about 50 with mild model dependence, so no model is fully excluded { though parts of the param eter range of som e m odels are probably excluded by non-observation of H . W ith m ore and better data from Run II the H of most of these models could be observed or excluded [21]. These small values for  $m_{\rm H}$  can also exceed limits from Br(b! s), but using light chargino and gluino contributions provides signi cant exibility. However, cases 8 and 16 exceed the lim its on Br(b! s) by more than a factor of two and are thus likely to be excluded, though we should note that this is based on using a unied m SUGRA model for these cases and may not

hold when departures from universality are entertained.

The list of possible excesses that can be obtained with a particular scenario, the allowed range in tan and the Higgs ZZH; couplings follow. Again, in CP violating cases  $C_h$  is the coupling of the lighter of the mostly CPeven neutral H iggs states while  $C_{H}$  is the coupling of the heavier such state. We have lim ited the range of tan surveyed to a maximum value of tan 50. For each point in the low energy parameter space the production cross section relative to the Standard M odel H iggs can be com puted from the couplings C  $_{\rm h}$  and C  $_{\rm H}$  . D ecay widths for Higgs decays to bottom, charm and tau are computed to determ in Br(h ! bb). From these the variable <sup>2</sup> can be determined for comparison to the LEP bounds. As LEP reports bounds in the lim it where m  $_{\rm h}$  ' m  $_{\rm A}$  we can take the parameter ' 1.

The column marked  $\U$  indicates a low-energy scenario that can be reached by a point in the m SUGRA parameter space at high energies. We will have more to say about this column in Section III. The column headed by has a Y if is very large, say well above several hundred G eV. This is particularly relevant because of

the question of ne-tuning needed to obtain electrow eak sym metry breaking. Such a large value of is necessary in some cases because of the need to enhance the bottom Yukawa coupling, and thus enhance the branching ratio of h! bb. This can be seen from the following

where we keep only the leading terms in tan . Here I(a;b;c) is a loop integral and g is the SU (2) gauge coupling. It is clear that once the relative sign between  $A_t$ ,  $M_g$  and is chosen, the large value of can make  $_b$  more negative and consequently enhance  $y_b$  for a xed input bottom quark mass.




FIG.2: Schem atic D istribution of the 17 cases in Table II. The example points in Table II are plotted in the (m<sub>h</sub>;m<sub>A</sub>) plane. Three points (N os. 10, 15 and 17) involve pseudoscalarm asses outside of the region shown. We have overlaid the \theoretically disallowed" region (light shading) and 95% exclusion contour from F igure 1 for the special case of the CP-conserving m<sub>h</sub><sup>0</sup> m ax scenario [1]. These contours are shown for reference purposes only: the bounds derived for the m<sub>h</sub><sup>0</sup> m ax scenario need not apply to the 17 speci c points we investigate.

W e next give a detailed description of the Higgs sector for an example point that gives rise to three, two, one or no excesses at LEP, respectively. Sample low-energy con gurations for all models are sum marized in Table II and plotted schematically in Figure 2.

A sam ple point in the parameter space of Entry No.1 has  $m_h$  ' 98 GeV,  $m_H$  = 115 GeV and  $m_h + m_A$  = 187 GeV. Its parameters are tan = 6, = 1700,  $m_H$  = 119,  $A_t$  = 370,  $A_b$  = 400, = 135°,  $M_1$  = 100,  $M_2$  = 200,  $M_3$  = 600 and  $m_{\mathcal{O}_3}$  =  $m_{\mathcal{B}_R}$  =  $m_{\mathcal{T}_R}$  = 500, with all parameters in GeV. This gives for the m asses of the three m ass eigenstates  $m_1$  = 88:9,  $m_2$  = 97:4, and  $m_3$  = 115:3 GeV, with  $C_i^2$  respectively of 0.036, 0.206, and 0.758. All three states have BR ('i ! bb) 0:94. These give about 2 signals at 98 and 115 GeV. Since m  $_{\rm A}$   $\,$  M  $_{\rm Z}$  the Z h and A h channels add to give an apparent 187 GeV signal.

Entry No. 5 is designed to  $tm_{H} = 115 \text{ GeV}$  and  $m_{h} + m_{A} = 187 \text{ GeV}$ . In this case one needs a large value to t the 187 GeV signal. This is because if the Higgs decay is like the SM Higgs decay, then the branching ratio to b; b pairs at this m ass region is about 80% and  $^2_{ZAh}$  will be too small to explain the signal. To satisfy the criteria for the 187 GeV signal we need to enhance the branching ratio to b; b w hich tends to require a large . All scanned points have  $^2_{ZAh} < 0.90$ . Our sample point has Br(A ! bb)Br(h ! bb) = 0.935 with parameters tan = 32, = 2000,  $m_{H}$  = 130,  $A_{t}$  =  $1750, A_b = 1000, M_1 = 300, M_2 = 300, M_3 = 1000,$  $m_{\sigma_3} = m_{B_P} = 1000$  and  $m_{t_R} = 1380$  with all masses in GeV. The masses of the three mass eigenstates are  $m_{h} = 90.7, m_{A} = 96.8$  and  $m_{H} = 115.0$  GeV, with  $C_{i}^{2}$ respectively of 0.008, 0 and 0.992. All three states have BR ('<sub>i</sub> ! bb) 0:98 which yields an apparent 2 signal at 115 GeV and 187 GeV .

Entry No.8 has m\_{\rm H} = 115 G eV with the other neutral H iggs states having smaller m asses. Its parameters are tan = 39.48, = 569, m\_{\rm H} = 126.8, A\_t = 832, A\_b = 926, M\_1 = 179, M\_2 = 344, M\_3 = 1117, m\_{\mathcal{G}\_3} = 926, m\_{\tilde{b}\_R} = 902 and m\_{t\_R} = 857, with all m asses in G eV. The m asses of the three m ass eigenstates are then m\_h = 94.4, m\_A = 98.0 and m\_H = 114.4 G eV, with C\_i^2 respectively of 0.042, 0 and 0.958. All three states have BR ('i ! bb) 0.94 which yields an apparent 2 signal at 115 G eV.

Entry No.15 has no signal at LEP and a lightest H iggs

boson m ass below 115 GeV. Its parameters are tan = 2:1, = 200, m<sub>H</sub> = 500 A<sub>t</sub> = A<sub>b</sub> = 4000, M<sub>1</sub> = 55, M<sub>2</sub> = 250, M<sub>3</sub> = 700 and m<sub> $\sigma_3$ </sub> = m<sub> $B_R$ </sub> = m<sub> $t_R</sub> = 2000, with all masses in GeV. The masses of the three mass eigenstates are m<sub>h</sub> = 111, m<sub>A</sub> = 494 and m<sub>H</sub> = 501 GeV, with C<sub>1</sub><sup>2</sup> respectively of 0.999, 0 and 0.001. The branching ratios of the lightest state are BR (h ! bb) = 0:3 and BR (h ! N<sub>1</sub>N<sub>1</sub>) = 0:621, where N<sub>1</sub> is the stable lightest superpartner and is a good candidate for the cold dark matter of the universe. In the case presented here, m<sub>N<sub>1</sub></sub> = 43.5 GeV.</sub>$

# III. IM PLICATIONS FOR SOFT SUPERSYMMETRY BREAKING

It would be very nice if one or more of the cases described in Section II pointed clearly to a sim ple high scale model which we could then study and perhaps motivate. Unfortunately, this does not seem to occur. The rst obstack is the fact that the Higgs sector values given in Tables I and II above do not com pletely specify the M SSM soft Lagrangian at the electroweak scale. Thus, translating these values to a high energy boundary condition scale uv through renorm alization group (RG) evolution will involve som e arbitrariness { for exam ple, in choosing 8

In som e instances, such as entry No.8 described above, the necessary low scale values could be obtained from a uni ed m SUGRA m odelat the high scale. In order to determ ine how many of the low -energy scenarios of Table I could be similarly obtained, we perform ed a scan over the ve param eters of the m in in al supergravity m odel at the scale uv = qut = 1.9 10<sup>46</sup> { uni ed scalar mass m<sub>0</sub>, uni ed gaugino m ass m  $_{1=2}$ , uni ed trilinear coupling A  $_0$ , and the sign of the -parameter. These paramtan eters were evolved to the electroweak scale  $_{ew} = m_Z$ using the code SuSpect with ferm ion masses and gauge coupling set to their default values [22], and the resulting Higgs sector compared with the 17 cases in Table I. Only four of these possibilities were found to be obtainable from such a uni ed model at the high-energy scale, and these models are marked by a Y in the appropriate colum n of Table I.

squark m asses.

The fact that so few entries can be obtained from m SUGRA can be understood as follows. In general the value of the pseudoscalar mass m<sub>A</sub> and the coupling of the lightest CP-even Higgs to the Z-boson are related: sm all values of m<sub>A</sub> in united models tends to require very large tan which also tends to imply C<sub>h</sub> ′ 0. For cases in the table where tan is restricted to be signicantly below tan = 50 but yet  $C_h^2 \notin 0$  we indicate the obtainable from m SUGRA. In addition, cases where the

term must be large yet the pseudoscalar mass is small are not common in mSUGRA. This leaves only entries Nos. 8, 10, 16 and 17 in Table I. For these models the values of the relevant parameters in the soft Lagrangian (and the value of the -parameter) are given in Table III at the input scale gut and at the electroweak scale in Table IV below.

For the rem aining cases, where a uni ed description at the high scale is nonexistent, we are forced to make som e arbitrary choices for the undeterm ined soft Lagrangian param eters in order to reconstruct the high-energy Lagrangian. It is comm on practice when working with lowenergy soft parameters to choose all squark masses to be degenerate for sim plicity { com pare, for exam ple, the de ned values of the squark masses in the  $m_{h^0}$ -max" scenario of (9). Of course such an outcom e at the electroweak scale would require a very special initial condition at the high energy scale { a fact not often appreciated in low-energy analyses. Nevertheless, thing the Higgs sectors in Table II to a low -energy soft supersymmetrybreaking Lagrangian is a far easier task when the squarks are taken to be degenerate at the electroweak scale, so we will adopt that procedure here when possible. Our choices for low energy values are given in Table V while the translated values at the GUT scale are displayed in Table VI.

Naturally, entries such as Nos. 8 and 16 which can be identied with a point in the m SUGRA parameter space have a simple appearance at the high scale. By contrast, those models which have no mapping to a unied-

m ass model show no discernible pattern in the soft Lagrangian. W hile some sm all degree of im provement m ay be possible by varying those parameters left unspecied at the low scale by the Higgs sector, we have found no instances where the patterns of severe hierarchies and negative scalar mass-squareds can be alleviated. Note that these non-universal cases are particularly perverse in that both charge and color symmetries are radiatively restored in these models as the parameters are evolved tow ards the electroweak scale.

Even allowing for the possibility that some of the highscale values in Table V I which appears in ilar can, in fact, be m ade to unify with the appropriate adjustm ent of low scale values, we are still confronted with a large number of unrelated parameters in the soft Lagrangian. Most models of supersymmetry breaking (such as m SUGRA) are studied for their sim plicity; they tend to involve very few free parameters. The traditional models of minimal gravity, m in im algauge and m in im alanom aly m ediation, as studied in the Snowmass Points and Slopes [23, 24] have too few param eters to possibly describe these nonuniversal cases even when all three are combined in arbitrary amounts. Nor do string-based models generally provide su cient exibility, whether they be heterotic based [25] or intersecting brane constructions such as Type IIB orientifold models [26]. W hile having su cient free parameters in the model is, strictly speaking, neither necessary nor su cient to potentially generate one of the entries in Table I, we feel it is a good indication of the theoretical challenge faced by models that cannot com e from mSUGRA or other simple benchmark models. This is particularly true when the number of free param eters within, say, the scalar sector and the num ber of hierarchies in the soft Lagrangian are considered.

That many of the entries in Table I in ply high scale soft supersymmetry breaking patterns with such unattractive features (and no discernible theoretical structure) can be considered one element of the netuning in such cases. It is not an automatic corollary, how ever, that the models that admit a uni ed explanation are necessarily less netuned. In Table V II we also provide two additional quantitative measures of the netuning in these 17 cases. The numbers  $_{\rm Z}$  and  $_{\rm A}$  are the sensitivities of m  $_{\rm Z}$  and m  $_{\rm A}$ , respectively, to small changes in the values of the independent high-scale values  $a_i$ ; i.e.  $= \frac{(i)^2}{(i)^2}$  where  $i = j(a_i=m)$  m =  $a_{ij}[7]$ .

In order to treat uni ed and non-uni ed models equally we have used the average scalar mass squared, gaugino m ass and trilinear coupling as free variables in computing these sensitivities, as well as the value of the bilinear B-term (in lieu of tan ) and the -parameter at the GUT scale for a total of ve  $a_i$  for each model. For example, to calculate the  $m_{1=2}$  for the nonuniversal models each gaugino mass was varied simultaneously by a certain percentage (in this case 1%). The RGEs were then solved with these three new gaugino mass input parameters and the new Z-boson mass computed at the electrow eak scale. From this  $(m_Z)=m_Z$  can be determined. The value of

 $(m_{1=2})=m_{1=2}$  is then given by the average of the three individual perturbations divided by the average of the three original values of the gaugino m asses.

As far as we can see, all models with m<sub>A</sub>  $m_h$ , or equivalently C<sub>H</sub> 1 are signi cantly ne-tuned. This is not clear from the low-scale param eters, but seem s to emerge when one examines the high-scale models that give rise to sm all m A . M odels which require specifying multiple soft parameters quite precisely also imply additional tuning costs relative to the m SUGRA models. This should be seen as evidence of the diculty in nding areas of the low -energy parameter space capable of producing m any of the entries in Table I. W hile the netuning \price" of the LEP results for the M SSM has been often discussed [27], it is apparent from Table VII that the least ne-tuned result continues to be the case with m  $_{\rm h}$  ' 115 GeV .

#### IV. FOCUSON MAXIMALMIXING

It may not seem surprising that the least-tuned interpretation of the LEP Higgs search is that the lightest Higgs eigenstate is Standard M odel-like and very near the current lim it of m<sub>h</sub> 114 G eV , as this is the hypothesis that is so often taken when studying the constraints on the MSSM parameter space in the literature. It is perhaps more surprising that the cases with m  $_{\rm A}$  $m_{\rm h}$  $m_{\rm Z}$ are so much more sensitive to initial conditions, given that the magnitude of tuning in a given model is com m only associated with the importance of radiative corrections to H iggs m asseigenvalues. Yet radiative corrections are crucial in all 17 of the possible M SSM con gurations { a fact that should give us pause in its own right.

Even the most \favored" possibility of m<sub>h</sub> ' 115 GeV tends to require some superpartner masses heavier that one might naively expect, in order to obtain the  $(75 \text{ GeV})^2$  radiative correction. In the standard

m SUGRA-based studies [28, 29] one typically needs here either squarks or gluinos in excess of 1 TeV in m ass at the low energy scale, with the latter being a much m ore serious problem for ne-tuning than the form er [30, 32]. M ost of these studies assume vanishing trilinear A -term s, how ever. The degree of tuning can be reduced substantially if the so-called  $\maxim$  alm ixing" scenario can be engineered [13]. In this case, the need for large superpartner m asses is mitigated by m axim izing the loop correction to the lightest H iggs boson m ass from the m  $^2_{\rm LR}$ entry of the stop m ass m atrix. In m odels whose scalar sector is well approximated by an overall universal scalar m ass m<sub>0</sub>, this tends to occur when A<sub>t</sub> ' 2m<sub>0</sub> at the

universality this relation remains approximately correct. To get a sense of how much the ne-tuning in the M SSM Higgs sector can be reduced when maximal mixing is achieved, consider the sole constraint on the M SSM parameter space involving a known, measured quantity

GUT scale [33]. In models with small departures from

where the parameters  $m_{H_D}^2$  and  $m_{H_U}^2$  are meant to be evaluated at the electroweak scale. Through the renormalization group equations these low-scale values can be translated into the high-scale input values of the entire soft supersymmetry-breaking Lagrangian [30, 31]

where all soft terms are understood to be evaluated at the input (GUT) scale in (13).

If we were not to specialize to the case of m inimal supergravity where gaugino and scalarm asses are uni ed to the values m  $_{1=2}$  and m  $_0$ , respectively, then the above equation would simplify to

Note the sizable coe cient for the gaugino mass term, especially in comparison to the relatively small coe cient in front of the scalar mass term. The bulk of these coefficients are coming from the gluino mass and the squark masses, respectively, as can be seen from the original expression (13). The size of the coe cients in (14) would seem to suggest that the result  $m_z = 91$  GeV would be a \reasonable" outcome if the typical size of a soft term was on the order of tens of GeV. But direct searches for

superpartners puts the typical size of these soft term s at 0 (m $_{\rm Z}$ ) or higher. And, as stated above, the requirem ent of a su ciently large radiative correction to the Higgs m ass pushes at least some of these parameters to even larger values. This is the essence of the M SSM ne tuning problem .

The coe cients in (14) are related to the sensitivity parameters  $_{i}$  introduced in the previous section. How - ever, we are more concerned with the cancellations im - plied by (14) required to achieve m<sub>Z</sub> = 91 GeV than with the sensitivity of this outcome to small changes in the masses them selves. In particular, the crux of the ne-tuning problem of the M SSM H iggs sector is that a supersymmetric parameter in the superpotential { the - parameter { must cancel to a high degree of accuracy the large contributions to the Z-boson m ass coming from the soft supersymmetry-breaking Lagrangian. We are thus led to de ne a di erent variable to measure this degree of tuning.

For any given theory of supersymmetry breaking and transmission to the observable sector, each of the quantities on the right hand side of (12) will be determined. In general, however, the value of the -parameter at the input scale will not be { the question of its origin typically requiring some additionalm odel input, such as a singlet which can couple to a Higgs bilinear or the inclusion of a




FIG. 4: E conom ics plot for m SUGRA with  $A_0 = 2m_0$ and tan = 10. The most e cient (least ne-tuned) point in the parameter space consistent with  $m_h = 115$  GeV and all observational constraints is the point of tangency of the H iggs mass contour (heavy solid line) and the contour of constant uning = 75 (dashed line). This point intersects the contour of constant gluino m ass (dotted line) form g = 800 GeV. For com parison we have included contours of constant X t evaluated at the electroweak scale. The shaded region in the lower right is ruled out by having a stau LSP and in the upper left by failure to break electrow eak sym metry.

G indice M asiero term in the K ahler potential. This will be the case, for example, in the string-inspired models we will consider in the next section. We thus introduce the variable de ned schem atically by

where c is the coe cient of the <sup>2</sup> term in (12) and the function f m $_{1}^{2}$ ; M<sub>a</sub>; A<sub>i</sub> represents the term s in the sum – m ation involving the soft Lagrangian parameters. This parameter represents the tuning on <sup>2</sup> at the high-energy scale (in units of the Z-boson m ass) necessary to cancel the contribution from the soft supersymmetry-breaking sector. That is, the ratio ( $=m_{Z}$ )<sup>2</sup> would need to be tuned to roughly one part in to achieve the observed value of the Z-boson m ass. This parameter is very similar to the quantity introduced by Chan, C hattopadhyay and N ath to quantify cancellation in the M SSM Higgs sector [34].

A nm ed with this variable we can safely com pare di erent theories { and di erent points within the param eter space of a single theory { to determ ine the degree of cancellation required to achieve the correct Z-boson mass. For example, in Figure 3 we investigate the tuning im plications of a 115 G eV Higgs mass within the minimal




FIG.5: G huino price plot form SUGRA with m $_0$  = 500 GeV. The necessary gaugino mass m $_{1=2}$  required to achieve m $_{\rm h}$  = 112 GeV and m $_{\rm h}$  = 115 GeV is indicated as a function of the GUT scale value of  $A_0$ =m $_0$  for tan = 10. Note the dramatic reduction in this \price," and the ne-tuning , when  $X_{\rm t}$  = 2:1 for  $A_0$  ' 2m $_0$ . The shaded region along the bottom of the plot is nuled out by direct search constraints on chargino masses from LEP, while the darker shaded region in the lower left corner has inconsistent electroweak symmetry breaking.

supergravity scenario w ith  $A_0 = 0$ . The contour of constant H iggs mass has the fam iliar form of being concave toward the origin. We have overlaid the contours of constant X<sub>t</sub> (determ ined at the electroweak scale), de ned in a manner sim ilar to that of (9) by

where m  $_{t_1}^2$  and m  $_{t_2}^2$  are the values of the lighter and heavier stop m ass eigenvalues, respectively. As anticipated, the case where  $A_0 = 0$  at the GUT scale does not give rise to the m axim alm ixing scenario X t' 2 at the electrow eak scale.

To get a sense of the ne-tuning burden on the parameter in this space we have drawn representative contours of constant tuning . A long the contour where  $m_h = 115 \text{ GeV}$ , the least ne-tuned point is the point of intersection with the contour = 95 at the far left edge of the plot. This intersection occurs at a gluino m ass of 750 G eV and the contourm  $_g = 750 \text{ GeV}$  is given by the dotted line in Figure 3. Note that the m ost \e cient" com bination of soft terms for achieving  $m_h = 115 \text{ GeV}$  occurs for the smallest possible (uni ed) gaugino m ass allowed by LEP bounds on chargino m asses, with a large scalarm ass. This is consistent with the relative coe cients

in (12). These contours are strictly speaking functions of the universal scalar mass m<sub>0</sub> and universal gaugino mass m<sub>1=2</sub>, but we keep in m ind that the key masses are those of the (nunning) gluino mass M<sub>3</sub> and the typical (nunning) squark mass m<sub>q</sub> by including these in the axis labels. We call these plots \economics plots" for their similarity to optimization theory in which one seeks to produce a xed amount of a good (in this case the Higgs mass) while minimizing the accompanying production of a negative externality (in this case ne-tuning).

As the value of the uni ed trilinear coupling  $A_0$  is varied, the location of this optim al point will move in the (m<sub>0</sub>;m<sub>1=2</sub>) plane, sweeping out a locus of optim al points. For example in Figure 4 we display the situation for  $A_0 = 2m_0$  at the GUT scale, again for tan = 10. Note that the optim al point has now moved to an interior solution with moderate gaugino and scalar masses since the contour of constant Higgs mass has developed a convex form. The optim alpoint now occurs for = 75 and a gluino mass of 800 G eV (represented by the dotted contour again). Here the typical size of the mixing parameter X<sub>t</sub> is larger than in Figure 3 with a value very near X<sub>t</sub> = 2 at the optim alpoint, as expected.

The e ect of the m ixing parameter X  $_{\rm t}$  is more dramatically displayed in Figures 5 and 6 for a universal scalar mass of m  $_0$  = 500 G eV and 1000 G eV, respectively. The gaugino mass is now on the vertical axis and

the ratio of A  $_0$  to m  $_0$  at the GUT scale on the horizontalaxis. This translated into a range of values for X  $_{\rm t}$  at the electrow eak scale, given by the thin, solid contours in those plots. The dram atic reduction of GUT-scale gaugino masses (the gluino \price") required to achieve a given H iggs m as value is clearly evident at  $X_t =$ 2:1, corresponding to  $A_0$  ' 2m<sub>0</sub>. The choice of a particular sign for this relation is the result of our conventions on de ning the sign of the -parameter (conventions opposite to those of [20]). Clearly, the ne-tuning inherent in a given model is reduced dram atically when the relation  $A_0$  '  $2m_0$  can be engineered, with important in plications for the accessibility of superpartner m asses at current and future colliders.

# V. MAXIMALMIXING IN STRING SCENARIOS

This relation  $A_0$  '  $2m_0$  is therefore an alluring goal for high-energy m odels, though few well-m otivated m odels seem to naturally predict this relation. In them inim al supergravity fram ework both trilinears and scalar masses are taken as independent variables so no such relation is predicted. In m in im al gauge m ediation the trilinear couplings are negligible in relation to gaugino and scalar m asses [35]. W hile a relation between these two variables is predicted in principle in anom aly mediation, they becom e e ectively free variables once a bulk scalar value is added to the theory to compensate for the negative slepton squared m asses [36, 37]. W hile other solutions to this problem exist, it is this early \m in im al" version of the m odel that was studied as part of the Snowm ass Points and Slopes [23]. Here we prefer to focus on supergravitybased scenarios of a string-theoretic origin with the hope that this added structure will in general provide som e understanding of the relation between scalar masses and soft trilinear couplings at the string or GUT scale.

String-inspired models are identied by the presence of certain gauge-singlet chiral super elds, moduli, whose P lanck-scale vacuum expectation values determine the couplings of the low-energy four-dimensional theory. Thus we imagine that the gauge and Y ukawa couplings of the observable sector are functions of these moduli elds (which we will denote here collectively by  $'^{n}$ ). In addition, we expect the K ahler potential for observable sector matter elds Z  $^{i}$  to also be a function of these moduli and we will denote here

The relation between the tree-level trilinear coupling  $(A_0)_{ijk}$  and the tree-level scalarm ass  $(m_0^2)_i$  at the boundary condition scale is then determ ined by the functional dependence of the various couplings on the moduli. For any supergravity model we have the fundam ental rela-

tions

where  $F^n$  is the auxiliary eld of the chiral super eld associated with the modulus '<sup>n</sup>, m<sub>3=2</sub> is the gravitino mass, W<sub>ijk</sub> is the (generally moduli dependent) Yukawa coupling between observable sector elds and K<sub>n</sub> = @K =@(<sup>n</sup>. A summation over all moduli '<sup>n</sup> which participate in communicating supersymmetry breaking via hF<sup>n</sup>i  $\in$  0 is implied in (18). For a fuller description of soft terms in a general supergravity theory, as well as the string models we will present below, the reader is referred to the Appendix.

Neglecting possible D-term contributions to the scalar potential, the value of the potential in the vacuum is given by

where a sum mation over moduli is again implied and  $K_{nn} = 0^2 K = 0'^n 0^{-n}$ . Requiring that this contribution to the cosm obgical vacuum energy vanish leads to a relation between the gravitino m ass and the supersymmetry breaking scale governed by the various hF<sup>n</sup> i. For the remainder of this section we will investigate various string scenarios using the general expressions in (17) and (18) to search for cases where A<sub>0</sub> ' 2m<sub>0</sub> can be obtained.

## A. Naive dilaton dom ination

The simplest string-based scenario is the case of dilaton dom ination. For the weakly-coupled heterotic string the gauge couplings of the low-energy theory are determined by the vacuum value of a single modulus eld, the dilaton S. This eld does not participate in the Yukawa couplings or the observable sector K ahlerm etric (17). By dilaton dom ination we refer to a situation in which this is the only modulus whose auxiliary eld gets a nonvanishing vacuum value. The tree level K ahler potential for the dilaton is simply K (S;  $\overline{S}$ ) =  $\ln(S + \overline{S})$  and thus the dilaton dom ination scenario is a natural realization of the special case

This string-inspired scenario has been studied at length in the literature [38, 39, 40, 41]. It is a special case of the m in in al supergravity scenario with the following soft term s

where we have chosen conventions such that gaugino m asses are positive. If we take the input string scale str to be the same as the GUT scale, neglecting the small di erence between these two scales [42] we arrive at the fam ous relation among the soft term s m  $_{1=2} = A_0 = \frac{P}{3m_0}$ . As this model is a subclass of m SUGRA models we can study it in the same way we studied the general cases of Section IV.

For example, in Figure 7 we plot the same parameter space as Figures 3 and 4 for tan = 10. The dilaton dom ination assumption requires the theory to lie on the locus of points identi ed by the heavy dashed line, where  $X_t$  ' 1;3 at the electroweak scale. In this model, with  $3m_0$  the optim algoint that gives rise to  $m_h =$  $A_{0} =$ 115 GeV is the point labeled by (A) with tuning = 84and gluino m ass m  $_{q}$  = 875 G eV (the inside contours of the heavy and light shaded regions, respectively). The only way to achieve this Higgs mass value in the dilaton dom ination scenario is to be at point (B) with a slightly greater am ount of ne-tuning = 100 but a m uch heavier gluino mass  $m_{q} = 1153 \text{ GeV}$  (the outside contours of the heavy and light shaded regions, respectively). W hile the optim alpoint cannot be reached, the topology of the Higgsmass contour is what we expect as we approach the




FIG.8:G luino price plot for dilaton dom ination w ith m<sub>0</sub> = 280 GeV. The subset of points for which  $A_0 = m_0 = -3$  as in the dilaton dom ination scenario are given by the vertical dashed line. At intersection of this contour with the contour for  $m_h = 115$  GeV we have X<sub>t</sub> ' 1:3 and = 100. The dotted horizontal line is a gluino m ass of  $m_g = 1150$  GeV. For low er Higgs m asses the dilaton dom ination scenario m oves closer to the optim alpoint in the low er left corner where X<sub>t</sub> ' 2:2. The excluded shaded regions are the same as Figure 5.

maximal mixing scenario, and this represents a general improvement in the netuning overall in this model.

Nevertheless, the dilaton domination scenario moves further from the optim alpoint as the Higgs mass constraint increases. In Figure 8 we present the analogous plot to Figure 5, with the restricted space of the dilaton dom ination paradigm indicated by the dashed vertical line. At lower Higgs mass values the necessary gluino mass is smaller, resulting in less ne-tuning and the optim alvalue of X t needed to achieve the maxim alm ixing scenario approaches the value dictated by the soft-term constraints of this model. Som e marginal improvement in ne tuning can, of course, be obtained by increasing the value of tan beyond the value studied in Figures 7 and 8. For example, in Figure 9 we display the entire parameter space for this model, de ned as it is by tan and one overallm ass scale, which we take to be the scalarmass.Fortan = 10 we see that  $m_h = 115 \text{ GeV}$  requires  $m_{q} = 1150 \text{ GeV}$  at the electroweak scale (the top contour of the horizontal shaded region) as before. At the maxim al value of tan for this Higgs mass allowed by the requirem ent of a neutral lightest supersymm etric particle (LSP), speci cally  $\tan = 32$ , the gluino mass can be lowered to 975 GeV (the bottom contour of the horizontal shaded region).

So we conclude that the generic point in the parameter space of this string-m otivated scenario involves less can-

In the lim it where only this overall Kahler modulus breaks supersymmetry (i.e. only  $F^{T} \in 0$ ) the scalar m asses take the tree-level form

where we have employed the second line of (18) and again assumed vanishing vacuum energy at them inim um . Note that in this Kahler modulus-dom inated lim it, when the modular weight of a eld takes the value  $n_i =$ 1, then the scalar m ass vanishes at this order. For values  $n_i =$ 

2; 3, etc. the scalarm asses are in aginary at the input scale. W hen the scalar mass vanishes at the tree level we must compute the one-loop correction to the tree-level value in the supergravity theory. This calculation has been perform ed [44, 45] and the leading correction in this lim it is given by  $(m_1^2)_i = (m_0^2)_i + m_i^2$  with  $m_i^2 = im_{3=2}^2$ .

In order to determ ine the trilinear A-terms in this fram ework we must know the dependence of the Yukawa couplings of the observable sector on the Kahlerm oduli. These can be obtained from symmetry aroum ents inherited from the underlying string theory and have been veried by direct computation [46, 47]. They involve the Dedekind function

The Kahler potential for the (overall) modulus T is given by K  $(T;T) = 3\ln(T + T)$  so that the two terms in the rst line of (18) com bine to form



and t is the lowest component of the chiral super eld T.

The last quantity we need is the soft gaugino mass for the three observable sector gauge groups. As m entioned above, at the leading order the gauge kinetic function for all gauge groups in the weakly coupled heterotic string is simply the dilaton S. Therefore, in the Kahler m odulus-dom inated regim e the gaugino m asses vanish at

cellation in the relation (11) for a given Higgs m ass than a generic point in the full m SUGRA parameter space. But the tuning is still sizable and the model requires a relatively large gluino mass. This latter problem can be remedied by invoking a dierent modulus eld from the string theory to perform the role of transmitting the supersymm etry breaking from a hidden sector to the observable sector.

## B. Nonuniversalm odular weights

W hile the kinetic functions of observable sector matter elds are typically not functions of the dilaton { at least in the case of the weakly coupled heterotic string { they typically are functions of the so-called K ahler m oduli T  $^{
m I}$ whose vacuum values determ ine the size of the compact space. In what follows we will assume, for the sake of sim plicity, that observable sector quantities depend only on a single overall modulus T. At the leading order the functional dependence of the Kahlerm etric for the elds Z<sup>i</sup> on this modulus is given by

where  $n_i$  is referred to as the modular weight of the eld Z<sup>i</sup>. These weights depend on the sector of the string




FIG.10: P aram eter space for the m oduli dom ination scenario w ith  $n_{H_u} = n_{H_u} = 2$  and  $\tan = 10$ . The large shaded area m arked  $m_A^2$  has an imaginary pseudoscalar m ass and is nuled out. The shaded area in the upper right m arked  $m_{f'}^2$  has an imaginary running m ass for one orm ore third-generation scalar ferm ions. The shaded area in between these two regions is nuled out as at least one physical m ass eigenstate for the scalar ferm ions is imaginary due to m ixing e ects. The region of the param eter space exam ined in Figure 11 is m arked by the vertical arrow at hR e T i = 2:8.

the leading order at the string scale. At the one-loop level the corrections to the gaugino masses involve the K ahler m oduli and take the form [48]

 $b_a$  is the beta-function coe cient for the group  $G_a$  with  $b_a = 3C_a$   $_iC_a^i$ , and  $_{gs}$  is the coe cient of the G reen-Schwarz counterterm introduced to restore modular invariance to the theory [49, 50, 51]. For the purposes of this section it is only necessary to know that this parameter is calculable from the underlying orbifold compactication and is a negative integer in the range  $_{gs} 2$  [0; 90]. Details on the origin of these expressions can be found in the Appendix.

The appearance of new free param eters, such as  $_{gs}$  and the various m odular weights  $n_i$ , as well as the m odular functions  $G_2$  (t;t) and (t + t) $G_2$  (t;t), would seem to indicate a greater degree of freedom in relating the scalar m asses to the trilinear scalar couplings. O flen in the literature this \m oduli-dom inated" regime is studied in the limit where  $n_i = 1$  for all elds. This would be the case, for example, if all observable sector m at-

ter were untwisted states of the underlying string theory. This limit was referred to as the  $\0-II$ " model in [38]. In fact, explicit surveys of sem i-realistic orbifold models [52] indicate that at least some subset of M SSM elds must be given by twisted-sector states for which

 $n_1 = 2; 3; \ldots$  This case was referred to as an 0 - I'' model in [38].




FIG.11: E conom ics plot for the m oduli dom ination scenario with  $n_{\rm H_{\,U}} = n_{\rm H_{\,U}} = 2$ . Despite the relatively large trilinear coupling A<sub>t</sub> the low-energy soft Lagrangian for this m odel is essentially a m inim al-m ixing scenario. The dotted line represents the contour m<sub>g</sub> = 2400 G eV. D epending on the value of the G reen-Schwarz coe cient, the cancellation coe cient lies in the range 375 1200 for m<sub>h</sub> = 115 G eV. The shaded region at the bottom of the plot is nuled out by direct search lim its for gluinos and/or charginos.

But when  $j_{ij} > 1$  in this modulus-dom instead lim it the corresponding scalar mass squared is negative. We m ight not consider this a troubling feature of the m odel if it is one or more of the Higgs scalar masses that are im aginary at the string scale. For example, if we consider the case  $n_{H_u} = 2; n_{Q_3} = n_{U_3} = 1$ , then the eld  $H_u$  will have a negative squared mass of 0 (m  $\frac{2}{3=2}$ ), the top quark trilinear coupling At will also be negative and of 0 (m  $_{3=2}$ ) while the gaugino m asses and squark m asses will be smaller by roughly an order of magnitude. Can such a set of boundary conditions give rise to a reasonable low-energy spectrum of soft term s? We surveyed the three cases  $(n_{H_{u}}; n_{H_{d}}) = (2; 1); (1; 2), and$ (2; 2) but found only the last case had any viable param eter space. This is hardly surprising, since the rst two cases give rise to large hypercharge D-term contributions to the RG evolution of scalar quarks and leptons, causing at least som e set of these elds to develop negative squared m asses at the electrow eak scale and thereby presum ably triggering the spontaneous breaking of color and electric charge. The viable parameter space in the  $(g_s;hReTi)$  plane for the case  $(n_{H_u};n_{H_d}) = (2; 2)$  is given in Figure 10.<sup>4</sup> The large shaded region labeled m  $_{\rm A}^2$ gives rises to an im aginary pseudoscalarm ass at the electroweak scale. In the upper right shaded region labeled in aginary at the low -energy scale. A representative slice of the remaining allowed parameter space, represented by the vertical double-arrow in Figure 10 is plotted in Figure 11.

Despite the fact that the top-quark trilinear coupling (and indeed, all third-generation trilinear couplings) are large relative to the typical squark and slepton m ass, this model ows in the infrared to a minim al-mixing scenario at low energies. The typical size of X<sub>t</sub> in Figure 11 is 0:3 X 0:3. The contours of constant Higgs mass nearly track those of constant gluino m ass: for exam ple, the contour  $m_h = 115 \text{ GeV}$  lies very near the contour  $m_{g} = 2400 \text{ GeV}$  . As the value of  $g_{s}$  increases, the absolute value of the gluino m ass increases as well, allowing the same value of m<sub>h</sub> for a low eroverall scale of soft term s { and hence a sm aller am ount of ne-tuning at the electroweak scale. Yet given the string/GUT scale relation  $\ensuremath{\mathfrak{m}_{3=2}^2}$  , the large m ass scale necessary to ensure m <sup>∠</sup><sub>H µ</sub> su ciently large gaugino m asses puts enorm ous pressure on the high-scale value of the parameter to compensate

the large positive contribution to  $m_z^2$  in (13). Far from improving the situation of the generic m SUGRA model, this lim it in the string moduli space is as ne-tuned as the worst of the models in Table V II.

## C. A model based on D-branes at intersections

The previous two string-based scenarios derived from the weakly coupled heterotic string. It m ight be thought that the inability to easily obtain the maxim alm ixing scenario in the Higgs sector is the result of the restrictive nature of these m odels. The m oduli sector of open string m odels is far richer than the heterotic string, with m ore ekls appearing in each of the three functions relevant to the low energy supergravity Lagrangian: the observable sector gauge kinetic functions, the K ahler m etric for the M SSM ekls and the Y ukaw a couplings of the observable sector superpotential.

For example, in orientifold compactications of Type I/Type IIB string theory { close relatives to the orbifold compactication of the heterotic string studied above { Kahlermodulinow appear at the leading order in gauge kinetic functions, while the dilaton eld can appear in the Kahler potential for the MSSM elds [53, 54]. The study of four-dimensional elective supergravity Lagrangians representing these theories is a subject of ongoing research. Many of the early studies, such as [26], were ultimately based on the well-known results of the weakly-coupled heterotic string with duality symmetries invoked

to m ap those results to the open string theory in the case Type I and Type IIB m odels. Not surprisingly, then, these e ective Lagrangians sharem any of the same structures and features of their heterotic counterparts. W hile it is now possible to study in greater detail the full richness of open string m odels, we prefer to restrict ourselves to a particularly simple con guration which closely resembles the m odels we studied above and leave a m ore com plete survey to future work.

Let us consider a particular con guration of Type IIB theory compactied on an orientifold with intersecting D 5-branes. The world volum e of these extended objects is six-dim ensional and is assumed to span 4D M inkowski space plus two of the six compact dimensions. The six dim ensional com pact space is assumed to factorize into three compact torii, each with a radius dictated by the vacuum value of an associated Kahlerm odulus T<sup>I</sup>. We then associate each of the sets of D 5 branes with a particular torus in the com pact space spanned by its world volum e with associated m odulus T<sup>I</sup>. As the gauge coupling on each stack of D 5 branes is determ ined by the vev of the associated T<sup>I</sup>, we will assume, for the sake of sim plicity, that the inverse radii of all the com pact torii are the sam e and that all three moduli participate equally in supersym m etry breaking. Then gaugino m asses will be uni ed at the boundary-condition scale as well:  $M_1 = M_2 = M_3$ .

So far this is similar to the dilaton-dominated scenario of the heterotic string theory. The novelty in this case is that the M SSM matter content is represented by open strings which can connect sets of 5-branes whose world volumes span di erent com plex compact dimensions. Fields represented by the massless modes of these strings will be denoted by two subscripts. For example, a eld Z<sup>i</sup> which is the massless mode of a string that stretches from a set of branes  $S_{\rm I}$  to a non-parallel set  $S_{\rm J}$  will be written Z<sup>i</sup><sub>IJ</sub>. For these elds the Kahler potential is given by (17) where

and the particular K ahlerm odulus  $T^{K}$  is identied by the requirement that  $I \notin J \notin K \notin I$  [26]. The K ahler potential for the moduli elds continues to be given by the leading-order form  $K = \ln(S + \overline{S}) \prod_{I=1}^{P_{3}} \ln(T^{I} + \overline{T}^{I})$ . Following [26] we take the Yukawa couplings of the observable sector to be independent of these moduli elds at the leading order. A particularly simple model is obtained when all MSSM elds are represented by such stretched strings { a case we will call the \universally stretched" regime. When the K ahler moduli have equal vacuum values (as we assumed above) and participate equally in supersymmetry breaking, the soft terms for




FIG. 12: E conom ics plot for the Type IIB brane m odel with universally stretched strings. The subspace of the m SUGRA m odel with the soft terms given in (31) is denoted by the labeled dashed line. The sim ilarity of this plot to the dilaton-dom inated m odel of Figure 7 is the result of our insistence upon gauge coupling uni cation at the string scale. An optim al scenario for a 115 G eV H iggs m ass would be the point labeled (A), but this brane m odel only allow s us to be at point (B) to satisfy this constraint. The di erence in tuning parameter is given by the dark shaded region, bounded on the interior by = 70 and on the exterior by = 90. The di erence in gluino m asses is even m ore profound, represented by the light shaded region bounded by m  $_{\rm q}$  = 750 G eV on the left and m  $_{\rm q}$  = 1050 G eV on the right.

To obtain (31) we once again used the assumption that the scalar potential has vanishing vacuum value. Note that this is a special case of the general m SUGRA paradigm, but in this case  $A_0 = 3 = 2m_{3=2}$  and thus the universally stretched regime represents a potential im provement in tuning over the dilaton dom inated lim it.

C om paring the econom ics plot of this model in Figure 12 with that of the dilaton dom ination model of Figure 7 it is clear that there is an in provement in the netuning, but that this in provement is small. The bous of points in the m SUGRA parameter space that are consistent with (31) are given by the labeled dashed line. The optimal point for  $m_h = 115 \text{ GeV}$  in Figure 12 is in nearly the same location in the ( $m_{1=2}$ ;  $m_0$ ) plane as in Figure 7, with  $= 70 \text{ and } m_g = 750 \text{ GeV}$ . But the contours of constant tuning parameter have moved inwards towards the origin, rejecting the increased value

of X<sub>t</sub> at the electroweak scale. As a result, the required low-scale gluino m ass at the point where the dashed line and m<sub>h</sub> = 115 G eV contour intersect is m<sub>g</sub> = 1050 G eV with = 90 there.

As in the dilaton dom inated case we conclude that tuning in the electroweak sector is generally mitigated in the universally stretched model relative to a generic point in the m SUGRA parameter space due to the relation between trilinear scalar couplings and scalar masses at the high scale. Yet we are still left with uncom fortably heavy gauginos (especially gluinos) and the constrained nature of the paradigm will not allow us to reach the <code>\optim al"</code> point for achieving m<sub>h</sub> = 115 GeV while simultaneously ensuring m<sub>z</sub> = 91 GeV.

#### D. M ore sophisticated m odels

So farwe have chosen to look at three particularly sim ple directions in the string moduli space. We have done so in part to keep the level of technical detail low { a beginning approach we feel is justiled in a rst examination of the theoretical implication of the LEP Higgs search. But there is also a reason of analytical simplicity: the key variable in achieving the maximal Higgs mass with the least cancellation in (11) is the value of the stop m ixing parameter X  $_{\rm t}$  at the electroweak scale. On the other hand, models of supersymmetry breaking and transmission to the observable sector descended from string theory give relations am ong soft term s at a very high energy scale. The two can be related in a straightforward man- $2m_0$  at the GUT scale in plies X t. ' ner (i.e.  $A_0$  ' 2 at the Z-m ass) only in certain restrictive regimes, such as a modelwith a high degree of universality among soft scalarm asses. Departures from the sim plifying assumptions m ade above will necessarily lead to nonuniversalities in the scalar sector and a much fuller analysis is necessary to determ ine how readily X  $_{
m t}$  ' 2 is achieved at the low scale. We do not wish to perform that analysis here, but we do wish to comment on what types of models might allow the freedom necessary to reach the maxim alm ixing scenario.

In subsections B and C we im agined scenarios in which Kahlerm odulidom inate the supersymmetry breaking in the observable sector { moduli which appear in the treelevel Kahler metric for matter elds. When we study top-down models directly tied to the underlying string theory we in agine this functional dependence to be that of (22) with  $n_i =$ 1; 2; 3 for weakly coupled heterotic models on orbifolds or  $n_i = 0; 1=2;$ 1 for Type I/IIB models on orientifolds. The restrictive nature of these choices kept us from realizing a phenomenologically optim al scenario. However, if it were possible to treat these m odular weights as arbitrary { even continuous parameters { it would not be at all di cult to construct situations with the desired properties. To what extent is such a treatm ent justi ed?

As m entioned previously, the modular weights are re-

lated to what sector of the string H ilbert space each light eld arises from . Just below the string scale, when the four dimensionale ective Lagrangian is rst de ned, these weights are indeed constrained to the values mentioned above. However, in the weakly coupled heterotic string we are compelled to make sure that our elective Lagrangian respects modular invariance. This symmetry should continue to hold even after any anom alous U (1) factor is integrated out of the theory. Thus, elds which take vacuum values to cancel the anom alous U (1) F I term must be removed from the theory in modular invariant (and U (1) invariant) combinations. For example, if the eld Y carries anom alous U (1) charge  $q_{\rm Y}^{\rm X}$  and acquires a vacuum value hY i  $\stackrel{6}{\bullet}$  0, then the appropriate combination

where  $V_X$  is the vector super eld representing the anom alous U (1) and  $n_Y$  is the modular weight of the eld Y.

to integrate out of the theory is [55, 56]

The result of rem oving this combination of elds from the theory is to shift the elds edular weight of the remaining light elds, if those elds also carry an anom alous U (1) charge. The amount of this shift is given by

where  $q_i^X$  is the anom abus U (1) charges of the light eld in question. Given the typical sizes of these charges [52] there is every reason to expect that the resulting m odular weights, if modi ed at all, will take quite unorthodox and generally non-integral values. The question of whether this e ect will produce the desired relation between Aterm s and scalar masses { and indeed, whether it occurs at all { is a model-dependent one.

A nother way to generalize the above cases is to modify the functional dependence of the Yukawa couplings and Kahler metrics of the MSSM elds on the various string moduli. For example, strongly coupled heterotic strings bring the dilaton into play even at the tree level for these quantities, while the Kahler moduli appear at the leading order in gauge kinetic functions. Even in the weakly coupled case it is possible to introduce som e nontrivial dilaton dependence into A -term s and scalarm asses if observable sector m atter couples to the G reen-Schwarz anom aly-cancellation term [57]. If the GS counterterm depends on the radii of the three com pact torii via the  $_{i}$   $Z_{i}^{I}$ , where  $Z_{i}^{I}$  is a matter combination  $(T^{I} + \overline{T}^{I})$ eld which carries a modular weight under the modulus T<sup>I</sup>, then even in the dilaton-dom inated lim it there is an e ect on the soft supersymmetry breaking terms due to the kinetic mixing induced by the Green-Schwarz counterterm .

Finally, we might expand the space of possible outcom es by considering models with a richer moduli spectrum to begin with. The orbifold models that inspired the cases A and B above were based on the  $Z_3$  orbifold,

for which the complex structure of the compact space is completely xed by the supersymmetry requirements. As such, it does not have free parameters that would be represented in the low-energy four dimensional theory as complex structure moduli. Such elds do appear, however, in the leading order supergravity e ective Lagrangian describing other orbifold models of the heterotic string [43], as well as models based on open string theories. For example, in the Type IIA models the gauge kinetic functions depend on complex structure moduli, with the Kahlerm oduli appearing only at the loop level to cancel anom alies [58, 59]. This is analogous to the introduction of Kahler moduli into the formula for the gauginom asses at the loop level in the heterotic string by the presence of a G reen-Schwarz counterterm (c.f. equation 28 above). The open string model studied in case C above was chosen for its extrem e sim plicity, as a rst departure from the con nes of the weakly-coupled heterotic case. But much more complicated structures are likely to appear in more realistic constructions. At the loop level in Type I/IIB m odels anom aly cancellation requirem ents introduce new twisted m oduli into the gauge kinetic functions: the \blow ing-up" m odes which param eterize the transition from the singular manifold represented by the orientifold to the presum ably m ore realistic sm ooth m anifold it is m eant to approxim ate [60, 61]. Thus in open string m odels we m ight expect greater freedom to nd cases where A  $_0$  ' 2m<sub>0</sub> is a robust prediction. It would be of great interest to search the (generally non-universal) models based on orientifold compacti cation of Type I/Type II string theory for points where  $m_Z = 91 \text{ GeV}$  appears as a natural outcom e of the supersymmetry breaking as the elective Lagrangians describing these models become more realistic.

## C on clusion

W e began this work asking the question,  $\W$  here do we stand after LEP II?" A coepted w isdom following the lack of a Higgs discovery at LEP has been that if the M SSM is the correct description of nature just above the electroweak scale then the lightest Higgs boson is at least 115 G eV in m ass and very Standard M odel-like in its properties. It is further generally accepted that this in plies an uncom fortable level of ne-tuning in the underlying supersymmetric Lagrangian, though precisely how m uch and how unsettling is a somewhat subjective matter. Is this post-LEP conclusion inevitable?

To answer this we boked at the data to nd all the logically distinct ways that the M SSM can be a correct description yet produce no H iggs discovery at LEP. In total we found 17 such possibilities { representing the prim ary purpose behind this work. The majority of these cases involve H iggs bosons with masses below the 115 G eV lim it, though the parameter space for each of these models are generally not of the same size. W hile all cases are logically on an equal, a priori footing not all are equally \tuned." W hen the issue of large cancellations between soft Lagrangian param eters and the param eter are included in the comparison, the conventionalwisdom of the post-LEP electroweak sector is seen as the most \plausible" outcom e.

G iven this hypothesis { based as it is on ne-tuning as a tool { what are the LEP results telling us about highscale theories? Can we follow our nose and light upon a preferred outcom e? From the bottom -up approach it is quite easy to engineer situations where the relation A<sub>0</sub> ′  $2m_0$  arises at high energy scale. The di culty is in nding such a construction that is also motivated by an underlying theory such as string theory. Starting here with some simple top-down approaches it appears that this preferred m odel is not yet obvious. So if we are com m itted to weak scale supersym m etry as a low -energy e ective Lagrangian derived ultimately from some sort of string theory, then we nd ourselves at a fork in the road. Should nature really be described by the minimal supersymm etric version of the Standard M odel then LEP m ay be suggesting a m ore com plicated string m odel than the simple ones we typically study { or perhaps special points in the moduli space of these theories. On the other hand, it may simply be that the ultim ate supersymmetric Standard M odel is not m in im al { see, for example, Ref. [67]. This would not be surprising as we often nd precisely such extended theories from top-down studies of string m odels.

If ne-tuning is really a worthwhile concept for the theoretical physicist, then its utility lies in directing our focus tow ands those theories that are most compatible with nature when data is lacking or am biguous. In this role the LEP data can still serve a valuable purpose, despite the lack of a Higgs discovery. A ssum ing that an appropriately de ned measure of ne-tuning is truly telling us som ething about nature, then studies which probe wellde ned departures from the minimal model can utilize the LEP data to identify promising avenues for further research

# Appendix

In this appendix we present the derivation of the soft supersymmetry breaking terms at the tree level in string-derived supergravity theories. We provide special expressions for modular invariant supergravity theories from weakly-coupled heterotic strings, as well as expressions for models based on orientifold compactication of Type-I/Type-IIB open string theories. More details and loop corrections to these expressions for the weakly-coupled heterotic string can be found in [45].

O fparticular in portance for the question of supersym m etry breaking are the types of string m oduli present in the low -energy theory and their couplings to the observable elds of the M SSM [49, 62, 63]. G augino m asses w ill depend on auxiliary elds related to m oduli appearing in the gauge kinetic function, while scalar m asses, trilinear A -term s and bilinear B -term s will depend on auxiliary elds related to those m oduli that appear in the superpotential couplings and/or K ahler potential for the M SSM elds [38, 64]. The precise form of these soft term s can be obtained by working out the component Lagrangian for the observable sector by standard techniques [65, 66].

We begin with the weakly coupled heterotic string and take the Kahlerpotential for the moduli elds to be given by the leading-order result

For the observable sector matter elds Z<sup>i</sup> with modular weights  $n_i^I$ , we will assume a diagonal K ahler metric given by K<sub>ij</sub> =  $_i(Z^n)_{ij} + O(\mathcal{Z}^{ij})$ , with

W e willadopt the ansatz of B rignole et al. [38] in which one assumes that the communication of supersymmetry breaking from the hidden sector to the observable sector occurs through the agency of one of the moduli { in this case either the dilaton S or the (universal) K ahler modulus T { by the presence of a non-vanishing vacuum expectation value of their auxiliary elds F <sup>S</sup> or F <sup>T</sup>. In principle both types of moduli could participate in supersymmetry breaking, and so one might introduce a G oldstino angle to parameterize the degree to which one sector or the other feels the supersymmetry breaking.

If these are the only sectors with non-vanishing auxiliary elds in the vacuum, then the further requirement that the overall vacuum energy at the minimum of the potential (38) be zero allows us to immediately identify (up to phases, which we will set to zero in what follows)<sup>6</sup>

The soft supersymmetry breaking terms depend on the moduli dependence of the observable sector superpotential and this is, in turn, determined by modular invariance. The diagonalmodular transformations

This symmetry is perturbatively valid to all orders in the underlying theory, but is anom abus at the bop level in the elective supergravity Lagrangian. To restore modular invariance the elective theory must contain a Green-Schwarz counterterm. In the chiral multiplet form ulation we are using to describe the dilaton this amounts to a modi cation of the dilaton K ahler potential from in (34) to read instead
