Relic density of dark matter in brane world cosmology

## Abstract

We investigate the therm all relic density of the cold dark matter in the context of the brane world cosm ology. Since the expansion law in a high energy regime is modified from the one in the standard cosm ology, if the dark matter decouples in such a high energy regime its relic number density is a ected by this modified expansion law. We derive analytic formulas for the number density of the dark matter. It is found that the resultant relic density is characterized by the \transition temperature" at which the modified expansion law in the brane world cosmology is connecting with the standard one, and can be considerably enhanced compared to that in the standard cosmology, if the transition temperature is low enough.

Recent various cosm ological observations, especially W M AP satellite [1], have established the CDM cosm ological model with a great accuracy, where the energy density in the present universe consists of about 73% of the cosm ological constant (dark energy), 23% of non-baryonic cold dark matter and just 4% of baryons. However, to clarify the identity of the dark matter particle is still a prime open problem in cosmology and particle physics. Many candidates for dark matter have been proposed. Among them, the neutralino in supersymmetric models is a suitable candidate, if the neutralino is the lightest supersymmetric particle (LSP) and the R-parity is conserved [2].

In the case that the dark m atter is the therm al relic, we can estim ate its number density by solving the Boltzm ann equation  $[\beta]$ ,

with the Friedmann equation,

$$H^{2} = \frac{8 \text{ G}}{3} ; \qquad (2)$$

where H  $\underline{a}$ =a is the Hubble parameter with a(t) being the scale factor, n is the actual number density,  $n_{EQ}$  is the number density in them all equilibrium, h vi is the them all averaged product of the annihilation cross section and the relative velocity v, is the energy density, and G is the Newton's gravitational constant. By using  $\underline{\ } = 4H = 4 = T + g = g$ , where g is the elective total number of relativistic degrees of freedom, in terms of the number density to entropy ratio Y = n=s and x = m=T, Eq. (1) can be rewritten as

if g=g is almost negligible as usual. As is well known, an approximate formula of the solution of the Boltzmann equation can be described as

with a constant = xs=H =  $0.26 (g_S = g^{1-2}) M_P m$  for models in which h vi is approximately parameterized as h vi =  $_0 + _1 x^1 + _0 (x^2)$ , where  $x_d = m = T_d$ ,  $T_d$  is the decoupling temperature and m is the mass of the dark matter particle, and  $M_P$  '  $1.2 10^9 G$  eV is the P lanck mass.

Recently, the brane world models have been attracting a lot of attention as a novel higher dimensional theory. In these models, it is assumed that the standard model particles are

con ned on a \3-brane" while gravity resides in the whole higher dimensional spacetime. The model rst proposed by R and all and Sundrum (RS) [4], the so-called RS IIm odel, is a simple and interesting one, and its cosmological evolution have been intensively investigated [5]. In the model, our 4-dimensional universe is realized on the 3-brane with a positive tension located at the ultra-violet boundary of a ve dimensional Anti de-Sitter spacetime. In this setup, the Friedmann equation for a spatially at spacetime in the RS brane cosmology is found to be

with M  $_5$  being the vedimensional Planck mass, the third term with a integration constant C is referred to as the \dark radiation", and we have omitted the four dimensional cosmological constant. The second term proportional to  $^2$  and the dark radiation are new ingredients in the brane world cosmology and lead to a non-standard expansion law.

In this paper, we investigate the brane cosm ologicale ect for the relic density of the dark matter due to this non-standard expansion law. If the new term s in Eq. (5) dominates over the term in the standard cosm ology at the freeze out time of the dark matter, they can cause a considerable modication for the relic abundance of the dark matter as we will show later.

Before turning to our analysis, we give some comments here. First, the dark radiation term is severely constrained by the success of the Big Bang Nucleosynthesis (BBN), since the term behaves like an additional radiation at the BBN era [6]. Hence, for simplicity, we neglect the term in the following analysis. Even if we include non-zero C consistent with the BBN constraint, we cannot expect the signicant elects from the dark radiation since at the era we will discuss the contribution of the dark radiation is negligible. The second term is also constrained by the BBN, which is roughly estimated as  $_0^{1-4} > 1 \text{ MeV}$  (or M  $_5 > 8.8 \text{ TeV}$ ). On the other hand, more sever constraint is obtained by the precision measurements of the gravitational law in sub-millimeter range. Through the vanishing cosmological constant condition, we note  $_0^{1-4} > 1.3 \text{ TeV}$  (or M  $_5 > 1.1 \text{ 10}^6 \text{ GeV}$ ) discussed in the original paper by Randall and Sundrum [4]. However note that this result, in general, is quite model dependent. For example, if we consider an extension of the model so as to introduce a bulk

scalar eld, the constraint can be moderated as discussed in [7]. Hence, hereafter we impose only the BBN constraint on  $_{0}$ .

We are interested in the early stage in the brane world cosmology where the  $^2$  term dom inates, namely,  $^2$ =  $_0$  . In this case the coupling factor of collision term in the Boltzmann equation is given by

with a temperature independent constant de ned as

where a new tem perature independent parameter  $x_t$  is defined as  $x_t^4 = \frac{1}{0} \frac{1}{2} = m$ . Note that the evolution of the universe can be divided into two eras. At the era  $x = x_t$  the  $x_t^2$  term in Eq. (5) dominates (brane world cosmology era), while at the era  $x_t^2$  the expansion law obeys the standard cosmological law (standard cosmology era). In the following, we call the temperature defined as  $T_t = m x_t^{-1}$  (or  $x_t^{-1}$  itself) \transition temperature" at which the evolution of the universe changes from the brane world cosmology era to the standard cosmology era. We consider the case that the decoupling temperature of the dark matter particle is higher than the transition temperature. In such a case, we can expect a considerable modication for the relic density of the dark matter from the one in the standard cosmology.

At the brane world cosm ology era the Boltzm ann equation can be read as

Here, for sim plicity, we have parameterized the average of the annihilation cross section times the relative velocity as h vi =  $_n$ x  $^n$  with a (mass dimension 2) constant  $_n$ . Note that, in the right-hand side of the above equation,  $x^2$  in the standard cosmology is replaced by the constant  $x_t^2$ . At the early time, the dark matter particle is in the thermal equilibrium and Y tracks  $Y_{EQ}$  closely. To begin, consider the small deviation from the thermal distribution =  $Y_{EQ}$   $Y_{EQ}$ . The Boltzmann equation leads to

where we have used an approximation formula  $Y_{E\,Q}=0.145\,(g=g_S)x^{3=2}e^x$  and  $dY_{E\,Q}=dx$  '  $Y_{E\,Q}$ . As the tem perature decreases or equivalently x becomes large, the deviation relatively grows since  $Y_{E\,Q}$  is exponentially dumping. Eventually the decoupling occurs at  $x_d$  roughly evaluated as  $(x_d)$  '  $Y_{E\,Q}$   $(x_d)$  , or explicitly

At further low temperature, 'Y Y  $_{EQ}$  is satisfied and  $Y_{EQ}^2$  term in the Boltzmann equation can be neglected so that

The solution is formally given by

For n = 0 (S-wave process), n = 1 (P-wave process), and n > 1 we nd

respectively. Note that  $(x)^{-1}$  is continuously growing without saturation for n-1. This is a very characteristic behavior of the brane world cosm ology, comparing the case in the standard cosmology where (x) saturates after decoupling and the resultant relic density is roughly given by Y (1)' Y  $(x_d)$ . For a large  $x-x_d$  in Eq. (14),  $(x_d)$  and  $x_d$  can be neglected. When x becomes large further and reaches  $x_t$ , the expansion law changes into the standard one, and then Y obeys the Boltzmann equation with the standard expansion law for  $x-x_t$ . Since the transition temperature is smaller than the decoupling temperature in the standard cosmology (which case we are interested in), we can expect that the number density freezes out as soon as the expansion law changes into the standard one. Therefore the resultant relic density can be roughly evaluated as Y  $(1)'-(x_t)$  in Eq. (14). In the following analysis, we will show that this expectation is in fact correct.

Now, we derive analytic form ulas of the nal relic density of the dark matter in the brane world cosmology. At low temperature where 'YY  $Y_{EO}$  is satisfied, the Boltzmann

equation is given by

and the solution is formally described as

For n = 0, the integration is given by the elliptic integral of the rst kind such as

where the elliptic integral of the rst kind F (;k) is de ned as

In the  $\lim_{x \to \infty} x \le 1$ , we obtain (with appropriate choice of the phase in F (;k))

In the case of  $x_d$   $x_t$ , the integration gives '  $1.85=x_t$ , and we not the resultant relic density Y (1 )'  $0.54x_t=(\ _0)$ . Note that the density is characterized by the transition temperature  $x_t$  as we expected. By using the well known formula (4), for a given h vi, we obtain the ratio of the energy density of the dark matter in the brane world cosmology ( $\ _{(b)}$ ) to the one in the standard cosmology ( $\ _{(s)}$ ) such that

where  $x_{d(s)}$  is the decoupling tem perature in the standard cosm ology. Sim ilarly, for n=1 we nd

Again, in the case of  $x_d$   $x_t$ , the integration gives '  $x_t^2 \ln (x_t = x_d)$ '  $x_t^2 \ln x_t$ , and we not the resultant relic density Y (1 ) '  $x_t^2 = (0.0 \ln x_t)$ . Thus the ratio of the energy density of the dark matter is found to be

We can obtain results for the case of n > 1 in the same manner. Now we have found that the relic energy density in the brane world cosmology is characterized by the transition temperature and can be enhanced compared to the one in the standard cosmology, if the transition temperature is lower than the decoupling temperature.

In sum mary, we have investigated the thermal relic density of the cold dark matter in the brane world cosmology. If the ve dimensional Planck mass is small enough, the <sup>2</sup> term in the modiled Friedmann equation can be excitive when the dark matter is decoupling. We have derived the analytic formulas for the relic density and found that the resultant relic density can be enhanced. The enhancement factor is characterized by the transition temperature, at which the evolution of the universe changes from the brane world cosmology era to the standard cosmology era.

It would be interesting to apply our result to detailed numerical analysis of the relic abundance of supersym metric dark matter, for example, the neutralino dark matter. A llowed regions obtained in the previous analysis in the standard cosmology [8] would be dramatically modiled if the transition temperature is small enough [9]. Furthermore, if there exists the brane world cosmology era in the history of the universe, the modiled expansion law a ects many physics controlled by the Boltzmann equations in the early universe. For example, we can expect considerable modileations for the thermal production of gravitino [10], the thermal leptogenesis scenario [11] etc. Those are worth investigating.
