W e investigate pion super uidity and its e ect on m eson properties and equation of state at nite temperature and isospin and baryon densities in the fram e of standard avor SU (2) N JL m odel. In m ean eld approxim ation to quarks and random phase approximation to mesons, the critical isospin chem ical potential for pion super uidity is exactly the pion m ass in the vacuum , and corresponding to the isospin sym m etry spontaneous breaking, there is in the pion super uidity phase a Goldstone mode which is the linear combination of the norm al sigm a and charged pion m odes. W e calculate num erically the gap equations for the chiral and pion condensates, the phase diagram s, the meson spectra, and the equation of state, and compare them with that obtained in other e ective m odels. The com petitions between pion superuidity and color superconductivity at nite baryon density and between pion and kaon super uidity at nite strangeness density in avor SU (3) N JL model are brie y discussed. I. IN TRODUCTION

It is generally believed that there exists a rich phase structure of Quantum Chromodynamics (QCD) at nite tem perature and baryon density, for instance, the deconnem ent process from hadron gas to quark-gluon plasm a, the transition from chiral symmetry breaking to the symm etry restoration [1], and the color superconductivity [2] at low temperature but high baryon density. Recently, the study on the QCD phase structure is extended to nite isospin density. The physical motivation to study QCD at nite isospin density and the corresponding pion super uidity is related to the investigation of com pact stars, isospin asymmetric nuclearmatter and heavy ion collisions at interm ediate energies. In early studies on dense nuclearm atter and com pact stars, it has been suggested that charged pions and even kaons are condensed at su ciently high density $[3\{6]$.

W hile the perturbation theory of QCD can well describe the properties of the new phases at high tem – perature and/or high density, the study on the phase structure at moderate (baryon or/and isospin) density depends on lattice QCD calculation and e ective models with QCD symmetries. W hile there is not yet precise lattice result at nite baryon density due to the Ferm ion sign problem [7], it is in principle no problem to do lattice simulation at nite isospin density [8]. Recently it is found that [9(11] there is a phase transition from norm al phase to pion super uidity at a critical isospin chem ical potential which is about the pion m ass in the vacuum, $_{\rm I}^{\rm c}$ ' m . The QCD phase structure at nite isospin density is also investigated in many low energy e ective models, such as chiral perturbation theory [8,12{15], N am bu{Jona-Lasinio (N JL) model [16{20], random matrix method [21,22], ladder QCD [23], and strong coupling lattice QCD [24].

One of the models that enables us to see directly how the dynam ic mechanisms of chiral symmetry breaking and restoration operate is the NJL model [25] applied to quarks [26{29]. The chiral phase transition line [26{32] in the tem perature and baryon chem ical potential (T в) plane calculated in the model is very close to the one obtained with lattice QCD. Recently, this model is also used to investigate the color superconductivity at m oderate baryon density [33{40]. It is nature to extend the N JL model to nite isospin chem ical potential [16,17]. In the fram e of general NJL Lagrangian with U_A (1) breaking term [19], it is analytically proved [20] at quark level that the critical isospin chem ical potential for pion super uidity is exactly the pion m ass in the vacuum , $T_{T}^{c} = m$, and this relation is independent of the model parameters, regularization scheme, U_A (1) breaking coupling, and color degrees of freedom $N_{\rm C}$.

Unlike the e ective models at hadron level where one can study the e ect of phase transitions on m eson and diquark properties in mean eld approximation, in the NJL m odel applied to quarks, only the order param eters of the phase transitions, namely the condensates, can be described at mean eld level, to study mesons and diquarks should go beyond the mean eld approximation. It is well-known that [27] in the mean eld approxim ation to quarks together with random phase approxim ation (RPA) to mesons in the NJL model, one can obtain the hadronic mass spectra and the static properties of m esons remarkably well, especially the Goldstone mode corresponding to the chiral sym m etry spontaneous breaking. However, in the pion super uidity or the color superconductivity phase, the structure of the bubble sum m ation in RPA is much more complicated than that in the chiralbreaking phase. The correlation among the mesons and diquarks becom es very im portant and leads to the Goldstone modes corresponding to the isospin and color sym m etry spontaneous breaking. In this paper, we study analytically and num erically the pion super uidity, its effect on the m eson properties, and its possible com petition with the color superconductivity and kaon condensation in the fram e of standard NJL m odelat nite tem perature and baryon, isospin and strangeness chem ical potentials.

The paper is organized as follows. In Section II, we establish the mean eld theory of the NJL model at nite tem perature and baryon and isospin densities. In Section III, we study the pion super uidity at zero tem perature, zero baryon chem ical potential, but nite isospin chem icalpotential, and calculate the chiral and pion condensates and therm odynam ic functions. In Section IV, we study the temperature behavior of the pion superuidity at zero baryon chem ical potential and show the phase diagram s in the tem perature and isospin chem ical potential plane. In Section V, we investigate the meson modes in both norm alphase and super uidity phase in RPA. In Section VI, the bosonized version of the SU (2) NJL model is discussed at nite isospin chem ical potential with pion condensation. In Section VII, we study the baryon chem ical potential e ect and the com petition between pion and diquark condensations. In Section VIII, we brie y discuss the avor SU (3) NJL model at nite isospin and strangeness chem ical potentials including both pion and kaon condensations. W e sum m arize in Section IX .

II. M EAN FIELD THEORY OF NJL MODEL AT FIN ITE $_{\rm I}$

The standard approach for dealing with the therm odynam ics of a variable particles is via the grand canonical ensemble. The key quantity for a system with baryon number conservation and isospin number conservation is the partition function de ned by

Here V is the volume of the system, the inverse tem – perature = 1=T, $_B$ and $_I$ are the baryon and isospin chem ical potentials, and B and I₃ the conserved baryon number and isospin number operators. If we take only quark eld as elementary eld of the system, the operators can be expressed as

The factors $1=N_c$ and 1=2 re ect the fact that N_c quarks make a baryon and quark's isospin quantum number is 1=2. In the imaginary time formulism of nite temperature eld theory, the partition function can be represented as

The above Lagrangian density has the symmetry U_B (1) SU_I (2) SU_A (2) corresponding to baryon number gauge symmetry, isospin symmetry and chiral symmetry, respectively. However, in the presence of a nonzero isospin chemical potential, the isospin symmetry which is related to B ose-E instein condensation of charged pions, and the chiral symmetry SU_A (2) breaks down to U_{IA} (1) global symmetry which is associated with the chiral condensation of sigma metry which is associated with the chiral condensation of sigma metry restoration at nite temperature and chemical potentials means only degenerate of

and $_0$ m eson m asses. At zero baryon chem ical potential, the \Ferm i surfaces" of the u (d) and anti-d (u) quarks coincide. Therefore, at su ciently high $_{\rm I} > 0$ the condensate of u and anti-d quarks is favored, and at su ciently high $_{\rm I} < 0$ the condensate of d and anti-u quarks is favored. Since at low isospin chem ical potential (and low tem perature and low baryon chem ical potential) there is no decon nem ent, the condensates can be idential end as B ose-E instein condensates of charged pions, $^+$ and ~. a nonzero condensate m eans spontaneous chiral sym – m etry breaking, and a nonzero condensate m eans spontaneous isospin symmetry breaking. The phase factor related to the condensates $_{+}$ and indicates the direction of the U_I(1) symmetry breaking. If the system

is in global therm al equilibrium, is a constant and it does not change any physical result. For convenience we choose = 0 in the following. As is well-known and will be seen later, there are corresponding Goldstone modes in the region of spontaneous chiral breaking and the region of spontaneous isospin breaking.

A.Gap Equations

The quark propagator (14) is the background of calculations for quarks in mean eld approximation and also form esons in RPA.From the de nitions of the chiral and pion condensates (7) and (8), it is easy to express them in term s of the matrix elements of the quark propagator,

Obviously, in the study without considering color superconductivity, the color degrees of freedom in the NJL model is trivial, and the trace in color space simply contributes a factor N $_c$. Performing the trace in spin space (the trace including the energy projectors are presented in Appendix A) and the M atsubara frequency summation we have

This group of gap equations has a symmetry that it is invariant under the transformations $_{u}$! $_{d}$; $_{d}$! $_{u}$; $_{I}$! $_{I}$. Therefore, we can only concentrate on the case $_{I} > 0$ and the results for the case $_{I} < 0$ can be obtained easily. It is also necessary to note that for $_{B} = 0$ or $_{I} = 0$, there is always $_{u} = _{d}$, since in this case the chemical potential di erence between u and u is the same as the di erence between d and d.

III.PURE ISOSPIN EFFECT IN MEAN FIELD APPROXIMATION

To solve the gap equations and calculate the therm odynam ic functions num erically, we should rst x them odel param eters. Because of the contact interaction between quarks that is introduced in the model, there is of course no con nem ent. A further consequence of this feature is that the model is non-renorm alizable, and it is necessary to introduce a regulator that serves as a length scale in the problem , and which can be thought of as indicating the onset of asymptotic freedom [41]. In the following we take a hard three-momentum cuto , which and the other two model parameters, the elective coupling constant G and the current quark mass m₀, can be xed by tting the pion mass m = 0.134 GeV, the pion decay constant f = 0.093 GeV, and the quark condensate density $_{\rm u} = _{\rm d} = (0.25 \ {\rm GeV})^3$ in the vacuum . They are [31]m₀ = 0, = 0.655 GeV and G = 5.01 GeV² in the chiral limit, and m₀ = 0.005 GeV, = 0.653 GeV, and G = 4.93 GeV² in the realword.

In this section we concentrate on the pure isospin e ect with $T = {}_B = 0$. In this case the di erence between the u quark and d quark condensates disappears and we need to calculate the total chiral condensate $= 2 {}_u = 2 {}_d$ only.

A.Pion and ChiralCondensates

It is clear that the order parameter = 0 is always a solution of the second gap equation, it corresponds to the phase with isospin symmetry at low isospin chemical potential. The other order parameter describing chiral properties in this phase is $_{\rm I}$ independent,

The condensates and scaled by the chiral condensate $_{0}$ in the vacuum are shown in Fig.(1) as functions of I. In chiral limit, pions are Goldstone particles of chiral symmetry spontaneous breaking, m = 0. Therefore, at I = 0 the pion condensate jumps up from the vacuum value = 0 to a nite value, and the chiral condensate jumps down from the vacuum value $_0 = 2(0.25 \,\text{GeV})^3$ to zero and then keeps zero in the region T > 0 due to the constraint of the gap equations (34). These sudden changes at the critical point $_{I}^{c} = 0$ m eans that in chiral lim it, no matter how small the isospin chem ical potential is, the chiral sym m etry is restored and pion B ose-E in stein condensate occurs. In the real world with nonzero current quark m ass, the critical point is at $\frac{c}{\tau} = m = 0.134$ GeV and the both chiral and pion super uidity phase transitions are of second order. W hen the isospin chem icalpotential is sm all, the vacuum state is not disturbed. Only when it exceeds the pion mass, the pion condensate goes up with τ and at the same time the chiral condensate drops down with I. The two condensates coexist in a wide region. Dierent from the result obtained with chiral perturbation theory [8] where the pion condensate at nite I is always less than the chiral condensate in the vacuum, = 0 < 1, in our calculation can be larger than 0 at som e interm ediate isospin chem ical potential. The pion condensate tends to zero at about I = 1.75 GeV. W hile the value of the endpoint of pion condensation in our calculation is closely related to the nite m om entum cuto , the disappearance of pion condensation at su ciently high isospin chem icalpotential can be understood in the frame of asymptotic freedom of QCD.

W hat is the isospin e ect on the chiral condensate if we do not consider isospin spontaneous breaking? In this case, the only condensate, the chiral condensate is controlled by the gap equation

In the case with $_{\rm B} = 0$, it is easy to see the symmetry of $!_1 = !_2$ and $!_3 = !_4$. The dispersion relations in this case are shown in Fig.(2) at T = 0. In both the isospin symmetric phase with $_{\rm I} = 0.1 \, {\rm GeV} < {\rm m}$ and the symmetry breaking phase with $_{\rm I} = 0.4 \, {\rm GeV} > {\rm m}$, any quasi-particle excitation needs energy. In the norm alphase with $_{\rm I} > {\rm m}$, the gap for the quasi-particle excitations, and in the pion super uidity phase with $_{\rm I} > {\rm m}$, the gap ismainly due to the pion condensate € 0. In the norm al phase, the minim a of the quasi-particle energies are located at k j = 0, but in the super uidity phase, the location of the minim a of !_1 and !_2 are shifted to a nite momentum when $_{\rm I}$ is large enough.

In the norm all phase we have $n_u^+(kj) = n_u(kj) = n_d^+(kj) = n_d^-(kj) = 0$, since the ground state in this case is just the vacuum state and there are no quark and anti-quark excitations. In the super uidity phase, there are excited quarks and anti-quarks, the occupation numbers are shown in Fig.(3) as functions of momentum. Note that the maxim alloccupation number is 2 because of the spin degenerate.

C.Bulk Properties

We rst calculate the isospin density. At $T = B_B = 0$ it is

norm alphase with $_{\rm I}$ < m the unchanged ground state leads to a zero isospin density. Only when $_{\rm I}$ exceeds the vacuum pion mass, $n_{\rm I}$ increases monotonously with $_{\rm I}$. This nonzero net isospin density is due to the Bose-E instein condensation of charged pions which results in di erent avor densities. To see this clearly, we plot the avor densities, scaled by the norm alnuclear density n_0 , as functions of isospin chem ical potential in Fig.(5). In the super uidity phase the relation $n_u^+ = n_d > n_d^+ = n_u$ leads to the net isospin density, and then the number of $_+$ in the system should be larger than the number of

the m easurable pressure p and the energy density are related to it. O fcourse, the rede nition of will not change the num ber densities and the entropy density since they are the derivatives of with respect to and T.

The pressure and energy density are shown in Fig.(6) at T = $_{\rm B}$ = 0. From the rede nition (47) they are zero in the vacuum and keep zero in the normal phase, since the isospin e ect is not strong enough to disturb the vacuum state. In the pion super uidity phase, the ratio of p to which describes the equation of state of the system goes up with increasing $_{\rm I}$ rst and then gets saturated, p= 0:7, at $_{\rm I}$ 0:5 G eV. This behavior indicates that the system is far from an ideal gas which satis es the equation of state $p = \frac{1}{3}$.

To conclude this subsection, we rem ark that the isospin number density n_I is perhaps a more physical variable than the isospin chem ical potential $_I$, since n_I can be directly measured. The chiral and pion condensates and , scaled by the chiral condensate $_0$ in the vacuum, the pressure p and energy density , and the ratio of p to are shown again in Figs.(7) and (8). D i erent from their

 $_{I}$ -dependence, Figs.(1) and (6), where the isospin sym – m etric and sym m etry breaking phases are shown sim ultaneously and are separated from each other at $_{I}$ = m ,

the isospin sym metric phase is now contracted at a point $n_{\rm I} = 0$. The isospin density corresponding to the saturated equation of state is about 5 times the norm al nuclear density.

IV.TEM PERATURE EFFECT IN MEAN FIELD APPROXIMATION

W e now study the tem perature behavior of the chiral and pion condensates and the therm odynam ic functions, and discuss the phase diagram in the T $_{\rm I}$ plane in mean eld approximation at $_{\rm B}$ = 0.

A.Chiral and P ion C ondensates

The tem perature dependence of the two condensates and , again scaled by the chiral condensate $_0$ in the vacuum, at a xed isospin chem ical potential I = 0.05GeV is shown in Fig.(9) in the chiral lim it. In the chiral lim it any small isospin chem ical potential will force the broken chiral symmetry to be restored and the isospin symmetry to be broken at T = 0. Therefore, the chiral condensate keeps zero, and the pion condensate is continuously melted in the hot medium. Finally at a critical tem perature T_c 0:18 GeV the pion condensate vanishes and the isospin symmetry is restored. At small isospin chem ical potential the value of the critical tem perature for isospin restoration is almost the same for chiral restoration in the study without considering pion condensation [27,31]. In Fig.(10) we show the pion and chiral condensates as functions of T at I = 0.15 GeV

and 0.2 GeV.For $_{\rm I}$ > m , the pion condensate is already nonzero at the beginning, then drops down due to the tem perature e ect, and nally disappears at a critical tem perature $T_{\rm c}$. Like the standard BCS theory, the critical tem perature and the pion condensate at T = 0 satis es the linear relation,

The relative strength of the two condensates at the beginning depends on the isospin chem ical potential, (T =0 > (T = 0) at small I and (T = 0) > (T = 0) at large . Qualitatively di erent from the study on chiral symmetry restoration without considering pion condensation where the chiral condensate decreases with increasing tem perature monotonously, here goes up continuously in the coexistence region of the two condensates, and drops down only in the region where the isospin symmetry is restored. However, we found that when I is close to the critical value I = pm, say m $\,$ < $\,$ $_{\rm I}\,$ < 0.2 GeV , the total condensate (the dashed line in Fig.(10), behaviors in a sim ilar way like the in the norm al study without considering pion condensation.

B.NumberDensities

The isospin density n_I and avor densities $n_{u,d}$, scaled by the norm alnuclear density n_0 , are shown in Fig.(11) as functions of isospin chemical potential $_I$ at $_B = 0$ but T = 0.1 GeV. At nite temperature, there is therm al excitation of particles. Since T = 0.1 GeV is not very high, the critical isospin chemical potential $_I^c$ for pion condensation is still approximately the vacuum pion m ass m . In the region of $_I < _I^c$, the small but nite isospin density is purely due to the therm al excitation, while in the region of $_I > _I^c$ the rapidly increasing density is dominated by the Bose-E instein condensation of charged pions. The therm al excitation depends strongly on the isospin chem ical potential carried by the particle. At $_{\rm I}$ < $_{\rm I}^{\rm c}$, the densities of quarks with positive isospin chem ical potential increase with $_{\rm I}$, while the densities of quarks with negative isospin chem ical potential decrease with $_{\rm I}$.

C. Phase Diagram in T I Plane

In the chiral lim it when $m_0 = 0$, the solution of the last gap equation of (19) for with u = d = 0 separates the region of isospin symmetry breaking with 60 from the region of symmetry restoration with = 0. The phase transition line dem arcating these two regions is given in $_{\rm I}$ plane for $_{\rm B} = 0$. the upper panel of Fig. (12) in the T Since an in nite small isospine ect can restore the chiral sym m etry, there is = 0 in the whole plane in the chiral lim it. In the realworld with nonzero current quark m ass, the system is in isospin symmetric phase not only at high tem perature and/or high isospin chem ical potential but also at low isospin chemical potential with I m. Since the chiral symmetry phase transition is not well de ned in the case with nonzero current quark mass, we did not show the chiral phase transition line. In principle, there is 60 in the whole T $_{\rm I}$ plane.

V.MESONSAT FINITE ISOSPIN DENSITY

We now investigate m eson properties at nite isospin chem ical potential. In the NJL m odel, the m eson m odes are regarded as quantum uctuations above the m ean ekd. The m eson m odes can be calculated in the fram e of RPA [27]. When the m ean ekd quark propagator is diagonal, for instance the case with only chiral condensation, the sum m ation of bubbles in RPA selects its speci c channel by choosing at each stage the sam e proper polarization function, a m eson m ode which is determ ined by the pole of the corresponding m eson propagator is related to its own polarization function $_{MM}$ (k) [30,31] only,

then directly use the method developed in [30,31] to calculate the masses of ; +; and 0. In the super uidity phase with nonzero and o diagonal matrix elements in the mean eld quark propagator, the collective excitations of the system will in principle not be the original meson modes in the vacuum but their mixture. Especially it is expected that there will be a G oldstone mode in the super uidity phase corresponding to the spontaneously isospin symmetry breaking.

In the following we will study the meson properties in the norm alphase (= 0) and super uidity phase (\neq 0) separately.

A.M eson Properties in Norm al Phase

In the vacuum, due to isospin symmetry, one can regard 1; 2 or +; or any other linear combination of 1; 2 as eigen collectivem odes. In the norm alphase with vanished pion condensate, the polarization function m atrix is diagonal with respect to the basis (; +; ; 3) but not diagonal with respect to the basis (; 1; 2; 3). This eans that in the norm alphase, the eigen collective m odes are ; +; ; 0. Thus the dispersion relation for each m ode is determ ined through the equation

From the polarization functions shown in Appendix B, it is easy to prove that M = 0 is a solution of (67) corresponding to the spontaneously isospin symmetry breaking. We call the massless meson mode as $_{\rm L}$ and the other heavy mode as $_{\rm H}$. The meson mass spectra in the chiral limit are shown in Fig.(13) as functions of $_{\rm I}$ at $T = _{\rm B} = 0$.

In the real world with nonzero current quark mass, there is not only the mixing between the charged pions, but also a mixing between and the charged pions. From the explicit expression of the polarization functions shown in Appendix B, we have

describing the strengthes of mixing and mixing. Their isospin dependence is shown in Fig.(14) at $T = {}_{B} = 0$. The mixing is much weaker than the

m ixing, since the form er is proportional to both chiral condensate and pion condensate, but the latter to the square of pion condensate, and in the super uidity phase the chiral symmetry is almost restored. The mixing is important only around the phase transition point $_{I}^{c} = m$, but the mixing is strong in a wide region after the phase transition.

The mass spectra calculated through solving the Eq.(64) num erically are shown in Fig.(15), together with M $_{\circ}$, Eq.(62) in the super uidity phase and the masses

(57) in the norm alphase, as functions of $_{\rm I}$ at T = $_{\rm B}$ = 0. Again we obtain the Goldstone mode re ecting correctly the spontaneous isospin symmetry breaking in the super uidity phase. In the norm alphase ; +; and 0 them selves are eigen modes of the collective excitation of the system, but in the super uidity phase, except for $_0$ which is still an eigen mode, ; + and are no longer eigen modes. Since the masses determined by (64) are continuously connected with the masses of ; $_+$ at the phase transition point I = m, we call and them ; + and , shown in Fig.(15). When $_{\rm I}$ is high enough, the pion condensation will disappear due to the asymptotic freedom of QCD, this turning point in the NJL model is about $\sim_{T}^{C} = 1:75 \text{ GeV}$, see Fig.(1). Above this turning point the mass spectra are again controlled by the polarization functions (56) and the $_{\rm I}$ dependence is similar to (57).

The mass spectra in the super uidity phase calculated in the NJL model here are very similar to the result predicted in chiral perturbation theory [8,12],

In this case, the broken $U_{\rm A}$ (1) sym m etry will be restored at su ciently high isospin density, indicating by the sam e and $_{0}$ m ass. It is clear that the di erence between the full calculation and the approxim ation neglecting m ixing is mainly in the narrow region above the phase transition point $_{\rm I}$ = m ~ .

U sing the analytical form of $_{22}$ evaluated in Appendix B, we nd that the above equation is exactly the same as the gap equation for the pion condensate. Therefore, in super uidity phase with $\stackrel{\bullet}{\leftarrow}$ 0, there is always a G oldstone m ode. Note that this m assless m ode holds in the whole super uidity phase at nite temperature and isospin and baryon chemical potentials.

The G oldstone m ode will extrem ely change the therm odynam ics of the system . In m ean eld approximation, only quarks contribute to the therm odynam ic potential, see (26). Since quarks are heavy at low temperature, the therm odynam ic functions scaled by the temperature, for example, $p=T^4$; $=T^4$; $s=T^3$ and $c=T^3$ approach to zero in the limit of T ! 0 [31]. However, when the meson uctuations are included, the massless meson mode will lead to power laws of therm odynam ic functions at low temperature, these scaled functions will approach to nonzero constants.

VI.PION SUPERFLUIDITY IN LINEAR SIGMA MODEL

In this section we study the linear sigm a model at nite isospin chem ical potential and compare it with the NJL model. Since the linear sigm a model can be regarded as a bosonized version of the NJL model, we want to know whether the former can reproduce the results we have worked out with the latter with quarks as elementary degrees of freedom. It is well-known that one can use the bosonization technique to integrate out the quark degrees of freedom and obtain the elective Lagrangian for the meson bound states in the NJL model [27,43]. In the realworld the Lagrangian is just the one of the linear sigm a model with an explicit chiral breaking term,

W e have chosen pion condensate to be real as in the NJL model. In this section we use and standing for the chiral and pion condensates in order to avoid confusion with the de nitions in the NJL model.

In the vacuum the constraints (83) on the potential give = f and = 0, and the sigm a mass can be read out from the quadratic term in the sigm a eld in the e ective Lagrangian (81), $m^2 = 4g^2 f^2 + m^2$.

At nite isospin density the two condensates in the ground state satisfy = 0; $= f^{1} \frac{1}{1+2} \frac{2}{1} = m^{2}$ in the chiral lim it. This is consistent with the NJL m odel: Any small isospin density can force the chiral symmetry to be restored in the chiral lim it. In the real world, we obtain = f; = 0 for $_{\rm I} < m$ which is the same as in the vacuum, and [5]

around the phase transition point $_{I}^{c} = m$ in the three electric models are almost the same.

If we take the limit m ! 1, we reproduce the result in the chiral perturbation theory [8,12]. However, the nite sigm a mass leads to a big di erence at large $_{\rm I}$. At large $_{\rm I}$, the ratio p= approaches 1 in the chiral perturbation theory, but only about 1=3 in the linear sigm a model and 0:7 in the NJL model, as shown in Fig.(16). W hile the three e ective models are very di erent in high density region, they behavior alm ost the same in the region close to the critical point, see also the chiral and pion condensates shown in the lower panel of (16).

The meson mass spectrum is easily obtained by diagonalizing the quadratic part of the elective Lagrangian (81). It is clear that $_0$ itself is an eigen mode of the system, while $_+$ and $_{\rm are not}$, like the case in the NJL model. A simple algebra calculation gives the result

The calculation without considering mixing is indicated by dashed lines. We nd that the mass spectra are qualitatively consistent with the NJL model and the chiral perturbation theory.

B.Finite Tem perature

There are two approaches to treat therm al excitation in the linear sigm a model, the Hartree-Fock approxim ation and the large N expansion. It is well-known that a disadvantage of the H artree-Fock approach in the discussion of chiral sym m etry restoration is the lack of the G oldstone m ode in the sym m etry breaking phase [44]. H ere we calculate the m ass spectra and phase diagram in the two approaches at nite tem perature and isospin density and com pare the results with the NJL calculation.

Since the sigm a m odel (78) can be regarded as a O (4) m odel, we adopt the large N expansion m ethod in the O (N) sigm a m odel with boson chem ical potential. W ith the sam e m ethod and technics given by H arber and W eldon [45], the m ass param eter M and condensates and are determ ined by the following gap equations

The Hartree-Fock approach in the super uidity phase is rather complicated, and there is no Goldstone mode at nite temperature in this approach. Here we will not present the treatment in the super uidity phase with $\frac{6}{0}$ 0. However, to calculate the phase transition line of pion super uidity in the T I plane is much easier. We need only the form ulas in the norm alphase with = 0. From the detailed derivation given in Appendix C, the elective m eson m asses and the chiral condensate in this phase are governed by the coupled equations,

The phase diagram in the T $_{\rm I}$ plane calculated with the large N expansion method and Hartree-Fock approximation is shown in Fig.(18) in the chiral limit (upper panel) and the realworld (lower panel). It is clear that the result of the large N expansion is qualitatively consistent with the NJL model calculation. Especially, in the chiral limit, when $_{\rm I}$! O the critical temperature in the large N approach is very close to the one obtained in the NJL model, while in the Hartree-Fock approximation the critical temperature approaches zero, which is certainly wrong.

V II.F IN ITE BARYON DENSITY AND D IQUARK CONDENSATION

W e have investigated the NJL m odel at nite isospin chem icalpotential I and tem perature T and m ade com parison with the other e ective models. We now turn to the discussion at nite baryon chemical potential $_{\rm B}$. It is well-known that [7,27,47] the baryon density e ect on decon nem ent and chiral restoration is qualitatively di erent from the tem perature e ect: the phase transition is of rst order at high baryon density but of second order or even a smooth crossover at high tem perature. The physics in high baryon density region is also very di erent from that in high isospin density region: the spontaneously broken symmetry is of color symmetry at su ciently high baryon chem ical potential but isospin symmetry at su ciently high isospin chemical potential, the form er is described by the diquark condensate h i and the latter by the pion condensate \cdot W e will rst consider the baryon density e ect on the pion condensation without considering the color superconductivity, and then discuss the competition between the pion super uidity and color superconductivity in the B т plane.

A.Finite Baryon Density E ect without Diquark Condensate

A swe indicated in the Section B, when the two chemical potentials $_{\rm B}$ and $_{\rm I}$ are both nonzero, the u and d quark condensates are di erent from each other, see (19). It is clear that the isospin chemical potential $_{\rm I}$ should be large enough to guarantee the phase transition of pion super uidity at nite baryon chemical potential $_{\rm B}$ and temperature T, at least it should be larger than the critical value m at T = $_{\rm B}$ = 0. In our num erical calculation we took it as 0.2 G eV. The $_{\rm B}$ dependence of the chiral and pion condensates, again scaled by the chiral condensate $_{0}$ in the vacuum, at xed T and $_{\rm I}$ is shown in Fig.(19). At zero temperature, the u and d quark condensates $_{\rm u}$ and $_{\rm d}$ are alm ost the same, and all the three condensates, $_{\rm u}$; $_{\rm d}$ and keep their vacuum values in the pion super uidity phase. At a critical value 0:85 GeV, a rst order phase transition happens, R the pion condensate jumps down from its vacuum value to zero, and the u and d quark condensates jum p up from their vacuum value to some larger values. In the norm al phase with = 0, the two chiral condensates decrease with increasing baryon chemical potential, and the difference between them becom es remarkable. The tem perature e ect changes the phase transition from st order to second order, see the lower panel for T = 0.1 GeV, and reduces the critical baryon chem ical potential from about 0:85 GeV to about 0:65 GeV. Also the temperature e ect leads to rem arkable di erence between the two chiral condensates not only in the norm alphase but also in the pion super uidity phase.

The tem perature dependence of the three condensates is indicated in Fig.(20) at xed chem icalpotentials. Sim – ilar to the case [30,31] of investigating chiral sym metry restoration without pion condensation, the tem perature e ect here results in a second order phase transition of pion super uidity. The phase diagram in the T $_{\rm B}$ plane at xed $_{\rm I}$ is shown in Fig.(21), which is very sim – ilar to the chiral phase transition line at $_{\rm I}$ = 0 [31]. The phase transition is of second order in high tem perature region and of rst order in high baryon chem ical potential region, and the tricritical point which connects the rst and second order phase transitions is located at T = 0.045 G eV and $_{\rm B}$ = 0.78 G eV .

Therefore, the norm alphase without pion and diquark condensations is in the square box $_{\rm I}$ < m and $_{\rm B}$ < m , shown in Fig.(22). The system is in the phase of color superconductivity with = 0 and \neq 0 for $_{\rm I}$ < m and $_{\rm B}$ > m and in the phase of pion super uidity for 0 and = 0 for B < m and I > m. with In the region of high $_{\rm I}$ and $_{\rm B}$, due to the symmetry between the pion and diquark condensates proposed by their gap equations, we can conclude that the pion and diquark condensates are equivalent in the phase diagram $_{\rm B}$ plane. This can be con med by taking in the ı the bosonized version [42] of the two color NJL model with chiral, pion and diquark condensates. The e ective potential in the bosonized version can be derived as

At su ciently small $_{\rm B}$ and large $_{\rm I}$, the system should be in the pion super uidity phase. The chiral and pion condensates and are controlled by the gap equations shown in Section II. Outside this rectangle, we know that the system is in color superconductivity phase with 60 and = 0 for $_{\rm I}$ < m and $_{\rm B} > \frac{3}{2}m_{\rm D}$, and in pion super uidity phase with 60 and = 0 for $_{\rm B} < \frac{3}{2}m_{\rm D}$ and $_{\rm I} > m$. As for the phase structure in the region with high baryon and isospin chem icalpotentials, it needs to consider the gap equations for the three condensates , and simultaneously. The dashed line in the lower panel of Fig.(22) which separates the phase with = 0 and 60 from the phase 60 and = 0 is just an estimation of us.

VIII.EXTENSION TO SU(3)NJLMODEL

We exam ine now the possible pion and kaon super uidity at nite isospin and strangeness chem ical potentials in the fram e of avor SU (3) NJL m odel. The Lagrangian density is de ned as [26{29]

The three e ective quark m asses are shown in Fig.(23) as functions of baryon chem icalpotential $_{\rm B}$ at T = $_{\rm S}$ = 0 and $_{\rm I}$ = 0.06 GeV < m . We use the model parameters xed in [46]. The three m asses keep their vacuum values till the common critical point where they suddenly jump down. The mass di erence between u and d quarks arisen from the nite isospin chem icalpotential can only be seen after the chiral transition.

In principle the m eson m ass spectra can be evaluated by solving the corresponding pole equation like (54) for two avor NJL m odel. The m eson polarization functions in avor space are evaluated in Appendix D. In general case with nonzero pion and kaon condensates, the o diagonal elements in the polarization function m atrix in avor space m akes it com plicated to solve the pole equation. How ever, in the region w ithout pion and kaon condensates we are interested in here, the o diagonal elements disappear and the pole equation is reduced to

IX . SU M M A R Y

It is well-known that physical sym metries of a system dom inate its behavior not only in the vacuum but also in hot and dense medium. The sym metries in the vacuum are usually changed by the temperature and density effect. In this paper we have investigated the changes of isospin sym metry, chiral sym metry and color sym metry and their rejection in meson spectra and them odynamic functions at nite temperature T and isospin, baryon and strangeness chemical potentials $_{\rm I}$; $_{\rm B}$ and $_{\rm S}$ in elective models.

We studied the avor SU (2) NJL model in detail. With the standard technics we set up in avor space the quark propagator matrix with o diagonal elements arisen from the pion condensation at nite isospin density. W ith the propagator we derived the gap equations determ ining the tem perature and chem ical potential dependence of the pion and chiral condensates, and obtained the therm odynam ic functions in mean eld approximation. By self-consistently solving the gap equations at nite isospin density and the pion mass equation in the vacuum, we analytically derived the critical isospin chem ical potential for pion super uidity, $C_{T} = m$, at quark level. Therefore, in chiral lim it with vanishing pion m ass, any sm all isospin e ect will lead to chiral sym m etry restoration and isospin symmetry spontaneous breaking even in the vacuum. In real world with nite current quark mass and at nite tem perature, there is a strong competition between the pion and chiral condensates in their coexistence region. The chiral condensate goes up continuously in the mixed region and drops down outside, while the pion condensate decreases m onotonously in the whole tem perature region. The bulk properties of the system in the lim it of high isospin density is also quite di erent from the corresponding ideal gas, the equation of state is hard and the ration of pressure to energy density approaches 0:7. We investigated the e ect of pion super uidity on the meson properties in the hot and dense quark-meson plasma, by taking into account the o diagonal elements in the meson polarization function matrix in isospin space. We found that the mean eld approximation to quarks together with RPA to mesons can well describe the isospin spontaneous breaking, there is a massless Goldstone mode which is a linear combination of the +; and modes in the whole super uidity phase. W e proved the Goldstone mode analytically in general case with nite T; $_{\rm I}$ and $_{\rm B}$. In the super uidity phase, while the $_0$ mode is still an eigen mode, the ; +

and mixing is very strong, especially in the region close to the phase transition point. We discussed also the competition between the pion super uidity and color superconductivity at nite baryon density. While we did not make full calculation with both pion and diquark condensates, we determ ined the critical baryon chemical potential $_{\rm B}^{\rm c}$ for color superconductivity. The region of the normal phase without pion and diquark condensates in $_{\rm S}$ I plane is controlled by the pion massm and diquark mass m_D in the vacuum. In the case of two colors it is in a square box de ned by I < m and B < m, and in the case of three colors it is in a rectangle de ned by I < m and B < 15m D.

We brie y extended our discussion on pion super uidity to the avor SU (3) NJL model at nite isospin and strangeness densities. We found that the conclusion of the critical isospin chemical potential $_{\rm I}^{\rm c} = m$ for pion super uidity does not change, and that the critical strangeness chemical potential for kaon super uidity is related not only to the kaon mass m_K but also to the isospin chemical potential, $_{\rm S}^{\rm c} = m_{\rm K}$ I=2. We showed the phase diagram of pion and kaon super uidity in $_{\rm S}$ I plane with possible charged pion condensates and kaon condensates.

W e have investigated the pion super uidity and m eson properties at tree level and the therm al excitation at nite isospin density in the bosonized version of the NJL model, namely, the linear sigm a model, and made comparison of our calculations in the NJL model and sigm a model with the result obtained in chiral perturbation theory. M any conclusions in the linear sigm a m odel are qualitatively or even quantitatively consistent with that in the NJL m odel. W e found that at zero tem perature the linear sign a model can reproduce the result of chiral perturbation theory by taking the limit m ! 1, but at nite tem perature the Hartree-Fock approxim ation can not recover the Goldstone mode in the pion super uidity phase. The phase diagram in the T ⊺ plane in large N expansion approach is more reasonable than the one in the Hartree-Fock approximation.

It is necessary to discuss the di erence among the effective models. The conclusion $_{I}^{c} = m$ is observed in alm ost all model calculations and lattice simulation. W hile obtaining this result is easy and looks trivial in the m eson e ective m odels such as chiral perturbation theory and linear sigm a model, because the pion mass is a param eter in these m odels, it is in the NJL m odela general result of mean eld approximation to quarks and RPA to mesons and diquarks. This is also true for kaon condensation. In chiral perturbation theory, the chiral and pion condensates are regarded as a rotation from each other. As a result, the maximum pion condensate should be the same as the chiral condensate in the vacuum . In the NJL model, we found that this rotation point of view is only true around the phase transition point. Beyond this region the pion condensate can be larger than the

m axim al chiral condensate in the vacuum. This behavior is qualitatively consistent with the lattice simulation [9{11]. As for the linear sigm a model, because the pion condensate increases with $_{\rm I}$ without bound, the phase structure at high $_{\rm I}$ is unphysical. Of course, due to the lack of con nem ent mechanism in the NJL model, we need a momentum cuto in num erical calculations. Therefore, we can not take the num erical results in high tem perature and high density regions seriously.
