R enorm alization of a gapless H artree-Fock approximation to a theory with spontaneously broken O (N)-symmetry

The renorm alization of a gapless -derivable H artree {Fock approximation to the O (N)-symmetric

⁴ theory is considered in the spontaneously broken phase. This kind of approach was proposed by three of us in a previous paper [1] in order to preserve all the desirable features of -derivable D yson-Schwinger resum mation schemes (i.e., validity of conservation laws and therm odynamic consistency) while simultaneously restoring the N am bu (G oldstone theorem in the broken phase. It is shown that unlike for the conventional H artree (Fock approximation this approach allows for a scale-independent renorm alization in the vacuum. How ever, the scale dependence still persists at nite tem peratures. V arious branches of the solution are studied. The occurrence of a limiting temperature inherent in the renorm alization scale is discussed.

I. IN TRODUCTION

Self-consistent -derivable approximations were introduced long ago in the context of the nonrelativistic manybody problem [2, 3] and then extended to relativistic quantum eld theory [4, 5]. Recently the interest in this method has been revived in view of its fruitful applications to calculations of the therm odynamic properties of the quark (gluon plasma [6] and to non-equilibrium quantum - eld dynamics [7, 8, 9], in particular in terms of the o -shell kinetic equation [10].

-derivable approximations are preferable for the dynamical treatment of a system, since they full the conservation laws of energy, momentum, and charge [3, 7, 10]. Moreover, the -derivable scheme also guarantees the therm odynamic consistency of an approximation [3], which makes it advantageous also for therm odynamic calculations. However, the -derivable scheme has its generic problem swhich were also realized long ago [5, 11].

The rstproblem is related to the fact that -derivable Dyson-Schwinger resummation schemes violate W ard{ Takahashi identities beyond the one-point level. This, in particular, results in the violation of the Nambu{ G oldstone (NG) theorem [5, 11, 12, 13] in the phase of spontaneously broken symmetry. On the other hand, so called \gapless" approximations [11] respect the NG theorem (which is referred to as the Hugenholtz{Pines theorem in physics of Bose{E instein condensed system s), though violate conservation laws and them odynamic consistency. In Ref. [13] it was shown that any derivable approximation can be corrected in such a way that it respects the NG theorem and becomes gapless. However, such modi cations again violate conservation laws and thermodynamic consistency and, hence, leads back to the problems of the gapless scheme. Recently three of us have proposed a phenomenological way to construct a \gapless -derivable" Hartree{Fock (gHF) approximation to the ⁴ theory in the phase of spontaneously broken O (N) symmetry [1]. This approximation simultaneously preserves all the desirable features of

-derivable schemes and respects the Nambu (Goldstone theorem in the broken phase. The treatment of Ref. [1] was based on a naive renormalization, where all divergent terms were simply om itted. This was done in order to avoid possible confusions between e ects of restoring the NG theorem and those related to renormalization. In the present paper we return to the issue of renormalization.

The renorm alization of the -derivable approximations is precisely the second main problem. Following Baym and Grinstein [5] it was believed that renormalization of -derivable approximations is possible only with medium

(e.g., tem perature) dependent counter term s, which is inconsistent with the goal of renorm alization. G reat progress in the proper renorm alization of such schemes was recently achieved in Refs. [13, 14, 16, 17, 18]. As the main result it was shown that partial resummation schemes can indeed be renorm alized with medium independent counter term sprovided the scheme is generated from a two-particle irreducible (2P I) functional, i.e., a -functional. Still, as we are going to demonstrate below, certain problem s remain in the case of spontaneously broken symmetry.

As an example case we investigate the 0 (N) model in the spontaneously broken phase which is a traditional

touchstone for new theoretical approaches, well applied to a variety of physical phenomena, such as the chiral phase transition in nuclear matter. Thus we continue the discussion of the \gapless Hartree Fock approxim ation started in the previous paper [1] and investigate its features towards renorm alization in comparison to the standard HF-approximation.

II. GAPLESS HARTREE {FOCK (gHF) APPROX IM AT IO N

W e consider the O (N)-m odel Lagrangian

where = (1; 2;:::; N) is an N-component scalar eld, ² = a a, with sum mation over a implied. For H = 0 this Lagrangian is invariant under 0 (N) rotations of the elds. If H = 0 and m² < 0, the sym metry of the ground state is spontaneously broken down to 0 (N 1), with N 1 G oldstone bosons (pions). The external eld H = H_h a is a term which explicitly breaks the 0 (N) sym metry. It is introduced to give the physical value of 140 M eV to the pion mass.

The elective action for this Lagrangian in the realtime form alism is de ned as (cf. Ref. [7])

In terms of the CJT formalism [4], the same e ective action is given as (e.g., cf. Ref. [8])

i.e., already in terms of the tree-level G reen's function, D $(1;2) = {}^{2}I = {}_{2}$ 1, and the full classical action of the $\,$ eld, I (). In the therm odynam ic lim it, the effective potential, $V_{C\,JT}$, and its interaction part, V_2 , are de ned as

Naturally, V_2 is similar to but is not quite the same. C ontrary to V_2 , the functional includes all 2P I interaction terms, i.e. also those of zero and rst loop order which result from interactions with the classical eld (rst two graphs in (4)).

The gHF approximation to the O (N) theory is dened by the functional [1]

where the diagram s on the rhs. constitutes the conventional HF approximation, while the phenomenological NG-theorem-restoring correction is specified below, see Eq. (9). Here the crossed pins denote the classical elds a, and loops are tadpoles

W ithin the -derivable scheme the rhs. of the equations of motion for the classical eld (J) and the G reen's function (self-energy) follow from the functional variation of $_{\rm gH\,F}$ with respect to the classical eld and G reen's function G, respectively

where D is the free propagator.

The correction, introduced in Ref. [1], is unambiguously determ ined proceeding from the following requirements: (i) it restores the NG theorem in the brokensymmetry phase, (ii) it does not change results in the phase of restored O(N) symmetry, because there is no need for it, (iii) it does not change the HF equation for the classical edd, since the conventional -derivable and gapless schemes [5, 11] provide the same classical-edd equation already without any modi cations. In particular, due to this latter requirement the correction does not contribute to the classical-edd equation (7). Proceeding from these requirements, this can be presented in manifestly O(N) symmetric form

The nature of this correction can be understood as follows. For the full theory, i.e., when all diagrams in the functional are taken into account, the gapless and - derivable schemes are identical and both respect the NG theorem. The conventional -derivable HF approximation om its an in nite set of diagrams which is necessary to restore its equivalence with the gapless scheme. The

correction to the HF approximation takes into account a part of those om itted diagrams (at the level of the actual approximation), and thus restores this equivalence in the pion sector. For the further discussion we switch to the notation in terms of the CJT elective potential, see e.g. [4, 19, 20], in order to comply with previous considerations in the literature.

The manifestly symmetric form of the CJT e ective potential in the gHF approximation reads

Since the self-energy (8) is momentum independent, the general form of the G reen's function can be written as follows

to Eq. (12), we project it on and states. In order to project the mean-eld equation (13) on the -direction, we just multiply it by $_{\rm c}$.

In the diagonal representation (\bigcirc 0, H = H and H = 0) these equations take the following form

where M² = $_{dc}M_{cd}^2$ and M² = $_{dc}M_{cd}^2$. Here we used Q = Q and Q = Q in terms of de nition (5). From these equations it is evident that the NG theorem is fullled. Indeed, in the phase of spontaneously broken symmetry (H = 0) the square-bracketed term of the eld equation (18) equals zero, which is precisely the pion mass, cf. Eq. (17). At the same time, as it has been demonstrated in numerous papers (see, e.g., Refs. [5, 11, 12, 19]), the solution of the conventional HF set of equations (7) { (8), i.e., without , violates the NG theorem . A detailed analysis of the conventional HF equations in a notation similar to ours has been given in Ref. [19].

III. RENORMALIZATION OF THE GHF APPROXIMATION

Signi cant progress in proper renormalization of -derivable approximations was recently achieved in Refs. [13, 14, 16]. Here we follow the renormalization scheme of Ref. [13], i.e., that constructed precisely for the conventional HF approximation to ⁴ theory in the $O\ (\!N\!$) broken phase. This renorm alization is based on the BPHZ form alism .

A. Equations of M otion

The equations of motion (16){(18) involve tadpole terms which, based on the explicit form of the G reen's function (11), can be written as

is regularized within dimensional regularization. Here ! 0, and is a regularization scale. We apply the same mass independent renorm alization conditions as in Ref. [13], i.e., that in the symmetric vacuum the selfenergies vanish [21]

for all a. Such a renorm alization scheme preserves the O (N) symmetry of the model [21]. Since $_{a}$ is momentum independent in the approximation under consideration, additionalmomentum -derivative conditions are not required. Upon application of this scheme, Eqs. (16) { (18) keep their form with the Q_a quantities substituted by the renorm alized tadpoles.

As it was shown in Ref. [13], this renorm alization description requires only vacuum (temperature independent) counter terms. For the sake of further discussion, note that according to Ref. [13] the renorm alization of the conventional HF approximation results in precisely the same equations as those in the CT scheme of Ref. [19], in spite of the di erent approaches used. The renorm alized conventional HF approximation was thoroughly studied in [19]. Therefore, those results are very useful for com – parison with the present treatment.

B. E ective Potential

The therm odynam ic potential (10) is renorm alized following the procedure outlined in Ref. [14]. In the gHF approxim ation complications arise only in the ln det G⁻¹ (k) term. Because of the topology of the diagram sused in the gHF approxim ation, for all other contributions to the e ective action, we only have to insert the already renorm alized self-energies, i.e., $Q_a^{(ren)}$ tadpoles of Eq. (26), to renorm alize them. This is legitim ate, because we do not encounter any additional contributions from subdivergences, cf. Ref. [14]. In the diagonal representation the rem aining part to be renorm alized takes the form

To renorm alize the e ective potential, we use a mass-independent renorm alization scheme in order to avoid e ects of unphysical IR singularities. We impose the following renorm alization conditions on the e ective potential

W e need precisely these three conditions to rem ove all the divergences. In posing these conditions, we keep in m ind that other parts of the e ective potential, except for L_a , have already been renorm alized such that they full lithese conditions on their own. This leads to

C. Vacuum (T = 0)

At T = 0, the quantities under investigation are \experimentally" know n^1 : M (T = 0) = m = 139 MeV, M (T = 0) = m = 600 MeV, and the pion decay constant $_0 = f = 93 MeV.At T = 0$ these known quantities should satisfy Eqs. (16) { (18) with renormalized tadpoles $Q_a^{(ren)}$, cf. Eq. (26),

The expressions manifestly show that the performed renormalization is -scale independent in the vacuum. Indeed, m² and can take any values depending on the choice of the renormalization scale , while the same observables keep their physical values at any renormalization scale (within a certain range of). In this respect, the gHF approximation is similar to the leading-order 1=N -approximation, where also both the NG theorem and scale-independent renormalization in the vacuum are fullled [19]. The restriction to a certain range is related to the conditions > 0 and m² < 0 which should be met. At the scale _0, determined by the equation

and m² become singular, cf. Eqs. (41) and (42). Moreover, $<_0$ implies m² > 0 and < 0, which defers a spontaneously broken phase and makes the theory unstable because of uncompensated attraction (⁴ < 0). Therefore, the range of scale independent renormalization in the vacuum is restricted from below by

The situation is completely di erent within the conventional HF approximation. In that case, physical observables do depend on the renormalization scale and can be reproduced only at a single value of the scale $^2 = m^2 = e$, as demonstrated in [19]. The reason of this di erence is that the conventional HF approximation of [19] violates the NG theorem at H = 0. This stems from the fact that the equations for the pion self-energy and the mean eld are not identical in the broken phase and thus leave three nondegenerate equations for three quantities m², and

, from which the value is unambiguously determined. In our case, this set of equations is degenerate, i.e., the equations for the pion self-energy and the mean eld are identical as a consequence of the full led NG theorem. This gives us freedom for an arbitrary choice of . Thus, we arrive at an important conclusion which concerns all partial resummation schemes applied to the case of spontaneously broken symmetry: a scale-independent renormalization in the vacuum is possible only if the scheme preserves the NG theorem. This is an important aspect with respect to possible renormalization-group considerations for this type of self consistent approximations. However, the scale dependence still persists at nite temperature, which is already seen from the analysis of the symmetry-restoration points.

D. Sym m etry R estoration Points at H = 0




FIG.1: M eson m asses as functions of tem perature for = 600 M eV and m = 0 case. Stable branch is presented by solid lines, whereas the m etastable one { by dashed lines.

Starting from the broken phase, where M 2 = 0 and 2 > 0, there exists a tem perature range T_R 2 [T₁;T₂], cf. Fig. 1 below, where the classical eld vanishes together with the pion m ass

This precisely occurs, when the two equations (17) and (18) reduce to a single one. Solving for this single equation with renormalized $Q_a^{(ren)}$ tadpoles (26) gives

where we have used Eqs. (41) and (42) to express m 2 and

in terms of the vacuum mass m . Strictly speaking, this is not a solution for $T_{\rm R}$, since the rh.s. of (46) still depends on $T_{\rm R}$ through M 2 ($T_{\rm R}$). Nevertheless, this expression is already quite simple to analyze.

The lower bound T_1 of condition (45) is of central im – portance for the phase transition in the conventional HF – approximation [1] but of minor relevance in the gHF – scheme, since it corresponds to the metastable solution, cf. Sect. IV below. It is determined if simultaneously also M² = 0 occurs

It is still -dependent, in spite of the scale-independent renorm alization in the vacuum. At large , i.e., above some $_1$, T_1^2 can even become negative, which means that then this solution does not exist.

For the stable solution of the gHF approximation it numerically occurs that M (T_R) m, cf. Ref. [1] and Sect. IV below. This almost removes the M (T_R) dependence from the r.h.s. of Eq. (46) and makes the corresponding temperature T_2 almost -independent

This value coincides with that of the naive renorm alization [1]. The solution T_2 corresponds to a partial sym metry restoration, since here we stillhave $M(T_2) \notin M(T_2)$ in spite of = 0.

IV. RESULTSFOR N = 4

For the num erical calculations we use the follow ing param eters: m = 600 MeV and f = 93 MeV. The pion m ass is either zero, m = 0, in the case of exact symmetry, or m = 139 MeV for the approximate symmetry. The general structure of the solutions to the renorm alized Eqs. (16) { (18) is similar to that obtained with the naive renorm alization [1] but with extra complications caused by the additional dependence on the renorm alization scale . A coording to Eq. (43) physically reasonable solutions exits only for > 0, where 0 as the solution of Eq. (43) equals ' 200 M eV for the above speci ed param eters.

There are several di erent branches of the solution. Stable and physically meaningful are determined by the principle of maximum pressure, the pressure being given by the elective potential (36)

Here the constant is determined by the condition that the pressure should vanish for the physical vacuum, i.e., in the spontaneously broken phase, while our renorm alization condition (32) determines $V_{gHF}^{(ren)}$ to be zero in the unphysical, symmetric vacuum.

A. Exact O (4) Sym m etry

The actual structure of the solution depends on the renormalization scale . We start with a moderate scale = 600 MeV, i.e., of the order of m . The results are presented in Figs.1{5.




FIG. 2: The same as in Fig. 1 but for the pressure di erence between stable and m etastable branches.




FIG.3: The same as in Fig. 1 but for the eld .

In the narrow tem perature range, displayed in Fig. 1, the results are qualitatively similar to those obtained with the naive renormalization [1]. The stable branch starts at T = 0 from the physical vacuum values for the m asses and the classical eld and crosses the m etastable branch at T_{cross} 440 MeV. In terms of the pressure, they are touching rather than crossing (see Fig. 2). Therefore, no transition from one branch to another occurs at $\ensuremath{\mathtt{T}_{\mathrm{cross}}}$. In the broken-symmetry phase, the pion m ass equals zero. Then a phase transition of the second order occurs at $T_{\rm 2}$ ' 180 MeV, at which the $% T_{\rm 2}$ eld becom es zero (see Fig. 3). How ever, the and m asses still di er beyond this transition point. They become equal only after a second phase transition, which is also of second order, at T_{cross}. Note that the equal-m ass solution above T_{cross} is precisely the same as in the conventional HF approximation (cf. Refs. [13, 19]), since the gapless modi cation term (9) vanishes in this case. The

 T_1 point proves to be irrelevant for the stable branch. Rather it is the starting point for the m etastable branch, which in the range of $T_1 < T < T_{\rm cross}$ precisely coincides with the solution of the conventional HF approximation [13, 19]. The corresponding eld is always zero for this branch. Contrary to the case of the naive renormalization [1], thism etastable branch ends at some tem perature ($650~{\rm M~eV}$).




FIG. 4: M eson m asses of Fig. 1 but in wider temperature region. The upperm etastable branch is displayed by the long-dashed line.

However, in the wider tem perature range, displayed in Fig. 4, we see a signi cant di erence from the results obtained with the naive renorm alization [1]. Neither stable nor m etastable solutions exist above a certain tem – perature T_{end} which is 1:15 GeV for the considered = 600 MeV. Let us rem ind that this solution above T_{cross} corresponds to the conventional HF approximation. Therefore, it is precisely the same as in previous conventional HF calculations with renorm alization [13, 19]. The occurrence of such an end point in the HF approximation was rst pointed out by Baym and Grinstein [5].

At T_{end} , the stable branch of the solution joins the upper branch. This upper branch at any tem perature corresponds to equal masses and zero eld, i.e., M = M and




FIG. 5: The same as in Fig. 4 but for the pressure.

= 0, and hence is also a solution to the conventional renorm alized HF approximation. It starts with very high values of masses (3 GeV) in the vacuum and also ends at T_{end} . The vacuum pressure for this branch, evaluated according to Eq. (49), is rather high (see Fig. 5).

It is important note that for the upper branch and at tem peratures near the endpoint the logarithm ic term s in the gap equation, $/\ln M^2 = ^2$), become large. This indicates that at such points the expansion of the functional in powers of the renormalized coupling becomes unreliable, because the elective coupling becomes large. Therefore we consider the upper branch not a physically meaningful solution. The same holds true for temperatures close to the endpoint temperature. Such a behavior must be expected for any elective theory and was indeed also observed in Quantum H adro D ynam ics (QHD) in [15].




FIG.6: M eson m asses as functions of tem perature for = 1200 MeV and m = 0 case. Stable branches are presented by solid lines, whereas m etastable ones by dashed lines.




FIG. 7: Zoom ed low-tem perature region of Fig. 6.

At larger renorm alization scales, , the global pattern of the solution remains qualitatively similar, as seen from Fig. 6. Only $T_{\rm cross}$ and $T_{\rm end}$ move to higher temperatures. Inspecting the low-temperature region in more detail, cf. Fig. 7, we see that a new metastable solution, which ends already at rather low temperature, appears.




FIG.8: The same as in Fig. 6 but for the eld .

This new solution has a nonzero eld (Fig. 8) but violates the NG theorem. In addition the metastable solution, which before started at T_1 , now begins at zero tem perature, since at = 1.2 GeV we have already $T_1^2 < 0$, cf. Eq. (47).

If we take a low value for the scale , the structure of the stable solution becom esm ore involved, see F igs.9{11. In the broken-sym m etry sector we still have a massless pion and a nonzero eld, see F ig.10. How ever, at higher tem peratures the m etastable branch, displayed by the dotted line, reveals back-bending. This back-bended part of the branch turns out to be the most stable one, see F ig.11. A s a result we arrive at a com plicated structure for the stable solution, where even the pressure turns out to be discontinuous.

A common feature for all scales is that the point of the rst phase transition, T_2 ' 180 MeV, is approximately -independent and has about the same value as that in the naive renormalization scheme [1]. At the same time, the point of the second phase transition, $T_{\rm cross}$, and the end point of the stable solution, $T_{\rm end}$, are essentially -dependent.

B. Approxim ate O (4) Sym m etry

In the case of explicitly broken symmetry (m = 139 MeV), the structure of solutions at various scales is similar to that described above for the chiral limit. Even the behavior of metastable branches remains similar. We illustrate the changes on the example of = 600 MeV, see Figs. 12{14 which looks the most physically appealing and is close to results of the naive renormalization [1]. The main di erence from the m = 0 case is that the sequence of two phase transitions is transform ed here into a smooth cross-over transition.

V. CONCLUSION

W e have studied a renorm alized version of the gapless -derivable HF approximation to the 4 theory with spontaneous breaking of the O (N) symmetry, proposed in Ref. [1]. This gHF approximation simultaneously preserves all the desirable features of -derivable approximation schemes (i.e., the validity of conservation laws and thermodynamic consistency) and respects the NG theorem in the phase of spontaneously broken symmetry.




FIG.9: M eson m asses as functions of tem perature for = 300 M eV and m = 0 case. Stable branches are presented by solid lines, whereas m etastable ones { by dashed lines.




FIG.10: The same as in Fig. 9 but for the eld .

This is achieved by adding a correction to the conventional functional. The nature of this correction can be understood as follows. The conventional -derivable HF approximation cuts o an in nite series of diagrams, am ong which are those providing the NG theorem in the phase of spontaneously broken symmetry. By introducing the correction to the HF approximation we take into account a part of those om itted diagrams (at the level of the actual approximation), which restores the NG theorem.

An advantage of the gHF approximation is that it allows for scale-independent renormalization in the vacuum, unlike the conventional HF approximation [19]. The scale independence in the vacuum is a direct consequence of the NG theorem, which makes the equations for the pion self-energy and classical eld degenerated. However, even in the gHF approximation, only renormalization scales higher than a certain value ($_0$, cf. Eq. (43)) are allowed, in order to ensure stability of the renormalized approximation.

N evertheless, the scale dependence still persists at nite tem peratures. The violation of renorm alization-scale independence of -derivable approxim ations was shown




FIG.11: The same as in Fig. 9 but for the pressure.




FIG.12: M eson m asses as functions of tem perature for = 600 MeV and m = 139 MeV case. Stable branches are presented by solid lines, whereas m etastable ones { by dashed lines.

in [23, 24] from the point of view of the renorm alizationgroup function. There the function, evaluated from the -functional form alism, was shown to deviate from its perturbative expansion, beginning at orders in the expansion parameter, higher than that explicitly taken in the functional. The reason is the violation of \crossing sym metry" in the sense of [14]: Solving the self-consistent equations of motion corresponds to a partial resum m ation of diagram s to any order in the expansion parameter (e.g., the coupling constant or ~, i.e., the order of bops in perturbative Feynm an diagram s) which is necessarily incom plete for any truncation of the functional.

W ithin our renorm alization scheme, it becomes clear that the renorm alization-scale dependence at nite temperatures originates from the subtraction of the hidden subdivergence" of the four-point function inside the self-consistent tadpole loop. As shown in [14], this four-point function consists of a resummation in only one channel, and thus the function of the scheme med four-point function deviates from the correct one at orders higher than contained in the approximation of the -functional, i.e., to O (2).




FIG.13: M eson m asses of Fig.12 but in wider temperature region.




FIG.14: The same as in Fig.12 but for the eld

At large scales (& m) the chiral phase transition proceeds similar to that in the naive renormalization scheme [1]. In the case of the exact O (N) symmetry, it proceeds through a sequence of two second-order phase transitions rather than a single one. In the st transition the mean eld vanishes but the meson masses still rem ain di erent. The tem perature of this phase transition, T_2 ' 180 M eV, is approximately -independent and has approxim ately the sam e value as that in the naive renormalization scheme [1]. In the second transition also the masses become equal, and the O (N) symmetry is completely restored. The corresponding tem perature, T_{cross}, turns out to be essentially -dependent. W hen the O (N) sym m etry is explicitly violated, the sequence of two phase transitions is transform ed into a sm ooth cross-over transition. Moreover, at 'm the results are even qualitatively close to those obtained with the naive renorm alization [1]. At sm all scales (say m = 2), the phase structure becom es very com plicated, how ever still respecting the NG theorem in the phase of spontaneously broken sym m etry.

A nother result concerns both the conventional renorm alized HF and gHF approxim ations, which in fact are identical in the phase of restored 0 (\mathbb{N}) sym m etry. There

exists an end point of the solution, i.e., a tem perature Tend above which there are no solutions to the gap equations. The occurrence of such an end point in the HF approximation was rst pointed out by Baym and Grinstein [5] and is caused by the dom inant role of $\ln (M^2 = 2)$ terms in the gap equations, which originate from the renormalization procedure. The dominant behavior of the $\ln (M^2 = 2)$ terms signals a breakdown of the HF approximation and the need to include higher-order corrections into the functional [5]. Another interesting question is whether one can nd a renorm alization-group improved -derivable approximation to cure this problem. We have found that at low scales (like . m = 2), the end point appears at rather low tem peratures, leaving almost no room for the HF (as well as gHF) approxim ation in the phase of restored O(N) symmetry. At the same time, at (& m), the end point moves to rather high energies $T_{end} \& 1:2 \text{ GeV}$, hence allowing this approximation at least at T . 1 G eV .

Sum m arizing, we have found that the gHF approxim ation is certainly advantageous as compared to the conventional HF one, since it respects the NG theorem and allows scale-independent renorm alization in the vacuum. These properties are closely interrelated. They both require that the set of equations of motion are degenerate in the phase of spontaneously broken sym m etry. Nevertheless, there still are serious problems with the renorm alization of -derivable approximations for a theory with a spontaneously broken sym m etry. At nite tem peratures the predictions of renorm alized gHF approximations es-

sentially depend on the renorm alization scale, contrary to the case of the renorm alized perturbation theory. In this respect, the gHF approximation becomes similar to the leading-order 1=N -approximation, where also both the NG theorem and scale-independent renormalization in the vacuum hold true [19]. However, in view of the medium -independent renormalization performed in accordance with Refs. [13, 14, 16], this scale-dependence at nite temperatures cannot be already interpreted as an artifact of temperature-dependence is a consequence oftriviality of the ⁴ theory [25] which, when it is renormalized, therefore requires an external scale to serve for a scale, below which it can be used as an elective eld theory to describe the low-energy phenom enology.
