# Vortices in gauge models at nite density with vector condensates

There exists a class of gauge models incorporating a nite density of matter in which the Higgs mechanism is provided by condensates of gauge (or gauge plus scalar) elds, i.e., there are vector condensates in this case. We describe vortex solutions in the simplest model in this class, the gauged SU (2) U (1) $_{\rm Y}$  -model with the chemical potential for hypercharge Y , in which the gauge symmetry is completely broken. It is shown that there are three types of topologically stable vortices in the model, connected either with photon eld or hypercharge gauge eld, or with both of them. Explicit vortex solutions are numerically found and their energy per unit length are calculated. The relevance of these solutions for the gluonic phase in the dense two-avorQCD is discussed.

### I. INTRODUCTION

Vortices are very special soliton-like excitations. In condensed matter physics, vortex solutions were discovered by Abrikosov [1]: They play a crucial role in the dynamics of type II superconductors. In relativistic quantum eld theory, vortices were rst considered by Nielsen and Olesen [2]. They can be important in cosmology, astroparticle physics, and for the connem ent dynamics in QCD-like theories (for reviews, see Ref. [3]). Vortex and vortex-like solutions in relativistic models at nite density of quark matter were studied in Ref. [4].

The existence of vortex solutions is usually connected with the Higgs mechanism in abelian U (1) gauge dynamics. The major degrees of freedom are a complex scalar Higgs—eld and a U (1) gauge—eld. In this paper, we will describe vortex solutions in a somewhat dierent class of gauge models incorporating a nite density of matter. The Higgs mechanism in these models is provided by condensates of gauge (or gauge plus scalar)—elds, i.e., there are vector condensates in this case. This class in particular includes the SU (2)<sub>L</sub>—U (1)<sub>Y</sub>—electroweak theory in the presence of a superdense ferm ionic matter [5, 6], (nonrenormalizable) models including massive vector bosons with a chemical potential for electric charge [7], and the gauged linear SU (2)<sub>L</sub>—U (1)<sub>Y</sub>—model (without ferm ions) with a chemical potential for hypercharge Y [8].  $^{1}$ 

It is also noticeable that a recently revealed gluonic phase in neutral two—avor quark matter [12] also relates to this class. In the gluonic phase, vector condensates of gluons cure a chrom om agnetic instability [13] in the two—avor superconducting (2SC) solution and lead to spontaneous breakdown of the SU (2)<sub>c</sub>  $\mathbb{U}$  (1)<sub>em</sub> SO (3)<sub>rot</sub> sym metry down to SO (2)<sub>rot</sub>. Here SU (2)<sub>c</sub> and  $\mathbb{U}$  (1)<sub>em</sub> are the color and electrom agnetic gauge sym metries in the 2SC medium, and SO (3)<sub>rot</sub> is the rotational group (recall that in the 2SC solution the color SU (3)<sub>c</sub> is broken down to SU (2)<sub>c</sub>). In other words, the gluonic phase describes an anisotropic medium in which the color and electric superconductivities coexist. Because it is naturally to expect that cold quark matter may exist in the core of compact stars (for reviews, see Ref. [14]), it would be of great interest to describe the dynamics of this phase in more detail, in particular, to clarify whether vortex excitations exist there.

Since the dynamics of the gluonic phase is very rich and complicated, as a rst step, it would be appropriate to use a

sim pler model relating to the sam e universality class, i.e., with the sam e sam ple of the sym metry breaking. Fortunately, such a model exists: It is the gauged—model with the chemical potential for the hypercharge introduced and studied in Ref. [8]. Let us describe it in more detail. Its Lagrangian density reads (we use the metric g = diag(1; 1; 1; 1)):

where the covariant derivative D = @ igA (ig^0=2)B , is a complex doublet eld  $^T$  = (' + ;' 0), and the chem ical potential is provided by external conditions (to be specific, we take > 0). Here A = A a = 2 are SU(2)\_L gauge elds (a are three Paulim atrices) and the eld strength  $F^{(a)}$  = @ A (a) @ A (a) + g abc A (b) A (c) . B is a U (1) gauge eld with the eld strength  $F^{(Y)}$  = @ B @ B . The hypercharge of the doublet equals + 1. This model has the same structure as the electroweak theory without fermions and with chemical potential for hypercharge Y . Note that the terms with the chemical potential are SU(2)\_L U(1)\_Y (and not SU(2)\_L SU(2)\_R) symmetric. This follows from the fact that the hypercharge generator Y is Y =  $2I_R^3$  where  $I_R^3$  is the third component of the right handed isospin generator. Henceforth we will omit the subscripts L and R, allowing various interpretations of the SU(2).

Because the chem ical potential explicitly breaks the Lorentz sym m etry, the sym m etry of the model is SU (2) U (1) $_{\rm Y}$  SO (3) $_{\rm rot}$ . As was shown in Ref. [8], for su ciently large values of the chem ical potential , the condensates of both the scalar doublet and the gauge eld A occur. These condensates break the sym m etry SU (2) U (1) $_{\rm Y}$  SO (3) $_{\rm rot}$  down to SO (2) $_{\rm rot}$ . This is the same sym m etry breaking pattern as in the gluonic phase of dense QCD [12], while the gauged -m odel is much simpler: It is renormalizable and for small coupling constants g,  $g^0$  and , the tree approximation is reliable there.

As will be shown below, topologically stable vortex solutions exist in this model indeed. Their structure is much richer and more complicated than that in the Abelian gauge model. In particular, there are dierent types of vortices connected either with photon eld or hypercharge gauge eld B, or with both of them.

The paper is organized as follows. In Section II, a general analysis of vortex solutions in this model is realized. We discuss a topological stability of these solutions and introduce three types of vortices: Magnetic vortices, hypermagnetic vortices, and hybrid ones. They are connected with photon eld, hypercharge eld B, and both of them, respectively. In Section III, an explicit solution for magnetic vortices is obtained. In Sections IV and V, explicit solutions for hypermagnetic vortices and hybrid ones, respectively, are derived. In Section VI, we sum marize the main results of the paper.

### II. VORTEX SOLUTIONS: GENERAL CONSIDERATION

The equations of motion in the gauged -model at nite density follow from Lagrangian (1):

As was shown in Ref. [8], for su ciently large values of the chemical potential, the vacuum solution of (2)-(4) is given by

W  $^{(\ )}=\frac{1}{2}$  (A  $^{(1)}$  iA  $^{(2)}$ ),  $^{T}=('^{+};'_{0})$  and all other elds are equal to zero.  $^{2}$  It is clear that this solution in plies that the initial sym m etry SU  $^{(2)}$  U  $^{(1)}$ Y SO  $^{(3)}$ rot is spontaneously broken down to SO  $^{(2)}$ rot. In particular, the electrom agnetic U  $^{(1)}$ em, with electric charge Q  $^{(2)}$ em =  $^{(1)}$ 4 Y = 2, is spontaneously broken by the condensate of W bosons, i.e., electric superconductivity takes place in this medium.

Note that because the U (1) $_Y$  symmetry is local, for nonzero chemical potential one should introduce a source term  $B_0J_0$  in Lagrangian density (1) in order to make the system neutral with respect to hypercharge Y . This is necessary since otherwise in such a system thermodynamic equilibrium could not be established. The value of the background hypercharge density  $J_0$  (representing very heavy particles) is determined from the requirement that  $B_0=0$  is a solution of the equation of motion for  $B_0$  (G auss's law) [8, 15]. There exists an alternative description of this dynamics in which a background hypercharge density  $J_0$  is considered as a free parameter and is taken to be zero. Then G auss's law will de ne the vacuum expectation value  $B_0$ i. It is not discult to check that these two approaches are equivalent if the chemical potential in the rst approach is taken to be equal to the value  $\frac{g^0}{2}hB_0$  i from the second one. In this paper, following Refs. [8, 15], we use the rst approach.

As was shown in Ref. [8], in accordance with the sample of spontaneous breakdown of the global symmetry,  $SO(3)_{rot}$ !  $SO(2)_{rot}$ , there are two gapless NG bosons in this model. The other excitations are massive (the Higgs mechanism). Because electric superconductivity is realized in the model, it is naturally to expect that vortices may exist there. As will be shown in this paper, this is indeed the case.

Vortices are topologically nontrivial con gurations with elds approaching their vacuum values at spatial in nity [3]. Mathematically, vortices are topologically stable whenever the rst hom otopy group  $_1$  ( $G_{int}=H_{int}$ ) of the vacuum manifold  $G_{int}=H_{int}$  is nontrivial (here  $G_{int}$  is an internal symmetry group of the action in a model and its subgroup  $H_{int}$  is a symmetry group of the vacuum.) We emphasize that this criterion of the topological stability is su cient but not necessary. In particular, as will be shown below, magnetic vortices, the most interesting vortex solutions in the present model, are topologically stable due to another criterion.

A coording to Eq. (5), two complex elds  $W_z^{()}$  and  $'_0$  have nonzero vacuum expectation values in the ground state of the gauged -m odel at nite density. Therefore a priori there can be different types of topologically stable vortex solutions: Both the eld  $W_z^{()}$  and the eld  $'_0$  can wind around the spatial circle at in nity. I.e., in the cylindrical coordinates (t; ; ; z), as ! 1, the asymptotics of these elds take the form

where l and n are integer. Let us turn to the analysis of a topological stability of solutions with these asymptotics. In this model, the internal group  $G_{\rm int}$  is SU(2) U  $(1)_{\rm Y}$  and the symmetry group  $H_{\rm int}$  of vacuum (5) is trivial. Therefore the rst hom otopy group of the vacuum manifold in the model is  $_1$  ( $G_{\rm int}=H_{\rm int}$ ) =  $_1$  (SU(2)) U  $(1)_{\rm Y}$ ) =  $_1$  (SU(2)) +  $_1$  ( $U(1)_{\rm Y}$ ) =  $_1$  ( $U(1)_{\rm Y}$ ) =  $_2$ , where Z is the group of integer numbers (here we use the fact that since the SU(2) manifold is simply connected,  $_1$  (SU(2)) = 0). This seems to suggest that there exist only topologically stable vortex solutions connected with the hypercharge  $U(1)_{\rm Y}$ . However, as will be shown below, the situation in this model is more sophisticated and there exist also other topologically stable vortices. The point is that while the scalar eld is assigned to the fundamental representation of the SU(2) group, the gauge eld  $A^{(a)}$  is assigned to the adjoint one. Because of that, SU(2) gauge transform ations for  $A^{(a)}$  reduce to SO(3) ones. It is in portant that, unlike SU(2), the manifold of SO(3) is not simply connected and  $_1$  (SO(3)) =  $_2$  with  $_2$  = 0;1. As will become clear in a moment, this point is quite in portant in the analysis of the topological stability of the solutions.

We begin by considering the conventional case when l = 0 in asymptotics (7):

This con guration can be obtained from the vacuum con guration (5) by using the U (1) gauge transform ation  $e^{in\ Y}$ . It is clear that in this case the solutions with dierent n are assigned to dierent topological classes described by the hom otopy group  $_1$  (U (1) $_Y$ ) = Z. Therefore, if such vortex solutions exist, they are topologically stable. Due to the evident reasons, we will call them hyperm agnetic vortices. They possess hyperm agnetic uxes with a (hyperm agnetic) winding number H = n.

Let us now turn to a more interesting case of asymptotics (7) with n = 0:

It is a rather unusual situation: The phase 1 is now related to a vector eld and not to a scalar one. It is clear that con guration (9) can be obtained from vacuum con guration (5) by using the gauge transform ation

where electric charge  $Q_{em} = I_3 + Y = 2$  is equal to -1 for the eld  $W_z^{()}$  and zero for the scalar eld  $'_0$ .

Because for the vector elds the SU (2) transform ations are reduced to the SO (3) ones, it is in portant to distinguish two cases: with 1 being even and 1 being odd. In the rst case, with 1=2k, as the angle running from 0 to 2, the gauge transform ation (10) de nes closed loops both on the manifold of SU (2) and that of U (1). Then, because  $_1$  (SU (2)  $_1$  U (1) $_2$  ) =  $_1$  (U (1) $_2$ ) =  $_2$ , we conclude that these solutions are topologically equivalent to the hyperm agnetic vortex solutions with the winding number H =  $_1$  k considered above.

The case with odd l=2k+1 ism ore sophisticated. In this case, as changing from 0 to 2, the gauge transform ation (10) does not de ne closed loops neither on the SU (2) manifold nor on the U (1) one. Therefore in this case one cannot use the hom otopic group  $_1$  (SU (2)  $_1$  U (1) one transform at the topological stability of these solutions. Let us show that for this purpose one can use the hom otopic group  $_1$  (SO (3)) instead. The reasons are the following. Because the hypercharge of the gauge  $_1$  eld  $_2$  is zero, the action of the gauge transform ation (10) on it is given by the operator  $_1$  (SO (3)) in transform ation (10) on it is given by  $_2$  this transform ation does do not a closed loop on the SO (3) manifold, which coincides with the vacuum manifold of  $_2$  in the description of the topological stability of these solutions.

Now, because odd values of l correspond to the element + 1 of  $_1$  (SO (3)) =  $Z_2$ , we conclude that this loop cannot be unwinded and, therefore, these vortex solutions are topologically stable. Due to the form of gauge transform ation (10), we will call them magnetic vortices. They possess magnetic uxes with a (magnetic) winding number M=(2k+1): The minus sign here corresponds to a negative electric charge of W bosons. A detailed study of the topological structure of the set of these solutions is beyond the scope of this paper. Here we will only argue that the solutions with dierent values of K are topologically inequivalent. The argument is based on gauge transform ation (10). It implies that although for odd L = L + 1 the path defined by this transform ation on the L (L) manifold is not closed, it contains L windings. Therefore the solutions with dierent L should be assigned to dierent topological classes, i.e., they cannot be transformed from one into another by using a continuous deformation.

The last case is that with the \hybrid" asymptotics

with both land n being nonzero. In this case the gauge transform ation (10) is replaced by

U sing the same arguments as above, we conclude the following. For even l=2k, these solutions are topologically equivalent to the hypermagnetic vortices with uxes corresponding to the winding number H=n-k. As to odd l=2k+1, they yield new topological classes of solutions. These solutions carry both magnetic and hypermagnetic uxes with winding numbers (M;H), with M taking odd integers l=(2k+1) and H=n. It will be shown in Sec. V that the hybrid vortices can be considered as composites of the magnetic and hypermagnetic ones.

As to the topological structure of the solutions for hybrid vortices with odd l = 2k + 1, a comparison of Eq. (12) with Eq. (10) suggests the following generalization of the conclusion that was made above for the case of the magnetic vortices: The hybrid vortices with dierent n k are topologically inequivalent.

This concludes the analysis of the topological stability of vortex solutions. As will be shown below, these three types of vortex solutions exist in the present model indeed.

#### III. MAGNETIC VORTICES

In this section, we will analyze the solutions for the magnetic vortices having asymptotics (9) with 1 being odd. To be concrete, we will take l = 1. In accordance with the discussion in the previous section, one should expect that the magnetic winding number M equals +1 in this case.

Vortex solutions are static z-independent con gurations. We will consider the following ansatz for them in the cylindrical coordinates (t; ; ; z) (the reasons for choosing this ansatz will be discussed in more detail below):

where A and Z are angular components of the electromagnetic eld A =  $\frac{g^0 A}{P} \frac{^{(3)} + gB}{g^2 + g^{02}}$  and the Z-boson eld Z =  $\frac{gA}{P} \frac{^{(3)} - g^0 B}{g^2 + g^{02}}$  (all other components of the elds are equal to zero).

U sing equations of motion (2)-(4), one can check that ansatz (13) is consistent with them and they reduce to the following system of ve coupled nonlinear ordinary dierential equations:

Note that although the phase in the exponent  $e^{-i}$  in W  $_z^{(-)}$  in Eq. (13) is of the electrom agnetic U (1)<sub>em</sub> origin, this ansatz contains in addition also Z eld. This is because the W condensate m ixes the gauge elds A and Z (see Eqs. (16) and (17)).

It is instructive to compare ansatz (13) and equations of motion (14)-(18) with those in the Abelian Higgs model. Obviously, W  $_{\rm Z}^{(\ )}$  plays the role of the Higgs eld. The elds A and Z are analogous to the Abelian gauge eld. The elds A $_{\rm t}^{(3)}$  and v do not have analogs in the Abelian Higgs model. Of course, they are present in ansatz (13) in order to ensure the correct vacuum asymptotics at in nity. Thus, the elds A $_{\rm t}^{(3)}$  and v have a somewhat dierent status in the vortex ansatz comparing to the elds W $_{\rm Z}^{(\ )}$ , A , and Z . We will discuss this point in more detail below, when we consider the ultraviolet boundary conditions for these elds.

The infrared boundary conditions at ! 1 follow from the requirement of niteness of the energy per unit length of a vortex, which implies that elds tend to their vacuum values:

As to the ultraviolet boundary conditions at = 0, because = 0 is a regular singular point of the system of di erential equations (14)-(18), these boundary conditions follow from the equations them selves if one utilizes the condition of regularity of the solution at this point:

The ultraviolet boundary conditions (20) for the elds W and A , Z are like those for a H iggs eld and a gauge eld, respectively, in the Abelian H iggs m odel: they guarantee that these elds are single valued at = 0. Unlike them , the elds  $A_t^{(3)}$  and v have N eum ann boundary conditions which im ply that there is no in ux of m om entum for these elds at the boundary = 0.

We solved numerically Eqs. (14)-(18) with boundary conditions (19)-(21) by using MATLAB. To be concrete, we considered the case with m  $^2$  > 0 and chose the parameters and  $gv_0 = \frac{1}{2}$  as in Ref. [8]: =m = 1:1 and  $gv_0 = \frac{1}{2}$ m = 0:1. For the values of the coupling constants g and  $g^0$  we used those from the electroweak theory: g = 0.65 and  $g^0 = 0.35$ . Then, using Eq. (6), one gets the value of the coupling constant : = 0.53. Therefore we work in the weak coupling regime when the tree approximation is reliable.




FIG. 1: D im ensionless elds  $\frac{W}{m}$ ,  $\frac{A_{t}^{(3)}}{m}$ ,  $\frac{A}{m}$ ,  $\frac{Z}{m}$ , and  $\frac{V}{m}$  as functions of r=m for the magnetic vortex solution.

The solution is shown in Fig. 1, where dimensionless elds W =m ,  $A_t^{(3)}$  =m ,  $A_t^{(3$ 

Substituting ansatz (13) into Eq. (1), we calculate the e ective potential (V = L):

Subtracting the energy density of the vacuum solution, we  $\,$  nd that the energy of the magnetic vortex per unit length is equal to 1.27 in units of m  $^2$ .

Note that the SU(2) U(1) $_{\rm Y}$  invariant de nition of the electrom agnetic eld strength  ${\rm F}^{\rm (em\ )}$  is

For the vortex solution with ansatz (13), it yields the conventional relation for the magnetic eldf:

It is well known that the magnetic ux of vortices is quantized and related to the winding number, which is a topological invariant. It is easy to check that this property takes place in the present case. Indeed, as follows from Eqs. (16) and (17), while the eld A has the asymptotics  $\frac{1}{e}$  as  $\frac{1}{e}$  1 (with  $e = \frac{p \cdot g \cdot g^0}{g^2 + g^{02}}$ ), the eld Z rapidly decreases in this limit. Therefore we not that for the magnetic vortex only the ux related to the electromagnetic eld A is nonzero. Then, using Eq. (24), we get:

I.e., as was expected, this vortex solution corresponds to the winding number +1.

### IV. HYPERMAGNETIC VORTICES

A hyperm agnetic vortex possesses asymptotics (8). To be concrete, we will take n = 1. As follows from the discussion in Sec. II, the hyperm agnetic winding number H should be now equal to -1.

In this case, we will use the following ansatz:

For this ansatz, the equations of motion (2)-(4) yield

The infrared boundary conditions for the hyperm agnetic vortex ansatz at ! 1 are the same as for the magnetic vortex and given in Eq. (19). The ultraviolet boundary conditions at = 0 are




FIG .2: D im ensionless elds  $\frac{W}{m}$ ,  $\frac{A_{t}^{(3)}}{m}$ ,  $\frac{A}{m}$ ,  $\frac{Z}{m}$ , and  $\frac{V}{m}$  as functions of r=m for the hypermagnetic vortex solution.

Comparing these boundary conditions with those in Eqs. (20) and (21) for the magnetic vortex, one can see that the ultraviolet boundary conditions for W and vare now interchanged. Of course, this point is related to the fact that the phase in the scalar eld  $'_0$  (and not vector eld W) is relevant for the hypermagnetic U (1) vortex. The numerical solution of Eqs. (27)-(31) with boundary conditions (19), (32), and (33) is shown in Fig. 2, where we use the same set of parameters as for the magnetic vortex.

The e ective potential for ansatz (26) is

Subtracting the energy density of the vacuum solution, we nd that the energy density of the hyperm agnetic vortex per unit length in units of  $m^2$  is equal to 0.79.

It follows from Eqs. (29) and (30) that A and Z have the asymptotics  $\frac{p^2q}{g^0}$  and  $\frac{p^2}{g^2+g^{\infty}}$  as ! 1. Therefore, the uxes of both elds A and Z are nonzero

It is not discult to see that these two uxes correspond to the hypermagnetic ux of the U ( $1_x$ ) gauge eld B (the hypermagnetic ux of the A<sup>(3)</sup> eld is zero):

Note that because the coupling of the Higgs eld with the eld B in the covariant derivative D = Q = Q = Q. (ig = 2) B is expressed through Q = Q = Q rather than Q = Q, this ux corresponds to the winding number -1, as was expected.

### V. HYBRID VORTICES

The hybrid vortex solutions carry both the magnetic and hyperm agnetic uxes with winding numbers (M; H). Their asymptotics are given in Eq. (11). To be concrete, we will consider the solutions with l=1; n=1 corresponding to (M; H) = (1; 1), i.e., we consider hybrid vortices with the equal and opposite phases of the W $_z$  and  $_0$  elds. C learly, the ansatz for these vortices should have the form

The equations of motion for these vortices are sort of a combination of the equations of motion for the magnetic and hypermagnetic ones:




FIG .3: D im ensionless elds  $\frac{W}{m}$ ,  $\frac{A_t^{(3)}}{m}$ ,  $\frac{A}{m}$ ,  $\frac{Z}{m}$ , and  $\frac{V}{m}$  as functions of r=m for the hybrid vortex solution with equal phases.

Note that in contrast to the cases of the magnetic and hypermagnetic vortices, now both functions W () and V () have the D irichlet boundary conditions at W = 0. The reason of this is clear: Because both W = 0 and V and V and V have nontrivial phases for hybrid vortices (38), the regularity of solutions at W = 0 can be ensured only if the moduli of these elds vanish at this point.




FIG. 4: D im ensionless elds  $\frac{W}{m}$ ,  $\frac{A_{t}^{(3)}}{m}$ ,  $\frac{A}{m}$ ,  $\frac{Z}{m}$ , and  $\frac{v}{m}$  as functions of r=m for the hybrid vortex solution with opposite

The num errical solutions of Eqs.(39)-(43) with boundary conditions (19), (44), and (45) are shown in Fig. 3 and Fig. 4. For these solutions, the same set of parameters was used as in the previous cases.

Subtracting the energy density of the vacuum solution, we nd that in units of m2, the energy per unit length of

hybrid vortices with the equal and opposite phases are equal to 1.49 and 2.3, respectively.

It follows from Eqs. (41) and (42) that A and Z have the asymptotics  $\frac{g^2(1 p^2) + g^{02}}{gg^0}$  and  $\frac{p}{g^2 + g^{02}}$  as Therefore, the uxes of hybrid vortices are equal to

where  $F_{\text{em};Z}^{\text{(M)}}$  and  $F_{\text{em};Z}^{\text{(H)}}$  are the uxes of the magnetic and hypermagnetic vortices given by Eqs.(25) and (35), (36), respectively (recall that  $F_{Z}^{\text{(M)}} = 0$ ). This suggests that the hybrid vortices can be considered as composites of the magnetic and hypermagnetic ones. Note that the sum of the energies per unit length for the magnetic vortex and the hypermagnetic one is equal to 1.27 + 0.79 = 2.06. On the other hand, because the energies for the hybrid vortices with = + and = - are equal to 1.49 and 2.3, respectively, they satisfy the inequality 1.49 < 2.06 < 2.3. This inequality in plies that while the hybrid vortex with equal phases is stable, the hybrid vortex with opposite phases is not.

#### VI. CONCLUSION

The set of vortex solutions we obtained in the gauged SU (2) U  $(1)_Y$  —m odel with the chemical potential for hypercharge is quite rich. In particular, there are dierent types of vortices connected either with photon eld or hypercharge gauge eld, or with both of them. The richness of this set is provided by the structure of the ground state (5), which includes vector condensates. This ground state describes an anisotropic medium with electric superconductivity.

It is quite noticeable that the sam ple of sym metry breaking in this model is the same as in the gluonic phase in neutral two-avorQCD [12], while the present model is much simpler. The point is that because of a nonzero baryon density in the gluonic phase, its dynamics in the hard-dense-bop approximation is mostly provided by quark bops. And since most of the initial sym metries (including rotational SO(3)<sub>rot</sub>) in this phase are spontaneously broken, the calculation of its elective action is quite involved. This makes the study of vortex solutions in the gluonic phase to be quite a discult problem. On the other hand, vortices could be very important for understanding the dynamics of quark matter in compact stars. The existence of such solutions in a related but much simpler model is encouraging.

It is instructive to compare the present vortex solutions with those in such complex condensed matter systems as the B phase in  ${}^3\text{He}$  [16] and high  $T_c$  superconductors [17]. Unlike the conventional Abrikosov-Nielsen-Olesen vortices [1, 2], the initial symmetries are not completely restored in the core of vortices in those systems. In  ${}^3\text{He}$ , vortices with an A-phase core or with asymmetric core are realized. In high  $T_c$  superconductors, there is an antiferrom agnetic condensate in the vortex core. A similar situation takes place for the magnetic and hypermagnetic vortices in the present model. In the core of a magnetic vortex, while the order parameter  $W_z^{(-)}$  is zero, the order parameter  $V_0$  is not (see Fig. 1). Therefore, in its core only the U (1)<sub>em</sub> symmetry is restored. In the core of a hypermagnetic vortex, we found that while  $V_0 = 0$ , the order parameter  $V_z^{(-)}$  is not zero (see Fig. 2). Therefore, only the U (1)<sub>Y</sub> symmetry is restored in the core in this case. On the other hand, the whole abelian U (1)<sub>em</sub> U (1)<sub>Y</sub> gauge symmetry is restored in the core of a hybrid vortex (see Figs. 3 and 4).

Recently, there has been a considerable interest in systems with coexisting order parameters (such as high  $T_c$  superconductors) in condensed matter [17]. Generating vector condensates is a very natural way of creating such systems (for example, in the present model, electric superconductivity coexists with spontaneous rotational symmetry breaking). This possibility deserves further study.
