# C onstruction and analysis of a sim pli ed many-body neutrino model

#### Abstract

In dense neutrino system $s$, such as found in the early U niverse, or near a supemova core, neutrino avor evolution is a ected by coherent neutrino-neutrino scattering. It has been recently suggested that $m$ any-particle quantum entanglem ent e ects $m$ ay play an essentialrole in these system $s$, potentially invalidating the traditional description in term $s$ of a set of single-particle evolution equations. W e model the neutrino system by a system of interacting spins, follow ing an earlier work which showed that such a spin system can in som e cases be solved exactly [1]. W e extend this work by constructing an exact analytical solution to a m ore general spin system, including in itial states w ith asym $m$ etric spin distribution and, m oreover, not necessarily aligned along the sam e axis. O ur solution exhibits a rich set of behaviors, including coherent oscillations and dephasing and a transition from the classical to quantum regim es. W e argue that the classical evolution of the spin system captures the entire coherent behavior of the neutrino system, while the quantum e ects in the spin system capture som e, but not all, of the neutrino incoherent evolution. By com paring the spin and neutrino system $s$, we nd no evidence for the violation of the accepted one-body description, though the argum ent involves som e subtleties not appreciated before. T he analysis in th is paperm ay apply to other two-state system sbeyond the neutrino eld.

## I. INTRODUCTION

In $m$ any neutrino system $s$ that are currently studied the rate of incoherent interactions is low enough to be com pletely negligible, yet coherent interactions (refraction) play an im portant, even crucial role. A classical exam ple is provided by the case of solar neutrinos: these neutrinos hardly scatter inside the Sun; nevertheless, their coherent interactions w ith the solarm atter plays an essential role in their avor evolution. This is of course the celebrated M SW theory of neutrino oscillations in $m$ atter [2,3].

T he classicalM SW theory describes neutrino propagation in a background of norm alm atter (electrons, neutrons, protons). There are system s, how ever, w here the num ber density of neutrinos them selves exceeds those of electrons and baryons, such as the early universe, or the so-called hot bubble region in an exploding supemova. Such system s additionally require a theory describing neutrino self-refraction.

Early investigations treated the neutrino background analogously to the M SW theory [4, 5]. P antaleone [7, 8], M CK ellar and Thom son [6], and Sigl and R a elt [9] showed, how ever, that the neutrino background is distinguished by an im portant subtlety: the induced $m$ ass term $s$ in general have nonzero o -diagonal com ponents

[^0]in the avorbasis. Physically, this m eans that avorcan be coherently exchanged betw een the neutrinos.
$T$ he authors of $[6,7,8,9]$ constructed the equation of $m$ otion of the neutrino system by using a one-body description for each neutrino. This treatm ent crucially depends on the assum ption that the state of the system can be factorized into a product of one-particle states. If this is not the case and the wavefiunctions of individual neutrinos are entangled, a very di erent treatm ent $m$ ay be required. A priori, it is not obvious that neutrinos w ould not develop such entanglem ent, due to the o -diagonal induced m ass term s . So the question arises whether this entanglem ent exists and has a substantial impact on the coherent avor evolution of the neutrino ensemble. The answ er could have a signi cant im pact on the predictions for the supemova neutrino signal, the synthesis of heavy elem ents in the supemova, and possibly B ig B ang $N$ ucleosynthesis and cosm ology.

The question was recently exam ined by Friedland \& Lunardini (F \& L I [10], F\& L II [1]) and by Bell, R aw 1inson and Saw yer (BRS [11]). A 11 three papers used a sim ilar setup, w ith a H am iltonian that w as restricted to \forw ard scattering" only [8]. W hile F \& L I argued that the coherent part of the neutrino evolution should be described by the one-particle form alism, the BRS paper reached an opposite conclusion.

To m ake their argum ent, BRS considered the evolution of a system initially in the avor eigenstates. W ith this choide, the one-particle form alism predicts no coherent avor conversion and thus conversion on the coherent tim e scale in this system would be an indication of the breakdow $n$ of the one-particle description (presum -
ably through the form ation of $m$ any-neutrino entangled states). The num erical calculation perform ed by BRS seem ed to suggest the presence ofsuch \fast" conversions, although the calculations involved a relatively sm allnum bers of neutrinos.

F\& L II [1] subsequently solved the neutrino model introduced by B R S analytically for the special case ofequal num bers of each neutrino species and equal strength interactions by m apping neutrino-neutrino interactions to spin-spin interactions. The solution in the lim it ofm any particles exhibited the equilibration tim e that is precisely what would be expected from incoherent scattering. T he analytical solution thus supported the one-particle description of the system .

O ne m ay wonder, how ever, if the initial state considered in F\&L II, nam ely, equal num bers of spins lup" and \down" was som ehow special. Could entanglem ent appears $w$ ith a m ore general setup?

In this paper we will present a generalization of the $m$ any-body neutrino $m$ odel introduced in $F \& L I I$, in the hope of understanding the quantum system better. We again consider a system ofm any neutrinos in which there are two avor species, so that it $m$ aps to a system of interacting spins (thanks to the SU (2) sym m etry of the problem ). W e generalize the m odel to initial states in which the species are not equally populated and where the in itial states are not necessarily in avor eigenstates. $W$ e show that the corresponding spin problem can still be solved exactly. The resulting solution exhibits a rich set of behaviors, as w ill be discussed in the follow ing.

E ven generalized in this way, the m odel still involves several sim pli cations and it is im portant to spell these out.

The m odel keeps only forw ard scattering term s. T hus, while the $m$ odel should correctly capture coherente ects in a realneutrino system, conclusions about incoherent scattering e ects in our model $m$ ust be intenpreted $w$ th care.

The m om entum degrees of freedom are ignored. Thee ects ofFerm istatistics are not included, that is the physical neutrino system is assum ed to have a phase-space density much less than one. This is indeed satis ed everyw here outside the neutrinosphere in a supemova. T he case of the neutrinos in the early universe $m$ ay be $m$ ore subtle ${ }^{1}$.

The interaction strength between any two neutrinos is taken to be the sam e, ignoring the angular

[^1]distribution of the neutrino m om enta (see later). The m odel thus aim s to describe the physical situation in an isotropic neutrino gas and hence $m$ ay orm ay not capture alle ects that could arise as a result of very anisotropic $m$ om entum distributions, such as those suggested in [12, 13].

These lim itations and assum ptions should be kept in $m$ ind when relating the results obtained for the spin system to the behavior of a real neutrino gas.

The problem of the avor evolution in dense neutrino system $s$ continues to receive a signi cant am ount of attention. In addition to the above mentioned papers [1, 10, 11, 12, 13], the reader is referred to [14, 15, 16, $17,18,19]$ for recent progress.
II. SETUPAND GOALS
A. The $H$ am iltonian and Eigenvalues

W e follow [11] and [1] by considering a system consisting of interacting $m$ assless neutrinos represented by plane waves in a box of volum e V . Since our prim ary $m$ otivation is to investigate coherent e ects in the neutrino system, in particular, the possible breakdown of the one-body approxim ation due to avor exchange, and not due to spatially dependent $m$ any-body correlations, we focus on the \forward" neutral current interactions betw een the neutrinos. In other words, we drop the mo$m$ entum degrees of freedom and include only scattering events that preserve neutrino m om enta and those that exchange the $m$ om enta [8, 10],

In the \usual" case of electrons, protons and neutrons in the background, the w aves scattered forw ard interfere coherently. For the neutrino background, how ever, this is not necessarily so and ourm odel, in addition to coherent e ects, captures som e of the incoherent e ects as well [1, 10]. The identi cation of coherent and incoherent e ects w ill be discussed at length in what follow $s$.

For $\mathrm{E} \quad \mathrm{m}_{\mathrm{z}} 0$ the neutral current interaction H am iltonian is

Here the sum is over all $k$ avors. The H am iltonian is invariant under a avor $S U(k)$ symmetry. Let us consider only tw o neutrino species, in which case the sym $m e-$ try becom es SU (2) and the avor space structure of the
interaction becom es equivalent to the interaction betw een pairs of spins. As explicitly shown in $F \& L I I$,
the interaction energy of tw o neutrinos, 1 and 2 , is proportional to the square of the total angular $m$ om entum of the corresponding spin system,

The coe cient of proportionality dependents on the relative angle between the neutrino m om enta , $\mathrm{g}=$ $\frac{{ }^{\mathrm{P}} \overline{2}_{\mathrm{G}} \mathrm{V}_{\mathrm{F}}}{}(1 \quad \cos )$ [8]. In a realistic neutrino system, the couplings are distributed according to the distribution of the relative angles betw een neutrino $m$ om enta. In order to $m$ ake our system solvable, w ew ill sim plify the problem and take all the couplings to be the sam e

It is hoped that this sim pli cation preserves the essential
features of the evolution [1, 11] (see, how ever, [12, 13]). $H$ enceforth we study this system of interacting spins to obtain inform ation about the neutrino system.

We will consider a system of $N+M$ spins, such that initially N spins all have a certain orientation (for de niteness, w ithout a loss of generality, \up") and the rem aining M spins all have a certain di erent orientation. At $t=0$, thus, the $N$ spins com bine in a state of angular m om entum $\mathrm{J}_{\mathrm{N}}=\mathrm{N}=2$ and projection $\mathrm{m}_{\mathrm{N}}=\mathrm{N}=2$, and the $M$ spins in a state of angular $m$ om enta $J_{M}=M=2$ and projection $m_{M}$. In term $s$ of the original neutrino system, we have a system of $N$ electron neutrinos, $j$ e $i$, and $M$ neutrinos in some other state $j_{x} i$. W e give the answer for a general $j_{x} i$ and then explicitly study two cases: $j_{x} i$ is avor eigenstate $j_{p} \frac{i}{}$ and $j_{x} i$ is a avor supenposition state $\left(j e^{i+j} i\right)=\overline{2}$.

The Ham iltonian for this system is

state. A s discussed in [1], the tim e scale w ith which this probability evolves, teq, tells us w hether the evolution has coherent or incoherent nature. In particular, for $M=\mathrm{N}$,

for coherent and incoherent evolution correspondingly. In a large spin system the coherent time scale is much shorter then the incoherent one. O ne of our goals w illbe to see which tim escales are present in our solution under di erent initial conditions.

The second goal is to com pare the coherent evolution we nd to the predictions of the one-particle form alism. A ccording to this form alism, the coherent evolution of a given neutrino is determ ined by the follow ing one-particle H am iltonian [4, 8]:

Here, $i$ is the avor state of the ith \background" neutrino i.e. the background is all the neutrinos except for the one for which the equation is w ritten. Explicitly, for tw o neutrino species ( $e$ and $) j_{i} i=\stackrel{i}{i} \underset{i}{e}$. The sum runs over all \background" neutrinos.
III. THEPROBABILITYOFSPIN

## A. $R$ esult

A swe show in this Section, the evolution of our system can be solved exactly. In the interests of clarity, w e begin by displaying the answ er for $\mathrm{P}_{1}(\mathrm{t})$ :

The rst two tem s in Eq. [16) give the $m$ ean value of the probability: $P_{1}=1=2 \mathrm{~m}$ eans com plete depolarization, or in the language of the neutrino system, an equal incoherent $m$ ixture of the two avors; the second term thus given the degree of polarization of the $m$ ean (\equilibrated") state. T he last term contains the tim e evolution of the system .

The inner products in the last two equations are C lebsch-G ordan coe cients, the ob jects in the parentheses are $3 j$-coe cients and those in curly brackets are $6 j$ coe cients. For de nitions, see, e.g., [20].

The rest of this Section presents two com plem entary derivations of these results. The derivations are som ewhat technical and the reader prim arily interested in the analysis of the rich physical properties of the solution $m$ ay w ish to skip to Sect. IV and retum to this Section later, as needed.

## B . C onstruction of the probability : overv iew

This solution can be found in either oftwo ways, both of which provide im portant, com plem entary physical insights into the spin system. These insights will prove very usefullater, as we discuss the physical properties of the solution. A dditionally, one or the other $m$ ethod $m$ ay be usefill for addressing still $m$ ore general spin con gurations. C orrespondingly, we show both $m$ ethods.

The rst approach is to \split o " the rst spin from the system, so that the rem aining $N+M \quad 1$ spins form $s$ la background" it interacts with. T he solution is constructed by rst coupling the angular
m om enta of the rem aining spins and then coupling the rst spin to the result. Thism ethod generalizes the idea em ployed in [1], but w ithout relying on the sym m etries speci cto the $\mathrm{N}=\mathrm{M}$ case.

The second approach is to treat the rst spin as a part of the system. W e solve for the evolution of all spins that start out in the lup" state. The solution can be found by observing that even w ith $N \not M$ the system possesses a very high degree of symm etry: all spins that start out in the sam e state evolve in the sam e way. This means, as we w ill show, that the problem can be reduced to that of just tw o coupled angular m om enta.

> C. M ethod I: splitting o the rst sp in

The outline of this approach is as follows. The time evolution of the system is easily w ritten dow $n$ in the basis of total angular $m$ om entum, since, as explained in Sect. [II, this is the H am iltonian eigenbasis. C orrespondingly, w e begin in Sect. IIIC 1]by constructing the density $m$ atrix for the system in this basis. In Sect. IIIC 2, this density $m$ atrix is rotated to a basis in which the rst spin has a well-de ned value. F inally, in Sect. IIIC 3 the
probability $P_{1}(t)$ is found.

## 3. P robability of Spin P reservation

The probability that the rst spin rem ains in the up state can be found from the density $m$ atrix. In general the probability of an eigenvalue $a_{i}$ represented by the op-
erator $A$ is $\operatorname{Tr}(A)$. In this case the operator is diagonal and hence probabilities are just the diagonalcom ponents of the density $m$ atrix. A though it is not im $m$ ediately obvious, the answ er just obtained coincides w ith E qs. (16), (17), and (18). N otice that $C^{( }(J)$ is not the same as C ( $J$ ) in Eq. (17) since, unlike Eq. (16), Eq. (29) does not contain the $1 / 2$ term.

## D . M ethod II: sym m etry of the entire system

$T$ he second $m$ ethod is based on an observation that since the coupling strength is the sam e for all spins the system possesses a very high degree of sym $m$ etry. In particular, all spins that start out in the sam e state evolve in the sam e way (up to relabeling). This sim ple observation proves to be very powerful for our analysis: it $m$ eans that all spins that start out in the \up" state com bine in a single com posite object with the angular mo$m$ entum $L_{1}=N=2$ at any $m$ om ent in tim $e$, not just at $t=0$. $T$ he sam e can be said about the rem aining $M$ spins ( $\mathrm{L}_{2}=\mathrm{M}=2$ ). Thus the problem reduces to a textbook case of just tw o interacting angular $m$ om enta.
$M$ ore precisely, at any $m$ om ent in tim e, the system is described as a supenposition of states i w ith de nite values of total angular $m$ om entum, $J_{i}$. E ach such state is obtained as a result of sym $m$ etrizations and antisym $m$ etrizations of individual spin wavefunctions. T he highest $J$ state is a com pletely sym $m$ etrical combination, the next one is obtained by perform ing one antisym $m$ etrization, etc (the general rules are given by Young's tableaux). The im portant point is that by sym $m$ etry
all spins that started out in the sam e state can only be sym $m$ etrized. That $m$ eans that all spins that started out in the sam e state can be assem bled in a single ob ject w ith the total (unchanging in tim e!) angularm om entum . $T$ his argum ent holds for any $t$.

It is conceptually straightforw ard to com pute the expectation value of the operator $j_{z}^{(1)}$ (the $z$ com ponent of the angular $m$ om entum of the rst com posite ob ject) at any $m$ om ent in tim $e$. $T$ he expectation value of the corresponding operator for each spin, $\mathrm{s}_{\mathrm{z}}^{(1)}$, can then be found by sim ply dividing by N , by sym m etry.

IV . A N A LY SIS:A FLAVOR SUPERPOSIT IO N BACKGROUND

A $s$ already $m$ entioned, the solution in Eqs. (16), (17), and (18) contains very rich physics found in the actual neutrino system. First, let us show that it contains both coherent oscillations and incoherent equilibration (decay). For that, let us consider the case

In the neutrino system, this corresponds to the rst N neutrinos initially being in the $j e^{i}$ avor eigenstate, while the rem aining $M$ neutrinos starting out in them axim ally $m$ ixed state. In this setup, the one-particle form alism predicts coherent evolution.

Indeed, our solution con m sthis. The explicit form of the coe cients C $(J)$ and $(J)$ is given in Eqs. (A 1) and (A2). U sing these values, we plot the behavior of the expectation value $P_{1}(t)$ for $N=100, M=120$ in $F$ ig. 2 . W e see that the evolution exhibits both oscillations and decay. T he oscillations re ect coherent behavior, while the decay occurs on a longer time scale, as would be expected for incoherent evolution.
$T$ his assertion can be $m$ ade quantitative. $T$ he key test of coherence/incoherence of the evolution is the scaling of the evolution tim es $w$ ith the num ber of particles. In the $\lim$ it of large $N$ and $M$, it is possible to show that a single \w avetrain" in Fig. 2 (oscillations plus decay) is described analytically by the follow ing form ula:

A detailed derivation of q . (40) is given in A ppendix B. Here, we notice that the oscillation period scales as $/\left(\mathbb{N}^{2}+M^{2}\right)^{1=2}$, as expected for coherent evolution, while the decay time goes like $N{ }^{1=2}\left(2+2 N^{2}=M^{2}\right)^{1=2}$, indicating its incoherent nature (cf Eqs. (13), (14)).

W e further observe that the frequency of the coherent oscillations agrees w th the predictions of the one-particle form alism for a neutrino in the background of $M \mathrm{maxi}$ $m$ ally neutrinos $\left(j e^{i+} j \quad i\right)=\overline{2}$ and $N \quad 1^{\prime} N$ neutrinos in the $j$ ei state. Indeed, the one-particle oscillation H am iltonian (15) in this case is

so that the oscillation frequencyp given by the di erence of the eigenvalues, is precisely $g^{N^{2}+M^{2}}$.

A very valuable physicalinsight can be gained from the idea that underlies M ethod II of solving for the evolution of the system, nam ely, that all spins in the sam e initial state alw ays combine to form an ob ject with a certain de nite value of the angular $m$ om entum. As explained in Sect. IIID, this $m$ eans that the system can be reduced to just tw o coupled angular m om enta, $\mathrm{j}_{\mathrm{N}}=\mathrm{N}=2$ and im $=M=2$. $W$ hen the numbers of spins $N$ and $M$ are su ciently large, the two com posite angular mo$m$ enta behave as nearly classical ob jects. They precess about the direction of the total angular $m$ om entum of the system. T hese are the fast oscillations seen in F ig. 2 .
$Q$ uantum $-m$ echanically, a system that has a de nite value of the totalangularm om entum does not sim ultaneously have de nite projections of the individual angular m om entum vectors that com prise it. C orrespondingly, after a while the com ponents of the angular $m$ om enta that are transverse to the total angular $m$ om entum undergo \quantum wash-out". The system equilibrates to a state in which only the com ponents of the constituent angularm om enta along the direction of the totalangular m om entum rem ain.

Let us check this quantitatively. The total angular $m$ om entum of the system (in the classical lim it) $m$ akes an angle cos $=\mathrm{N}=\overline{\mathrm{P}} \overline{\mathrm{N}^{2}+\mathrm{M}^{2}} \mathrm{w}$ th the positive z direction. H ence, the pro jection of the net angularm om entum of the rst $N$ spins on the direction of the total angular m om entum of the whole system is $\mathrm{N}=2$ cos. A fter a su cient am ount of time this is the only com ponent that rem ains, the transverse com ponents are w ashed-out. P ro jecting it back on the $z$-axis, we get $N=2$ cos or, using Eqs. (33), (34),

A dditional insight about classical and quantum features of the evolution can be gained by restoring the factors of the P lank's constant in Eq. (40). It is sim ple to see that the product gt com es with a one factor of
~. The logic is as follows: (i) from Eq. (9) it is obvious that the energy is proportional to $\sim^{2}$ (from the angular m om entum squared factor); (ii) next, in computing the evolution phase (exp ( $\mathrm{i} t=\sim$ )), we divide by one pow er of ~; (iii) this leads to one power of $\sim$ in the argum ent of the cosine in Eq. (14), i.e., gt com es w ith one factor of ~. Eq. (40) then reads

We see that the argument of the cosine $g \sim \overline{N^{2}+M^{2}} t=g J_{t o t} t$ involves only the classical value of the total angular $m$ om entum $J_{\text {tot }}$, while the decay exponent involves two powers of $\sim$, of which only one is absorbed into the de nition of classical angular m om enta. The decay exponent is a quantum e ect, in a sense that its physical origin lies in the quantum uncertainty principle. This allow s us to $m$ ake an im portant identi cation: coherent evolution in the neutrino system $m$ aps into the classical behavior of the angular $m$ om enta, while incoherent e ects in the neutrino system correspond to quantum e ects in the spin system. This im portant point will be developed further in Sect. V A.
$F$ inally, we note that the solution is periodic and the wavetrain, having seem ingly com pletely decayed aw ay, reem erges after som e time. This phenom enon is due to the fact that the spin system possesses a fundam ental frequency, of which all other frequencies (the argum ents of the cosines in Eq. (16) ) are multiples. This e ect will be discussed in detail in Sect. V C.

## V. ANALYSIS:A FLAVOR EIGENSTATE BACKGROUND

W e next analyze the probability for the case that the state $j_{M}$ is $m$ ade of spin down particles (or neutrinos in the $m$ uon avor eigenstate). H ence we identify the quantum numbers as

O ne reason this case is interesting for us is that for this system the one-particle form alism predicts no coherent avor conversion. Indeed, the $o$-diagonal term $s$ in the H am iltonian (15) vanish.

The explicit form of the coe cients C $(J)$ and $(J)$ is given in Appendix A, Eqs. A 3), A5), and A 4). As explained there, for the case $N=M$ our probability agrees exactly w ith that found in F \& L II.

W e have plotted the probability according to these equations for various num bers of sp in dow $n(M)$ and spin
up $(\mathbb{N})$ particles and a subset of these is show $n$ in $F$ ig. 3 . $T$ hetime on the gures is scaled such that $=\operatorname{tg}(\mathbb{N}+M)$ so that we m ay com pare our results to those in $\mathrm{F} \& \mathrm{~L}$ II and BRS.

The $m$ ain features of the solution we nd are the follow ing:

A s seen in the left panel of $F$ ig 3 , for $N \quad M$ (to be quanti ed later), the system equilibrates to som e value of $P_{1}$ and subsequently for a long tim e show $s$ no evolution. This behavior is sim ilar to what w as observed in the case of Sect. [IV). Just like that system, the w avetrain reem erges after som e tim e.

A s seen in the right panelofF if3, the equilibration happens on tim e scales characteristic of incoherent evolution, $t_{\text {eq }} \quad g^{1}((M+N)=2)^{1=2}$. Unlike the case of Sect. (IV) though, in the present case for $\mathrm{N}=\mathrm{M}$ we do not see coherent oscillations w th the decaying wavetrain. In fact, it was explicitly shown in $F \& L I I$ that for $N=M$ the probability Bi_depends on tim e only through the com bination
N gt. Thus, the evolution hasm anifestly incoherent nature. (cfEq. 40) ).

As $\mathrm{N} \quad \mathrm{M}$ jis increased, the value off in equilibrium, $\mathrm{P}_{1}$, increases and for large $\mathrm{N} \quad \mathrm{M}$ jthe system stops evolving, entering a \freeze-out" state. This trend can be clearly seen in $F$ ig.3. A s further illustrated in $F$ ig. 4, where $P_{1}$ is plotted as a function of $N \quad M$ for $x \in d+N$, the $m$ inim um value of $P_{1}=1=2$ occurs when $N=M$. That $P_{1}$ rises for both signs of $(\mathbb{N} \quad M)$ appears counterintuitive at rst. Indeed, it $m$ eans if $w e$ have a single spin up coupled to a very large system of spins dow $n$, the rst spin does not equilibrate to a state $m$ ostly oriented dow $n$, but rem ains aligned up.

As iN $M$ jis increased, in addition to decay, the system start exhibiting oscillations, the frequency of which grows with $\mathrm{AN}_{\mathrm{N}}^{\mathrm{M}} \mathrm{j}$. The amplitude of these oscillations gets progressively sm aller as $\mathrm{M} \quad \mathrm{N} j$ increases, since the system approaches the freeze-out state. This behavior can be seen in Fig. [5, which reproduces at higher resolution the case $M=1280, \mathrm{~N}=2600$ of F ig. 3 .

In what follow s, we w ill discuss these features further. This will allow us to gain a deeper understanding of the spin system and its relationship to the neutrino system. W ew ill rst show how the transition from the regim e in which the spins equilibrate to the freeze-out regim e illustrates the interplay of \classical" and \quantum "e ects. W e w ill then discuss the tim e scale of the evolution and whether the system follows the predictions of the oneparticle H am iltonian in the classical regim e. Finally, in Sect. V C we will com m ent on the periodicity of our solution.

A. From equilibration to freeze-out: a quantum -to-classical tran sition

In the course of the analysis in Sect.IV, we have encountered a situation in which fast coherent processes in the neutrino system corresponded to classicale ects in the spin system, while slow er incoherent processes in the neutrino system corresponded to quantum e ects in the spin system. This physical picture is further illustrated by the system $\mathrm{m}_{\mathrm{N}}=\mathrm{N}=2, \mathrm{~m}_{\mathrm{M}}=\mathrm{M}=2$ we are now considering.

O nce again, we recall that this system is reduced to tw o angular m om enta as described in Sect. IIID. W hen N and M are large, these two angular $m$ om enta becom e approxim ately classicalob jects, $\tilde{\mathrm{J}}_{1}$ and $\tilde{\mathrm{J}}_{2}$. T hese ob jects are coupled $w$ ith an interaction const $\tilde{J}_{1} \tilde{J}_{2}$. By energy conservation, this quantity stays xed, and since the

lengths of both vectors are xed the angle betw een the vectors $\tilde{j}_{1}$ and $\tilde{j}_{2}$ stays xed. Since the two vectors start out pointing in opposite directions, they rem ain pointing in opposite directions. T he only possibility left is for the system to tilt as a whole, but that w ould violate mo$m$ entum conservation, unless the totalm om entum of the system is zero ( $N=M$ ). Thus, the classical system is frozen, unless $j_{1}=j_{2}$, which is a special point.

O ur calculation shows that quantum mechanical effects actually resolve this discontinuity. The transition from the freeze-out to equilibration happens in some nite range of angular $m$ om enta.

W hat physics sets this range? Let us consider the tw o angular $m$ om enta being added as sem iclassical ob jects. $T$ hen, in addition to the angularm om enta in the $z$ direction, they each possess \quantum " angular mom enta in
the $x \quad y$ plane. These $m$ om enta are of the order

That this is quantum e ect is seen by restoring the units: $J_{x y} \quad J \sim$. This \quantum " angularm om entum is what is responsible for the equilibration.

W hen the two angularm om enta are added, their $x \quad y$ quantum m om enta are also combined and the net object has $J_{x} y$ of the same order as the ingredients. If the net classical $m$ om entum along the $z$ axis is greater then $J_{x} y$, the equilibration $w$ illbe suppressed. In other words, we arrive at the physical condition that deter$m$ ines the boundary between equilibration and \freezeout"

This boundary betw een freeze-out and equilibration can be quanti ed by the analytical expression for the equilibrium $P_{1}$ that can be derived for $M M \quad N j$ $(\mathrm{M}+\mathrm{N})$ (see A ppendix C):

Up to a sm all correction in the prefactor in Eq. (46), $P_{1}$ depends on and in combination ${ }^{2}=$. M oreover, $F$ (a) quickly drops to zero as a is increased beyond one. H ence, the width $\mathbb{M} \quad \mathrm{N}$ jof the \quantum equilibration region" indeed scales with $\mathrm{N}+\mathrm{M}$ as $\overline{\mathrm{N}+\mathrm{M}}$.

This scaling can be seen in F ig. 4. The curves show $n$ there are obtained by using the exact solution, E qs. (16), (A 3), (A 4), (A 5). They are well described by Eq. (46).

## B . Equilibration $T$ im e

W e now discuss the tim e scales that control the evolution of our system. W e are particularly interested to see how the evolution scales $w$ th the num ber of spins in the lim it when the spin system is large.

A s already $m$ entioned, the case of $N=M$ considered in $F \& L I I$ is straightforw pprd: for large $N$ the evolution is uniquely dependent on $\overline{\mathrm{N}} t$ and the decay curve is

O ur investigations in Sect. VA, how ever, show ed that in general the situation is less obvious. For $N \in M$ F igs. 3 , 5 show a m ore com plicated evolution pattem. Indeed, as we show next, in this case a new, shorter tim e scale enters the evolution.

First, let us consider the sim plest exam ple, an obvious lim iting case $N=1$. A s can be easily seen from Eq. (16), the evolution contains just a single oscillation frequency, as $J_{m}$ in $=M=2 \quad 1=2$ and $J_{m a x}=M=2+1=2$. The corresponding value of $(M=2 \quad 1=2)$ is $2=(M+1)^{2} . W e$ thus have

W e see that the oscillation tim escale grow s linearly w ith the num ber of spins, not as a square root as in Eq. (48). W e also notioe that the am plitude of the oscillation is suppressed by the second pow er of the num ber of spins.

N ext, let us consider a m ore nontrivialcase $\overline{\mathrm{N}+\mathrm{M}}<$ NN $\quad \mathrm{M} \quad(\mathrm{N}+\mathrm{M})$. This case is characterized by the decay of the w avetrajn to the value $\mathrm{P}_{1}$ given in Eq. (46) . It tums out that for $\overline{N+M}<N \quad M j(N+M)$ the decay behavior is qualitatively di erent from Eq. 48). $T$ he w avetrain in this case is approxim ately described by

For details see A ppendix D, where an asym ptotic series for $P_{1}(t)$ is derived. Eq. (51) contains the leading term of this series. For su ciently large M M N (com pared to $\overline{\mathrm{N}+\mathrm{M}}$ ) it gives an excellent approxim ation of the true result, as can be seen in $F$ ig. 6.

By inspecting Eq. 51), we clearly see that for nonzero $\mathrm{M} \quad \mathrm{N} j \mathrm{a}$ new frequency, $2 g=g(\mathbb{N} \quad \mathrm{M})$ enters the problem. We stress that this frequency depends on

N M linearly. The am plitude of the oscillations at the $m$ axim um is suppressed by $(\mathbb{N}+M)=N \quad M$ j, so as a function of $M \quad N$ jthe oscillations increase in frequency and decrease in am plitude. Finally, the oscillations decay w ith time as only a power law and the decay tim e, teq $\quad \mathrm{N} \quad \mathrm{M} \dot{\mathrm{F}}(\mathrm{g}(\mathbb{N}+\mathrm{M}))$ increaseswith $\mathrm{M} \quad \mathrm{N} j$. Com pare this $w$ ith the situation for $N=M$, in which case the decay tim e scale is $t_{\text {eq }} \quad 1=(g \overline{\mathrm{~N}})$ and the decay has exponential dependence.

At last, what conclusions can be draw $n$ about the applicability of the one-particle coherent H am iltonian in this case? O ur conclusions is that one can de ne in what sense it is applicable, but the argum ent is a bit subtle. Unlike in the case $N=M$ considered in $F \& L I$, in the $m$ ore general setup considered here we nd a new frequency, linearly dependent on the di erence $\mathrm{N} \quad \mathrm{M} j$. C an this be reconciled w ith Eq. [15), which states that in the neutrino system which begins as a collection of avor eigenstates there should not be any avor coherent conversion? W e recall that while the frequency of our solution increases $w$ ith $\mathrm{j} \mathrm{N} \quad \mathrm{M} j$ the am plitude of the corresponding oscillations becom es sm aller and sm aller (see E q. 51) ) . T he oscillations becom e high-frequency as the system enters a state of freeze-out. T he one-particle coherent lim it corresponding to neglecting the residual sm all oscillations.

A di erent way to state this is that the oscillation am plitude is suppressed by $(M+N)=(\mathbb{N} \quad \mathrm{M})^{2}$ and becom es large only when $-\mathrm{N} \quad \mathrm{M}$ japproaches $\overline{\mathrm{N}+\mathrm{M}}$. In the latter case, how ever, the oscillation frequency, obviously, becom es of order $\overline{N+M}$, and hence indistinguishable from the incoherent tim e scale.

## C. The P eriod of the P robab ility

In this section we study the periodicity of the probability $P_{1}(t)$ observed in Fig. 3. R ecall, the probability is

T he periodicity is a consequence of the probability being a sum of cosines w th frequencies that are multiples of the low est, fundam ental frequency.

## 1. T he C ase for $\mathrm{N}=1$ or $\mathrm{M}=1$

W e rst consider the case when N or M is one. C onsider $\mathrm{N}=1$. For this case there is only one cosine term w ith $\mathrm{J}=\frac{\mathrm{M}}{2} \quad \frac{1}{2} . \mathrm{T}$ herefore E $q$. (52) reduces to,

$N$ ote that the period is the sam e for the case of a avor eigenstate background and a avor superposition background because the period only depends on the argum ent of the cosine. T he argum ent of the cosine is the sam e for both cases. T he discontinuity betw een the period when $\mathrm{N}=1$ or $\mathrm{M}=1$ and the other cases arises because in the rst tw o cases there is an interference ofm any cosine waves (as there the cosines are sum $m$ ed over) and in the last case there is only one cosine wave. For $M=N$, our results reduce to that found in $F$ \& $L$ II.
$N$ otice that, up to the factor of two controlled by whether $N+M$ is even or odd, the period of the spin system depends only on the value of the spin-spin coupling $g$ and not on the size of the spin system. For a neutrino system, $g=\frac{\mathrm{P}_{\overline{2}_{G_{\mathrm{F}}}}}{\mathrm{V}}$ and the period seem s to depend on the volum e occupied by the neutrino system. In fact, in a real neutrino gas, non-forw ard scattering e ects would destroy any periodicity. We recall that for su ciently large num bers of neutrinos the tim e scale of incoherent forw ard scattering, E q. (14), ism uch sm aller than the period found here and, $m$ oreover, that forw ard incoherent scattering is only a sm all fraction of the total incoherent scattering (see F \& L II). Thus, the periodicity is an exam ple of an e ect in the spin system that is not realized in the actual neutrino system. In the context of the spin system, on the other hand, the e ect is perfectly physical
and indeed is rem iniscent of the well-know $n$ \spin echo" e ect experim entally observed in actual spin system $s$.

As a nal comment note that when we approxim ate the sum s over the cosines by the integrals, in Eqs. (40), (46), and (51), the periodicity of the solution is destroyed. $T$ his has to do w th the disappearance of the fundam ental (low est) frequency in the system. T he sam e observation wasmade in $F \& L I I$ for $N=M$.

## 3. A note about m inim a

$P$ Let us call the case when $P_{1}=1=2+{ }^{P}{ }_{J} C(J)$
$J$ ( $J$ ) (which is the lowest possible value that the probability can be) a perfect $m$ inim um. For the perfect $m$ inim um to occur we m ust have, cos $[g t(2 J+2)]=1$ sim ultaneously for all J . The period of each cosine decreases as $J$ increases, therefore we only need to nd the tim e when the cosine with the largest period and the cosine w th the sm allest period are sim ultaneously equal to
1.

By a calculation analogous to that for the period one can show that if $N+M=$ even there $w i l l$ never be a perfect $m$ inim $u m$. If $N+M$ is odd the tim es when the probability attains a perfect $m$ in $m$ um is,

$N$ ote that this is halfw aypbetw een pesfect m axim a (the case where $\left.P_{1}(t)=1=2+\quad{ }_{J} C(J)+\quad{ }_{J}(J)\right)$. Hence if $\mathrm{M}+\mathrm{N}$ is odd (or J is half an integer) the probability has both a perfect $m$ inim um and a perfect $m$ axim um. $T$ his result show $s$ yet another intriguing physical feature of the spin system. W hile a system with $\mathrm{N}+\mathrm{M}=$ even is characterized by a set of recurring $m$ axim $a$, in the system $w$ ith $N+M=$ odd every other such $m$ axim um is replaced by a minimum. This behavior is ilhustrated in F ig. 7 .

> VI. THE FREEZE-OUTEFFECTANDAREAL NEUTRINOGAS:A CRITICALANALYSIS
A. O verview of the problem

In Sect. V we found that a general $\backslash \mathrm{N}+\mathrm{M}$ " ( $\mathrm{N} \in \mathrm{M}$ ) spin system that starts polarized in the $z$ direction typically equilibrate very little, even on the longer incoherent tim e scale, exgept in cases when $N$ and $M$ are very close ( $\mathbb{N} \quad \mathrm{M} j . \overline{\mathrm{N}}$ ). Obviously, it is im portant to understand if this nding corresponds to the behavior of a real neutrino gas. This question is not a trivial one. A s $m$ entioned in the introduction, going from a neutrino gas to the spin $m$ odel involves several sim plifying assum $p-$ tions: only forw ard scattering is kept, equal interaction strengths are assum ed, the interactions are taken to be continuous in tim e, etc. All these assum ptions could, in principle, introduce certain artifacts in the system and it is not a priori obvious that the freeze-out behavior found in the toy $m$ odel is not just such an artifact. W e w ill exam ine this question next.
B. Interference of neutrino scattering am plitudes

C onsider a test neutrino, taken for de niteness to be $j_{e}>$, ying though a box with the gas of neutrinos. A ssum e the neutrinos in the gas are in the avoreigenstates,

Let us lim it scattering to only the forw ard process and ask: what is the probability that scattering changes avor of the test neutrino?

Let us review the argum ents of $F$ \& L I. Om itting the avor-preserving neutral current piece, which is the sam e for allneutrinos, we can w rite the result of the interaction to rst order in the interaction am plitude a as

$\overline{2}_{\mathrm{F}}$ (1 cos ) $t=V$ [1, 10], where $t$ is the duration of the interaction betw een a pair of neutrinos. Since the nal states are $m$ utually orthogonal, the probability of avor change goes as $\mathrm{M} \mathrm{a}^{2}$ indicating the incoherent nature of the evolution.

Eq. (60) assum es that the tim e step $t$ is sm all such that not only C t 1, but also NC t 1 are satis ed. W hile the form er is indeed true for any reasonable neutrino system of interest [10], the latter need not hold, as N a or M a for large N and M are not necessarily sm all. To m ake contact w ith the spin system, which stays continuously coupled, we must consider longer interaction tim es. C orrespondingly, we need to m odify Eq. (60), keeping higher powers of a.

O ne can accom plish this by regarding (60) as the rst orderterm in the perturbative expansion of the w avefunction at the time $t(\mathbb{N C} t \quad 1, M C t \quad 1)$, and using
this to $m$ ake further steps in time to the time $T=n t$ (C T 1, but not necessarily N CT 1, M CT 1). Let us de ne a convenient notation of the initial state
and the \exchange" state

The reason for the freeze-outbehavior is now clear. For large values on N M , the probability of a transition to the exchange state is suppressed by the factor $(\mathbb{N} M)^{2}$.

N otice rst of all that this e ect disappears when $\mathrm{N}=\mathrm{M}$. This is why in this case one can observe fiull equilibration and test the incoherent nature of the evolution. H ow ever, one should note that in the present approxim ation the N ! M lim it gives ic T as the am plitude for the state $£ i$. As in this case the phase of the initial and exchange states are the sam e, we regard one factor of $T$ in the probability as a relic of the energy conservation delta function, and obtain as the probability per unit time for a transition from the intial state

## C. D oes the freeze-out happen in a real neutrino system ?

Finally, we can address the key question: does the freeze-out observed in the $m$ odel of interacting spins actually happen in a real neutrino system? The answer is negative.

Let us retum to the argum ents in the previous subsection. U pon closer inspection of Eq. (60), it becom es clear that for large $N$, $M$ and tim es $T \quad C^{1}$, the problem is in fact equivalent to an oscillation set-up with

which is nothing but the condition we found in the spin system, Eq. (45), up to a trivial factor. This provides a pow erfulcheck of the validity ofE q. (69) and the physical picture that led to it.

W e can now give interpret Eq. (69) the follow ing interpretation. For $N, M \quad 1$, the states $\bar{j} i, \Psi_{i} i$ are approxim ately energy eigenstates. Strictly speaking, of course, the true energy eigenstates are m ixtures of jii, $\Psi_{i} i$, but for large $N, M$ one of the eigenstates is predom inately行i, w ith a sm all adm ixture of the other states, and vice versa. C orrespondingly, we can loosely speak of the energies of the $\overline{J i}$ and $\Psi_{i} i$ states. For $N \in M$ the state $\bar{j} i$ and any of the states $\Psi_{i} i$ have di erent energies. The incoherent spin ips in the spin system are thus forbidden by energy conservation (enforoed by the oscillating exponent in Eq. (69) ).

In a real neutrino system, of course, there is an additional degree of freedom: the neutrino $m$ om entum. The energy liberated in the process of avor exchange is converted into a slight shiff of the neutrino kinetic energy and the energy conservation is assured. In the sim plest $m$ anifestation of this point, a neutrino existing a dense neutrino region will gain a small am ount of kinetic energy. (T he neutrino-neutrino interactions, just like any interactions betw een like particles $m$ ediated by a vector boson, are repulsive.)
$T$ hus, the freeze-out observed in the spin $m$ odel is an artifact of the $m$ odel, $m$ ore speci cally, a consequence of the dropped degrees of freedom, neutrino m om enta.
$T$ his discussion applies to the system of neutrino plane waves in a box, which was the system for which the spin m odel was created. It is instructive to instead consider a system of interacting neutrino wavepackets. In this system the interaction energy is localized to the regions occupied by the overlapping wavepackets, w ith the total interaction energy (averaged over volum e) being the sam e as in the case of plane w aves. T he statem ent of the changing kinetic energy, as the neutrino $m$ oves from $a$
$m$ ore dense to a less dense region, has its analogue in the case ofw avepackets as well: T he kinetic energy of a given packet changes as it interacts $w$ ith another packet. U pon spatialaveraging this change, one gets the \plane w aves" result. There are few er interactions in less dense regions, hence the averaged kinetic energy there is higher.

The advantage of thinking about wave packets is that in this case it is clear that the rate of incoherent scattering cannot be suppressed: for su ciently sm allw avepackets they interact with each other two-at-a-tim e, giving the usual scattering rate. The answer in the physical system cannot depend on the size of the wavepackets, since the interaction H am iltonian is energy-independent.
VII. CONCLUSIONS

N o problem in physics can be solved exactly. O ften, how ever, a given physicalproblem could be m apped onto an idealized system, for which a com plete solution exists. O ne then needs to critically exam inew hich features of the solution carry through to the originalphysicalsystem and which arise as artifacts of the sim plifying assum ptions $m$ ade along the way.

W e have perform ed just such an analysis. O ur goal was to investigate coherent e ects in a gas of neutrinos. W e have sim pli ed the system by lim iting the scattering to only forw ard direction and om itting the m om entum degrees of freedom. W ith only the avor degrees of freedom rem aining, the neutrino system could be mapped onto a system of coupled spins. We further sim pli ed the problem by setting the coupling strengths to be equal, and considering a certain class of initial states. $W$ e have show $n$ that the resulting spin $m$ odel could be solved exactly. Our solution generalizes the analysis of F \& L II [1], where a particular initial state, the one with equal num bers of up and dow $n$ spins, w as considered.
$T$ he solution proved to be very instructive. $T$ he spin system exhibited both coherent oscillations and incoherent decay, reproducing e ects expected for a realneutrino gas. Several exam ples were considered in Sects. IV and V. A s these exam ples dem onstrate, coherent e ects in the neutrino system correspond to the behavior of the spin system in the classical lim it; likew ise, incoherent effects in the form er have their analogue in quantum e ects in the latter.

W e have presented two di erent $m$ ethods of obtaining the solution. T he rst construction separates the system in three parts: the test spin, the other spins that started in the sam e orientation and the rem aining spins. T he second $m$ ethod exploits the high degree of sym $m$ etry of our chosen initial states. B oth $m$ ethods have com plem entary advantages. The second of the $m$ ethods provided crucial physical intuition for understanding the classical lim it of the system and the interplay ofquantum and classicaleffects, as show $n$ in Sects. IV and V A. A the sam e tim e, the rst $m$ ethod is $m$ ore general and can be used to generate solutions for any initial state of the test spin by
sim ply changing the state of the test spin by adjusting the param eter in Sect. IIIC 3).

Severalinteresting results were found. O ne such result involves the subtlety of identifying coherente ects in the neutrino system by taking a classicallim it of the spin system. T he special case considered in [1] seem ed to suggest that in the large $N$ quantum e ects separate from classical ones necessarily by having longer tim e scales (scaling as a square root in the num ber of particles). W hat we found in Sect. V B is that som e quantum e ects instead decouple by having a vanishing am plitude, while their frequency scales as if they w ere classicale ects.

A nother interesting nding of our analysis is that in certain spin system $s$ the evolution does not lead to equilibration, even on the incoherent tim e scales. For exam ple, the system considered in Sect. V is \frozen-out", unless the initial num bers of spins up and dow $n$ are very close. By studying this exam ple and com paring it to the case considered in Sect. IV we conclude the freeze-out happens in the spin system for any $m$ ode where quantum e ects are suppressed a large classical (coherent) e ect. W e have seen, e.g., in Sect. V A that equilibration is precluded by the conservation of the classical angular mo$m$ entum. Only when the classical angular $m$ om entum is reduced to the level com parable to the quantum e ects is the equilibration allow ed to proceed. The special case considered in [1] falls into the latter category.

W e have explained in Sect. VI that the physicalorigin of the freeze-out e ect com es from dropping the $m$ om entum degrees of freedom of the neutrino system. W hile the freeze-out certainly happens in the spin system, it does not happen in a real neutrino gas. This gives an im portant exam ple of the lim itations of the spin m odel: while it captures all coherent e ects in the neutrino system, it does not alw ays capture incoherent e ects, only those that are not classically suppressed.

In addition to giving the fullsolution in Eqs. (16), (17), and (18), in severalcase w e have derived approxim ate expressions that elucidate the physics of the system. For exam ple, Eq. 40) cleanly dem onstrates the presence of both oscillation and decay in the spin system. Eq. (46) helps to understand the interplay of classical and quantum e ects in the processes of equilibration and freezeout. F inally, E q. (51) show ed the subtlety of decoupling the quantum e ect in the classical lim it.

W e believe that our extensive investigation here will contribute to better understanding of the avorevolution in dense neutrino system $\mathrm{s} . \mathrm{W}$ e also hope that our results could nd applications beyond the neutrino eld.

The form of q . (D6) suggests that the solution is oscillating in time. It is instructive to understand how this oscillatory behavior disappears in the $\lim$ it ${ }^{2}=!0$. $F$ irst of all, notice that the sum $m$ ation in Eq. (6) goes to some $\mathrm{n}_{\mathrm{m} \text { ax }}$, not to in nity. Indeed, the presence of the factorial $n$ ! indicates that we are dealing $w$ ith an asym ptotic series. For any given choice of and there w ill be an optim al num ber of term s in the series, $\mathrm{n}_{\mathrm{m} \text { ax }}$, that approxim ates the original integral best. The term $s$ beyond $n_{m}$ ax grow in absolute value and the series diverges. $W$ e easily estim ate $\mathrm{n}_{\mathrm{m}}$ ax from the condition that the ratio of the two consecutive term $s$ at $t=0$ be 1 , ( $\mathrm{n}=2$ ) $1 \quad 1 \quad 1$, or

is provided by Eq. D3), indeed not show ing any oscillations. The oscjllations thus appear as $M \quad N$ jis increased beyond $\overline{\mathrm{M}+\mathrm{N}}$, when the series in Eq. (D6) starts providing a better and better description of the true answ er.
