Testing Fundam ental Sym m etries with b! -Vector Decays

A bstract

Putting together kinematical and dynamical analysis, a complete study of the decay channels $_b$! V(1), with ! p and V(J=)! '' or V(0)! ; is performed. An intensive use of the helicity formalism is involved on the kinematical side, while on the dynamical side, Heavy Quark E ective Theory (HQET) is applied for an accurate determination of the hadronic matrix elements between the baryons $_b$ and . Emphasis is put on the major role of the $_b$ polarization for constructing T-odd observables and the standard 0 ! mixing has the bene telect of amplifying the process of direct CP violation between $_b$ and $_b$ decays.

1 Introduction

Huge statistics of beauty hadrons are expected to be produced at the CERN-LHC proton-proton collider starting in 2007. O by by by this will lead to a thorough study of discrete sym metries, C; P and T in b-quark physics, in the fram ework of the Standard M odel (SM) as well as beyond the Standard M odel. It is also well known that the violation of CP sym metry via the Cabibbo-Kobayashi-Maskawa (CKM) mechanism is one of the cornerstone of the Standard M odel of particle physics in the electroweak sector. Thanks to the foreseen CERN-LHC collider, non-leptonic and leptonic b-baryon decays may allow us to get informations about the CKM matrix elements, analysis of the CPT operators may be performed and dierent non-perturbative aspects of QCD may also be investigated.

Looking for T in e R eversal (TR) violation e ects in b-baryon decays can provide us a new eld of research. Firstly, this can be seen as a complementary test of CP violation by assuming the correctness of the CPT theorem. Secondly, this can also be a path to follow in order to search for processes beyond the Standard Model. On the theoretical side, most of the time, the T in e R eversal violation e ect comes from an additional term related to the physics beyond SM and added by hand in the QCD Lagrangian. On the experimental side, various observables which are T-odd under time reversal operations can be measured, so that b-decay seems to be one of the most promising channel to reveal TR violation signal.

In a previous letter quoted as [1], a general formulation based on the M . Jacob-G $\mathcal L$. W ick-J $\mathcal D$. Jackson (JW J) helicity formalism has been set for studying the decay process $_{\rm b}$! V (1), where ! p with V ! I 1 or V ! $^{+}$. Emphasis was put on the importance of the initial $_{\rm b}$ polarization as well as the correlations among the angular distributions of the nal decay products. On the dynamical side, the Hadronic Matrix E lements (HME) appearing in the decay amplitude were computed, at the tree level approximation, in the framework of the factorization hypothesis for two-body non-leptonic weak decay of heavy quark. A conmation in the validity of the factorization hypothesis was the agreement found between the theoretical estimate of the $_{\rm b}$! J=decay width and its experimental measurement given by the Particle Data Group (PDG) average [2].

In our present work, calculations are performed in a more exhaustive and detailed manner. On the dynamical side, both tree and penguin diagrams are involved in the evaluation of the HME. In our case, the non-leptonic $_{\rm b}$ -decay proceeding through the W-loop involves either the b! u or b! s transitions, respectively. The Cabibbo-K obayashi-M askawa matrix elements, $V_{\rm ub}$; $V_{\rm us}$; $V_{\rm cs}$; $V_{\rm tb}$; $V_{\rm td}$ and $V_{\rm ts}$ representing the charged current couplings between quark transitions take place in the tree and QCD, electroweak, QCD-electroweak penguin diagrams calculated for the decay $_{\rm b}$! V (1). O there diagrams such as the annihilation and box diagrams have been neglected in our approach. A key point in the calculation of non-leptonic baryon decays is the calculation of hadronic transition form factors between baryons that will be derived by making use of Heavy Quark E ective Theory (HQET).

On the kinem atical side, helicity methods are employed with an emphasis put on the polarization of the intermediate resonances and V = J = ; 0;! and their particular role in testing the fundamental symmetries like Parity and T ime R eversal operations as well. It is worth to say that the present work mainly based on the cascade-type analysis is very

useful in analysing polarization properties and T im eReversale ects. Them ain advantage of the decay cascade type holds in a treatment where every decay in the decay chain is performed in its respective rest frame. Finally, full Monte-Carlo simulations including all the kinematics and dynamics are performed according to the computational model.

The rem inder of the paper is organized as follows. In Section 2, we present the kinematical properties of $_{\rm b}$! V (1) decays where the M . Jacob, G $_{\rm c}$. W ick and JD . Jackson helicity formalism is extensively applied. In this section, we also emphasize the physical importance of polarization, mainly that of the intermediate resonances, and V , respectively. In Section 3, we derive the decays of the intermediate resonances previously mentioned: all the calculations of $_{\rm c}$! p , V ! I and V ! are performed a la Jacob-W ick-Jackson where the role of the helicity frame is strongly alighted.

A first the kinematical analysis of $_b$! V (1) decays, we focus on the dynamical analysis of $_b$ -decay in Section 4. Transition form factors are derived in Heavy Quark E ective Theory which is well suited for $_b$ -decay since the b quark mass is large enough to play the adequate energy scale in order to make an expansion in $1=m_b$ of the QCD Lagrangian written in the HQET formalism. Corrections to the order of O ($1=m_b$) are included into the weak transition form factors between the baryons $_b$ and and an usual model for describing baryon wave functions is also applied in our calculations. The weak decay amplitude of the analysed process is derived by following an E ective Field Theory (EFT) approach. Operator product expansion and Wilson coe cients are used in order to include long and short distance physics, respectively. Moreover, in the special case of V=0 and !, the charge symmetry violation mixing between these two vectors is included since it may rise to a large signal of CP violation due to a large strong phase dynamically produced at the ! resonance.

In Section 5, we list all the num erical inputs, CKM m atrix elements, quark and m eson m asses and decay constants that are needed for calculating all the physical observables related to our analysis. Section 6 is devoted to results and discussions regarding all the simulations we made for $_{\rm b}$! V (1) decays: branching ratio, BR, CP violating asymmetry parameter, $_{\rm AS}$, polarization, P, and various angular distributions. In this section, we also stress on the main physical observables which can be measured with the future detectors at the CERN-LHC proton-proton collider. In Section 7, we discuss in detail the search for T im e-odd observables and we conclude this section by proposing an observable which is odd under T im e Reversal operation: the distributions in cosine and sine of the normal-vectors to the decay planes of the intermediate resonances, and V, in the $_{\rm b}$ frame. Finally, our main results are sum marized in the last section where conclusions and global search for discrete symmetries are discussed.

2 Kinematical properties of b! V (1) decays

The hyperons produced in proton-proton collisions as well as in other hadron collisions are usually polarized in the transverse direction. The average value of the hyperon spin being non equal to zero and, owing to Parity conservation in strong interaction, the spin direction is orthogonal to the production plane de ned by the incident beam momentum, \mathfrak{p}_1 , and the hyperon momentum, \mathfrak{p}_h . Usually, the degree of polarization depends on the

center of m ass energy, $_{b}^{p}$, and the hyperon transverse m omentum $[\beta]$. In the case of pp! $_{b}$ + X at high $_{s}$, the b quark could replace the s quark of an ordinary and it is expected that the beauty baryon, $_{b}$, will be polarized in the same way than the hyperon. We do no \mathbb{N}_{P} as the normal vector to the production plane:

where p_1 and p_0 are the vector-momenta of one incident proton beam and p_0 , respectively.

Let ($_{b}X\ Y\ Z$) be the rest fram e (see Fig. 1) of the $_{b}$ particle. The quantization axis ($_{b}Z$) is chosen to be parallel to N_{P} . The other orthogonal axis ($_{b}X$) and ($_{b}Y$) are arbitrary in the production plane. In our further analysis, the ($_{b}X$) axis is taken parallel to the momentum p_{1} , which constrains the direction of the ($_{b}Y$) axis in the production plane. The spin projection, M $_{i}$, of the $_{b}$ along the transverse axis ($_{b}Z$) takes the values 1=2. An important physical parameter is the $_{b}$ Polarization Density Matrix (PDM), ($_{b}$). It is a (2 2) herm it in matrix with real diagonal elements verifying $_{i=1}^{2}$ $_{ii}^{b}$ = 1. The physical meaning of the diagonal matrix elements is the following: the probability of getting $_{b}$ produced with M $_{i}$ = 1=2 is given by $_{11}^{b}$ and $_{22}^{b}$, respectively. Finally, the initial $_{b}$ polarization, P $_{b}$, is given by hS $_{b}$ N_{P} i = P $_{b}$ = $_{11}^{b}$ $_{22}^{b}$:

In the fram ework of the JW J helicity form alism [4], the decay amplitude, A_0 (M $_i$), for $_b$ (M $_i$)! ($_1$)V ($_2$) is obtained by applying the W igner-E dkart theorem to the S-m atrix element:

where p = (p; ;) is the vector-m om entum of the hyperon in the $_{\rm b}$ frame (Fig. 1). $_{\rm 1}$ and $_{\rm 2}$ are the respective helicities of and V with the possible values $_{\rm 1}$ = 1=2 and $_{\rm 2}$ = 1;0;+1. The momentum projection along the () axis (parallel to p) is given by M $_{\rm f}$ = $_{\rm 1}$ = 2 = 1=2. The M $_{\rm f}$ values constrain those of $_{\rm 1}$ and $_{\rm 2}$ since, among six possible combinations, only four are physical. If M $_{\rm f}$ = +1=2 then ($_{\rm 1}$; $_{\rm 2}$) = (1=2;0) or (1=2; 1). If M $_{\rm f}$ = 1=2 then ($_{\rm 1}$; $_{\rm 2}$) = (1=2;1) or (1=2;0). On other side, the hadronic matrix element, A ($_{\rm 1}$; $_{\rm 2}$) ($_{\rm b}$! V), contains all the decay dynam ics describing, for a set of helicities $_{\rm 1}$ and $_{\rm 2}$, the hadronic part of the decay $_{\rm b}$! V and nally the W igner matrix element,

is expressed according to the Jackson convention [4]. A coording to standard rules, the di erential cross-section, d , must take account of the undeterm ined helicity initial state and include a sum m ation over individual nalhelicity states, the total angular m om entum along the helicity () axis, $= M_f = 1_0$, being xed. We get the expression:

As it is known, Parity is not conserved in weak interactions therefore the hadronic matrix element A $_{(1;2)}$ ($_{b}$! V) is not equal to A $_{(1;2)}$ ($_{b}$! V). In order to handle in an

easy manner lengthy calculations, the following mathematical expressions are introduced:

which represent respectively the weight of the helicity states +1=2 and 1=2 along the () axis. W ith such notations, the di erential cross-section can be rewritten in the simple form:

Then, by averaging over the azimuthal angle, , a standard relation is obtained for the polar angular distribution:

where it can be noticed that polar angular dissym etries are intimately related to the initial polarization of the $\,_{\rm b}$ resonance.

2.1 Physical importance of the polarization

Parity violation in $_{b}$ weak decays into V necessarily leads to a polarization process of the two intermediate resonances and V. In order to determ ine the vector-polarization of each resonance, a new set of axis is needed according to which properties of the vector-polarization $P^{(i)}$ with i=; V by Parity and V im V eversal (TR) transform ations will be more obvious. Let V be the unit vector which is parallel to the preceding vector V, V, V being transverse to V production plane, and V the momentum of a resonance in the V rest fram V. The following unit vectors are defined (the index (i) being dropped):

In this new frame, the vector-polarization of any resonance de ned in the original $_{\rm b}$ frame can be rewritten like:

such that each component can be easily computed, $P_j^{(i)} = P^{(i)}$ jew ith j = L;N;T. We recall that $P_L;P_N;P_T$ are named longitudinal, normal and transverse polarizations, respectively. Using the properties of the spin, s, and the vector-polarization, P, under Parity and TR operations, we can deduce those of $P_j^{(i)}$ displayed in Table 1.

It is worth noticing that the norm alpolarization (of any resonance) $P_{\rm N}$ is odd by T im e-R eversal operation. It allows us to say that the know ledge of the vector-polarization, P, and particularly its norm aloom ponent, $P_{\rm N}$, are essential observables for performing any test of validity of T im e-R eversal sym m etry.

2.2 Polarization of the intermediate resonances

Interm ediate resonance states, and V, can be described by a density-matrix named which analytic expression is given by standard quantum -mechanical relations:

where T is the transition-m atrix related to the S-m atrix by S=1+iT. Its elements being the hadronic elements, A $_{(1;2)}$ ($_b$! V), m entioned beforehand. W ith the help of the density-m atrix f , the vector-polarization of the global system m ade out of f and V can be estimated according to the relation:

where Tr is the trace operator and S the spin of the global system dened by $S = \mathcal{F}_1 + \mathcal{F}_2 \mathbf{j}$. S_1 and S_2 being the spin of the baryon and the vector meson V, respectively.

The striking point is that the nal system is composed of two correlated subsystems because only four spin-states instead of six are required to describe the quantum system (V). So, in order to determ ine the kinematics features of each resonance, namely

and V, and particularly there vector-polarization, P and P^V , some modi cations of the previous relations are requested. Our task will consist in estimating individual density-matrix and vector-polarization for each resonance by strictly applying quantum – mechanical rules [5, 6].

2.3 Determination of P

helicity states and its vector-polarization can be extracted from the above relations by sum m ing over the kinem atics variables of the vector-m eson states, especially its helicity states. Departing from formulas (15) and (16), the following relation can be inferred:

This clearly shows that polarization depends a priorion its em ission angles. In Eq. (17), we have also de ned:

= $_1$ $_2$, the vector-m eson helicity $_2$ which varies with the kinematical constraint = M $_{\rm f}$ = 1=2.

~ are the Pauli spin 1=2 m atrices and they are de ned in the (xyz) rest-frame where the axis x; y and z are respectively identied with the normal, transverse and longitudinal axis previously de ned.

The matrix elements given in the right-handed side of Eq. (17) can be explicitly calculated [7] and the three components of P get the following expressions:

In these detailed form ulas given in Eqs. (19-21), we underline the importance of two input param eters:

(i) the initial $_{\rm b}$ polarization, P $_{\rm b}$, and (ii) the non-diagonal matrix element, $_{\rm +}{}^{\rm b}$, which appears essentially in the interference term s.

2.4 Longitudinal polarization of V

Vector meson has spin $S_{(2)} = 1$ and therefore three helicity states. The components of its vector-spin operator, S_j ; j = x; y; z, are (3 3) matrices and they are defined in a new set of longitudinal, normal and transverse axis. The longitudinal one being the spin quantization axis and verifying the standard relation: $S_z j_2 i = 2j_2 i$.

Com putation of the norm aland transverse components, respectively $P_N^{\,\,V}$ and $P_T^{\,\,V}$, as well as the analytical method of extracting these values from experimental data will not be exposed here. In this paper, in a rst aim, only the longitudinal component, $P_L^{\,\,V}$, will be estimated. A coording to the basic relation:

where the kinematics functions (1=2) have been dened in Section 2. It may be noticed that the mathematical form of P_L^V is very similar to that of P_L (same longitudinal axis) so that the helicity value $_2=0$ does not play any role in the longitudinal polarization of the vector-meson.

3 Decays of the intermediate resonances

Perform ing appropriate rotations and Lorentz boosts, the decay products of each resonance can be studied in its own helicity frame (see Fig. 1). The quantization axis of each frame is chosen parallel to the corresponding resonance momentum in the b frame i.e. $O_1z_1^i$ jp and $O_2z_2^i$ jp $_V=p$. Again, conservation of the total angular momentum (in each frame) constrains the helicities of the nal particles. For the decays $(1) \cdot P(3) \cdot (4)$ and $V(2) \cdot (5)^{+} \cdot (6)$ or $V(2) \cdot h \cdot (5)^{+} \cdot (6)$; the respective helicities are (3;4) = (1=2;0) and (5;6) = (1=2;1=2) in case of leptons or (5;6) = (0;0) in case of 0 mesons.

In the helicity frame, the projection of the total angular momentum, m $_{i}$, along the proton momentum, p $_{p}$, is given by m $_{1}$ = $_{3}$ $_{4}$ = $_{1}$ =2. In the vector meson helicity frame, this projection is equal to m $_{2}$ = $_{5}$ $_{6}$ = $_{1}$;0;+1 if leptons and m $_{2}$ =0 if pions. The decay amplitude, A $_{i}$ ($_{i}$), of each resonance can be written similarly as in Eq. (2), requiring only that the kinematics of its decay products are xed. Thus, we obtain,

where $_1$ and $_1$ are respectively the polar and azim uthal angles of the proton m omentum in the rest fram e while $_2$ and $_2$ are those of ' (h) in the V rest fram e. Finally, A $_{(\,_3;\,_4)}$ (! p) and A $_{(\,_5;\,_6)}$ (V ! $_1^+$ l ; $_1^+$ h) are the dynam ical amplitudes of the strong interaction part of the decay processes ! p and V ! $_1^+$ l ; $_1^+$ h , respectively.

3.1 A nalytical form of the decay probability

The general decay am plitude, A_1^g (M $_i$; $_1$; $_2$), for the process of sequence decays $_b$ (M $_i$)! ($_1$)V ($_2$)! p '' ($_1$)h h can be factorized according to the three decay am plitudes A_0 (M $_i$); A_1 ($_1$) and A_2 ($_2$). It must include all the possible intermediate states, so that a sum over the helicity states ($_1$; $_2$) is performed:

The decay probability, d , depending on the am plitude, A $_{\text{I}}^{\text{g}}$ (M $_{\text{i}}$; $_{\text{l}}$; $_{\text{l}}$), takes the form ,

where the polarization density matrix, $_{M_{i}M_{i}^{0}}$, is used to take into account the unknown initial $_{b}$ spin states, M $_{i}$. Since the helicities of the nal particles are not measured, a sum mation over the helicity values $_{3}$; $_{4}$; $_{5}$ and $_{6}$ is performed as well. From the above relations, angular distributions of the decay products of both the two resonances can be deduced. A lthough these angular distributions are well established in the literature, the method outlined before allows us to compute the Polarization D ensity M atrix (PDM) elements of each resonance. We underline that these angular distributions are important ingredients for the determination of its vector-polarization, $P^{(i)}$ (i = V).

Taking advantage of parity conservation in strong or electrom agnetic V-decays, a relatively simple polar angular distribution can be obtained after averaging over the azim uthal angle 2. Thus, in case of leptonic decays:

4 Hadronization

In this section, the Heavy Q wark E ective Theory [8,9,10] (HQET) form alism will be used to evaluate the hadronic form factors involved in $_{\rm b}$ -decay. Weak transitions including heavy quarks can be safely described when the mass of a heavy quark is large enough compared to the QCD scale, $_{\rm QCD}$. Properties such as avour and spin symmetries can be exploited in such way that corrections of the order of $1=m_{\rm Q}$ are system atically calculated within an elective eld theory. Then, the hadronic amplitude of the weak decay is investigated by means of the elective Hamiltonian, B=1, where the Operator Product Expansion formalism separates the soft and hard regimes.

4.1 Transition form factors

The decay, $_{\rm b}$! V, is usually described by the following general amplitude, A ($_{\rm b}$! V),

The Stech's approach [11] mainly assumes that the o-shell energy of a constituent diquark is close to its constituent mass (without dependence of its space momentum) in the rest frame of the baryon. Moreover, the spectator quark retains its original momentum and spin before nalhadronization. Therefore, the energy carried by the spectator quark is equal to that of the spectator in the rest frame of the nal state particle and the relevant b-quark space momenta are much smaller than the b quark mass: indeed, it is assumed to be of the order of the connement scale, $_{QCD}$. This approach rstly used in the meson case can be generalized to a heavy baryon considered as a bound state of a b quark and a scalar diquark. 4.5 Operator Product Expansion

The Operator P roduct Expansion (OPE) [15, 16, 17] is used to separate the calculation of a baryonic decay amplitude, into two distinct physical regimes. One is called hard or short-distance physics, represented by W ilson Coe cients and the other is called soft or long-distance physics. This part is described by $O_i()$, and is derived by using a non-perturbative approach. The operators, O_n , entering from the Operator P roduct Expansion (OPE) to reproduce the weak interaction of quarks, can be understood as local operators which govern a given decay. They can be written, in a generic form, as,

The W ilson coe cients [16], C $_{\rm i}$ (), represent the physical contributions from scales higher than (of the order of 0 (m $_{\rm b}$) in b-quark decay) and since QCD has the property of asymptotic freedom, they can be calculated in perturbation theory. They include contributions of all heavy particles, and are calculated to the next-to-leading order (NLO) in such a way that one can get some corrections O($_{\rm s}$) from the leading-log-order (LO). 4.7 ⁰! mixing scheme

The direct CP violating asymmetry parameter, a_{CP} , integrated over all the available range of energy of the $^+$ invariant mass is found to be small for most of the non-leptonic exclusive b-decays when either the factorization framework is applied. However, it appears that the asymmetry may be large in the vicinity of a given resonance, namely the ! meson in our case. To obtain a large signal for direct CP violation requires some mechanism to make both sin and r large. We stress that 0 ! mixing has the dual advantages that the strong phase dierence is large (passing rapidly through 90° at the ! resonance) and well known [23, 24, 25, 26, 27, 28]. In the vector meson dominance model [29], the photon propagator is dressed by coupling to the vector mesons 0 and !. In this regard, the 0 ! mixing mechanism [30, 31] has been developed. In most phenomenological applications, the widely used CKM matrix parametrization is the Wolfenstein parametrization [38,39]. One of the main advantages in comparison with the standard parametrization [40,41] is its easy analytical derivation at any order of . a Four independent parameters, ;A; and , are usually used to describe the CKM matrix and each of these parameters can be (in) directly measured experimentally. By expanding each element of the CKM matrix as a power series in the parameter = $\sin_c = 0.2224$ (c is the Gell-Mann-Levy-Cabibbo angle), and going beyond the leading order in terms of in a perturbative expansion of the CKM matrix, it is found that the CKM matrix takes the following form (up to corrections of O (c):

5.2.2 Form factors and decay constants

The baryon heavy-to-light form factors, $F_i(k^2)$ and $G_i(k^2)$, depending on the inner structure of the hadrons have been calculated in Section 4.

The decay constants for vector mesons, f_V , do not suer from uncertainties as large as those for form factors since they are well determined experimentally from leptonic and semi-leptonic decays. Let us rst recall the usual denition for a vector meson,

6 Physical results and simulations

According to the preceding sections, all the essential parameters to perform precise simulations can be determined. We will particularly focuss on the polarization, P, the PDM element, $_{00}^{V}$, of the vector-meson, the helicity and CP violating asymmetry parameters, $_{AS}^{b}$ and $_{CP}$, of $_{b}$ -decay and nally the branching ratios BR ($_{b}$! V) where V holds for $_{0}^{0}$! and J= .

6.1 Branching ratios

By means of kinematical analysis developed in Sections 2 and 3 and the factorization procedure developed in Section 4, it allows us to compute the branching ratios of $_{\rm b}$! $_{\rm b}$

6.2 Special case of ⁰! mixing

It is well known that the ! m eson decays into $^+$ pair with a branching ratio of 2.2% and thus m ixes with the 0 m eson by electrom agnetic interaction. So, this m ixing can be taken into account for the computation of the branching ratio BR ($_b$! 0) on one hand, and for comparison with the conjugate process $_b$! 0 on the other hand. This comparison will allow us to check the direct CP violation in the sector of beauty baryons if a notable difference is found between $_b$ -decay and its charge conjugated one.

Computing the branching ratio of the charge conjugated process requires that only the CKM matrix elements, V_{ij} , must be complex conjugated, while the intrinsic tree and penguin amplitudes are left unchanged. Owing to the important 0 width, $_0$ = $150~M~eV=c^2$, by comparison to the ! one, $_!$ = $8~M~eV=c^2$, the branching ratios BR ($_{\rm b}$ ($_{\rm b}$)! () 0 (!)), which matrix element is given by relation (112), is estimated by making use of M onte-Carlo techniques. The $^+$ invariant squared mass, s , is generated according to a relativistic B reit-W igner [43] where the mass M $_{\rm R}$ and width $_{\rm R}$ are identied with M and , respectively. For each generated invariant mass, s , the CP violating asymmetry parameter, $a_{\rm CP}$ (s), between the two conjugated channels can be de ned as,

In Fig. 7, the CP violating asymmetry is plotted according to s. A remarkable e ect is seen in the mass interval [720 820]M eV= 2 , which includes the ! meson mass. W hatever is the value of N $_{\rm c}^{\rm eff}$, one observes a strong enhancement of a_{CP} (s) when the invariant mass is in the vicinity of 780M eV= 2 .

In Table 3, the num erous results obtained from the M -C simulations are gathered in case of 0 ! mixing for $_b$! $^0(!)$! $^+$ decay: mainly these are the mean branching ratio, BR, the asymmetry parameter, $a_{\rm CP}$, computed in the whole range of $^+$ mass and the same asymmetry, $a_{\rm CP}$ (!), limited to the ! mass interval. Because of 0 ! mixing, the branching ratio BR ($_b$! $^0(!)$) weakly increases in comparison to that of BR ($_b$! 0). We also notice that the $a_{\rm CP}$ (!) for $_b$! $^+$ always reaches its maximum value when s is in the range of the onega mass. However, its maximum value strongly varies according to the ective number of color, N $_{\rm c}^{\rm eff}$. Due to a lack of experimental data for the branching ratio BR ($_b$! 0 (!)), there is no way

of constraining N $_{\rm c}^{\rm eff}$, unfortunately. In any case, the actual result can be seen as a clear signal of direct C P violation between beauty baryon and beauty anti-baryon.

6.3 Helicity asymmetry and angular distribution

6.3.1 b! V decay

W ith respect to the de nition of the helicity asymmetry parameter, $_{AS}^{b}$, given in Section 3, its numerical value depends on the nature of the vector-meson V:

In Fig. 8 are plotted the cos and distributions of the -baryon in $_{\rm b}$ rest-frame, in case of $_{\rm b}$! $^{\rm 0}$ (!). Results are only shown in case of $^{\rm 0}$ vector since they are very similar for J= .

6.3.2 ! p decay

From preceding relations, both polar and azim uthal angular distributions of proton and can be obtained thanks to the complete determination of the polarization, P, and the PDM element $_{12}$. A gain, these values strongly depend on the nature of the vector-meson V coming from $_{\rm b}$ decays. One obtains the following results:

It is worthy noticing that, in the fram ework of the factorization hypothesis previously exposed, the non-diagonal matrix element, $_{12}$, is real, which makes easier the kinematics simulations. In Fig. 9 are also plotted the cos and distributions of the proton in rest-frame in case of $_{\rm b}$! 0 (!). Similar results have been obtained in case of J= .

6.3.3 V! ''; h^+h decays

The angular distributions of lepton or pseudoscalar m eson in the vector-m eson rest-fram e essentially depend on the normalized PDM element $_{00}^{V}$. The latter is related to the probability of the vector-m eson V to get an helicity value $_{2}$ = 0. Its numerical values are $_{00}^{J=}$ = 0:66 and $_{00}$ = 0:79, for J= and 0 , respectively..

Despite the complicated form of W $_2$ ($_2$; $_2$) diplayed in Eq. (35), the distribution of the azim uthal angle $_2$ will be uniform in the angular range [0;2]. Finally, in Fig. 10 are shown the cos and cos distributions for $_b$! 0 (!)! $^+$ and $_b$! $_$ J=! $^+$, respectively.

7 Time-odd observables

Previously, it has been shown that, in an appropriate frame related to each intermediate resonance, the normal component of the resonance vector-polarization is a Time-odd observable and its measure could be a signal of TR violation. However, experimental determination of $P_N^{(i)}$ (i = ;V) is a dicult task [44] and it requires high statistics data. Luckily, other possibilities to test TR symmetry exist. They have been developed by several authors and they rely on the search for Triple Product Correlations (TPC) among physical parameters represented by expressions like a_i \mathcal{B}_j , where vectors a_i ; \mathcal{B}_j and e_k are either momentum or spin [45, 46, 47]. It is worth recalling that the spin of any particle is not a direct measurable quantity and, only polarization with respect to a given direction can be determined.

In the following, emphasis is put on TPC built from nalkinem atics variables measured in the $_{\rm b}$ rest-frame. Needless to say that the detailed calculations performed in this work, both the (geometrical) angular distributions and the (dynamical) form factors deduced from HQET, represent important ingredients for precise computations of the TPC or their spectrum. In the recent years, L. Sehgal [48] and L. W olfenstein [49] analyzed very thoroughly experimental data coming from the reaction K $_{\rm L}^{\rm 0}$! $^{+}$ e $^{+}$ e , and they interpreted some kinematics asymmetry as T-odd e ects. However, these e ects do not necessarily indicate a TR violation, provided that complementary hypothesis (like non-conservation of CPT symmetry) have to be done.

Inspired by the pioneering work of these authors, we give a special care to the analysis of som e particular angles. First of all, we recall how the basis vectors of the $_{\rm b}$ rest-fram e (de ned in Section 1) transform under TR:

An important question arises: what could be the order of magnitude of these TR violation processes? The only way to answer this question is the method of M-C \sin ulations which provides us the interesting spectra of $\cos_{(n_i)}$ and $\sin_{(n_i)}$ in order to cross-check the TR violation assumption. Exhaustive M-C studies were performed by using all the allowed values of the input parameters of our model and they reveal strong correlations of the T-odd observables with the azim uthal angular distribution.

(i) By adopting the sim ple hypothesis of a at distribution for d=d, no dissym etries are observed in any of $\cos_{(n_i)}$ or $\sin_{(n_i)}$ distributions. Their mean values are very close to zero and the absolute value of the asym metry factor, AS (X), de ned by,

What could be the origin of these asymmetry discrepancies, despite the fact that the normal vectors n and n_V respectively to and V decay planes play similar role?

In our opinion, it is caused by the very difference of the azim uthal angular distributions p in rest-frame and p in p in

8 Conclusion

We have studied the decay process $_{\rm b}$! V (1) where the vector meson V is either J=; $^{\rm 0}$ or!, with the inclusion of $^{\rm 0}$! mixing when it was appropriate. When the invariant mass of the $^{\rm +}$ pair is in the vicinity of the! resonance, it is found that the CP violating parameter, $a_{\rm CP}$, reaches its maximum value. In our analysis, we have also investigated the branching ratios, BR, polarizations, P, and direct CP and helicity violating parameters, $a_{\rm CP}$ and $a_{\rm AS}$, respectively, for the same channels.

Thanks to an intensive use of the Jacob-Wick-Jackson helicity formalism, rigorous and detailed calculations of the b-decays into one baryon and one vector meson have been carried out completely. This helicity formalism allows us to clearly separate the kinematical and dynamical contributions in the computation of the amplitude corresponding to b! V(1) decay. The cascade-type analysis is indeed very useful for analysing polarization properties and T in eR eversale ects since the analysis of every decay in the decay chain can be performed in its respective rest frame. In order to apply our form alism, all the num erical simulations have been performed thanks to a Monte-Carlo method. We also dealt at length with the uncertainties coming from the input param eters. In particular, these include the Cabibbo-Kobayashi-Maskawa matrix element param eters, and , the e ective number of colors, N $_{\rm c}^{\rm eff}$, com ing from the factorisation scheme we have followed and the phenomenological model of the baryon wave functions for b and . Moreover, the heavy quark e ective theory has been applied in order to estimate the various form factors, $F_i(q^2)$ and $G_i(q^2)$, which usually describe dynamics of the electroweak transition between two baryons. Corrections at the order of O (1=mb) have been included when the form factors were computed. In the calculation of b-baryon decays, we need the W ilson coe cients, C (m b), for the tree and penguin operators at the scale m_b. We worked with the renormalization scheme independent Wilson coe cients. One of the major uncertainties is that the hadronic matrix elements for both tree and penguin operators involve nonperturbative QCD. We have worked in the factorisation approximation, with N c treated as an elective parameter de ned as N eff. A lthough one m ust have some doubts about factorisation, it has been pointed out that it may be quite reliable in energetic weak b-decays. The recent experimental measurement of branching

ratio for $_{\text{b}}$! J= has con rm ed the theoretical calculations we made for a value of N $_{\text{c}}^{\text{eff}}$ close to 2.5-3.5.

As regards theoretical results for the branching ratios b! J=; h! b!!, we made a comparison with PDG for b! J= where an agreement is found 2:1 1:9 10^6 and BR th (_b! J=) = 3:1 10^6). $(BR^{exp}(_b! J=) = 4:7$ 0 and $_{\mathrm{b}}$! !, the lack of experimental results does not allow us to draw conclusions. However, we made two theoretical branching ratio (in unit of 10^{-7}) predictions, from 1:6 to 2:4 and from 0:64 to 2:23 for $_{\rm b}$! 0 and $_{\rm b}$! respectively. We have to keep in mind that, because of the diculty in dealing with non factorizable e ects associated with nal state interactions, which are more complex for baryon decays than meson decays, these latter results are more dependent on the e ective number of colors, N_c^{eff} . In the special case of 0 ! m ixing, the branching ratio , has a mean value around 2:15 107. The direct violating CP asymmetry parameter, a_{CP} , has also been calculated and a clear signal of direct CPviolation between beauty baryon and beauty antibaryon has been observed. We have determ ined a range for the maximum of direct CP asymmetry, amax, as a function of the param eter, N $_{\rm c}^{\rm eff}$ and the $^{+}$ invariant m ass. M oreover, the mean value of the direct CP violating asym m etry for $_{\rm b}$! 0 (!)! , has been computed as well.

By making use of the helicity asymmetry parameter, $_{\rm AS}$, determined for $_{\rm b}$! ⁰ (!), respectively, it allowed us to a complete determination of the polar angular distribution of the hyperon in the b rest-frame. In fact, the knowledge of the polarization, P, which depends on the nature of the vector m eson produced, in addition to that of the PDM elements, $_{ii}^{b}$, made available the polar and azim uthal angular distributions of the proton (and pion) in the rest fram e. In a similar way, the polar and azim uthal angular distributions of leptons and pseudo-scalar m esons in the vector m eson rest-fram e have been also computed. From weak decays analysis, one knows that vectorpolarizations of outgoing resonances (or som e of their com ponents in appropriate fram es) are T-odd observables. In our case, the normal components of P and P^{V} are T-odd, respectively and this might lead to a clear signal of TR violation. It is also well known that Triple Product Correlations (TPC) between momentum and spin can be used to put in evidence TR violation. However, not all TPC's can be exploited on the experim ental side, because essentially of the di culties to measure spin (s). In our work, we have shown that new and unsuspected observables can be measured: angular distributions of the norm alvectors to the decay planes of the intermediate resonances in the $\,$ $_{
m b}$ -frame. We found that the magnitude of their e ects is directly related to the b polarization density matrix (PDM) and more precisely to the non-diagonal elements, + b, appearing in the interference term s of the decay am plitude. However, despite our ignorance of the real and im aginary parts of +b, sensible e ects of T im e R eversal asymmetry can be measured, provided the latter are not too small with respect to unity.

In our opinion, new elds of research like direct CP violation and T-odd observables indicating a possible non-conservation of T in eR eversal symmetry can be investigated in the sector of beauty baryons and especially the $_{\rm b}$ -bayons which can be highly produced in the future hadronic machine like LHC. In order to reach this aim, all uncertainties in our calculations still have to be decreased, for example non-factorizable e ects have to be evaluated with more accuracy. Moreover, we strongly need more numerous and accurate experimental data in $_{\rm b}$ -decays, especially the $_{\rm b}$ polarization. We expect that

our predictions should provide useful guidance for future investigations and urge our experim ental colleagues to m easure all the observables related to $_{\rm b}$ baryon decays, if we want to understand direct CP violation and T im e R eversal sym m etry better.




Figure 1: Left-handed: $_{\rm b}$ decay in its transversity fram e. R ight-handed: helicity fram es for the $_{\rm b}$ and vector m eson V decays, respectively.




Figure 2: From left-up to right-down, tree (T), color-commensurate (C), exchange (E) and bow tie (B) diagrams which are allowed in transition $_{\rm b}$! M $_{\rm 1}$: The squared dot represents the electroweak interaction in the Standard M odel. It can be shown that the contribution of each diagram to the total amplitude follows T C E B.




Figure 3: Form factor distributions, $F_i(!)$, for $_b$! V . The full, dashed and dot-dashed lines represent $F_1(!)$; $F_2(!)$ and $F_3(!)$, respectively.




Figure 4: Form factor distributions, $G_i(!)$, for $_b$! V . The full, dashed and dot-dashed lines represent $G_1(!)$; $G_2(!)$ and $G_3(!)$, respectively.




Figure 5: Baryon function distributions for $_{\rm b}$ and $_{\rm b}$ The full and dashed lines represent the $_{\rm b}$ and $_{\rm b}$ distributions, respectively.




Figure 6: Form factor distributions, $_{\rm i}(!)$, for $_{\rm b}$! V. The full and dashed lines represent $_{\rm 1}(!)$ and $_{\rm 2}(!)$ respectively.




Figure 7: B ranching ratio asym m etry, a_{CP} (!), as a function of the invariant m ass in case of $_b$! of (!)! and for N $_c^{eff}$ = 3.




Figure 8: \cos (left) and (right) distributions of the -baryon in $_b$ rest-fram e, in case of $_b$! 0 (!). The Y axis m eans $\frac{dN}{d\cos}$ (left) and $\frac{dN}{d}$ (right).




Figure 9: \cos_P (left) and $_P$ (right) distributions of the proton in rest-frame in case of $_b$! $_0^0$ (!). The Y axis means $_{\frac{dN}{d\cos_P}}$ (left) and $_{\frac{dN}{d}}$ (right).




Figure 10: \cos (left) and \cos (right) distributions in vector rest-frame, for $_b$! or $_b$! and $_b$! J= ! + , respectively. The Y axis means $\frac{dN}{d\cos}$ (left) and $\frac{dN}{d}$ (right).
