# Testing the theory of QGP-induced energy loss at RH IC and the LHC

We compare an analytic model of jet quenching, based on the GLV non-Abelian energy bases form alism, to numerical results for the centrality dependent suppression of hadron cross sections in Au+Au and Cu+Cu collisions at RHIC. Simulations of neutral pion quenching versus the size of the colliding nuclear system are presented to high transverse momentum  $p_T$ . At low and moderate  $p_T$ , we study the contribution of medium -induced gluon brem sstrahlung to single inclusive hadron production. In Pb+Pb collisions at the LHC, the redistribution of the lost energy is shown to play a critical role in yielding nuclear suppression that does not violate the participant scaling limit.

# I. IN TRODUCTION

Strong suppression of single inclusive pions and charged hadrons at large transverse m om entum, as large as  $p_T = 20 \text{ GeV} [1, 2]$ , is arguably one of the most fascinating phenomena from the heavy ion program at the Relativistic Heavy Ion Collider (RHIC). It signies the transition from soft, collective and strongly modeldependent physics to the high  $p_T$  or  $E_T$  production of particles and jets that is well understood in term s of the perturbative Quantum Chromodynam ics (pQCD) factorization approach. Calibrated hard probes can thus be used to sample the properties of the medium created in collisions of heavy nuclei [3]. With capabilities to de-50 GeV pions and  $E_T$ 500 GeV jets with tect pr good statistics, experiments at the Large Hadron Collider (LHC) will be able to critically test such perturbative calculations of hadron and jet modi cation in the quark-gluon plasm a (QGP) at a new energy frontier.

Following the discovery [4] of jet quenching in Au+Au collisions and its veri cation through d+Au measurem ents [5] at R H IC, heavy ion theory has emphasized the need for a system atic study of the energy and system size dependence of leading particle attenuation [3, 6]. Previous measurements have been limited to transverse mom enta p<sub>T</sub> 10 GeV and Au+Au collisions at RHIC []. M ore recent results up to  $p_T$ 20 GeV 1, 2] in both Au+Au and Cu+Cu reactions were shown to be com patible with several theoretical estimates, emphasizing the nalstate QGP-induced suppression of jets (, 8, 9]. In this Letter, we compare for the st time analytic 3] and num erical [6] models of jet absorption in order to establish the role of sub-leading e ects, such as the running of the strong coupling constant s with the Debye ' gT in the plasma. We present our screening scale predictions for  $^{0}$  quenching versus centrality,  $p_{T}$  and s, based on the G yulassy-Levai-V itev (G LV ) approach to the m edium -induced non-A belian energy loss [10]. W e note that redistribution of the lost energy in small and moderate pr hadrons plays a signi cant role in the transition from high  $p_T$  suppression to low  $p_T$  enhancement of the back-to back two particle correlations [11]. In this

Letter we give results for single inclusive pions and identify the range of transverse m om enta at RHIC and the LHC where the gluon feedback is important.

In Section II we present a simple analytic model for the system size, N<sub>part</sub>, dependence of jet quenching in nucleus-nucleus collisions. Section III contains select intermediate results from the GLV theory, including the evaluation of the mean gluon number hN<sub>g</sub>i and fractional energy loss h E =E i. The derivation of the radiative gluon contribution to smalland moderate  $p_{\rm T}$  hadron production is given in Section IV . Section V presents the calculated suppression of  $^0$  production in Cu+Cu and Au+Au collisions at RHIC and Pb+Pb collisions at the LHC.Conclusions are given in Section V I.

# II. ANALYTIC MODEL OF JET QUENCHING

W hile tom ographic determ ination of the properties of them edium created in nucleus-nucleus collisions can only be achieved through detailed num erical simulations, it is useful to de ne a simpli ed analytic model which incorporates the essential features of jet quenching calculations. We rst review the approach form ulated in <code>\$]</code> and discuss its advantages and lim itations.

The nal state m edium -induced energy loss occurs after the hard partonic scattering ab! cd and before the fragm entation of the parent parton into a jet of colorless hadrons. We consider for simplicity high  $p_T > 5 \text{ GeV}$ hadron production at R H IC and will show later that the contribution of the induced brem sstrahlung in this region is sm all. There are two equivalent ways of im plem enting energy loss in the perturbative QCD hadron production formalism. The rst one associates E with the kinematic modi cation of the momentum fraction  $z = p_c^{\dagger} = p_c^{\dagger}$ in the fragmentation function  $D_{h=c}(z)$ , leaving the hard parton production cross section d  $^{c}=dyd^{2}p_{T_{c}}$  unm odi ed. The second approach reduces the jet cross section in the presence of the medium but leaves  $D_{h=c}(z)$  unaltered. It can conveniently be implemented in an analytic model of QGP-induced leading hadron suppression. We take the underlying parton production cross section to be of

power law type

where n = n (y;  $p_{T_c}$ ;  $\overline{s}$ ) and  $p_0$  2.5 GeV at RHIC. In a nite p range, xed rapidity y and center of mass energy  $\overline{s}$ , a constant n = hn (y;  $p_{T_c}$ ;  $\overline{s}$ ) i is a good approximation. At RHIC, in the region of 5 GeV <  $p_{T_c}$  < 10 GeV, the spectra scale roughly as  $n_q = 7$ ,  $n_g = 8.4$ . Fragmentation functions are convoluted with the partonic cross section as follows

In Eq. (2)  $z_{m \text{ in}} = p_T = p_{T_{c} m ax}$  and the subsequent approximation is most reliable when  $z_{m \text{ in}}$  1. It should be noted that hzi will also depend on the partonic and hadronic species.

The second input to the analytic model comes from the radiative energy loss form alism [10]. To understand the system size dependence of jet quenching, we use the approximate G LV formula which relates E to the size and the soft parton rapidity density of the medium. For (1+1)D B jorken expansion, in the limit of large parton energy  $2E = {}^{2}L$  1, we not [2]

In Eq. (3) L is the jet path length in the medium and A<sub>2</sub> is the transverse area.  $C_R = 4=3$  (3) for quarks (gluons), respectively, is the quadratic C asim ir in the fundam ental (adjoint) representation of SU (3). Num erical simulations of E = E clearly indicate a weaker dependence of the fractional energy loss on the jet energy than given in Eq. (3).

The key to understanding the dependence of jet quenching on the heavy ion species and centrality is the e ective atom icm ass number,  $A_e$ , or the number of participants, N<sub>part</sub>, dependence of the characteristic plasm a parameters in Eq. (3) [3],

up to logarithm ic corrections from Eq. (3). If a parton loses this momentum fraction during its propagation in the medium to escape with momentum  $p_{T_{\rm c}}^{\rm quench}$ , immediately after the hard collision  $p_{T_{\rm c}}=p_{T_{\rm c}}^{\rm quench}=(1~)$ . In Eq. (7) e is the average over all parton species and accounts for the color charge, geometry and multi-gluon uctuations. From this result we can easily derive the

system size dependence of the nuclearm odi cation factor

In Eq. (8)  $k=(n \ 2)$  is the proportionality coe cient in Eq. (6) which depends on the microscopic properties of the medium but not on its size. With n 1 and experimentally measured and theoretically calculated suppression, 5 fold in central Au+ Au collisions at RHIC,  $e = N_{part}^{2=3} k=(n \ 2)$  is small. We thus predict that the logarithm of nuclear suppression, Eq. (8), has simple power law dependence on the system size

where the leading correction goes as  $k^2 N_{part}^{4=3}=2 (n 2)$ 

We focus on the most central nuclear collisions and use in pact parameters b = 1 3 fm depending on the atom ic mass A. An optical G lauber model calculation is used to evaluate N<sup>2=3</sup><sub>part</sub> with <sup>in</sup><sub>pp</sub> = 42 mb and a Wood-Saxon nuclear density with results given in Table I. The analytic prediction for the system size dependence of jet quenching is shown in Fig. 1. It is xed by the magnitude of the suppression established in central Au+ Au collisions [7] and consistent with existing simulations [12]. From this analysis we expect a factor 2 suppression in

centralCu+Cu collisions. C om parison to the prelim inary PHENIX  $p_T > 7$  GeV data [1] and STAR  $p_T > 6$  GeV data [2] is also shown in the bottom panel of Fig. 1 with good agreement within the experimental uncertainties. D ashed and solid lines illustrate the di erence between Eqs. (8) and (9) when normalized to the same suppression in centralAu+Au collisions.

The main advantage of the GLV analytic model is the ability to provide guidance on the magnitude of the QGP - induced jet quenching versus centrality and address a large body of experimental data. Its limitations include a xed coupling constant  $_{\rm s}$ , in plementation of only the mean, though suitably reduced, energy loss E and the inability to incorporate additional nuclear e ects, such as the Cronin multiple scattering [5] and nuclear shadow - ing [14]. It also relies on a reference numerical calculation in central A+A collisions in the same  $p_{\rm T}$  and y range as wellas  $\frac{1}{5}$  [12]. The deviation of oN g=dy from the exact

participant scaling in Eq. (4) may lead to less quenching and improved agreem ent with the data in peripheral reactions, but is here neglected.

# III. NUMERICAL EVALUATION OF THE QGP-INDUCED ENERGY LOSS

The solution for the di erential in energy (!) and transverse momentum (k) spectrum of medium induced gluon radiation has been obtained order by order in the correlations between the multiple scattering centers in nuclear matter using the reaction operator approach [10]

Here  $q_i$  are the momentum transfers from the medium, distributed according to a normalized elastic dimential cross section  $_{e1}(i)^{1} d_{e1}(i)=d^{2}q_{i}$ , and  $z_{k} = z_{k} = z_{k-1}$ are the separations of the subsequent scattering centers. In Eq. (10) the color current propagators and inverse formation times are denoted by

N um erical results have been obtained to third order in the opacity,  $hL = {}_gi$ , with all correlations of up to four scattering centers, including the initial hard interaction. To speed up the evaluation of the squared amplitudes, the oscillating quantum coherence phases between the points of interaction were converted to Lorentzians using an exponentially falling geom etry with no sharp edges. The requirem ent that the mean locations  $z_k$ , k = 1 of n scatterers are the same as the one for a uniform soft parton distribution xes the parameter  $I_e$  of such geom etry [10]:

have been incorporated for consistency with our previous work [12]. It was recently shown that for physical onshell nal state gluons the medium induced radiation is infrared and collinear safe [11]. This allows relaxation of the = $Q \times x$ , kj constraints in the future, though it should be noted that the D ebye screening scale still controls the sm allk and ! cancellation between the single and double B om diagram s in the opacity expansion [10].

To evaluate the e ect of multiple gluon emission and arrive at a probabilistic distribution P () for the fractional energy loss =  $E = E = \prod_{i=1}^{n} i$ ,  $i = !_i = E$ , we are motivated by an independent Poisson gluon emission ansatz, but incorporate kinem atic constraints [13]:

We normalize this probability density to unity and Eq. (15) ensures that at every step energy is conserved. As a consequence, for small jet energies and large E = Ethe gluon distribution is distinctly non-Poisson. We evaluate the mean energy loss as follow s:

In Ref. [12] we considered jet production following the binary collision density  $T_{AA}$  (b) in central Au+Au reactions at r = 200 GeV. In an elementary hard interaction inclusive jets are distributed uniform ly in azin uth relative to the reaction plane. We calculated hh E  $ii_{geom}$ : using the line integral, Eq. (10), through the (1+1)D B jorken expanding medium density by correctly weighing the amount of lost energy with the jet production rate. Cylindrical geometry with radius L = 6 fm that gives the same mean energy loss h E i for uniform initial soft parton rapidity density was then constrained. Using Eqs. (4) and (5) we can determ ine the e ective length L, transverse area  $A_2 = L^2$ , gluon rapidity density dN g=dy and e ective atom ic mass Ae for shadowing applications [14] in interacting heavy ion system s of di erent size. Table II sum m arizes the param eters used in our calculation of central, mid-central

and peripheral Au+Au and Cu+Cu collisions at p = 200 GeV at RHIC. For central collisions with p = 5:5 TeV at the LHC, we use dN g = dy = 2000; 3000 and 4000 to test the sensitivity of jet quenching to the QGP

properties.

The calculated fractional energy loss and mean gluon number for quark and gluon jets versus their energy for the centralities and densities discussed above are shown in the left and right panels of Fig. 2. Only in the lim it E <sub>jet</sub> ! 1, E =E ! 0 does the energy loss for quarks and gluons approach the naive ratio  $E^{q} = E^{q} = C_{A} = C_{F} = 9=4$ . For large fractional energy losses this ratio is determined by the E E constraint. In this regime no simple scaling arguments related to the properties of the dense nuclear matter and the color charge are applicable. It should be noted that at high E <sub>jet</sub> the fractional energy loss is not large even at the LHC.

In our calculation the strong coupling constant  $_{\rm s}$  is not used as a free param eter but evaluated at the typical scale in the elastic scattering cross section  $_{\rm el}(i)$  and the gluon mean free path  $_{\rm g}(i) = 1 = _{\rm el}(i)$  (i). At the radiation vertex,  $_{\rm s}(k^2)$  is also sensitive to the increase of the tem perature or density of the medium, / T<sup>3</sup>, with the increase of dN  $^{\rm g}$ =dy at a xed transverse area  $A_2$ . The e ects described here lead to sub-linear dependence of the energy loss on dN  $^{\rm g}$ =dy. For the LHC example, given in Fig. 2, this can be a 50% correction for large E  $_{\rm jet}$  and even more signi cant at low  $E_{\rm jet}$  when com – pared to Eq. (3). Conversely, at low parton densities in peripheral collisions the energy loss will be larger than naively expected.

A nother in portant point, seen in the right panel of F ig. 2, is that except for very low jet energies the mean gluon num berhN<sub>g</sub>i is not sm all (1) and the probability of not radiating gluons,  $P_0 = \exp(hN_gi)$ , is never large. Full results for P () were shown in  $\S$ , 13]. We nd that the probability density does not approximate a ()+ (1 a) (1), a < 1. The latter ansatz yields  $\mathbb{R}_A$  ( $p_T$ ) = a independent on the collision energy or  $p_T$ . Instead, P () is much more uniform ly distributed in the interval [0;1] and our calculations retain sensitivity to the local slope and the parton species contribution to the di erential inclusive hadron production cross section, see Eq. (8).

We nally note that multi-gluon uctuations, given by Eq. (15), reduce the jet quenching e ect relative to the application of the mean h E = E i shown in Fig. 2 [13]. This can be seen by comparing the  $_{\rm e}$ 0:2 in central Au+Au reactions, obtained from Eq. (8), to the fractional energy loss for 10 G eV quark jets, e < h = E i. To investigate the scaling of energy loss with N  $_{\rm part}$  we select quark jets of E <sub>jet</sub> = 10;20 and 30 G eV at m idrapidity at RHIC and N  $_{part}$  = 9;21;55;103;167 and 328. These cover fractional energy losses 0 < h = E i < 0.4with num erical results shown in Fig. 3. Power law ts, also plotted, give exponents n = 0.60 0.63 that are not very di erent from the naive n = 2=3 expectation from Eq. (6) that was used in Fig. 1. We conclude that the deviation between the calculated energy loss with kinem atic constraints and running strong coupling constants and its asymptotic xed  $_{\rm s}$  analytic behavior is smaller when the variation of the energy loss is associated with a change in the system size rather than a large change in

the density of the medium alone.

# IV. NUCLEAR EFFECTS ON INCLUSIVE HADRON PRODUCTION

The lowest order perturbative QCD cross section for single inclusive hadrons in nucleon-nucleon (NN) reactions, including non-vanishing transversem om entum  $k_{a,b}$  distributions of the incom ing partons, is given by

Here  $z_c = p_T = p_{T_c}$ ,  $x_{a;b} = p_{a;b}^+ = P_{a;b}^+$ . In our notation  $_{a;b=N} (x_b; _f)$  are the parton distribution functions (PDFs),  $D_{h=c}(z_c; _f)$  are the fragmentation functions (FFs) and we have chosen the factorization/fragmentation, and renormalization scales  $_f = _r = p_{T_c}$ . The distribution of non-zero transverse momenta of the incoming partons is parametrized as follows

The physical requirem ent for hard partonic scattering is ensured by  $k_{a,b} < x_{a,b}$  s and K = 1.5 is a phenom enological K -factor at R H IC. For further details see [6, 8]. C om parison to the P H E N IX measurem ent of <sup>0</sup> production in  $\overline{s} = 200 \text{ GeV } p+p$  collisions at R H IC is shown in the insert of Fig. 4.

Nuclear e ects can be incorporated in the pQCD formalism, Eq. (17), and fall in two categories: medium induced kinematic modi cations to the perturbative formulas and possibly universal modi cations to the PDFs

and FFs. An example of the latter are param eterizations of nuclear shadowing  $S_{q;g=A}$  (x; f) [14] included in this calculation via

In future work we will combine dynamical calculations of coherent nuclear enhanced power corrections with other elastic and inelastic elects in nuclear matter [4]. Transverse momentum broadening of the incoming partons, leads to enhancement of the dilerential particle distributions at  $p_T$  few GeV §] and can be accounted for in Eqs. (17), (18) as follows:

Here  $hk_{a,b}^2 i_{m ed} = (2 \ ^2L_{a,b} = \ _{a,b})$  and the typicalm on entum transfers squared  $^2$ , mean free paths  $_{a,b}$  and parton propagation lengths  $L_{a,b}$  refer to cold nuclear matter [5, 6].

In the QGP, nal state energy loss is the dominant e ect that alters the single and double inclusive hadron production cross sections [5, 6]. Application to the attenuation of leading hadrons as a kinem atic modi cation of the momentum fraction z in the FFsD  $_{h=c}$  (z) is considered standard [6, 8, 9]. The redistribution of the lost energy in soft and moderate  $p_T$  hadrons was only recently derived in the pQCD approach, rst for back-to-back two particle correlations [11]. The established dram atic transition from the high  $p_T$  factor of four suppression

 $(R_{\rm A\,A}~0.25)$  to the low  $p_{\rm T}$  factor of two enhancement  $(R_{\rm A\,A}~2)$  m akes it in perative to study thise ect for single inclusive particle production. One possibility is that the fraction of the hadrons from the brem sstrahlung gluons is negligible or sm allover the full accessible  $p_{\rm T}$  range. At the other extreme, a very large fraction m ay compromise the current jet quenching phenomenology, leading to  $R_{\rm A\,A}~1$  at moderate transverse momenta even in dense matter.

W ith this motivation, we rst give results for the modi cation of inclusive hadron production from nal state radiative energy loss. It can be represented as:

Here P ( ) is calculated from Eqs. (10), (15) and dN  $_{\rm g}$  =d is the distribution of the average gluons versus ~=~! =E so that

It is easy to verify the momentum sum rule for all hadronic fragments from the attenuated jet and the radiative gluons. W ith appropriate changes of variables

Figure (4) shows the invariant  $^{0}$  multiplicity in central Au+Au and Cu+Cu reactions. Data is from PHENIX [7]. At high  $p_{\rm T}$ , comparisons been the jet quenching theory and the experim entalm easurem ent can (and should) also be made for the di erential cross sections. At low  $p_{\rm T}$ , a deviation is present due to the xed order baseline pQCD calculation and QGP e ects are more accurately studied via  $R_{\rm AA}$  ( $p_{\rm T}$ ).

# V. QUENCHING OF INCLUSIVE PIONSAT RHIC AND THE LHC

Having evaluated the energy loss of quark and gluon jets in the QGP media speci ed in Table II, we calculate the quenched pion spectra using Eqs. (17), (19), (20) and (21). Figure 5 shows  $R_{AA}$  ( $p_T$ ) for central, sem i-central and peripheral collisions. The predictions

in Cu+Cu reactions are for a constant suppression factor, as in Au+Au, at high  $p_T$ . Prelim inary PHENIX data, rst compared to this theory in Ref. [], are also

included. It should be noted that even in peripheral reactions there can be noticeable particle attenuation. This is larger than the analytic estimates due to sub-leading e ects of the medium density on the parton energy loss, discussed in the previous Section, see Fig. 5. Whether such e ects are observable or compensated by the nonuniform QGP density in the transverse plane is subject to experimental veri cation. Finally, we make the im portant observation that for similar densities and system sizes, for example dN  $^{g}$ =dy = 410 in mid-centralAu+Au and dN  $^{g}$ =dy = 370 in centralCu+Cu, the magnitude of the predicted pion suppression is similar.

Pb+Pb collisions at the LHC represent the future energy frontier of QGP studies in heavy ion reactions. We have explored the sensitivity of  $R_{AA}$  ( $p_T$ ) to the parton rapidity density in central nuclear reactions with dN <sup>g</sup>=dy ' 2000;3000 and 4000. In [9] a seven-fold increase of the medium density in going form RHIC to the LHC was assumed. In this work we adhere to a more modest two-to four-fold increase of the softhadron rapidity density and emphasize that future measurements of jet quenching must be correlated to dN <sup>g</sup>=dy ' dN <sup>h</sup>=dy (3=2)dN <sup>ch</sup>=dy [6, 8, 12] to verify the consistency of the phenom enological results.

From Figs. 5, 6 and 7 we conclude that at low and m oderate  $p_T$ , jet suppression at the LHC is larger than at RH IC. However, at high  $p_T > 30 - 50$  GeV this ordering is reversed. The physics reason for our result is that the fractional energy loss h E = E i of 100 GeV quark and gluon jets at the LHC is not very di erent from that of 25 GeV jets at RH IC, see Fig. 2. In addition, the power law dependence of the hadronic and the underlying partonic spectrum  $n_{_{\rm C}}(y;p_{T_{\rm C}};r)$  s) changes (decreases) from r = 200 GeV to r = 5.5 TeV. This is shown in the insert of Fig. 6 and a ects the magnitude of calculated nuclear suppression, Eq. (8). LHC will soon provide an extended  $p_T$  range to test the correlation of  $R_{\rm AA}$  ( $p_T$ ) with the sti ness of the di erential particle spectra.

To assess the importance of the gluon feedback term in Eq. (21), we extend, in Fig.7, the calculation of  $R_{\rm AA}$  ( $p_{\rm T}$ ) for centralA u+ Au and Pb+ Pb collisions to low and moderate transversem on enta. At RH IC the redistribution of the lost energy leads to small, 25%, modi cation of the neutral pion cross section in the  $p_{\rm T}$  1 2 GeV range and modest improvement in the theoretical description of that data. In contrast, at the LHC the fragmentation of medium-induced gluons is a much more signi – cant 100% correction to the low and moderate  $p_{\rm T}$   $^0$  production rate.

The need for the more consistent treatment of jet energy loss, Eq. (21), is also illustrated by comparing  $R_{AA}$  ( $p_T$ ) in Fig. 7 to the participant scaling ratio: (N <sub>part</sub>=2)=N <sub>col</sub> [15]. At high  $p_T$  there is no lower lim it on the quenching of jets. At low  $p_T$  the total available energy of the collision, (N<sub>part</sub>=2)<sup>T</sup> s, suggests participant scaling of bulk particle production con im ed by hydrodynam ic calculations [16]. Previous estimates of leading particle suppression at low and moderate  $p_T$  have vio-

lated this limit [6, 9]. Fig. 7 shows that the gluon feedback can ensure numerically  $R_{AA}$  (p<sub>T</sub>) ( $N_{part}=2$ )= $N_{col}$  at m id-rapidity at the LHC for the densities considered here and is important everywhere in the region  $p_T$  15 GeV.

## VI. CONCLUSIONS

In this Letter we presented predictions for the nuclearmodi cation of inclusive neutral pion production in Au+Au and Cu+Cu collisions at  $\overline{s} = 200 \text{ GeV}$  versus

centrality and transverse m om entum . Pb+Pb reactions at s = 5.5 TeV at the LHC were also discussed and our calculations at mid-rapidity accounted for Cronin multiple scattering [5], nuclear shadowing [14] and nal state radiative energy loss in the quark-gluon plasm a [10]. E lastic energy loss was not considered here, since its effects are still under debate [17] relative to the attenuation of jets via gluon brem sstrahlung. W e com pared our num erical results to a simpli ed analytic model for centrality dependent jet quenching [6] and show ed that there are non-negligible corrections in the evaluation and im plem entation of radiative energy loss related to the tem perature or dependence of the strong coupling constant. W hile the dependence of the observable hadron suppression on dN <sup>g</sup>=dy was shown to be sub-linear, this calculation retains sensitivity to both the properties of the medium and the underlying perturbative baseline cross sections.

At low and moderate transverse momenta we derived the contribution to single inclusive pion production from the fragm entation of medium -induced gluons. At RHIC we found this e ect to be a modest, 25%, correction. Our result should be contrasted with the case of back-toback di-hadron correlations where the redistribution of the lost energy controls the Q G P -induced transition from suppression to enhancem ent of large angle inclusive two particle production [11]. At the LHC, how ever, even in inclusive one pion calculations, gluon feedback is shown 15 GeV cross section in central Pb+Pb to alter the  $p_T$ reactions by as much as a factor of two. In summary, results reported in this Letter not only provide a more consistent theoretical fram ework to treat the e ects of medium-induced gluon bremsstrahlung but also rectify the over-quenching of jets at low  $p_T$  in the lim it of large fractional energy loss [6, 9].
