Correlation between Leptonic CP V iolation and - Symmetry B reaking

Considering the – symmetry, we discuss a direct linkage between phases of avor neutrino m asses and leptonic CP violation by determining three eigenvectors associated with M = M $^{\rm y}$ M for a complex avor neutrino m ass m atrix M in the avor basis. Since the D irac CP violation is absent in the – symmetric limit, leptonic CP violation is sensitive to the – symmetry breaking, whose e ect can be evaluated by perturbation. It is found that the D irac phase () arises from the – symmetry breaking part of M $_{\rm e}$ $_{\rm pe}$ and an additional phase () is associated with the – symmetric part of M $_{\rm e}$ $_{\rm pe}$ and an additional phase () is associated with the – symmetric part of M $_{\rm e}$ $_{\rm pe}$, where M $_{\rm ij}$ stands for an ij matrix element (i; j=e; ;). The phase is redundant and can be removed but leaves its e ect in the D irac CP violation characterized by sin (+). The perturbative results suggest the exact form ula of m ixing parameters including that of and , which turns out to be free from the e ects of the redundant phases. As a result, it is generally shown that the maxim all atm ospheric neutrino mixing necessarily accompanies either sin $_{13} = 0$ or cos(+) = 0, the latter of which indicates maximal CP violation, where $_{13}$ is the $_{\rm e}^-$ mixing angle.

I. IN TRODUCTION

P roperties of neutrinos have been extensively studied by various experiments [1, 2, 3, 4] since the historical conremation of the atm ospheric neutrino oscillations by the Super-K am iokande collaboration [5]. For our understanding of hidden properties of the neutrinos it is physically signicant to observe leptonic CP violation in future neutrino experiments [6] since there is no reason that prevents the appearance of CP violation in the lepton sector. Theoretically, leptonic CP violation is sensitive to phases [7] of the PM NS (Pontecorvo-MakiNakagawa-Sakata) unitary matrix $U_{PM NS}$ that converts the avor neutrinos $_{e;}$; into the massive neutrinos $_{1;2;3}$: $_{f} = (U_{PM NS})_{fi i}$ (f=e; ; ; i=1,2,3) β], where a neutrino mass matrix M in the avor basis is transformed into $U_{PM NS}^{T}$ M $U_{PM NS} = \text{diag.}(m_1;m_2;m_3)$. CP e ects in neutrino reactions are known to be characterized by the Jarkskog invariant J_{CP} proportional to sin $_{13}$ sin [9], where $_{13}$ and , respectively, stand for the $_{e}$ - mixing angle and the CP violating D irac phase. How ever, these two quantities are not experimentally well known and the current data show the upper bound on $_{13}$ [10]:

and no indication of the presence of . For a given value of $_{13}$, CP violation becomes maximal if = =2 (modulo). It is of great importance to accumulate theoretical know ledge about $_{13}$ and . We expect that it also provides useful information on the choice of CP phases in the leptogenesis [11] to create the baryon number in the Universe [12].

The leptonic CP violation is usually parameterized by phases in $U_{PM NS}$ given by the particle data group [13], which we call $U_{PM NS}^{PDG}$, as $U_{PM NS}^{PDG}$ () = U (;0;0)K (1; 2; 3):

for $c_{ij} = \cos_{ij}$ and $s_{ij} = \sin_{ij}$ (i; j=1,2,3), where $_{ij}$ stand for three neutrino m ixing angles. The M a prana CP violation phases are determined by two combinations of $_{1;2;3}$ such as $_{i}$ $_{3}$ (i=1,2,3). Since the know ledge on avor neutrino m asses M contains all information of new physics of neutrinos, to speak about CP violations, it is useful to nd direct linkage between phases in M and CP violating D irac and M a prana phases. However, phases in M are not uniquely determined because of the freedom of the rede nition of phases of the avor neutrinos w ithout a ecting physical consequences and thus contain redundant phases. This freedom dictates other versions of $U_{PM NS}$ than Eq.(2). The true e ect of the D irac CP violation can only be discussed after obtaining $U_{PM NS}$ and is described in terms ($U_{PM NS}$) fi through J_{CP} , which is free from the e ect of the rede nition. There is a useful form ula without referring to $U_{PM NS}$ to determ ine the Jarkskog invariant in term sofM V M (M), whose m atrix element is denoted by M $_{ij}$ (i; j= e; ;) [14]: $J_{CP} = \text{Im} (M_{e} M_{e}) = (m_{12}^{2} m_{23}^{2} m_{31}^{2})$, where $m_{2j}^{2} = m_{1}^{2} m_{2j}^{2} (m_{2j}^{2} = m_{1}^{2} m_{2j}^{2} m_{2j}^{2} m_{2j}^{2} = m_{1}^{2} m_{2j}^{2} m_{2j}^{2} m_{2j}^{2} = m_{1}^{2} m_{2j}^{2} m_{2j}^{2} m_{2j}^{2} m_{2j}^{2} = m_{1}^{2} m_{2j}^{2} m_{2j}$

We have advocated the use of the – symmetry [5, 16, 17, 18, 19] to evaluate e ects of leptonic CP violation [20, 21, 22, 23]. It is based on the observation that the – symmetric texture gives sin $_{13} = 0$ (or sin $_{12} = 0$ [24]) giving no Dirac CP violation.¹ Therefore, leptonic CP violation is sensitive to how the – symmetry is broken. For example, if the – symmetry breaking part of M is restricted to be pure in aginary and if its symmetric part is real, the Dirac CP violation becomes maximal for given mixing angles and the atm ospheric neutrino mixing is also becomes maximal [20, 21, 22, 25]. This texture shows M_e = M_e (= 1) and M = M , where M_{ij} (i; j=e; ;) stands for the i-j matrix element of M 2 . It can be further shown that this condition is extended to a more general one: $M_{e} = M_{e}$ jand $M_{j} = M_{j}$ j[22].³

It is known that the – symmetry required for neutrinos is badly broken by charged leptons. Since a pair of the charged lepton and neutrino forms an SU $(2)_{\rm L}$ -doublet, discussions based on the – symmetry required for neutrinos m ay be useless. However, it should be noted that to talk about the experimental results of neutrino mixings is alm ost equivalent to talk about theoretical results based on the approximate – symmetry. This is based on the good guiding principle to understand sources of small quantities in physics, which is the naturalness [26]. The naturalness dictates that the smallness of a certain physical quantity (such as \sin^2_{13} 1 and/or m² = jm²_{atm} j 1) in plies a certain protection symmetry (such as the – symmetry). Furthermore, the similarity between charged leptons and neutrinos loses direct linkage because charged leptons are D irac particles but neutrinos can be M a jorana particles. This signi cant di erence yields su cient power to construct various models based on the – symmetry [17, 18, 27, 28].

In this article, along this line of thought, we discuss properties of the leptonic CP violation without entailing details of textures and exam ine constraints on various avor neutrino masses to be compatible with the current neutrino oscillation data. We focus on describing the CP violating D irac phase as well as the mixing angles in terms of avor neutrino masses as general as possible. As a result, $U_{PM NS}$ is completely expressed in terms of avor neutrino masses and we understand which avor neutrino masses mainly control which part of the leptonic CP violation [29]. To construct $U_{PM NS}$, we must not three eigenvectors associated with M [24, 29, 30]. We rst determ ine eigenvectors for the – symmetric part of M. In the symmetric limit, the eigenvectors are found to generally contain a redundant phase to be denoted by in the e^- mixing, which serves as an additional CP violating D irac phase after the – symmetry breaking e ects are included. Next, to see the – symmetry breaking e ects, we employ the usual perturbative analysis of M, where the – symmetry breaking part of M is treated as a perturbation. This perturbation yields another phase to be denoted by associated with the – mixing to $11U_{PM NS}$ in a consistent m anner. However, this phase is completely removed without a ecting CP violation. On the other hand, to remove the phase a ects CP violation and results in + as a physical CP violating D irac phase. We keep in the PM NS unitary m atrix to trace its e ect. Considering the perturbative results, we are led to general form ula to express these mixings, and CP phases in terms of M itself.

Our form ula are shown to indeed reproduce the perturbative results and to consistently take care of the e ect of the redundant phases and . It turns out that and are determined to be

where $M_e^0 = e^i M_e$, and $M_e^0 = e^i M_e$ are the rede ned m asses, which mean that the e ect of is absorbed by the rede nition of masses. If is removed, M_e^0 , are shifted to $M_e^0 = e^{i(-)}M_e$, and $M_e^0 = e^{i(+)}M_e$, which give + in place of in Eq.3) as expected. The atm ospheric neutrino mixing angle is also determined and given by

where = Re(M^{0}) = Re(M^{0}), N = Re² M^{0} + (M M)²=4, and M⁰ = e²ⁱ M. The observed mass di erence squared m² is given by m² = m²₂ m²₁ (> 0). For textures with sin ₁₃ 6 0, the maximal atmospheric neutrino mixing is indeed provided by the maximal CP violating Dirac phase giving cos(+) = 0 as long as M = M is satistical. It should be noted that the combination of M_e M M_e (= M_e M M_e) appearing in J_{CP} becomes independent of the rede nition of the avor neutrinos as expected because of M⁰_e M⁰ M⁰_e = M_e M M_e (for M_e⁰ = eⁱ⁽⁻⁾ M_e, M⁰_e⁰ = eⁱ⁽⁺⁾ M_e and M⁰ = e²ⁱ M.

This paper is organized as follows. In the next section Sec.II, we discuss physical consequence of the - symmetric part of M. The new phase is generally associated with M_{e ;e}. In Sec.III, the discussions are further extended to include textures without the - symmetry. We is calculate U_{PMNS} composed of three eigenvectors by the perturbative method, which treats a - symmetry breaking part of M as a perturbation. We next derive a set of form ula suggested by the results of the perturbation to calculate them ixing angles and phases, which can be applicable to any textures without the approximate - symmetry. In Sec.IV, properties of neutrino oscillations are discussed by using our results given by the form ula. To see the power of our form ula, a simple neutrino mass matrix is analyzed. The nal section is devoted to summary and discussions.

Let us begin with de ning a neutrino mass matrix M parameterized by⁴

The - sym metry can be defined by the invariance of the avor neutrino mass terms in the lagrangian under the interchange of \circ or \circ . As a result, we obtain $M_e = M_e$ and M = M for \circ or $M_e = M_e$ and M = M for \circ or $M_e = M_e$ and M = M for \circ or $M_e = M_e$ for the - sym metric part under the interchange of \circ . If M has CP phases, we have to use the H erm it in matrix M to not eigenvectors of M, which can be divided into the - sym metric part M_{sym} and the - sym metry breaking part M_b as shown in the Appendix A.

The - symmetric part M sym in Eq.(A3) is analyzed in this section. We introduce a phase parameter to express

The corresponding eigenvectors are calculated to be

respectively, for , $_{+}$ and , where N = $\frac{q}{2 + X^2}$. There is an ambiguity to have an overall phase in each eigenvector. The orthogonality condition is obviously satisfied because of X $_{+}$ X = 2.

Considering the phase in Eq.(11), we parameterize the PMNS unitary matrix to be: $U_{PMNS}^{(0)}$ (;) = U (;;0)K (1;2;3): with

It should be noted that the D irac CP violation is characterized by sin $_{13} \sin(+)$ instead of sin $_{13} \sin$ as indicated by J_{CP} . It is obvious that M $_{sym}$ is equivalent to

corresponding to Eq.(A 7) with $_{+}$ = and = 0. Since M $_{\text{sym}}^{0}$ yields U $_{\text{PM NS}}^{\text{PDG}}$ with = 0, the phase disappears and no CP violation exists. However, if there are - sym metry breaking e ects, CP violation is active. It is anticipated that the e ect of remains in Dirac CP violation, where in U $_{\text{PM NS}}^{\text{PDG}}$ is replaced by + at U $_{\text{PM NS}}^{(0)}$. To trace the e ect of explicitly, we keep in the PMNS unitary matrix hereafter.

As have been pointed out in Ref.[24], there are two categories that characterize the e ect from the - sym m etry. In term softhe mixing angles, the - sym m etry requires either sin $_{13} = 0$ or sin $_{12} = 0$. In term s of the eigenvalues of Eq.(9), two categories depend on the order of j j and j j namely, on how these three eigenvalues are assigned to $m_{1;2;3}$. For $m_1 = m_2 = m_1$, and $m_3 = m_3$, if M gives j j < j + j < j j as the norm alm ass ordering or j j < j + j as the inverted m ass ordering, we not $U_{PM NS}$ described by

The Dirac CP violation is absent in both cases because of sin $_{13} \sin(+) = 0$ satised by either sin $_{13} = 0$ or + = 0.

We have more convenient formula for masses and mixing angles as shown in the Appendix B with = 0. These formula yield the same results given by the eigenvectors and eigenvalues. Applying M _{sym} to these relations, we not that

III. - SYMMETRY BREAKING AND CP PHASES

The - symmetry breaking M_b in Eq.(A3) is analyzed in this section. We choose conventional perturbative analysis with M_b treated as a perturbation to nd eigenvectors and eigenvalues associated with M. An additional phase is induced by E in M_b as a main source, which is to be removed by the rede nition of ; . The inclusion of M_b creates either sin $_{13} \notin 0$ or sin $_{12} \notin 0$. However, the perturbative treatment only allows to induce tiny magnitude of sin $_{12,13}$. For sin $_{12}$ 0, we cannot give the consistent result with the observation, which requires that $\sin^2 2_{12} = 0$ (1), and physical consequence of textures with $\sin_{12} = 0$ in the - symmetric limit will be discussed in a separate article.

A. Perturbative Results

The starting eigenvectors and eigenvalues are provided by

To give complete discussions on the leptonic CP violation, we have to consider the M a jorana CP violation. As in Eq.(61), the redundant phase from ains in the M a jorana phase because M a jorana masses directly receive the elect of phases in M. Since the present method is based on the Herm ite matrix M y M, the CP violating M a jorana phases disappear in M y M. To obtain elects of the M a jorana phases, the simplest way is to perform the transform attion U_{PMNS}^{T} M U_{PMNS} M U_{PMNS} = diag.(m₁;m₂;m₃), which is expected to lead to the similar result to the one shown in the Appendix of Ref.[21]. We will discuss this extension of the present method in future publication.
