## D W ave H eavy M esons

We rst extract the binding energy and decay constants of the D wave heavy m eson doublets (1;2) and (2;3) with QCD sum rule in the leading order of heavy quark elective theory. Then we study their pionic (;K;) couplings using the light cone sum rule, from which the parameter can also be extracted. We then calculate the pionic decay widths of the strange/non-strange D wave heavy D =B m esons and discuss the possible candidates for the D wave charm -strange m esons. Further experimental information, such as the ratio between D<sub>s</sub> and DK m odes, will be very useful to distinguish various assignments for D<sub>sJ</sub> (2860;2715).

# I. IN TRODUCTION

Recently BarBar reported two new  $D_s$  states,  $D_{sJ}$  (2860) and  $D_{sJ}$  (2690) in the DK channel. Their widths are = 48 7 10 MeV and = 112 7 36 MeV respectively [1]. For  $D_{sJ}$  (2860) the signi cance of signalis5 in the D<sup>0</sup>K<sup>+</sup> channel and 2.8 in the D<sup>+</sup>K<sup>0</sup><sub>s</sub> channel. Belle observed another state  $D_{sJ}$  (2715) with  $J^P = 1$  in B<sup>+</sup> ! D<sup>0</sup>D<sub>sJ</sub> ! D<sup>0</sup>D<sup>0</sup>K<sup>+</sup> [2]. Its width is = 115 20 MeV.NoD K or D<sub>s</sub> mode has been detected for all of them.

The  $J^P$  of  $D_{sJ}$  (2860) and  $D_{sJ}$  (2690) can be  $0^+$ ;1;2<sup>+</sup>;3; since they decay to two psedusca m esons.  $D_{sJ}$  (2860) was proposed as the rst radialexcitation of  $D_{sJ}$  (2317) based on a coupled channelm odel [3] or an improved potentialm odel [4]. Colangeb et al considered  $D_{sJ}$  (2860) as the D wave 3 state [5]. The m ass of  $D_{sJ}$  (2715) or  $D_{sJ}$  (2690) is consistent with the potentialm odel prediction of the cs radially excited  $2^3S_1$  state [4, 6]. Based on chiral symm etry consideration, a D wave 1 state with m ass M = 2720 MeV is also predicted if the  $D_{sJ}$  (2536) is taken as the P wave 1<sup>+</sup> state [7]. The strong decay widths for these states are discussed using the  ${}^{3}P_{0}$  m odel in [8].

The heavy quark e ective theory (HQET) provides a system atic expansion in terms of 1=m o for hadrons containing a single heavy quark, where  $m_0$  is the heavy quark mass [9]. In HQET the heavy mesons can be grouped into doublets with de nite j, since the angular monum ent of light components j. is a good quantum number in the m<sub>Q</sub> ! 1 lim it. They are  $\frac{1}{2}$  doublet (0 ;1 ) with orbital angular monum ent L = 0,  $\frac{1}{2}^+$ doublet  $(0^+;1^+)$  and  $\frac{3}{2}^+$  doublet  $(1^+;2^+)$  with L = 1. For L = 2 there are (1 ; 2) and (2 ; 3) doublets with  $j_{1}^{p} = \frac{3}{2}$  and  $\frac{5}{2}$  respectively. The states with the same  $J^P$ , such as the two 1 and two 1<sup>+</sup> states, can be distinguished in the m $_{\circ}$ ! 1 lim it, which is one of the advantage of working in HQET. The D wave heavy m esons  $(B_1; B_2), (B_2; B_3)$  were considered in the quark model [10]. The sem ileptonic decay of B m eson to the D wave doublets was calculated using three point QCD sum rule

[11]. The decay property of the heavy m esons till L = 2 was calculated using the  ${}^{3}P_{0}$  m odel in [12].

Light cone QCD sum rule (LCQSR) has proven very useful in extracting the hadronic form factors and coupling constants in the past decade [13]. Unlike the traditional SVZ sum rule [14], it was based on the twist expansion on the light cone. The strong couplings and sem ileptonic decay form factors of the low lying heavy m esons have been calculated using this method both in fullQCD and in HQET [15].

In this paper we rst extract the m ass param eters and decay constants of D wave doublets in section II. Then we study the strong couplings of the D wave heavy doublets with light pseduscalarm esons , K and in section III. We work in the fram ework of LCQ SR in the leading order of HQET. We present our num erical analysis in section IV. In section V we calculate the strong decay widths to light hadrons and discuss the possible D wave dam estimates are sum marized in section V I.

#### II. TW O-POINT QCD SUM RULES

The proper interpolating currents  $J_{j;P}^{1}$ ; <sup>j</sup> for the states with the quantum number j, P, j, in HQET were given in [16], with j the total spin of the heavy m eson, P the parity and j, the angular momentum of light com - ponents. In the m<sub>Q</sub> ! 1 lim it, the currents satisfy the following conditions

where 1 j is the polarization tensor for the spin j state. v denotes the velocity of the heavy quark. The transverse metric tensor  $g_t = g v v \cdot S$  denotes symmetrizing the indices and subtracting the trace terms

separately in the sets  $\begin{pmatrix} 1 & j \end{pmatrix}$  and  $\begin{pmatrix} 1 & j \end{pmatrix}$ .  $f_{P;j}$ , is a constant.  $_{P;j}$ , is a function of x. Both of them depend only on P and j.

where  $h_v$  is the heavy quark eld in HQET and t = v #. The de nitions of T ' ' ' and T ' ' ' are

given in Appendix A.

We rst study the two point sum rules for the (1;2) and (2;3) doublets. We consider the following correlation functions:

At the quark-gluon level it can be calculated with the leading order lagrangian in HQET. Invoking quarkhadron duality and making the Borel transform ation, we get the following sum rules from eqs. (10) and (11)

Here  $m_0^2$  hqqi = hqg G qi. Only terms of the lowest order in  $_s$  and operators with dimension less than six have been included. For the  $\frac{5}{2}$  doublet there is no mixing condensate due to the higher derivation.

We use the following values for the QCD parameters: hqqi =  $(0.24 \text{ GeV})^3$ , h  $_s\text{GGi} = 0.038 \text{ GeV}^4$ , m  $_0^2 = 0.8 \text{ GeV}^2$ .

R equiring that the high-order power corrections is less than 30% of the perturbation term without the cuto  $!_{\rm c}$  and the contribution of the pole term is larger than 35% of the continuum contribution given by the perturbation integral in the region  $!>!_{\rm c}$ , we arrive at the stability region of the sum rules  $!_{\rm c}$  = 3.2 3:6 GeV, T = 0.8 1:0 GeV.

The errors are due to the variation of T and the uncertainty in  $!_c$ . In Fig. 1 and 2, we show the variations of m asses with T for di erent  $!_c$ .

The masses of D wave mesons in the quark model are around 2.8 GeV for D meson and 6 GeV for B meson [10]. 1=m  $_{\rm Q}$  correction may be quite in portant for D wave

# III. SUM RULES FOR DECAY AMPLITUDES

Now let us consider the strong couplings of D wave doublets  $\frac{3}{2}$  and  $\frac{5}{2}$  with light hadrons. For the light quark being a u (or d) quark, the D wave heavy mesons decay to pion, while for the light quark being a strange quark, it can decay either to BK or B<sub>s</sub>. In the following

we will denote the light hadron as pion and discuss all three cases. The strong decay amplitudes for D wave 1 and 3 states to ground doublet (0 ;1 ) are

where , , and " are polarizations of the D wave 3,1 states and ground 1 state respectively.  $I = 1; \frac{1}{2}$ for charged and neutral pion m esons respectively, while for the K and m esons it equals one.  $g(B_1^{\circ}B)$  etc are the coupling constants in HQET and are related to those in fullQCD by

The pion (or K / ) distribution am plitudes are de ned as the matrix elements of nonlocal operators between the vacuum and pion state. Up to twist four they are [20, 21]:

The expressions for the light cone wave functions ' (u) etc are presented in Appendix B together with the relevant parameters for , K and .

Expressing eq. (29) with the light cone wave functions, we get the expression for the correlator function in the quark-gluon level

where  $u_0 = \frac{T_1}{T_1 + T_2}$ ,  $T = \frac{T_1 T_2}{T_1 + T_2}$ .  $T_1$ ,  $T_2$  are the Borel parameters, and  $f_n(x) = 1$  e<sup>x</sup>  $P^n \frac{x^k}{k!}$ . The factor  $f_n$  is  $R_1^{k=0}$  used to subtract the integral  $\frac{1}{2} s^n e^{-\frac{s}{2}} ds$  as a contribution of the continuum. The sum rules we have obtained from the correlators (20)–(28) are collected in Appendix C together with the de nitions of  $G_1$  etc.

### IV. NUMERICAL RESULTS

For the ground states and P wave heavy m esons, we will use [17, 18]:

The mass parameters and decay constants for the D wave doublets have been obtained in section II from the two

point sum rule:

We choose to work at the symmetric point  $T_1 = T_2 = 2T$ , i.e.,  $u_0 = 1=2$  as traditionally done in literature [15]. The working region for T can be obtained by requiring that the higher twist contribution is less than 30% and the continuum contribution is less than 40% of the whole sum rule, we then get !  $_c = 3.2$  3:6 GeV and the working region 2:0 < T < 2:5 GeV for eqs. (C 2), (C 6) and (C 12) in Appendix C and 1.2 < T < 2:0 GeV for others. The working regions for the rst three sum rules are higher than that for the others because there are zero points between 1 and 2 GeV for them and stability develops only for T above 2 GeV. From eq. (32) the coupling reads

W e use the central values for the mass parameters and the error is due to the variation of T and the uncertainty of !  $_{\rm c}$ . The central value corresponds to T = 1:6 G eV and !  $_{\rm c}$  = 3:4 G eV. There is cancelation between the twist 2 and twist 3 contributions in the sum rule.

For D wave heavy mesons with a strange quark, the couplings can be obtained by the same way. Notice that in the case, f should be replaced by  $\frac{p^2}{6}$  f due to the quark components of meson, where f = 0.16 GeV is the decay constant of meson. From eq. (32) we can get the couplings between the ground state doublet and D wave doublet with a strange quark,

The couplings between the  $\frac{3}{2}$  and  $\frac{5}{2}$  doublets and other doublets are collected in Table I. We can see that the SU (3)<sub>f</sub> breaking e ect is not very big here.

# V. STRONG DECAY W IDTHSFOR D WAVE HEAVY MESONS

Having calculated the coupling constants, one can obtain the pionic decay widths of D wave heavy m esons. The widths for D wave states decaying to 0 , 1 ,  $1^{\scriptscriptstyle +}$  states are

### A. Nonstrange case

W e take 2.8 G eV and 6.2 G eV for the m assess of D wave charm ed and bottom ed m esons respectively. M  $_{\rm D}$  = 1:87 G eV, M  $_{\rm D}$  = 2:01 G eV, M  $_{\rm D_1}$  = 2:42 G eV, M  $_{\rm B}$  = 5:28 G eV, M  $_{\rm B}$  = 5:33 G eV [19] and M  $_{\rm B_1}$  = 5:75 G eV from quark m odel prediction [10]. A fter summing over the charged and neutral m odes, we get the results listed in Table II.

#### B. Strange case

We use  $M_{D_s} = 1.97 \text{ GeV}$ ,  $M_{D_s} = 2.11 \text{ GeV}$ ,  $M_{B_s} = 5.37 \text{ GeV}$ ,  $M_{B_s} = 5.41 \text{ GeV}$  [19]. Then for the charm - strange sector we have Table III. We do not consider the D K mode and three-body modes in the present work.

For the 2 , 3 states with  $j_{\nu} = \frac{5}{2}$ , we define that the widths are quite small and the branching fraction is perhaps more useful. In the charm -strange sector the ratio of widths (central values) for DK, DK, DK, Ds and D modes is 1:0.4:0.1:0.02.

# VI. CONCLUSION

In this work we extract the mass and decay constants using the traditional two point sum rule and calculate the strong couplings of D wave heavy meson doublets with light hadrons , K and using LCQSR in the leading order of HQET.We also extract them as sparameter from LCQSR for the coupling within the same D wave doublet. The extracted mass parameters from two approaches are consistent with each other.We then calculate the widths of D wave heavy mesons decaying to light hadrons.

We have not considered the  $1=m_{\rm Q}$  correction and radiative corrections. Heavy quark expansion works well for B m esons where the  $1=m_{\rm b}$  correction is under control and not so large. However, the  $1=m_{\rm c}$  correction is not so sm all for the charm ed m esons. It will be desirable to consider both the  $1=m_{\rm Q}$  and radiative corrections in the future investigation.

A coording to our present calculation, the ratios such as  $\frac{(D_{sJ} (2860)! D_K)}{(D_{sJ} (2860)! D_s)}$  are useful in distinguishing various interpretations of D<sub>sJ</sub> (2860) and D<sub>sJ</sub> (2715). Treating D<sub>sJ</sub> (2860) as a D wave 1 state, we nd the above ratio is 0.4 2.2. If it is the radial excitation of D<sub>s</sub>, this ratio is 0.09 [8].

The pionic widths of D wave states are not very large. W ith a mass of 2.86 GeV, the partial decay width of the 1 D wave D<sub>s</sub> state into D K and D modes is 34 118 MeV.W ith a mass of 2.715 GeV its pionic width is 15 57 MeV. Note that D K modes may be equally important. So detection of other decay channels, such as D<sub>s</sub> and D K modes, will be very helpful in the classi cation of these new states.
