Decay Constants of P seudo-scalar M esons in Bethe-Salpeter Fram ework with Generalized Structure of Hadron-Quark Vertex

A bstract

W e employ the fram ework of Bethe-Salpeter equation under Covariant Instantaneous Ansatz to study the leptonic decays of pæudoscalar m esons. The D irac structure of hadron-quark vertex function is generalized to include various D irac covariants besides 5 from their complete set. The covariants are incorporated in accordance with a power counting rule, order by order in powers of the inverse of the m eson m ass. The decay constants are calculated with the incorporation of leading order covariants. M ost of the results are dram atically im proved.

1 Introduction

Quantum Chromodynamics (QCD) is regarded as the correct theory for strong interactions. Investigation of bound states of quarks (and/or gluons) is one of the most e ective methods to study this dynamics among these constituents. Since the task of calculating hadron structure from QCD itælf is very di cult (as can be sæn from various lattice QCD methods), one can on the other hand rely on speci c models to gain some understanding of it at low energies, and this study can most e ectively be accomplished by applying a particular fram ework to a diverse range of phenom ena. Meson decays provide an important opportunity for exploring the structure of these simplest bound states in QCD and for studying the non-perturbative (long distance) aspect of the strong interactions. Besides vector m esons (see, e.g., [1] and refs. therein), pseudo-scalar mesons have for a long time been a m a pr focus of attention to understand the inner structure of hadrons from non-perturbative QCD. A number of such studies [2, 3, 4, 5, 6, 7] dealing with decays of pseudo-scalar mesons at quark level of compositeness have been carried out recently. In this paper, we study leptonic decays of pseudoscalar m esons such as K , D , D $_{\rm S}$ and B , which proceed through the coupling of the quark-antiquark bop to the axial vector current as shown in Figure 1.

A realistic description of pseudo-scalar mesons at the quark level of compositeness would be an important element in our understanding of hadron dynamics and reaction processes at scales where QCD degrees of freedom are relevant. Such studies o er a direct probe of hadron structure and help in revealing some aspects of the underlying quark-gluon dynamics. The relativistic description for analyzing mesons as composite objects is provided by the framework of Bethe-Salpeter Equation (BSE) in this paper. We em – ploy the QCD oriented BSE under Covariant Instantaneous Ansatz (CIA) [8]. CIA is a Lorentz-covariant generalization of Instantaneous Approxim ation. For qq system, CIA formulation [8] ensures an exact interconnection between 3D and 4D forms of the BSE. The 3D form of BSE serves form aking contact with the mass spectra, whereas the 4D form provides the H qq vertex function (**q**) for the evaluation of various transition amplitudes. A BSE fram ework under Instantaneous Approxim ation form ulation sim ilar to the CIA formulation was also earlier suggested by the Bonn group [9].

We had earlier employed the framework of BSE under CIA for calculation of decay constants [8, 10] of heavy-light pseudo-scalar m esons and F for ⁰! 2 process. We also evaluated the leptonic decays of vector m esons,

such as ,!, [1] in this fram ew ork. How ever, one of the sim pli ed assum ptions in all these calculations was that the H qq vertex was restricted to have a single D irac structure (e.g., 5 for pseudo-scalar m esons, " for vector m esons, etc.). How ever, recent studies [5, 12, 13] have revealed that various m esons have m any di erent covariant structures in their wave functions whose inclusion was also found necessary to obtain quantitatively accurate observables [12] and it was further noticed that all D irac covariants do not contribute equally and only some of them are relevant for calculation of meson mass spectrum and decay constants. Such a copious Dirac structure of the BS wave function in fact was already indicated by Llewellyn Smith [14]. Hence it is necessary to introduce various D irac structures into the H qq vertex for di erent kinds of mesons. In the recent work [1], we developed a power counting rule for incorporating various D irac covariants in the structure of vertex function, order by order in powers of inverse of meson mass, and calculated the leptonic decays of equal m ass vector m esons such as ,!, , taking into account the leading order covariants since they are expected to contribute maximum to observables according to our scheme. On the line of that work, in this paper we rst discuss the power counting rule for choosing various D irac covariants from their com plete set (see, e.g., [5, 12, 13, 14]) for pseudo-scalar mesons in Section 2. In section 3 we calculate leptonic decay constants of them employing the wave function developed in section 2. We then conclude with discussions in Section 4.

2 Structure of generalized vertex function (g) for pseudo-scalar mesons in BSE under CIA

For introducing the variables and for the convenience to discuss the generalized hadron-quark vertex in BS wave function under CIA, we give the similar outline for CIA as in Ref. [1, 11]. We start with a 4D BSE for scalar qq system with an elective kernel K and 4D wave function (P;q):

Here m $_{1,2}$ are (e ective) constituent m assess of quarks. The 4-m omenta of the quark and anti-quark, $p_{1,2}$, are related to the internal 4-m omentum q and totalm omentum P of hadron of m ass M as

The CIA Ansatz on the BS kernelK in Eq. (1) is,

is observed to be orthogonal to the total 4-m om entum P (i.e., $\hat{q}P = 0$), irrespective of whether the individual quarks are on-shell or o -shell. A sim ilar form of the BS kernelwas also suggested in ref. [9]. The longitudinal component of q,

does not appear in the form K $(q;q^0)$ of the kernel. For reducing Eq. (1) to the 3D form, one can de ne a 3D wave function (q) as

Following usual steps outlined in [1, 8, 11], we get the H qq vertex function (q) under C IA for the case of scalar quarks:

where D (g) is a 3D denom inator function whose value can be easily worked out by contour integration by noting the positions of the poles in the complex

plane [1, 8, 11]. By this process, an exact interconnection between 3D wave function (\mathbf{q}) and the 4D wave function $(\mathbf{P};\mathbf{q})$ and hence that between 3D and 4D BSE is thus brought out, where the 3D form serves for making

contact with the mass spectrum of hadrons, whereas the 4D form provides the H qq vertex function (q) which satis es a 4D BSE with a natural o -shell extension over the entire 4D space (due to the positive de niteness of the quantity $q^2 = q^2 - \frac{(q - P)}{P^2}$ throughout the entire 4D space) and thus provides a fully Lorentz-covariant basis for evaluation of various transition amplitudes through various quark loop diagrams (see Figure 1).

To apply the above simplied discussions to the case of ferm ionic quarks constituting a particular m eson we proceed in the same m anner as [1]: The scalar propagators in the above equations are replaced by the proper ferm ionic propagators S_F . Then, on observing the vertex (3) now is a 4 4 matrix in the spinor space, we should incorporate its relevant D irac structures, for which we take quidance from some recent studies [5, 12, 13], as well as Liewelyn-Sm ith's classic paper [14], which have revealed that various m esons have m any di erent covariant structures in their wave functions whose inclusion was found necessary to obtain quantitatively accurate observables. It was also noticed recently [12] that all D irac covariants do not contribute equally and only som e covariants are considered to be relevant for calculation of mass spectrum and decay constants. Ref. [12] has also calculated m asses and decay constants of vector m esons for various subsets of covariants from their complete set. Towards this end, we make use of the power counting rule developed in [1] for incorporating various D irac covariants in the structure of H qq vertex function for a particular m eson, order-by-order in powers of inverse of the meson mass M , so as to system atically choose am ong various covariants from their complete set and write wave functions for various m esons.

As far as a pseudo-scalar meson is concerned, its H qq vertex function, which has a certain dimensionality of mass, can be expressed as a linear combination of four D irac covariants ${}_{i}^{P}$ (i = 0; :::; 3) [12, 13, 14], each multiplying a Lorentz scalar amplitude $F_{i}(q^{2}; q P; P^{2})$. The choice of the D irac covariants is not unique as can also be seen from the choice of covariants used in Ref. [12, 13]. For adapting this decomposition to write the structure of vertex function (q), we re-express the H qq vertex function by making the amplitudes $F_{i}(q^{2}; q P; P^{2})$ dimensionless, weighing each D irac covariant with an appropriate power of M. Thus each term in the expansion of (q) is associated with a certain power of M. In detail, we can express $_{P}$ as a polynom ial in various powers of 1=M :

Here B_i (i = 0; ...; 3) are four dimensionless and constant coe cients (which are taken to be constant on lines of [1], only to consider the leading powers of 1=M) to be determ ined. Now since we use constituent quark masses where the quark mass m is approximately half of the hadron mass M, we can use the ansatz

in the rest frame of the hadron (am ong all the pseudo-scalar mesons, pion enjoys the special status in view of its unusually smallmass (< $_{QCD}$) and its case should be considered separately. See the discussions in Section 4). Then each of the four terms in Eq. (9) receives suppression by di erent powers of 1=M. Thus we can arrange these terms as an expansion in powers of 0 ($\frac{1}{M}$). We can see in the expansion of $_{\rm P}$ that the structures associated with the coe cients B $_0$; B₁ have magnitudes 0 ($\frac{1}{M^{-0}}$) and are of leading order, while those with B₂; B₃ are 0 ($\frac{1}{M^{-1}}$) and are next-to-leading order. This na ve power counting rule suggests that the maximum contribution to the calculation of any pseudo-scalar meson observable should come from the leading order D irac structures $_5$ and i $_5$ (P) $\frac{1}{M}$ associated with the constant coe cients B₀ and B₁, respectively. As a rst application of this to the pseudo-scalar meson sector and on lines sim ilar to [1] for vector meson case, we take the form of the H qq vertex function incorporating the leading order terms in expansion (9) and ignoring 0 ($\frac{1}{M^{-1}}$) terms for the moment, i.e.,

As has been stated in [1], the restriction from charge Parity on the wave function of the eigenstate should be respected ¹.

From the above analysis of the structure of H qq vertex function in Eq.(12) we notice that, at leading order, the structure of 3D wave function (q) as well as the form of the 3D B SE are left untouched and have the same form as in our

¹To get the complete set of the D irac structure for a certain kind of mesons, the restriction by the (space) Parity have been employed; and it is easy to see that the requirements of the space Parity and the charge Parity are the same for the vertex as well as the full wave function (see also [14]).

previous works, which justi as the usage of the same form of the input kernel we used earlier. Now we brie y mention some features of the BS form ulation employed. The structure of BSE is characterized by a single elective kernel arising out of a four-ferm ion Lagrangian in the Nambu-Jonalasino [15, 16] sense. The form alism is fully consistent with Nambu-Jona-Lasino [16] picture of chiral symmetry breaking but is additionally Lorentz-invariant because of the unique properties of the quantity q^2 , which is positive de nite throughout the entire 4D space. The input kernel K $(q;q^0)$ in BSE is taken as one-gluon-exchange like as regards color $(\frac{1}{2} \sim \frac{1}{2} \sim 2)$ and spin ((1) (2)) dependence. The scalar function V $(q q^0)$ is a sum of one-gluon exchange V_{OGE} and a con ning term V_{C onf:} [1, 11, 15]. Thus

The ansatz employed for the spring constant $!_{q\bar{q}}^2$ in the above equation is [1,11,15]

Here the proportionality of $!_{q\bar{q}}^2$ on $_{\rm S}$ (Q²) is needed to provide a more direct QCD motivation to con nement. This assumption further facilitates a avour variation in $!_{q\bar{q}}^2$. And $!_0^2$ in Eq.(13) and Eq.(14) is postulated as a universal spring constant which is common to all avours.

In the expression for V (\hat{q} \hat{q}^0), as far as the integrand of con ning term $V_{C \text{ onf}}$: is concerned, the constant term $C_0 = !_0^2$ is designed to take into account the correct zero point energies, while a_0 term ($a_0 << 1$) simulates an e ect of an alm ost linear con nem ent for heavy quark sectors (large m₁;m₂), retaining the harm onic form for light quark sectors (sm allm₁;m₂) [1, 15], as is

believed to be true for QCD. Hence the term $r^2 (1 + 4a_0 m_1 m_2 M_2^2 r^2)^{\frac{1}{2}}$ in the above expression is responsible for e ecting a smooth transition from harmonic (qq) to linear (QQ) con nem ent. The values of basic input parameters of the model are $a_0 = .028$; $C_0 = .29$; $l_0 = .158$ (GeV) and = .206 eV [1,10,11,15] which have been calibrated to t the qq hadron m ass spectrum obtained by solving the 3D BSE [15].

Now comes to the problem of the 3D BS wave function. The ground state wave function (g) satisfies the 3D BSE [1] on the surface P = 0, which is appropriate for making contact with O(3)-like mass spectrum [15]. Its fuller structure (described in Ref. [15]) is reducible to that of a 3D harm onic oscillator with coe cients dependent on the hadron mass M and the total quantum number N. The ground state wave function (g) deducible from this equation thus has a G aussian structure [1, 8, 11] and is expressible as:

In the structure of (q) in Eq. (16), the parameter is the inverse range parameter which incorporates the content of BS dynamics and is dependent on the input kernel K (q; q⁰). The structure of is given in Section 3.

3 Decays constants f_P of P seudo-scalar M esons

Decay constants f_P can be evaluated through the loop diagram shown in Figure 1 which gives the coupling of the two-quark loop to the axial vector current and can be evaluated as:

In the following calculation, we only take the leading order terms in the structure of hadron-quark vertex function (\hat{q}) as in Eq. (12). S_F are the

ferm ionic propagators for the two constituent quarks of the hadron and the non-perturbative aspects enter through the (**q**). Using (P;q) from Eq.(19) and the structure of H qq vertex (**q**) from Eq.(12), evaluating trace over – matrices and multiplying both sides of Eq.(18) by $P = (M^2)$, we can express f_P as:

where according to Eq.(3) and Eq.(5), we had expressed scalar products $p_1 p_1$ P and p P as

with $m_{12} = m_1 + m_2$ and $m = m_2 - m_1$. Here we have employed unequal mass kinematics when the hadron constituents have dimensions. We see that on the right hand side of the expression for f_P , each of the expressions multiplying the constant parameters B_0 and B_1 consist of two parts, of which only the second part explicitly involves the o-shell parameter

(that is term s involving multiplying B_0 , and term s involving both and 2 multiplying B_1)). It is seen that the o -shell contribution which vanishes for $m_1 = m_2$ in case of f_P calculation in CIA [10] using only the covariant 5, now no longer vanishes for $m_1 = m_2$ in the above calculation, due to the term 4M 4 2 multiplying B_1 when another leading order covariant i 5 P = M is also incorporated in H qq vertex function. This possibly implies that the o -shellpart of f_P does not arise from unequalm ass kinem at ics alone, which is in complete contrast to the earlier CIA calculation of f_P [10] employing only 5. This serves as a clear pointer to the fact that in this BS-CIA m odel, the D irac covariants other than $_5$ m ight also be important for the study of processes involving large q^2 (o -shell), which is also suggested in [17].

Carrying out integration over d by noting the pole positions in the com - plex - plane

In the above, the quantities $D_1; E_1; E_2$ are: $D_1 = m_{12} m + M^2; E_1 = m^2 m_{12}^2 - 4M^2 m_1 m_2 - M^4; E_2 = E_1 - 3M^2 m_1 m_2$, while the integrals $I_1; I_2; I_3$ and I_4 over the o-shell parameter d are:

We have thus evaluated the general expressions for f_P (Eq.(23)) and N_P (Eq.(28)) in the fram ework of BSE under CIA, with D irac structure (i₅) (P)=M introduced in the H qq vertex function as the leading order structure as wellas 5, according to our power counting rule. We see that so far the results are independent of any m odel for (b). However, for calculating the num erical values of these decay constants one needs to know the constant coe cients B₀ and B₁ which are associated with the D irac structures 5 and (i₅) (P)=M, respectively. The relative value, $\frac{B_1}{B_0}$ is a free parameter without any further

know ledge of the meson structure in the fram ework discussed above. As a rst step, we vary this parameter to see the e ect of introducing the D irac covariant i $_5$ P=M . We see that at $\beta=B_0=:163$, $f_K=159$: SM eV, which is the experimental value of this quantity. For making comparison with results of other models and data, we use this value of the ratio $B_1=B_0$. We also vary $B_1=B_0$ in the range :14 :17 to demonstrate the dependence on this parameter. The results are given in Table I along with those of otherm odels and experimental data. It is seen that most of the numerical values of these decay constants in BSE under CTA improve when $_5(P)=M$ is introduced in the vertex function in comparison to the values calculated with only $_5$. Further discussions are in Sec. 4.

4 D iscussions

In this paper we have stwritten H qq vertex function for a pseudo-scalar m eson employing the power counting rule [1] for the incorporation of various D irac covariants from their complete set. They are incorporated order-by-order in powers of inverse of the meson mass. We then calculate f_P for unequal mass pseudo-scalar mesons (K, D, D_S, B) in the framework of Bethe-Salpeter Equation under CIA, using the hadron-quark vertex function

(**q**) in Eq. (12) with the incorporation of the leading order covariants. Unequalm ass kinem atics is employed in this calculation. It is seen that the values of D ecay constants can improve considerably when the D irac structure i₅ (P)=M is introduced in the vertex function with tuned parameter $\frac{B_1}{B_0}$, and come closer to the results of some recent calculations [12, 13, 19, 20] as well as agree with experimental results [21] within error though f_B is a bit lower (but still within 1-, for details see Table 1).

In a recent work [12], the Leptonic decay constants f_P have been calculated for light pseudo-scalar mesons within a ladder-rainbow truncation of coupled D yson-Schwinger and Bethe-Salpeter Equations using H qq vertex function to be a linear combination of four dimensionless orthogonal D irac covariants where each covariant multiplies a scalar amplitude $F_i(q^2; q \ P; P^2)$ for three dimensionless for eactive interactions. The decay constants for pseudo-scalar meson K calculated in that model [5, 12] for an intermediate value of one of the parameter sets: $! = 0.4 \text{GeV}; D = 0.93 \text{GeV}^2$ is $f_K = 155 \text{M eV}$. In our model with leading covariant $_5$ alone we obtain $f_K = 153.5 \text{M eV}$, which is quite close to this gure. However, here we include

the other leading order D irac covariant i $_5$ P=M besides $_5$, and get f_P as a function of the parameter ratio $B_1=B_0$. We then calibrate $B_1=B_0$ to reproduce the experimental value of K aon decay constant, $f_K = 159.8M$ eV to get the value $B_1=B_0 = :163:U$ sing this value of tuned parameter, we then obtain $f_D = 232:78M$ eV (E xpt: 222:6 16:7), $f_{D_s} = 295:18M$ eV (E xpt: 294 27), which agree with data [21] within the errors. The decay constant for B-m eson predicted in our framework is $f_B = 191:6M$ eV, which is not far from the recent experimental result for f_B [22]. Further our model predicts f_{D_s} value to be around 22% larger than f_D value which is roughly consistent with the prediction of m ost of the models which generally predict f_{D_s} to be 10% - 25% larger than f_D (as per recent studies in Ref.[22]). These results are demonstrated in Table I.

Am ong all the pseudo-scalar m esons, pion en pys a special status. The large di erence between the sum of two constituent quark masses and the pion mass shows that the quark is far o -shell and q could be the same order as the pion mass. So it seems better to incorporate all the four D irac covariants. However, the present experim ental condition does not make it econom ical and practical to take into account all four D irac covariants and make a global tting, for the experimental precision is in dierent ranks for the mesons covered in this paper. On the other hand, from Table I we see that the f_P value calculated with only the leading order D irac covariants 5 and i 5 P=M rather than all the four D irac covariants for pion can give the results di erent from data by only about 20%. This indicates the moderate contribution from the other two higher order D irac covariants for pion. Such a case can be contrasted with the case of introducing the other LEAD ING order covariant i 5 P≓M (besides $_5$) for three heavy m esons, where we see the signi cant contribution as large as that from $_5$ term since they are equally leading order covariants and the results for f_P using these leading order covariants for heavier mesons are quite close to their experimental values.

These numerical results for f_P obtained in our framework with use of leading order covariants $_5$ and $_5$ P=M, as well as those of $f_{\rm F}$ [1] con rm the validity of our power counting rule, according to which the leading order covariants should contribute maximum to meson observables, and inspire the possibility to investigate the higher order terms in order to get better agreement between calculations and data (when enough precision is obtained), hence help to obtain a better understanding of the hadron inner structure.

Table 1: Leptonic decay constants (in M eV) f_P in BSE under CIA for range of values of ratio $B_1=B_0$. The decay constants are calculated from data [21]. The m asses of hadrons are also from [21]. The values of constituent quark m asses used are set to be $m_{u,d} = 300M \text{ eV}$, $m_s = 540M \text{ eV}$, $m_c = 1500M \text{ eV}$; $m_b = 4500M \text{ eV}$, which is compatible with the other parameters xed from hadron spectrum. Comparisons with results obtained from other m odels are also provided. As discussed in the paper, we calibrate $B_1=B_0$ to K aon data (the 2nd line), however, if we calibrate $B_1=B_0$ to pion data the results (the 5th line) are as good for the heavier m esons.
