Just so Higgs boson

W e discuss a m inim al extension to the standard m odel in which there are two H iggs bosons and, in addition to the usual ferm ion content, two ferm ion doublets and one ferm ion singlet. The little hierachy problem is solved by the vanishing of the one-loop corrections to the quadratic term s of the scalar potential. The electro-weak ground state is therefore stable for values of the cut o up to 10 TeV. The H iggs boson m ass can take values signi cantly larger than the current LEP bounds and still be consistent with electro-weak precision m easurem ents.

I. MOTIVATIONS

There is some tension between the value of the electroweak (EW) vacuum and the scale at which we expect new physics to become manifest according to EW precision measurements [1]. If we take the latter scale around 10 TeV as the cuto of our electric theory, some degree of ne tuning is necessary in the scalar potential in order to guarantee the vacuum stability against radiative corrections. This little hierachy problem | and before it the more general (and more serious) problem of the large hierarchy between the EW vacuum and the GUT and Planck scale | has been used as a clue to the development of models in which the scalar sector of the standard model is enlarged to provide better stability, as, for instance, in supersymmetry, technicolor and little-Higgs models.

Here we discuss a di erent approach in which no new symmetry is introduced to cancel loop corrections and instead the parameters of the lagrangian are such as to make the one-loop corrections vanish and thus ensure the stability of the elective potential for the scalar particles up to the energy scale at which two-loop elects begin to be sizable, namely 10 TeV. Clearly, by its very nature, such a procedure can only be applied to the little hierarchy problem and not to the more general GUT or Planck scale hierarchy problem. It is a limited solution to a little (hierarchy) problem , a problem that contrary to those arising in much larger hierarchies may well be contingent to the choice of the lagrangian parameters.

Given the simplicity of the idea behind this approach, it is not surprising that it was suggested early on (by Veltman [2]) in the following terms: the quadratically divergent one-loop correction to the Higgs boson mass m_h ,

can be made to vanish, or at least made small enough, if m_h happens to be around 316 GeV at the tree level. The remaining contributions not included in (1) are proportional to the light quark masses and therefore negligible.

Such a cancellation does not originate from any dynam ics and it is the accidental result of the values of the physical parameters of the theory. The absence of this quadratically divergent term in the two-point function of the scalar bosons makes possible to increase the cut-o for the theory to a higher value with respect to the standard model (SM) where the renormalization of the Higgs boson mass and the given value of the expectation value v_W impose a cut o of around 1 TeV to avoid unnaturally precise cancellations among terms.

We now know that a value of $m_h = 316 \text{ GeV}$ is a little over 3 with respect to current precision measurements of EW data [1]. This how ever does not mean that a scenario in which the Higgs boson mass is chosen just so to make the cancellation a la Veltman is ruled out. It only means that we must either enlarge the SM with new particles propagating below 1 TeV and then redo the EW data t [4] or introduce new physics at a higher scale, the e ect of which is to correct the precision observables and make room for the shifted value of the Higgs boson mass (as described in the framework of the e ective EW lagrangian in [3]).

Bearing this in m ind, we introduce the m in im alextension to the SM in which

quadratically divergent contributions cancel at one-loop a la Veltm an;

it is consistent with the EW precision data.

The model, as we shall see, is quite simple and provides an explicit example of an extension of the SM in which the mass of the Higgs boson can assume signicantly larger values with respect to the current lower bound without having the EW precision measurements violated. In so doing, it introduces a characteristic spectrum of states beyond the SM that can be investigated at the LHC.

The model is natural in the sense that the EW vacuum is stable against a cut o of the order of 10 TeV for a large choice of parameters. It is just so because the physical parameters are chosen by hand in order to satisfy the constraints. These parameters are however numbers of order unity and not extravagantly small or large; moreover, they can be chosen among many possible values so that no unique determination is required, as it would be in the original Veltman's condition where the only free parameter is the Higgs boson mass, or what amounts to the same thing the quartic coupling \cdot .

Because among the additional states required there is a stable neutral (exotic) ferm ion, we also discuss to what extent this state can be considered a candidate for dark matter.

II. THE MODEL: HOW THE HIGGSGOT ITS MASS

We consider a model in which there are two scalar EW doublets, h_1 and h_2 , the lightest scalar component of which is going to be identi ed with the SM Higgs boson and two W eyl ferm ion doublets, $_1$ and $_2$. In addition, we also introduce a W eyl ferm ion $_3$ which is a SU $(2)_W$ U $(1)_Y$ singlet.

Let us brie y discuss to what extent this choice of new states is the minimal extension which cancels the quadratic divergence. In the model with only two Higgs bosons it is possible to reduce or indeed cancel the contribution of the top quark to the quadratic divergence but not that of the gauge bosons and the cuto cannot be raised up to 10 TeV. We comment on this class of models in sec.VII below. The mass of a single ferm ion doublet (with two singlets) is necessarily proportional to the scalar eld vacuum expectation and cannot be varied independently of the Veltman condition (if we want to choose naturally the Yukawa of the new ferm ions). Two doublet ferm ions are also necessary in order to be anom aly free. The singlet ferm ion is necessary to lift the ferm ion degeneracy and couple the ferm ions to the scalar elds.

The states of the model are similar to those of a SUSY minimal extension of the scalar sector of the SM into a Wess-Zumino chiralmodel in which the singlet boson has been integrated out. However, a model with softly broken supersymmetry cannot be the model we are discussing because the supersymmetry, if present at any scale, would make the quadratically divergence zero.

The lagrangian for the scalar bosons is given by

where $\tilde{h}_2 = i_2 h_2$. The potential in eq. (3) is the most general for the two H iggs doublets once we impose a parity symmetry T_1 according to which the two doublets h_1 and h_2 are, respectively even and odd. In this way, the quadratic and quartic m ixing terms are forbidden, which makes the discussion simpler.

The lagrangian of eq. (3) can be studied to nd the ground state that triggers the electroweak symmetry breaking. It is

The requirement of matching the EW vacuum v_w to this vacuum state constains one parameter of the model. The mass eigenstates of the scalar particles can thus be derived. The masses are

for the three neutral scalar bosons (two of which, h and H, are scalars and one, A, a pseudoscalar),

By introducing the mixing angle and to rotate the scalar boson gauge states into the mass eigenstates, we write:

The exotic ferm ion content of the model is given by two SU $(2)_W$ doublets:

and one SU $(2)_W$ singlet $_3$; we can also de ne the M a jorana 4-com ponents ferm ions current eigenstates as

The SM ferm ions are even under the T_1 parity symmetry and therefore can have Yukawa interactions only with the scalar doublet h_1 . The exotic doublet ferm ions i are odd under this parity symmetry while the singlet 3 is even. We also introduce an additional parity T_2 under which the Higgs bosons are even while all the exotic ferm ions are odd (SM particles are always even under both parities). In this way the exotic ferm ions do not mix with the SM ferm ions and may have Yukawa terms only with the scalar doublet h_2 .

The lagrangian for the exotic ferm ions is simply given by the kinetic and the Yukawa term s, that is

From L_m we see that the charged D irac ferm ion \sim^+ has mass m $_+ = \sim$ while once we insert eq. (4) into eq. (10) the M a jorana mass matrix for the neutral states is given by

This matrix is diagonalized by a neutralino mixing matrix V which satis es $V^T M^0 V = M_{diag}^0$. From the 2components mass eigenvectors of eq. (10) $\int_{i=1,3}^{0} we de ne the 4-components neutral fermions that will be our neutralinos$

where in eq. (11) the de nition of \sim_2^0 takes into account that the corresponding eigenvalue of the M a prana mass matrix is negative.

From L_{kin} of eq. (10) using the mass eigenstates de ned in eq. (11) we obtain the interaction term s of the new ferm ions with the gauge bosons

where the factor $i = (1)^{i}$ keeps into account the signs of the eigenvalues of the M a jorana m ass m atrix of eq. (10). This lagrangian is necessary in order to compute the one-loop radiative corrections to the scalar potential.

III. VELTMAN CONDITION REDUX

As stated in the introduction, we want to stabilize the potential given by eq. (3) at one-loop level, that is we want that the one-loop $\frac{2}{i}$ quadratically divergent contributions to $\frac{2}{i}$ be zero. As in the SM the quadratically divergent contributions arise by loops of gauge bosons, scalars and ferm ions. We therefore not two Veltman conditions by imposing

In eq. (13) g, g^0 are the electroweak gauge couplings, i the parameter of the scalar potential of eq. (3), t the top Yukawa de ned as $t = v_w = v_1$ since the SM fermions couple only to the scalar doublet h_1 and $k_{1,4}$ are the Yukawa coupling of eq. (10). The contributions of the lighter SM fermions to eq. (13) have been neglected.

Notice that if we did not have the parity symmetry T_1 and the fermions would have interacted with both h_1 and h_2 we would have generated a divergent mixed contribution that could have been canceled only by a bare term.

In writing eq. (13) we have taken a common cuto for the divergent loops of di erent states. The possibility that there exist di erent cuto s for the di erent contributions does not change our result because a change of order 0 (1) in the s only means a similar change of order 0 (1) in the parameters of the model $_{i}$ and k_{i} .

O noe these two conditions are satis ed the scalar potential is stable at one-loop order and so is its vacuum state. We interpret these conditions as two constraints on the 10 free parameters of the model.

IV. THE EW PARAMETERS S, TAND U

For our purposes, the consistence of the model against EW precision measurements can be checked by means of oblique corrections. These corrections can be classified [5] by means of three parameters:

where the functions $_{nm}$ ($q^2 = 0$) represent the vacuum polarizations of the gauge vactors in the various directions of isospin space. O ther corrections functions | like the functions Y and W of ref. [6] are not relevant here because mainly sensitive to physics in which there are new vector bosons.

EW precision m easurements severely constrain the possible values of the three parameters S, T and U. In the SM, the data allow [1], for a Higgs boson m ass of $m_h = 117 \text{ GeV}$,

These constraints must be rescaled for the di erent values of the Higgs boson mass. If we want the model to be consistent with the EW precision measurements within, for instance, one sigm a we have three further constraints on the parameters of the model 5 of which still remain free at this point.

A mass of the Higgs boson larger than the reference value will make the parameter T smaller, the size of the correction going like the $\ln m_h^2 = m_Z^2$. This can be compensated by the ferm ion contribution which can give a T > 0 of size m² hm² where m² is the isospin splitting of the ferm ion masses. The parameter S is changed by the larger Higgs mass with a S > 0, a change that is in general di cult to compensate. In our model a negative contribution to S comes about because of the ferm ion with both D irac and M a jorana masses which gives a negative contribution proportional to $\ln (m_1 + m_2)$, and $m_1 + m_2$ is the isospin mass splitting between the chargino and the neutralino i.

Let us consider their contributions to T and S separately in a simplied model which helps in visualizing better how scalar and ferm ion contributions compensate one other in order to accom odate the EW experimental values.

For what concerns the ferm ions, suppose to be in the simple case in which $m + m_{i}$. The ferm ion contribution to the T parameter can be written as

where T_{LL}^{f} takes into account the one loop contributions that arise from the vacuum polarizations of the gauge bosons of the kind $LL_{11;33}^{L}$ and $R_{11;33}^{R}$, T_{LR}^{f} the ones that arise from $LR_{11;33}^{R}$ and $RL_{11;33}^{L}$. The latters are not present in the SM case. K exping only the leading contributions, we have

where $U_{i,ij}^{eff}$ are elective couplings related to the neutralino mixing matrix V and are in general dierent for the LL contribution and for the LR one. For example U_i^{eff} in T_{LL}^f is given by $k = V_{ik}^y V_{ki}$. Notice that when the third neutralino decouples, the T_{LL}^f contribution goes to zero when $m_{i+1} = m_{i,2}^0$ and the isospin symmetry is restored. The same happens also for T_{LR}^f . In a manner similar to the T parameter, the S parameter receives a ferm ion contribution that can be splitted in

a combination of di erent entries of the neutralino mixing matrix V. Notice that we recover the contribution of two SM -like doublets when the hypercharges di erence in S_{LR}^{f} gives 1=2 and U_{ij} in S_{LL}^{f} is equal to 1[5].

The previous expressions can be further simplied if we consider the ferm ion mass matrix of eq. (10) in the limit in which $^{\circ}$ is much larger than \sim ; $k_{1;4}v_2$. In this limit the neutral ferm ion mixing matrix is approximately given by

If it holds also that ~ larger than $k_{1;4}v_2$, m + ' m ${}_{1;2}^{\circ}$, T^f and S^f can be easily expressed in terms of the mass splitting, see g.1. Notice that eq. (20) is valid form ${}_{1;2}^{\circ}$ < m ${}_{3}^{\circ}$ < m ${}_{1}^{\circ}$ = m ${}_{12}^{\circ}$. For this reason we have plotted T^f and S^f in g.1 corresponding to only one value of m ${}_{3}^{\circ}$, since in the range allowed di erences are minimal.

For what concerns the scalar sector, consider the case in which m_{H^+} ' m_A . In this limit, T^s and S^s assume a simple form . We have

W e can compare the contribution of the scalar sector of our model with respect to the SM one. In the SM we have

EW precision measurements indicate that at 2 m_h 185 GeV [1] and therefore the introduction of the fermions in our model is justified if T^s and S^s exceeds the contributions T_h^{SM} and S_h^{SM} corresponding to m_h ' 185 GeV. This is shown in g.2.

For xed m_h and m_H, and a given ferm ion spectrum that accommodates the T parameter, the ferm ion contribution to S is xed and therefore the only freedom left is in the values of m_A and m_{H+}. In the case in which m_{H+} ' m_A, their total contribution to S has the same sign of the ferm ion one, therefore we expect that m_A cannot in general be to heavy. This is veried in the num erical analysis.

V. A DARK MATTER CANDIDATE?

The lightest neutral exotic ferm ion state in the model is similar to the neutralinos in a minimal supersymmetric extension of the SM (NM SSM) in which the composition is dominated by Higgsinos. It is stable because the lagrangian does not contain couplings between the SM and the exotic ferm ions or, alternatively, you can think of the lagrangian as written with a underlying conserved parity.

We compute by means of the program DARKSUSY [7] its relic abundance $_{DM}$ h². To do this we need the lagrangian written on the exotic ferm ion mass eigenstates:

where $H_{n=1;2} = h; H$ are the two neutral scalars, A the pseudoscalar, H the charged scalar, the mixing angle de ned in eq. (7) and U^R is the mixing matrix related to the real neutral components of the two doublets h_1 and h_2 given by

where is the mixing angle de ned in eq. (8).

The analysis shows that the relic abundance is always at least one order of magnitude too small than the presently favorite abundance of dark matter in the Universe. This seems to be due to the lack of cancellations among di erent diagram s introduced by the arbitrariness in the Yukawa couplings that makes pair annihilation rates too large. Therefore, the lightest neutral exotic ferm ion can at most be a marginal component of dark matter.

VI. THE MODEL SOLVED

The model has eleven parameters, 10 of which are in principle free once the ground state has been identied with v_W . If we enforce the Veltman conditions and thus make the one-loop quadratically divergent corrections vanish we are left with eight parameters. These can be treaded for the masses of the 4 scalar and 4 ferm ion states. These can be varied and for each choice of them the S, T and U parameters computed and compared against the EW constraints.

We vary the dimensionless parameters within one order of magnitude. In particular, we keep the $_i$ and the $_i$ between 1 and 4 (after which the perturbative analysis may break down). Mass parameters and ~ are varied between 100 and 300 GeV.

We nd that for a large choice of the ve remaining parameters the model is consistent with the EW precision measurements. For these choices, masses as large as 450 GeV are possible for the lightest neutral scalar H iggs boson.

As its mass increases those of the neutral pseudoscalar tends to favor lighter values so that there are solutions in which the lightest H iggs boson is the pseudoscalar. The lightest neutral ferm ion mass tends to increase together with the mass of the H iggs boson.

Figure 3 shows some of the possible values we obtain for the Higgs boson and lightest neutral ferm ion masses for values of the parameters which satisfy within 1 the EW precision masurements. Figure 4 shows the distribution of the masses for the scalar and pseudoscalar states under the same conditions.

O ur result m ay help in dispelling excessive surprise in not seeing a bantam weight H iggs boson with m_h just above the current LEP bound of 117 G eV and should encourage searches at the LHC for a H iggs boson substantially heavier than the current LEP bound | what we can call a welterweight at m_h around 300 G eV or even a cruiserweight at 500 G eV. Such a scenario has been pointed out recently in [8] and [9] in the fram ework of the little H iggs m odels[10] and in [11, 13] in a two-H iggs extension of the SM.

VII. MODELSW ITH TWO HIGGS BOSONS AND NO EXTRA FERM IONS

D i erent possibilities of realizing a minimal extention of the scalar sector of the SM could have a natural cut-o around few TeV while being compatible with EW precision measurements have been discussed in the last year. The authors of [11, 12, 13] have analyzed di erent realizations of the 2 Higgs doublets model (2HDM) and have

param etrized the ne tuning param eter in terms of the dependence of the mass of the light Higgs boson on the cut{o . In the Barbieri-Hall (BH) model [11] both doublets acquire a VEV, but the small mixing angle between them makes the light scalar coupling to the top quark quite small and becames proportional to the mass of the heavy neutral scalar. The mass of the heavy neutral scalar is then bounded by the requirem ent of satisfying the EW precision measurements and this allows to reach more or less 2 TeV when the light Higgs boson has a mass m_h = 115 G eV. The twin doublets model [12] is a particular version of the 2HDM in which only one doublet couples to the SM ferm ions. The symmetry of the model makes possible to improve the bound found in the BH model and to reach a cut-o between 3 and 4 TeV. Finally, the inert doublet model (DM) [13] proposes a di erent picture. Instead of trying to justify through naturalness the existence of a light Higgs boson and a cut-o of few TeV, it describes the possibility of having a heavy Higgs while being still compatible with EW precision measurements. The cut-o of the model turns out to be of few TeV (a value that would be natural even in the SM context if the Higgs were heavy). The new feature of the IDM is that the model may be compatible with the EW precision measurements even in the presence of a heavy Higgs boson. This is realized thanks to the contribution to the EW param eters that arises from the heavy new scalars. In general, in the di erent realizations of the 2HDM the T parameter receives a SM -like contribution and a contribution that arises from loops involving the new scalars. These contributions are approximately given by [14]

where tan $= v_2 = v_1$ with v_i the vev of h_i and the mixing angle between the two neutral scalars. If both the doublets acquire a VEV (BH, twin and the just-so models) T_b is negligible because $m_A = m_{H^+}$ cannot be too large (for natural choice of the $_i$ parameter of the potential). On the contrary, in the IDM T_b m ay not be negligible and can balance the contribution to T_a arising from a heavy Higgs boson; in this way, the model predicts a heavy Higgs boson and a cut-o around 3 TeV. In conclusion, in all the version of 2HDM the cut-o can be around 5 TeV but not much higher.

Our approach is di erent with respect to the models that present in proved naturalness. The cancellation of the Veltam condition xes our cut-o at 10 TeV and the requirements to be compatible with the EW precision measurements and to cover the most general neutral scalar spectrum forces us to include at least a new fermion doublet.
