D i ractive P roduction at the Tevatron and the LHC

We present predictions for the di ractive production of mesons in the central rapidity region usually covered by collider detectors. The predicted cross sections are based on the Bialas-Landsho form alism for both exclusive and inclusive production and makes use of the DPEMC Monte-Carlo simulation adapted with kinematics appropriate for small-mass di ractive production. We compare generator-level results with a CDF measurement for exclusive production, and study background and other scenarios including the contribution of inclusive production. The results agree with the Tevatron data and are extrapolated, highlighting the exclusive contribution at LHC energies. A possible new measurement at the Tevatron using the D forward detectors is investigated, taking advantage of the dom inance of exclusive production for high enough di ractive mass fraction.

I. IN TRODUCTION

Exclusive and inclusive central di ractive production of heavy states have been studied previously in the double P om eron exchange form alism (DPE) [1, 2, 3, 4, 5, 6, 7, 8], and experim ental results have been presented [9], attracting theoretical attention. Indeed, massive dijets have been copiously produced in inclusive di ractive production at the T evatron and there is presently an active search for exclusive di ractive production of heavy states. O nem otivation for this search is that the H iggs boson could be produced in such a m ode, allowing for a good m ass determ ination for this elusive particle if such exclusive events are identi ed [1]. H ow ever the estim ated cross sections and signal-over-noise ratios are still a matter of debate.

One way to address this problem is looking for a similar production mechanism with lighter particles like the mesons [10]. This would give rise to high enough cross sections to check the dynam icalmechanisms. Indeed, exclusive production of $_{\rm c}$ has been reported by the CDF collaboration [12] with an upper limit for the cross section of

O ur goal in the present paper is to analyse both exclusive and inclusive di ractive production of $_{C_0}$ and $_{b_0}$ in the context of the Tevatron, making useful predictions for the LHC. A possible new measurement using the D forward detectors is also investigated. As a general fram ework, we use an extension to low mass states of the Bialas-Landsho (BL) model [] for both exclusive and inclusive production. More precisely, we consider the inclusive model as applied in Ref.[5] and the extension to purely exclusive processes [8], using the corresponding color-singlet ($J_z = 0$) subprocess cross sections of the original Bialas-Landsho formalism for di ractive Higgs production [], applied also to heavy quark pairs in [3]. In fact, in our approach, both inclusive and exclusive diagram s come from the same

non-perturbative approach, originated in [1]. The model for exclusive production starts with the same soft P om eron exchange diagrams (for ordinary digt production the gg ! gg diagrams are also included [13]) and corrects the result by non-perturbative rapidity-gap survival factors [14, 15]. For inclusive production in the same fram ew ork, no such factor is applied, but the norm alisation is xed by thing the CDF digt data 9]. The energy dependence is related to the rise of ordinary hadronic cross-sections through features of the soft P om eron [16]. We think that the non-perturbative Bialas-Landsho approach is well suited for the production of relatively low-m ass di ractive states¹.

The full kinem atics is evaluated for low -m ass exclusive production and im plem ented in the DPEMC M onte Carlo generator [17], originally designed for heavy m ass states. We use the generator level distributions to estim ate the m easurem ents at detector level, and to study the system atic uncertainties due the lack of a full detector simulation.

II. THE BIALAS-LANDSHOFF FORMALISM

O ne generally considers two types of DPE topologies for the production of a heavy state: exclusive DPE [1, 2, 3, 4, 8], where the central object is produced alone, separated from the outgoing hadrons by rapidity gaps:

and inclusive DPE [2, 4, 5, 6, 7], where the colliding Pom erons are resolved (very much like ordinary hadrons), accompanying the central object with Pom eron \rem nants" (X,Y):

in both cases h represents the colliding hadrons.

In general, exclusive production is considered m ost prom ising, since a better signal-to-background ratio is expected. Indeed, if the events are exclusive, i.e., no other particles are produced in addition to the heavy object and the outgoing hadrons, the m easurem ent of the scattered hadrons in near-beam detectors provides inform ation on the m ass of the heavy object [11], and the dynam ics of the hard process. How ever, the approxim ations m ade for heavy m ass states lead to inconsistent results in the case of lighter objects, so in our case we have to develop the full kinem atics for all m ass states.

In order to evaluate both inclusive and exclusive di ractive production, we use an extension $\{\}\]$ to the purely exclusive processes of the original Bialas-Landsho form alism for di ractive Higgs production 1[], also applied to heavy quark pairs [3]. In this extension, both inclusive and exclusive diagram s come from the same approach and are based on soft P om eron exchange diagram s (for ordinary dijet production the gg ! gg diagram s are also included [13]). In the exclusive case one has to correct the result by non-perturbative rapidity-gap survival factors [14, 15], while in the inclusive case the norm alisation is xed [] by reference with dijet production [9]. The values of the survival probabilities are the same as for the di ractive Higgs production in R ef. [], namely 0.1 and 0.03 for respectively the Tevatron and the LHC. The energy dependence of the cross section is related to the rise of ordinary hadronic cross sections through features of the soft P om eron [16].

W ith respect to previous works, the form use of the Bialas-Landsho cross sections have to include now the full kinematics for di ractive meson states and thus valid for small masses in general. This kinematics is explained in the next section. For the exclusive meson production in hadron-hadron collisions, one has

¹ At this point, only $_{c0}$ and $_{b0}$ m esons can be evaluated. Indeed, due to non-zero $p_{?}$ of the initial state (pp or pp), there will be contributions of $_{c_2}$ and $_{b_2}$ in the exclusive am plitude. This will be discussed in a further paper.

M ost importantly, M $_{diff}^2$ is the expression of the di ractive m ass produced in the central region in terms of the kinem atic variables. For low-m ass states, as the 0 s, it sensibly di ers from the expression for heavy di ractive states, as will be derived in the next section and in Appendix A. This is one major modi cation one has to introduce w r.t. the original form alism .

For inclusive production, the cross sections are given by

where one makes use of the parton structure functions $G_p(x_i^g;)$ in the Pomeron, for a given scale . Note that in Equation (5), the normalisation C^{inc} is xed by normalising the prediction on the measurement of the dijet diractive cross section by the CDF collaboration [5].

In both equations, the variables v_i and i denote the transverse m om enta and fractionalm om entum losses of the outgoing hadrons. In the second equation, x_i^g denote the fractionalm om entum carried by the gluons in the Pom eron. Note that in the inclusive case, the usual kinematics is used for M $\frac{2}{\text{diff}}$ $\frac{M^2}{x^2x^2}$:

III. FULL K IN EM AT ICS FOR EXCLUSIVE PRODUCTION

Let us rst recall the m ethod used to generate exclusive events in the DPEMC M onte C arb generator [7]. The rst step is to random ly generate t_1 , t_2 and t_1 , following an exponential distribution for $f_i j$, where $f_i j$ is the 4-m om entum transferred and t_1 is the momentum boss for the hadron i. Exclusive events have the property that the full energy available in the center-of-m ass is used to produce the directive object, or in other words there is no Pom eron rem nant. The directive m ass can be expressed as:

The value of $_2$ is thus imposed by this relationship. The produced events in the generator are then weighted as usual by the cross section.

The approximation (6) is no longer true for low mass states such as mesons, and we had to modify the method to generate events in this case. We derived the di ractive mass from full 4-momentum conservation (see Appendix A). Using the full kinematics, Equation (6) is replaced by

where = $\cos_1 \cos_2 + \sin_1 \sin_2 (\cos'_1 \cos'_2 + \sin'_1 \sin'_2)$, is the scattering angle and ' the polar angle. It is important to notice that this form ula depends not only on 1 and 2 but also on the angles of the hadrons 1;' 1 and 2;' 2:t and are related by the following form ula:

We use the following method to generate low mass exclusive events within the framework of DPMEC [17]. We start by generating $_1$, $_2$ (following an exponential distribution) and $_1$ random ly, which gives t_1 by the equation (8). $_2$ is then computed inverting equation (7), giving also t_2 . The events are then weighted according to the cross section. The new steps are thus to use the variables and , avoiding the cum bersom e solution of equation (7) in terms of and t. Table (I) presents our results for the cross section predictions at the Tevatron and the LHC. The energy dependence for the exclusive production cross section can be seen in the Fig. 1 for the $_{b_0}$ (left) and $_{c_0}$ (right) m esons. The gap survival probability (the probability of the gaps not to be populated) S^2_{gap} is taken to be 0.1 at the Tevatron and 0.03 at the LHC (cf. A B.K aidabv et al in [14]).

Note that our estimates for exclusive $_{c_0}$ production at the Tevatron are higher than other recent predictions [10]. The dimension and higher than other recent predictions [10]. The dimension and higher that the BL exclusive cross section has a smoother dependence with the center of mass energy (\overline{s}) (see Fig. 1). We should also note that our model does not contain Sudakov factors contrary to Ref. [4, 10]. The ender of the Sudakov suppression is how ever supposed to be small at small masses, and plays a more important role at higher masses.

Possible sources of background for exclusive production include:

cosm ic events which can fake an exclusiveness;

exclusive and inclusive 2 production;

quasi-exclusive production, which are dened by a high mass fraction F_{M} (e.g. F_{M} 0.75-0.95),

where the mass fraction F_M is the ratio between M and the total di ractive mass M_{diff} . We will study this last contam ination to the exclusive signal in the following.

As shown in table I, exclusive $_{c_0}$ production at the Tevatron has a noticeable cross section, with the potential to be detected in the traditional decay $_{c_0}$! J= (! ⁺ +)+ . The CDF C ollaboration has presented preliminary results [12] for exclusive J= + production using the rapidity gap selection of di ractive events in R un II (s=1.96 TeV). The cuts used by CDF are the following: p_T () 1:5 (GeV), j () j 3:5 and j () j 0:6. The CDF collaboration provided an upper limit on $_{c_0}$ production cross section at the Tevatron, uncorrected for residual backgrounds such as cosm ics²:

If we apply the CDF cuts at generator level, we predict the following cross section

In order to make a more realistic comparison, we need also to consider the non-exclusive background which can enter directly in the experimental cross section determination. In particular, the contamination due to quasi-exclusive events need to be considered properly. In this class of events the QCD radiation, or in other words the energy loss in the Pomeron remnant and in soft QCD radiation, is small. CDF remove most of the inclusive background using a cut on the mass fraction, $F_M > 0.85$. For exclusive events, F_M is expected to be close to one, since the full available energy is used to produce the meson, and smaller than one for inclusive events. However, this cut is of course applied at the detector level by the CDF collaboration, whereas we can only apply it at the generator level. Due to the fact that we are missing the smearing between detector and generator levels, we choose to investigate the e ect on the cross section due to various mass-fraction cuts, as displayed in Table II.

We also compared the transverse momentum (p_T) distributions of the $_{C_0}$ for inclusive, exclusive and quasi-exclusive production, the latest de ned as $F_M = 0.75$ (Fig. 2). As expected, the exclusive p_T distribution reaches higher values, so this variable could be used to enhance the exclusive production signal.

The quasi-exclusive contam ination to the exclusive signal also su ers from the unknown gluon density in the Pomeron at high in particular. This uncertainty, estim ated to be about 50% [18], can be taken into account by multiplying the gluon density in the Pomeron, measured at HERA, by a factor (1) where varies between -1.0 and 1.0 [19]. If is negative, we enhance the gluon density at high by de nition. The QCD ts to the HERA data lead to the following value of the parameter: = 0.0 0.6.

In sum m ary, the sources of contam ination to the exclusive signal can derive from the sm earing in the m ass fraction, which is a pure experimental e ect, or the uncertainties in the gluon density in the Pom eron, which is a theoretical limitation.

Table II gives the quasi-exclusive cross section at the Tevatron after applying the CDF cuts, and di erent cuts on the mass fraction and values of the parameer. We thus not that the signal seen by the CDF collaboration could be explained by a combination of a higher gluon density at high and some smearing elects due to the reconstruction of the mass fraction. Table III gives the exclusive production cross section after each of the CDF cuts.

VI. POSSIBILITY OF A NEW MEASUREMENT AT D

We now exam ine the possibility of measuring the exclusive $_{c_0}$ production at the Tevatron using the rom an pot detectors in the D α collaboration.

A fter interfacing the DPEMC generator with a program designed to propagate (anti)protons through the Tevatron lattice, from the D interacting point to the rom an pot detectors [20], we can predict the number of events observed for di erent tagging con gurations. The Forward Proton Detector (FPD) installed by the D collaboration [21] consists of eight quadrupole spectrum eters, four being located on the outgoing proton side, and the other four on the antiproton side.

E ach spectrom eter allows the trajectory reconstruction of the outgoing protons and antiprotons near the beam pipe determ ining their energies and scattering angles. The quadrupole detectors are sensitive to outgoing particles with $\pm j > 0.6$ GeV² and $< 3.10^{-2}$, with good acceptance for high mass objects produced di ractively in the D main detector.

We use the following selection cuts: (p_T ($^+$) 2.0 (GeV) or p_T () 2.0 (GeV)) and j () j 2.0 and j () j 3.0) (see Table IV).

We note that the number of events in double tagged con guration is quite small after applying the selection cuts, so this con guration might not be useful. However, a single tag event with a rapidity gap on the other side yields a good number of events, with the additional bene t of having the kinematics determined for one of the scattered particles.

From the results on section IV, we expect a high production cross section of $_{\rm c}$ m esons at the LHC.We can estim ate the num ber of events accessible to the TOTEM /CMS detectors, bene thing from the good acceptance of the TOTEM detectors for low mass objects. The TOTEM acceptance for the high optics and low values is typically 90 %, for the range 0 < jj < 1 GeV². Then for 10 pb⁻¹ of data, 5.3 10⁶ double tagged events are predicted, with no requirement in the central detector activity. In this way, one might look for the $_{\rm C_0}$ in the reconstructed di ractive mass.

If central activity is required, the lowest possible muon p_T cut at low luminosity is on the order of p_T 1:5 (GeV) for j j 2:4 [2]. O therwise, the muon p_T threshold would be 4 (GeV), which is too high for exclusive c_0 production. The predictions for exclusive and quasi-exclusive production at the LHC are shown in tables V and VI. We note that the number of events can be dominated by exclusive production, independent of uncertainties in the gluon distribution, if a high enough cut on the mass fraction can be made, for instance at 0.95, which requires a good coverage of the CMS detector at high rapidities.

V III. CONCLUSION

We calculate the di ractive production cross section for mesons at the Tevatron and LHC using an extended version of the Bialas-Landsho model, including the full kinematics needed for low mass states. Both exclusive and inclusive production have been evaluated and discussed with various physically motivated cuts at generator level. The results can be listed as follows.

The results for exclusive production at the Tevatron agree with a recent CDF upper limit for the exclusive production of $_{C_0}$; with the default parameters of the model (assuming that the non perturbative gluon coupling to the proton G²=4 1);

In the same conditions, the non-exclusive background (in particular \quasi-exclusive" events which we evaluate from the inclusive spectrum) can reach sim ilar levels as the exclusive signal, due to experim ental and theoretical uncertainties, making di cult to establish the observation of exclusive events within the current parameters;

The possibility of observing exclusive $_{c_0}$ production at the Tevatron, using the D forward detector is thoroughly investigated, showing the possibility of a measurement if a tight cut on the ratio between the $_{c_0}$ mass and the total di ractive mass can be performed successfully.

Exclusive production at the LHC, using the CM S/TOTEM detectors, is also investigated and appears prom ising, but again a high enough cut on the mass fraction is to be made before the observation of exclusive production can be established with a good con dence level. It could be suitable for a mass fraction, for instance at 0.95, which requires a good coverage of the CMS detector at high rapidities.

Due the low mass of the mesons, we must evaluate the full kinematics of an exclusive production. The start point is the 4-m om entum conservation in the center-of-m om entum frame.
