Out of equilibrium quantum eld dynamics in external elds

Abstract. The quantum dynamics of the symmetry broken $(^{2})^{2}$ scalar eld theory in the presence of an hom ogeneous external eld is investigated in the large N limit. We consider an initial them all state of tem perature T for a constant external eld J. A subsequent sign ip of the external eld, J ! J, gives rise to an out of equilibrium nonperturbative quantum eld dynamics. We review here the dynamics for the symmetry broken $(^{2})^{2}$ scalar N component eld theory in the large N limit, with particular stress in the comparison between the results when the initial tem perature is zero and when it is nite. The presence of a nite temperature m odi es the dynamical elective potential for the expectation value, and also makes that the transition between the two regimes of the early dynamics occurs for lower values of the external eld. The two regimes are characterized by the presence or absence of a temporal trapping close to the metastable equilibrium position of the potential. In the cases when the trapping occurs it is shorter for larger initial temperatures.

1 Introduction

Several in portant physical system s, as the ultrarelativistic heavy ion collisions [1] and the early universe [2], present out of equilibrium dense concentrations of particles. The presence of these concentrations in ply the need of out of equilibrium nonperturbative quantum eld theory methods, as the large N lim it.

2 The model

We consider N scalar elds, , with a $(\ ^2)^2$ sel nteraction in the presence of an external eld J . The action and the lagrangian density are given by

We restrict ourselves to the case where the symmetry is spontaneously broken, i.e., m² < 0; and we mainly consider small coupling constants , because this slows the dynamics and allows a better study of its di erent parts.

We consider here the evolution of a initial therm al state of temperature T after a ip in the hom ogeneous

external eld J $\, ! \,$ J . We can choose the axes in the N -dimensional internal space such that

For an initial them alstate we have an expectation value parallel to the external eld. The following decom position can be done

with $\frac{p}{N}$ (t) = h (x)i; thus, h (x)i = 0. W hile in the remaining N 1 directions transversal to the expectation value, h (x)i = 0.

3 Evolution equations in the large N lim it

A swe have one direction parallel to the expectation value and N 1 transversal, the uctuations in the transverse directions dom inate in the large N limit, while those in the longitudinal direction only contribute to the evolution equations as corrections of order 1=N.

The large N limit provides explicit evolution equations for the expectation value and the modes of the quantum uctuations. See Refs. [3] and [4] for the detailed expressions. W e will discuss here the results obtained with this evolution equations, in particular the e ects of the initial tem perature. In order to sim plify the expression of the results, we introduce the following adim ensional variables:

The fact that the initial state is not the ground state but a therm all state increases the initial value of g . It can be shown that (0) is approxim ately given by

T = 0 (0) is the zero tem perature value, that for g 1 only depends on j (see Ref. [3]). The second term on the righthand side of Eq. (7) is the therm alcontribution com puted in the hard therm al loop approximation [5]. This expression for (0) implies that it is greater for larger initial tem peratures.

4 E ective dynam ical potential for the expectation value

W e can de ne a potential

that can be interpreted as a dynam icale ective potential because the evolution equation for (in the large N lim it) can be written as [3, 4]

It must be stressed that $V_{de; > 0}$ is an elective potential only for (and not for the modes).

5 Equilibrium states for the dynam ical potential

The dynamicale ective potential for 0 can be de ned as V_{de} ; $_0(;) = V_{de}$; $_{0}(;)$ 2j. Therefore, the stationary states for the initial dynam ics for times 0 (before the external eld has been ipped) are the solutions of $V_{de; 0}^{0}$ () = 0 (the prime means derivative). Thus, they verify 3+

we have three roots. There is a globalm inim um that corresponds to a stable equilibrium state, a local minimum

that corresponds to a metastable equilibrium state, and a local maximum (unstable equilibrium) (see Fig. 1). On the other hand, for larger external elds $(j > j_d)$ there is a single extrem e that corresponds to a globalm in im um (stable equilibrium).

As a larger initial tem perature increases q (0), it contributes to restoring the symmetry and as consequence m akes the value of j_d low er [see Eq. (11)].

We consider here the more interesting case $j < j_d$, where a potential barrier is present.

6 Early time dynam ics and dynam ical regimes

After the initial ip of the external eld sign at = 0 the positions of the absolute m in im um and the relative m in imum of the potential are interchanged, and the state of the system becom es a m etastable state (Fig. 1). The existence of a potential barrier gives rise to two di erent dynam ical regimes. In the stone the system can directly overcome the barrier, and rapidly reaches the neighborhoods of the globalm in im um . W hile in the second regime the system can not overcom e the barrier directly, and it gets tem porally trapped close to the m etastable state. The external eld critical value j_c that separates the two regimes, untrapped jjj> j_c, or trapped jjj< j_c, is

 $\frac{\overline{q}}{3}$: Therefore, we see that if the initial tem perature is higher enough the system will not be trapped. In addition, Eq. (12) states how the trapping can disappear due to a

combination of the e ects of both the initial tem perature and the external eld (see g.2).

W hen the trapping is present spinodal instabilities made the modes grow and nally their backreaction allows the system to go close to the stable state. A detailed analysis of the spinodal instability allows to obtain the trapping time, or spinodal time $_{\rm s}$ (see Refs. [3,4]). At early times (< $_{\rm s}$), the electric squared mass oscillates with a negative average, 2 , j in plying the grow th of the modes due to spinodal instability. This in plies a quasiexponential grow th of g () for < $_{\rm s}$

the value for zero tem perature. A fler a certain time, the spinodal time $_{\rm s}$, the quantum and therm all e ects start to be important in the dynamics, g $_{\rm s}$ ($_{\rm s}$) compensates

 2 and the exponential growth of the mode functions stops, then the mode functions start to have an oscillatory behavior. Thus, the spinodal time $_{\rm s}$ is dened as

A good approximate expression for the spinodal time is

For ¹ we see that a higher initial tem perature in plies a shorter trapping period.

7 Interm ediate tim e dynam ics

A fler the early dynam ics described in the previous section, the system enters a quasiperiodic regime, both for $j < j_c$ and for $j > j_c$. The system at this intermediate times presents a clear separation between fast variables and slow variables. (), g (), and the elective squared mass oscillate fast, while the amplitude of their oscillations slow ly decreases. This quasiperiodic regime in the large N limit evolution equations is present both for zero and nonzero initial temperatures. (See Refs. [3,4].)

8 Conclusions

O ne of the main features of the dynam ics is the existence in some cases of a trapping stage in the dynam ics, that have been characterized. In particular, we have seen that the main in uence of the initial temperature is to contribute to the restoration of the sym m etry of the potential, and as a consequence a higher initial temperature shortens or even avoids the initial trapping. For intermediate tim es we have found a quasiperiodic regim e. How ever, how much this dynam ics will be modi ed by the inclusion of next to leading order terms in the large N approximation [6] is still an open question.
