# On the absence and presence of pole(s) in ferm ion propagator in the sim ple model w ith $m$ ass generation

#### Abstract

$W$ ithin the $P$ auli-V illars regularization technique the ferm ion propagator is studied in the fram ew ork ofSchw inger-D yson equations in the E uclidean space. M aking the generalization ofFukuda and K ugo proposals, the analytical continuation is perform ed into the tim elike region of fourm om enta. $T$ he $m$ assive gauge boson is considered and the ferm ion propagator pole structure is discussed in detail.

## I. INTRODUCTION

The naturalnonperturbative fram ew ork for the study of in frared properties of $Q C D G$ reen's fiunctions in the whole $M$ inkow skispace is the form alism of Schw inger-D yson equations (SDES). The complex of SDEs is an in nite tower of coupled integral equations which must be truncated to be tractable in practice. M ost of the studies concems the solution of SDEs in Q uantum Chrom odynam ics [l] where it is believed they can give the correct description of chiral sym $m$ etry breaking and con nem ent. It is well known fact the the $m$ asses of the particles can be largely enhanced in strong coupling theory like QCD. The property and di culty to extract a correct picture of dynam ical m ass generation attractsm uch attention in recent $m$ odeling of $C D$ [2, 3], Technicolors [4] and strong coupling $m$ odels w ith spinless scalarbosons [5]. T he $m$ odels in tw o later cases represent the dynam icalaltematives to Standard m odel $H$ iggs $m$ echanism. These $m$ odels can break sym $m$ etry but avoid the introduction of negative scalar boson $m$ ass term for this purpose.

In QCD, this is certainly the asym ptotic freedom and its associated regulating character of the ultraviolet $m$ odes which $m$ akes chiral sym $m$ etry breaking physically $m$ eaningful. The same is assum ed to be valid for Technicolor, how ever where the typical scale is readjusted about a few orders ofm agnitudes. In possible strong interacting $H$ iggs extensions of Standard $m$ odel the $m$ echanism can be di erent since it could follow the ultraviolet com pletions of such m odels. In general, the m echanism is not com pletely understood but it is expected it can be quite exotic as m other strong interacting theory can be [6]. H aving no direct experim ental hints which $m$ echanism ofm ass generations the N ature has chosen, we can construct models based on e ective interactions. The should describe correctly physics until som e energy scales, above this, the underlying but unknow $n$ theory is assum ed to be valid.

In this paper we m ake a look on a sim ply approxim ated gauge theory of unspeci ed sym $m$ etry and regularize the high energy m ode by Pauli-V illars regulators. The P auli-V illars regulators then can be interpreted as the e ect of physically hidden sector which e ects is observed rather indirectly in the physical spectrum. Very recently, the old fashionable idea of $W$ ick and Lee [7] has been reopened in [8]. To this point we consider strongly interacting theory and extend the technique of Fukuda-K ugo solution [G] of gap equation to the case of $P$ auli-V illars regularization. W e consider su ciently heavy gauge boson w ith m ass satisfying $<$, where is P auli- V illars regulator. To see, what is the physical pole $m$ ass of ferm ion which received its $m$ ass dynam ically, we $m$ ake a continuation of the Schw inger-D yson equation to the tim elike axis of $m$ om enta $p^{2}>0 . W$ efound rather nontrivial results depending on the $m$ ass ratio $=$.

T he layout of the paper is as follow s. Section II is devoted to the overview ofFukuda-K ugo (tim elike) ladder ferm ion SDE w ith hard cuto regularization. The results $w$ ith $m$ assless and $m$ assive gauge boson propagators inside the loop of SDE are obtained by the direct solution of the original integral equation. T he absence of ferm ion poles has been actually con m ed in the region predicted by the authors of [ g ], how ever, in the light of our further discussion we di er in the interpretation. In Section III we do the same for the equation $w$ ith $P$ auli-V illars regulator. The num erical solution is shown in Section IV . C ontrary to the naively regularized ladder QED, the real ferm ion pole has been alw ays identi ed, at least for nonvanishing. N ote, the case of van ishing boson $m$ ass is $m$ ore com plicated issue and to this point the reader can see rather recent paper [10] where the study of propagator of con ned quarks has been attem pted. $N$ ote for com pleteness and bearing in $m$ ind the fact that even gluons can reach their $m$ asses dynam ically [12], the technicalm ethod proposed here can be straightforw ardly used for "Q CD w th m assive gluons". In Section $V$ we discuss the possible form of singularities in the context of $L$ orentz invariance constraint. In C onclusion (Section VI) the basic results are sum $m$ arized and further directions of research $w$ ithin this approach are outlined.

In this paper we w ill use the follow ing conventions: the positive variables $x ; y$ will represent the square ofm om enta in the whole $M$ inkow ski space, i.e. for instance $x=p^{2}$ for tim elike $m$ omenta when $p^{2}>0$ while $x=p^{2}$ for
$\mathrm{p}^{2}$ in spacelike region. N ote, our m etric is $\mathrm{g}=\operatorname{diag}(1 ; 1 ; 1 ; 1)$. For purpose of clarity we label the $m$ ass function $B$ as $B_{s}$ in the spacelike region of fourm om enta and as $B_{t}$ when evaluated for tim elike fourm om entum (i.e. $\left.B\left(p^{2}\right)=B_{s}(x)\left(p^{2}\right)+B_{t}(x)\left(p^{2}\right)\right)$.

## II. MASKAWA-NAKAJIMA/FUKUDA-KUGOEQUATION

In this Section we review som e basic facts on the M askaw $\mathrm{a}-\mathrm{N}$ aka j m a/Fukuda- K ugo equation. This equation represents ladder approxim ation of the ferm ion SD E w th the $m$ om entum integration is regulated by an upper boundary cuto $=\mathrm{p}_{\mathrm{E} ; \mathrm{max}}^{2}$.

In parity conserving theory the ferm ion propagator $S$ can be characterized by two independent scalar function $A$; $B$ such that $S(p)=\left[\begin{array}{ll}A & G P \\ B\end{array}\right]^{1}$ (bare ferm ion propagator is $S_{0}=\left[\begin{array}{ll}6 p & m_{0}\end{array}\right]^{1}$ ). In the ladder approxim ation, the equation for inverse of $S$ can be written

$w$ here $m_{0}$ is a bare $m$ ass and $G$ is boson propagator. The equation Eq. (2.1) and the classi cation of the solutions has been discussed in [11] especially in Landau-like gauge for $w$ hich the $m$ assive propagator reads

Few years later, Fukuda and K ugo have found the solution for the tim elike $m$ om enta for $=0$. They observe no real pole for resulting ferm ion propagator. H ence the absence of free propagating $m$ ode has been interpreted as a sign for con nem ent at that time. First, disregarding the known de ciency of integral cuto regularization schem $e$, we overview the $m$ ethod of solution and resolve (2.1) also for nonzero. Up to our know ledge such solution has never been explicitly published in the literature. W e leave the question of the reliability of 'would be' con ning solution into the discussing section IV ..

In the next we will follow the paper [9], using $A=1$ approxim ation and $m$ aking $W$ ick rotation and angular integration (see A ppendix A) we get

where is the cuto and where $C=3 g^{2} C_{2}(R)=4{ }^{2}, C_{2}(R)$ denotes the $C$ asim ir invariant of the quark representation $\left(C_{2}(R)=4=3\right.$ for $\left.Q C D\right)$. The equation (2.3) can be quite easily solved by the $m$ ethod of iteration avoiding thus inconvenient conversion to the nonlinear di erential equation. W hen $\mathrm{m}_{0}=0$ but $\mathrm{B} \in 0$ we talk about dynam ical chiral sym $m$ etry breaking.
$H$ aving kept the solution $B_{s}(y)$ for spacelike $y$ we can de ne the 'synthetic ferm ion $m$ ass' $\hat{B}(x)$ at tim elike axis of foum om enta such that $\hat{B}(x)=B_{s}(x)$ is a solution of integral (2.3) for tim elike $x$ :

which represents correct continuation until the rst singularity is crossed on the tim elike axis of ${ }^{2}$. The continuation on the usual physical cut of tim elike $m$ om enta $x>(m+)^{2}$ reads

and note the presence of Feynm an in nitesim ali", which has been om itted in the originalpaper [9].
To see this continuation was correct let us assume the sm oothness of B at the vicinity of the pole $y=m{ }^{2}$, i.e. $B_{t}^{2}\left(m^{2}\right)=m^{2}$. Then one can use the functional relation

where stands for the standard $H$ eaviside step function. C learly, ( 2.8 ) represents one loop perturbation theory result when $C$ is a $s m$ all param eter, $3 C=4 \ll 1$.

In general one have to solve the Eq. (2.5). A ssum ing sm oothness of the function B the equation (2.5) can be rew rilten as follow s:

The Eq. (2.9) represents integral inhom ogeneous equations (even for zero $\mathrm{m}_{0}$ ) w ith the one singular kemel in the integrand of I. It can be solved by a standard num ericalm ethod and we provide som e details in the A ppendix B. The dynam ical chiral sym m etry breaking is of great interest for us and we will concem on these solutions in this paper. Inclusion of sm all explicit chiralbreaking term is straightforw ard and we leave this case aside of our interest.

In order to scale the dim ensionfull quantities we take $=1$ in arbitrary units. Further, the num erical hard cuto is adjusted to be $=e^{5} r 148$. Its value constraints the m eaningfil region of the square of foum om enta as $\mathrm{p}^{2} 2\left({ }^{2} ;{ }^{2}\right)$. T he num erical solutions for various coupling constant are presented in F ig. 1.

A s expected already from the discussion in [9] there are several phases of the theory. They have been con $m$ ed and actually found also here. $T$ hey are as follow $s$ :
I. Chiral sym $m$ etric phase-for the coupling bellow the critical value ${ }_{c}$, there is only trivial solution $B=0$.
II. Chiral sym $m$ etry breaking phase, where the propagator has a real pole. In this case we get also nontrivial solution for $B$. For our param eters ; this phase is characterized by the coupling strength $2(c ; 1: 4)$ and the pole m ass m is at m ost of order. In fact, we can observe and have found two solution for $=1: 4$. A though num erically they both cut the axis $\overline{p^{2}}$, the one of them only sw eep the region under the diagonaland their tim elike high energy asym ptotic crucially di er. O fcourse, the question of uniqueness of such continuation naturally arises.
III. Chiral sym $m$ etry breaking phase above $=1: 4$, where the $m$ ass ratio $m=\prime 4: 2$ (and $\underset{\sim}{B}(0)$ ( 3 ) is achieved, the pole and associate analytical cut vanish and the $m$ ass function blow $s$ to 'in nity' like ( $p^{2}$ ) for large $p^{2}$. N ote, no sign of such transition is observed in the spacelike regim e. C learly the spacelike solution does not re ect dram atic changes that happen in tim elike part of the $M$ inkow ski space. The solutions in the regim e III. have been originally called 'con ning' because of the absence of real pole and associate particle production threshold. In fact we have to be m ore carefill w ith the interpretation, particularly because the $W$ ick rotation is not allow ed, the rotation of the contour cross the singularity at tim elike $m$ om entum in nity. $C$ learly, in this case the hard cuto regularization of the $m$ om entum integral does not com $m$ ute $w$ ith the $W$ ick rotation and there is neither con dence that we obtain a true solution in the whole $M$ inkow ski space. This is because we are dealing with non-asym ptotic free theory where the result are not independent on the UV integral cuto. W e argue here, the "w ould be" con ning solution would be $m$ eaningful only when the theory is de ned in the Euclidean space from the beginning. C learly, this is not the case of ladder Q ED and the observed nontrivial solution can be an artifact of given schem e. A lthough we suppose that these things are rather well known, we discussed them explicitly here for the purpose of clarity.

## A . M assless vector boson

The solution for $m$ assless vector boson has been rstly obtain in [G]. For this purpose the authors of the paper [9] transform the integral equation into the di erential one which has been solved num erically. Here we con m their solution by direct solution of the original integral equation. Taking a lim it ! 0 in Eq's (2.3) and (2.9) is straightforw ard. The SDE for selfenergy in the $m$ assless case $\left(m_{0}==0\right)$ then reads

where $N_{C}$ is the num ber of colors and where we have already om itted intensi $m$ al im aginary prefactor i" since as it is known that the equation $y B_{t}^{2}(y)=0$ has no real roots in hard cuto theory. The inhom ogeneous term in (2.13) is sim ple constant-the usual ferm ion condensate:

The num erical results are shown in $F$ ig. 2 for three distinct values of the coupling constant. Sim ilarly to previously discussed region III ofm assive boson case the results could be interpreted w ith a great care. A gain the $W$ ick rotation invalidates because of naive regularization schem $e$ and the resulting tim elike high m om entum behaviour can be an artifact of inappropriate calculation schem e.

## III. DYNAMICALMASSGENERATION W ITH PAULI-VILLARSREGULARIZATION

In this Section we consider the ferm ion gap equation regularized by $P$ auli-V illars regulator function. Such construction is very straightforw ard in our approxim ation since it achieved by the replacem ent of the gauge boson propagator by the sum of ordinary, i.e. original one propagator, and the "w rong sign" boson propagator but $w$ ith $P$ auli- $V$ illars $m$ ass instead of . Explicitly, we m ake the follow ing in the kemel of the gap equation

W thin a nite we do not consider the hard cuto, which is form ally rem oved from now. and where we have also introduced e ective gluon m ass .
In order to safely de ne the pole ferm ion $m$ ass we consider $m$ assive boson case in presented study. W e suppose that the tim elike singularity can be drastically changed due to the presence of strong interaction and we leave this com plicated problem for separate num erical search and discussion elsew here. H ow ever, as usually we assum e no dynam ical singularities in the ferm ion propagator in the rst and the third quadrant of com plex $p^{2}$ plane. It not even allow s to perform standard $W$ ick rotation, but the $m$ ain advantage of presented $m$ ethod is that we can readily follow the Fukuda-K ugo trick and $m$ ake the continuation to the tim elike axis.

D oing this explicitly we get for spacelike solution:

The equations (3.3) have been solved num erically by the $m$ ethod of iterations, som e useful details conceming the num erical treatm ent can be found in the A ppendix.

Rem ind here known feature of QCD scaling: the constituent quark masses are of the sam e size as the QCD scale, i.e. B (0) ' . In this paper, for any reason, we freely focus on a larger region of param eter space providing us
 solutions in Fig. 3-6. Form ost of the solutions we $x$ the $m$ ass ratio to be ${ }^{2}={ }^{2}=10$, the exception is explicitly $m$ entioned. The critical value of the coupling has been identi ed $c^{\prime}$, 3:8, bellow that we do observe the trivial solution only. In Fig. 3 the num erical solution is plotted for the coupling strength $=4: 0$. Being rather close to the critical value $c$, the quark propagator has a one realpole at som e point $m$ which value is very closed to the infrared $m$ ass $B(0)$. W ithout any doubt, the constituent $m$ ass can be freely identi ed $w$ ith the infrared $m$ ass or $w$ th the pole one. In Fig 4. the solution for $=5$ is show $n$ and we observe that propagator develops two realpoles under the rst branch point. The absonptive part of $B$ is largely enhanced because the both di erentiations $d B(m)=d m$ are not so far from 1 (see Eq. (3.3) ). Such solution is possible since the boson is $m$ assive, how ever it $m$ ay be an artifact of our approxim ation. The observation of two pole solutions is in agreem ent $w$ ith sim ilar observation $m$ ad in [13], how ever we regard this as a curiosity rather then possible physical scenario. Increasing the coupling firther, then the second pole vanishes at som e point and we retain $w$ ith the one realpole solution again. This situation is exhibited in $F$ ig 5 . p N ote, the propagator becom es largely enhance bellow m , since the function $\mathrm{B}_{t}$ lies very closed to the diagonal of
$\overline{p^{2}} ; B_{t}$ graph. C ontrary to the case of solutions $w$ ith tw o poles, the im aginary part of $B$ appears to be suppressed now, because of di erentiation $B^{0}(m)<0$. In that case the pole $m$ ass largely di er from the infrared value $B(0)$, it is typically few tim es higher.

## IV . D ISCUSSION OF THERESULTS

In this section we continue the discussion of the results and qualitatively com pare $w$ th the already know $n$ results presented in literature. We also discussed the location of the poles in the com plex plane and its relations with the violation of Lorentz invariance.

In QCD w ith chiralquarks the asym ptotic freedom ensures the niteness of dynam ically generated $m$ asses $w$ thout any use of regularization schem e . In our case the in nity is regulated by the P auli-V illars term induced by auxiliary unphysical eld added to the Lagrangian, hence the $m$ ass function would be nite even when the bare $m$ ass is added. A s we have checked explicitly for $s m$ all bare $m$ ass, it a ect the ultraviolet behaviour of the $m$ ass function but has a little e ect in the infrared and the singularity structure rem ains the sam e. The $m$ ain result of our paper is the num erical observation of the fact that the real singularity is never absent in our translation invariance preserving calculation scheme. The singularity is a real pole for large param eter space of ; and How ever approaching the $\lim$ it of vanishing boson $m$ ass, the pole is going to $m$ eet the branch point and the situation is getting $m$ ore com plicated. In F ig. 5 the result is plotted for a sm all ratio ${ }^{2}={ }^{2}=0: 001 . W$ e should note that the exact $m$ assless lim it $m$ ay not be well de ned in approach presented here so that Fukuda-K ugo continuation m ethod is not fiully justi ed in this case. Recall, the functionalused in our equations is de ned on the set ofdi erentiable functions, while in contradiction, the di erentiation $B^{0}(\mathrm{~m}) \mathrm{m}$ ay not exist in the exact m assless case $=0$. The zero boson m ass case w ill be studied elsew here due to its ow n serious physical consequences.

Stating w thout proof, we suppose that true $m$ ass generation and the evidence of nontrivial pole of the ferm ion propagator go hand by hand w ith the property of asym ptotic freedom (decreasing ofe ective coupling at ultraviolet), whilst the absence of real pole as happened to the propagator function in Fukuda-K ugo equation is artifact of im proper calculation schem e (hard cuto regularization). Further note, the num erical results obtained here qualitatively correspond w ith the results of the papers [13], where the sam em odel was studied in the M inkow ski space for the rst time. At this place we discuss som e com m on and som e distinct features of solutions presented here and in the paper [13]. In both approaches the validity of W ick rotation is assum ed. In other words, no (dynam ically generated) com plex singularities are assum ed in the rst and the third quadrant of ${ }^{2}$ com plex plane. Them ain distinction is the analyticity assum ption explicitly used in the paper [13], w here it was assum ed that the propagator is holom orphic in the whole $p^{2}$ com plex plane up to a realpositive sem i-axis and that the propagator satisfy certain integral (generalized spectral) representation. To this point, there is no sim ilar assum ption in the approach developed by Fukuda-K ugo and followed in presented paper. In the $m$ ethod presented here the correlator at tim elike regim e of fourm om enta is built on a base of the know ledge of its spacelike counter-partner. H ow ever, being possibly out of the dom ain of analyticity we should be aw are that such continuation is by no mean unique. On the other hand, there is also reasonable quantitative agreem ent w ith [13], especially when we are not far form the critical coupling characterizing dynam icalchiralsym $m$ etry breaking. A ctually, depending on the coupling strength the propagator develops one or tw o realpoles w ith corresponding branch points providing their values are in an approxim ate agreem ent w ith [13].

In the literature there is a certain e ort to guess the com plex structure of $\mathrm{Q} C \mathrm{D}$ G reen's fiunction by the $m$ ethod of continuation of Euclidean result or by indirect reading from the phenom enological consequences which would follow form particularly assum ed singularity structure of $G$ reens fiunctions. Complex conjugated singularities of quark and
ferm ion propagator in planar strong coupling QED have been considered in the context of con nem ent [14] and in P T sym $m$ etric $Q$ uantum $F$ ield theory [15]. A dditionally recent studies have $m$ odeled Euclidean space lattice data $w$ ith propagators that have com plex con jugate singularities [16, 17]. M ore phenom enologically, the m eson bound states [18] and the parton distributions [19] has been calculated with a quark consisting of pairs of com plex four $m$ om enta. In $m$ any, if not at all of these recent studies, the fact that com plex singularity structure can a ect the Lorentz invariance of the theory has been overlooked. Therefore, in what follow we m ention the question of $W$ ick rotation, location of com plex poles and possible lost of Lorentz invariance in order to pay attention for.

A ctually, increasing the coupling strength one can expect that apart of the real pole a new com plex singularities appear. The area of real part of $p^{2}$ where we can expect new complex singularities in the propagator function is indicated by the ellipses in Fig. 6. In recent, we are not able to estim ate the characteristic of the behaviour and/or the position of these com plex singularities w ith good con dence. Instead of this, w ew ould like to present the argum ent which largely enforces our believe in the validity of $W$ ick rotation in a case of full realistic solution of Schw inger-D yson equations. R ecall at this place, there is know $n$ relation betw een location of com plex singularities of $G$ reens functions and the Lorentz invariance of the theory. Indeed, its m ore than 30 years known that com plex singularities located sim ultaneously on both side of the realaxis of $p^{2}$ autom atically generates Lorentz violating peaces in the propagator itself [20]. In th is case the naiveW ick rotation invalidates and one has to account the com plex singularities in a suitable $m$ anner. A ctually, assum ing the com plex poles (w ith non vanishing Im part) one can exhibit the existence ofLorentz violating pieces originally not expected in. T he evaluation of the appropriate Feynm an integral has been exhibited for the case of com plex conjugated poles in [20] (som e prefactor has been corrected in the paper 21], the actual evaluation has been perform ed for scalar eld content only, the extension to the loop integralw ith intemal ferm ion links is rather straightforw ard) due to the rather di erent reasons. The generalization to $m$ ore general locations of singularities were already discussed in [20]. From these argum ents it follow $s$ : if the true exact solution respect the Lorentz invariance of the theory then selfconsistence of the $S c h w$ inger-D yson equation solution for quark propagator can not involve com plex poles on the both sides of the real axis of the square of the foum om entum. In Lorentz invariant theory, the $W$ ick rotation is indirectly justi ed in this way.

## V. CONCLUSION

Them odelwe have described, is of course not true QCD and hence we do not claim that the ferm ion propagator we have studied here is truly representative of the singularity structure of the quark propagator. In a m ore realistic m odels, which include the dressed vertex unction and/or higher order skeleton graphs, one expects that the details of the propagator structure would be di erent. It should also inconporate the aspect of asym ptotic freedom in a $m$ ore proper way. H ow ever, our study dem onstrates that singularity structure of the quark propagator is very likely dom inated by the real singularity and we expect a quantitative but not a qualitative changes when the approxim ations im prove. W e discuss possible singularity structure in the entire com plex plane ofm om enta. W e argue, in the Lorentz covariant form ulation of QCD (and any QFT) the singularties of the propagators (and of integral kemel of gap equations at all) $m$ ust appear only on the one side -upper or dow $n$-separately for the left and the right half com plex plane. O therw ise we necessarily sacrify Lorentz invariance of the theory. T his argum ent strongly support the validity of W ick rotations in Lorentz invariant theory.

To avoid som e unw anted num erical uctuations which usually stem from asym $m$ etric distribution of $m$ esh points when $P$. integration is num erically perform ed, w e use a standard trick. C onsider for th is purpose the third ofconsidered $m$ om entum regin ewhere $x$ runs over the interval $\left((+m)^{2} ;(2+m)^{2}\right)$ (see B4b). In our num erical treatm ent the integral is replaced by a discrete sum $w$ th the appropriate ( $G$ aussian) weights, i.e.

where the later two term s vanishes in the exact continuum lim it. W e have found this approach is very stable and the pole $m$ ass $m$ can be identi ed after few runs of the iteration program. In order to achieve better stability, the actual search of the root of equation $B(x) \quad x=0$ has been perform ed by hand for each solution. A fter $m$ aking a few iterations in $m_{j}$ then the achieved num erical accuracy of our search is estim ated by $m$ ' step=m where 'step' $m$ eans the di erence of tw o neighboring points at vicinity ofm. Likew ise in the case of SD E in Euclidean space, the integrals w ere cut by the ultraviolet cuto .

G eneralizing to the case of Eq. (3.3) is rather straightforw ard. The principal value integration is treated in the sam e fashion as in the case ofFukuda-K ugo equation. $N$ ow the relevant term reads
