Landscape of Little H ierarchy

A bstract

We investigate the little hierarchy between Z boson m ass and the SUSY breaking scale in the context of landscape of electroweak sym m etry breaking vacua. We consider the radiative sym — metry breaking and found that the scale where the electroweak sym metry breaking conditions are satisted and the average stop mass scale is preferred to be very close to each other in spite of the fact that their origins depend on dierent parameters of the model. If the electroweak sym metry breaking scale is xed at about 1 TeV by the supersym metry model parameters then the little hierarchy seems to be preferred among the electroweak sym metry breaking vacua. We characterize the little hierarchy by a probability function and the mSUGRA model is used as an example to show the 90% and 95% probability contours in the experimentally allowed region. We also investigate the size of the Higgsino mass by considering the distribution of electroweak sym metry breaking scale.

1 Introduction

One of the key motivations for supersymmetric (SUSY) extension of the Standard Model (SM) is the stabilization of the large hierarchy between the Planck scale and the weak scale. A lthough the SM particle spectrum gets doubled in the SUSY extension, these new particles around the weak scale add an additional attraction for SUSY theories by unifying gauge couplings at the grand uni ed scale [1]. However, the new particles are not yet to be seen. Neither the LEP nor the Tevatron is successful so far in their attempts to discover these particles, and the search attempts have already exceeded the Z boson mass scale. The SUSY extension which is invoked to explain the electroweak scale seems to require most of the superpartners above the electroweak scale. In the SUSY breaking models mediated by minimal supergravity (mSUGRA) [2, 3], where the squarks and sleptons masses are unied at the GUT scale, the average stop mass scale is about 1 TeV or above. Question now arises regarding the justication of the heavy superpartner masses. Can this little hierarchy between the Z boson mass and the superpartner masses be rationalized in these models?

We need to understand rst the relation between the SUSY breaking m asses and the Z boson m ass. The electroweak sym m etry breaking relates the SUSY breaking m ass scale to the Z boson m ass, M $_{\rm Z}$. At the tree level, the m inimization of the Higgs potential gives rise to M $_{\rm Z}^2$ =2 ' $_{\rm H_u}^2$ in the large tan limit, where $_{\rm H_u}$ is the SUSY breaking m ass for up-type Higgs boson, and is the Higgsino m ass which is the coe cient of the bilinear term in the superpotential. Since $_{\rm IM}^2$ is of the order of the stop m ass scale, the natural expectation is that M $_{\rm Z}$ is as large as stop m ass, unless there is a cancellation. One can quantify the amount of cancellation by a sensitivity function and nds that smaller (and therefore small $_{\rm IM}^2$ is needed [4]. One can then conclude that the hierarchy between the SUSY breaking m ass scale and Z boson m ass is not preferred unless 2 and $_{\rm H_u}^2$ are related in a given SUSY breaking m odel. This is called naturalness of the electroweak sym m etry breaking.

In order to determ ine the possible location of the SUSY breaking mass scale, we need to go back to the origin of the SUSY models. The SUSY models are expected to arise from well motivated string theory. String theory has many vacua and one expects to have wide range of possibilities of the SUSY model parameters in these vacua [5]. The SUSY parameters can be the vacuum expectation values (VEVs) of the moduli elds. Many of these vacua can give rise to the SUSY extension of the SM where the electroweak symmetry is broken. One can then ask about the distribution of the model parameters in these vacua once the requirement is made that the electroweak symmetry has to be broken. Can one understand the hierarchy between the SUSY breaking mass scale and the Z boson mass from the distribution of the model parameters? One can also ask whether the same conclusion as naturalness holds if a

distribution function of the $M_Z = m_{H_u}$ jhierarchy is considered. The distribution functions are needed more than the sensitivity function in the context of statistics of vacua.

So far we did not include the features of radiative symmetry breaking [6] in our discussion. Since the theory is not nite, one needs to care about large log correction in the symmetry breaking conditions. The SUSY breaking mass squared, $m_{H_{\rm u}}^2$, is driven to be negative at low energy by the renormalization group ow and that leads us to satisfy the electroweak symmetry breaking condition. The radiative symmetry breaking connects the stop mass scale to the Z boson mass in the following way. The symmetry breaking condition (i.e., $m_{H_{ij}}^2$ satis ed at a scale Q₀. The tree-level Z boson mass, M $_{\rm Z}^2$ (Q) ' $2 \left(m_{\rm H_{\, 0}}^2 + {}^2 \right)$ (Q), depends on the renormalization scale, Q. The proper Z boson mass is given approximately at the averaged stop mass scale Qt where the correction from 1-bop Higgs potential is negligible. Those two scales, Q_0 and Q_r , are unrelated in general, and the electroweak symmetry is broken when $Q_0 > Q_t$. Now expanding the tree-level Z boson mass, M $_{\rm Z}$ (Q), around the scale Q_0 , one gets M $_{\rm Z}^2$ / $\ln (Q_0 = Q_t)$. Consequently, the scales Q_0 and Q_t need to be close by when the average stop m ass is about 1 TeV. So instead of looking for a reason to explain the smallness of $M_{\rm Z} = M_{\rm H_u}$ j, we need to understand the proximity of the scales Q_0 and $Q_{\rm T}$. We therefore direct our investigation to the distribution of the scales Q $_0$ and Q $_t$ in the context of the statistics of vacua.

We consider the distribution of the hierarchy between M $_{\rm Z}$ and Q $_{\rm t}$, and determ ine the distribution function assuming that the any SUSY breaking vacuum is equally probable. We determ ine whether the proximity of Q $_{\rm 0}$ and Q $_{\rm t}$ is natural in a large number of vacua. If this closeness is enough probable in the landscape of the electroweak symmetry breaking vacua, the hierarchy between the SUSY breaking scale and M $_{\rm Z}$ can easily be rationalized when Q $_{\rm 0}$ is at TeV scale due to a model parameter. It is also interesting to determine the sensitivity function of the Q $_{\rm 0}$ =Q $_{\rm t}$ hierarchy and compare it with the distribution function. We also determine the probability of a given hierarchy between the Q $_{\rm t}$ and M $_{\rm Z}$ in mSUGRA model and show 90% and 95% probability contour in the experimentally allowed parameter space. The average of the ln (Q $_{\rm 0}$ =Q $_{\rm t}$) is considered in a recent reference [7] in the context ofmultiple vacua and it was shown that the Q $_{\rm 0}$ should be close to Q $_{\rm t}$ scale. We propose to use the probability function to describe the amount of little hierarchy in this paper.

It is not only interesting to investigate the distribution of Q_t to understand the little hierarchy, but also important to investigate the size of other parameters, especially the size of , which is claimed to be small for naturalness. To investigate the size of , there is another important scale Q_H in addition to the scales Q₀ and Q_t. The Q_H is the scale where m $_{\rm H_u}^2$ becomes negative. By de nition, Q_t < Q₀ < Q_H for the electroweak symmetry breaking vacua.

The hierarchy between Q_0 and Q_H determ ines the preferred size of and therefore the size of can be understood for the distribution of $Q_0 = Q_H$. To obtain \natural vacua" (or small), all three scales need to be close by. It is also interesting to inquire about whether there are lots of natural vacua among the landscape of electroweak breaking vacua varying the model param eters.

The paper is organized as follows. In section 2, we address the little hierarchy problem. In section 3, we discuss the conditions of the electroweak symmetry breaking and determine the sensitivity function of little hierarchy. In section 4, we describe the little hierarchy problem in the landscape of electroweak vacua and determine the probability function of little hierarchy. We also determine the 90% and 95% probability contours in the mSUGRA model including the experimental constraints. In section 5, we discuss the landscapes of dierent scale associated with the electroweak symmetry breaking vacua and study the possible size of , and section 6 contains our conclusion.

2 Little Hierarchy Problem

The little hierarchy problem is often described by using a sensitivity function [4]. One can quantify the ne-tuning in the minimization condition of Higgs potential by the sensitivity function and concludes that small Higgsino mass is needed for natural electroweak symmetry breaking. However, distribution functions are more appropriate rather than the sensitivity function in the context of statistics of vacua. In this section, we discuss the distribution function of the hierarchy for the tree-level condition to see whether the same conclusion also holds.

The tree-level Higgs potential is given as

The quartic term is obtained by D -term and thus the coupling is related to the gauge couplings. The quadratic term s are given by SUSY breaking H iggs m asses, m $_{\rm H_d}^2$ and m $_{\rm H_u}^2$, H iggsino m ass and SUSY breaking bilinear H iggs m ass B : m $_{\rm 1}^2$ = m $_{\rm H_d}^2$ + $_{\rm 1}^2$, m $_{\rm 2}^2$ = m $_{\rm H_u}^2$ + $_{\rm 2}^2$ and m $_{\rm 3}^2$ = B . M in in izing the H iggs potential by H iggs VEVs ($v_{\rm d}$ = hH $_{\rm d}^0$ i, $v_{\rm u}$ = hH $_{\rm u}^0$ i), we obtain

which corresponds to the conditions M $_{\rm Z}^2$ > 0 and sin 2 < 1 in Eq.(2). The second condition is obtained by the stabilization of the H iggs potential along the at direction, $jv_{\rm u}j=jv_{\rm d}j$. The Z boson m ass can be expressed as

In the radiative electroweak sym metry breaking scenario [6], the condition Eq.(3) is satised at the weak scale by renormalization group equation (RGE). The SUSY breaking scalar mass squared for up-type Higgs, $m_{H_u}^2$, is driven to a negative value by large top Yukawa coupling. Naively, $m_{H_u}^2$ is of the same order as the stop and gluino masses at weak scale (especially, when the SUSY breaking scalar masses are assumed to be universal), and consequently, the Z boson mass is of the same order as the SUSY particles. The colored particles are expected to be heavier than sleptons, wino and bino due to the RGE excts using naive boundary conditions at the Planck or the GUT scale. In other word, the uncolored SUSY particles should have been observed in LEP2 experiment. Non-observation of the uncolored superparticles leads stop and gluino masses to be much heavier than the Z boson mass (especially when the gaugino masses are united at the GUT scale). Moreover, the lightest Higgs mass bound ($m_h > 114.4 \text{ GeV}$) pushes up the stop mass or the trilinear scalar coupling for stop A_t.

Surely, there is a freedom of cancellation in Eq.(5), and there is no problem with the electroweak symmetry breaking even if SUSY particles are much heavier than the mass of the Z boson. However, the cancellation seems unnatural as can be seen in the following discussion.

The sensitivity function to measure the ne-tuning is de ned as [4]

When [f(x)] is small, the function f is sensitive to x and the degree of ne-tuning is large. The sensitivity for the Z boson mass is calculated from Eq.(5) as $M_z(x) = M_z^2 = (2^{-2})$. The parameter needs to be small to generate less sensitivity. This is the usual naturalness statement. When

is much larger than the Z boson mass, the ne-tuning is severe. For example, when M $_{\rm H}=500$ G eV , the sensitivity M $_{\rm Z}$ ()] is about 2% .

In order to describe the SUSY parameters in terms of the statistics of vacua, in this paper, we suggest that the distribution function and the probability function are more appropriate rather than the sensitivity function.

Let us calculate the distribution function of the M $_Z$ -M $_H$ hierarchy (r_H M_Z =M $_H$). A ssum e that any H iggsino m ass is equally probable (D [] = const). Then one obtains the distribution function of r_H as

by using the relation dP = D [r_H]d r_H = D []d . The distribution function is normalized to make D [r_H]d r_H = 1. Since the distribution function books dierent by measure, we should use the probability function by integrating the distribution function to avoid a bias for the choice of measure. The probability for r_H > r_0 is given as

So, the probability for M $_{\rm H}$ < 2M $_{\rm Z}$ is calculated to be 93% . The probability for M $_{\rm H}$ > 200 G eV (500 G eV) is only about 5% (1%).

Since the parameter is complex in general, the proper distribution function of may be D [j \mathring{J}] = const (or D [] /) if any complex value is equally probable. In this case, the distribution function is D [r_H] = r_H and the probability function is P [r_H < r₀] = r₀²=2. The probability function can be written as M $_Z^2$ = (2M $_H^2$) which naively corresponds to [M $_Z$ ()]. The probability for ne-tuning is relaxed than before: The probability for M $_H$ > 200 G eV (500 G eV) is about 10% (2%). We note that the complex does not mean CP violation directly since the phase of can be rotated out by the eld rede nition of Higgs elds when B parameter is real.

M ore generically, the probability function is

when D [$^{\rm m}$] = const, and the probability can be written approximately m M $_{\rm Z}^2$ = (4M $_{\rm H}$ 2) in the ne-tune region, which naively corresponds to the sensitivity function of [M $_{\rm Z}$ ($^{\rm m=2}$)]. Therefore, naturalness statement holds and the little hierarchy is not rationalized even if we use the probability function when is distributed.

There are mainly two directions to solve the little hierarchy problem. In one direction one needs to select a suitable mass spectrum of SUSY particles at low energy. For example, if squark, sleptons and wino are naturally heavier than the SUSY breaking Higgs mass M $_{\rm H}$ in a SUSY model, the LEP2 experiments do not con ict with the ne-tuning. In this case, a favorable SUSY breaking scenario will be chosen such as mirage mediation model [8, 9].

The other direction is to reconsider the distribution of parameter and to see what is a suitable parameter to distribute in order to discuss the ne-tuning in electroweak symmetry breaking. In this paper, we investigate this direction.

3 Conditions of Radiative Electroweak Symmetry Breaking

In the previous section, we only study tree-level conditions, Eq.(2), which do not include the conditions that the sym metry breaking is radiatively induced. Let us describe the conditions of the radiative electroweak sym metry breaking.

As we discussed, it seems that the ne-tuning is needed in Eq.(5) and the ne-tuning has less probability. At what scale do we need the ne-tuning? Since the mass parameters are running, we have to x the scale where we need ne-tuning. The minimization conditions, Eq.(2), are given in the tree level for a given scale Q. There exists a 1-loop corrected potential [10],

where J is a spin of the matter. Since m_J depends on the Higgs VEVs, we need to include the derivatives of 1-loop potential in minimization of the Higgs potential. We can use a scheme that the scale Q is chosen to make the derivatives of 1-loop potential $(V=(v_{ux})^2)^2$ to be small [11]. One can not that the scale is a geometrical average of the stop mass, $(Q_t)^2$ ($(m_{t_1}, m_{t_2})^{1-2}$). As a result, the tree-level relations Eq.(2) are approximately satisfied at the scale $(Q_t)^2$, and the electroweak symmetry breaking conditions Eqs.(3,4) need to be satisfied at $(Q_t)^2$. Defining the scale where the electroweak symmetry is broken (Eq.(3) is satisfied) as $(Q_t)^2$, and the scale where the stability condition Eq.(4) is violated as $(Q_t)^2$, we can obtain the window of radiative electroweak symmetry breaking as




Figure 1: RGE evolutions of 2 and $m_{\rm H\,_u}^2$ are plotted as functions of the scale Q (G eV). The H iggsino m ass is chosen to make Q $_0$ = 1 TeV . The proper Z boson m ass is evaluated at the scale Q $_{\rm t}$.

The true Z boson mass is given as M $_{\rm Z}^2$ ' M $_{\rm Z}^2$ (Q $_{\rm t}$). By de nition, M $_{\rm Z}^2$ (Q $_{\rm 0}$) = 0. Therefore, expanding the function around Q $_{\rm 0}$, we obtain

where S is a trace of scalar masses with hypercharge weight. Approximately, we obtain

neglecting gauge couplings g^0 , g_2 , and bottom , tau Yukawa couplings y_b , y .

The interpretation of Eq.(15) is illustrated in Fig.1. In Fig.1, the SUSY breaking mass parameters in mSUGRA are made to be dimensionless unit since the RGE evolution does not depend on overall scale factor. As it is obvious from the gure, the little hierarchy is characterized by the smallness of the triangle. The little hierarchy problem can be rephrased in terms of the question why the size of the triangle is small. There are two ways to make the triangle small. The vertical tuning corresponds to the tuning of parameter with xed M $_{\rm H}$

as in the previous section. The parameter tuning is equivalent to tuning Q_0 after xing Q_t . The horizontal adjustment of the triangle corresponds to the tuning of $\ln (Q_0 = Q_t)$.

We stress that the smallness of is not crucial for the little hierarchy due to the fact that m $_{\rm H\,_u}^2$ and $_{\rm L}^2$ are canceled at Q $_{\rm L}$. In that sense, the usual ne-tune quantity $_{\rm L}^2$ ()] = M $_{\rm L}^2$ = 2 $_{\rm L}^2$ does not play a key role to describe ne-tuning in radiative electroweak symmetry breaking when Q $_{\rm L}$ is xed at a TeV scale. We point out that the horizontal adjusting quantity $_{\rm L}^2$ (Q $_{\rm L}^2$) is more important to discuss the little hierarchy in radiative electroweak symmetry breaking. A ctually, one can calculate the sensitivity function of $_{\rm L}^2$ (Q $_{\rm L}^2$) to be

If $\ln (Q_0 = Q_t)$ 0, then $[M_Z(Q_t)]$ is small and Z boson mass is sensitive to Q_t .

The question is now whether $\ln (Q_0 = Q_r)^2 \le O(1)$ is natural. Apparently, there is no reason that Q_t is related to Q_0^2 . For example, let us assume that all the mass parameters (including and B) to be proportional to a single mass scale M $_{
m S}$. Namely, the mass parameters in the model are written as m $_{\sigma}^{2}$ = $m_{\sigma}^{2}M_{S}$, m_{g} = $m_{g}M_{S}$, A_{u} = $\hat{A}_{u}M_{S}$, = $^{N}M_{S}$ and so on. The dim ensionless coe cients m^2 , m^2 , m^2 , m^2 , m^2 etc are determined when we x a SUSY breaking scenario. The parameter is also proportional to SUSY breaking scale in Giudice-Masiero mechanism [13] in which the -term is forbidden in the superpotential by a symmetry and the Higgsino massoriginates from the Higgs bilinear term in Kahler potential. In this case, Q_0 does not depend on M $_{\rm S}$ since RGEs are hom ogeneous di erential equations. The averaged stop m ass Q_{t} , on the other hand, of course depends on M $_{\rm S}$. Since the scale $Q_{\rm 0}$ is determined radiatively, it is hierarchically smaller than the grand uni ed scale or the P lanck scale M $_{\rm P}$. Namely, the scale Q $_{\rm t}$ is a dim ensionful param eter, while the scale Q $_{\rm 0}\,$ is expressed as Q $_{\rm 0}\,$ dim ensionless O (1) param eter t. How can those two scales be related? A ctually, in any SUSY breaking scenario, the determ ination of the coe cients and the overall scale are completely di erent issues. W hy Q₀ and Q_r are so close to make $\ln (Q_0 = Q_r)^2 < 0$ (1)? This is an essential question of radiative electroweak symmetry breaking and the origin of SUSY breaking. In addition, when $Q_0 < Q_t$, the electroweak symmetry does not break. It is just like living on the edge of a cli.

 $^{^2}$ W e comm ent that $\ln{(Q_0=Q_t)^2}$ ' 1 is satis ed in the scenario of no-scale supergravity [12] in which the scale Q_t is determined dynamically.

4 Landscape of Electroweak Symmetry Breaking Vacua

Anthropic principle teaches us that we need not worry about the fact that Q_{τ} appears within the window for electroweak symmetry breaking, Eq. (12). So, the question is whether the little hierarchy is natural am ong the electroweak sym metry breaking vacua. To see that, we exam ine the landscape of the electroweak sym metry breaking vacua.

As we have mentioned in the previous section, let us assume that all mass parameters are proportional to single SUSY breaking mass scale such that m $_{\sigma}^{2}$ = m $_{\sigma}^{2}$ M $_{S}^{2}$, m $_{g}$ = m $_{g}^{4}$ M $_{S}^{3}$, $A_u = \hat{A_u} M_S$, = ^M_S and so on. Then, the radiative electroweak sym m etry breaking scale Q_0 does not depend on M $_{\rm S}$ when the dimensionless coe cients are xed. On the other hand, Q $_{\rm r}$ is naively proportional to M $_{\rm S}$. The SUSY breaking mass scale M $_{\rm S}$ is specified by the F-term of a SUSY breaking spurion eld X, as M $_{\rm S}$ / ${}_{\rm F}{}_{\rm X}$ ${}_{\rm P}{}$. If any complex value of ${}_{\rm F}{}_{\rm X}$ is equally probable, the distribution function of M $_{

m S}$. Therefore, as one of the sim plest example, we calculate the distribution function when the distribution of Qt is proportional to Q_r after xing Q_0 .

Now, we calculate the distribution function of the Z boson and the stop mass hierarchy using Eq.(18). The hierarchy $R_t = M_z = m_t$ is given as

U sing the relation, D $[R_t] = D [Q_t]dQ_t = dR_t$, we obtain the distribution function of R_t as

where we normalize the distribution function to make D $[R_t]dR_t = 1$. W hen Q_t the stability condition will break, but we neglect the condition to calculate the distribution function since the distribution for Q_t Q_0 (R_t 1) is exponentially suppressed.

We plot the distribution function D $[R_t]$ in the case $A_t = m_t = 1$ (namely = 9=(4 2)) in Fig. The peak of the distribution is $R_r = {}^{p} = 2$ ' 024: From the distribution, one can nd that a little hierarchy between the stop and the Z boson masses are probable among the electroweak symmetry breaking vacua. When we look at the distribution function of R_{τ}^2 **(**2R D[R] = D[R]




Figure 2: The distribution functions D $[R_t]$ (left) and D $[R_t^2]$ (right) are shown.

it becomes more clear that there is a strong probability for $\ln Q_0 = Q_t$ '0.

U sually, it is said that a small value of [f(x)] is unwanted since f is sensitive for x and a ne-tuning is needed. In fact, for the distribution in the section 2, the probability function naively corresponds to the sensitivity function. However, we have encountered an example where the probability and the sensitivity have dierent qualitative features. Namely, the ne-tuning becomes most probable.

One may think that it boks awkward that ne-tuning is preferable. However, it can happen when we consider a distribution. Let us illustrate it for the distribution of $f(x) = a \ln (1=x)$. A ssume that any x is equally probable for 0 < x < 1. Then y = f(x) is distributed for y > 0 and the distribution function is obtained as D $[y] / \exp(y=a)$. On the other hand, $[f(x)] = \ln (1=x) = y=a$. Therefore, y = 0 is the most probable, while the sensitivity function becomes zero at the point. It can be understood intuitively from the sem i-log graph such as in the Fig.1. The vertical lines are dense for larger values of horizontal logarithm is axis. Surely, y < 0 is more probable than y > 0 if x > 1 is allowed. However, if we compare this example with our model of concern, y < 0 corresponds to the vacua where the electroweak symmetry breaking would not happen. Among the electroweak symmetry breaking vacua, therefore, the ne-tuned vacua are more probable. Furthermore, the distribution for less hierarchy is exponentially suppressed due to the loop factor.

As seen in the Fig.2, the shape of the distribution function looks dierent in dierent measures, dR_t or dR_t^2 . So it is better to use the probability function for a numerical quantity of little hierarchy instead of the distribution function. The probability for $R_t > R_0$ is given by

So, we obtain the probability for $m_{\tau} > 2M_{z}$ (3M $_{z}$) is 89% (62%), and

at 90% probability.

We have assumed that the distribution function of M $_{\rm S}$ is proportional to M $_{\rm S}$ because the SUSY breaking order parameter is complex. When the order parameter is real in the case of D term breaking, the distribution function of M $_{\rm S}$ is constant. In general, if n real components cooperate the overall SUSY breaking scale, the distribution function is D M $_{\rm S}$] / M $_{\rm S}^{\rm n}$ 1 (or D M $_{\rm S}^{\rm n}$) = const), and we obtain the probability function as

In Ref.[7], the authors use an average of R $_{t}^{2}$,

to claim the closeness of the Q_t and Q_0 . The probability that it is more hierarchical than the average is 63% (= 1 1=e), namely, it is about two times more probable rather than that of less hierarchy. Therefore, we propose to use the probability to describe the little hierarchy.

Since the sensitivity function is not the proper quantity in the landscape picture distributing the overall SUSY breaking scale, we suggest to use the probability function Eq.(26) to characterize the little hierarchy. We plot the 90% and 95% probability contours (in the case of n=2) in the minimal supergravity with $A_0=0$ and tan =10;40. To calculate the probability, we only distribute the overall SUSY breaking scale for each m $_0=m_{1=2}$ ratio.

As calculated in Eq.(25), the averaged stop mass is less than 1 TeV at 90% probability. We can see from the gure that the 95% probability region can be tested at the LHC and the future dark matter detection experiments since the SUSY particle masses are not very large. This region lies in the allowed parameter space. The parameter space is constrained by the dark matter constraint [14], the lower limit on Higgsmass, LEP bounds on SUSY particles [15], b! s bound [16] and the muon g 2 data [17].

5 Several Landscapes in M in im al Supergravity

In the m in imal supergravity model [2, 3], the parameters are given as (m₀; m₁₌₂; A₀; ;B). One usually uses B to determ ine tan , and uses to solve M_Z using Eq.(5) at the weak scale. So far, the parameter set is (m₀; m₁₌₂; A₀; tan ;sgn()). In solving the equation for the Z boson




Figure 3: 90% and 95% probability contours (black lines) are shown in the allowed parameter space for tan = 10 (left) and tan = 40 (right). The blue narrow bands are allowed by dark matter constraints. The lightest Higgs mass m_H 114 GeV is in the pink shaded region. The red shaded region is disallowed by the LEP data. The lightest supersymmetry particle is charged in the green region. a 11 10^{10} in the light blue shaded region. The brick red hatched region obeys the 2:2 $10^4 < \mathrm{Br}[b!\ s] < 4:5$ 10^4 constraint. The blue vertical and horizontal line show the ILC (800 GeV) reach in $^0_2 \sim ^0_1$ and $^0_1 \sim ^0_1$ nal states. The black region is not allowed by radiative electroweak symmetry breaking. We use m_t = 172:7 GeV for this graph.

mass by , one may need netuning and the probability of netuning is small as we have seen in section 2.

In the landscape, as we have seen in the previous section, the dimensionless parameters (m₀, $\hat{A_0}$, ^, tan) are given and one dimensionful scale m₁₌₂ is distributed, where m₀ = m₀=m₁₌₂, $\hat{A_0}$ = $\hat{A_0}$ =m₁₌₂, ^ = =m₁₌₂. The electroweak symmetry breaking scale Q₀ is the function of these four dimensionless parameters up to a cuto scale, M_P or M_{GUT}. Once these four parameters are xed, m₁₌₂ is consumed to solve Z boson mass and a ne-tuning may be needed. However, the ne-tuning for the little hierarchy has enough probability among the landscape of electroweak symmetry breaking vacua.

The di erence in above two results depends on what parameter is distributed in the land-scape. In the rst case, $(m_0, A_0, m_{1=2}, \tan)$ is xed and is distributed, and in the latter case, $(m_0, \hat{A_0}, \hat{A_0}, \hat{A_0}, \hat{A_0}, \hat{A_0})$ is xed and $m_{1=2}$ is distributed. In the landscape distributed by , the ne-tuning vacua is less probable, and thus the small is demanded as in the usual naturalness

statem ent. We emphasize that the usual naturalness statem ent is not necessarily applied in the landscape distributed by m $_{1=2}$.

In the anthropic picture, the landscape mostly prefers a little hierarchy irrespective of Q_0 . We are interested in the vacua where Q_0 is at TeV scale in our universe. In the parameter space where Q_0 is at TeV scale, ^ is not necessarily small. A ctually, ^ is almost determined irrespective of m_0 when Q_0 is at a TeV scale in the minimal supergravity since M_H^2 has a focus point around the TeV scale [18]. As a result, the parameter and the CP odd Higgs boson mass can be large with enough probability in the landscape contrary to the usual naturalness statement.

We have xed the scale Q_0 in our discussion of landscape in the previous section. What happens when Q_0 is also distributed? To see that, let us study the distribution of Q_0 as well as the other parameters.

5.1 Landscape of the scale Q_0

Let us $\,$ rst see the landscape of the scale Q $_0$ distributed by $\,$. The scale is given as

The scale dependence of can be written as ${}^2(Q_0) = {}^2_0 I(Q_0)$. Therefore, when any complex value of ${}_0$ is equally probable $(D[j_0]^2] = const$), the distribution of t_0 in Q_0 is

$$D [t_0] = D [_0^2] \frac{d_0^2}{dt_0} = C \frac{d}{dt_0} \frac{M_H^2(t_0)}{I(t_0)};$$

where c is a constant. The parameter may be a function of moduli, e.g. = f(z). Then the distribution is D [] = D [z]df 1 =d . In the case where D [m_0] = const, we obtain

$$D \ [t_0] = c \ \frac{M_H^2}{I} \frac{\frac{m_2}{2}}{dt_0} \frac{d M_H^2}{I} :$$

The maximal value of Q_0 is the scale where M $_H^2 = 0$. We do not this scale Q_H , namely M $_H^2$ (Q_H) = 0. Surely, Q_H does not depend on and the overall mass scale. Since the RGE of m $_{H_u}^2$ becomes larger at lower scale, the large Q_0 - Q_H hierarchy (Q_0 Q_H) is more probable for 2. However, the little hierarchy between Z boson mass and SUSY breaking masses is not very probable as we have seen in section 2.

5.2 Landscape of the scale Q_H

How about the Q_H landscape? The scale Q_H is function of m_0 , $\hat{A_0}$ (in the unit of $m_{1=2}$) and tan . For simplicity, let us choose $A_0=0$ and neglect tan dependence. We parameterize




Figure 4: The distribution of Q_H is shown when $m_0 = m_0 = m_{1=2}$ is distributed. Q_H is the scale where SUSY breaking Higgs mass squared becomes negative.

m $_0$ = tan $_T$ and any $_T$ (0 < $_T$ < =2) is equally probable. The $_T$ can be identified to the mixing between dilaton and moduli which breaks SUSY. The scale dependence of m $_{\rm H_u}^2$ can be written as

$$m_{H_0}^2 (Q) = m_0^2 K_0 (Q) + m_{1=2}^2 K_{1=2} (Q)$$

Then the distribution function of the scale t_H $\ln Q_H$ where $m_{H_u}(Q_H) = 0$ is

$$D \ [t_{H}] = c^{t} \frac{\frac{V}{u}}{K_{1=2}} \frac{K_{0}}{K_{0} + K_{1=2}} \frac{d}{dt} \frac{K_{1=2}}{K_{0}}$$

In the minimal supergravity, Q_H has a maximal value Q_H^{max} 10^{10} GeV for $m_0 = 0$ and $K_{1=2}(Q_H^{max}) = 0$, and a minimal value Q_H^{min} 5 TeV (when tan = 40) for large m_0 and $K_0(Q_H^{min}) = 0$. We plot the distribution function in Fig.4. The scale t_H does not have strong preference except for the scales to be around the minimal and maximal values. The probability around the minimal and maximal values arising from the integration of the distribution function is not very large. Therefore, in the landscape, we do not obtain a typical preference of the hierarchy.

5.3 Landscapes of Q_{τ} and Q_{0}

We distribute both m $_{1=2}$ and ^ with D $[m]_{1=2}^2] = D [^2] = const.$ The distribution function is given as dP = D $[m]_{1=2}^2$ $[D]_{1=2}^2$ d^2. We note that d and d^ is the same measure up to normalization when m $_{1=2}$ is xed, but if m $_{1=2}$ is also distributed, those two measures need to be distinguished.

When m $_{1=2}$ and ^ are distributed, both Q $_{t}$ and Q $_{0}$ are distributed. The distribution function of to and the ln Q $_{t}$ can be written as D [to;t] = c (to t) $e^{2t} \frac{d}{dt} \frac{M_H^2}{I} j_{=t_0}$, where is a step function. Dening tz to (tz > 0), we obtain

D [t₀; t_z] = ce
$2t_z$
 e 2t_0 $\frac{d}{dt} \frac{M_H^2}{I}$; (33)

and the distribution function can be decomposed as D [t_z] / e 2t_z and D [t_0] / e 2t_0 $\frac{d}{dt}$ M $_H^2$ = Ij. The hierarchy between the Z boson and stop mass is given as M $_Z^2$ =m $_t$ = t_z as in Eq.(20). The little hierarchy of M $_Z$ -m $_t$ is probable from the distribution function D [t_z] / e 2t_z in the same way when we just use m $_{1=2}$ distribution.

Since the large t_0 is strongly probable due to the exponential factor in the distribution function D $[t_0]$ / $e^{2t_0} j_{dt}^d M_H^2 = I j$ the scale Q_0 is most probably just below the maximal value of Q_0 which is the scale Q_H . Therefore, all three scales, Q_t , Q_0 and Q_H are close by. Since Q_0 is just below the scale Q_H , the parameter must be small by de nition:

In fact, the small is the most probable as one can see from the distribution function which is calculated as

$$D [^{2}(Q_{0})]' c 1 + \frac{2}{M_{u}^{2} j} \exp 2 \frac{2}{M_{u}^{2} j};$$

where dot represents for $t = \ln Q$ derivative. Therefore, this landscape mostly prefers the little hierarchy with small Higgsino mass, which is a demand from naturalness. For our universe, we have to choose the SUSY breaking scenario to make the Q_H to be TeV scale. In the minimal supergravity, m_0 needs to be large to make Q_H to be at the TeV scale, which corresponds to the focus point solution [18]. We stress that naturalness is not required in this landscape, but the naturalness vacua are most probable.

We remark that Q_H must not be distributed in this landscape, otherwise SUSY breaking scale becomes just below the maximal value of Q_H , which is 10^{10} GeV in minimal supergravity.

5.4 Sum mary of dierent Landscapes

We have studied several landscapes to distribute parameters (m $_{1=2}$, ^, m^0) in m inimal supergravity. The important scales to describe the landscape of electroweak symmetry breaking vacua are stop mass Q $_{t}$, symmetry breaking scale Q $_{0}$ (at 2 = M $_{H}^{2}$), and the scale Q $_{H}$ where M $_{H}$ = 0. The scales Q $_{0}$ and Q $_{H}$ do not depend on the overall mass scale which we choose m $_{1=2}$, and Q $_{H}$ does not depend on ^.

W e consider the following typical landscapes:

- 1. If we distribute the overall mass scale that is chosen to be m $_{1=2}$, we can obtain a little hierarchy with enough probability irrespective of the sensitivity function. Naturalness (smallness of) is not necessary in the landscape.
- 2. If we distribute and x the overall scale, the little hierarchy between Z boson mass and SUSY breaking scale is not probable, but the hierarchy between $Q_0 Q_H$ is probable i.e., a large could exist.
- 3. If we distribute only m_0 , we do not obtain any particular probable hierarchy.
- 4. If we distribute both m $_{1=2}$ and $^{\circ}$, it is probable that all three scales are close. Therefore, naturalness vacua with little hierarchy is the most probable. The SUSY breaking scenario needs to be xed to make Q $_{\rm H}$ (or Q $_{\rm H}^{\rm max}$ if it is distributed) to be TeV scale in our universe. In them SUGRA model, m $_{0}$ $^{\prime}$ O (10) is required. One can consider specic SUSY breaking models such as in Ref.[19, 20].

6 Conclusion

The absence of the SUSY signals at LEP and Tevatron has pushed up the SUSY particle mass scale compared to the M $_{\rm Z}$ scale. The colored SUSY particles are now around 1 TeV scale in the m SUGRA models and therefore created a little hierarchy between this scale and the Z boson mass scale. It is said that naturalness of the electroweak symmetry breaking requires the smallness of the Higgsino mass .

We investigated this situation in the context of landscape of electroweak sym metry breaking vacua. We include radiative sym metry breaking and found that in order to obtain a little hierarchy between Z boson mass and SUSY breaking scale with enough probability, we need to distribute the overall SUSY breaking mass scale. In this landscape, the naturalness (small value of) is not required. The Higgsino mass can be large or small and the scale Q_0 where the electroweak symmetry breaking conditions are satisted needs to be chosen around 1 TeV in our universe as one of the vacua in the landscape of little hierarchy. In this scenario, the SUSY breaking mass is preferred to be just below the scale Q_0 , in the electroweak symmetry breaking vacua and therefore the little hierarchy can be rationalized.

If is also distributed along with the overall SUSY breaking mass, natural vacua (small) is found to be probable among the electroweak symmetry breaking vacua. In this landscape, the scale $Q_{\rm H}$, where the SUSY breaking Higgs mass squared turns negative, has to be selected at a TeV scale in our universe by choosing a SUSY breaking scenario.

If we only distribute , the little hierarchy is less probable, and the naturalness is dem anded as usually discussed.

We note that the landscape with overall scale distribution supports the little hierarchy with enough probability, but do not support huge hierarchy between SUSY breaking scale and the Z boson mass, such as split SUSY [21] or non-SUSY standard model at low energy where all SUSY particles are decoupled. Actually, the stop mass is less than 3 TeV at 99% probability. We also comment that the vacua with all scalar particles (including Higgs elds) and gauginos being decoupled are enormously probable rather than low energy SUSY vacua in this landscape picture. The proper statement is that the little hierarchy is mostly probable among the low energy SUSY vacua with radiative electroweak symmetry breaking by Higgsmechanism.
