# $P$ ion form factor at very large $Q^{2}$

#### Abstract

The pion form factor at very large $Q^{2}$ is obtained by using a new pion wave function. It show s that when $Q^{2} \gg(1: 8 \mathrm{GeV})^{2}$ the pion form factor reaches the asym ptotic lim it $\frac{s\left(Q^{2}\right)}{Q^{2}}$.


$P$ ion form factor is a very im portant quantity in hadron physics. The current $m$ atrix elem ent of pion is w ritten as

$w$ here $\quad$ is the $w a v e$ function of $p i o n, k_{1} ; k_{2}$ are intemal $m$ om enta of $p i o n, p_{i}$ and $p_{f}$ are the $m$ om enta of initial and nal pion respectively, $T_{H}$ is the kemel of the $m$ atrix elem ent, $Q^{2}=\left(p_{f} p_{i}\right)^{2}, P=\left(p_{f}+p_{i}\right)$. In Refs.[1] the pion form factor at large $m$ om entum transfer has been studied by perturbative QCD. The perturbative QCD predicts that one gluon exchange dom inates $\mathrm{T}_{\mathrm{H}}$ and at large $\mathrm{Q}^{2}$

U sing a set of pion wave function, in Refs.[1] it is obtained

where the pion decay constant $\mathrm{f}=0: 186 \mathrm{GeV}$ is taken.
It is known that the wave function of pion is determ ined by nonperturbative QCD [2]. A s a $m$ atter of fact, in $R$ ef.[3] three di erent wave functions are chosen to calculate $F\left(Q^{2}\right)$. A nother wave function ofpion is discussed in Ref.[4]. In this short note a new wave function of pion is introduced to calculate $F\left(Q^{2}\right)$ at large $Q^{2}$. Eq. (2) is valid at large $Q^{2}$. The range
off $\left(Q^{2}\right)$ in which the behavior (2) is valid is another issue. W etry to nd the range in this note.

A proper wave function of pion determ ined by nonperturbative QCD should at least satisfy tw o criteria: determ ining the pion decay constant $f$ and the form factor at lower $Q^{2}$ in both space-like and tim e-like regions. N onperturbative Q CD is not solved analytically. It is well know $n$ that current algebra is successfiul in studying hadron physics at low er energies. $T$ he vector and axial-vector currents are constructed by quark elds. C hiralsym $m$ etry is one of the features of QCD. T herefore, current algebra has close relation $w$ ith nonperturbative QCD. In Ref.[5]based on current algebra and chiralsym $m$ etry an e ective chirallagrangian of pseudoscalar, vector, and axial-vectorm esons is constructed as

where $a={ }_{i} a^{i}+f, v=i^{i}+!, u=\operatorname{expfi}{ }_{5}\left(i_{i}+\right) g$, and $M$ is the $m$ atrix of current quark $m$ asses. $m$ is the constituent quark $m$ ass and it originates in quark condensation. Therefore, this theory has dynam ical chiral sym m etry breaking. Integrating out the quark elds, the Lagrangian of $m$ esons is obtained. T he tree diagram $s$ are at leading order in $N_{C}$ expansion and loop diagram s of $m$ esons are at higher order. It is known that quark condensation and $\mathrm{N}_{\mathrm{C}}$ expansion are from nonperturbative QCD.Therefore, the e ects of
nonperturbative Q CD are em bedded in the Lagrangian (4). M eson physics has been extensively studied by this Lagrangian. Theory agrees with data very well. D etails can be found in Ref.[5]. By nom alizing the kinetic term of pion to $\frac{1}{2} @{ }^{\text {i } @ ~} \quad$, the pion decay constant is de ned

k is in Euclidean space. In this theory the pion elds have two sourøes: $\mathrm{u}=\operatorname{expfi}_{5} \mathrm{~g}=$ $1+i_{5}+:::$ and the shifting a ! a (physical) $\frac{\mathrm{c}}{\mathrm{g}}$ @ . The shifting is caused by the $m$ ixing term $a^{i} @{ }^{i} . c$ is determ ined to be

and $g$ is obtained from nom alizing the kinetic term of the vector elds and determ ined to be 0.39 by tting the decay rate of ! ee . A fter norm alization the pion eld of Eq. (4) is rede ned as $\frac{2}{f}$. Combining these two sources together, the vertex related to pion is obtained as

where the di erential operator only acts on pion eld. It is w orth to $m$ ention that the second term ofEq. (8) is very im portant in understanding the $m$ eson physics related to pion [5]. $P$ ion
form factor is derived［6］

T he radius of charged pion is obtained from Eq．（9）

The second term of Eq．（10）is the new result obtained from this theory［5］and it $m$ akes signi cant contribution to $\left\langle r^{2}\right\rangle$ ．B oth the form factor and the radius agree $w$ ith data very well．In Refs．［6］the vertiges are derived up to the $4^{\text {th }}$ order in derivative and the agreem ent betw een the theory and the experim ents in both space－like and tim e－like regions up to 边 ${ }^{\text {〕 }}(1: 2 \mathrm{GeV})^{2}$ ．In Eqs．$(9,10)$ the term $s$ obtained from the shifting of a eld plays an essential role．W thout these term $s$ theoretical results do not $t$ the data．

U sing the vertex（8），the wave function of pion is derived as

A s m entioned above，$f$ is de ned by norm alizing the kinetic term of pion elds．On the other hand，f can be derived by the pion w ave function（11）

Substituting Eq.(11) into Eq.(12), Eq.(5) is revealed. In the study of pion form factor(9) the Vector M eson D om inanc (VM D) is used. The VM D is a natural result of Eq.(4) [5]. It is equivalent to reexpress $F \quad\left(Q^{2}\right)$ done in Refs.[6] by pion wave function (11). Therefore, the pion wave function obtained from Eq.(11) passes the two tests: determ inations of $f$ and F ( $Q^{2}$ ) at lower values of $Q^{2}$.

At large $Q^{2}$ perturbative $Q C D$ is working [1]. $U$ sing the pion wave fiunction (11) and $T_{H}$ with one gluon exchange as given in Res.[1], the m atrix elem ent of current of pion (1) is w ritten as

where $(k ; p)$ is the pion wave function in $m$ om entum space, $k$ is the intemalm om entum and $p$ is the $m$ om entum of the pion,

In Ref.[5] the universal coupling constant $g$ is de ned as

T he integral is in Euclidean space. A smentioned above $g$ takes nite value, therefore, a cuto of the integralhas to be introduced and is determ ined by the value ofg as $=1: 8 \mathrm{GeV}$. For $\mathrm{Q}^{2} \gg(1: 8 \mathrm{GeV})^{2}$ Eq.(13) is rew rilten as

The pion form factor at $\mathrm{Q}^{2} \gg(1: 8 \mathrm{GeV})^{2}$ is obtained

In sum $m$ ary, a new wave function of pion which is successful in obtaining $f$ and the pion form factor at low er $Q^{2}$ is used to calculate the pion form factor at very large $Q^{2}$. T he F $\left(Q^{2}\right)$ obtained in this short note is m uch sm aller than the one presented in $R$ efs. [1]. T he Eq.(17) is valid in the range $\mathrm{Q}^{2} \gg(1: 8 \mathrm{GeV})^{2}$.
