# Fluctuations and the Phase Transition in a ChiralM odelwith Polyakov Loops

W e explore the NJL m odelw ith Polyakov bops for a system of three colors and two avors within the m ean-eld approximation, where both chiral sym m etry and con nem ent are taken into account. W e focus on the phase structure of the m odel and study the chiral and Polyakov bop susceptibilities.

#### I. IN TRODUCTION

Low-energy phenom ena of QCD have been studied in various e ective m odels based on chiral sym m etry. H ow ever, the relation of spontaneous chiral sym m etry breaking and con nement remains an open issue. Recently, color degrees of freedom were introduced in the N am bu{ Jona-Lasinio (NJL) Lagrangian [1, 2] through an e ective gluon potential expressed in term s of Polyakov loops (PNJL model) [3, 4]. The basic ingredients of the model are constituent quarks and the Polyakov loop, which is an order parameter of the Z(3) symmetry of QCD in the heavy quark lim it. The model has a non-vanishing coupling of the constituent quarks to the Polyakov loop and m im ics con nement in the sense that only threequark states contribute to the therm odynamics in the low-tem perature phase. Hence, the PNJL model yields a better description of QCD therm odynamics near the phase transition than the NJL model. Furtherm ore, due to the sym m etries of the Lagrangian, the m odel belongs to the sam e universality class as that expected for QCD. Thus, the model can be considered as a testing ground for the critical phenom ena related to the breaking of the globalZ (3) and chiral sym m etries.

It has been shown that the PNJL model, formulated at nite temperature and nite quark chemical potential, well reproduces some of the thermodynamical observables computed within lattice gauge theory (LGT). The properties of the equation of state [4], the in-medium modi cation of meson masses [5] as well as the validity and applicability of the Taylor expansion in quark chemicalpotential used in LGT were recently addressed within the PNJL model [6, 7, 8, 9]. In Ref. [10] the model was extended to a system with nite isospin chemicalpotential and pion condensation was studied.

Enhanced uctuations are characteristic for phase transitions. Thus, the exploration of uctuations is a prom ising tool for probing the phase structure of a system. The phase boundaries can be identiaed by the response of the uctuations to changes in the therm odynam ic param eters. In this article we describe the susceptibilities of the order param eters and their properties in the PNJL m odel follow ing R ef. [11].

# II. NAMBU {JONA-LASINIO MODEL W ITH POLYAKOV LOOPS

An extension of the NJL Lagrangian by coupling the quarks to a uniform temporal background gauge edd, which manifests itself entirely in the Polyakov loop, has been proposed to account for interactions with the color gauge edd in elective chiralmodels [3, 4]. The PNJL Lagrangian for three colors ( $N_c = 3$ ) and two avors ( $N_f = 2$ ) with non-local four-ferm ion interactions is given by

where  $\hat{m} = \text{diag}(m_u; m_d)$  is the current quark m ass, ^ = diag( $_u; _d$ ) is the quark chem icalpotential and ~ are the Pauli matrices. We assume isospin symmetry and take  $m_u = m_d - m_0$  and  $_u = _d$ .

Here we have introduced non-local interactions which are controlled by a form factor in order to deal with the ultraviolet singularities that appear in the loop integrations. In coordinate space, the form factor F(x) for the non-local current-current interaction reads:

A possible choice for the regulator is in m om entum space given by [12]:

where f (p) is the Fourier transform of the form factor F (x) and p is the three (m om entum. The NJL sector is controlled by four parameters: the strength of four-ferm ion interaction  $G_S$ , the current quark m ass m<sub>0</sub> and the constants and , which characterize the range of the non-locality. These parameters are determined in vacuum, for a given , by requiring that the experimental

values of the pion parameters and the quark condensate are reproduced.

The interaction between the elective gluon eld and the quarks in the PNJL Lagrangian is in plemented (2.1) by m eans of a covariant derivative

where we introduce the standard notation  $A = gA^{a} \frac{a}{2}$ . Here g is the color SU (3) gauge coupling constant and a are the G ell-M ann m atrices.

The e ective potential U of the gluon eld in (2.1) is expressed in terms of the traced Polyakov loop and its conjugate

with P being the path (Euclidean time) ordering, and = 1=T with  $A_4$  =  $iA_0$ . In the heavy quark mass limit, QCD has the Z(3) center symmetry which is spontaneously broken in the high-temperature phase. The therm al expectation value of the Polyakov loop h i acts as an order parameter of the Z(3) symmetry. Consequently, h i = 0 at low temperatures in the con ned phase and h i  $\leq$  0 at high temperatures corresponding to the decon ned phase.

The elective potential U(;) of the gluon eld is expressed in term softhe Polyakov loops so as to preserve the Z (3) symmetry of the pure gauge theory [13]. We adopt an elective potential of the following form [4]:

The coe cients T  $_0$ ,  $a_i$  and  $b_i$  are xed by requiring that the equation of state obtained in pure gauge theory on the lattice is reproduced. In particular, at T $_0 = 270 \text{ M eV}$  the model reproduces the rst order decon nem ent phase transition of the pure gauge theory.

## III. SUSCEPT IB IL IT IES AND THE PHASE STRUCTURE

In the PNJL model the constituent quarks and the Polyakov loops are elds related with the order parameters for the chiral and Z (3) symmetry breaking.




FIG.1: The chiral  $m_m$  (dashed-line) and the Polyakov loop 11 (solid-line) susceptibilities in the chiral lim it as functions of temperature T for = 0.

In LGT the susceptibilities associated with these elds show clear signals of the phase transitions [14].

In Fig. 1 we show the chiral mm and Polyakov loop  $_{11} = h$  i h ih is susceptibilities computed at = 0in the PNJL model in the chiral lim it within the mean eld approximation. The chiral susceptibility exhibits a very narrow divergent peak at the chiral critical tem perature  $T_{ch}$ , while the peak of  $_{11}$  is much broader and the susceptibility remains nite at all temperatures. This is due to the explicit breaking of the Z (3) sym metry by the presence of quark elds in the PNJL Lagrangian. Nevertheless, 11 still exhibits a peak structure that can be considered as a signal for the decon nem ent transition in this model. One nds the interference of 11 with mm in Fig.1: At the chiral transition,  $T = T_{ch}$ , there is a narrow structure in 11. W e stress that this feature is not related with the decon nem ent transition, but expresses the coupling of quarks to the Polyakov loops. Thus, for the param eters used in the model, the decon nem ent transition, signaled by the broad bum p in 11, sets in earlier than the chiral transition at vanishing net quark density.




FIG.2: The phase diagram of the PNJL model in the chiral lim it. The solid (dashed) line denotes the chiral (decon nement) phase transition respectively. The TCP (bold-point) is located at ( $T_c = 157$ ;  $_c = 266$ ) MeV.

The peak positions of the mm and mm susceptibilities determ ine the phase boundaries in the (T; ){plane. At nite chem ical potential, there is a shift of the chiral phase transition to lower temperatures. In Fig. 2 we show the resulting phase diagram for the PN JL model. The boundary lines of decon nem ent and chiral symmetry restoration do not coincide. There is only one com – m on point in the phase diagram where the two transitions appear simultaneously. Recent LG T results both at vanishing and at nite quark chem ical potential show that decon nem ent and chiral symmetry restoration appear in QCD along the same critical line [14]. In general it is possible to choose the PN JL model parameters such that the both critical tem peratures coincide at = 0.

From Fig.2 one nds that the slope of  $T_{dec}$  as a function of is alm ost at, indicating that at low tem perature the chiral phase transition should appear much earlier than decon nem ent. How ever, there are general arguments, that the decon nem ent transition should precede restoration of chiral symmetry (see e.g. [15, 16]). In view

of this, it seems unlikely that at T ' 0 the chiral symmetry sets in at the lower baryon density than decon nement. In the PNJL model, the parameters of the elective gluon potential were xed by tting quenched LGT calculations. Consequently, the parameters are taken as independent on . However, it is conceivable that the elect of dynamical quarks can modify the coel cients of this potential, thus resulting in {dependence of the parameters. Consequently, the slope of  $T_{\rm dec}$  as a function of could be steeper <sup>1</sup>. Consequently, the elective Polyakov loop potential (2.7) should, with -independent coel cients, be considered as a good approximation only for =T < 1.

W hile the susceptibilities mm and mm exhibit expected behaviors associated with the phase transitions, other Polyakov loop susceptibilities,

are negative in a broad temperature range above  $T_{ch}$ [11]. This is in disagreement with recent lattice results, where II is always positive in the presence of dynamical quarks [14]. A possible origin of this behavior could be the approximation to the elective Polyakov loop potential used in the Eq. (2.7).

Recently an improved e ective potential with temperature-dependent coe cients has been sug-




FIG.3: The  $_{11} = _{11}$  susceptibility in the chiral limit as a function of temperature T for = 0. The elective Polyakov loop potential (3.2) was used.

The polynom ial in and , used in (2.7), is replaced by a logarithm ic term, which accounts for the H aarm easure in the group integral. The parameters in (3.2) were xed to reproduce the lattice results for pure gauge QCD therm odynam ics and for the behavior of the Polyakov loop. In Fig. 3 we show the 11 susceptibility calculated with the potential of Eq. (3.2). The improved potential indeed yields positive values for all the Polyakov loop susceptibilities. We note that the phase diagram calculated with the improved potential is sim ilar to that obtained with the previous choice of the Polyakov loop interactions, shown in Fig. 2.

## IV. SUMMARY AND DISCUSSIONS

W e introduced susceptibilities related with the three di erent order param eters in the PN JL model, and analyzed their properties and their behavior near the phase transitions. In particular, for the quark-antiquark and chiral density-density correlations we have discussed the interplay between the restoration of chiral sym m etry and decon nem ent. W e observed that a coincidence of the decon nem ent and chiral sym m etry restoration is accidental.

We found that, within the mean eld approximation and with the polynomial form of an eld ective gluon potential the correlations of the Polyakov loops in the quark { quark channel show an unphysical behavior, being negative in a broad parameter range. This behavior was

traced back to the param eterization of the Polyakov loop potential. We argue that the Z (N)-invariance of this potential and the t to lattice therm odynam ics in the pure gluon sector is not su cient to provide correct description of the Polyakov loop uctuations. A ctually it was pointed out [7] that the polynom ial form used in this work does not possess the complete group structure of color SU (3) sym metry. The im proved potential of R ef. [7] yields a positive, i.e. physical, 11 susceptibility, in qualitative agreem ent with the LGT results.
