# P om eron w ith a running coupling constant in the nucleus

A bstract
The running coupling is introduced into the equation for propagation of the pom eron in the nucleus via the bootstrap relation. T he resulting equation coincides w ith the one obtained in the colour dipole form alism by sum $m$ ing contributions from quark-antiquark loops, w ith a general choige of the regularization schem e.

## 1 Introduction

Lately a renewed interest has been shown tow ards introduction of a running coupling into the BFKL dynam ics. Sum mation of contributions from the quark-antiquark loops to the evolution of the gluon density has been used to restore the full dependence of the coupling on the running scale in the color dipole approach [1, 2, 3]. It tumed out that the obtained kemel for the linear BFKL equation essentially coincides w th the one whidh we found $m$ any years ago by im posing the bootstrap condition necessary for the fiul m ent of unitarity [4, 5]. In this paper we draw attention to the fact that the bootstrap condition in fact allows to derive also the structure of the triple pom eron interaction and thus the form of the non-linear BFKL equation describing propagation of the pom eron in the nucleus. This is a simple consequence of the possibility to express the basic splitting kemel from 2 to 3 and 4 ghons ('the Bartels vertex', [6]) via the basic BFKL interaction. The relation betw een the splltting vertex and reggeized ghon interaction, together w ith the bootstrap, are the necessary ingredients of the pom eron interaction in the reggeized gluon approach. Indeed they allow to present all contributions to the 4 -ghon am plitude in the standard form of a pom eron splitting into two pom erons. Thus preserving these two relations seem $s$ to be essential for the construction of pom eron interaction $w$ ith the running coupling.

As in our earlier paper, we have to stress from the start that introduction of the running coupling into the BFK L form alism cannot be m ade rigorously and uniquely. T he form alism adm its transverse $m$ om enta of any $m$ agnitude, including very $s m$ all ones, at $w h$ ich the concept of the gluon and its coupling looses any sense. T he introduced running coupling has to be arti cially continued to sm all m om entum values, where it is com pletely undeterm ined. The only inform ation one can get from the running of the coupling refers to the region of $h$ igh $m$ om enta. It rem ains to be seen in what $m$ easure this inform ation depends on the low $m$ om entum behaviour, which cannot be xed theoretically in any reliable manner. It is known however that the non-linear BFKL equation, unlike the linear one, is not very sensitive to the infrared region. So hopefully this equation has a better chance to produce results weakly dependent on the assum ed infrared behaviour of the running coupling.

The paper is organized as follow s . T he rst section is dedicated to the derivation of the triplepom eron vertex w th the running coupling introduced via the bootstrap relation. A fter recalling this m ethod to introduce the running coupling, we go along the sam e steps as in [7, [8], where the vertex was derived in the $\lim$ it $N_{C}$ ! 1 for the $x e d$ coupling. In Section 3 we construct the fiull am plitude w ith a single triple pom eron interaction, coupling the vertex $w$ ith three pom erons. This result enables us to build the equation for the pom eron in the large nucleus in Section 4. Finally in Section 5 we com pare our results $w$ ith those obtained w ithin the colour dipole approach.
$H$ aving in $m$ ind application of the form alism to the large nucleus as a target, we lim it ourselves to the case of propagation of pom erons w th zero totalm om enta. H ow ever generalization to non-zero totalm om enta is straightforw ard.

## 2 T rịle-P om eron vertex

### 2.1 G eneralities

A smentioned in the Introduction, this paper follows the idea to introduce a running coupling via the bootstrap [4, 5]. D erivation of the triple-pom eron vertex in the $\lim$ it $N_{c}!1$ then goes as presented in [7, 8] for the xed coupling case.

B asic form ulas for the introduction of a running coupling via the bootstrap condition consist in expressing both the ghon trajectory ! and interghon interaction in the vacuum channelk in term s of a single function (q) of the gluon $m$ om entum, which then can be chosen to conform to the high-m om entum behaviour of the ghon density w ith a running coupling. Explicitly

In these de nitions it is assum ed that $q_{1}+q_{2}=q_{1}^{0}+q_{2}^{0}=q$. For arbitrary (q) the follow ing bootstrap relation is satis ed:

$w$ here $V$ is the standard BFKL interaction. N ote that the extra 2 in the denom inator corresponds to the BFKL weight $1=(2)^{3}$ in the $m$ om entum integration, which we prefer to take standardly as $1=(2)^{2}$.

From the high-m om entum behaviour of the ghon distribution with a running coupling one nds

A s to the behaviour of (q) at $s m$ all $m$ om enta, we shall assum e

which guarantees that the ghon trajectory! (q) passes through zero at $q=0$ in accordance w ith the ghon properties. T he asym ptotic (5) and condition (7) are the only properties of (q) which follow from the theoretical reasoning. A concrete form of (q) interpolating between (7) and (5) $m$ ay be chosen di erently. O ne hopes that the follow ing physical results will not strongly depend on the choige.

O ur old derivation in (7] of the triple-pom eron vertex was actually based on the property (7) obviously valid for (4), the bootstrap relation and the relation betw een the B artels transition vertex $\mathrm{K}_{2!} 3$ and interghon BFKL interaction V (Eq. (12) in [7])

$H$ ere and in the follow ing we frequently denote ghon $m$ om enta just by num bers: $1 \quad q_{1}, 1^{0} \quad q_{1}^{0}$ etc. A lso we use $12 \quad q_{1}+q_{2}$. A $1 l$ the rest conclusions were obtained from these three relations in a purely algebraic $m$ anner.

O ur idea is that if we de ne the transition vertex by a sim ilar relation in term $s$ of the new intergluon vertex K , Eq. (2), then all the derivation $w$ ill rem ain valid also for arbitrary (q) satisfying (7) and thus for a running coupling, provided (q) is chosen appropriately. In the next subsection we brie y recapitulate successive stages of the derivation for arbitrary (q)w ith (0) $=0$.

## 2 .2 Leading order in $N_{C}$ ! 1

The changes necessary to pass to arbitrary (q) are minim al. Obviously in our old form ulas we have to drop the coupling constant $g$ factors, since now $g$ is provided by $1=. W$ e also drop factors $N_{c}$ in the interaction because we prefer to include it into the kemel K . $W$ ith these com $m$ ents, the tw o-ghon equation becom es

and $f\left(q_{1} ; q_{2}\right)$ is just the quark-antiquark loop with, say, the ghon $w$ ith $m$ om entum $q_{1}$ coupled to the quark and the other, w ith $m$ om entum $q_{2}$, coupled to the antiquark. W ith the running coupling D 20 does not change its form, but both ! in (10) and $K$ in (9) are now given by Eqs. (1) and (2) respectively.

The three-ghon system exists in two colour states, which di er in the ordering of the three ghons along the loop, 123 and 213. For each order the equation is

The new elem ent is the term $\mathrm{D}_{2}!3$ whidh corresponds to transitions of the in itial tw o-ghon system into the nal three-ghon system. This transition is accom plished by the $2!3$ vertex W which, as explained, we de ne via the new interghon interaction by a relation sim ilar to (8)

N ext step is to show that Eq. (12) for the three-gluon system is solved by the reggeized zero term ansatz:

Passing to the $4-g l u o n$ system, in the $\lim$ it $N_{c}$ ! 1 we nd two con gurations di ering by the order of ghons along the quark-antuquark loop: 1234 and 2134. The equation goveming the 4-ghon system is

Repeating the corresponding derivation in [7] we dem onstrate that in the lim it $\mathrm{N}_{\mathrm{c}}$ ! 1 the solution of the $4-g h u o n$ equation is again given by the reggeized zero-order term s :

T he proof is purely algebraic and is wholly based on the bootstrap and relations (15) and (7) valid for any choice of function (q) w ith $(0)=0$.

### 2.3 The triple pom eron con guration

Next step is to study the next-to-leading con guration in $\mathrm{N}_{\mathrm{c}}$ ! 1 corresponding to the triple pom eron interaction. A gain the derivation practically literally repeats our old one for a xed coupling constant. T he goveming 4-ghon equation is sim ilar to Eq. (20)

The form al di erence is in the absence of interaction between the two nal pom erons, which are assum ed to be $m$ ade of ghon pairs $(1,2)$ and $(3,4)$, doubling of the rest interactions acting in the vacuum colour channels and in the appearance of the term $D_{4!4}$, which describes transitions from the leading colour con guration to the subleading one corresponding to two pom erons.

$T$ his form ula is identical to the old one in [7], but $w$ ith new expressions forboth $W$ and ! in term $s$ of function .

### 2.4 The triple pom eron vertex

C orresponding to the two inhom ogeneous term $s$ in Eq. (34) its solution is split in two term $s$, the double pom eron exchange term, generated by $\mathrm{D}_{40}$, and the triple pom eron interaction term Z $\quad D_{2}$. H ow ever one can sim plify the solution transferring the part of the double pom eron exchange term leading in the high-energy lim it into the triple interaction part ( $[9,8]$ ). This is achieved by separating from the total solution the reggeized D 40 term :

The derivation again uses only the bootstrap, relation (15) between $W$ and $K$ and property (7). $T$ he explicit form for the new triple-pom eron vertex $Y$ tums out to be

For a xed coupling constant this expression was found long ago in [9]. In our approach it rem ains true also for arbitrary function (q) and thus for a running coupling introduced by $m$ eans of this function.

## 3 C oupling to pom erons

### 3.1 M om entum space approach

In the $m$ om entum space coupling the vertex $Y$ to two ougoing pom erons is straightforw ard. The two pom erons are described by a product $P(1 ; 2) P(3 ; 4)$ and all one is to do is to integrate this product w th $Y \quad D_{2}$ over the gluon $m$ om enta $1,2,3$ and 4 with 12 and 34 xed and $1234=0$ from the $m$ om entum conservation.

Aswith a xed coupling constant, there are certain properties of the wave function and the vertex which sim plify the resulting expression. First we expect that the pom eron wave function in the coordinate space $P\left(r_{1} ; r_{2}\right)$ vanishes if the two ghons are located at the sam e spatial point: $P(r ; r)=0$. This property is well-known for the BFKL pomeron $w$ ith a xed coupling constant and is related to the behaviour of (4) at $q=0 . W$ th a running coupling this behaviour does not change, so we expect that the coordinate $w$ ave function $w i l l$ continue to vanish at $r_{1}=r_{2}$. As a result the last ve term $s$ in the sum (39) w ill give no contribution, since they depend only on the sum of the $m$ om enta in one of the pom erons and so put the two ghons at the sam e spatial point in it. If the $m$ entioned property of the pom eron $w$ ave function is violated $w$ ith the introduction of a running coupling, we still can drop the ve last tem s once we restrict ourselves to the case when the tw o pom erons are taken at zero totalm om entum : $12=34=0$, which is the only case relevant for the pom eron propagation through the nucleus. Indeed direct inspection show s that

## 5 D iscussion

Eqs. (78) and (82) present our nal result for the non-linear BFKL equation w ith the running coupling. W e stress that function (q) in them is determ ined only by its asym ptotic form (5) together w th the requirem ent (7). A sim ple possibility is to choose

with b given by (6) and arbitrary $a>1$. A lso one has to rem em ber that the equations are derived only in the leading order in the running coupling. A lready subleading term $s$ of the relative order $1=\ln \left(q^{2}={ }^{2}\right)$ rem ain undeterm ined, since they correspond to the next-to-leading order in the running coupling.

O ur nal coordinate space equation (82) fully coincides w th Eq. (101) in (1] obtained in the dipole form alism (for the forw ard case). H ow ever in our approach the running couplings $s(r)$ and ${ }_{s}\left(r_{1} ; r_{2}\right)$ are de ned by Eq. (81) in a generalm anner, irrespective to any regularization procedure and are determ ined by the concrete choige of function (q). In fact they are xed only in as far the high $m$ om entum behaviour of this function is know $n$ and so adm it a high degree of arbitrariness. It rem ains to be seen how this arbitrariness in uence concrete results which follow from the solution of the evolution equation (82).

## 6 A ppendix. Function $F\left(r_{1} ; r_{2}\right)$ w ith a xed coupling constant

W e chedk that for a xed coupling constant function $F\left(r_{1} ; r_{2}\right)$ indeed passes into the expression corresponding to Eq. (57). In the xed coupling case (k) is given by (4) Then we nd

Form ing $F\left(r_{1} ; r_{2}\right)$ according to (71) we see that term sw ith c canceland dropping term sproportional to ${ }^{2}\left(r_{1}\right)$ or ${ }^{2}\left(r_{2}\right)$ we nd
